They had the intense desire to meet with their idols and also they had the means to buy the most expensive tickets and they lined up, expecting to meet with their favorite stars and have a swell time at the IIFA extravaganza. But then, it was not to be. At least, for many.

The Indian Panorama received a couple of letters describing IIFA as a hopeless and flop show, to be mild, and as a show meant to cheat patrons, at the worst. Media colleagues have also spoken about the event as the most ill organized and unwelcoming to spectators.

IIFA needs to know that its approval rating has surely gone down in this part of the world. A letter from a renowned and highly respected gentleman from medical profession says it all.

I am sure you have a very good insight on majority of what happened at and behind the IIFA show and that your coverage will narrate all that. From my perspective, I had a fair amount of doctor and other friends who flew in and bought expensive tickets 1500-5000 dollars and here is their feedback.

including Matt Damon, Julia Roberts etc. It is hard to resist the temptation of seeing SRK and Salmaan on the same stage. But, the show had none of that. This was a very cleverly done false and fraudulent marketing. Many of these people are exploring possibility of legal recourses in getting their money back, given the false claims and fraudulent marketing. (Look in to the VIP package)

2. The VIP tickets 2500 and above had a pre-event cocktail listed as part of ticket price. But to their unpleasant surprise, they had to stand in line and buy an overpriced beer and chicken fingers etc.... So much for the VIP treatment
3. The green carpet concept was essentially a fraud in its own way, where there was lot of green but hardly any carpet. There was no VIP treatment in that green carpet.
4. The show only had one focus i.e. a TV show for the colors TV as was clear by the two hosts talking at length with a poorly

written non entertaining script. Singers and Star line up was good, but even then Wizcraft managed to produce a boring show for the most part.

5. One of the moms wrote on my Facebook page that she felt sorry for those 200 kids and their dedicated parents who paid more than \$300 to participate in dance with Salman Khan.

They spent 5 days and more than 15 hours a day in dance practice at MetLife stadium. All the kids sat in the brutal 100 degree heat for the stars to come practice with them. Unfortunately, Salman never showed up for any of the practice until Thursday night at 8pm.

On the day of the event the kids were asked to be there at 1pm because Salman wanted to practice with them. Once again Salman never showed up for practice. These poor kids were sitting at the stadium from 1pm and got to perform at 3 am. On Thursday, there was also an incident happened which injured seven or more kids. One of which got severely injured

and ended up in the hospital.

## Indian American Sundar Pichai, Google's CEO, joins Alphabet's Board of Directors

**SAN JOSE (TIP):** Google's Indian American CEO Sundar Pichai is joining parent company Alphabet's board, according to an announcement on July 24 from the company.

"Sundar has been doing a great job as Google's CEO, driving strong growth, partnerships, and tremendous product innovation. I really enjoy working with him and I'm excited that he is joining the Alphabet board," said Larry Page, CEO of Alphabet, in a statement.

Formerly the Product Chief of Google, Pichai's current role as CEO was announced on 10 August 2015, as part of the restructuring process that made Alphabet Inc. into Google's parent company, and he assumed the position on 2 October 2015.

Pichai worked in engineering and product management at Applied Materials and in management consulting at McKinsey & Company.

Pichai joined Google in 2004, where he led the product management and innovation efforts for a suite of Google's client software products, including Google Chrome and Chrome OS, as well as being largely responsible for Google Drive. He went on to oversee the development of different applications such as Gmail and Google Maps. On 19 November 2009, Pichai gave a demonstration of Chrome OS and the Chromebook was released for trial and testing in 2011, and released to the public in 2012. On 20 May 2010, he announced the open-sourcing of the new video codec VP8 by Google, and introduced the new video format, WebM.

On 13 March 2013, Pichai added Android to the list of Google products that he oversees. Android was formerly managed by Andy Rubin. He was a director of Jive Software from April 2011 to 30 July 2013. Pichai was selected to become the next CEO of Google on 10 August 2015 after previously being appointed Product Chief by CEO, Larry Page. On 24 October 2015 he stepped into the new position at the completion of the formation of Alphabet Inc., the new holding company for the Google company family.

## Indian American Businesswoman Pleads Guilty to Tech Worker Visa Fraud

**SAN JOSE (TIP):** A San Jose businesswoman of Indian origin pleaded guilty in federal court last week to three counts of visa fraud. In pleading guilty, Sridevi Aiyaswamy, 50, of San Jose, admitted that between April 2010 and June 2013 she made numerous false statements, and submitted over 25 fraudulent documents, to the United States Citizenship and Immigration Services (USCIS) for the purpose of obtaining H-1B non-immigrant classifications for skilled foreign workers.

Acting as a petitioner on behalf of foreign worker beneficiaries, Aiyaswamy falsely represented in I-129 petitions that the foreign worker beneficiaries would be working at Cisco, an information technology and networking company in San Jose, Calif. Aiyaswamy further submitted counterfeit statements of work with forged signatures as back-up documentation to the I-129 petitions. In fact, at the time she submitted these documents to USCIS, Aiyaswamy knew that the statements regarding offers of work from Cisco for these beneficiaries were false statements, and that Cisco had not made any offers of employment regarding these individuals.

A federal grand jury indicted Aiyaswamy on December 3, 2015, charging her with 34 counts of visa fraud, in violation of 18 U.S.C. § 1546(a). Pursuant to today's plea agreement, Aiyaswamy pleaded guilty to three of the counts of visa fraud and the government agreed to request dismissal of the remaining counts.

Aiyaswamy is currently free on bond. Judge Koh scheduled her sentencing for November 15, 2017, at 9:15 a.m. The maximum statutory penalty for visa fraud is 10 years in prison and a \$250,000 fine.

## Arundhati Roy's Novel 'The Ministry of Utmost Happiness' in Booker Longlist

**LONDON (TIP):** Indian novelist Arundhati Roy, who won the Man Booker prize in 1997 for "The God of Small Things," is among the contenders for this year's Man Booker Prize for fiction.

On a longlist thronged with literary titans, whose combined trophy cabinet would include the Pulitzer, the Costa, the Baileys, the Folio, the Impac and the Goldsmiths prizes, Roy - the only author to have won the Booker before - is listed for her novel about an Indian transgender woman, which judges called a "rich and vital book". Speaking about why it took her two decades to produce a second novel, Roy told the Guardian earlier this year that "fiction just takes its time. It's no hurry. I can't write it faster or slower than I have; it's like you're a sedimentary rock that's just gathering all these layers, and swimming around."

On July 26, The Man Booker Prize unveiled the 13 titles longlisted for its annual £50,000 (\$81,625) award.

144 titles were submitted for consideration for the 2017 prize. The Man Booker Prize is open to any book-length work of fiction written in English that has been published in the U.K. This year's award is being judged by Baroness Lola Young, literary critic Lila Zam Zangeneh, novelist Sarah Hall, artist Tom Phillips and writer Colin Thubron. The six finalists will be named Sept. 13, and the winner of the 50,000-pound (\$65,000) prize will be announced on Oct. 17.

## Indian American Attorney Running for Civil Court Judgeship

**NEW YORK (TIP):**

Indian American Hemalee J. Patel, a lawyer and involved Brooklyn community member, is running for civil court judge in the 6th municipal district in Brooklyn, reports Kings County Politics. The district includes Northern Park Slope, Lefferts Gardens and a stretch between Coney Island Avenue and Ocean Avenue to Avenue M.

Currently, Patel serves as a Court Attorney-Referee in Richmond County (Staten Island) Supreme Court, where she conducts trials and hearings on financial issues in matrimonial matters, including equitable distribution, child support and maintenance. And while she understands legislative government, she remains drawn to the judicial branch and helping immigrants and less moneyed people navigate the often daunting judicial system, and leaving with the feeling they had a fair and just day in court.

"The quality of our lives is directly and deeply influenced by those who serve the public and I consider myself privileged to be a civil servant and try always to be one in the truest sense. This means, to my mind, that I must not only do my best, but convey that intention by being at all times honest, fair and courteous to the parties and attorneys who appear before me," said Patel.

Patel came to the U.S. from India at the age of 5 with her mother, after her father had first come here.

"As an immigrant South Asian woman I have a unique perspective that, along with my background, experience and proven ability in performing the duties and responsibilities of a Court Attorney-Referee, prepares me to undertake a career as a judge," said Patel.

She grew up in Queens, attended New York University in Manhattan, and attended Brooklyn Law School. She resides with her family in Bay Ridge.

# Missed the chance to act, Mr President

As a seasoned parliamentarian, the now ex-President, Pranab Mukherjee, is known to weigh his words before uttering them and he must have taken extra caution about what to say in his parting speech. Yet the farewell message was a little odd for the occasion. The President was telling the government not to do something which he had not disapproved of when the occasion demanded. While Mr Mukherjee's emphasis on "debate, discussion and dissent" and his observation that "disruptions hurt the Opposition more" were all well taken, it was his advice to the government to take the Ordinance route sparingly that has drawn maximum attention.

As President, Mr Mukherjee gave unqualified assent to Ordinances - as many times and as often presented. Not even once did he return to the government for reconsideration any of the crucial recommendations - be it the frequent issue of Ordinances or the imposition of President's rule. The land Ordinance was promulgated thrice. It had replaced the land Bill, which was widely dubbed "anti-farmer" and had remained stuck in the Rajya Sabha before its dilution. Again, the President happily sided with the government in approving the Ordinance that criminalized the holding of Rs 500 and Rs 1000 currency notes beyond December 31, 2016. Despite the nationwide dislocation, loss of jobs and farmer distress it caused without achieving any of the purported gains, the President did not try to satisfy himself, by asking the government or the RBI, whether sufficient arrangements were made for executing such an important policy measure.

The unquestioned approval of President's rule in the two Opposition-ruled states of Arunachal Pradesh and Uttarakhand also did not enhance his stature. It was finally left to the Supreme Court to right the wrong. His predecessor, K R Narayanan, had sent back Cabinet resolutions seeking President's rule in UP and Bihar. Most of the time the President's job is ceremonial. It is on such occasions that the worth of the Rashtrapati Bhavan occupant is judged. Pranab Mukherjee was found wanting at times. Only towards the end of his term did he talk of issues not to the government's liking such as growing intolerance, Parliament turning dysfunctional and constitutional values. It did not add up, Mr Mukherjee.

Bhim Rao Ambedkar, the chief framer of the Indian Constitution, was also an original economic thinker. The originality of his economic thinking can be interpreted as eclecticism due to his non-adherence to any one particular economic ideology - Marxism, neo-classical economic thought, support for market economy or state regulation. However, behind his eclecticism lies a common running thread in his ideas on different economic issues. That unity was provided by his concern for the Dalit sections of Indian society.

In adopting this approach, he can be compared with Karl Marx who was ruthless in his rigorous analysis of capitalism. That rigor was not merely an academic enterprise but closely linked with defending the interests of the working class. In both cases -Marx for the working class and Ambedkar for the Dalits - there was no compromise in the objective analysis of the economic conditions to suit any partisan considerations.

On the contrary, both viewed a scientific examination of the economic conditions as a necessary condition for advancing the interests of the working class and the Dalits (for Ambedkar). In the Indian context, in particular, and South-Asian context in general, the social categories of class and caste overlap and interpenetrate each other despite the autonomous status. Three main issues on which Ambedkar focused his intellectual energies were: monetary circulation in the economy, size of land holdings as a part of the broader agriculture strategy and public finance especially the pattern of federal finance.

In his writings on money, he directly challenged the dominant Keynesian view in the 1930s regarding the delinking of supply of money from gold reserves. Keynes had argued that due to the development of the monetary-exchange mechanism in advanced capitalist economies such as the UK, there was no need to limit the supply of money by linking it with the gold reserves. Ambedkar opposed this view not because he had any special fascination with gold but because he considered that delinking of money supply from gold reserves would open the possibilities of excessive supply of money. This, in turn, could lead to financial instability and inflation. From the viewpoint of the poor sections of society, Ambedkar thought that both inflation and financial instability would hit them adversely. The rich might benefit from financial instability by using a range of alternative investment options. The 2007-8 financial crisis of the global capitalist economy, triggered by unregulated financial markets and resulting in huge income and wealth inequalities, is a testimony to Ambedkar's prophetic insights. For him, the seemingly technical question of

# Ambedkar: Economics crucial for social justice

money supply and gold reserves needed to be assessed for how these impacted the welfare of Dalits who constituted the bulk of the poorer segment.

Ambedkar adopted the same method to assess the conditions in India's rural economy. He argued that fragmentation of land holdings in India was leading to decreasing the average size of land holdings to an economically inefficient level. He advocated consolidation of landholdings in order to increase the average size of a farming unit. On the face of it, this may seem against the interests of small landholders. However, from the viewpoint of economic efficiency, he did not consider the defense of uneconomic landholding size was in the interests of poor peasantry or landless workers. He, therefore, proposed cooperative agriculture which ensured pooling of smaller units into a bigger unit to avail of the economies of scale. In his view, cooperative farming was desirable for small landholders and landless workers who were mostly Dalits. In looking at alternative modes of farming and suggesting cooperative farming as the most-desirable system, Ambedkar's goal was the defense of the economic interest of the Dalits.

The third major issue Ambedkar examined was the question of public finance, dealing with revenue and expenditure of different layers of governance. His basic premise was that each level of government needed to have appropriate sources of revenue to meet its expenditure obligations. He further argued that along with the quantitative dimensions of revenue and expenditure, it was necessary to examine the qualitative dimensions of the revenue-expenditure pattern. A government may be able to generate generous revenue but it might fritter away that revenue through unproductive expenditure such as luxury spending by ministers and government officials. In contrast, even a modest increase in revenue if spent on

public goods such as health and education can have a multiplier effect on improving the quality of life. The provision of such public goods is especially important for the Dalits and other poorer sections of society.

Ambedkar also examined the impact of centralization versus decentralization on the life conditions of Dalits. From one angle, he seemed to be supportive of centralization but he also considered excessive centralization as a threat. In arguments in support of centralization, he viewed that decentralization could empower the local upper-caste elites more against the Dalits. He viewed centralization as creating conditions for authoritarianism that can weaken democracy.

In Ambedkar's view, the weakening of democracy was not in the interests of the Dalits. Precisely for this reason, Ambedkar opposed and defeated a proposal from Jawaharlal Nehru that India's Constitution could be amended by a simple majority in the Parliament. He viewed Nehru's proposal as paving the way for increased centralization and succeeded in inserting that a government needed to have at least a two-third majority in the Parliament to make a constitutional amendment. In supporting or opposing centralization, his key concern was the defense of Dalits' political and economic interests.

All those who oppose caste and other forms of discrimination need to learn this Ambedkarite method of keeping the concerns of Dalits as the central determining criterion in assessing different policy options. In the era of global climate change, a creative development of Ambedkar's ideas is necessary to suggest sustainable and egalitarian modes of economic activities.

# Country without a Prime Minister

The office of Pakistan's Prime Minister is subject to pulls and pressures far in excess of those in other democracies. But even by these standards, Nawaz Sharif is under inordinate stress. He is facing a court case and a scathing media trial.

A three-member Bench of the Supreme Court is yet to give a final verdict regarding his disqualification. The decision will be based on the report by a Joint Investigation Team (JIT) established by the orders of the court to investigate Mr. Sharif and his family's assets after the leak of the Panama Papers related to holdings in offshore companies.

The question now is whether the Chief Justice will give a verdict based on the decision of the three judges or call for a larger Bench. The judiciary might like to get the decision popularly accepted by calling for a larger Bench. It is not as if all onlookers are convinced about the judges or the JIT being bipartisan.

#### Odds stacked against PM

It is a fact that corruption investigations are not easy, especially when the country's main anti-corruption institutions, the National Accountability Bureau (NAB) and the Federal Investigation Agency (FIA), lack forensic investigation expertise. Even in the case of some of the Sharifs' assets, the JIT hired the services of a foreign company. Notwithstanding such lacunae, the highest court was willing to open up a Pandora's box of investigating "a constant murmur nationally as well internationally about respondent No. 1 (Nawaz Sharif) indulging in corruption, corrupt practices and money laundering". If proven guilty, Mr. Sharif cannot hold office as per Article 62 (1) (f) of the 1973 Constitution as he would be declared as not being *sadiq* (truthful) and *ameen* (honest). Even if the judges feel uncomfortable using the JIT report as the basis of their decision, the axe could still fall on Mr. Sharif on the basis of him officiating as a director in a company registered in the UAE while he was heading the government.

There are today very few people betting on Mr. Sharif completing his term, which if he does, he'd be the first Prime Minister to do. But as far as the popular narrative in the country goes, Mr. Sharif is already gone. The

working of the state bureaucracy has already slowed down in anticipation of some transition.

There are even rumors of Mr. Sharif's current Interior Minister, Chaudhry Nisar, being favored by both the Establishment and the rival Pakistan Tehreek-e-Insaf party as one of the candidates to replace him while the Pakistan Muslim League (Nawaz) government is allowed to complete the term.

In any case, there will be no hurry to hold the next elections due to the need for a new delimitation of constituencies based on the recently held census - senior judges believe the delimitation should take place. Meanwhile, Mr. Sharif's future role in politics will be determined by how far the court proceedings drag and how it turns out personally and politically for him in the months and years to come. What is certain is that Mr. Sharif is not inclined to resign, as was expected of him, but, if it comes to that, to go down as a political martyr - a man politically victimized by non-parliamentary institutions of the country.

The media campaign aims to make him bleed politically and increase his losses the longer he stays. Interestingly, there are serving state officials in numerous WhatsApp groups who are gently directing conversations in a certain direction, or watching while their partners do the same. It is not that lack of accountability is not a huge problem in Pakistan but that accountability has always been used as a political tool to punish rivals. Hence, ordinary people forgave Dr. A.Q. Khan, the architect of Pakistan's nuclear program, and accept him as a hero despite his confession on television regarding illegal sale of nuclear technology because in their eyes he did return something for all he took. Also, in the absence of the enactment of a strong law or principle of the rule of law, even courts are perceived by the man on the street as either corrupt or highly political. Moreover, when the law is meant to selectively conduct accountability (excluding the military and the judiciary), many raised eyebrows at an earlier judgment in the Panama Papers case that quoted Mario Puzo's *The Godfather* but no law.

#### Post-verdict scenarios

Since the power rests with the judges, their

verdict will influence the short- or longer-term future of the Sharif family. The real conversation in the drawing rooms these days is whether it is just Mr. Sharif who will be disqualified or whether it would extend to his entire family - two sons and a daughter who are the ones actually named in the Panama leaks. With his eyes already on the 2018 elections, Mr. Sharif would hope that his daughter and political heir, Maryam Nawaz, survives this crisis. This means that even if the PML(N) remains, it would be mired in infighting and could be as easily manipulated as the Pakistan Muslim League (Quaid-e-Azam) was. While parts of central and north Punjab will remain aligned with Mr. Sharif, there will be much greater activity in south and south-west Punjab where people will be influenced by, as per local political lingo, 'whichever way the strong wind blows'. This is translated as a clear indication that the Establishment is not in a party's favor.

But the process of shifting gears will essentially start with electable candidates moving to another party or contesting elections as independent candidates. In urban centers, the anti-corruption slogan, compounded with the anti-incumbency factor, will play a role.

The case against Mr. Sharif is indeed critical as the manner in which the court proceeds will determine not only his short- to medium-term political moves but also his long- to longer-term future. If the judges do not appear bipartisan and use the principle of law rather than their opinion - a fashion that dates back to Justice Iftikhar Chaudhry's days - Mr. Sharif will be perceived as a victim rather than a culprit.

Even his disqualification will then generate the myth that he was punished for something else rather than what the court and the JIT tried him for. This may not save Mr. Sharif now but will haunt the Establishment in a few years.

## DiNapoli Audit Recommends Better Protections for Child Performers

**ALBANY, NY (TIP):** The state Department of Labor is falling short in enforcing New York's laws to protect child performers, according to an audit released by New York State Comptroller Thomas P. DiNapoli. State auditors found shortfalls with how work permits were given to children and employers, inadequate monitoring of work conditions, and insufficient enforcement of requirements to set aside some of the children's earnings in a trust.

"New York needs to do more to protect child actors, dancers, musicians and models," DiNapoli said. "We have laws on the books to make certain that children are working with permits, and employers and parents are following the rules to protect the safety, health and financial rights of child performers. The state Department of Labor should hold the entertainment and modeling industries accountable to protect these children."

In New York, the state Department of Labor (DOL) enforces the laws to protect child performers, including issuing work permits, observing working conditions and enforcing trust accounts. DOL issues one-year permits to performers under 18 years of age and certificates to employers every three years. From April 1, 2014 to October 31, 2016, DOL issued about 27,000 child performer permits including: about 8,000 temporary permits, 11,000 new annual permits, 4,500 annual permit renewals, and 3,500 permits not identified by type. For the same period, DOL issued 844 employer certificates.

The law also requires 15 percent of a child's earnings to be placed in a trust. In 2004, after laws were adopted to better protect child performers, the Comptroller's office established accounts for performers' earnings (deposits from employers) if parents or guardians failed to establish a trust account or to provide trust account information to the employer. Through October 2016, more than \$640,000 had been deposited with the Comptroller for about 5,600 child performers.

**Auditors examined the period of April 2014 to March 2017 and found:**

- DOL issued both annual permits and employer certificates without receiving all the documentation required, such as proof of a child's date of birth, evidence of the child's academic performance, health forms and trust account information. Auditors tested permit records and found more than half of the annual permits sampled were issued without Social Security numbers, trust information or other required documentation.

- At least 133 children were issued multiple temporary permits, which DOL failed to identify. Children are allowed only one temporary permit in a lifetime. One performer, who obtained a temporary permit which is only valid for 15 days, had 19 deposits into the trust held by the State Comptroller for multiple performances over a two-year period. Auditors found five performers without permits were paid over \$10,000 for a single performance, and three performers without permits were paid over \$20,000 each for a single performance.

- DOL did not conduct any site visits or assess workplace conditions during the audit period. Nor had it taken measures to proactively verify permits, certifications, and education or safety provisions for child entertainers.

- The numbers of annual deposits with the State Comptroller increased from 14 deposits in 2004 to 1,174 in 2016. Thirty-five percent of this money was deposited in just the last year. However, half of this money was deposited more than five years ago, and 29 percent over 10 years ago. In some cases, the funds have been held for so long that the performers are no longer children, having already attained the age of 18. Some accounts consist of multiple deposits over years, and some are for just one performance.

- The highest number of trust account deposits for one performer was 27, and the highest single deposit was over \$26,000. Accounts are as old as May 2004, with one having a balance over \$25,000. However, the amount owed to most child performers is small, ranging from \$1 to \$100.

The Comptroller's office routinely attempts to reach out to parents or performers when money is turned over to it for the trust account. Where there are poor records or incomplete records, it is difficult to identify the rightful owners. Individuals who are interested in inquiring if the Comptroller is holding money for a child performer, can call 518-474-4017.

### DiNapoli's auditors recommended DOL:

- Design and implement a system of internal controls to ensure that the laws governing the welfare of child performers are followed and that parents/guardians and employers comply with the requirements of the law.

- In conjunction with the Office of Information Technology Services, develop a system that can easily and readily store, access, and analyze required child performer and employer information and develop a process to identify and correct apparent System flaws.

DOL disagreed with many of the audits findings. Auditors point out that DOL had numerous opportunities to comment on the audit's findings and did not provide any preliminary feedback and incorrectly read its own data. DOL's complete response is included in the audit.

## Nassau County Comptroller Maragos: The Nassau County Living Wage Rate Will Increase August 1 to \$16.07 Per Hour

**MINEOLA, NY (TIP):** Effective August 1, 2017, the current Living Wage rate for employees of vendors with Nassau County service contracts will increase to \$16.07 per hour for employees without health benefits from \$15.78, and to \$13.98 per hour with health benefits from \$13.73. The increases are adjusted annually based on the New York Metropolitan CPI-U Index, and will remain in effect until July 31, 2018.

The Nassau County Living Wage Law was enacted by the Nassau County Legislature in 2006 to raise the minimum wage of the employees of vendors with County service contracts. The County Attorney is responsible for calculating the annual increases and the Comptroller's Office is responsible for auditing the rate increase and in monitoring compliance with the Law.

## Federal Brief Filed on Long Island Workplace Discrimination Case Comes Day After Trump Proposes Banning Transgender Military Service Members

**LONG ISLAND, NY (TIP):** A day after President Trump tweeted remarks calling for a ban on transgender military personnel, calling them both a "burden" and "disruption," the Department of Justice filed a brief in the U.S. Circuit Court of Appeals seeking to roll back workplace discrimination based on one's sexual orientation.

The case, which the federal brief was filed for, involves the firing of a skydiving instructor from a Long Island company after a customer complained about having to parachute with a gay man.

David Kilmnick, President of the New York LGBT Network based on Long Island, issued the following

statement:

"The Trump Administration's latest shameful assault on the LGBT community should give every American pause. It's inexcusable for President Trump and his administration to continue assaulting the LGBT community for political gain. The LGBT Network stands united with every American who has ever been the victim of discrimination and hate in the workplace. And it's simply unconscionable that lawyers, paid for with public tax dollars, are being employed to parse language pertaining to who can and cannot be discriminated against. At the end of the day, discrimination is discrimination, regardless of who the victim is."

## Indian American MIT researcher develops smart sticker to prevent sexual abuse

**BOSTON (TIP):** An Indian American student from the Massachusetts Institute of Technology is getting the attention of the world for her invention of a smart device that can prevent women from sexual assault.

Manisha Mohan, a Masters student at MIT has developed a device that she has named Intrepid, which investigates multiple methods that can detect initial signs of assault and develop methods for communication and prevention of assault.

The device, which is a smart sticker, is connected to a smartphone via Bluetooth and it can be attached to any piece of clothing.

In order for the device to start working, the user must first download and install an app that accompanies the device. The user can add their phone number and enter five other immediate contacts that will be either called or sent with a message in any case of emergency.

The app developed by Mohan also has an additional option in which if there is no timely response from the wearer.

Mohan's device, if produced in large numbers, can be proposed as one of the solutions to combat Child Sexual Abuse (CSA), College Campus assault and abuse of elderly and disabled.

The device works on two different mode - active mode and passive mode. In active mode distress message is sent when the victim is unconscious or cannot fight against the assaulter, for example in the case of infants, bed-ridden patients, elderly, disabled, intoxicated people. In passive mode, the victim can self-active the safety mechanism feature.

The design of the clothing to which the smart sticker can be attached to is based on input from sexual assault survivors, 338 on-line participants, 67 volunteers and 20 users.

According to the official MIT page of Intrepid, "Users evaluated the clothing appeal, functionality, cultural sensitivity and provided feedback on their general sense of security wearing the smart clothing."

"We demonstrate the practicality of our unobtrusive design with user studies that support our technological development and use of olfactory stimuli by showing the effect of smells on sexual arousal and partner selection. We believe our techno social approach can help improve user safety and prevent sexual assault," the website added.

## US admiral stands ready to obey a Trump nuclear strike order

**CANBERRA (TIP):** The US Pacific Fleet commander said on July 27 he would launch a nuclear strike against China next week if President Donald Trump ordered it, and warned against the military ever shifting its allegiance from its commander in chief.

Adm Scott Swift was responding to a hypothetical question at an Australian National University security conference following a major joint US-Australian military exercise off the Australian coast. The drills were monitored by a Chinese intelligence-gathering ship off northeast Australia.

Asked by an academic in the audience whether he would make a nuclear attack on China next week if Trump ordered it, Swift replied: "The answer would be: yes."

"Every member of the US military has sworn an oath to defend the constitution of the United States against all enemies foreign and domestic and to obey the officers and the president of the United States as commander and chief appointed over us," Swift said.

"This is core to the American democracy and any time you have a military that is moving away from a focus and an allegiance to civilian control, then we really have a significant problem," he added. (AP)

# White House infighting turns ugly: Scaramucci vs Priebus

**WASHINGTON (TIP):** The bitter-infighting among top staffers at White House turned ugly as Anthony Scaramucci, President Donald Trump's new communications director, launched a foul-mouthed attack on his rival Reince Priebus, calling him a "paranoid schizophrenic", a news website has claimed.

Scaramucci, the Wall Street financier who joined the administration last week, had earlier vowed to crack down on leaks from the White House, threatening to fire everyone, if necessary, to stop aides from leaking information.

"Reince is a f----- paranoid schizophrenic, a paranoiac," Scaramucci told New Yorker writer Ryan Lizza on a phone call Wednesday. The journalist revealed this in a lead story on the news website yesterday.

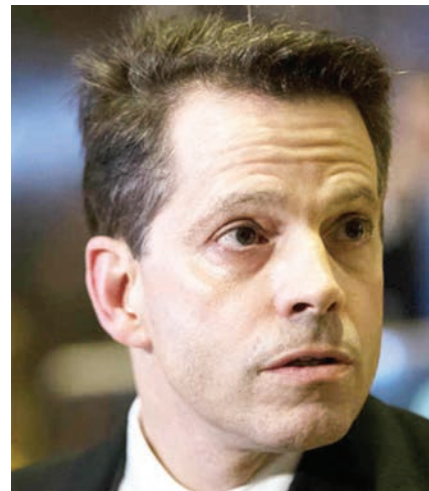
Scaramucci, he wrote, called him to find out who the source of his information was, about the dinner he had with Trump the other night.

Lizza claimed when he refused to divulge the source of information, Scaramucci got agitated.

"I've asked people not to leak things for a period of time and give me a honeymoon period," he said.

"They won't do it. He was getting more and more worked up, and he eventually convinced himself that Priebus was my source," he wrote.

"They'll all be fired by me," Scaramucci said, according to Lizza.



"I fired one guy the other day. I have three to four people I'll fire tomorrow. I'll get to the person who leaked that to you. Reince Priebus-if you want to leak something-- he'll be asked to resign very shortly," he said.

Lizza wrote that Scaramucci believed Priebus had been worried about the dinner because he hadn't been invited.

"Reince is a fXXXXXX paranoid schizophrenic, a paranoiac," Scaramucci said.

Priebus and the White House did not respond to allegations.

Ever since his appointment as the White House Director of Communications, Scaramucci has portrayed himself as a close confidant of the US President.

Last Friday, Sean Spicer had

resigned as White House Press Secretary after Trump appointed Scaramucci as the White House Communications Director.

According to New Yorker, Scaramucci also told Lizza that unlike other senior officials, he had no interest in media attention.

"I'm not Steve Bannon, I'm not trying to s\*\*\* my own c\*\*\*," he said, speaking of Trump's chief strategist.

"I'm not trying to build my own brand off the f\*\*\*\*\* strength of the President. I'm here to serve the country." Bannon did not comment.

The White House Communications Director said that his list of allegations included leaking the Hannity dinner and the details from his financial-disclosure form. (PTI)

## Indian American doctor accused of health care fraud and money laundering

**MILFORD, CT (TIP):** A federal grand jury in Bridgeport returned an indictment on July 26 charging Indian American physician Dr. Bharat Patel, 70, of Milford, and his ally Dr. Ramil Mansourov, 47, of Darien, both residents of Connecticut, with narcotics distribution, health care fraud and money laundering offenses.

Patel was arrested on a federal criminal complaint on July 12 and is detained. Mansourov was apprehended by the Canada Border Services Agency on an immigration offense on July 13 and is currently detained in Canada.

The five-count indictment charges Patel and Mansourov with one count of conspiracy to distribute oxycodone and hydrocodone, an offense that carries a maximum term of imprisonment of 20 years, and one count health care fraud, an offense that carries a maximum term of imprisonment of 10 years. The indictment also charges Mansourov with two counts and Patel with one count of money laundering, an offense that carries a maximum term of imprisonment of 20 years.

The indictment also seeks the forfeiture of Patel's Milford residence, Mansourov's Darien residence, \$16,521.25 seized from a safe deposit box rented by PATEL, and money judgments equal to the proceeds of Patel and Mansourov alleged criminal conduct.

## Amazon's Jeff Bezos bumps Bill Gates from world's richest position

**WASHINGTON (TIP):** Amazon's founder CEO Jeff Bezos may have ended Microsoft badshah Bill Gates' long reign since 1995 as the world's richest individual - a position interrupted only briefly by the likes of Berkshire Hathaway's Warren Buffett and Mexican billionaire Carlos Slim.

A one per cent bump in the shares of Amazon on Thursday morning pushed the personal wealth of Bezos, who owns about 17% of the company, to over \$91 billion, overtaking Gates' approximately \$90 billion, give or take a few million. Gates has generally been regarded as the wealthiest individual on the planet except when Slim bumped him from the top spot in 2012 and his friend and bridge partner Buffett topped him a few years earlier in 2008. Gates regained the top position on both occasions within a year. Because their wealth is largely a result of the shares they own their company and its fluctuating price, it is possible that the wealthiest title may go back and forth between Gates and Bezos - both from Seattle — for a while.

But Bezos+ is considered a good bet to hold the title in the long run given Amazon's phenomenal run and seemingly endless business interests and revenue stream.

In the past week alone, Bezos' net worth has increased by almost \$3 billion due to a 3% increase in Amazon's stock price; it has increased \$16.5 billion since Forbes' 2017 Billionaires List was published in March, when he was ranked third behind Gates and Buffett. Amazon's market cap+ is now over \$500 billion, just \$72 billion shy of Microsoft's \$575 billion, and the internet giant's bull run not only positions it to overtake the software giant, but also - according to some market experts — put it on track to become the world's first trillion dollar company.

Bezos is also an early investor in Google, and holds interest in AirBnB, Uber, and Twitter among other unicorn companies. Ironically, Amazon's hot streak has coincided with the election as President of Donald Trump, who is not favorably disposed towards Bezos or Amazon despite his pro-business credentials. The company has seen a 40% increase in revenue this year alone, adding billions to the wealth of Bezos, who also happens to own The Washington Post, which has been sharply critical of the President. # Indian American Anantha Chandrakasan takes over as MIT's Dean of School of Engineering

**BOSTON (TIP):** Indian American Anantha P. Chandrakasan, the Vannevar Bush Professor and head of the Department of Electrical Engineering and Computer Science (EECS), has been resumed charge as dean of MIT's School of Engineering, from July 1.

During his six-year tenure as head of MIT's largest academic department, Chandrakasan spearheaded a number of initiatives that opened opportunities for students, postdocs, and faculty to conduct research, explore entrepreneurial projects, and engage with EECS.

"Anantha balances his intellectual creativity and infectious energy with a remarkable ability to deeply listen to, learn from, and integrate other people's views into a compelling vision," MIT President L. Rafael Reif says. "In a time of significant challenges, from new pressures on federal funding to the rising global competition for top engineering talent, I am confident that Anantha will guide the School of Engineering to maintain and enhance its position of leadership. And I believe that in the process he will help make all of MIT stronger, too."

Since joining the MIT faculty in 1994, Chandrakasan has produced a significant body of research focused largely on making electronic circuits more energy efficient. His early work on low-power chips for portable computers helped make possible the development of today's smartphones and other mobile devices. More recently, his research has addressed the challenge of powering even more energy-constrained technologies, such as the "internet of things" that would allow many everyday devices to send and receive data via networked servers while being powered from a tiny energy source.

In an email today announcing the news to the MIT community, Provost Martin Schmidt described Chandrakasan as "a people-centered and innovative leader." Schmidt continued, "Having observed Anantha's collaborative approach to building a shared vision within EECS, I am excited for the opportunities that lie ahead for the School of Engineering."

While at the helm of EECS, Chandrakasan launched a number of initiatives on behalf of the department's students. "That's what excites me about an administrative job," he says. "It's how I can enhance the student and postdoc experience. I want to create exciting opportunities for them, whether that's in entrepreneurship, research, or maker activities. One of the key things I plan to do as dean is to connect directly with students."

Many of these initiatives were themselves designed with student input, including the Advanced Undergraduate Research Opportunities Program, more commonly known as "SuperUROP." This year-long independent research program, launched in EECS in 2012 and expanded to the whole School of Engineering in

2015, was shaped in response to feedback about why some EECS students were opting out of MIT's traditional UROP program.

Chandrakasan also initiated the Rising Stars program in EECS, an annual event that convenes graduate and postdoc women for the purpose of sharing advice about the early stages of an academic career. Another program for EECS postdocs created under his direction, Postdoc6, aims to foster a sense of community for postdocs and help them develop skills that will serve their careers. Chandrakasan also helped create StartMIT, an independent activities period (IAP) class that provides students and postdocs the opportunity to learn from and interact with industrial innovation leaders.

"I tend to be a people person," Chandrakasan says. "Of course, data is always important, but it's not where I start. I'm like the quarterback who throws it up in the end zone. I try things, and some of them don't work, which I'm totally fine with; other things we try and then refine. But I do a lot of homework, talking to students and faculty, getting feedback, and incorporating them to improve our efforts."

"I'm also very passionate about helping our faculty explore new research areas," says Chandrakasan, who as department head has sought unrestricted grants and other funding to provide faculty with this flexibility. These efforts have enabled several Faculty Research Innovation Fellowships, for midcareer faculty who seek to branch out in new directions.

Chandrakasan also has a long-standing interest in creating opportunities for innovation outside the lab. He is a board member and chair of the advisory committee dealing with MIT policies for The Engine, a new accelerator launched by MIT last fall to support startup companies working on scientific and technological innovation

with the potential for transformative societal impact. In the latter role, he has overseen five working groups consisting of faculty, students, postdocs, and staff with specialized expertise, and created suggestions for how the MIT community can work with The Engine.

"In building out the concept for The Engine, it was vitally important to make sure it would meet the needs of faculty, student, and alumni entrepreneurs," says MIT Executive Vice-President and Treasurer Israel Ruiz, who helped spearhead The Engine's development. "As the faculty lead, Anantha played an indispensable role in gathering feedback from a wide range of voices and transforming it into actionable ideas for how The Engine should work."

Online learning is another area of interest for Chandrakasan: "I'm very excited about the whole online arena and how we can use MITx for residential education," he says. Last fall, EECS and the Office of Digital Learning piloted a full-credit online course for a small cohort of students on campus, who gave the experience strong marks for providing flexibility and reducing stress. "I'm looking forward to working with the other department heads to see how we can get a license to experiment with these new modes of education," he says.

Born in Chennai, India, Chandrakasan moved to the United States while in high school. His mother was a biochemist and Fulbright scholar, and he enjoyed spending time in her lab where she conducted research on collagen.

"I always knew I wanted to be an engineer and a professor," he says. "My mother really inspired me into an academic career. When I entered graduate school, I knew on day one that I wanted to be academic professor."

Chandrakasan earned his bachelor's (1989), master's (1990), and doctoral (1994) degrees in electrical engineering and computer science from the University of California at Berkeley - the latter two after being rejected from MIT's graduate program, he notes with a laugh. After joining the MIT faculty, he was the director of the Microsystems Technology Laboratories (MTL) from 2006 until he became the head of EECS in 2011.

Chandrakasan is a recipient of awards including the 2009 Semiconductor Industry Association (SIA) University Researcher Award, the 2013 IEEE Donald O. Pederson Award in Solid-State Circuits, an honorary doctorate from KU Leuven in 2016, and the UC Berkeley EE Distinguished Alumni Award. He was also recognized as the author with the highest number of publications in the 60-year history of the IEEE International Solid-State Circuits Conference (ISSCC), the foremost global forum for presentation of advances in solid-state circuits and systems-on-a-chip. Since 2010, he served as the ISSCC Conference Chair. A fellow of IEEE, in 2015 he was elected to the National Academy of Engineering.

## USCIS Resumes H-1B Premium Processing for Certain Cap-Exempt Petitions



The H-1B visa has an annual cap of 65,000 visas each fiscal year

**WASHINGTON (TIP):** U.S. Citizenship and Immigration Services (USCIS) on July 24 announced that it will resume premium processing for certain cap-exempt H-1B petitions effective immediately. The H-1B visa has an annual cap of 65,000 visas each fiscal year. Additionally, there is an annual "master's cap" of 20,000 petitions filed for beneficiaries with a U.S. master's degree or higher.

**Premium processing will resume for petitions that may be exempt from the cap if the H-1B petitioner is:**

- \* An institution of higher education;
- \* A nonprofit related to or affiliated with an institution of higher education; or
- \* A nonprofit research or governmental research organization.

Premium processing will also resume for petitions that may also be exempt if the beneficiary will be employed at a qualifying cap-exempt institution, organization or entity.

Those cap-exempt petitioners who are eligible for premium processing can file Form I-907, Request for Premium Processing Service for Form I-129, Petition for a Nonimmigrant Worker. Form I-907 can be filed together with an H-1B petition or separately for a pending H-1B petition.

USCIS previously announced that premium processing resumed on June 26 for H-1B petitions filed on behalf of physicians under the Conrad 30 waiver program as well as interested government agency waivers. USCIS plans to resume premium processing of other H-1B petitions as workloads permit. USCIS will make additional announcements with specific details related to when we will begin accepting premium processing for those petitions. Until then, premium processing remains temporarily suspended for all other H-1B petitions. USCIS will reject any Form I-907 filed for those petitions, and if the petitioner submitted one check combining the Form I-907 and Form I-129 fees, USCIS will have to reject both forms.

## Pentagon blocks \$350 million military aid to Pakistan

**WASHINGTON DC (TIP):** The US Department of Defense withheld military payments to Pakistan, after Secretary of Defense Jim Mattis told Congressional defense committees that he was unable to certify that Pakistan took sufficient action against the Haqqani network to permit full reimbursement of the fiscal year 2016 Coalition support funds (CSF). The Pakistan-based Haqqani network has been accused for carrying out many high-profile terror acts against US and Indian interests in Afghanistan, including the 2008 bombing of the Indian mission in Kabul that killed 58 people. This is the second year in a row that the Defense Secretary has refused to certify to Congress, as mandated under National Defense Authorization Act (NDAA), that Pakistan has taken satisfactory action against the Haqqani network.

Pakistan had been allotted \$900m in military aid to through the special fund. The country has already received \$550m of that, but Mattis' decision means \$50m will be withheld. The remaining \$300m was rescinded by Congress as part of a broader appropriations act, earlier this year. The Coalition Support Fund (CSF) authority reimburses key cooperating nations for logistical, military and other support provided to US combat operations. Pakistan is the largest recipient of CSF reimbursements, having received more than USD 14 billion since 2002. The US is in the process of reviewing its policy on Afghanistan and Pakistan. Last week, the State Department in a report to the Congress had listed Pakistan as one of the countries having terrorist safe havens. Sanjay Puri, Chairman, US India Political Action Committee, welcomed the announcement adding, "USINPAC has been advocating for years to reevaluate military aid to Pakistan. We cannot have US taxpayer money going towards terror attacks against US and Indian interests from groups in Pakistan."

## POLITICAL DRAMA IN BIHAR

# Nitish says decision to quit was in Bihar interest, mandate not to serve one family

**PATNA(TIP)** : The decision to part ways with the RJD and join hands with the BJP was taken in the interest of Bihar and will ensure development and justice for the state, Nitish Kumar on July 27 said after being sworn in as the chief minister.

Kumar resigned the post Wednesday night after a fall out with the alliance partner RJD over corruption charges against Lalu Yadav and some of his family members, including son Tejashwi, who was the then deputy chief minister.

"Whatever decision we have taken will be in the interest of Bihar and of its people. It will ensure development and justice. It will also ensure progress. This is a collective decision. I ensure that our commitment is towards the people of Bihar," Nitish Kumar told reporters.

Kumar was sworn in as the chief minister of the state along side senior BJP leader Sushil Kumar Modi, who will be his deputy in the new government, at the Raj Bhawan in Patna.

## NITISH-MODI REUNION NOT A HURRIED AFFAIR

The reunion of Narendra Modi and Nitish Kumar appeared hurried on Wednesday, but it was in the works for nearly seven months.

Warmth returned to the chilly relationship between the Prime Minister and Bihar chief minister as early as this January.

The two astute politicians met after a long gap at a function in Patna to commemorate the 350th birth anniversary of Guru Gobind Singh. It was January 5 and TV screens flashed images of the two politicians sitting together, smiling at each other and even holding hands at different moments. The bitterness of parting ways and poll

campaign was over.

"The unease in the relationship between the two leaders was over," a BJP leader said. "Over the next months, they remained in touch, directly and through emissaries."

The onstage bonhomie between the two was quite palpable.

Modi praised Nitish for arrangements he made for prakash utsav and going ahead with prohibition despite opposition. Kumar reciprocated by praising Modi for successfully implementing a liquor ban in Gujarat as its chief minister.

The event at the historic Gandhi Maidan in Patna happened within months of Kumar supporting Modi's decision to recall high-value banknotes. He also supported Modi on the military "surgical strikes" against terrorist hideouts in Pakistan-occupied Kashmir.

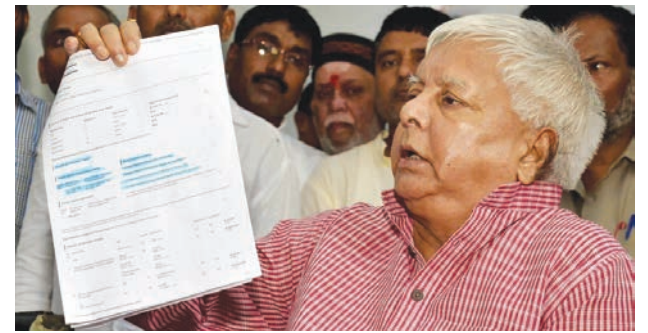
Less than a week after this bonhomie blossomed, Kumar had an ice-breaking meeting with a top BJP leader in Patna.

They met again in Delhi in February to explore if a reunion can happen and on what terms.

The subsequent months saw Kumar talking of a grand alliance against the BJP, and simultaneously sharing with the BJP leadership his unease about the functioning of RJD chief Lalu Prasad, his alliance partner.

He was jittery over Prasad calling the shots in departments headed by his son, deputy chief minister Tejashwi. This was not acceptable to a leader conscious of his image. A senior Union minister remained in constant touch with Kumar and every move was communicated to Prime Minister Modi and BJP chief Amit Shah.

A dispute between Tejashwi and another minister close to Kumar over a government project in Raxaul was another flashpoint. He was upset over friction between allies on sharing boards and corporation and the Congress's dilly-dally on strategic matters.

## LALU PRASAD TO TAKE FIGHT FOR BIHAR TO SUPREME COURT

**PATNA (TIP)**: The battle for Bihar is expected to reach the Supreme Court but legal experts see little hope for Lalu Prasad, who has said that he will approach the top court against the governor's decision to not call his Rashtriya Janata Dal for government formation.

Prasad's ally Nitish Kumar dumped their so-called Grand Alliance on Wednesday and decided to partner with the Bharatiya Janata Party within hours, a development that Prasad has claimed should not have been allowed by governor Keshri Nath Tripathi since his was the largest party by elected legislators.

Legal experts say there is nothing illegal about the governor's action and that he had the prerogative to invite whoever he thought had a better shot at forming government.

"The idea of a single-largest party comes after election; after a crisis comes the concept of who has the larger and a stable combination – So the governor has the discretion to call on a combination or a party that will enjoy majority on the floor of the house," said senior advocate Rajeev Dhawan.

Dhawan cited the example of Goa and Manipur, where too the governor's action was challenged in the Supreme Court but nothing came of it.

The 2017 Goa elections saw a close contest in the 40-member assembly. BJP won 13 seats, while the Congress-NCP with 18 was the single largest collective. Yet the governor invited and appointed a BJP coalition with the MGP (three seats), Goa Forward Party (three seats) and three independents to form the government. Congress took the matter to the Supreme court but its petition was dismissed. Chief Justice of India J S Kehar had then said, "Where are your numbers? You could have finished the case in 30 seconds by showing that BJP don't have the numbers. It seems you were not confident about the support you have. You should have asked the governor what nonsense she is doing and confidently said look we have the numbers. You should have sat on a dharna. You did nothing. You could have filed affidavits of your supporters before us. You are putting us in the position of the governor. These things you should have stated before the governor."

# Amid Sikkim standoff, Doval, Yang discuss major problems

## Talks include bilateral relations, international and regional issues and multilateral affairs

**BEIJING/ NEW DELHI (TIP)**: National Security Adviser Ajit Doval and his Chinese counterpart Yang Jiechi discussed "major problems" in bilateral ties, the Foreign Ministry here said after the first high-level meeting between India and China since the military standoff erupted in the Sikkim sector on June 16.

The Chinese foreign ministry, in a brief readout on Doval-Yang meeting, said Yang "elaborated China's position on bilateral issues and major problems", which is being seen as an apparent reference to the standoff in the Doklam area.

China's state-run Xinhua news agency also reported that Yang met separately with Doval and his other counterparts from South Africa and Brazil. Though there were no direct reference to the Sikkim standoff in the Xinhua report, it said the talks between Doval and Yang included bilateral relations, international and regional issues and multilateral affairs. Though China had maintained that there won't be a meaningful dialogue without the unconditional withdrawal of Indian troops, India has been maintaining that the

unilateral action by China to build a road in the area was altering the status quo and had serious security implications for India.

India has also been pitching for diplomatic solution to resolve the standoff but sought simultaneous withdrawal of troops of both the sides from the tri-junction with Bhutan. However, the Chinese official media has been carrying a blistering campaign accusing India of trespassing into the Chinese territory.

Doval arrived here yesterday to take part in the Brazil, Russia, India, China, South Africa (BRICS) NSAs meeting being hosted by Yang, who, like Doval, is the Special Representative for India-China boundary talks.

His visit has raised expectations about the likelihood of India and China finding a way-out of the over the month-long standoff. While the media had no access to today's meetings, it will be allowed to cover tomorrow's joint meeting of the NSAs of the five-member bloc. Doval, along with other heads of the delegations, will also call on Chinese President Xi Jinping tomorrow evening.

# Oppn protests in RS over 'kidnapping' of Gujarat Congress MLA

**NEW DELHI (TIP):** Opposition Congress on July 28 created uproar in the Rajya Sabha, forcing four adjournments in quick succession, alleging that Gujarat Police had kidnapped its MLA in the state with a view to influencing the upcoming elections to the Upper House.

Congress members trooped into the Well of the House raising anti-government slogans and charging the BJP with "stealing" MLAs to help its candidates win the Rajya Sabha polls, forcing brief adjournments one after the other.

Deputy Chairman PJ Kurien first adjourned the proceedings for 10 minutes soon after the House assembled as Congress leaders, including Leader of Opposition Ghulam Nabi Azad and Anand Sharma, raised the issue and party members stormed into the Well raising slogans.

Similar scenes were witnessed when the House met again, forcing Kurien to adjourn the proceedings till 1200 hours. A repeat of the protests saw Chairman Hamid Ansari to adjourn the House again after it reassembled at noon.

As there was no let-up in the opposition protests, the House was again adjourned till 1430 hours.

Azad said he was not raising the issue of three Congress MLAs who had resigned from the party and one of them being immediately named as the BJP candidate for the Rajya Sabha polls.

He said Punabhai Gamit, MLA from reserved constituency of Vyara, after attending district Congress executive committee, had gone for tea to another MLA's house when the district superintendent of police "kidnapped" him.

The police officer, he alleged, told the MLA that the Congress had decided not to give him a ticket for the upcoming assembly elections and he should leave the party and join the BJP and he would arrange his meeting with the BJP president and get him the ticket.

Azad alleged that the police officer who picked the Congress MLA up was the one who was arrested in a fake encounter case. The MLA managed to flee when he asked the police officer to allow him to get a changeover of clothes, he claimed.

"You are stealing MLAs by using the police (to garner votes)," Azad said, adding, "You should be ashamed." Earlier, Sharma had raised the issue

through a point of order saying the Constitution was being violated by the ruling BJP which was using the police to "kidnap" MLAs.

"They are stealing MLAs," he said, adding that it must be guaranteed that the biennial elections to the Rajya Sabha are free and fair and MLAs are released.

Union Minister Parshottam Rupala sought to counter the charge saying it was an internal matter of the Congress, whose MLAs, including the leader of the party in the state assembly, were deserting it. "Why are you complaining here?" he said. Minister of State for Parliamentary Affairs Mukhtar Abbas Naqvi said it is the Election Commission's responsibility to hold free and fair elections. "If they have a complaint, they should go to the Election Commission. The Rajya Sabha is not the place to protest."

The Congress is not able "to keep its house in order", Naqvi said, prompting the opposition party MPs to troop into the Well shouting slogans.

"You have to protect the Constitution... Voters are being kidnapped, where do we go," Azad said.

Kurien said the Chair had nothing to do with elections.

"If what has been narrated has happened, solution lies elsewhere. You can approach police, you can approach election commission and seek remedy. I have no remedy for this," he said.

He asked protesting members to return to their seats but his pleas went unheeded. "What is the use of obstructing," he asked before

adjourning the proceedings for 10 minutes.

When the House reassembled, Anand Sharma (Congress) again raised the issue of kidnapping.

To this, Kurien asked what he could do.

Azad suggested that the Chair can give a direction to the Election Commission to ensure fair election. He said the officer involved in the incident should be removed.

Kurien, however, said the Election Commission "does not require a direction from the Chair" to conduct free and fair election, as it is bound to do so and "they are doing it".

"If you have a complaint, approach the Election Commission," he said.

As the Congress members trooped into the Well and started shouting slogans, Naqvi took potshots at the main opposition party saying they would also demand a direction to the Supreme Court as several of their members are involved in "corruption" cases.

The Congress would also seek direction to the Election Commission as they are losing the elections, the minister added.

Kurien asked agitated Congress members to return to their seats so that Zero Hour business could be taken.

However, Congress members kept shouting slogans from the well. Kurien adjourned the House till noon.

When the House met at noon, Chairman Hamid Ansari adjourned the proceedings, first briefly for 15 minutes and then till 1430 hours. *Source: PTI*

## NO AUTOMATIC ARREST IN DOWRY CASES, SAYS SC

**NEW DELHI (TIP):** In an important verdict, the Supreme Court today put an end to automatic arrests in cruelty and dowry-related cases under Section 498A of IPC that has often been misused to harass innocent family members of husbands named in complaints.

A Bench headed by Justice AK Goel — which ordered setting up of one or more family welfare committees comprising three members in each district — said, "Every complaint under Section 498A received by the police or the Magistrate should be referred to and looked into by such a committee."

The committee would interact with the parties personally or by means of telephonic/electronic communication and give a report within a month to the authority which referred the complaint to it, the Bench said, adding that the report would be on "the factual aspects and its opinion" in the matter.

"Till the report of the committee is received, no arrest should normally be effected. The report may be then considered by the Investigating Officer or the Magistrate on its own merit," said the Bench, which also included Justice UU Lalit.

"Complaints under Section 498A and other connected offences may be investigated only by a designated Investigating Officer of the area. Such designations may be made within one month from today," the Bench said. Such officers may be given training, to be completed within four months from today, it added.

The Bench also issued certain directions on how to deal with bail matters. "If a bail application is filed with at least one clear day's notice to the Public Prosecutor/complainant, it should be decided as far as possible on the same day.

"Recovery of disputed dowry items may not by itself be a ground for denial of bail if maintenance or other rights of wife/minor children can otherwise be protected. Needless to say that in dealing with bail matters, individual roles, prima facie truth of the allegations, requirement of further arrest/custody and interest of justice must be carefully weighed... In respect of persons ordinarily residing out of India, impounding of passports or issuance of Red Corner Notice should not be a routine."

The Bench said: "It will be open to the District Judge or a designated senior judicial officer nominated by the District Judge to club all connected cases between the parties arising out of matrimonial disputes so that a holistic view is taken by the court to whom all such cases are entrusted; and personal appearance of all family members and particularly outstation members may not be required and the trial court ought to grant exemption from personal appearance or permit appearance by video-conferencing without adversely affecting progress of the trial.

"These directions will not apply to the offences involving tangible physical injuries or death," it clarified.

## Island named after Kalam

**BHUBANESWAR (TIP):** The Odisha Government formally named the Outer Wheeler island in Bhadrak district as APJ Abdul Kalam Island as a tribute to the former President on his second death anniversary.

The Revenue and Disaster Management Department yesterday issued a gazette notification after obtaining a no objection certificate from the Ministry of Home Affairs, said Revenue and Disaster Management Minister Maheswar Mohanty. Mohanty today handed over a copy of the notification to Chief Minister Naveen Patnaik, who had earlier announced to name the Wheeler Island after Kalam. Patnaik paid tribute to Kalam at a function. He recalled Kalam's emotional attachment with the interim test range at Chandipur in Balasore district and Wheeler Island in Bhadrak district. Kalam spent most of his time at these two places as part of his efforts to develop missiles for the protection of the country, the Chief Minister said after paying floral tributes. *Source: PTI*

## M'RASHTRA 'OKAY' IF HC SENDS DUTT BACK TO JAIL

**MUMBAI (TIP):** The Maharashtra Government told the Bombay High Court that the state did not have any objection if the latter ordered actor Sanjay Dutt back to jail.

Advocate General Ashutosh Kumbhakoni told a HC Bench comprising RM Savant and Sadhana Jadhav that Dutt could be sent back to jail if there was any violation in the remission of his sentence. The court is hearing a public interest litigation petition challenging the release of Dutt from jail eight months early.

The court had also asked the state government to explain the regular paroles and furloughs

granted to Dutt while he was serving his sentence in Pune's Yerwada jail. "Within two months from his surrender on May 16, 2013, how could authorities allow his parole and furlough leave application concurrently?" the court asked.

"We do not want to set the clock back in time. We are not for a moment suggesting that he (Dutt) go back to jail," Justice Savant said.

The state government told the court that the practice of granting parole to convicts was meant to motivating them into good behaviour in prison. Dutt was sentenced to five years in for possessing and destroying an AK-56 assault rifle.



# THE DIGNIFIED PRESIDENT OF INDIA — PRANAB MUKHERJEE

Pranab Mukherjee's tenure as the 13th President of India ended on July 24, bringing to a close a political career spanning nearly five decades in government and in the Congress party, both extremely eventful and hugely successful.

Pranab Mukherjee's political journey started in West Bengal in the 1969 by-election in Midnapore when he was the election agent for V K Krishna Menon, who ran as an independent candidate. He caught the eye of Siddhartha Shankar Ray who recommended him to prime minister Indira Gandhi, who gave him a Rajya Sabha seat. Thus at the age of 35, Pranab entered the Rajya Sabha. Within a short period he had gained Mrs Gandhi's confidence and became a minister of state in her government.

In the wake of Rajiv Gandhi's tragic assassination, the Congress party emerged as the single largest party, but there was no clarity as to who would be Prime Minister. Pranab was not an MP and PV Narasimha Rao had announced his retirement from active politics. Arjun Singh and Sharad Pawar became prime contenders. But as the number of MPs from south India was large, Narasimha Rao was called out of retirement and chosen to be Prime Minister.

During Cabinet formation, Narasimha Rao actively consulted his friend and colleague, Pranab. It appeared certain that Pranab would become the finance minister. But quite unexpectedly, he was left out of the Cabinet altogether and Dr Manmohan Singh was named finance minister. Pranab was shocked. As consolation, Narasimha Rao asked Pranab to take up the deputy chairmanship of the Planning Commission.

Now when a former finance minister is left out of the Cabinet and sent to the Planning Commission, it clearly signals the end of an active political career. Pranab told the Prime Minister that he would think about the offer. Narasimha Rao is supposed to have remarked, "Take as much time as you like, but join on Monday." Narasimha Rao assured Pranab that he would one day tell him the reason for his exclusion from the Cabinet, but he never did.

One can describe Pranab in one word – a survivor. His survival skills in politics are indeed remarkable. After Rajiv Gandhi became prime minister in 1984, he dropped Pranab from the Cabinet and also from the Congress Working Committee. He was subsequently expelled from the Congress party itself, pushing Pranab to launch his own party, the 'Rashtriya Samajwadi Congress,' in 1986. But his political career had clearly stalled. He later admitted he was no mass leader. Within two years, he was back in favour with Rajiv Gandhi and merged his party in the Congress. Despite all the ups and downs, he always bounced back.

Pranab is very good at keeping secrets. In fact, Indiraji used to say, "Whenever Pranab is given any confidential information, it never comes out of his belly. What comes out is only the smoke from his pipe." His excellent command over the English language, drafting skills, razor-sharp memory, vast knowledge of national and international affairs and mastery of parliamentary procedures made him indispensable in the cabinet and the Party. Whenever any complicated and contentious issue arose in the Cabinet, he was called upon to resolve it. He would invariably be asked to draft various AICC resolutions and chair different party committees.

In Dr Manmohan Singh's cabinet, Pranab was the de facto number two. He was the chairman of more than 95 GoMs and EGoMs (Empowered Group of Ministers). I was a member of many such groups dealing with Enron, spectrum, WTO,

Bhopal disaster and disinvestment. One time the issue of amending the law to remove the domicile condition for contesting Rajya Sabha elections came up for discussion. Dr Manmohan Singh was elected from Assam and Pranab had been once elected from Gujarat. The proposal was accepted after a brief discussion as was the proposal for open voting. I insisted that the same condition be made applicable to the legislative council elections in the states. But Pranab strongly opposed this and my proposal was not accepted. Unfortunately, "horse trading" in legislative council elections continues unabated.

Pranab worked under three Prime Ministers – Indiraji, Narasimha Rao and Dr Manmohan Singh. He is the only finance minister to have presented budgets both before the 1991 reforms in the license-permit raj regime as well after the 1991 economic reforms. He took bold decisions after the global economic crisis of 2008 which helped shield the Indian economy. As commerce minister in 1993, Pranab championed the cause of trade liberalisation. But as India dealt with GATT, especially its intellectual property rights regime, the fear was drug prices would increase. Pranab's skilful negotiations not only prevented that from happening, but also charted India's entry

into the WTO.

The Indo-US nuclear deal over 2005-8 was a landmark achievement of the Manmohan Singh government. Both countries wanted to get India out of the discriminatory nuclear world order, facilitate India's participation in nuclear commerce and allow it benefits of clean nuclear energy. But because the Left parties supported the UPA government in power and the Left was against India joining hands with the US, a coordination committee between the UPA and the Left parties was constituted under Pranab's chairmanship – and myself as its convenor. The Committee succeeded in obtaining the consent of the Left, thanks only to the skilful leadership of Pranab and his personal equation with its leaders.

He fulfilled the role of President of India with great dignity. Concerns were raised when the government changed after the 2014 election. But he did not needlessly confront prime minister Narendra Modi's government and always went by the book. At the same time, he often publicly appealed for tolerance, lamented the poor quality of parliamentary debate, and urged protection of the Constitution and democratic values. He was certainly not a "rubber-stamp President".

## WHAT MAKES PRANAB MUKHERJEE'S TENURE AS PRESIDENT UNIQUE

As Pranab Mukherjee exits the Rashtrapati Bhavan to hand over the reins to Ram Nath Kovind – India's 14th president, it is an appropriate time to look back to steps and actions that were taken by him that made his tenure unique from others

### Ordinances and Mercy petitions

Pranab Mukherjee's tenure's biggest highlight could be the tough stance he took when it came to his judicial powers. Unlike many of his predecessors who seemed to think twice when it came to reviewing mercy petitions, Mukherjee was quite hands on. Of the 34 mercy petitions that were presented to him, he rejected 30, a number which is second only to G Venkataraman. He also promulgated or re-promulgated 26 ordinances.

### Peoples president

Under his tenure, many steps were taken to make Rashtrapati Bhavan closer to the common man. Steps were taken to reduce security checks within the Rashtrapati Bhavan to make it more inclusive for people. Many important events were shifted to the Rashtrapati Bhavan so that the public won't suffer from security measures due to presidential movement.

Mukherjee also became the first president to take teaching classes for the school children. An in-residence program aimed at encouraging talented scholars and artists was also set up. The official twitter account of the Rashtrapati Bhavan was launched on July 1, 2014.

### Brought an end to the colonial hangover

Perhaps one of the greatest achievements of Pranab Mukherjee was the fact that he brought an end to certain practices that were a product of the imperial rule in the country. He ended the practice of using the honorific title 'His Excellency' while addressing the President on the first anniversary of his term. Even governors were encouraged to follow this practice.

### Welfare programs

A Smartgram pilot project was launched on July 2, 2016 with the aim of developing and modernising villages. At the initial stage, five villages from Haryana was included in the program. Under another initiative Mukherjee also launched the 4S initiative ie; samskriti, samagam, sparsh and sanskar aimed at overall welfare of senior citizens and children residing in the estate.

Re-development of the Rashtrapati Bhavan A new museum was established in the estate's carriage halls and stables building. Roof top solar panels, water harvesting and recycling programmes were initiated in the Bhavan to make it energy efficient and self-reliant. Also, measures were taken to re-introduce the heritage Buggy in the estate after a gap of over three decades. Pranab Mukherjee Public Library was also set up in the estate. This included the cataloguing and bar coding of the vast number of books as part of the E-Pustakalaya project. Apart from all this, the presidential retreat in Dehradun known as the Rashtrapati Ashiana was also renovated.

### RAAG DESH

#### STORY

Three officers of the Indian National Army are on trial for treason. An ailing lawyer must help them face the consequence of their courage.

#### REVIEW

We are living in the time of terrific national pride. If your patriotism doesn't reflect in your attitude, your cuisine, your movie-theatre etiquette and your twitter feed, its existence is called into question. And while we jump to conclusions faster than we can say 'India', we often forget the people who fought actual blood-and-bullet wars (as opposed to shouting matches on news shows) to get us where we are today.

Raag Desh takes us back to these heroes. It tells the story of Maj. Gen. Shahnawaz Khan (Kunal Kapoor), Lt. Col. Gurbaksh Singh Dhillon (Amit Sadh) and Col. Prem Sahgal

(Mohit Marwah), three officers of Subhash Chandra Bose's Indian National Army, who put everything on the line and gathered troops to re-enter India to take down the British after the Second World War. Khan, Dhillon and Sahgal are captured and tried in court for conspiring against the British Indian Army, while their lawyer, Bhulabhai Desai (Kenneth Desai), tries to twist facts to free them of the charges.

Writer-Director Tigmanshu Dhulia has chosen to narrate an incredibly interesting anecdote from our freedom struggle. The hard work of his four-member research team and two-member writing team is evident. Whether the story needed to be told in a non-linear fashion is debatable, but it mostly gets the point across. In a lot of ways, it educates you about the socio-political climate of the time. However, its educational quality is its bane.

Even though Dhulia painstakingly recreates the pre-independence era with researched costumes and sets, and employs multiple languages (the Japanese speak Japanese, the British speak English; no shady dubbing here) to maintain authenticity, the movie proceeds with the mechanical tone of a disinterested college professor. It gives you numbers and dates and facts and suddenly introduces relatives of the protagonists who have stories of their own. It's death by information.

Had the movie been freed of its half-hearted side-tracks it would have made for great infotainment. It is only half of that word now.





## CHARLIZE THERON WANTS TO DO ANOTHER 'MAD MAX' MOVIE

Actress Charlize Theron wants to return for a 'Mad Max' movie based on her character Furiosa.

The 41-year-old actress said she knows more of the character's backstory, including how she lost her arm, but will wait for director George Miller to be ready. "But I'm going to be 42 in August, so let's get to it," she said.

Theron, who was speaking at the Comic-con, will next be seen in 'Atomic Blonde', and the actress opened up about her wish to essay an unrepentant woman who plays by the rules men get to play by. "Women in film typically need a reason to become warriors losing a child or husband. They can just be warriors," she said. "That's what Atomic Blonde is supposed to portray. Lorraine is simply herself. There's no explanation for why the way she is the way she is," she added.

Along with this, rising Australian director Alethea Jones is in talks to helm the flick, after being handpicked by Hathaway, who was integral in the search for a filmmaker.

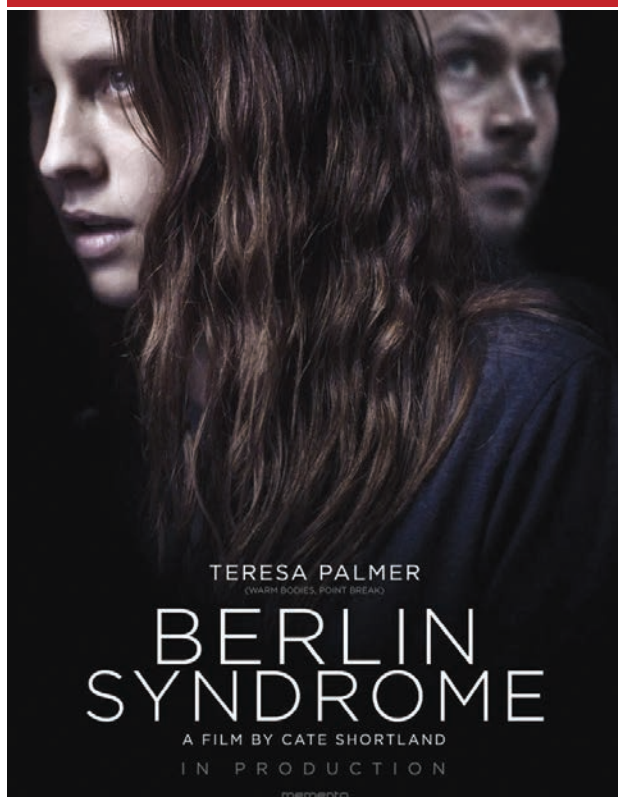

# BERLIN SYNDROME

### Review

Clare (Teresa Palmer) is an explorer in search of a new beginning. Andi (Max Riemelt), a mysterious and charming young man catches her fancy on a busy Berlin street. She's a photographer from Australia. He's a German native, who teaches English. After an instant attraction, their intriguing story takes an unlikely turn when the girl discovers there's more to him than meets the eye.

### Story

Berlin Syndrome works on your mind. Cate Shortland's slow-moving arthouse thriller manages to suffocate you with

its creepy and unpredictable nature and atmospheric execution. Shot within the confines of a secluded house, the intense cinematography makes you feel claustrophobic, evoking a sense of paranoia. The psychological thriller manages to instil fear and will make you think twice before trusting strangers or walking into strange homes. You might also rethink your exotic fantasies of 'falling for a stranger in a foreign country'.

The concept isn't original per se as various foreign indie films have played around a similar theme – a film revolving around a trapped protagonist. However, Shortland's nuanced interpretation of her characters and their psyche is what makes the difference. She makes you wonder how everything can be subjective; including one's perception of 'abnormal'.

Interestingly, there are no character clichés per se. You often wonder if Clare would be 'institutionalised' eventually, after being trapped in Andi's house for the longest time. The twists and turns keep you guessing and wondering if the lead pair's strange relationship might actually have a deeper meaning. Speaking of the pair, the film solely rests on the shoulders of its two lead actors - Teresa Palmer (who looks and acts exactly like Kristen Stewart) and Max Riemelt. They portray their characters' vulnerabilities, fear and erraticism with utmost conviction.

Overall, this one's creepy and unsettling but will largely appeal to a niche audience, owing to its languid pace and world cinema sensibilities.

## Britain's Boris Johnson compares Maori greeting to headbutt

**WELLINGTON (TIP):** Britain's gaffe-prone Foreign Secretary Boris Johnson likened a traditional Maori greeting to a headbutt Monday while visiting indigenous leaders in New Zealand.

Johnson opened his two-day trip with a visit to a marae, or Maori meeting house, in Kaikoura, the South Island town that was hit by a massive earthquake last year.

While there he was greeted with a hongi, the Maori welcome which involves two people pressing their noses together.

The ritual symbolises participants sharing the breath of life, but Johnson said he was concerned about how it would be received in Scotland, home of the "Glasgow kiss", or headbutt.

"Thank you for teaching me the hongi, I think it is a beautiful form of introduction, though it might be misinterpreted in a pub in Glasgow if you were to try it," he said.

Johnson also quipped that "the marae has a tradition of strong female leadership, which we also have back home", referring to his boss, British Prime Minister Theresa May.

Johnson is on a two-day visit to New Zealand which is expected to focus on trade, foreign policy and international security issues.

While in Wellington, Johnson will also unveil a war memorial and will meet New Zealand Prime Minister Bill English.

It is the former London mayor's first visit to New Zealand.

"I also have to say that this is the most mind-blowingly, mind-numbingly beautiful country that I've ever seen," he said.

"I think probably the only landscape that I can think of that can conceivably do justice to the imagination of JRR Tolkien and the Lord of the Rings."

Johnson has a history of blunders, including touting the trade benefits of Scotch whisky in a Sikh temple earlier this year, before being told that alcohol was against the religion.

Prior to becoming Britain's top diplomat, he compared Hillary Clinton to "sadistic nurse in a mental hospital" and said ex-US president Barack Obama was "part-Kenyan" with "an ancestral dislike of the British Empire". (AFP)

## Muslim woman assaulted, hijab pulled off in UK

**LONDON (TIP):** A Muslim woman's hijab was pulled off allegedly by a man in a vicious assault in London, amid a spike in hate crime incidents following a series of terror attacks by Islamists in the UK.

Aniso Abdulkadir was waiting for a tube at Baker Street station on July 16 when she says the man grabbed her headscarf before lashing out with his fists and pinning one of her friends up against a wall, the BBC reported.

"This man at Baker Street station forcefully attempted to pull my hijab off and when I instinctively grabbed ahold of my scarf he hit me," Abdulkadir tweeted and posted a picture of the man who allegedly attacked her.

"He proceeded to verbally abuse my friends and I, pinning one of them against the wall and spitting in her face," the tweet read.

Abdulkadir added that a woman who was present was also threatening and verbally abusive, the report said.

A British Transport Police spokesman said it was being investigated as a hate crime.

"Behaviour like this is totally unacceptable and will not be tolerated...This incident has been reported to us and we're investigating," the official said.

However, a man claiming to be the man in the image tweeted on July 17 to protest his innocence, claiming he had been defending his partner from what he called a "racist attack", the Guardian reported.

He said the allegation against him was "completely false".

"I would like to confirm I never hit or attacked anyone I simply defused the situation by separating them," Pawel Uzcziwek wrote.

"The police is fully cooperating with me and will be able to obtain CCTV footage showing the three women attempting to attack my partner because we are in an interracial relationship," he claimed.

The assault comes amid a spike in hate crime incidents in the UK following a suicide bombing at a concert in Manchester that claimed 22 lives and an attack in London by three terrorists, who drove a van into pedestrians and then went on a stabbing spree, killing eight persons before being shot dead.

Anti-Muslim crimes in the British capital increased fivefold since the London attack, London Mayor Sadiq Khan had said, warning that police would take a "zero-tolerance approach". (AFP)

# Shakespeare was gay, wrote sonnets for men: UK scholar

**LONDON (TIP):** William Shakespeare, whose sexuality has been a long-running debate in academic circles, may have been a gay, a top UK theatre director has claimed, asserting that it was "no longer acceptable" for performers to conceal the sexual orientation of the Bard's homosexual characters.

Artistic director of Britain's major theatre company 'Royal Shakespeare Company' Greg Doran said he believed it was Shakespeare's sexuality which gave the noted playwright an outsider's insight that had helped his work.

"I guess a growing understanding of Shakespeare as I have worked with him over the many years that I have, makes me realise that his perspective is very possibly that of an outsider," Doran said.

"It allows him to get inside the soul of a black general, a Venetian jew, an Egyptian queen or whatever and that perhaps that outsider perspective has something to do with his sexuality," he told BBC Radio 4. Doran said the key clues to understanding Shakespeare's sexuality were in his sonnets. "He wrote a cycle of 154 sonnets, which were published in 1609, and 126 of those sonnets are addressed to a man and not to a woman," Doran said.



He said directors should not hide the sexuality of Shakespeare's gay characters including Antonio in *The Merchant of Venice*, who is "absolutely clearly in love with the young man Bassanio and sometimes that is kind of toned down".

Doran said their love had instead been depicted as "we chaps are very fond of each other".

"It's not, it's clearly a very particular portrait of a gay man and I think in the 21st century it's no longer acceptable to play that as anything other than a homosexual," he said.

Debate over Shakespeare's sexuality has raged for decades among scholars.

Three years ago leading scholars clashed in the *Times Literary Supplement* about the issue, *The Telegraph* reported.

Brian Vickers started the row by criticising a book suggesting sonnet 116 appeared in a "primarily homosexual context," the report said.

He said it was an "anachronistic assumption" because Shakespeare, 52, was using a form of rhetoric that allowed men to express love without implying sexual attraction.

Stanley Wells, a Shakespeare expert at the University of Birmingham, said, "Shakespeare was certainly not exclusively gay. He married Anne Hathaway when he was only 18 and they had a daughter, Susanna, within six months, then twins - a boy, Hamnet and a girl, Judith".

"But he was pretty certainly bisexual, and actively so. The strongest evidence comes from the sonnets, in some of which he writes of a triangular relationship with a man and a woman. Some people claim that these poems are fictional, but I think this is an evasion," the report quoted Wells as saying.

Shakespeare wrote 154 sonnets, 38 plays and two long narrative poems. Born in 1564, the Bard died in 1616. (PTI)

## Iran in 'successful' test of satellite-launch rocket

**TEHRAN (TIP):** Iran on July 27 "successfully" tested a satellite-launch rocket, days after warning Washington of a response to new US sanctions over the Islamic republic's ballistic missile programme, state television said.

It said the launch vehicle, named Simorgh after a bird in Iranian mythology, was capable of propelling a satellite weighing 250 kilograms to an altitude of 500 kilometres above earth.

The launch marked the official inauguration of Iran's Imam Khomeini space centre, named after the late founder of the Islamic republic, built for sending satellites into space, the television said, without giving its location.

Western states suspect Iran of developing the technology capable of launching long-range ballistic missiles with conventional or nuclear payloads, a charge denied by Tehran which insists its space programme has purely peaceful aims.

Iran's four other launches of domestically produced satellites since 2009 have all sparked condemnation in the West.

President Hassan Rouhani said yesterday that Iran would respond in kind to any breach by the United States of a 2015 nuclear deal after the House of Representatives passed a new sanctions bill.

"If the enemy steps over part of the agreement, we will do the same, and if they step over the entire deal, we will do the same too," Rouhani said at a cabinet meeting.

The Iranian parliament's national security and foreign affairs committee said it would hold an extraordinary session on Saturday to discuss its formal response.

The parliament voted earlier this month to fast-track a bill introduced in June that would increase funds for Iran's missile programme and Revolutionary Guards.

"We must always develop our defence capability and we will strengthen our defensive weapons regardless of the opinion of others," Rouhani said.

The US House passed a new sanctions bill on Tuesday targeting the Revolutionary Guards over its missile programme.

As part of its space programme, Iran has also sent two capsules into space, the first in February 2010 carrying a rat, tortoises and insects, and the other in January 2013 when a monkey was sent into space and returned to earth safely, according to official media. (AFP)

## Japan defence minister quits amid plunging support for PM

**TOKYO (TIP):** Japan's hawkish defence minister on July 28 said she had resigned over a long-brewing scandal involving the handling of military documents, in a political blow to Prime Minister Shinzo Abe.

Abe, who has seen his popularity plummet in recent weeks over a series of controversies, immediately apologised to the nation over the saga.

"I decided to resign as defence minister," Tomomi Inada told a press conference. "I submitted my resignation to the prime minister and it was accepted."

Inada, a close confidante of Abe who shares his staunchly nationalist views, was appointed defence minister in August 2016, a time when she was touted as a possible future leader.

But her nearly year-long stint has been characterised by repeated controversy, including increasing criticism of the ministry's handling of log reports filed by Japanese peacekeepers in South Sudan showing worsening security.

Abe, who became prime minister for a second time in December 2012 with a vow to rejuvenate Japan's economy, has been hit by scandals and gaffes involving members of his ruling Liberal Democratic Party (LDP).

"I apologise from the bottom of my heart to the people for this situation in which a minister resigns," Abe told reporters after the resignation.

"All responsibilities lie with me, the prime minister, in the appointment of cabinet ministers," Abe said, adding he "must seriously accept the people's severe criticism".

The most recent setback to the prime minister has been claims he showed favouritism to a friend in a business deal, an accusation he has vigorously denied. His government's public support ratings have fallen precipitously over the summer, with voters punishing the LDP in local Tokyo elections early this month.

The party suffered a drubbing in the vote for Tokyo's municipal assembly that media and analysts chalked up to a growing perception of "arrogance" on the part of his government.

It lost more than half of its seats, with the result seen as a bellwether for national political sentiment.

Abe will reportedly revamp his cabinet next week in a bid to reboot his government. During her tenure, Inada delighted conservatives but drew domestic and international criticism in December when she prayed at a controversial war shrine in Tokyo -- the day after accompanying Abe on a symbolic visit of reconciliation to Pearl Harbor in the United States.

Yasukuni Shrine honours millions of mostly Japanese war dead, but is contentious for lionising senior military and political figures convicted of war crimes by an international tribunal. (Reuters)

# Kremlin warns against 'harmful' new US sanctions on Russia

**MOSCOW (TIP):** The Kremlin on July 28 warned that new US sanctions on Russia would hit the interests of both sides as Congress gears up to approved fresh punitive measures.

"We consider such a continuation of the rhetoric of sanctions counter-productive and harmful to the interests of both countries," Kremlin spokesman Dmitry Peskov said.

In mid-June, the US Senate overwhelmingly passed tough sanctions, but the text stalled in the House of Representatives, until agreement was reached on Saturday.

The House is now set to vote Tuesday on a bill that targets Russia -- for its alleged meddling in the 2016 presidential election and its annexation of Crimea from Ukraine in 2014 -- as well as Iran and North Korea, for its ballistic missile tests. Initially, US President Donald Trump resisted the legislation, which would prevent him from unilaterally easing penalties against Moscow in the future -- effectively placing him under Congress's watch.

But he seems to be left with little



option but to sign off on the move as a political firestorm swirls over potential collusion between his campaign and Russia.

Peskov said the Kremlin is still waiting and watching to see if Trump will approve the measures, after White House communications director Anthony Scaramucci said the US leader was weighing his decision.

Before Trump definitively takes a decision it is too early to talk about any

potential counter measure from Moscow, Peskov said.

Ties between Moscow and Washington have slumped to their lowest since the Cold War as the US slapped sanctions on Moscow over its meddling in Ukraine.

Russia had hoped that Trump's election might ease relations between the two sides, but those prospects have dimmed in the face of a major political pushback in Washington. (AFP)

# Beijing sends conciliatory signals after Doval's first meeting with his Chinese counterpart Yang Jiechi

**BEIJING (TIP):** In the first official meeting between top Indian and Chinese officials since the Doklam stand-off+ became public, national security adviser Ajit Doval met state councillor Yang Jiechi here on July 27, offering the possibility of serious diplomatic efforts to deescalate the confrontation.

Yang, who as China's state councillor overseeing foreign affairs occupies a powerful position in the state council, is the Chinese nominee in the India-China special representative level dialogue with Doval. An influential post, the state councillor is a member of the state council.

Indications of how the bilateral meeting went could be gleaned by the commentary released by the official Xinhua news agency which sent out a conciliatory signal before Doval is expected to meet Chinese president Xi Jinping+ on Friday. It spoke of the need to enhance mutual trust as the two countries are "not born rivals".

The comments released by the official Xinhua news agency made a strong plea to avoid the possibility of a war. "Most economies, including those in the West, will find themselves negatively affected by an India-China war in a globalised and intertwined world today," it said. In Delhi, the Indian government reminded China of the agreements on peace and tranquility that go back to 1993.

Yang also held separate meetings with security officials of three other countries on the sidelines of a security dialogue of BRICS nations comprising Brazil, Russia, India,

China and South Africa.

He discussed issues concerning bilateral relations, international and regional issues and multilateral affairs with the visiting security officials, the official Xinhua news agency said.

The remarks are a contrast to the hectoring tone in the comments published in publications like Global Times that are seen to reflect the views of the government.

China's official spokespersons have accused India of trespassing into Chinese territory, ignoring India's protests that the face-off near the Sikkim-Tibet-Bhutan trijunction has been caused by unilateral attempts by China to alter the ground position.

There are signs that the two neighbours might be able to scale down tensions that have spiked due to the military muscle flexing over China's bid to build a road through a plateau in Bhutanese territory.

This is the first time in weeks that the official media ran a commentary without demanding withdrawal of Indian troops from the disputed Doklam region. China has so far been insisting that troop withdrawal is a pre-condition to a "meaningful dialogue".

Doval reached Beijing on Thursday ahead of his planned meetings with Chinese President Xi Jinping and state councillor Yang Jiechi on Friday.

"The recent border issue between the two countries shows a lack of strategic trust on the Indian side," Xinhua said.

It is not China but a set of problems common to all developing countries

like corruption, a lack of quality education and healthcare that is holding back India.

"India must understand that China wishes what's good for the Indian people and would love to see a strong India standing shoulder by shoulder with China," Xinhua, which reflects the government's thinking said, giving an emotional touch to the vexed relationship.

Doval's formal purpose of visiting Beijing is to attend a security dialogue of BRICS nations. He is expected to discuss the border standoff with Chinese leaders in separate meetings.

Chinese foreign ministry has said that bilateral meetings are usually held during BRICS meetings and indirectly confirmed meetings on the border issue with Doval.

"Instead of being rivals, India and China have much more common ground, common interests and common aspirations. Both as developing countries, the two need to work together on important issues like fighting climate change, protectionism and the financial privileges of Washington," Xinhua said.

It further said, "Hopefully, wisdom will guide the two countries to common prosperity. There is more than enough room for them to co-exist and thrive in Asia and in the world".

"Both China and India need to enhance communication and nurture trust between them, first by recognizing that the two are not born rivals and that harboring ill will against each other is dangerous," Xinhua added.

# Russia signs deal to use Syria air base for 49 years

**MOSCOW (TIP):** President Vladimir Putin has signed a law ratifying a deal with the Syrian government allowing Russia to keep its air base in Syria for almost half a century, official documents show.

The original deal, signed in Damascus in January, sets out the terms under which Russia can use its Hmeymim air base in Latakia Province which it has used to carry out air strikes against forces opposing President Bashar al-Assad.

Putin approved the agreement on Wednesday, after the two chambers of the Russian parliament backed it earlier this month, according to the government's official information portal.

The document says Russian forces will be deployed at the Hmeymim base for 49 years with the option of extending that arrangement for 25-year periods.

The base has been at the heart of Moscow's military foray since it intervened in the conflict in September 2015, helping turn the tide in favour of Assad, one of Russia's closest Middle East allies. (Reuters)

# Wildfires prompt 10,000 evacuations on French Riviera

**MARSEILLE (TIP):** Firefighters evacuated thousands of campers and local residents after a wildfire broke out on France's tourist-thronged Riviera coast overnight.

The blaze was the latest of several wind-whipped fires that are ravaging forest and scrubland on the hills and slopes that spill into the Mediterranean sea between the Marseilles and the city of Nice in the southeastern corner of France.

Not far west of the yacht-filled marinas of Saint-Tropez resort, 10,000 people were evacuated - 3,000 of them from campsites - as a fast-encroaching fire ripped through the hills of La Lodes les Manures, the Lavabo and Bromes.

"A fast-spreading fire broke out at 22:50 (2050 GMT), burning up about 800 hectares of land," the local government prefect's office said in a statement.

Hundreds of firefighters fought the blaze with planes and helicopters dropping tonnes of water on the tinder box hills where fires regularly break out in summer time, often as a result of a carelessly discarded cigarette butt.

Thousands of hectares of land have been devastated by flames since the start of the week, although Tuesday night's evacuation was far larger than other more minor ones where dozens of people and horses were moved to safety from fast-encroaching infernos.

High winds risked whipping up more fires, said the prefect's office of the Vary region, where most of the blazes are located.

So far there have been no deaths reported in the summertime wildfires, unlike in other countries such as Portugal where they have killed dozens (Reuters)

# China steps up warning to Botswana over Dalai Lama visit

**BEIJING (TIP):** China stepped up its warning to Botswana on July 27 over a planned visit by exiled Tibetan spiritual leader the Dalai Lama next month, demanding the African nation respect China's core interests.

The Dalai Lama, reviled by Beijing as a dangerous separatist, is expected to address a human rights conference in the capital, Gaborone, on August 17-19 and will also meet Botswana's president. China is a major investor in Botswana's economy.

China has already "clearly" expressed its point of view about the Dalai Lama's visit, Foreign Ministry spokesman Lu Kang told a daily news briefing.

"Issues relating to Tibet concern China's sovereignty and territory integrity. We demand the relevant country earnestly respect China's core interests and make the correct political decision on this matter," Lu said, using stronger language than before on the issue.

"China will not interfere in other countries' internal affairs, but will certainly not tolerate another country doing anything that harms China's core interests," he added, without elaborating.

The Dalai Lama, who fled from Tibet into exile in India in 1959 following a failed uprising against Chinese rule, has long been at loggerheads with China, which sent its troops into Tibet in 1950.

The Dalai Lama, who won the Nobel Peace Prize in 1989, denies he is seeking independence for his Himalayan homeland. He says he is merely seeking greater rights, including religious freedom and genuine autonomy. Visits by the Dalai Lama to foreign countries infuriate China. (Reuters)

### What to do?

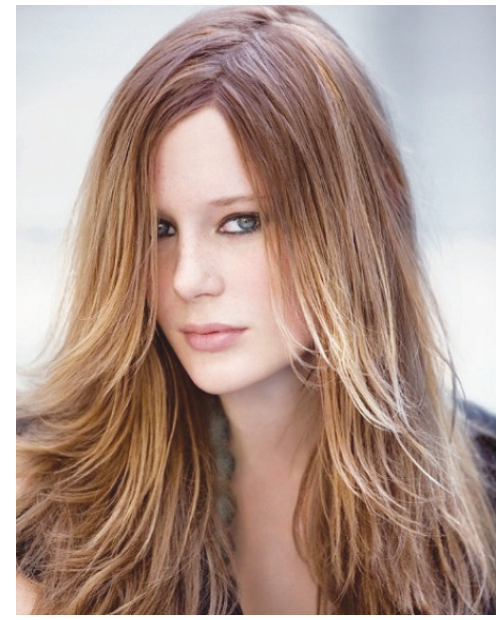

### MAWA KACHORI

#### INGREDIENTS

500 gm all purpose flour, 1 kilogram sugar, 200 gm khoya,

700 ml water, 1 pinch saffron, 15 gm peeled pistachios, 15 gm peeled almonds, 2.5 cup ghee



#### Method

- Make a dough with all purpose flour, ghee and water and rest for 30 minutes.
- Divide into balls and stuff center with mawa, and flatten to make discs.
- Fry in ghee till golden brown. Make sugar syrup by heating water and sugar till the sugar dissolves completely.
- Just before serving dip the fried Kachoris in sugar syrup and garnish with chopped nuts.

### MALAI GHEVAR

#### INGREDIENTS

500 gm all purpose flour, 1 1/2 litre water, 50 gm sugar, 1 gm saffron, 150 gm ghee, 1 litre milk, 5 gm powdered green, cardamom, 2 ice cubes, 20 gm chopped almonds. 10 gm chopped melon seeds, 20 gm chopped cashews, 500 gm sugar, 1 pinch saffron, 250 ml water, 3 cup ghee

#### Method

- Heat ghee in a heavy-bottomed pan and cool by adding ice, by this all the impurities are left behind and pure ghee gets accumulated on the surface.
- Massage the ghee nicely till it is smooth and start incorporating the flour and water slowly till you get batter.
- Heat ghee in a heavy-bottomed pan, place a circular mould and start pouring the batter in center, fry till it is golden brown.
- Now, to prepare the sugar syrup for the main dish, heat water and sugar till the sugar dissolves completely.
- Add the fried Ghevar to the warm syrup and remove.
- To make the malai, heat milk, sugar, cardamom powder and saffron and reduce to half. Cool till it thickens. Top the malai on the ghevar and garnish with chopped nuts.

## WAYS TO MAKE YOUR LIPSTICK LAST LONGER

## Regenerative properties of Liver help tackle Hepatitis

Hepatitis causes inflammation of the liver; it can cause either acute and chronic infection or inflammation. Liver is one of the few organs in the body with regenerative properties. Hepatitis is a group of infectious disease known as Hepatitis A, B, C, D and E. As per World Health Organization (WHO), in India, 40 million people are infected with Hepatitis B and around 6 to 12 million people are infected with chronic Hepatitis C.

Hepatitis is asymptomatic, it is estimated that only 5% of people with chronic hepatitis know of their infection, and less than 1% have access to treatment. Symptoms of Hepatitis are jaundice, dark colored urine, fatigue, nausea, vomiting and abdominal pain. Hepatitis B, C and D are commonly transmitted through blood, semen and other body fluids. Although Hepatitis A does not generally result in chronic infection, Hepatitis B and C can increase incidence of liver cirrhosis, liver failure or liver cancer.

Vaccinations are now available for hepatitis A, B and C but Hepatitis B and C are the most common cause of liver cirrhosis and cancer, according to WHO. Dr Pradeep Mahajan, Regenerative medicine researcher, says "Liver disease can progress to cirrhosis and liver failure. The majority of the liver (80 %) is made up of liver cells called hepatocytes. These cells have an average lifespan of 150 days, which means that the liver is constantly renewing itself under normal conditions. It is only organ that can regenerate. In many countries, autologous cells therapy is used for clinically treating liver disease. The major advantage with using these cells is that because they come from the patient, there is no risk of rejection when they are transplanted back."

"Mesenchymal stem cells (MSCs) are capable of promoting regeneration of liver tissue. Autoimmune hepatitis may benefit by the immune-modulatory potential of MSCs. Bone marrow MSCs have also been shown to reduce levels of liver enzymes and subsequently resolve inflammation. It is the Anti-fibrotic property of MSCs which aids in eliminating fibrotic or scar tissue that would otherwise impair vascular supply and delay regeneration".



## Smoking may increase sensitivity to social stress: Study

Lighting a cigarette may not be a good way to relax and it may increase sensitivity to social stress, according to a new study by the French National Centre for Scientific Research published on Tuesday.

Researchers found that exposure to nicotine, rather than withdrawal from it, which is commonly seen as anxiety-inducing in smokers, produced a stressing effect on lab mice, reports Efe news.

"(The experiments) suggest that nicotine could enhance the effects of stress," said Philippe Faure, the centre's head of research, during the study's presentation in Paris.

Scientists from the University of Paris-Seine's Neuroscience Laboratory and the University of Nice Sophia Antipolis' Institute of Molecular and Cellular Pharmacology evaluated the levels of social stress in the rodents when exposed to nicotine. Social stress was induced when the critters were subjected to repeated aggressions by their dominant congeners.

## Your car may contain harmful pollutants

If you thought driving a car on a heavily polluted road may be safe, think twice. According to a new study, car cabins contain extremely high levels of some harmful particulate matter, twice the amount previously thought.

The findings showed the pollution inside the cars contained twice the amount of chemicals that cause oxidative stress, thought to be involved in the development of many diseases including respiratory and heart disease, cancer and some types of neuro-degenerative diseases.

"We found that people are likely getting a double whammy of exposure in terms of health during rush-hour commutes," said Michael Bergin, professor at the Duke University in North Carolina.

The pollutants can cause the body to produce chemicals to deal with the reactive oxygen, while particulate matter also causes the same response.

In combination, the exposure triggers an overreaction that can be destructive to healthy cells and DNA, the researchers said, in the paper published in the journal Atmospheric Environment.

To explore what drivers are actually exposed to during rush hour, researchers from strapped specially designed sampling devices -- that draws in air at a similar rate to human lungs -- into the passenger seats of cars of more than 30 different cars as they completed more than 60 rush hour commutes in downtown Atlanta.

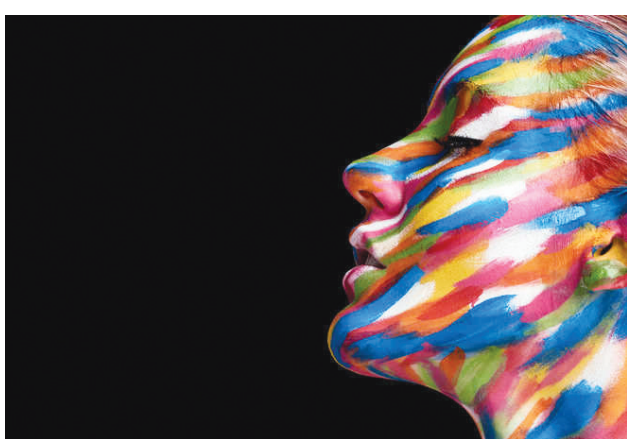


The devices detected up to twice as much particulate matter as the roadside sensors.

It is because, "the chemical composition of exhaust changes very quickly, even in the space of just a few feet", explained Heidi Vreeland, doctoral student at the Duke University.

"And morning sun heats the roadways, which causes an updraft that brings more pollution higher into the air," Vreeland added.

"If these chemicals are as bad for people as many researchers believe, then commuters should seriously be rethinking their driving habits," Bergin added.



## USER-INTERACTIVE COLOR CHANGING ELECTRONIC SKIN DEVELOPED

**BEIJING (TIP):** Scientists have developed a user-interactive colour changing electronic skin inspired by chameleons that could be used in robotics, prosthetics and wearables.

While science has been able to replicate the ability of animals such as chameleons, octopus and squids to change colour with artificial skin, the colour changes are often only visible to the naked eye when the material is put under huge mechanical strain.

Now, researchers from Tsinghua University in China have developed a new type of user-interactive electronic skin, with a colour change perceptible to the human eye, and achieved it with a much-reduced level of strain.

The team employed flexible electronics made from graphene, in the form of a highly-sensitive resistive strain sensor; combined with a stretchable organic electrochromic device.

Researchers explored the substrate (underlying) effect on the electromechanical behaviour of graphene.

To obtain good performance with a simple process and reduced cost, they designed a structure to use graphene as both the highly sensitive strain-sensing element and the insensitive stretchable electrode of the electric current density (ECD) layer.

"We found subtle strain - between zero and 10 per cent - was enough to cause an obvious colour change, and the RGB (red green blue) value of the colour quantified the magnitude of the applied strain," said Tingting Yang from Tsinghua University.

"Graphene, with its high transparency, rapid carrier transport, flexibility and large specific surface area, shows application potential for flexible electronics, including stretchable electrodes, super capacitor, sensors, and optical devices," said Hongwei Zhu, professor at Tsinghua University.

However, our results also show that the mechanical property of the substrate was strongly relevant to the performance of the strain sensing materials, Zhu said.

"It's important to note that the capability we found for interactive colour changes with such a small strain range has been rarely reported before. This user-interactive e-skin should be promising for applications in wearable devices, robots and prosthetics in the future," Yang added.

**SAN FRANCISCO (TIP):** Microsoft has announced the end of days for its pioneering Paint application as it focuses on software for 3-D drawing.

Paint drawing and image processing

software that made its debut in 1985 with the Windows operating system was among the applications listed as "removed or deprecated" in a Windows 10 Fall Creators Update set for release later this year.

Features or functions on the list "are not in active development and might be removed in future releases," according to the US technology company.

For decades, Paint was among applications installed by default on Windows-powered personal computers and drew a strong following.

Fans of the application will be able to take solace in a Paint 3-D version launched early this year. Source: AFP



# NEW 4D CAMERA TO BOOST ROBOT VISION, VIRTUAL REALITY

**BOSTON (TIP):** Stanford scientists have developed a first-of-its-kind camera which can generate information-rich four dimensional (4D) images that robots need to navigate the world.

The camera, which captures nearly 140 degrees of information, can be better than current options for close-up robotic vision and augmented reality, researchers said.

"We want to consider what would be the right camera for a robot that drives or delivers packages by air. We are great at making cameras for humans but do robots need to see the way humans do? Probably not," said Donald Dansereau, a postdoctoral fellow at Stanford University in the US.

The robots have to move around, gathering different perspectives, if they want to understand certain aspects of their environment, such as movement and material composition of different objects.

The new camera could allow them to gather much the same information in a single image. The researchers also see this being used in autonomous vehicles and augmented and virtual reality technologies.

The difference between looking through a normal camera and the new design is like the difference between looking through a peephole and a window, the scientists said.

"A 2D photo is like a peephole because you cannot move your head around to gain more information about depth, translucency or light scattering," Dansereau said.



"Looking through a window, you can move and, as a result, identify features like shape, transparency and shininess," he said.

That additional information comes from a type of photography called light field photography, first described in 1996 by Stanford researchers.

Light field photography captures the same image as a conventional 2D camera plus information about the direction and distance of the light hitting the lens, creating what is known as a 4D image.

A well-known feature of light field photography is that it allows users to refocus images after they are taken because the images include information about the light position and direction. Robots might use this to see through

rain and other things that could obscure their vision.

This camera system's wide field of view, detailed depth information and potential compact size are all desirable features for imaging systems incorporated in wearables, robotics, autonomous vehicles and augmented and virtual reality.

"It could enable various types of artificially intelligent technology to understand how far away objects are, whether they are moving and what they have made of," said Gordon Wetzstein, assistant professor at Stanford.

"This system could be helpful in any situation where you have limited space and you want the computer to understand the entire world around it," Wetzstein said. Source: PTI

## Moon's interior may contain water, say researchers

**NEW YORK (TIP):** There may be substantial amounts of trapped water in the interior of the moon, researchers have said.

By analysing satellite data, researchers at Brown University in the US discovered rich amounts of indigenous water within the volcanic deposits or within layers of rocks spread across the lunar surface after ancient volcanoes erupted on the moon, Xinhua news agency reported.

This suggests that water may be rich in the moon's mantle, the layer between the crust and the core, according to the study published in the journal Nature Geoscience.

The study's lead author, Ralph Milliken, said past findings of water on the moon did not appear to come from indigenous sources.

The moon is believed to have been formed from debris of an object that hit the Earth early in the solar system's history, but the essential hydrogen to form



water could hardly survive the heat in the formation of the moon. Li Shuai, who co-authored the story, said, "Water did somehow survive or that it was brought in shortly after the impact by asteroids or comets before the moon had completely

solidified. The exact origin of water in the lunar interior is still a big question."

The finding also sheds light on future lunar exploration as water could potentially be extracted from volcanic deposits.

# AXIS BANK BUYS SNAPDEAL'S FREECHARGE FOR RS 385 CRORE

**MUMBAI (TIP):** After nearly a year of scouting for a buyer, struggling e-commerce firm Snapdeal today agreed to sell its payment wallet FreeCharge to Axis Bank for Rs 385 crore, almost 90 per cent lower than what it had paid for the firm in 2015.

The price paid by the third largest private sector lender for the acquisition — which will help it double the customer base and address the digitally savvy people — is also higher than what was reportedly offered by other suitors.

According to some reports, others were offering \$15-20 million for FreeCharge, which was acquired by Snapdeal for \$400 million in 2015 during heady days for the e-commerce sector in the country.

Rival e-commerce company and wallet Paytm had made an offer \$10-20 million for FreeCharge, while Amazon also made a late bid for the digital payments platform.

From business as well as value-addition angles, the deal does not make much sense as other banks have been going slow in investing in wallets after the RBI-promoted National Payments Corporation has launched UPI and IMPS applications.

Echoing similar views, Sandy Shen, a research director at Gartner, said, "Though the acquisition will give Axis Bank a jump-start in customer acquisition, whether the bank can keep growing that number is a question." "Digital wallet is a highly competitive space with dozens of players and it takes lots of efforts and resources to increase merchant acceptance and offer good services, which is key in winning over the customers," he said.

Stating that it is difficult to put a price tag for such buys, Axis Bank MD and Chief Executive Shikha Sharma said, "What we are excited about is its tech platform, its capabilities, customer base and the brand. We'd certainly like to continue with the brand."

The announcement comes at a time

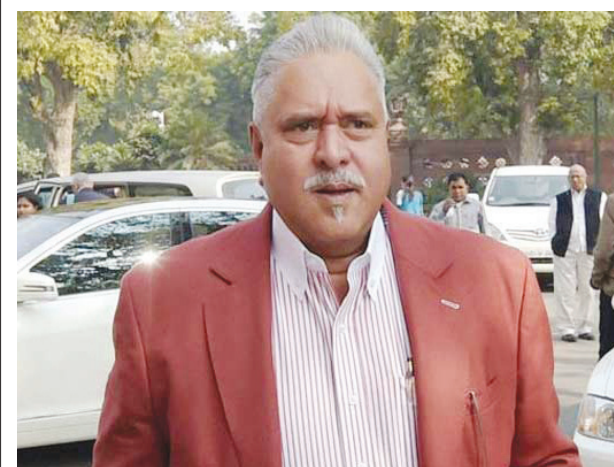

## Diageo asks Vijay Mallya to return \$40 m

**LONDON/NEW DELHI (TIP):** British liquor giant Diageo said it had asked beleaguered businessman Vijay Mallya to return \$40 million paid to him as part of the \$75 million (Rs 515 crore) sweetheart deal for his exit from United Spirits Ltd (USL).

Diageo has stopped payment of \$7 million a year to Mallya as part of the deal and sought compensation for the losses incurred by it.

The British firm had agreed to pay Mallya, who now lives in the UK after Indian banks approached courts to recover money lent to his now defunct airline, \$75 million over five years as global non-compete and non-interference fee post his exit from USL.

Citing violation of the agreement by Mallya, Diageo has also ruled out the future instalments to him, saying "it was not liable to pay such amount". "Diageo and other group companies have demanded from Mallya the repayment of \$40 million which was paid by Diageo on 25 February, 2016, and also sought compensation from him for various losses incurred by the relevant members of the Diageo group on account of the breaches committed by him," Diageo said.

Diageo has paid \$40 million of the total \$75 million on signing of the pact on February 25, 2016, while the balance \$35 million was to be paid in equal instalments of \$7 million a year over five years. This was subject to and conditional on Mallya's compliance, with certain terms, it said. *Source: PTI*

## JIO EFFECT: AIRTEL Q1 PROFIT TANKS 75%

**NEW DELHI (TIP):** Country's largest telecom company, Bharti Airtel today posted 74.89% decline in consolidated net profit to Rs 367 crore for the June quarter of the current fiscal, hit hard by the disruptive pricing of newcomer Reliance Jio.

In contrast, its net income was Rs 1,462 crore in the April-June quarter of last fiscal, 2016-17. Total revenue fell 14% to Rs 21,958 crore in the first quarter of 2017-18, from Rs 25,546 crore in the year-ago period. "The pricing disruption in the Indian telecom market caused by the entry of a new operator continued with industry revenues declining over 15% year-on-year, creating further stress on sector profitability, cash flows and leverage," Gopal Vittal, MD and CEO, India & South Asia, Bharti Airtel said.

## Hero MotoCorp Q1 net up at Rs 914.04 crore

Riding on its best-ever quarterly unit sales, two-wheeler market leader Hero MotoCorp on Tuesday reported a 3.5% increase in profit after tax at Rs 914.04 crore for the April-June quarter. Revenue from operations during the period under review stood at Rs 8,612.91 crore as against Rs 8,010.66 crore in the year-ago quarter, up 7.52%.

## Vedanta profit doubles to Rs 1,525 crore

Mining conglomerate Vedanta Ltd's consolidated profit after tax doubled to Rs 1,525 crore for the quarter through June, driven by strong show in zinc and oil and gas businesses, the company said on Tuesday. Total income during the quarter was at Rs 20,397 crore, an increase of 23 per cent over a year ago. The quantum jump in profit during the April-June quarter was on account of volumes and improved zinc pricing.

## Amazon CEO Bezos was briefly the world's richest man

**NEW YORK (TIP):** Amazon CEO Jeff Bezos briefly became the world's richest man Thursday in Forbes magazine's tracking of wealth, as stock in his e-commerce company hit an all-time high.

Microsoft founder Bill Gates reclaimed the lead by afternoon, as Amazon's stock fell nearly 1 per cent for the day to \$1,046.

Amazon shares have been trading at a record high. They hit \$1,083.31 at about noon Thursday. According to securities filings, Bezos owns about 80 million shares, or 17 percent; those shares were valued at more than \$87 billion at the peak. Bezos also owns The Washington Post through a holding company.

Forbes said Bezos' net worth was about \$90.6 billion when the market opened Thursday. Gates had \$90.1 billion. Forbes said Gates would have been the undisputed leader had he not given billions of dollars away to various philanthropic causes. Bezos issued a request for philanthropic ideas in a tweet in June, just before Amazon announced a \$13.7 billion deal for organic grocer Whole Foods.

The changes in Bezos' fortune coincided with Amazon's report of a 77 percent decline in quarterly profit on heavy spending. Shares fell another 2 percent in after-markets trading as the company missed Wall Street's expectations on profit.

Amazon said it earned \$197 million, or 40 cents per share, in the second quarter, down from \$857 million, or \$1.78 per share, a year ago. Analysts surveyed by Zacks investment Research were expecting earnings of \$1.40 per share on revenue.

Revenue grew 25 percent to \$38 billion, compared with \$30 billion a year ago. That topped expectations of \$37.2 billion.

But Amazon has long been known for investing the money it makes back into its businesses. For the second quarter, Amazon reported operating expenses of \$37 billion, a 28 percent increase from a year earlier.

# TULSIDAS JAYANTI

## FALLS ON JULY 29

**T**ulsidas (1497-1623 C.E.) was a Hindu saint and the poet. Tulsidas is renowned for his great devotion towards Lord Rama. Tulsidas composed several works but he is best known as the author of the epic Ramcharitmanas, a retelling of the Sanskrit Ramayana in the vernacular Awadhi language.

Tulsidas was acclaimed to be a reincarnation of Maharishi Valmiki, the composer of the original Ramayana in Sanskrit. He is also considered to be the composer of Hanuman Chalisa, a popular devotional hymn in Awadhi dedicated to Lord Hanuman.

Tulsidas spent most of his life in the city of Varanasi. The famous Tulsī Ghat on the Ganges River in Varanasi is named after him. The famous Sankatmochan Temple dedicated to God Hanuman is believed to be founded by Tulsidas.

According to Hindu lunar calendar, Tulsidas was born on Shravana, Shukla Paksha Saptami and this day is observed as birth anniversary of Poet Tulsidas. Tulsidas is also known as Goswami Tulsidas.

### Biography of Tulsidas

He was the composer of the original Ramayana into Sanskrit. He lived in Varanasi till death. The name of Tulsī ghat is after him. He was great poet in Hindi, Indian, world literature and founded the temple Sankatmochan.

Goswami Tulsidas was a great Hindu poet saint, reformer as well as philosopher and composed various popular books. He is renowned for his dedication to the Lord Rama and being the author of great epic, the Ramcharitmanas. He was always admired as a reincarnation of the Valmiki (original composer of the Ramayana in Sanskrit and Hanuman Chalisa). Goswami Tulsidas lived his whole life as well as died in the city of Benares society in the India.

### History

Tulsidas was born at the 7th day in the month of Shraavana (July or August), in the bright half of the lunar. His birth place is identified at the Rajapur (also known as the Chitrakuta) at the banks of the Yamuna river in UP. The name of his parents is Hulsī and Atmaram Dubey. According to the biographers, various opinions are there regarding the birth year of Tulsidas. Many of them say according to the Vikrami Samvat that he took birth in 1554 and other say it was 1532. He lived his life around 126 years.

According to the legend, Tulsidas took the 12 months to come out to the world, till then he stayed in the womb of his mother. He had all the 32 teeth from his birth and looks like a five year old boy. After his birth, he told Rama word instead of crying. That's why he named as Rambola, he himself had stated in Vinayapatrika. At the fourth night after his birth his father had passed away because of the danger to life. Tulsidas had stated in his works Kavitavali and Vinayapatrika about his parents abandonment after his birth.

Chuniya (the female maid of his mother Hulsī) took Tulsidas to her town, Haripur and took care of him. She died after caring him for just five and a half years. After that event, Rambola lived as a poor orphan and walked door to door begging for alms. It is assumed that the Goddess Parvati took up the form of a Brahmin for taking care of the Rambola.

He himself had given some of the facts and events of his life in his various works. Two ancient sources of his life are the Bhaktamal and Bhaktirasbodhini composed by the Nabhadās and Priyadas respectively. Nabhadās had written in his writing about Tulsidas and described him as an incarnation of the Valmiki. Priyadas composed his writing 100 years after the death of Tulsidas and described the seven miracles and spiritual experiences of the Tulsidas. Two other biographies of Tulsidas are Mula



Gosain Charit and Gosain Charit composed by Veni Madhav Das in 1630 and Dasanidas (or Bhavanidas) around 1770 respectively.

### Incarnation of the Valmiki

It is believed that Tulsidas was the reincarnation of Valmiki. According to the Hindu scripture Bhavishyottar Purana, Lord Shiva had described to his wife Parvati that how Valmiki will incarnate in the Kal Yuga.

According to the sources, it is considered that the Hanuman was used to go to Valmiki to hear him singing the Ramayana. After the triumph of Lord Rama over Ravana, Hanuman was continued to worship the Rama at Himalayas.

### Learning

Rambola (Tulsidas) was given the Virakta Diksha (known as Vairagi initiation) and got the new name, Tulsidas. His Upanayana was performed by the Narharidas at Ayodhya when he was just of 7 years old. He started his first learning at the Ayodhya. He mentioned in his epic the Ramcharitmanas that his guru narrated him the Ramayana over and over again. He came to the sacred city Varanasi when he was just 15-16 years old and got the knowledge of Sanskrit grammar, Hindu literature and philosophy, four Vedas, six Vedangas, Jyotisha from his guru Shesha Sanatana at the Panchaganga Ghat in Varanasi.

After study, he came back to his birthplace, Chitrakuta by the permission of his Guru. He started to live in his family home and narrating the story of Ramayana.

### Marriage history

He got married to the Ratnavali (the daughter of Dinbandhu Pathak of Mahewa village and Kaushambi district) at the 13th day of the Jyeshtha month (May or June) in the year 1583. After some years of the marriage he got a son named Tarak who died in his toddler state. Once upon a time, his wife went to her father's home when Tulsidas had gone to the Hanuman temple. When he returned home and did not see his wife, he swam a long River Yamuna in order to meet his wife. Ratnavali was very upset with his activity and blamed him. She remarked that devote yourself to the God fully. He then left her wife and went to the holy city of Prayag (where he renounced the stages of Grihastha life and became a Sadhu). According to the some authors, he was unmarried and Sadhu from the birth.

### How he meet to Lord Hanuman

Tulsidas meet the Hanuman at his own Katha, he fell at the Hanuman's feet and shouting that I know who you are so you cannot get away leaving me. Then, the Hanuman blessed him a lot. Tulsidas had expressed his feeling in front of Hanuman that he want to see Rama confronting each other. Hanuman guided him and told that go to the Chitrakuta where you would really see the Rama.

### How he meet to the Rama

After getting instructed with the Hanuman, he pursued the instructions of Hanuman and started to live in the Ashram at Ramghat in Chitrakuta. One day when he went for making the Parikrama of the Kamadgiri Mountain, he saw the two princes on the horsebacks. But he

could not distinguish them. Later when he acknowledged that they were Rama and Lakshman by the Hanuman, he got disappointed. All these events are described by himself in his writing Gitavali. On the next morning, he met Rama again when he was making sandalwood paste. Rama came to him and asked for a Tilaka with sandalwood paste, in this way he had a full sight of the Rama. Tulsidas was so happy and he forgot about the sandalwood paste, then Rama took tilak himself and applied on his forehead and also on the Tulsidas's forehead.

In the Vinayapatrika, Tulsidas had mentioned the miracles at Chitrakuta and lot of thanks to the Rama. He got darshan of the Yajnavalkya (speaker) and Bharadvaja (listener) in the Magha Mela under a banyan tree.

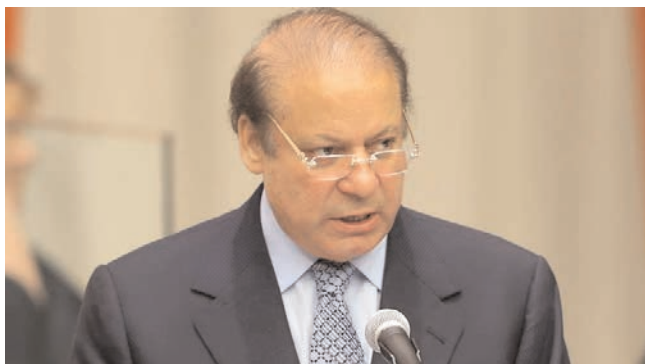

Meanwhile, interior minister Chaudhry Nisar Ali Khan on Thursday said that he would resign and quit politics after the Supreme Court judgment on the Panamagate case.

Nawaz Sharif leads Pakistan's most powerful political family and the ruling PML-N party.

Sharif, who has been the prime minister of Pakistan for a record three time, faces the risk of being disqualified if the court finds him guilty of corruption and money laundering.

### What is Panamagate

The scandal is about alleged money laundering by Sharif in 1990s, when he twice served as prime minister, to purchase assets in London. The assets surfaced when Panama Papers leak last year revealed that they were managed through offshore companies owned by Sharif's children.

## Sri Lanka allays India's concerns, renegotiates port deal with China

**COLOMBO (TP):** Sri Lanka's cabinet has cleared a revised agreement for its Chinese-built southern port of Hambantota on July 24, the government said, after terms of the first pact sparked widespread public anger in the island nation.

The port, close to the world's busiest shipping lanes, has been mired in controversy ever since state-run China Merchants Port Holdings, which built it for \$1.5 billion, signed an agreement taking an 80 per cent stake.

Under the new deal, which Reuters has examined, the Sri Lankan government has sought to limit China's role to running commercial operations at the port while it has oversight of broader security.

Chinese control of Hambantota, which is part of its modern-day "Silk Route" across Asia+ and beyond, as well as a plan to acquire 15,000 acres (23 sq miles) to develop an industrial zone next door, had raised fears that it could also be used for Chinese naval vessels.

Sri Lankans demonstrated in the streets+ at the time, fearing loss of their land, while politicians said such large-scale transfer of land to the Chinese impinged on the country's sovereignty.

Details of the new agreement have not yet been made public. But according to parts of the document seen by Reuters, two companies are being set up to split the operations of the port and allay concerns, in India mainly but also in Japan and the United States, that it won't be used for military purposes. (Reuters)

## Myanmar insists no North Korea links as US envoy visits

**YANGON (TIP):** Myanmar has no military ties with North Korea, a Myanmar official said on Monday, as a US diplomat responsible for North Korea arrived for talks in which he is likely to seek assurances on efforts to isolate it.

Ambassador Joseph Yun was set to meet Myanmar's State Counsellor Aung San Suu Kyi and the military's commander in chief in the capital, Naypyitaw, on Monday, according to the U.S. Embassy in Yangon. Yun attended a conference in Singapore over the weekend focusing on tension on the Korean peninsula over the North's unrelenting nuclear and missile programmes. Ambassador Joseph Yun's trip to Asia was announced after North Korea's test on July 4 of an intercontinental ballistic missile that it says can carry a large nuclear warhead and some experts believe has the range to reach Alaska. Myanmar is the only other stop on his trip, pointing to concern in Washington that Myanmar's army, which used to have ties with North Korea, continues to give succour to Kim Jong Il's regime. (Reuters)

# Pakistani council orders 'revenge rape' of 16-year-old girl

**ISLAMABAD (TIP):** Pakistani police have arrested 25 members of an informal village council accused of ordering the rape of a 16-year-old girl as revenge for her brother's alleged sexual assault of another girl.

The Supreme Court also requested a report on the case, which echoed a notorious case from 2002 in which another teenager was gang-raped on a local council's order.

"A total of 29 people were involved in this ghastly crime, and we have 25 of them in our custody," Multan City Police Officer Ahsan Younus told Reuters by telephone on July 27.

Earlier this month, a local council in the southern city of Multan was called after a family accused a 16-year-old boy of raping a 13-year-old neighbour.

The council ruled that the sister of the boy should be handed over to the victim's brother to be raped. The punishment was carried out on July 17 after her family handed the girl over.

The case came to light when both families filed criminal charges with police accusing the other family's son of rape.

Questioning both sides in the cases, however, soon revealed the role of the informal village council, Younus said.

"All the village council elders who ordered the revenge rape have been arrested," he said.

Both the victims and their mothers have been sent to a women's protection centre, he added.



Pakistan has a centuries-old tradition of quick justice handed down by gatherings of local elders, known as jirgas or panchayats, seen by many villagers as preferable to the often-cumbersome and corrupt formal legal system. In most of the country, jirgas are tolerated but not recognised by the formal courts and police.

The jirgas and the practice of "revenge rape" drew international attention in 2002 when a woman named Mukhtaran Mai was ordered gang-raped by a local council for a male relative's alleged crime.

Mai took the rare step of filing criminal charges against her attackers,

and six men were convicted and sentenced to death later that year, though five of them were later freed on appeal.

Mai went on to become a high-profile campaigner for women's rights in Pakistan. "Another Tribe Court (panchayat) in south Punjab Multan and another girl was raped. We are still in 2002," Mai said on her official Twitter account this week.

Speaking to Reuters by telephone, Mai denounced the revenge rape.

"If there were any justice in the panchayat, they should have shot the rapist. Why punish an innocent girl instead?" (Reuters)

## 26 Afghan soldiers killed in Taliban attack on Kandahar base: Defence ministry

**KANDAHAR (TP):** At least 26 Afghan soldiers have been killed and 13 wounded in a Taliban attack on a military base in Kandahar province, the defence ministry said on July 26, the latest blow to struggling security forces.

The militants "attacked an army camp in Karzali area of Khakrez district of Kandahar last night," MoD spokesman General Dawlat Waziri said.

Afghan soldiers "bravely resisted", he said, killing more than 80 insurgents.

Residents in the area described an hours-long attack launched by a 30-strong convoy carrying "hundreds" of Taliban who assaulted the base from multiple directions.

Air support was called in, several residents said, though that was not immediately confirmed by officials. The insurgents claimed the attack via their Twitter account.

The resurgent Taliban have been ramping up their campaign against beleaguered government forces, underscoring rising insecurity in the war-torn country throughout the warmer weather fighting season.

Afghan security forces, beset by killings, desertions and non-existent "ghost soldiers" on the payroll, have been struggling to beat back insurgents since US-led NATO troops ended their combat mission in December 2014.



According to US watchdog SIGAR, casualties among Afghan security forces soared by 35 percent in 2016, with 6,800 soldiers and police killed.

The insurgents have carried out more complex attacks against security forces in 2017.

In April more than 140 soldiers are believed to have been killed on a base

outside the northern city of Mazar-i-Sharif, one of the deadliest ever Taliban attacks on a military installation.

While in early March gunmen disguised as doctors stormed the Sardar Daud Khan hospital — the country's largest military hospital — in Kabul, killing dozens. (AFP)

Pray at the pagodas at India’s only existing Chinatown in Tangra, marvel at the creations and stories of the idol makers of Kumortuli and spare some moments of solitude at Mother House—Kolkata’s offbeat attractions will leave you coming back for more. Admire the cenotaphs and epitaphs at Kolkata’s heritage Christian cemetery, visit the historical Lal Dighi and do stopover at Belvedere Road to admire India’s largest library, the National Library.

Apart from all the historic buildings, temples and museums, there are several other interesting places to visit in Kolkata.

### LAL DIGHI

A large enough water body, spanning across 25 acres of land, Lal Dighi (literally translates into the Red Pond) is a lesser-known wonder of Kolkata that can have a charming effect on you. Earlier it was known as Dalhousie Square or Tank Square. The water body or tank is of historical significance because the surrounding area was also the place where the Battle of Lal Dighi was fought between Siraj-ud-Daulah and the British East India Company in 1756. The pond is said to have acquired the name during the festival of holi when the tank became red or crimson in colour.

Due to years of negligence the pond has lost its former charm and attracts very less crowd these days. However, one of the perks of a visit to the pond is a magnificent view of the Kolkata General Post Office (GPO), the Reserve Bank of India building and also the iconic Writers Building. The state government has also been pumping in money to renovate the area and restore it as a tourist attraction. Take a trip down history or capture the panoramic views of the city’s skyline—a tour of Lal Dighi will fill you with a sense of wonder.

### NATIONAL LIBRARY OF INDIA

The foundation of the National Library of India dates back to 1836 with the formation of the Calcutta Public Library. In 1903, it was merged with the Imperial Library for public use by Lord Curzon, former Governor General of India. After independence, it was renamed the National Library of India and opened to the public in 1953. Spread over 30 acres of land, it is India’s largest library by volume. Boasting of an extensive collection of books, (more than two million)—the library is worth visiting, for book lovers, it is a unique experience. A treasure trove of knowledge,

the architecture of the building exudes ultimate colonial grandeur. The building flaunts an impressive structure with tall pillars and arches. The green-coloured doors and windows against the white building is an attraction in itself. Roman beams, Corinthian pillars, off-white ceilings—all command appreciation. Dining tables, fire places and a London-made grandfather clock used by the British viceroys continue to be well preserved by the library authorities. The entire area is surrounded by thick foliage that adds to its beauty. You can undertake a walk around the campus and also capture it in your lenses. Do remember to carry your identity card while visiting the library. Given its proximity to the Alipore Zoological Gardens, you can visit the two on the same day. Once in the city of Kolkata, a tour of the National Library will keep you coming back for more.

### MOTHER HOUSE

The Mother House is the erstwhile residence of probably the most renowned and inspirational female figures in Indian History—Mother Teresa. If you are searching for something more meaningful, more awe inspiring, do not forget to visit this landmark. The house was built by Mother Teresa in 1950

with the motive of selfless service to humankind and also to uplift humanity and take it towards salvation. She lived and worked in this home from 1953 till 1997 when she breathed her last.

The simplicity of the area renders a heartwarming feeling to all those who visit this place. The site of the tomb is extremely simple and humble, yet exudes a benign vibration that fills the heart with utmost gratitude. Adjacent to the building is a small museum named Mother Teresa’s Life Spirit and Message. The museum houses her belongings such as her sandals, a dinner bowl used by her; a crucifix and a few other objects. With a crown-of-thorns above her modest bed, the mother’s room is preserved in all its simplicity. It is barely 15 minutes away from the Park Street Metro Station.

### CHINATOWN

Hidden between the narrow alleys of Tangra, lies Kolkata’s very own (and India’s only existing) Chinatown. The area is a landmark for the City of Joy. Though not frequented by too many tourists, the area has its own charm. If you want to experience a completely different aspect of the city and of course have some delectable Chinese

delicacies—then remember to include Chinatown in your itinerary. Chinatown has succeeded in preserving its very own customs and traditions for nearly two centuries. At the same time it has imbibed some existing Indian and Bengali customs too. Once home to several tanneries, today the area has developed a distinctive character of its own. While the tanneries have been shifted to another part of the city, Chinatown has continued to retain its oriental charm.

The brightly coloured doors of houses and dangling paper lamps impart a liveliness to the entire neighbourhood. After offering prayers at the Chinese pagodas, buy some souvenirs or authentic Chinese sauces from roadside shops (do not forget to bargain for the goods though). Once you have explored the area, head straight towards any of the food joints that Chinatown is peppered with. Opt for the prawn and crab soup, Peking duck, and the authentic Schezwan fried rice. Currently, the local residents are partnering with the Chinese community of Singapore to refurbish the area. This is being done not only to preserve Chinese heritage, but also to promote tourism. Post facelift, Chinatown should become a mandatory visit for tourists and Kolkata residents.

## Obamacare Repeal Fails...

Speaker Ryan tried to reassure senators balking at the narrow bill, but he left the door open for "skinny" passage. The health insurance lobby came off the sidelines Thursday, July 27, to warn Republicans against repealing the individual mandate.

While 49 Republican Senators voted for Skinny Repeal, 3 said Nay. All 48 Democrats opposed the repeal. Senate, thus, rejected the scaled-down Obamacare repeal.

Senator John McCain, Republican of Arizona, cast a decisive vote to defeat the proposal, joining two other Republicans, Susan Collins of Maine and Lisa Murkowski of Alaska, in opposing it.

The 49-51 vote was a huge setback for the majority leader, Mitch McConnell of Kentucky, who has spent the last three months trying to devise a repeal bill that could win support from members of his conference.

The truncated Republican plan was far less than what Republicans once envisioned. Republican leaders, unable to overcome complaints from both moderate and conservative members of their caucus, said the skeletal plan was just a vehicle to permit negotiations with the House, which passed a much more ambitious repeal bill in early May.

The so-called "skinny" repeal bill, as it became known at the Capitol this week, would still have broad effects on health care. The bill would increase the number of people who are uninsured by 15 million next year compared with current law, according to the nonpartisan Congressional Budget Office. Premiums for people buying insurance on their own would increase by

roughly 20 percent, the budget office said.

# Nitish Kumar wins trust vote in Bihar Assembly

**PATNA (TIP):** Nitish Kumar on July 28 won the trust vote in the Bihar Assembly a day after he took oath as Chief Minister to head the JD-U-BJP government after dumping the Grand Alliance.

In a 243-member Bihar Assembly, 131 members cast their votes in favor of Nitish Kumar and 108 went against.

The RJD staged a walkout of the House after the Nitish government won the trust vote.

RJD leader Teleshwi Yadav, the son of Lalu Prasad Yadav, spoke first on the confidence motion and launched a scathing attack against Kumar for dumping the

Grand Alliance government.

RJD MLAs protested in the portico of Assembly, signaling their aggressive mood ahead of the trust vote.

The NDA alliance had submitted a list of 132 MLAs to the governor. These include 71 of JD(U), BJP 53, RLSP two, LJP two, HAM one and three independents.

In the 243-member Bihar Assembly, the RJD has 80 MLAs, the Congress 27 and the CPI-ML has three.

The Janata Dal-United leaders said Nitish Kumar was "calm and cool" and spent the early morning at his official residence as usual, not worried about the trust vote.

support of 132 MLAs for Nitish to form the next government. Tripathi then set the time for Thursday's swearing-in ceremony and said Nitish has to prove his majority in the state Assembly+ within two days of being sworn in.

Teleshwi and RJD leaders also met the governor+ on Wednesday to protest the governor's decision to invite Nitish to form the government.

"RJD being the single largest party in the state should be given an opportunity to stake claim to form the government," Teleshwi said.

The JD(U), BJP, their allies and supporting independent MLAs together account for 132 seats in the 243-member Bihar Assembly, 10 more than the magic figure of 122.

The RJD has 81 MLAs, and even if the Congress with 27 MLAs and the CPI-ML with 3 decide to back Teleshwi, their number would add up to just 110.

## Pranab Mukherjee bids...

"With a sense of gratitude and a prayer in my heart, I take leave of you. I leave with a sense of fulfillment and happiness of having served the people of this great country through this institution - as their humble servant," he said in his address to members of both the houses at the Central Hall of Parliament.

The 71-year-old Kovind was administered the oath of office by Chief Justice of India J S Khehar at an impressive ceremony in the Central Hall of Parliament. He took oath in the name of God and pledged to "preserve, protect and defend the Constitution and the law".

The ceremony was attended by Mukherjee, Vice President Hamid Ansari, Lok Sabha Speaker Sumitra Mahajan and Prime Minister Narendra Modi, Governors, Chief Ministers, Union Ministers, Parliamentarians diplomats and 22 members from Kovind's family. Kovind began his innings in office invoking Sardar Patel, Deendayal Upadhyay - leaders looked up by the Sangh parivar and dove-tailing their message with that of Mahatma Gandhi. Absent from the President's inaugural speech was any reference to Congress stalwarts barring those held dear by the BJP.

A section of BJP MPs raised slogans of 'Jai Shri Ram' and 'Bharat Mata ki Jai' soon after Kovind was sworn-in as the President.

Upadhyaya's philosophy of 'antodyaya' was also reflected in the President's speech as he spoke of reaching the fruits of development to the "last person, in the last house in the last village." At the outset, the President said he was conscious that he was

following in the footsteps of stalwarts such as Dr Rajendra Prasad, S Radhakrishnan, APJ Abdul Kalam and his immediate predecessor Pranab Mukherjee.

"We need to build an India that is an economic leader as well as moral exemplar. For us, those two touchstones can never be separate. They are and must forever be linked," said Kovind, the first leader from Uttar Pradesh to adorn the top constitutional post.

Reflecting a clear shift from the era of entitlement furthered during the UPA, the President spoke of the government being a facilitator in nation building.

"Nations are not built by governments alone. The government can at best be a facilitator, and a trigger for society's innate entrepreneurial and creative instincts. Nation building requires national pride," Kovind said.

Referring to Mahatma Gandhi, Sardar Patel and B.R. Ambedkar, the President said these leaders did not believe that political freedom was enough. "For them, it was crucial to also achieve economic and social freedom for millions of our people," he said.

"The key to India's success is its diversity. Our diversity is the core that makes us so unique. In this land, we find a mix of states and regions, religions, languages, cultures, lifestyles and much more. We are so different and yet so similar and united," the President said. Kovind said India of the 21st century India will be in conformity with its ancient values as well as compliant with the fourth industrial revolution. "There is no dichotomy there, no question of choice. We must combine tradition and technology, the wisdom of an age-old Bharat and the science of a contemporary India," he said.

Earlier, the President-elect and his wife Savita were ceremonially escorted to the Rashtrapati Bhawan where Mukherjee took Kovind on a guided tour of the Rashtrapati Bhawan.

# BCCI HAS NO ROAD MAP TO PROMOTE WOMEN'S CRICKET

**NEW DELHI (TIP):** So, what's next for the Indian women's cricket team that made the final of the World Cup? And what lies in store for several young girls who want to play for the country? Sadly, cricket administrators have no answers to these crucial questions, at least right now.

The Committee of Administrators (CoA) and women cricketers hope the Indian cricket board (BCCI) will ensure that the wave of popularity the women cricket is riding at present does not fizzle out. The board, caught in a fight for survival in the wake of the Lodha Committee's recommendations, doesn't seem to have women's cricket on its priority list, so much so that nobody knows when the women's team will play their next match. "We don't know when we would assemble for our next series," said a member of the World Cup squad.

A BCCI office-bearer said: "Everyone is looking to save his chair at the moment. We don't know who will be in, and who will be out. We are uncertain of our own future, so how can we promise something to the women's team?"

The World Cup squad was felicitated by the board in New Delhi today; each player was given a cheque for Rs 50 lakh. Later, Railways Minister Suresh Prabhu announced Rs 13 lakh each for the 10 players employed with the department.

## Demand for women's IPL

Following India's spirited performance in the World Cup, the demand for starting an IPL-like tournament for women is growing. Besides, women cricketers want a Future Tours Programme (FTP) in place, as is there for their male counterparts. "If women's IPL happens, players from other countries will come and play here. Sharing the dressing room with international players will

boost the confidence of local players," said Harmanpreet Kaur. "Similarly, more international fixtures will help the team prepare for the next World Cup."

## Edulji wants league next year

CoA member and former India captain Diana Edulji advocated the need for a T20 league and an organised tournament calendar. "Apart from felicitations, cash awards and government jobs, where are we heading next? Is this all we want, or do we want to build on this momentum?" Edulji asked. Edulji knows she doesn't have much time to turn her ideas into reality since CoA isn't going to last forever. "In 3-4 months, I would like to put in place a system for women cricketers. Maybe, by next year, BCCI would be able to start a T20 league (for them)," said Edulji.

## No talent pool, sponsors

It's not going to be easy, though. BCCI

cites the lack of a talent pool in women's cricket as a stumbling block to start a T20 league. "Name 30 Indian women cricketers who we can put in the players' auction in case we start the league? Apart from these 15-20 girls, no other name comes to mind. Also, there are no sponsors. Corporates are not ready yet to invest in these girls. These girls can play the Big Bash League in Australia like Harmanpreet and Smriti Mandhana," said a BCCI official.

But isn't it BCCI's responsibility to find sponsors and arrange funds for women's cricket? Shouldn't the board be organising more inter-school, inter-college, inter-university, inter-district and inter-state tournaments for women cricketers on a regular basis to increase the talent pool? Yes, the board has recently provided central contracts to women cricketers, besides enhancing their daily allowance. But there's a long way to go before women's cricket can come even close to men's in terms of facilities, structures and rewards.

# BCCI gets bolder, raises objection to five key reforms

**NEW DELHI (TIP):** In another act of brazen defiance, the Indian cricket board (BCCI) decided against implementing the contentious age, tenure and cooling-off recommendations at its Special General Meeting (SGM) here today. BCCI, after showing intent over the past few weeks to implement most of the recommendations made by the Lodha Committee, did a complete U-turn at its SGM, with the participating representatives of the state units unanimously voicing their objection to five "difficult and impractical" reforms.

The five recommendations the officials objected to are: matters pertaining to membership (one-state one-vote); demarcation of the functions of the elected office-bearers and the appointed executives; size of the proposed Apex Council (BCCI wants to increase the number of its members to six from five); size of the national selection panel (BCCI wants a five-member selection panel while the Lodha Committee had recommended a three-member body); and, most importantly, the age, tenure and cooling-off period. The resolution was passed unanimously.

BCCI's objection to the recommendations pertaining to the age, tenure and cooling-off period is likely to invite the Supreme Court's wrath at the all-important September 5 hearing. The hearing scheduled for August 18 would revolve around two issues — filling the two vacant posts of the Committee of Administrators (CoA), and looking into the difficulties, as pointed out by BCCI today, in implementing the Lodha reforms.

BCCI also has problems with the 'conflict of interest' recommendation and certain words like "friends", "relatives" and "associates" in the clause. It has demanded more clarification from the SC on the issue. The other objection BCCI came up with was regarding the "restriction on government servants" to join BCCI and its state units. "Railways has to be represented by a government servant, so how could you bar someone? We want more clarity from the SC," acting secretary Amitabh Choudhary said. "This list of difficulties will be submitted to the Supreme Court. We will give a copy of the adopted resolution to CoA for its consideration," Choudhary added.

It's been more than a year since the top court directed BCCI to implement the recommendations in "totality". The board, however, has managed to defy the order so far. "It's clear that former BCCI president N Srinivasan is still calling the shots despite being barred by the Supreme Court from attending the SGM."

# BACK WITH A BANG

## Dhawan smashes a career-best 190 in his comeback match; Pujara hits his 12th ton

**GALLE (TIP):** Shikhar Dhawan smashed a career-best 190 on his Test return and Cheteshwar Pujara hit 144 not out to put India on course for a massive first innings total in the first Test against Sri Lanka on Wednesday. The duo scored 253 runs for the second wicket, with Dhawan playing the aggressor and Pujara the accumulator as India dominated the opening day to reach 399/3 at stumps. Ajinkya Rahane was batting on 39 with Pujara, their fourth-wicket association already worth 113 runs at the Galle International Stadium.

With regular openers Murali Vijay and Lokesh Rahul indisposed, Dhawan and Abhinav Mukund opened the Indian innings after captain Virat Kohli opted to bat in the first match of the three-Test series. Mukund fell for 12 to Nuwan Pradeep, but Dhawan grabbed the opportunity with both hands. The 31-year-old was on 31 when

he lashed at Lahiru Kumara, only for Asela Gunaratne to spill the catch at second slip.

Compounding Sri Lanka's crisis, Gunaratne had to be rushed to Colombo with a fractured thumb and looks certain to miss the remainder of the Test, and possibly the series. Dhawan did not look back after the reprieve and toyed with the Sri Lankan attack, pulling the pacers and sweeping the spinners freely.

A sweep off Dilruwan Perera brought up his fifth Test century off just 110 balls. India scored nearly run-a-ball after lunch with Dhawan plundering 100-plus runs in one session for the second time in his career.

The 31-year-old was cruising towards his maiden Test double century when he threw away his wicket, stepping out to slap a Pradeep delivery straight to Angelo Mathews

at mid-off. Pujara, on the other hand, played with characteristic assuredness to bring up his 12th Test century, which included 12 boundaries.

Pradeep claimed his third wicket when he dismissed Kohli for three with a short ball when Rangana Herath, leading Sri Lanka in the absence of ailing Dinesh Chandimal, challenged the original not-out decision.

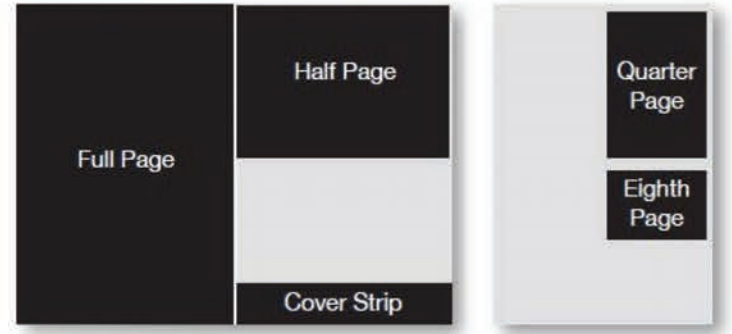
