UN SECURITY COUNCIL CONDEMNS PULWAMA ATTACK

Sources at the UN said the UNSC statement was released after prolonged Security Council negotiations.

UNITED NATIONS (TIP): The United Nations Security Council (UNSC) on Thursday, February 21, issued a statement condemning the Pulwama attack and underlining the need to hold those responsible, accountable. Significantly Jaish-e-Mohammed (JeM) has been named on the statement as having taken responsibility for the attack.

"The members of the Security Council condemned in the strongest terms the heinous and cowardly suicide bombing in Jammu and Kashmir, which resulted in over 40 Indian paramilitary forces dead



and dozens wounded on February 14, 2019, for which Jaish-e-Mohammed has claimed responsibility," the statement said.

Sources at the UN said the UNSC statement was released after prolonged Security Council negotiations. China had wanted additional time to think it through as it had some concerns, they said. France is also working, in parallel, to sanction JeM chief Masood Azhar at the UNSC. Similar action against Azhar in 2017 was blocked by China

Long Island's Indian community condemns Kashmir attack, commits funds for CRPF martyrs

HICKSVILLE, NY (TIP): A score and more Indian American community organizations and media groups held a meeting on Feb 17 to condemn the Pakistan abetted terror attack in Kashmir and to raise funds for the families of the 41 CRPF jawans martyred in that attack.

Despite a short notice, over 250 people including some eminent Indian Americans attended the solemn event at Antun's by Minar, which was initiated by Kamlesh Mehta, Chairman and Publisher of The South Asian Times. It was put together by Jasbir Jay Singh, President of IDP (India Day Parade) USA and Mukesh Modi, also of IDPUSA.

While all the speakers condemned the dastardly suicide attack and blamed Pakistan for continuing to foment trouble in the Valley, suggestions for how India should respond ranged from surgical strikes to lobbying the US to declare Pakistan as state sponsor of terror, to revoking Article 370 giving special status to Kashmir. The Indian community and their leaders were also exhorted to approach US Senators and Congress members to isolate Pakistan diplomatically.

The Indian Consulate was represented by Deputy Consul General Shatrughan Sinha. In his stately speech, he read out names of the martyred CRPF jawans and also the statement of support from the White House. He assured the audience that the Indian government is aware of the grief, sorrow and anger among Indians and NRIs following the Pulwama attack. Prime Minister Narendra Modi has promised adequate response, for which all options are on the table, he added.

Eminent attorney Ravi Batra said India is on the way to becoming world power like America so that nobody dare launch a terror attack. He suggested Pakistan's ex-sportstar PM Imran Khan should step up and make India and the US less unhappy by making reparations - setting aside a corpus to help the families of CRPF martyrs. He wished there were a 'kill switch' on the internet to stop the incubation of terrorists.

Chintu Patel, co-chairman of Amneal Pharmaceuticals, said provocations by Pakistan have crossed a level and now India has to attack the situation from all angles, military as well as financially squeezing and isolating Islamabad diplomatically. He suggested the community should also highlight he issue in the US media.

Kamlesh Mehta in his speech emphasized on the need to find permanent solution for the festering problem in Kashmir caused by cross-border terrorism. More pertinent to the occasion, he made an appeal to raise and send funds for the families of martyrs.

Large donors who made pledges at the event included NRI Foundation headed by Deepak Kavadia, Ravi Batra, Chintu Patel, and The South Asian Times. Kavadia suggested people can also donate by going to the Bharat Ke Veer website.

Chintu Patel, along with support from Kamlesh Mehta and Jagdish Sewhani, announced setting up a foundation to help Indian armed forces on a regular basis.

Prof Indrajit Saluja, Publisher-Editor of The Indian Panorama, said that for the wounds Pakistan has inflicted, there needs to be a heroic response now from India.

Indian Overseas Congress President Shudh Jasuja invoked Guru Gobind Singh and said time of picking up the sword has come, and bad actors need to be eliminated for good.

Sunil Hali, Publisher of The Indian Express - North American Edition, in an emotional tone said he wished India could target the terror masterminds in Pakistan the way Osama bin Laden was killed by US Seals. He

also opined that if thousands of crores of rupees in aid India gives to Kashmir is stopped, they will come to their senses.

Ashok Vyas recited his powerful poem on the subject and read out a message from Parikh Worldwide Media's Chairman, Dr Sudhir Parikh.

FIA's new President Alok Kumar also spoke and informed the gathering of a Candlelight Vigil on Feb 21 at Royal Albert's Palace in Fords, NJ.

Jagdish Sewhani, president of the American India Public Affairs Committee, informed of a demonstration soon outside Pakistan consulate in New York to condemn the Pulwama attack. He said the ecosystem that supports Islamabad's evil intentions has to be destroyed.

Hundle joined UCI in January from UC Merced, where she was an assistant professor of anthropology and associated faculty with the critical race & ethnic studies program. Her current research explores the politics of race, gender, citizenship and decolonization in Uganda after the expulsion of the racialized Asian community in 1972. Her research and writing have been funded by the National Science Foundation, the Wenner-Gren Foundation and multiple UC awards, including the UC President's Faculty Research Fellowship. Indian-American Doctor in Florida Convicted of Health Care Fraud

STUART, FL(TIP): An Indian-American doctor was convicted by a federal jury of committing repeated acts of health care fraud out of her practice in Stuart, Florida.

Sheetal Kanar Kumar, M.D., 48, was arraigned on twenty-six counts of health care fraud. According to the indictment, Dr. Kumar owned and operated the medical practice Advanced Healthcare for Women in Stuart, Florida. She was an obstetrician and gynecologist licensed to practice medicine. She also provided medical services treating incontinence. From at least as early as January 2014, until July 2017, Dr. Kumar submitted or caused the fraudulent submission of claims to Medicare, Medicaid and private insurance companies. The fraudulent claims sought money for specific health care benefits, items, and services that were not provided as billed. As a result of such false and fraudulent claims, Medicare, Medicaid and private insurance companies, made payments in the approximate amount of \$926,802. Dr. Kumar was found guilty by a jury of committing twenty-three counts of health care fraud and is scheduled to be sentenced on April 19, 2019.

Later in the day, another assault was reported to police. Police responded and spoke with the suspect, John Crain, who admitted to attacking the clerk and that he "hated Muslims" and believed that the clerk was Muslim. CBS13 said it confirmed that the clerk is Sikh.

Two indicted in connection with alleged Multi-Million Dollar bribery of Indian officials

NEW JERSEY (TIP): A federal grand jury returned an indictment Feb 14 against the former president and the former chief legal officer of Cognizant Technology Solutions Corporation, a publicly traded Fortune 200 technology services company based in Teaneck, New Jersey, in connection with an alleged foreign bribery scheme.

Assistant Attorney General Brian A. Benczkowski of the Justice Department's Criminal Division, U.S. Attorney Craig Carpenito of the District of New Jersey and Special Agent in Charge Gregory W. Ehrle of the FBI Newark Field Office made the announcement.

Gordon Coburn, 55, of Beaver Creek, Colorado, and Steven Schwartz, 51, of Greenwich, Connecticut, were charged in a 12-count indictment with one count of conspiracy to violate the Foreign Corrupt Practices Act (FCPA), three counts of violating the FCPA, seven counts of falsifying books and records, and one count of circumventing and failing to implement internal accounting controls. The charges stem from an alleged scheme to bribe one or more government officials in India to ensure the issuance of a construction permit necessary to complete the development of an office campus that would support thousands of employees and become one of Cognizant's largest facilities in India.

According to the indictment, in or about April 2014, Coburn and Schwartz allegedly authorized an unlawful payment of approximately \$2 million to one or more foreign government officials in India to secure and obtain a necessary permit to open a new office campus. To conceal Cognizant's involvement in the scheme, Coburn, Schwartz and others allegedly agreed that a third-party construction company would obtain the permit by making the illegal bribe payment and that Cognizant would reimburse the construction company through phony construction invoices at the end of the project. The indictment further alleges that in or about late June 2014, after the co-conspirators had agreed that the construction company would make the bribe payment on behalf of Cognizant, the construction company secured the necessary government order for Cognizant to obtain the permit, allowing Cognizant to complete the development of the office campus and avoid millions of dollars in costs. Months later, the co-conspirators are alleged to have knowingly caused Cognizant to funnel over \$2 million to the construction company disguised as payment for cost overruns on the office campus when they knew that the actual purpose of the payment was to reimburse the construction company for the bribe payment. According to the indictment, as Coburn, Schwartz and others had previously agreed, they hid the bribe reimbursement payment within a series of line items in a construction change order request to be paid to the construction company, thereby concealing the true nature and purpose of the reimbursement, falsifying Cognizant's books and records, and circumventing and failing to implement its internal controls. New York City Health Department Launches Graphic New Anti-Smoking Media Campaign

Smoking kills about 12,000 New Yorkers every year. Type 2 diabetes, liver cancer and colorectal cancer are all caused by smoking

NEW YORK CITY, NY (TIP): The Health Department, on February 20, launched "Smoking = Suffering," a new campaign that highlights three more reasons to quit smoking: diabetes, colorectal cancer and liver cancer.

Tobacco continues to be a leading cause of preventable death in New York City, killing an estimated 12,000 people annually. Although adult smoking rates in New York City declined from 21.5 percent in 2002 to 13.4 percent in 2017, there are still almost 900,000 adult New Yorkers who smoke. MORE THAN \$4 MILLION HAS BEEN SPENT BY CANDIDATES VYING FOR THE OPEN SEAT OF PUBLIC ADVOCATE

NEW YORK CITY (TIP): The race for public advocate is already the most expensive special election in New York City's history - and candidates are just getting started.

More than \$4 million has been spent by candidates vying for the open seat, according to the latest data available from the New York City Campaign

Finance Board. That figure is expected to skyrocket between now and the Feb. 26 election as the remaining candidates have some \$2 million in their combined war chests.

Councilman Jumaane Williams (D-Brooklyn) outspent all other candidates through Feb. 11, the latest date covered in the CFB's most recent

reporting period. The campaign has doled out more than \$767,000 on the race, including \$280,000 in TV ad placements.

The only other candidate who has spent more than even \$20,000 on TV spots is Assemblyman Michael Blake (D-Bronx), who put up \$200,000 across two separate TV ad buys this month.

Saudi Crown Prince's visit:
The lure of geo-economics
vs 'brotherly love'

The times have changed. Till recently, Saudi Arabia would go along with vitriolic Pakistani resolutions on Kashmir at the Organisation of Islamic Cooperation (OIC). Visiting Saudi Arabian Crown Prince Mohammed bin Salman's commiserations over the Pulwama attack fell short of expectations. Some renitence is understandable - Pakistan army serves as Riyadh's Praetorian Guard, there are 20 lakh Pakistanis in Saudi Arabia, and for decades, the US-Saudi-Pakistan troika has acted in close concert to superimpose its foreign policy on the region. Nor do the Saudis have very clean hands, having involved themselves in backing non-state actors, from Afghanistan to Syria.

Despite these constraints, India's success in breaking into the Saudi security calculus is laudable: there is an offer for real-time intelligence sharing, which was recently in evidence when Riyadh deported half a dozen Lashkar-e-Taiba suspects along with the prospect of a partnership in maritime security that matches with India's desire to keep a military eye on its sea lanes of communication carrying bulk of its energy supplies. But more important is the move towards erecting formal structures for interaction on anti-terrorism and investment.

India has played its cards well to elicit a shift in the Saudi approach which could have implications for Pakistani behavior; though Riyadh also stands diminished after its stalemate against the resource-strapped Houthis and the clumsy murder of a journalist in Turkey. But the catalyst may have been geo-economics. Mohammed has set his country on the path of modernization- women can now drive; female preachers are encouraged, and the Saudis are raring to enter downstream areas in petroleum overseas. India is among the eight countries identified for an expanding economic footprint with talk of \$100 billion in investment. The Crown Prince also advised the Pakistanis about the need to gain from India's economic resurgence, provided they had a 'great leader'. The Saudis have come a long way. They not just condemned the Pulwama attack, but also denounced it. The lure of the market seems to be triumphing over brotherly love.

Air Canada ignoring its Punjabi Customer Base

No Flights from Vancouver & Toronto to Amritsar

As the number of Punjabis swelled to over a million in Canada. Air Canada decided to start Toronto – New Delhi flight on all seven days of the week. Who advised Air Canada to take this decision is not known. The fact remains that more than 80% load of Air Canada Toronto – New Delhi flight

It is the paramount duty of all modes of transportation, including the railways, airways and road transportation to serve the customers as conveniently as possible. Punjabis are settled in Canada since early 1900s. They started with a few hundred landing in small numbers in Vancouver area prior to World War I and their numbers kept swelling in later years. Most of them were from the districts of Lyallpur, Montgomery, Lahore, Amritsar, Jalandhar, Hoshiarpur and Kapurthala. After the 1947 partition of Punjab, most of the immigrants from Lahore, Lyallpur and Montgomery moved to the districts of Ferozepur, Amritsar, Gurdaspur, Kapurthala, Ludhiana, Jalandhar and Hoshiarpur. All this area is served by Amritsar Airport, the oldest in East Punjab, in operation since 1944.

After independence of India, the Canadian immigration laws were made more liberal and during the 1950s, the numbers of Punjabis swelled to over 100000 in whole of Canada, most of them were clustered around the city of Vancouver in the British Columbia Province. When air travel picked

In a jiffy, Jet Airways decided to cancel their Amritsar – London operation. After sometime, GMR built a new terminal at New Delhi Airport called T-3. Somehow Air India decided to fly first thrice weekly from New Delhi via London to Toronto and subsequently they started New Delhi – London – Toronto daily flight. Changing gear quickly, they started flying on Amritsar – New Delhi – London route daily and commenced a new service to Toronto from New Delhi. Subsequently Amritsar was dropped from the route to the dismay of all Punjabis.

The Punjabi diaspora living in all major cities of Australia, including Sydney, Melbourne, Perth, Gold Coast, Adelaide and Brisbane is served very well by one Singapore based Scoot Airlines and two Kuala Lumpur based companies Malindo Airlines and Air Asia X. They pick up passengers daily from Amritsar and transfer them to the Australian flights. Scoot now serves Auckland in New Zealand too. Similarly all the Pacific rim countries are served by flights from Kuala Lumpur and Singapore. Now the Punjabi origin passengers bound for South East Asian countries and Australia / New Zealand do not

up steam, during the 1960s, the Ontario Province, which was geographically closer to the United Kingdom and India, started getting more Punjabi immigrants from Great Britain and the Indian Punjab. Toronto, being the largest city in Canada and its surrounding areas started getting bulk of the immigrants of Punjabi origin both from England and India. Vancouver got most of the rest.

When I reached the USA in 1980, the number of Indian Punjabis in Canada had exceeded half a million, the majority of them were in British Columbia. Ontario had the second biggest concentration, followed by Alberta and Quebec. Air India, in a business savvy decision, around early years of 2000s, decided to fly to Toronto. They already had a service from Amritsar to Birmingham. It was wiser on their part to extend the Air India service to Toronto. For a few years the Amritsar – Birmingham – Toronto service of Air India was running with a load factor of 80 to 90%. Very high for Air India compared to other flights. Turkmenistan Airlines also had a successful operation between Birmingham – Ashgabat – Amritsar and they were running in decent profit.

Sensing success of Amritsar – Birmingham – Toronto service of Air India, a newly emerging company Jet Airways also started a six days per week service to London (Heathrow). It was also running with a passenger load of 80 % to 90%. Air India had three slots per day (21 slots per week) at the most sought after Heathrow Airport in metropolitan London. They were operating one flight every day from Bombay and New Delhi to London. For quite some time, their third slot was not being used. Heathrow, being too much in demand, decided to cancel the third slot. Air India did

Of late Air Canada has started another non-stop service from Vancouver to New Delhi. For this flight too, 80 to 90% load comes from Amritsar region. Who advised Air Canada to take this step beats my imagination? More over Amritsar is the home to the most sacred shrine of the Sikh community, the Golden Temple, where every Punjabi likes to bow his/her head on arrival as well as at the time of departure. Things have changed for the better at Amritsar International Airport.

Amritsar is very well connected to the Middle – East. There are three daily flights to Dubai and one to Doha. Amritsar has three flights per/day to Mumbai, which connect Amritsar to Manchester (UK) too. Birmingham is served thrice a week from Amritsar by Air India and four times a week by Turkmenistan Airlines. The European

have to travel to New Delhi for seven to eight hours by cars and buses.

The story of Canada is totally perplexing. This great nation has the largest contingent of high level elected officials of Punjabi origin, including MPs. Tanmanjeet Singh Dhesi, the member of parliament from Slough (London) is single-handedly toiling hard to connect London with Amritsar. But none from the nearly two dozen MPs of Canada is even making a well meaning attempt to directly connect Punjabi diaspora living in Canada with Amritsar International Airport.

Kohli, Sameep Singh Gumtala, Yogesh Kamra and Michael Raul among others have launched a signature campaign to connect two major cities of Canada and London (UK) with Amritsar by direct flights. This campaign is in full steam, already about 20000 signatures have been obtained. It will be submitted to Air Canada and other organizations for action. Hopefully something positive will emerge.

British aide to Malaysian ex-PM charged with money laundering: Report

KUALA LUMPUR (TIP): Malaysian authorities charged Paul Stadlen, a British national who had worked for disgraced former prime minister Najib Razak as a media adviser, with two counts of money laundering, state news agency Bernama reported on Wednesday. Najib was ousted in a general election last year amid widespread public anger over a multibillion-dollar graft scandal at state fund 1Malaysia Development Berhad (1MDB). Malaysian anti-graft investigators issued a notice in November calling for Stadlen, whose whereabouts are unknown, to assist in its 1MDB probe. Malaysian media reports say he fled the country shortly after Najib's shock defeat in the May 9 election.

Stadlen was charged in absentia on Wednesday with laundering a total of 14.3 million ringgit (\$3.5 million) that were proceeds from illegal activities and had been deposited in the client account of a law firm that prosecutors claimed received money from Najib. Stadlen was accused of ordering the sum to be transferred from the account to several companies and individuals between June 2014 and August 2015, Bernama said, citing charge sheets filed at a Kuala Lumpur court. Bangladesh shuts 20,000 websites in anti-porn 'war'

DHAKA (TIP): Bangladesh authorities have blocked almost 20,000 websites as part of an anti-pornography "war", a minister said Tuesday. Internet providers in the conservative Muslim-majority nation took down pornography and gambling websites in the past week under orders from the telecommunications regulator. AFP

Protests in Nepal after satirical song taken off Web

KATHMANDU (TIP): The sudden withdrawal of a popular song — full of satire aimed at corruption and highly placed public figures — from YouTube and other social media by its creator, apparently under political pressure, has sparked a spate of protests across the country and among the Nepali diaspora.

"Lutna sake loot kanchha, lutna sake loot, aru deshma paidaina, Nepal ma chha chhut," (Loot whatever you can, as you can do that in Nepal) is a popular song by Pashupati Sharma. It disappeared from social media abruptly on Saturday night, with a note from Sharma that while he would make certain changes in the wording, he would not surrender his right as a Nepali citizen to raise his voice against corruption and wrong-doers.

As reports about the song's withdrawal began coming up, an avalanche of support for the singer, and the right to protest against the government, have dominated public discourse. As protests against the ban began pouring in, Kiran Poudel, senior vice-chairman of the Nepal Yuba Sangh, a youth front affiliated to the ruling Nepal Communist Party, issued a general appeal to all to boycott Sharma, alleging that he has insulted the country's President and tried to project Communist rule as "the rule of Yamaraj (the god of death)". 70 killed in major Bangladesh fire

Among victims, five children, nine women | Blaze started from chemical warehouse

DHAKA (TIP): A fire ravished adjoining apartment buildings and chemical warehouses in a historic part of the Bangladesh capital Dhaka, killing at least 70 persons and injuring several others.

Officials said the fire broke out at a chemical warehouse on the ground floor of a four-storey building named Hazi Wahed Mansion behind a mosque in Old Dhaka's congested Chawkbazar area on Wednesday night and the flames then quickly spread through four other buildings nearby, including a community centre where a wedding party was on.

"The salvage campaign is ending here," mayor of Dhaka (South) Sayeed Khokon said.

Fire officials said the blaze had claimed 70 lives so far.

Dhaka Metropolitan Police officials said the fire spread rapidly due to the multiple chemical godowns that were situated in the area.

Fire service control room spokesman Kamrul Ahsan confirmed the death toll to be 70 while state-run Dhaka Medical College Hospital's director Brigadier General AKM Nasiruddin said bodies were kept at their disposal. Nasiruddin, however, feared that the toll may rise as several people were being treated at the facility with critical burn injuries.

Khokon called off the rescue operation around 12.10 pm after nearly 14 hours of efforts. Two-hundred firefighters from 37 units doused the blaze, making their way to the scene through narrow lanes with fire engines. "Some of the bodies were burned very badly, difficult to be identified... of the victims, five are children and nine women," a doctor said.

Bangladesh's fire service chief Ali Ahmed said the blaze may have started with a gas cylinder before quickly spreading through the building where chemicals were stored.

Pakistan gifted gold-plated assault rifle to Saudi Crown Prince

ISLAMABAD (TIP): At a time when Pakistan is under immense global pressure on terrorism, the country's cash-strapped government has gifted Saudi Crown Prince Mohammad bin Salman a gold-plated assault rifle, a media report said.

The unusual gift for a visiting foreign dignitary was presented to Mohammad during his first official visit to Islamabad.

The News International reported that Pakistan's Senate delegation called on the Crown Prince at the Prime Minister's House where Senate Chairman Sadiq Sanjrani gifted him a portrait and a gold-plated gun.

The Prince is also Saudi Arabia's defence minister. In a similar gesture from the cash-rich kingdom in January, Saudi Prince Fahd Bin Sultan Bin Abdul Aziz Al Saud, also the Tabuk Governor, presented a gift of 'gold Kalashnikov' and bullets to Prime Minister Khan at the Prime Minister's Office here.

Khan had thanked him for the gold-plated Russian gun.

The Saudi Crown Prince's just-concluded high-profile visit to Islamabad came in the midst of heightened tensions between India and Pakistan following one of the worst terror attacks in Jammu and Kashmir in which 40 CRPF soldiers were killed. The attack was carried out by Pakistan-based Jaish-e-Mohammad. The international community



led by the US has pressed Pakistan to deny safe haven to terror groups operating from its soil and bring the perpetrators of the Pulwama attack to justice. Pakistan and Saudi Arabia on Sunday signed a slew of investment agreements worth USD 20 billion which will

provide a welcome relief to the teetering economy of the cash-strapped Pakistan.

Pakistan is negotiating with the International Monetary Fund a multi-billion bailout package to overcome the country's financial instability. (PTI)

Father slams Kamala Harris over pot-smoking joke

WASHINGTON (TIP): US Democratic presidential candidate Senator Kamala Harris, who is of Indian and Jamaican descent, has been slammed by her father for saying that she smoked marijuana in her younger years and supports it becoming legalized.

Donald Harris, an economics professor at Stanford University, claimed his daughter was playing "identity politics" and added that she was harming her family's Jamaican ancestors, the media reported on Wednesday. "My dear departed grandmothers... as well as my deceased parents, must be turning in their grave right now to see their family's name, reputation and proud Jamaican identity being connected, in any way, jokingly or not with the fraudulent stereotype of a pot-smoking joy seeker and in the pursuit of identity politics," he said. U.S. to leave 200 troops in Syria as "peacekeeping group": White House

WASHINGTON (TIP): The Trump administration will leave 200 US troops in Syria to act as a "small peacekeeping group", the White House has announced following President Donald Trump's order for a "full" withdrawal of the American military from the war-torn country.

The White House announced the decision on Thursday, February 21, after Mr. Trump spoke with Turkish President Recep Tayyip Erdogan over the phone.

"A small peacekeeping group of about 200 will remain in Syria for a period of time," White House Press Secretary Sarah Sanders said in a statement after the call between the two leaders.

In December, Mr. Trump abruptly declared victory against the Islamic State (ISIS) in Iraq and Syria and announced that the more than 2,000 US troops in Syria would be withdrawn immediately.

Senate confirms William Barr as attorney general

WASHINGTON (TIP): With a 54-45 vote, the Senate on Thursday, February 14, confirmed William Barr as Attorney General.

This will be Barr's second tour as attorney general; he led the Justice Department during the George H.W. Bush administration.

Barr's nomination last year marked an unusual return to politics for the 68-year-old.

An old guard conservative, Barr has held many of Washington's most influential legal perches, including a stint as the head of the Justice Department's Office of Legal Counsel, where he helped shape legal opinions that influenced White House policy and action.

After Bush's re-election defeat, Barr left government service for lucrative positions in the private sector, becoming the general counsel of Verizon up until 2008 and serving on the board of Time Warner, CNN's former parent company, through last year.

In his confirmation hearing last month, Barr pointed to this distance from the Washington career ladder as one of the reasons he decided to take the job.

"I feel I'm in a position in life where I can do the right thing and not really care about the consequences in the sense that I can truly be independent," Barr said.

MUELLER INVESTIGATION: Barr's claim of independence did little to assuage Senate Democrats skeptical of his potential handling of the looming conclusion of Mueller's investigation.

In their rejection, many Democrats have pointed to a 19-page memo Barr wrote and sent to senior White House and Justice Department officials last year that criticized an element of the special counsel probe.

"We must be clear-eyed about the moment our country is facing and the Attorney General's important role in ensuring the integrity of our democratic institutions," Sen. Chris Coons, a Democrat from Delaware, said

in a statement Wednesday announcing his no vote.

IMMIGRATION: Barr has a reputation as a hardliner on immigration and crime.

His plans to build a barrier along the US-Mexico border in 1992 will ring familiar in an administration currently engaged in a funding fight for a wall to stop an influx of illegal immigration, and in his confirmation hearing last month, Barr aligned himself with the President's views on border security.

Barr's stance on criminal justice, however, appear to have evolved since he endorsed a Justice Department publication titled "The Case for More Incarceration" in 1992, when violent crime rates hit record highs in the country.

Pressed by Democrats at his confirmation hearing last month, Barr said, "I don't think comparing the policies that were in effect in 1992 to the situation now is really fair," and told senators that he would carry out a newly passed bipartisan sentencing reform bill.

"I think the time was right to take stock and make changes to our penal system based on current experience, so I have no problem with the approach of reforming the sentencing

structure and I will faithfully enforce that law," Barr said.

CYBER SECURITY: Barr will face a new landscape of challenges in his second turn at Justice, including foreign threats and cyber crimes that were not on the department's radar, or even physical possibilities, in the early 1990s.

Chinese state-sponsored hacking and intellectual property theft are now top of mind for the Department of Justice, and federal prosecutors have brought a number of cases against Chinese nationals - and that country's biggest telecommunications manufacturer - in recent months.

"The primary rival of the United States is China. I think Russia is half the size it was when we were facing them at the peak of the Cold War. Their economy's long-term prognosis is nowhere near China's," Barr testified last month.

Barr has also set his sights on American technology companies and told senators at his confirmation hearing that he would use the Justice Department's antitrust division to explore questions around competition in Silicon Valley.

Barr agreed to return to the Justice Department out of a sense of "patriotism" and he will likely aim to helm the department in a way that restores some normalcy after a period of criticism from the President and his allies, his friends say.

"This is a person who has a special commitment to making sure that the Justice Department is really seen in a great light," said Paul McNulty, a former deputy attorney general who was Barr's top deputy for policy and communications. "He'd really want his legacy on a second time around at DOJ to be that he made the department stronger, because it's that special to him." (Source: CNN)

US Treasury Sanctions Indian Narcotics Trafficker Jasmeet Hakimzada and his Network

WASHINGTON (TIP): On February 20, the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) identified Indian national Jasmeet Hakimzada as a Significant Foreign Narcotics Trafficker pursuant to the Foreign Narcotics Kingpin Designation Act (Kingpin Act). OFAC also designated two Indian nationals and four entities registered in India or the United Arab Emirates (UAE) that form part of the narcotics trafficking organization run by Jasmeet Hakimzada. As a result, any assets in the United States or in the possession or control of U.S. persons must be blocked and reported to OFAC. OFAC's regulations generally prohibit all dealings by U.S. persons or within (or transiting) the United States that involve any property or interests in property of blocked persons.

"Jasmeet Hakimzada's global drug trafficking and money laundering network has been involved in smuggling heroin and synthetic opioids around the world," said Sigal Mandelker, Under Secretary for Terrorism and Financial Intelligence. "This action is a result of years of effort with our U.S. and foreign partners to disrupt the activities of this significant narcotics trafficking organization. We are leveraging extensive international partnerships to deploy a multilayered, coordinated approach to secure our borders and deny narcotics traffickers access to the United States."

Indian narcotics trafficker Jasmeet Hakimzada, who resides in the UAE, runs a global drug trafficking network that smuggles heroin, cocaine, ephedrine, ketamine, and synthetic opioids into the United States, Australia, New Zealand, and the United Kingdom. Since at least 2008, Jasmeet Hakimzada has laundered hundreds of millions of dollars of illicit proceeds using his UAE-based company Maiwand General Trading Company LLC through financial institutions in the United States, Brazil, India, Panama, the UAE, and the UK.

OFAC also designated two individuals who also reside in the UAE, for their roles in Jasmeet Hakimzada's criminal organization: Harmohan Hakimzada, Jasmeet's father, is his primary partner in the drug trafficking and money laundering operation; and Eljeet Kaur,

Jasmeet's mother, who serves as an officer in two front companies in India.

The four entities designated today include three entities based in India - Maiwand Exim Private Limited, Maiwand Tobacco Limited, and Maiwand Beverages Limited - and UAE-based Maiwand General Trading Company LLC, which operates as a front for an array of illicit activities to include shipping narcotics and illegal pharmaceuticals as well as laundering large sums of narcotics proceeds.

On April 5, 2017, a federal grand jury in the U.S. District Court for the Middle District of Tennessee indicted Jasmeet Hakimzada on 46 counts of drug trafficking and money laundering. Over the course of three years from 2014 through 2016, Homeland Security Investigations (HSI) conducted an extensive investigation into Jasmeet Hakimzada's global narcotics and money laundering operation uncovering dozens of drug trafficking and money laundering-related transactions transiting the United States involving numerous U.S. banks, as well as drug shipments directly to the United States using commercial international courier services. Number of people with Master's and Ph.D. Degrees doubles since 2000

About 13.1 Percent Have a Master's, Professional Degree or Doctorate

WASHINGTON (TIP): The educational level of American adults is on the rise as more college graduates go on to earn master's, professional and doctoral degrees, says a US Census report dated February 21.

Since 2000, the number of people age 25 and over whose highest degree was a master's has doubled to 21 million. The number of doctoral degree holders has more than doubled to 4.5 million.

Now, about 13.1 percent of U.S. adults have an advanced degree, up from 8.6 percent in 2000.

These findings come from the U.S. Census Bureau's Educational Attainment in the United States: 2018 table package that uses data from the Current Population Survey Annual Social and Economic Supplement.

It examines the educational attainment of adults age 25 and older by demographic and social characteristics, such as age, sex, race and Hispanic origin, nativity and disability status.

In 2017, on average a person with an advanced degree earned 3.7 times as much as a high school dropout.

The tables show, among other things, that



women make up a smaller share of high school dropouts than men, the share of Asians with advanced degrees is growing and that recent immigrants are more likely to go to college than earlier immigrants or native-born. They also clearly show a rise in the number of college graduates who have advanced degrees. In 2000, one-third of people with at least a bachelor's degree had completed an advanced degree. By 2018, 37 percent had done so.

In 2017, on average a person with an advanced degree earned 3.7 times as much as a high school dropout.

Some Highlights

The percentage of people age 25 and over who had completed less than a high school diploma or equivalent was higher for men

(10.6 percent) than for women (9.8 percent).

Between 2000 and 2018, the percentage of people 25 years and older who had completed a bachelor's degree or higher increased by 9 percentage points, from 25.6 percent to 35.0 percent.

Among Asians ages 25 to 29 in 2018, almost 7 in 10 (69.5 percent) had a bachelor's or higher degree. Five years earlier (in 2013), the bachelor's degree attainment rate for this group was 59 percent.

Recent immigrants to the United States were more likely to have a college education than earlier immigrants or the native born.

Among immigrants who have arrived since 2000, 38.8 percent have a bachelor's degree or higher, compared with 35.2 percent of the native-born. Among earlier immigrants, the rate of college education was lower - for those who arrived in the 1990s, it was 31.3 percent.

Naturalized citizens were among the groups with high levels of college attainment - 38.4 percent had a bachelor's degree or higher.

The children of immigrants were also likely to have a bachelor's degree (39.6 percent).



Indian American Law Firm Executive gets 7 years Imprisonment for Fraud

ATLANTA (TIP): A Federal Judge has sentenced Indian American Asha R. Maurya, former controller in a now defunct law firm, to seven years in prison, and three years of supervised release for participating in a fraud scheme. Her co-conspirator Nathan E. Hardwick IV, an Atlanta real estate attorney, has been sentenced to 15 years in federal prison for orchestrating a scheme to defraud his law firm out of millions of dollars. Maurya was also ordered to forfeit \$900,000 in criminal proceeds. Their restitution hearing is scheduled for May 9, 2019.

According to U.S. Attorney Byung J. "BJay" Pak, the charges and other information presented in court: Hardwick and Asha R. Maurya engaged in a scheme to defraud MHS LAW, Inc. and its subsidiaries, Morris Hardwick Schneider, LLC, and LandCastle Title, LLC, (collectively referred to as "MHS"). MHS owned and operated a law firm that specialized in residential real estate closings and foreclosures, and it ran a title business. MHS employed approximately 800 people in 16 states. Hardwick was the managing partner of the law firm and the CEO of the title business. He also ran the law firm's closing division, which was based in Atlanta. Maurya managed MHS's accounting operations under Hardwick's supervision and control.

In early 2007, Hardwick and his law partners sold off part of their business, and Hardwick pocketed approximately \$11.8 million. Hardwick quickly squandered that money, however, and by the end of 2010 was broke and deeply in debt.

From January 2011 through August 2014, Hardwick siphoned off more than \$26 million from MHS's accounts to pay his personal debts and expenses and to finance his extravagant lifestyle. More than \$19 million of that was client money that was stolen from MHS's attorney trust accounts. Hardwick spent approximately \$18.5 million of the fraud proceeds on gambling, private jets, and more than 50 different social companions.

MHS's audited financial statements showed that the firm's combined net income from 2011 through 2013 was approximately \$10 million. During that same three-year period, however, Hardwick took more than \$20 million out of the firm's accounts.

Both Hardwick and Maurya made numerous false statements to Hardwick's law partners concerning the amount of money that Hardwick was taking out of the firm. Hardwick and Maurya conspired to cover-up the fraud.

Indian American to Pay \$1.25 Million to Settle False Claims Act Allegations

PHILADELPHIA (TIP): Prime Healthcare Services and CEO Dr. Prem Reddy have agreed to pay \$1.25 million to settle false claims act allegations, U.S. Attorney William M. McSwain announced.

He would pay the United States \$1.25 million to settle allegations that two Prime hospitals in Pennsylvania - Roxborough Memorial Hospital in Philadelphia and Lower Bucks Hospital in Bristol - knowingly submitted false claims to Medicare by engaging in the following conduct: (1) admitting patients to the hospital for overnight stays who required only less costly, outpatient care and (2) billing for more expensive patient diagnoses than the patients had (the latter practice known as "up-coding").

"We are committed to ensuring that hospitals, companies that own and operate

them, and their executives appropriately bill Medicare," said U.S. Attorney McSwain. "Charging the government for more costly services than what the patient actually needs and billing the government for more serious diagnoses than what the patient actually has is a waste of taxpayer dollars. Those who engage in these practices will be held accountable."

Headquartered in Ontario, California, Prime is one of the largest hospital systems in the nation, with 45 acute-care hospitals located in 14 states. Prime acquired Roxborough Memorial Hospital on February 22, 2012, and Lower Bucks Hospital on October 3, 2012.

The Settlement resolves allegations that Prime submitted or caused the submission of fraudulent claims to Medicare. Specifically, from the date that Prime acquired

Roxborough and Lower Bucks through September 30, 2013, under Prime management, Roxborough and Lower Bucks hospitals admitted emergency room Medicare patients for costly and medically unnecessary one- and two-day overnight hospital stays, instead of treating the patients in less costly outpatient service or keeping them under observation. In addition, from the dates of acquisition through December 31, 2014, the hospitals upcoded inpatient diagnoses (i.e., billed Medicare for more serious medical conditions than the patients actually had) to increase Medicare payments.

As part of a separate lawsuit in the Central District of California, Prime and Dr. Reddy paid the United States \$65 million dollars in August 2018 to settle similar Medicare fraud allegations arising out of 14 Prime hospitals in California.

Congresswoman Grace Meng to Reintroduce Measure Promoting International Mother Language Day

WASHINGTON (TIP): U.S. Rep. Grace Meng (D-NY) announced that she will reintroduce a resolution in the House of Representatives that aims to promote International Mother Language Day in the United States. February 21 was declared as the International Mother Language Day at the initiative of Bangladesh.

International Mother Language Day was established in 1999 by the United Nations Educational, Scientific and Cultural Organization (UNESCO) to increase awareness of linguistic diversity and multilingualism. The United Nations has been observing the day since 2000 to promote linguistic and cultural diversity and multilingualism. Although the holiday is celebrated across the globe, it holds special significance to Bangladesh and those of Bangladeshi descent. The observance date



February 21 was declared as the International Mother Language Day at the initiative of Bangladesh

was chosen to commemorate the day in 1952 in Bangladesh where students died demonstrating for recognition of Bengali as a national language of Pakistan. Dhaka, now the Capital of Bangladesh, was then controlled by Pakistan.

"I am proud to once again introduce this important resolution and I urge all of my Congressional colleagues to support it," said Meng. "Passage of this measure would go a long way towards making more Americans aware of what International Mother Language Day is about. It would also help increase the number of people who observe the holiday in the U.S., and increase awareness of its significance to Bangladesh and those of Bangladeshi descent. I look forward to my measure moving through the House."

Meng plans to reintroduce her measure end February. It would support the goals and ideals of International Mother Language Day, and encourage people in the U.S. to observe it with appropriate ceremonies, programs and activities. Meng has sponsored the resolution during the past three sessions of Congress.

Free air travel for paramilitary forces posted in J&K

NEW DELHI (TIP): All paramilitary personnel deployed in Jammu and Kashmir (J&K) will now be entitled to take commercial flights to either join duty or go on leave.

In an order issued on Thursday, the Ministry of Home Affairs (MHA) said it has "approved the entitlement of air travel on Delhi-Srinagar, Srinagar-Delhi, Jammu-Srinagar and Srinagar-Jammu sectors to all the personnel of the Central Armed Police Forces (CAPFs)". This includes their journey for joining duty, transfer, tour or going on leave, it said.

The CRPF, however, clarified that convoy movement would continue to transport logistics and personnel as and when required, with adequate security measures.

The order comes a week after the attack on a CRPF convoy in Pulwama, in which 40 security personnel were killed. The convoy was on its way from Jammu to Srinagar. Many of those killed were returning after leave.

Sources said questions were raised as to why the troops were not allowed to travel by air so that the risk and threat of travelling on road, in large convoys in the Valley, is eliminated.

MHA officials said that till now, this air travel facility was only available to officers in the rank of Inspectors and above. A senior official said all CAPF personnel will now be able to book tickets on regular commercial flights and claim reimbursement from their organisation or force for travel to and from Kashmir.

Court adjourns hearing in Sunanda Pushkar death case till March 7

NEW DELHI (TIP): A Delhi court on Thursday began hearing the Sunanda Pushkar death case. Sunanda Pushkar's husband and Congress MP Shashi Tharoor, who has been accused of abetting her suicide, was present in the court. The court adjourned the matter till March 7 for further hearing.



The police asked the court for 10 days' time to argue on charges against Shashi Tharoor. While, Tharoor's lawyer Vikas Pahwa said that they have filed revision petition for non compliance of evidence under section 207 of the CrPC (supply the accused of copy of police report and other documents) as the documents provided by the prosecution to them have some discrepancies.

Shashi Tharoor has been charged under sections 498-A (husband or his relative subjecting a woman to cruelty) and 306 of the Indian Penal Code (IPC).

Sunanda Pushkar was found dead in a suite of a luxury hotel in the city on the night of January 17, 2014. The couple were staying in the hotel as the official bungalow of Tharoor was being renovated at that time. Earlier this month, a Delhi court had sent the Sunanda Pushkar death case to Sessions court for further proceedings.

Additional Chief Metropolitan Magistrate Samar Vishal sent the case to Additional Sessions Judge Arun Bhardwaj since the offence under Section 306 (abetment of suicide) of the IPC.

India will stop share of its water flowing into Pakistan: Gadkari

NEW DELHI (TIP): India has decided to stop the flow of its share of water to Pakistan from rivers under the Indus Water Treaty, a move seen as an immediate fallout of deadly terrorist attack that killed 40 paramilitary personnel in south Kashmir.

Water Resources Minister Nitin Gadkari tweeted to convey the decision of the government to stop India's share of water going to Pakistan.

But the actual implementation of the decision may take up to six years as dams as high as 100 metres will have to be built to stop such flow, officials said insisting it decision was in no way a violation of the Treaty and was only aimed at getting the rightful due to people of the country.

Under the Indus Water Treaty signed in 1960, the waters of the western rivers -- the Indus, Jhelum, and Chenab -- was given to Pakistan and those of the eastern rivers -- the Ravi, Beas, and Sutlej -- to India.

India's share of water from Ravi, Beas and Sutlej rivers came to 33 million acres feet (MAF). While about 95 per cent of the water was being used in the country after the construction of three main dams across the rivers, close to 5 per cent water or 1.6 MAF would flow to Pakistan.

To gain access to this water, India is now building more dams which will be completed in six years, officials said.

Another official said the decision was taken two months back.

Water to Pakistan from the three rivers has been flowing for 60 years while the country needs the same to meet needs of its citizens, they said insisting stopping of its share of water from going to Pakistan is in no way a violation of the Treaty.

"Under the leadership of Hon'ble PM Sri @narendramodi ji, Our Govt. has decided to stop our share of water which used to flow to Pakistan. We will divert water from Eastern rivers and supply it to our people in Jammu and Kashmir and Punjab," Gadkari said in a

tweet. He further said, "The construction of dam has started at Shahpur- Kandi on Ravi river. Moreover, UJH project will store our share of water for use in J&K and the balance water will flow from 2nd Ravi-BEAS Link to provide water to other basin states."

Gadkari's tweets have come barely a week after the gruesome Pulwama terror attack on February 14 in which as many as 40 CRPF personnel were martyred when a terrorist rammed an explosives laden vehicle into a bus carrying them. New Delhi believes the attack was planned and supported by elements in Pakistan. Following the attack, the government revoked the Most Favoured Nation (MFN) status given to Pakistan and also imposed 200 per cent customs duty on all goods imported from the neighbouring country.

"We have started the work of purification of river Yamuna ... After the formation of India and Pakistan, Pakistan got three rivers, and India got three rivers. The rightful water of our three rivers was flowing to Pakistan. Now

we will build three projects on them, and divert the water to river Yamuna," Gadkari has said yesterday at Baghpat in Uttar Pradesh while addressing a public rally.

The Union Cabinet in December had approved the Shahpurkandi dam project on the Ravi river in Punjab, a move that was intended to help India arrest its share of water flowing into Pakistan.

For this, a central assistance of Rs 485.38 crore for irrigation component over five years from 2018-19 to 2022-23 was also announced.

The Indus Waters Treaty was signed between India and Pakistan in 1960 for sharing of Indus waters. According to the Treaty, India got the full rights for utilisation of waters of the three eastern rivers -- Ravi, Beas and Satluj. "Some of the water of the Ravi river at present is going waste through the Madhopur Headworks downstream to Pakistan. Implementation of the project would minimise such wastage of water," the government has said in a statement.

BSP to contest 38 LS seats, SP 37 in UP

LUCKNOW (TIP): The Bahujan Samaj Party will contest 38 Lok Sabha seats in Uttar Pradesh while the Samajwadi Party would field candidates in 37 constituencies in the upcoming parliamentary polls.

A release signed by BSP chief Mayawati and SP president Akhilesh Yadav listed the name of the constituencies that the two parties are going to contest in the Lok Sabha polls as part of their alliance for the Lok Sabha elections. The 37 seats in the SP quota include Kairana, Moradabad, Sambhal, Rampur, Mainpuri, Firozabad, Badaun, Bareilly, Lucknow, Etawah, Kanpur, Kannauj, Jhansi, Banda, Allahabad, Kaushambi, Phulpur, Faizabad, Gonda, Gorakhpur, Azamgarh, Varanasi, and Mirzapur.

The BSP will contest from Saharanpur, Bijnor, Nagina, Aligarh, Agra, Fatehpur Sikri, Dhaurahara, Sitapur, Sultanpur, Pratapgarh, Kaiserganj, Basti, Salempur, Jaunpur, Bhadohi and Deoria, among other constituencies.

The two parties announced a tie-up for

the parliamentary elections last month. The BSP and the SP had then decided to put up candidates on equal number of seats. But the release signed by the two party chiefs named one less constituency for the Samajwadi Party. The Rashtriya Lok Dal (RLD), which had been in talks to join the opposition alliance in Uttar Pradesh, is expected to be given three seats.

At the time of announcing their election tie-up, Mayawati and Akhilesh Yadav had said that the alliance would not field any candidate at Amethi and Rae Bareilly parliamentary constituencies, represented by Congress president Rahul Gandhi and UPA chairperson Sonia Gandhi respectively. Akhilesh Yadav had later reasoned that they hadn't kept the Congress out in the cold because it was leaving two seats for them. Mayawati had earlier explained that one issue with getting the Congress on board was that the party had "no real vote transfer". Congress leaders have indicated that the other reason, probably had something to do with the number of seats the party wanted.

SC to consider pleas against Rafale verdict



NEW DELHI (TIP): The Supreme Court said it would consider hearing petitions seeking review of its verdict dismissing petitions demanding a probe into alleged irregularities in procurement of 36 Rafale fighter jets from France under an inter-governmental agreement (IGA).

In a relief to the Modi government, the top court had on December 14 dismissed petitions seeking probe into India-France deal for procurement of 36 Rafale fighter jets — a twin-engine Medium Multi Role Combat Aircraft (MMRCA) manufactured by French aerospace company Dassault Aviation — holding there was no commercial favouritism. There was no occasion to "really doubt the decision making process" warranting setting aside of the contract, it had said. Lawyer Prashant Bhushan today requested a Bench headed by Chief Justice Ranjan Gogoi to consider the submission that his review petition and an application seeking perjury prosecution of some government officials for "misleading" the court during earlier hearings be listed urgently.

Terrorism 'common concern', says Saudi Crown Prince after talks with PM Modi

NEW DELHI (TIP): Terrorism and extremism are "common concerns" and Saudi Arabia will extend all cooperation to India and other countries in the region to deal with them, Saudi Crown Prince Mohammed bin Salman said on Wednesday after holding extensive talks with Prime Minister Narendra Modi.

While the two leaders in their respective press statements after their meeting did not mention Pakistan, top officials in the Ministry of External Affairs later said Pakistan's complicity in the Pulwama terror strike was underlined during their parleys where they also condemned the terrorist attack by the Pakistan-based JeM in "strongest" possible terms.

The meeting took place two days after the influential Arab leader concluded a high profile visit to Islamabad, and in the backdrop of escalating tension between India and Pakistan in the aftermath of the Pulwama terror attack in which 40 CRPF personnel were killed by a Jaish-e-Mohammad suicide bomber.

In his statement, Modi called the attack a "cruel symbol" of the scourge of terrorism and sought punishment for terrorists and their backers.

The crown prince, however, did not mention the Pulwama strike in his remarks.

Asserting that close contact between people of Saudi and India was a "living bridge" for the two countries, Modi also welcomed the



Crown Prince's announcement of a potential investment of USD 100 billion in India in areas like energy, refining, petrochemicals, infrastructure, agriculture, manufacturing etc. Briefing reporters on the Saudi Crown Prince's visit and issues discussed during his meeting with Modi, T S Tirumurti, Secretary (ER) in Ministry of External Affairs said they also underlined the importance of comprehensive sanctioning of not just terror organisations, but also terrorists by the United Nations, in an apparent reference to New Delhi's demand for JeM head Massod

Azhar's listing by the global body.

The reference to the listing issue assumes significance as in a joint statement, Pakistan and Saudi Arabia on Monday called for avoiding "politicisation" of the UN listing regime, at a time India is stepping up efforts to brand the Jaish-e-Mohammed terror group's chief Masood Azhar a global terrorist.

In an interview to PTI, Foreign Minister Adel bin Ahmed Al-Jubeir on Wednesday said any terrorist or anyone who supports and finances terrorism must be proscribed by the United Nations. *Source: PTI*

SC holds Anil Ambani guilty of contempt in Ericsson case, told to clear dues in 4 weeks

NEW DELHI (TIP): The Supreme Court on Wednesday held industrialist Anil Ambani guilty of contempt in a case filed by telecom equipment maker Ericsson. The court slapped a fine of Rs 1 crore on three Reliance Group companies - RCom, Reliance Telecom Ltd and Reliance Infratel Ltd - in the case. The Swedish telecom equipment maker had complained that Reliance Communications had not paid up as ordered by the court earlier.

The apex court directed Anil Ambani to pay the dues of Rs 453 crore in four weeks failing which he will be sentenced to three-month jail term. An amount of 118 crore is already deposited with the registry. The court directed this amount to be released immediately.

The court observed that RCom had no intention to pay and had "willfully" not paid Ericsson the due amount. An apology by RCom was also rejected by the top court.

Earlier, a bench of Justices RF Nariman and Vineet Saran on February 13 reserved its judgment when Ericsson India had alleged that the Reliance Group has money to invest in the Rafale jet deal but they were unable to clear its dues of Rs 550 crore. The Anil Ambani-led company denied the charge.

Anil Ambani had told the Supreme Court that has entered insolvency proceedings due to failure of Reliance Communications (RCom) assets sale deal with Mukesh Ambani-led Reliance Jio. He argued that he is not in control of the funds.

Modi arrives in South Korea on two-day visit to bolster ties

SEOUL (TIP): Prime Minister Narendra Modi arrived here Thursday on a two-day visit to strengthen India's strategic ties with South Korea and seek to enhance bilateral cooperation in diverse areas, including trade and investment. Ahead of his visit, the prime minister described South Korea as an important partner for India's key initiatives such as 'Make in India', and said as fellow democracies the two countries share values and vision for regional and global peace.

Modi is visiting South Korea on the invitation of President Moon Jae-in. This is his second visit to the Republic of Korea since 2015 and second summit meeting with President Moon Jae-in.

Spokesperson of the Ministry of External Affairs Raveesh Kumar said the visit would strengthen India's special strategic partnership with South Korea and add dynamism to the Look East Policy. During the visit, Prime Minister Modi will have bilateral and business engagements, unveil a bust of Mahatma Gandhi and accept the Seoul Peace Prize conferred upon him, Kumar said in a tweet. Earlier in his departure statement, Modi said his visit is reflective of the importance "we both attach to our relationship". "We regard the Republic of Korea as a valued friend, a nation with which we have a Special Strategic Partnership. As fellow democracies, India and the ROK have shared values and a shared vision for regional and global peace," the prime minister said.

After Maharashtra, TN, BJP eyes poll alliances in Kerala, Andhra

NEW DELHI (TIP): Internal assessments that predicted a tough contest in the Hindi heartland, which it swept in 2014; a desire to retain the party's base in the west; and the compulsion to make inroads into new territories have prompted the Bharatiya Janata Party to seal pre-poll alliances with existing and new partners, senior leaders of the party said on condition of anonymity.

The BJP's focus will now shift to working out the fine-print of agreements in Bihar, Maharashtra and Tami Nadu; ironing out differences in the Northeast; and prospecting for possible pre-and post-poll alliances in Kerala and Andhra Pradesh, the BJP leaders added.

"Uttar Pradesh and Bihar have become a tight contest against a united opposition. We needed to firm up alliances," one of the BJP leaders said. "We ceded space to allies such as the Janata Dal (United), buried differences with the Shiv Sena, and kept our ambitions under check in Tamil Nadu to forge alliances that can help us return to power." The Bihar deal is the oldest, and was struck in December 2018. The BJP's deals with the Sena in Maharashtra and the AIADMK in Tamil Nadu were finalised earlier this week.

The BJP has now turned its attention to other states.

"Our alliance with the Shiromani Akali Dal in Punjab remains intact and there is no major issue over number of seats we will contest," the BJP leader added. Of the 13 Lok Sabha seats of Punjab, the Akalis got 10 to contest in the last election and the BJP 3. "The numbers will remain the same," a second BJP leader said. The party may also cede a seat or two to alliance partners in Jharkhand, where all opposition parties have joined hands, the second leader added.

The BJP's Kerala unit is in talks with the Bharatiya Dharma Jana Sena, an outfit with following among the OBC Ezhava community. "They want about half a dozen seats and discussions are on," a third BJP leader said. "The BJP may also support a couple of independent candidates in the state." Kerala has 20 Lok Sabha seats and despite

fielding candidates in 18 in the last parliamentary election, the party could not win even a single seat.

The BJP continues to flirt with actor-politician Pawan Kalyan (of the Jana Sena) in Andhra Pradesh, but he continues to remain non-committal. The party has, meanwhile, suffered a setback in the Northeast with the Asom Gana Parishad walking out of the National Democratic Alliance over the citizenship amendment bill, which intends to grant citizenship to non-Muslims from Pakistan, Bangladesh and Afghanistan. The BJP was relieved after the Bodo People's Front, another ally from Assam, decided to remain with the NDA, but 11 other regional parties gave it the jitters by openly opposing the proposed law.

After the reading, Rabbi Joseph Potasnik, Executive Vice President of the New York Board of Rabbis, moderated an interfaith conversation about the lasting impact of the Holocaust, including current awareness and prevention of genocide, with Dr. Hershkowitz, Ms. Jaffe, Ms. Sharpe, and Imam Dr. Tahir Kukaj, Vice President of the Albanian Islamic Cultural Center in Staten Island.

So begins Dr. Allen Hershkowitz's memoir of searching for his father's history in the concentration camps at the hands of the Nazis. This multi-racial, multi-denominational, multi-generational event started with a reading of the memoir and finished with an interfaith conversation about the Holocaust and its reverberations today.

"My story offers a uniquely powerful reminder of how poisonous hatred can be, and the miraculous strength inbred in those committed to survive."

"Hate crimes have risen for the past four years and in 2017, the last year for which complete data exists, there was a 57 percent jump in anti-Semitic crimes in the U.S.. Sadly, racist, homophobic, and anti-Semitic hate crimes are on the rise worldwide," said Dr. Allen Hershkowitz, author of the memoir 'Finding My Father's Auschwitz File.' "January 27th, International Holocaust Remembrance Day, offers a timely opportunity to gather and reflect on our common humanity, to emphasize that people of good will hear the cries of the world. My book documents the story of my parents' persecution by Nazi murderers, the slaughter of their first three children,

their first spouses, their parents and relatives, simply because they were Jewish."

"International Holocaust Day of Remembrance marks the anniversary of the liberation of the Nazi concentration camps," said William Spencer Reilly, Executive Director of The Sheen Center. "This is a day when all people of all faiths reflect on one of the darkest chapters in human history, look to the future in our common hope to make the world a better place, and celebrate the human spirit of survival and perseverance. Allen's remarkable and personal story of piecing together his parents' history in the camps is something we are proud to share."

Dr. Hershkowitz learned little from his parents about their past. It was not until he uncovered his father's Auschwitz file that he recognized how far from understanding their history he was. His father's life, as well as the life of his mother, was a miraculous drama. In October 2011, with the hundredth anniversary of his father's birth approaching -- he was born December 12, 1912 -- Hershkowitz decided it was time to visit Auschwitz. He took a detour on his way home from Portugal for the High Holy Days and finally went to Auschwitz and found that his father's file had miraculously survived the Nazis' burning of inmate records before they abandoned the camp.

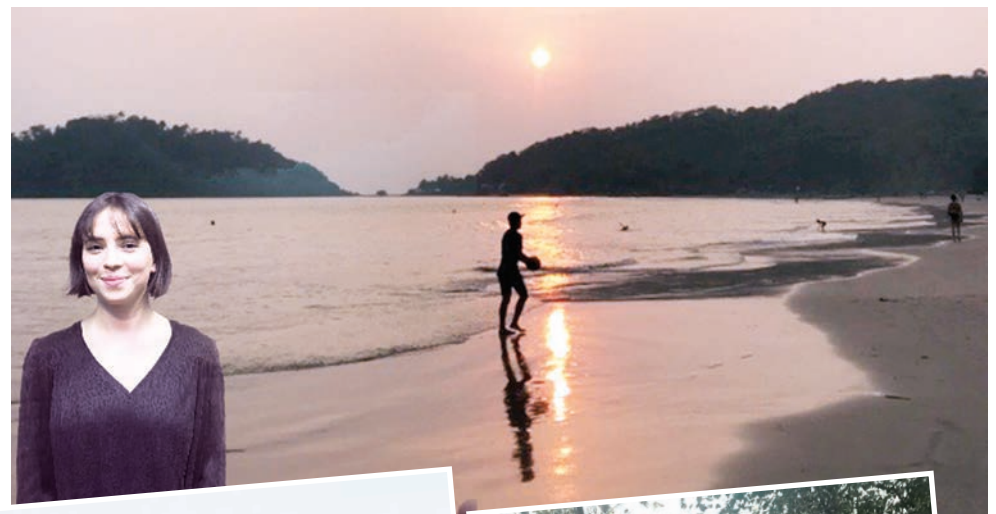
aspiration of the client.

Sanjay Kapoor's daughter Shanaya to make her Bollywood debut in cousin Janhvi Kapoor's next

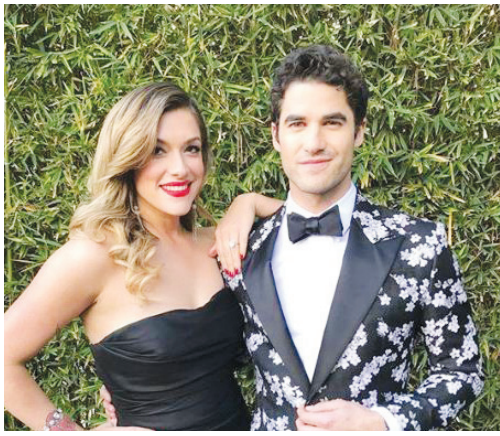

The wedding was attended by many of Criss' fellow 'Glee' alums, including Lea Michele, John Stamos, Chord Overstreet and Harry Shum Jr.

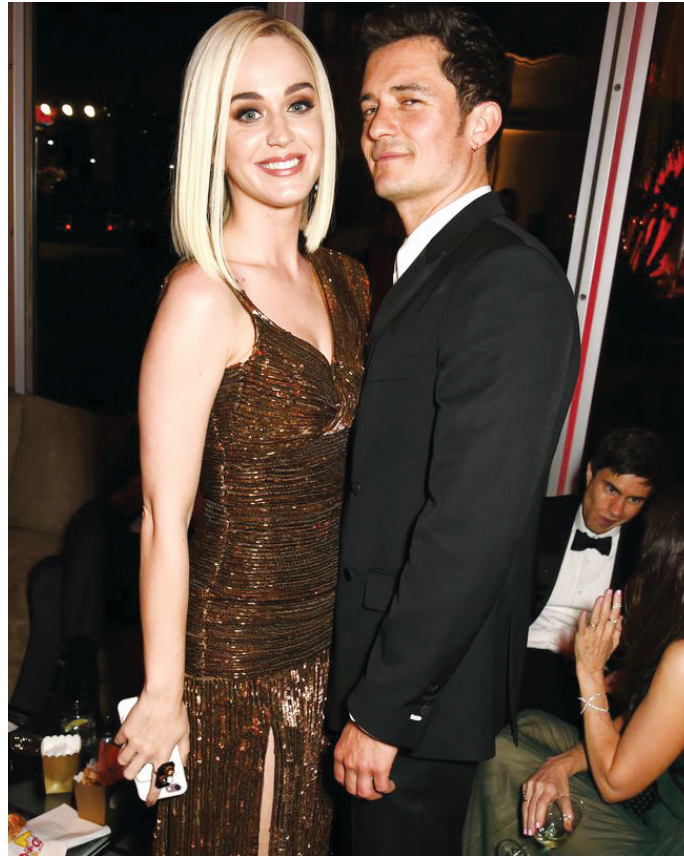
The actor had announced his engagement to Swier in January 2018.

Money of Brilliant Earth tells Town & Country the ring could cost between \$25,000 and \$50,000 if the middle stone is a ruby, while Andrew Brown, president of WP Diamonds, tells E! News the ring could be worth \$5 million.

The exact price tag remains unconfirmed, but we do know the ring's structure has a royal connection. Perry's piece of jewelry is known as a cluster ring, according to Stephen Feuerman of NYC jeweler Stephen Russell, which specializes in period jewelry.

The design came into style around 1900, but resurged in popularity after Prince Charles proposed to Princess Diana with a sapphire cluster ring with surrounding diamonds in 1981.

"Lady Di really brought them back into fashion when Charles gave her one," Feuerman tells BAZAAR.com. (Prince William later used the same ring to propose to Kate Middleton in 2010.)

Indian Origin Gas Station Clerk shot dead in Florida

TAMPA (TIP): Kotha Goverdhan Reddy, a native from Telangana was allegedly shot dead by unidentified gunmen in Florida on Feb 19. He worked as a clerk at a gas station located near the Pensacola area of the city. He came to Florida six years ago. News agency ANI reported that the victim is survived by his wife and two teenager daughters who stay in village Raheem Khan Pet in Telangana's Yadadri Bhongir district.

"We received information that on Tuesday late night, two persons barged into the gas station store where Goverdhan was alone and opened fire on him," Madhusudan Reddy, the brother of the victim, told ANI. "The local authorities are suspecting that the two unidentified men who shot Goverdhan would be robbers. Exactly we don't know the reason why the assailants had killed my brother... We are waiting for details," he was further quoted by ANI.

The Pensacola police said that based on CCTV footage, they identified at least three people who were involved in the crime and arrested them.

South Korea retracts guidelines on look-alike K-pop stars

SEOUL (TIP): Government guidelines aimed at promoting more diversity in South Korea's K-pop world have been withdrawn after critics said they amounted to state censorship of a booming industry.

The guidelines issued last week complained that K-pop stars looked too alike, saying "the problem of ... uniformity among singers is serious", and noting most idols were thin and wore identical make-up and skimpy outfits.

South Korea's K-pop world is a multi-billion-dollar business, but so too is the plastic surgery industry in the image-obsessed country, and tens of thousands of people go under the knife every year in pursuit of the perfect look.

The guidelines from the ministry of gender equality drew criticism online -- and also from a lawmaker who said it was reminiscent of censorship during the country's period of authoritarian government which ended in 1980s.

Demanding the state apologises, Lawmaker Ha Tae-keung said the guidelines were a "totalitarian and unconstitutional idea".

In a survey of teenagers last year, nearly 70 per cent said the idea of trying to become a celebrity in the entertainment industry had crossed their mind.

The ministry alluded to the impact TV celebrities have on young people in the guidelines. "Overt concerns for how one should look on TV has a negative impact not only on adults, but also on teenagers and children," it said. AFP

China's desire for close Iran ties unchanged, Xi says ahead of Saudi Prince's visit

BEIJING (TIP): China's desire to develop close ties with Iran will remain unchanged, regardless of the international situation, President Xi Jinping told the Speaker of Iran's Parliament, ahead of Thursday's visit to Beijing by Saudi Arabia's Crown Prince.

China has traditionally played little role in Middle East conflicts or diplomacy, despite relying on the region for oil, with Iran its fourth largest supplier last year, but has been trying to raise its profile, especially in the Arab world.

Saudi Arabia's King Salman visited Beijing in 2017, and Saudi Crown Prince Mohammed bin Salman arrives on Thursday for a two-day visit.

However, China has had to walk a fine line, as it also has close ties with Saudi Arabia's regional foe, Iran.

Meeting Iranian Parliament Speaker Ali Larijani on Wednesday, Xi said the two countries had a long friendship and shared long-tested mutual trust, according to a Chinese foreign ministry statement issued on Thursday.

"No matter how the international and regional situation changes, China's resolve to develop a comprehensive strategic partnership with Iran will remain unchanged," it paraphrased Xi as saying.

China and Iran should further deepen strategic mutual trust and continue to support each other on core interests and major



concerns, Xi added.

China advocates cooperation among international and regional parties to swiftly put the Middle East on the road of stability and development, he said.

"We support Iran in playing a constructive role in maintaining regional peace and stability and are willing to closely communicate and coordinate on regional issues," Xi added.

In Beijing, Larijani has been accompanied by Oil Minister Bijan Zanganeh and Foreign Minister Mohammad Javad Zarif, who met his Chinese counterpart on Tuesday.

Washington's major European allies opposed a decision last year by U.S. President Donald Trump to abandon the Iran nuclear deal that included China and Russia, and lifted international sanctions on Iran, in return for curbs on its nuclear programme. Reuters

Former New Zealand PM denies writing article in China's official paper

WELLINGTON (TIP): New Zealand's former prime minister has denied writing an article attributed to her by the official newspaper of China's ruling communist party that praised the Asian giant's economic development at a time of strained ties.

The first-person opinion piece, headlined "We need to learn to listen to China", was published under Jenny Shipley's name on the website of the People's Daily on Monday. It had become its top-read English-language story by Thursday.

"It is important for the foreign minister and prime minister and others to understand that I would never think of getting into a public situation like this, at such an important time for New Zealand's relationship," Shipley told the New Zealand Herald newspaper. She said she had not been aware of the piece.

Shipley, who is the chairwoman of the New Zealand subsidiary of China Construction Bank, did not respond to Reuters' request for comment on Thursday.

The People's Daily, which published a Chinese version in the newspaper's main edition on Jan. 23, said it was looking into the matter and declined further immediate comment.

The item drew a backlash from Foreign Minister Winston Peters, who told Radio New Zealand on Wednesday its timing was "very unwise".



An intelligence agency decision in November that rejected participation by Chinese technology giant Huawei in New Zealand's 5G network has left politicians and foreign policy analysts worried about relations with one of New Zealand's key trading partners.

Prime Minister Jacinda Ardern's first visit to Beijing has faced scheduling issues and China last week postponed the New Zealand launch of a major tourism campaign. Shipley said she had been interviewed by a Chinese newspaper in

December for a feature article that had already been published, the New Zealand Herald said. An article with comments on topics similar to those in Monday's piece ran last month on the website of the China Daily, a separate state-run newspaper, but was couched in the third person and put Shipley's comments in quotation marks.

Shipley was New Zealand's first female prime minister and led the country from 1997 to 1999 as head of the centre-right National Party. Reuters

UK strips teen of citizenship, Begum had joined IS in Syria

Currently in a refugee camp, she describes move as 'unjust'

LONDON (TIP) Britain stripped a teenager who travelled to join Islamic State of her citizenship on security grounds, triggering a row over the ramifications of leaving a 19-year-old mother with a jihadist fighter's child to fend for herself in a war zone.

The fate of Shamima Begum, who was found in a detention camp in Syria last week, has illustrated the ethical, legal and security conundrum that governments face when dealing with the families of militants who swore to destroy the West.

With Islamic State depleted and Kurdish-led militia poised to seize the group's last holdout in eastern Syria, Western capitals are trying to work out what to do with battle-hardened foreign jihadist fighters, and their wives and children.

Begum, who gave birth to a son at the weekend, prompted a public backlash in Britain by appearing unrepentant about seeing severed heads and even claiming the 2017 Manchester suicide attack was justified.

Begum, who is currently in a Syrian refugee camp, described the move as "unjust". "I am not that shocked but I am a bit shocked. It's a bit upsetting and frustrating. I feel like it's a bit unjust on me and my son," she told 'ITV News' channel from the camp.

Begum claimed that she was being treated harshly because "I was on the news four years ago", saying that she heard of "other people being sent back to Britain". "I don't know why my case is any different," she added.

She had pleaded to be repatriated back to her family in London and said that she was not a threat. But ITV News published a February 19 letter from the interior ministry to her mother that said Home Secretary Sajid



Javid had taken the decision to deprive Begum of her British citizenship.

The letter asked Begum's mother to inform her daughter of the decision and set out the appeal process. When asked about the decision, a spokesman said Javid's priority was "the safety and security of Britain and the people who live here".

The government's move to strip Begum of her citizenship has been attacked by the Opposition Labour Party, with shadow home secretary Diane Abbott calling it a failure of security obligations and breach of human rights law

"If the government is proposing to make Shamima Begum stateless it is not just a breach of international human rights law but is a failure to meet our security obligations to the international community," Diane Abbott, Labour spokeswoman on home issues

Under the 1981 British Nationality Act, the UK home secretary has the power to deprive a person of their citizenship if satisfied that it would be "conducive to the public good" and they would not become stateless as a result

Meanwhile, an e-petition started last week since Begum's case hit the headlines has attracted nearly 45,000 signatures calling for preventing her return to the UK

'Concrete measures' on sex abuse must: Pope

VATICAN CIT (TIP): Pope Francis opened on Thursday a landmark summit at the Vatican on fighting child sex abuse, saying that the world expected "concrete measures" on tackling paedophilia in the Catholic Church.

The pontiff will dedicate the next three and a half days to discussing the Church's response to child abuse by members of the clergy with bishops from around the world. "The Holy people of God are watching and waiting not for simple and obvious condemnations, but concrete and efficient measures," he said as the summit opened, the first of its kind.

The pope is aiming to tackle the continuing scandal, which again hit the Church in 2018 in countries across the globe, including Chile, Germany and the United States. —AFP

Mongolia shuts KFC after dozens hospitalised

ULAANBAATAR (TIP): Mongolian authorities have temporarily closed all KFC restaurants in the country after more than 200 customers suffered food poisoning symptoms and dozens were hospitalised.

The first cases emerged earlier this month, with 16 persons showing symptoms of food poisoning, including diarrhoea, vomiting and high fever after eating at the fried chicken franchise. Ulaanbaatar's Metropolitan Professional Inspection Department said 247 similar cases had been reported and 42 people had been hospitalised. AFP

Huawei's founder says world can't live without it

BEIJING (TIP): The founder of Chinese telecom giant Huawei has hit back at the US efforts to blacklist the company, saying defiantly that the world cannot do without Huawei and its "more advanced" technology. "There's no way the US can crush us," Ren Zhengfei said in an interview with the BBC.

"The world cannot leave us because we are more advanced." Ren (74), also denounced as "politically motivated" the December arrest of his daughter, Huawei Chief Financial Officer Meng Wanzhou, who is accused of violating US sanctions against Iran. AFP

'Suicide bomber who killed 27 members of Iran's Guards was Pakistani'

GENEVA (TIP): The man who carried out a suicide bombing which killed 27 members of Iran's elite Revolutionary Guards near the border with Pakistan last week was Pakistani, a senior Revolutionary Guards commander said on Tuesday, according to the Tasnim news agency.

One other member of the militant cell that planned the attack was also a Pakistani citizen, the head of the Guards' ground forces, Brigadier General Mohammad Pakpour said. Iran has repeatedly blamed Pakistan for sheltering militants connected with attacks in the border area, although Tuesday's remarks appear to be the first time Tehran has said Pakistani citizens were directly involved in the attack. (Reuters)

Putin warns new missiles could target 'decision-making centres'

MOSCOW (TIP): President Vladimir Putin on Wednesday said Russia would have to deploy missiles targeting "decision-making centres" if Washington sends missiles to Europe.

The announcement comes after the US said it would withdraw from a key Cold War-era arms treaty over what it said were Russian violations, prompting a mirror move from Moscow.

"Russia does not intend to be the first to deploy such missiles in Europe," Putin said during an annual state of the nation address.

"If (the US) develops and deploys them in Europe... this will dramatically exacerbate the international security situation, creating serious threats to Russia," he said.

"I'm saying this clearly and openly, Russia will be forced to deploy weapons that can be used... against the decision-making centres that are behind the missiles systems which threaten us."

He earlier accused Washington of using "far-fetched accusations" to withdraw from the Intermediate-Range Nuclear Forces (INF) agreement.

Putin said he understood concerns about the bilateral deal, namely that other countries could continue to develop weapons that are banned for the US and Russia.

"The current state of affairs of course raises questions," he told the audience of



lawmakers and celebrities.

"Our American partners should have been honest... and not use far-fetched accusations against Russia to justify their unilateral withdrawal from the treaty," he added.

The United States has repeatedly accused Russia of violating the INF by developing banned weapons and this month President Donald Trump said Washington was starting a process to withdraw from the treaty.

In a tit-for-tat move, Putin said Moscow was

also leaving the treaty and beginning work on new types of weapons that would breach the agreement.

Many analysts say abandoning the treaty effectively signalled the start of a new arms race.

The INF deal was signed in 1987 by then US President Ronald Reagan and Soviet leader Mikhail Gorbachev and resolved a crisis over Soviet nuclear-tipped ballistic missiles targeting Western capitals. — AFP

Castor oil pack for gentle detox, pain and inflammation

Take a piece of flannel and place it in the bowl or glass container and pour enough castor oil over it to soak it (make sure it's saturated, but it doesn't need to be dripping in oil).

Place an old towel on a flat surface (either a couch, bed or the floor). For added protection, you can put down a garbage bag underneath the towel so that your bed or couch won't get stained from any oil that may escape from the plastic cover.

Place the saturated flannel over the affected area of your body and cover the pack with plastic.

Place the heating pad or hot water bottle over the pack, cover with a towel and let it sit on the treated area such as the liver for at least 30-60 minutes. During this time you can rest, read a book, listen to music, meditate, or do your healing affirmations. If treating the liver, you can lie on the right side over the pack.

When the time is up, remove the pack and clean the area with water and a bit of baking soda to get the stickiness off.

You can keep the pack for reuse for a few months, stored in a plastic bag in a cool place. Just add another 2-3 tablespoons of castor oil for the next session.

It is recommended to have having 2-3 castor oil packs per week for liver detox over 2-3 weeks but if you have time for



more (to do them daily), that would greatly enhance healing and repair. To boost the liver detox have 1 tablespoon of olive oil just before you apply the pack.

Bengali Fish Fingers

A popular and easy to make Bengali style appetizer/snack. These fish fingers are well suited for any occasion, party or can also be served as an evening snack.

Ingredients

White Fish Fillets - 300 gms, skinless, boneless, Eggs - 2, Fennel Seeds - 1 tsp, Cumin Seeds - 1 tsp, Mustard Seeds - 1 tsp, Nigella Seeds - 1 tsp, Fenugreek Seeds (Methi) - 1/2 tsp, Maida - 1 1/2 tbsps, Besan Flour - 1/2 tbsps, Red Chilli Powder - 1 tsp, Garlic - 3 cloves, crushed, Ginger - 1 inch piece, grated, Oil as required, Breadcrumbs - 1 to 2 cups, Coriander Leaves - handful, chopped, Salt as per taste

Method

- Combine the cumin seeds, fennel seeds, mustard seeds, nigella seeds and methi in a mixer jar. Grind them together and transfer to a bowl. Add the maida, besan, red chilli powder, garlic, coriander leaves, ginger and enough salt. Beat the eggs in a bowl and add to the flour. Gently whisk until combined. Chop the fish fillets into small bite-sized pieces or strips. Heat oil in a deep frying pan. Dip the fish fillets into the batter and remove. Allow any excess to drip off and dredge it in the breadcrumbs, coating it fully. Gently slide them into the hot oil and fry until cooked through or crisp and golden brown.

Cardamom butter chicken

Ingredients

2 garlic cloves, roughly chopped, thumb-sized piece ginger, 2 green chillies, chopped (leave seeds in if you like it hot), small bunch coriander, leaves picked, stalks roughly chopped, 3 tbsps ghee, 2 onions, 2 tsp each turmeric, garam masala and ground cumin, 1 tsp ground fenugreek, 4 chicken breasts, cut into 2 1/2 cm cubes, 4 cloves, 12 cardamom pods, seeds removed, 1 cinnamon stick, 400g can tomato, 150ml pot yogurt, 50ml double cream.

Method

Place the garlic, ginger, chillies and coriander stalks in the small bowl of a food processor with a good pinch of salt, and blend to a fine paste – or grind to a paste using a pestle and mortar. Heat 2 tbsps of the ghee or oil in a large pan, add the onions and cook slowly for 15-20 mins until golden and caramelised. Tip in the garlic-ginger paste, turn up the heat and cook for a further 5 mins. Add the ground spices and cook for 2 mins more until fragrant. Scoop the spicy onion mixture out of the pan into a bowl.

Add the remaining ghee or oil to the pan and cook the chicken over a medium-high heat until browned all over. Tip into a bowl, cover and set aside. Return the onion mixture to the pan along with the whole spices, tomatoes and a can full of water (400ml). Bring to the boil, then cover and simmer gently for 40 mins. Return the chicken to the pan and cook, uncovered, for a further 10 mins until the sauce has thickened and the chicken is cooked through. Stir in the yogurt and cream, season well and scatter with coriander leaves. Serve with chapatis and rice.

NEW DRUG MAY HELP DELAY AGEING IN HUMANS

Researchers, including one of Indian origin, have developed a promising drug that significantly increases muscle size, strength and metabolic state in aged mice, and may help delay ageing process in humans.

As we age, our bodies increasingly lose the ability to repair and rebuild degenerating skeletal muscles, said researchers from the University of Texas Medical Branch (UTMB) in the US.

Beginning around age 35, muscle mass, strength and function continually decline as we get older, according to the study published in *Biochemical Pharmacology*.

This can dramatically limit the ability of older adults to live fully active and independent lives.

"There are no treatments currently available to delay, arrest or reverse age-related muscle degeneration," said Harshini Neelakantan, a research scientist at UTMB.

"These initial results support the development of an innovative drug treatment that has the potential to help the elderly to become fitter, faster and stronger, thus enabling them to live more active and independent lives as they age," Neelakantan said.

"We identified a protein in muscle stem cells that appears to be responsible for their age-related dysfunction, and then developed a small molecule drug that limits the effects of this protein," said Stanley Watowich, an associate professor at UTMB.

"By resetting muscle stem cells to a more youthful state, we were able to rejuvenate them so that they could more effectively repair muscle tissues," Watowich said.

In the study, aged mice with a muscle injury were treated with either the drug or a placebo. Following seven days of drug treatment, researchers found that the aged mice that received the drug had more functional muscle stem cells that



WHAT CAUSES AGEING?

Ageing is caused by a complex interplay between genes and environment. Both external environment, things like diet, exercise, stress and infection, and the environment of each cell, things like oxidative stress and epigenetic changes (changes in marks on DNA) affect how our cells, and therefore how our whole body ages.

DNA inside our cells is constantly being damaged. This is normally repaired by 'in house' DNA repair mechanisms. But these mechanisms become less effective as we age.

Telomeres are the regions at the end of chromosomes. They comprise repeated DNA sequences that protect the important DNA from being chopped off each time DNA is copied so the cell can divide and reproduce.

Epigenetic alterations are reversible marks on DNA that do not change the DNA sequence. These include DNA methylation, post-translation histone modification, and chromatin remodelling. Epigenetic marks change as we age.

Proteins in our cells are constantly being recycled. Old damaged proteins are removed, and new proteins are made to replace them. If this system doesn't work, there is an accumulation of damaged proteins in cell.

were actively repairing the injured muscle.

In the treated group, muscle fibre size doubled, and muscle strength increased by 70 per cent, compared with the

placebo group.

In addition, the blood chemistry of the drug-treated and untreated mice was similar, suggesting no adverse drug effects were occurring. *Source: PTI*



Antibiotics can cause seizures, delirium

Common antibiotics may be linked to a serious disruption in brain function, called delirium, and other brain problems, researchers including one of Indian-origin have claimed. Delirium causes mental confusion that may be accompanied by hallucinations and agitation. Medications are often the cause of delirium, but antibiotics are not necessarily the first medications doctors may suspect.

"People who have delirium are more likely to have other complications, go into a nursing home instead of going home after being in the hospital and are more likely to die than people who do not develop delirium," said Shamik Bhattacharyya, of Harvard Medical School and Brigham and Women's Hospital in Boston. "Any efforts we can make to help identify the cause of delirium have the potential to be greatly beneficial," said Bhattacharyya.

For the study, researchers reviewed all available scientific reports and found case reports on 391 patients, over seven decades, who were given antibiotics and later developed delirium and other brain problems. A total of 54 different antibiotics were involved, from 12 different classes of antibiotics ranging from commonly used antibiotics such as sulfonamides and ciprofloxacin to intravenous antibiotics such as cefepime and penicillin.

About 47% had delusions or hallucinations, 14% had seizures, 15% had involuntary muscle twitching and 5% had loss of control of body movements. EEG, a test that detects electrical activity in the brain, was abnormal in 70% of the cases.

As many as 25% of the people who developed delirium had kidney failure. The researchers identified three types of delirium and other brain problems related to antibiotics.

Type 1 was characterised by seizures and most often associated with penicillin and cephalosporins. Type 2 was marked by symptoms of psychosis and associated with procaine penicillin, sulfonamides, fluoroquinolones and macrolides. Both Type 1 and Type 2 had a quick onset of symptoms, within days. Once antibiotics were stopped, symptoms also stopped within days.

Type 3 was characterised by abnormal brain scans and impaired muscle coordination and other signs of brain dysfunction, and was only associated with the drug metronidazole.

Green tea helps you fight arthritis

Here's to green tea once again. A compound found in green tea may help combat joint pain, inflammation and tissue damage caused by rheumatoid arthritis, researchers, including those from India, have claimed.

Rheumatoid arthritis is a debilitating autoimmune disorder that mostly affects the small joints of the hands and feet. It causes painful swelling that progresses into cartilage damage, bone erosion and joint deformity.

"Existing drugs for rheumatoid arthritis are expensive, immunosuppressive and sometimes unsuitable for long-term use," said Salahuddin Ahmed, lead researcher on the project from Washington State University (WSU) in Spokane.

His team evaluated a phytochemical called epigallocatechin-3-gallate (EGCG), which is a molecule with anti-inflammatory properties found in green tea.

The study suggests that EGCG has high potential as a treatment for rheumatoid arthritis because of how effectively the molecule blocks the effects of the disease without blocking other cellular functions. "This study has opened the field of research into using EGCG for targeting TAK1 -- an important signalling protein -- through which proinflammatory



cytokines transmit their signals to cause inflammation and tissue destruction in rheumatoid arthritis," said Ahmed.

The researchers, including Anil Singh and Sadiq Umar from WSU, confirmed their findings in a pre-clinical animal model of human rheumatoid arthritis, where they observed that ankle swelling in animals given EGCG in a 10-day treatment plan was markedly reduced.

AMERICA'S FIRST SOCIAL MEDIA NETWORKS REVEALED

Long before the advent of Facebook, Instagram and Snapchat, early Mississippian Mound cultures in America's southern Appalachian Mountains shared artistic trends and technologies across regional networks that functioned in similar ways as modern social media, according to a study.

The findings, published in the journal Proceedings of the National Academy of Sciences, suggest that strong social connections between common people have always played an important role in helping societies guard themselves against the vagaries of unpredictable leaders and ruling classes.

"Just as we have our own networks of 'friends' and 'followers' on platforms like Facebook and Twitter, societies that existed in North America between 1,200 and 350 years ago had their own information sharing networks," said Jacob Lulewicz, lecturer at the Washington University in the US.

"Our study found a way to reconstruct these indigenous communication networks," he said in a statement.

"Our analysis shows how these networks laid the groundwork for Native American political systems that began developing as far back as 600 AD," Lulewicz said.

The study utilises sophisticated social network analysis to map social and political connections that helped unite friends and families in dozens of Native American villages well before the arrival of European explorers.

The findings are based on a messaging archive that is preserved not in bytes, but in bits of pottery sherds unearthed over many years in archaeology digs at dozens of Mississippian culture sites scattered across southern Appalachia.

INSTAGRAM TESTING DONATION STICKER ON STORIES

Facebook-owned photo-messaging app Instagram is reportedly testing a donation sticker on its Stories feature that would offer fundraising and donation tools for charity or personal reasons.

"Instagram is working on 'Donation' sticker. It lets users start fundraisers for their favorite non-profits," tipster Jane Manchun Wong tweeted on Monday.

Facebook has been hosting such fundraising tools since 2015 and it recently dropped fees associated with those donations. "Over the past few years, Instagram has been experimenting with what payments would look like on the platform, but it has so far only released test features to allow select users to book spa appointments and restaurant reservations," The Verge reported.

Instagram has also been developing a standalone app for shopping indicating the possibility for payment functionalities to also exist on Stories, the media has reported.

Since Instagram has not officially addressed the subject as yet, whether or not donation sticker rolls out to the public still remains unclear. *Source: IANS*



MASSIVE MOUNTAINS DISCOVERED UNDER EARTH'S CRUST

Scientists have discovered massive mountains in the Earth's mantle, an advance that may change our understanding of how the planet was formed.

Most school children learn that the Earth has three layers: a crust, mantle and core, which is subdivided into an inner and outer core.

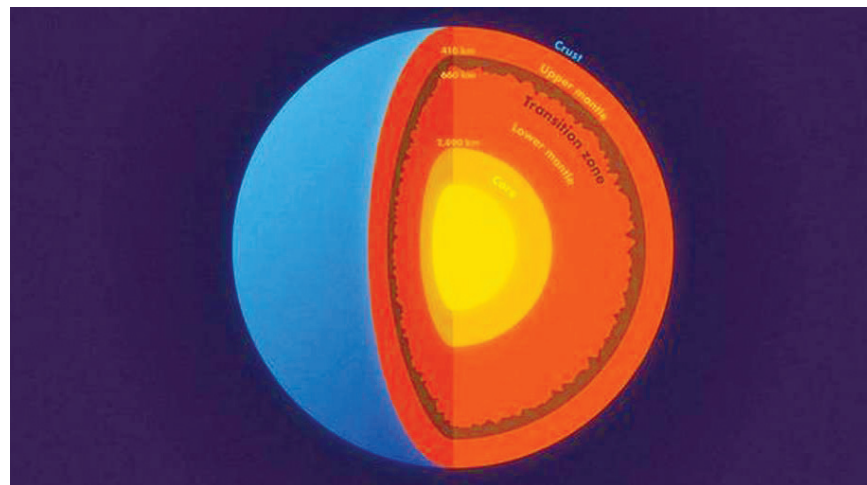
While that is not wrong, it does leave out several other layers that scientists have identified within the Earth.

In a study published in the journal Science, scientists used data from an enormous earthquake in Bolivia to find mountains and other topography on a layer located 660 kilometers straight down, which separates the upper and lower mantle.

Lacking a formal name for this layer, the researchers simply call it "the 660-km boundary."

To peer deep into the Earth, scientists from the Princeton University in the US and the Institute of Geodesy and Geophysics in China, used the most powerful waves on the planet, which are generated by massive earthquakes.

Data from earthquakes that are magnitude 7.0 or higher send out



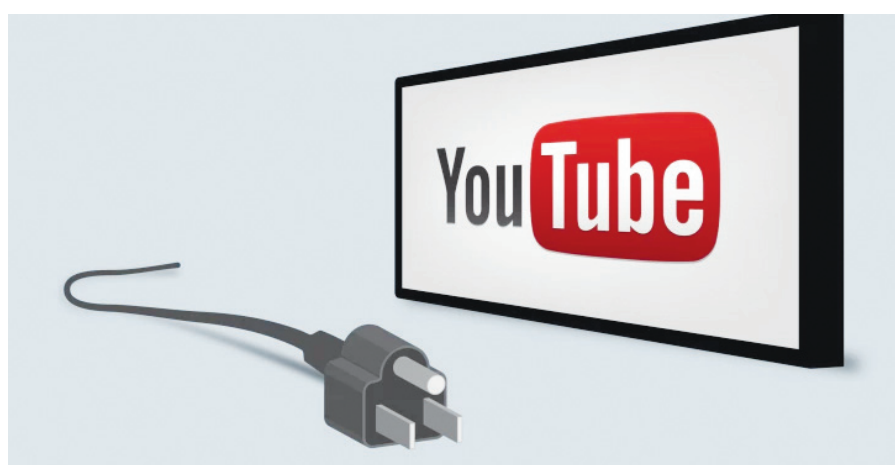
shockwaves in all directions that can travel through the core to the other side of the planet—and back again.

For this study, the key data came from waves picked up after a magnitude 8.2 earthquake—the second-largest deep earthquake ever recorded—that shook Bolivia in 1994. Scientists used powerful computers to simulate the complicated behaviour of scattering waves in the deep Earth. The technology depends on a fundamental property of waves: their

ability to bend and bounce.

Just as light waves can bounce (reflect) off a mirror or bend (refract) when passing through a prism, earthquake waves travel straight through homogenous rocks but reflect or refract when they encounter any boundary or roughness. "We know that almost all objects have surface roughness and therefore scatter light," said Wenbo Wu, who was at Princeton at the time of the study. *Source: PTI*

YouTube revamps Strike rules, intensifies punitive action



Google-owned video sharing platform YouTube has revamped its community guidelines and after almost a decade, updated its Strike rules.

"Starting February 25, all channels will receive a one-time warning the first time they post content that crosses the line, with no penalties to their channel except for the removal of that content," the YouTube team wrote in a blog-post on Tuesday.

Under the new guidelines and Strike rules, the first strike would result in a one-week freeze on the ability to upload any new content to YouTube, including live streaming. The second strike in any 90-day period will result in a two-week freeze and the third strike would result in channel termination.

Moreover, the platform is expanding its policy resources aiming to provide more details about what behaviour could result in a strike. "We always want to make it

clear why a strike occurred, hence we're making our email and desktop notifications clearer to provide more details on which policy was violated," the post said.

YouTube is also adding new mobile and in-product notifications to highlight important information on strikes.

"Our strikes system is an important way for us to help creators and artists understand when they've crossed the line by uploading content that undermines that goal. We'll build on this and all the progress we've made over the last year by continuing to consult with you as we strengthen enforcement and update our policies," the post added.

Copyright strikes will continue to be issued when YouTube receives legal requests from rights holders, will not offer a warning strike and follow the company's separate penalty system detailed on the copyright strike page. *Source: IANS*

WhatsApp's bug lets anyone bypass Face ID, Touch ID lock on iPhones

WhatsApp recently rolled out long-awaited biometric support for iPhone users. The feature allows users to add another layer of privacy by adding Touch ID or Face ID lock. WhatsApp's new feature is now facing a critical bug in less than a few weeks of its roll out.

According to a Reddit threat, the bug allows anyone to bypass the additional security layer when using the WhatsApp share shortcut on any other application. The bug works when users have set authentication kick-in time to after in minute, after 15 minutes and after 1 hour.

The feature works perfectly when a user has set the kick-in time to "immediately." In simpler terms, WhatsApp does not show the additional security layer when using the sharing extension, reported Gadgets360. "While transitioning to the next screen, you observe that no FaceID or TouchID verification takes place if an option other than 'Immediately' was set previously. Now just exit out to the iOS Home Screen. (If in some cases, it asks for FaceID or TouchID verification, just cancel it and try clicking on WhatsApp icon in the iOS Share Sheet again)."



Venezuelan oil finds home in India as US shuns shipments

India is feasting on Venezuelan oil, after the U.S. imposed a de facto ban on crude imports from the Latin American nation.

While flows to the U.S. came to a halt, India became the No. 1 buyer of Venezuelan crude in the first half of February, with imports jumping 66 percent to 620,000 barrels a day. Indian refiners Reliance Industries Ltd and Nayara Energy Ltd, which is backed by Rosneft Oil Co PJSC, are driving the boost.

Still, Venezuelan crude exports have plunged since U.S. President Donald Trump ratcheted up sanctions against the country's oil company. Shipments of oil, the commodity that bankrolls the regime of embattled president Nicolas Maduro, fell to 1.12 million barrels daily in the first half of February, down 9.2 percent compared with the same period in January. No U.S.-bound vessels have left Venezuelan ports in that time.

CENTRE CLEARS PLAN TO INFUSE RS 48,000 CRORE IN 12 STATE-OWNED BANKS

NEW DELHI (TIP): The finance ministry Wednesday announced to pump in Rs 48,239 crore in 12 public sector banks in this fiscal to help them maintain regulatory capital requirements and finance growth plans.

Financial Services Secretary Rajiv Kumar said that the government will infuse Rs 9,086 crore in Corporation Bank and Rs 6,896 crore in Allahabad Bank -- the two "better-performing" banks currently under the Prompt Corrective Action (PCA) supervision of the RBI.

Further, Rs 4,638 crore and Rs 205 crore will be provided to Bank of India and Bank of Maharashtra. These banks have recently come out of the regulatory supervisory framework PCA of the RBI.

Kumar further said Punjab National Bank will get Rs 5,908 crore, Union Bank of India Rs 4,112 crore, Andhra Bank Rs 3,256 crore and Syndicate Bank Rs 1,603 crore.

The government will pump in Rs 12,535 crore in four other banks under PCA -- Central Bank of India, United Bank, UCO Bank and Indian Overseas Bank. The government in December had infused Rs 28,615 crore into seven public sector banks (PSBs) through recapitalisation bonds.

Samsung launches folding smartphone, first 5G handset

Samsung on Wednesday unveiled a smartphone that folds open to be a tablet, becoming the first major manufacturer to offer the feature as it strives to stoke excitement in a slumping market.

The South Korean giant also appeared to get the jump on rivals by announcing the first smartphone for fifth-generation --or 5G--wireless networks, while stepping up its efforts in artificial intelligence and wearables.

The Galaxy Fold, unveiled at a San Francisco event, serves as a smartphone with a 4.6-inch display and opens like a book to become a 7.3-inch tablet.

"We are giving you a device that



doesn't just define a new category, it defies category," said Samsung's Justin Denison at the event. The Fold will be available from April 26 starting at USD 1,980, the company said. The launch comes as the smartphone market experiences its worst-ever decline with consumers keeping devices longer and waiting for new innovations.

Samsung made the announcement on the home turf of rival Apple, with the two giants battling in the premium segment of the market.

Denison touted the Fold as "a one-of-a-kind luxury device" and boasted that it let three apps operate simultaneously on its large screen.

Bitcoin gets a delayed boost after JPMorgan embraces cryptocurrencies

Bitcoin is approaching \$4,000 for the first time since the start of the year, as the largest cryptocurrency gets a delayed boost from the announcement last week that JPMorgan has developed a prototype digital coin that it plans to use to speed up payments between corporate customers.

"What some people have pointed to is that because they're using distributed ledger technology and they're calling it a cryptocurrency, that could have a positive effect on the industry," said Mati Greenspan, senior market analyst at eToro in Tel Aviv.

Greenspan credited a jump in Ethereum over the weekend tied to the production of coins for helping to create an optimistic environment that pushed most crypto prices higher. Ether rose 17 % Monday, and was up 3.6 % to around \$146 as of 10:30 a.m. in New York. Bitcoin climbed as much as 3.1 % Tuesday to \$3,970.

At least one measure followed by technical analysts suggests Bitcoin has more room to run, with the digital token in a solid buy trend for the first time since mid-December.

In addition, the VERA Convergence Divergence indicator turned positive today for the first time in over two months,



indicating this rally may take Bitcoin over the heavily resisted \$4,000 level. The last time Bitcoin triggered a buy signal it gained \$1,100 over the next 10 days. *Source: Bloomberg*



GOOGLE TO ACQUIRE DATA MIGRATION COMPANY 'ALOOMA'

Alphabet Inc's Google said on Tuesday it will buy data migration company Aloomo, as part of efforts to catch up with bigger cloud service rivals Amazon.com Inc and Microsoft Corp.

Google trails Amazon and Microsoft in the fast-growing business of helping companies move to the cloud, with Google Cloud holding 8.5 % of worldwide cloud market share at the end of 2018, according to Canalis.

Amazon Web Services had a 31.7 % share and Microsoft Azure 16.8 % during the same period, the market research firm said.

Google in November hired former Oracle Corp product head Thomas Kurian as the chief executive officer of the cloud division.

Headquartered in Redwood City, California, Aloomo helps enterprise companies streamline database migration in the cloud with a tool that enables moving data from multiple sources to a single data warehouse.

The company has raised about \$15 million from investors including leading venture funds such as Sequoia Capital and Lightspeed, according to Crunchbase. Google did not disclose terms of the deal. *Source: Reuters*

AGNI: THE HINDU FIRE GOD

Agni, the god of Fire, is one of the most prominent of the deities of the Vedas. With the single exception of Indra, more hymns are addressed to Angi than to any other deity. To this day, Agni forms a part of many rites-of-passage ceremonies for Hindus, including birth, marriage and death.

The Origin & Appearance of Agni

In legend, various accounts are given of the origin of Agni. By one account, he is said to be a son of Dyaus and Prithivi. Another version says he is the son of Brahma, named Abhimani. By yet another account he is reckoned amongst the children of Kasyapa and Aditi, and hence is one of the Adityas. In the later writings, he is described as a son of Angiras, king of the Pitris (fathers of mankind), and the authorship of several hymns is ascribed to him.

In artwork, Agni is represented as a red man, having three legs and seven arms, dark eyes, eyebrows and hair. He rides on a ram, wears a poita (Brahmanical thread), and a garland of fruit. Flames of fire issue from his mouth, and seven streams of glory radiate from his body.

It is hard to overestimate the importance of Agni in Hindu religious practice and belief.

The Many Hues of Agni

Agni is an immortal who has taken up his abode with mortals as their guest. He is the domestic priest who rises before the dawn; he embodies a purified and intensified form of the sacrificial duties assigned to various human functionaries.

Agni is the most divine of the sages and is intimately acquainted with all the forms of worship. He is the wise director and the protector of all ceremonies, who enables men to serve the gods in a correct and acceptable manner.

He is a swift messenger moving between heaven and earth, commissioned both by gods and men to maintain their mutual communication. He both communicates to the immortals the hymns and offerings of earthly worshippers, and also brings the immortals down from the skies to the place of sacrifice. He accompanies the gods when they visit the earth and shares in the reverence and adoration they receive. He makes human offerings tangible; without him, the gods experience no satisfaction.

The Uniqueness of Agni

Agni is the lord, protector, and king of men. He is the lord of the house, dwelling in every abode. He is a guest in every home; he despises no man and he lives in every family. He is therefore considered as a mediator between gods and men and a witness of their actions. To the present day, Agni is worshiped and his blessing sought on all solemn occasions, including birth, marriage, and death.

In the old hymns, Agni is said to dwell in the two pieces of wood which produce fire when rubbed together--the living being that springs out of dry, dead wood. As the poet says, as soon as he is born the child begins to consume his parents. Agni's growth is seen as a marvel, since he is born to a mother who cannot nourish him, but instead receives his nourishment from offerings of clarified butter poured into this mouth.

The Might of Agni

The highest divine functions are ascribed to Agni. Although in some accounts he depicted as the son of heaven and earth, in others he is said to have formed heaven and earth and all that flies or walks, stands or moves. Agni formed the sun and adorned the heavens



with stars. Men tremble at his mighty deeds, and his edicts cannot be resisted. Earth, heaven, and all things obey his commands. All the gods fear and do homage to Agni. He knows the secrets of mortals and hears all invocations addressed to him.

Why do Hindus Worship Agni?

The worshippers of Agni will prosper, be wealthy and live long. Agni will watch with a thousand eyes over the man who brings him food and nourishes him with offerings. No mortal enemy can gain mastery over the person who sacrifices to Agni. Agni also confers immortality. In a funeral hymn, Agni is asked to use his heat to warm the unborn (immortal) part of the deceased and to carry it to the world of the righteous.

Agni carries men across calamities, as a ship over the sea. He commands all the riches in earth and heaven and therefore is invoked for riches, food, deliverance and all other forms of temporal good. He also forgives any sins that may have been committed through folly. All gods are said to be included within Agni; he surrounds them as the circumference of a wheel does the spokes.

Agni in Hindu Scriptures & Epics

Agni appears in many epic Vedic hymns.

In a celebrated hymn of the Rig-Veda, Indra and the other gods are called upon to destroy the Kravyads (the flesh-eaters), or Rakshas, enemies of the gods. But Agni himself is a Kravyad, and as such he takes an entirely different character. In this hymn, Agni exists in a form as hideous as the beings he has been called upon to devour. Nevertheless, he sharpens his two iron tusks, puts his enemies into his mouth and devours them. He heats the edges of his shafts and sends them into the hearts of the Rakshas.

In the Mahabharata, Agni is exhausted by

devouring too many offerings and wishes to restore his strength by consuming the whole Khandava forest. Initially, Indra prevents Agni from doing this, once Agni obtains the assistance of Krishna and Arjuna, he baffles Indra, and accomplished his goal.

According to the Ramayana, in order to assist Vishnu, when Agni is incarnate as Rama, he becomes the father of Nila by a monkey mother.

Finally, in Vishnu Purana, Agni marries Swaha, by whom he has three sons: Pavaka, Pavamana, and Suchi.

The Seven Names of Agni

Agni has many names: Vahni (who receives the hom, or burnt sacrifice); Vitihotra, (who sanctifies the worshipper); Dhananjaya (who conquers riches); Jivalana (who burns); Dhumketu (whose sign is smoke); Chhagaratha (who rides on a ram); Saptajihva (who has seven tongues).

Me and My God: Guru Nanak Enlightened Me on the Walls of Separation

To date, we are among the oceans of knowledge that religion and science have amassed in front of us. It is because of that expansion in the knowledge that we also seem to be at the verge of really seeing God. It is in the vortex of that knowledge by which I comprehend Nanak telling me that the reality of creation is the home in which God lives, manifested, and revealed.

Five hundred fifty years ago, in 1469, Guru Nanak appeared on this earth. With him, he brought the Divine Wisdom to shine on this earth. He named it "Gurmat." Whereas Gurmat showed us, God, it also pointed out two walls or prevailing deceptions that keep us separated from God. These walls of separation are harder than steel to break.

It was during a study circle at the Gurdwara of the Medical College Amritsar in 1951 or so that Dr. Harbhajan Singh asked this question, "Will the predicted expansion of knowledge in science hurt or help the spread of Sikhism worldwide?" Putting it another way, will scientists be attracted to Sikhi or they will begin ignoring it.

The late Dr. Harbhajan Singh was the Professor of Surgery, and the Study Circle was a regular weekly feature of the Gurdwara.

My answer was that, undoubtedly, the expansion of knowledge about the universe and the natural laws would help Sikhi to attract more adherents.

My answer was considered so startling that it was reported by the major Sikh newspaper of the day because most people in those days believed that modern science and education would drive people towards atheism and agnosticism. Moreover, the Sikh youth, in particular, will be impacted adversely; they will abandon Sikhism. So much so that many parents would not send their children to college for fear of their abandoning Sikhi.

Guru Nanak and the Expanse of Knowledge

Since the days of those Amritsar study circles, our knowledge of the creations has expanded substantially; billions of Galaxies, new worlds in Blackhole, intelligence in the brain and heart cells, on and on. I have been in the thick of it. I obtained my doctorate in Biomedical Sciences, and since then I pursued the scientific discoveries as my profession as well as my pastime.

Further, I was born in the house of Guru Nanak. That is a story in itself that I published elsewhere (Sikh Review). Here I must acknowledge that I am one of many who is and had been overwhelmingly grateful to be blessed with the association of Guru Nanak for the past 550 years. It makes me humble every day as I appreciate intriguing Guru

Meeting the Guru, Says Nanak, now comprehended my Icon of Worship. I see The Perfect Architect of Creations pervading and permeating the water, the land, and the sky.

Nanak invented an icon in which he embedded the implication of the above verse. We exhibit it prominently in all our religious places and at homes. It is ?- EkOnkaar. It literally means, One Reality manifested in all creations.

Walls Between Me and My God

Five hundred fifty years ago, in 1469, Guru Nanak appeared on this earth. With him, he brought the Divine Wisdom to shine on this earth. He named it "Gurmat." Whereas Gurmat showed us, God, it also pointed out two walls or prevailing deceptions that keep us separated from God. These walls of separation are harder than steel to break.

Wall of Narcissism

Narcissism or egotism closes the human mind so that we think that we know it all and we are the center of everything. As said Deepak Chopra, "the ego is not who you really are. The ego is your Self-image; it is your social mask; it is the role you are playing. Your social mask thrives on approval. It wants control, and it is sustained by power because it lives in fear". Thus, our narcissism becomes a wall between us and our Creator.

To learn more on ego, I may direct you to read Dr. IJ Singh (<http://www.sikhnet.com/news/little-ego-may-be-good-thing>). Here I emphasize that narcissism is a wall that separates us from our Creator. Guru told us of this wall as the following verse.

ਧਨ ਪਿਰ ਕਾ ਇਕ ਹੀ ਸੰਗਿ ਵਾਸਾ ਵਿਚਿ ਹਉਮੈ ਭੀਤਿ ਕਰਾਰੀ SGGS, p.1263

The soul-bride and the Divine spouse live together as one, but there is a hard wall of egotism standing between them. The closed-mindedness barricades the path to reach the Creator even when He is manifested in the creation around us.

Walls of Religiosities Invented by Professional Clergy

Although not intended by the founders of various religions, definitely not by the Founders of Sikhi, the professional clergies have attained a status of God's ambassadors or agents in every religion. In Sikhism, they are known as Baba, Bhai, Granthi, Saint, etc. Invariably, they are ill-educated. They bring into the religion, worst kind of religiosity.

These clergies scare the congregations into modes of worshiping the SABD Guru as the SABD was a human deity. For example, they invoke their deity with a variety of tasty foods, expensive clothing, and currency. Their anthropomorphic Guru needs heating and cooling of the room, expensive bedding, and restriction on access. Some ban the Guru from traveling overseas. Some are known to prescribe specific language to communicate, discuss, or do vichaar. Similarly, some promote specific dress culture that is ethnic and not universally adaptable.

The Guru condemned such inroads of religiosity in the harshest language. Let me cite a few examples of Guru's disapproval; SGGS says:

ਵੇਸ ਕਰੇ ਕੁਰੁਪਿ ਕੁਲਖਣੀ ਮਨਿ ਖੋਟੈ ਕੁਤਿਆਰਿ ॥ ਪਿਰ ਕੈ ਭਾਣੈ ਨਾ ਚਲੈ ਹੁਕਮੁ ਕਰੇ ਗਾਵਾਰਿ SGGS p.89

She may wear good clothes, but the bride is still ugly and rude when her mind is false and impure. When the spouse does not walk in harmony with the Will of the God spouse, it is foolish to ask for favors.

ਕਰਿ ਪੰਜੀਰ ਖਵਾਇਓ ਚੋਰ ॥ ਉਹੁ ਜਨਮਿ ਨ ਮਰੈ ਰੇ ਸਾਕਤ ਵੋਰ SGGS, p. 1136

You prepare sweet treats and feed them to your stone god. God is not born, and He does not die, you foolish, faithless cynic!

ਪੰਡਿਤ ਮੁਲਾਂ ਜੋ ਲਿਖਿ ਦੀਆ ॥ ਛਾਡਿ ਚਲੇ ਹਮ ਕਛੁ ਨ ਲੀਆ SGGS, p.1159

Whatever the Pandit and the Mullan have written (the path of religiosity), I have abandoned all of that; I have not taken any of it.

(India had moved the 1267 Sanctions Committee to ban Azhar twice before in 2009 and 2016). On Tuesday, UN Secretary General António Guterres had called on India and Pakistan to defuse tensions and for "meaningful mutual engagement."

Condemning terrorism in all its forms as one of the most serious threats to international peace, the UNSC offered its condolences to those impacted by the attack.

"The members of the Security Council expressed their deepest sympathy and condolences to the families of the victims, as well as to the Indian people and the government of India and wished a speedy and full recovery to those who were injured," the statement said.

In what appears to be a thinly veiled reference to Pakistan, the Council has asked countries to cooperate actively with the Government of India.

"The members of the Security Council underlined the need to hold perpetrators, organizers, financiers and sponsors of these reprehensible acts of terrorism accountable and bring them to justice, and urged all States, in accordance with their obligations

under international law and relevant Security Council resolutions, to cooperate actively with the Government of India and all other relevant authorities in this regard," the statement read.

"The members of the Security Council reiterated that any acts of terrorism are criminal and unjustifiable, regardless of their motivation, wherever, whenever and by whomsoever committed. They reaffirmed the need for all States to combat by all means, in accordance with the Charter of the United Nations and other obligations under international law, including international human rights law, international refugee law and international humanitarian law, threats to international peace and security caused by terrorist acts," it said.

Mueller could submit report to...

After the expected announcement, U.S. Attorney General William Barr will review Mr. Mueller's findings and submit his own summary to Congress, CNN reported. Democrats have been concerned that Mr. Barr, who has discretion over what is ultimately made public, will choose to limit disclosure.

Under Special Counsel regulations, Mr. Mueller must submit a confidential report to

the Attorney-General. Mr. Barr, in turn, is required to provide information on the report to the judiciary committees of Congress.

Pak bans Hafiz Saeed-led JuD...

amid intense global pressure to rein in the militant groups following the Pulwama terror attack that killed 40 CRPF jawans.

A spokesman of the Interior Ministry said the decision to ban these groups was taken during a meeting of the National Security Committee (NSC) chaired by Prime Minister Imran Khan at his office on Thursday.

"It was decided during the meeting to accelerate action against proscribed organizations," the spokesperson said in a statement.

"It was further decided that Jamat-ud-Dawa and Falah-e-Insaniat Foundation be notified as proscribed organizations by the Ministry of Interior," he added.

Earlier, the two outfits were kept on the watchlist of the interior ministry.

According to officials, JuD's network includes 300 seminaries and schools, hospitals, a publishing house and ambulance service. The two groups have about 50,000 volunteers and hundreds of other paid workers.

The JuD is believed to be the front organization for the LeT which is responsible for carrying out the Mumbai attack that killed 166 people. It has been declared as a foreign terrorist organization by the US in June 2014.

The US Department of the Treasury has designated its chief Saeed as a Specially Designated Global Terrorist, and the US, since 2012, has offered a USD 10 million reward for information that brings Saeed to justice.

Saeed was listed under UN Security Council Resolution 1267 in December 2008. He was released from house arrest in Pakistan in November 2017.

The NSC meeting also reviewed the National Action Plan against terrorism in detail. Services chiefs and key ministers were in attendance.

"We need to move to ensure that militancy and extremism are rooted from the society and the State never becomes hostage to extremists," Khan said as he directed both the interior ministry and the security institutions to immediately accelerate actions on ground. (Source: PTI)

Sadhguru calls upon youth to...

We have to create business friendly environment for all. We have to invest in various areas and create livelihood", said Sadhguru on February 17, at the 16th edition of India Conference, one of the largest student-run conferences focusing on India in the USA. One of the most enlightened persons of our time, Sadhguru said population growth and unequal distribution of wealth must lead to migration, and no walls or barriers could stop the influx.

Asked to comment on the subject of rape, Sadhguru said, "We have to deal with it in a sensible way. This is not a social issue - it's a human issue. This debate has to come".

On democracy in America, Sadhguru said he believed there is no democracy in the United States. "It's feudalism", he said. "My father was a Republican so am I. Same for the Democrats. How is it democracy? Every citizen has the right to express own opinion. I don't want to take any political side. If one individual can move million votes - that means we are going back to feudalism not democracy. The idea of democracy and secret ballot is that every person will decide on his/her own and cast the vote. Political party membership should be taken away. Political parties should not enroll members because people are voting for you without looking at what you have done. Every five years we must evaluate what politicians have done - should I give them another chance or not. I support this party and I will vote for them without judging their work - this is feudalism. This destroys fundamental democratic fabric".

On the issue of marriage and relationship between man and woman, husband and wife, Sadhguru quipped; "Be it marketplace or marriage - for any relationship to sustain it has to be beneficial for both parties. Unless it benefits both, the business won't last long".

NEERGARH FALLS

Visit Neergarh Waterfall just after monsoon season and you will witness water cascading thousands of feet from the mountain top. There are small pools along the hike where a hiker can sit and enjoy the serenity of falls, while soaking the tired feet. You can also consider taking a dip into the pool of fresh water. Trekking through Neergarh waterfall and passing by shallow pool will give you a feel and touch of what the state of Uttarakhand is all about. Vendors are also available here to sell the beverages, which will cost slightly higher but a cup of tea in hand will be a good idea to enjoy the surreal beauty of the place.

NEELKANTH TEMPLE

There are steep & narrow roads taking above the hill, which will add the extra spice of adventure amidst the beauty. There is river flowing on one side and mountain terrain is on the other side. Road is very curvy and narrow with steep slopes.

TREKKING

Trekking is all about reconnecting yourself with nature and exploring the wonders of the Himalayas. For adventure enthusiasts, it is a much sought after option to escape the daily mundane life to find themselves in the lap of nature. Walking through verdant landscape, lush greenery and waterfall, and breathing in fresh air really prove to be a refreshing experience. Located in the lap of the Shivalik Himalayas, the picturesque town of Rishikesh offers a host of scenic locales for trekkers. It gives the trekker a chance to witness the outstanding scenery of flowery green meadows, dense forests, fascinating local communities and astounding landscape of the eastern part of the Garhwal Himalayan ranges. There are all sorts of treks available near Rishikesh, which can be categorised into easy, moderate and hard treks. Small treks can be done in the adjoining villages and waterfalls while longer treks can be taken in near-by mountains. Few famous treks which can be

taken near Rishikesh are Neer Garh waterfall trek, Kunjapuri trek, Neelkanth Temple Trek, and Jhilmil Gufa Trek. Longer treks which serve route from Rishikesh are Gomukh (Gaumukh) Trek, Valley of flower Trek, Tungnath-Chandrasheela Trek, Deoria Taal Trek, Hemkund sahib trek, Kuari Pass Trek and Roop Kund Trek.

DEVPRAYAG

In Sanskrit, prayag means 'confluence' and Devprayag stands for 'holy confluence'. Devprayag is the confluence of two holy rivers Alaknanda and Bhagirathi to form Ganga. According to religious scriptures, Devprayag is one of the five important holy confluences. Rivers like Bhagirathi, Alaknanda & the mythological river Saraswati (flowing underground) meet to form the River Ganga. River Bhagirathi originates from Gangotri and Alaknanda originates from Badrinath, both of which are considered sacred destinations for Hindus across the world. Devprayag is the last prayag of River Alaknanda. Religiously, the site is very sacred and holds immense significance among the Hindu followers. It is believed that Lord Rama and the King Dushratha did penance here. There is an ancient temple of Raghunathji built above the confluence with massive rocks. It is believed that the temple was built more than ten thousand years ago. There is a small water spring called Baitalshila, which is believed to have powers to cure leprosy. Devprayag is also hugely blessed with divine natural beauty and showers tourists with its serenity. The place is accessible throughout the year and can be visited anytime.

RAJAJI NATIONAL PARK

Rajaji National Park is known for its pristine scenic beauty and rich bio-diversity. A paradise for nature lovers and wildlife enthusiasts, Rajaji National Park or Chilla Park is just 25 km away from Rishikesh. A normal safari by jeep usually takes 3 to 4 hours to complete the 36 km stretch of safari range and costs around Rs. 1200-1500 per person. It is carried out twice in a day; at 7 am in the morning and around 2 pm in the afternoon. Rajaji National Park is home to Asian elephants, deers, birds, tigers (only few), and antelopes such as the Nilgai, langoors etc. This park is the first staging ground for the migratory birds when they cross Himalayas to enter India.



IPL: BCCI announces schedule for 2 weeks, CSK to play RCB in opener

NEW DELHI (TIP): Defending champions Chennai Super Kings will take on Royal Challengers Bangalore in the opening encounter of the 12th Indian Premier League for which a provisional two-week schedule was announced by the BCCI on Tuesday.

The opening game has been scheduled for March 23 in Chennai, the BCCI announced in its schedule comprising 17 games.

The IPL will be off to an earlier-than-usual start this year owing to the general elections, dates of which are yet to be announced. Any change in the provisional itinerary—from March 23 to April 5 — will be revised accordingly.

“These are still subject to the announcement of the Lok Sabha 2019 election dates. Once these have been released, the BCCI will address any issues with the first two weeks and will also prepare a schedule for the remainder of the season working with the local authorities around the polling dates,” read an official statement from the IPL.

On March 24, Kolkata Knight Riders will host Sunrisers Hyderabad in the afternoon encounter of a double header in which Mumbai Indians will take on Delhi Capitals in Mumbai.

Rajasthan Royals and Kings XI Punjab will meet each other in Jaipur to complete the first round of games.

A total of 17 matches will be played during this two-week phase across the 8 home venues of the respective franchises.

All teams will play a minimum of four games with Delhi Capitals and RCB competing in five matches each during this time. Every side will play a



minimum of two home and two away matches except for Delhi and RCB.

While Delhi will compete in three home games, RCB will play an equal number of away encounters.

While the weekends will have double-headers but the schedule doesn't clarify whether the BCCI will continue with the usual 4 pm (afternoon) and 8 pm (evening) format or there will be a change in timing.

INDIA EVES LOOK TO DOMINATE ENGLAND AFTER SUCCESS IN NEW ZEALAND

MUMBAI (TIP): Indian women will plunge into the three-game ODI rubber against England evens here on Friday with their confidence bolstered by their recent 2-1 series victory against New Zealand in the latter's backyard.

With it being a short series, the outfit that wins the opening game, will be at a big advantage going into the next two clashes with all of them to be played at the Wankhede Stadium as part of the ICC Championship.

The hosts cannot afford to take England lightly, as the visiting team boasts of some big names in women's cricket.

Opener Smriti Mandhana, who amassed 196 runs including a hundred and a 90 in New Zealand, will be a key player with the bat for the Indian women's team.

There are others too such as the experienced captain Mithali Raj, the first woman cricketer to appear in 200 ODIs.

However, the hosts will miss the aggressive Harmanpreet Kaur, who was ruled out of the entire series with an ankle injury and has been replaced by Harleen Deol.

Then there is also the young Jemimah Rodrigues to shore up the home teams batting.

It would be interesting to see whether Rodrigues or Punam Raut, who played her last ODI against Sri Lanka in September 2018, gets a look in.

The Mithali Raj-led team has had middle-order issues in the past and newly-appointed coach W V Raman would be keen to sort them as quickly as possible.

But the hosts would not have an easy outing facing the English attack.

The Indian bowling has an all-round look with the pace attack being led by veteran Jhulan Goswami and also comprising the likes of Shikha Pandey and Mansi Joshi.

With spin being a key element on Indian wickets, the role of slow bowlers Deepti Sharma, Ekta Bisht and Poonam Yadav in the middle overs would be crucial.

England evens, on the other hand, are a force to reckon with in the 50-over format. They have experienced campaigners in the top-order such as Danni Wyatt (746 runs in 61 matches) and 28-year-old Heather Knight.

Heather, with 2,331 runs to her credit in 86 ODIs, displayed good form in the practice game against the Board Presidents XI and showed her anchoring capabilities.

With all-rounders like Sophie Ecclestone, experienced pacer Anya Shrubsole and accurate medium pacer Nat Sciver in the reckoning, England has the bowling attack to trouble the hosts.

Anya would also take confidence from her four wicket haul in the warm-up game.
