Senate Rejects by a 59-41 Vote Trump's emergency declaration

Trump tweets: Look "forward to VETOING the just passed Democrat inspired Resolution"

WASHINGTON (TIP): The Senate passed a resolution March 14 to overturn President Donald Trump's declaration of a national emergency at the U.S.-Mexico border. Twelve Republicans joined 47 Democrats in voting to pass the resolution. By a 59-41 votes, the Senate passed the resolution disapproving the president's February national emergency declaration over the "border crisis." The House earlier passed the resolution by a 245-182 margin (13 Republicans abandoned the president on that vote).

The 12 GOP Senators who voted for the resolution blocking Trump's emergency declaration are Lamar Alexander, Susan Collins, Mike Lee, Lisa Murkowski, Roy Blunt, Rand Paul, Pat Toomey, Rob Portman, Jerry Moran, Marco Rubio, Roger Wicker, and Mitt Romney.

"A vote for today's resolution by Republican Senators is a vote for Nancy Pelosi, Crime, and the Open Border Democrats", Trump took to his Twitter account to rebuke potential defector. When the bill moves to his desk, Trump will likely issue his first veto of his presidency. **contd on Page 32**

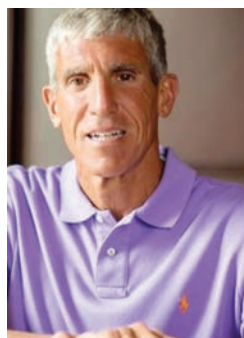
Norway MPs want Nobel Peace prize for student climate campaigner Greta

CEOs, Actresses among others arrested in Nationwide College Admissions Scam

LOS ANGELES (TIP): Dozens of individuals involved in a nationwide conspiracy that facilitated cheating on college entrance exams and the admission of students to elite universities as purported athletic recruits were arrested by federal agents in multiple states on March 12 and charged in federal court in Boston. Athletic coaches from Yale, Stanford, USC, Wake Forest and Georgetown, among others, are implicated, as well as parents and exam administrators.

William "Rick" Singer, 58, of Newport Beach, Calif., was charged with racketeering conspiracy, money laundering conspiracy and obstruction of justice. Singer owned and operated the Edge College & Career Network LLC ("The Key") - a for-profit college counselling and preparation business **contd on Page 32**

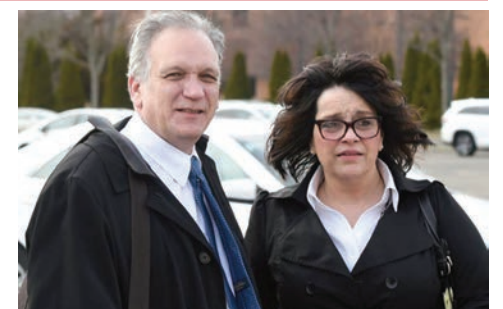

NEW YORK (TIP): Paul Manafort, President Donald Trump's former campaign chief, was indicted March 13 for a year-long residential mortgage fraud scheme through which Manafort and others falsified business records to illegally obtain millions of dollars, Manhattan District Attorney Cyrus R. Vance, Jr. announced. New York prosecutors announced the criminal charges against him only minutes after his sentencing in a federal case to 43 months of additional prison time. **contd on Page 32**

Former Nassau County Executive Edward Mangano and wife Linda convicted in Bribery case

MINEOLA, NY (TIP): A federal jury convicted former Nassau County Executive Edward Mangano and his wife Linda on March 8 of corruption charges. Following a seven-week trial, the jury in Central Islip, New York, returned guilty verdicts against Mangano on multiple counts of accepting bribes and kickbacks in exchange for official government action, and for conspiracy to obstruct justice. 'Extremely Close' On Criminal Justice Changes, says Senate Majority Leader Andrea Stewart-Cousins

NEW YORK (TIP): State lawmakers "are extremely close" to forging a deal on criminal justice law changes that include ensuring a speedy trial, changing how evidence during discovery is handled and a curtailment of cash bail, Senate Majority Leader Andrea Stewart-Cousins said Thursday, March 14, in a radio interview.

"We are extremely close, extremely close in the discovery, in speedy trial, a lot closer on bail," she said on WNYC's *The Brian Lehrer Show*. "We understand that what we do is going to impact the lives of so many people incarcerated. So we want to get it right. We want to make sure it really reforms the criminal justice system in ways that will protect the innocent and make sure that people who should be in jail are in jail."

This is contrary to Gov. Andrew Cuomo's public comments that the Legislature is far apart on the issue that he wants included in a final version of the state budget, due at the end of the month. Stewart-Cousins, as well as legislators who want to see the changes made this session, have said they are trying to take their time in order to get the details "right" on the issue - satisfying both criminal justice advocates as well as prosecutors and law enforcement officials who raised concerns.

Meanwhile, the legalization of marijuana in the budget appears to be increasingly falling out of the talks.

"I'm interested in making sure that whatever we do we do it in a way that makes sense," Stewart-Cousins said Thursday. "Obviously this is a new industry for us, it would be a new market for us. This is not a rush to make sure this just gets done."

He has testified in Sacramento on behalf of the office to advocate for these policy changes.

Indian Women Activists Honored by Harvard Law School

BOSTON (TIP): Activist Sudha Bharadwaj and lawyer Menaka Guruswamy were among 21 women honored by the Harvard Law School this year through a portrait exhibition on the occasion of International Women's Day. Bharadwaj was arrested in the Bhima Koregaon case in August and is currently in a prison in Pune. Guruswamy argued in Supreme Court against parts of Section 377 that criminalized homosexual activity. The portrait exhibit showcased the "astounding contributions of women around the world to the areas of law and policy". This year's exhibit had 21 honorees, each of whom were nominated by Harvard Law School students, faculty or staff. The women featured in the exhibit are "powerful voices in their respective fields, whether they are sitting on a high court bench, standing in front of a classroom, or marching in the streets". Bharadwaj is a human rights lawyer who has worked for several decades in Chhattisgarh. She was arrested in connection with an investigation into a public meeting that was organized before caste-related violence erupted at Bhima Koregaon near Pune on January 1, 2018. Guruswamy, a BR Ambedkar Research Scholar and a lecturer at Columbia Law School, was one of the lawyers who argued against Section 377 of the Indian Penal Code which criminalized "sex against the order of nature". In September 2018, a Constitution Bench of the Supreme Court decriminalized homosexual activity between consenting adults, which was punishable by up to 10 years in jail according to Section 377.

BOSTON (TIP): Vinod Khosla, the co-founder of Sun Microsystems and chairman of Khosla Ventures, described his thoughts on how to tackle the world's most challenging problems while addressing an MIT audience earlier this month. On March 6, Khosla had a "fireside chat" with Dennis Whyte, the Hitachi America Professor of Engineering, head of the Department of Nuclear Science and Engineering, and director of the Plasma Science and Fusion Center. The discussion was the 2019 David J. Rose Lecture, an event dedicated to the memory of a longtime professor of nuclear engineering and pioneer of fusion research. Vinod Khosla feels that when it comes to tackling the really big problems facing the world - providing enough food, water, energy, and meaningful work for a growing population - "some problems are too important not to work on," he said. "Let's not focus on the probability of success, let's focus on the consequences of success." Last year, Khosla became one of the initial investors in a company established to develop MIT's pioneering approach to producing practical fusion power. Source - MIT News

It's Tax time



Tax Time Guide from IRS

Protect personal, financial and tax information

WASHINGTON (TIP): The Internal Revenue Service today urged taxpayers to protect the security of their personal, financial and tax information. Con artists use scams and schemes to steal personal information and money from unsuspecting victims, particularly during tax time.

This news release is part of a series called the Tax Time Guide, a resource to help taxpayers file an accurate tax return. Additional help is available in Publication 17, Your Federal Income Tax, and the tax reform information page.

The IRS doesn't initiate contact with taxpayers by email, text messages or social media channels to request personal or financial information. The public should be alert to scammers posing as the IRS to steal personal information. There are ways to know if it's really the IRS calling or knocking on someone's door.

The IRS also works with the Security Summit, a partnership with state tax agencies and the private-sector tax industry, to help protect taxpayer information and defend against identity theft. Taxpayers and tax professionals can take steps to help in this effort.

PROTECT PERSONAL INFORMATION: Treat personal information like cash - don't hand it out to just anyone. Social Security numbers, credit card numbers, bank and even utility account numbers can be used to help steal a person's money or open new accounts. Every time a taxpayer receives a request for

personal information, they should think about whether the request is truly necessary. Scammers will do everything they can to appear trustworthy and legitimate.

AVOID PHISHING SCAMS: The easiest way for criminals to steal sensitive data is simply to ask for it. Learn to recognize phishing emails, calls or texts that pose as familiar organizations such as banks, credit card companies or even the IRS. These ruses generally urge taxpayers to give up sensitive data such as passwords, Social Security numbers and bank account or credit card numbers. They are called phishing scams because they attempt to lure the receiver into taking the bait.

Be aware that an unsolicited email with a request to download an attachment or click on a URL could appear to come from someone that you know like a friend, work colleague or tax professional if their email has been spoofed or compromised.

Don't assume internet advertisements, pop-up ads or emails are from reputable companies. If an ad or offer looks too good to be true, take a moment to check out the company behind it. Type the company or product name into a search engine with terms like "review," "complaint" or "scam."

The IRS urges people to never download "security" software from a pop-up ad. A pervasive ploy is a pop-up ad that indicates it has detected a virus on the computer. Don't fall for it. The download most likely will install some type of malware. Reputable

security software companies do not advertise in this manner. For more information on reporting IRS-related phishing see "Report Phishing" on IRS.gov.

Safeguard personal data in daily, online activity

Taxpayers should safeguard their Social Security number. Provide it only when necessary.

Provide personal information over reputable, encrypted websites only. Shopping or banking online should be done only on sites that use encryption. People should look for "https" at the beginning of a web address (the "s" stands for secure) and be sure "https" is on every page of the site.

USE STRONG PASSWORDS: The longer the password, the tougher it is to crack. Use at least 10 characters; 12 is ideal for most home users. Mix letters, numbers and special characters. Try to be unpredictable - don't use names, birthdates or common words. Don't use the same password for many accounts and don't share them on the phone, in texts or by email. Consider using a passphrase versus a password. Legitimate companies will not send messages asking for passwords. Receiving such a message probably means it's a scam. Keep passwords in a secure place or use password management software.

Set password and encryption protections for wireless networks. If a home or business Wi-Fi is unsecured, it allows any computer within range to access the wireless network and potentially steal information from

connected devices.

USE SECURITY SOFTWARE : An anti-malware program should provide protection from viruses, Trojans, spyware and adware. The IRS urges people, especially tax professionals, to use an anti-malware program and always keep it up to date.

Set security software to update automatically so it can be upgraded as threats emerge. Also, make sure the security software is "on" at all times. Invest in encryption software to ensure data at rest is protected from unauthorized access by hackers or identity thieves. Educate children about the threats of opening suspicious web pages, emails or documents.

BACK UP FILES: No system is completely secure. Copy important files, including federal and state tax returns, onto a removable disc or a back-up drive, and store it in a safe place. Federal and state tax returns are important financial documents. People need them from time to time for home mortgages or college financial aid applications. These steps also can help taxpayers more easily prepare next year's tax return. If storing sensitive tax and financial records on a personal computer, use a file encryption program to add an additional layer of security.

Indian American Pharmacist in New Jersey Pleads Guilty in Income Tax Fraud

NEWARK, NJ (TIP): An Indian American licensed pharmacist from Monmouth County, New Jersey, on March 5 admitted cashing millions of dollars' worth of his pharmacy's checks to evade the payment of income taxes, U.S. Attorney Craig Carpenito announced.

Ajay Barthwal, 43, of Morganville, New Jersey, pleaded guilty before U.S. District Judge William J. Martini in Newark federal court to an information charging him with conspiracy to commit tax evasion in connection with income he received from Old Bridge Drugs & Surgicals (OBDS), a retail pharmacy in Old Bridge, New Jersey, during calendar years 2009 through 2011, that he failed to report on the income tax returns he filed for those years.

According to documents filed in this case and statements made in court:

Barthwal and his wife claimed to be each 50 percent owners of OBDS. However, Barthwal was actually a one-third owner in OBDS, and two other individuals, Dilip Naik and Bhavesh Mistry, both of whom have previously pleaded guilty to related tax crimes, were each one-third owners and "silent partners."

As a partnership, OBDS was required to file an IRS Form 1065 U.S. Partnership Income Tax Return. Income received by the business would flow through to the individual partners' Individual Income Tax Return, IRS Forms 1040. As owners of OBDS, Barthwal, Naik and Mistry each were responsible for accurately reporting to the IRS their business income and respective personal incomes.

Barthwal admitted that from at least Jan. 1, 2009, through Nov. 5, 2012, he, Naik and Mistry all agreed to evade paying income taxes. He admitted that he, Naik and Mistry agreed to hide taxable revenue of \$9,343,234, which OBDS had received, by submitting to the IRS tax returns that substantially under-reported the gross receipts of OBDS for calendar years 2009 through 2011.

Beginning in January 2009, Barthwal and Naik caused business receipts from OBDS to be cashed at a check cashier located in Jersey City, New Jersey. Barthwal then deposited only a portion of the OBDS business receipts into the OBDS operating account, and Barthwal,

Naik and Mistry each received approximately one-third of the proceeds of the OBDS business receipts that were not deposited into the operating account.

In early 2009, Barthwal, Naik and Mistry agreed to hide the undeposited gross cash receipts from OBDS from the IRS. Barthwal admitted that he, Naik and Mistry failed to pay \$4,114,102 in taxes that would have been due and owing to the IRS.

The count of conspiracy to commit tax evasion is punishable by a maximum of five years in prison and a fine of \$250,000, or twice the gross gain or loss caused by the offense, whichever is greater. Sentencing is scheduled for July 7, 2019.

Indian American accused of campaign finance violation

NEW YORK (TIP): National Legal and Policy Center (NLPC) filed a formal Complaint March 4 with the Federal Election Commission (FEC) against Rep. Alexandria Ocasio-Cortez (D-NY), her chief of staff Saikat Chakrabarti, an Indian American, and several other individuals and groups who 'orchestrated an extensive operation to hide hundreds of thousands of dollars in campaign spending during the 2018 campaign, in violation of the Federal Election Campaign Act of 1971, as amended.'

According to reports, the funds were expended in support of ten or more Congressional candidates by a for-profit entity called Brand New Congress LLC, apparently operated by Chakrabarti. The Act requires that all expenditures of \$200 or more to be disclosed to the FEC, and their purpose identified. The Complaint alleges that Chakrabarti's LLC served as a "cutout," for at least \$885,735 received from Ocasio-Cortez's campaign and two federal political action committees, Brand New Congress PAC and Justice Democrats PAC. Ocasio-Cortez's campaign paid Justice Democrats, a Tennessee-based PAC founded by Chakrabarti, a total of \$41,108.59 for "campaign services" and "strategic consulting" in 2017 and 2018, Federal Election Commission filings show.

But PACs are not vendors and cannot provide more than \$5,000 a year worth of services for any single candidate, according to FEC regulations. If candidates go above this amount, they need to seek advice directly from the FEC. The Policy Center has requested that the FEC begin a formal investigation into several named individuals and entities, including Rep. Ocasio-Cortez personally, as well as her 2018 congressional campaign committee and Chakrabarti.

Media Orchestrated War Hysteria a Danger Signal for Punjab

I am summing up the seven -decade old history of Punjab. The wounds of 1947 partition, during which approximately one million lives were lost and twenty million were made to abandon their homes and hearths and migrate penniless to newer lands, that the 1947-48 Kashmir War started. During those days more than 50% of the Indian Army consisted of Punjabi soldiers from among the Dogras of Pathankot and Kangra, the Jatts of Gurgaon, Rohtak and Hissar and the Sikhs of all districts of Punjab. The commissioned officers included a large chunk of Hindu Khatri of upper strata too. A large number of these soldiers were deployed in Kashmir.

On the industrial front, the woolen mills of Dhariwal and Amritsar were working 24 hours to produce winter uniforms for the soldiers deployed in war. Amritsar aerodrome was busy lifting the soldiers, their uniforms and ammunition to air strips in Kashmir. This war ended with honors for Brigadier Pritam Singh in the Poonch area, Brigadier Atma Singh in the pot belly of Kashmir and Brigadier Kulwant Singh (later Lt. General) in Northern Kashmir and Air Commodore Mehar Singh. It was Mehar Singh, who was India's finest Air Force pilot in the entire theatre of war in 1947-48.

In 1965, once again war broke out in the month of September. Pakistan made minor intrusions into East Punjab in Fazilka, Hussainiwala and Khemkaran sectors, but India, under the superb guidance of Lt. General Harbaksh Singh General Officer Commanding of the Western Army Command pushed relatively deeper into Lahore (G.T. Road), Burki (Lahore district) and Sialkot Sectors. So far so good, but on the last day, when people all over India and Pakistan were celebrating ceasefire, only a few minutes after ceasefire came into effect, bombers of Pakistan Air Force bombed Amritsar's largest industrial area of Chheharta, killing more than three hundred industrial workers. This pressed the panic button and between one hundred to two hundred thousand wealthy industrialists and merchants left Amritsar permanently for Mumbai, Faridabad, New Delhi, Panipat, Ludhiana and other safer places.

Then came the two -decade long insurgency in Punjab from 1978 to 1997. It started slowly in 1978 after bloody gunfire by the Nirankaris on Bhindranwala supporters. But after the Operation Blue Star of June 1984, there was a

protracted insurgency up to the end of 1995. The militants dominated at night and the police and the paramilitary forces were in control during the day light hours. The industrialists and the wealthy were feeling insecure and suffocated. This led to the biggest mass exodus of the employment generating business houses of Amritsar, Batala, Ferozepore, Fazilka and Tarn Taran. Pain was felt as far away as Jalandhar and Ludhiana.

After the December 13, 2001, militant attack on the Parliament House in New Delhi, there was a massive troop deployment all along the sensitive border in Punjab. After the terror attack of February 14, 2019 in Pulwama (Kashmir), a war hysteria is being generated by several TV channels based in New Delhi and Mumbai. The owners and anchors of these channels are perfectly safe in their citadels, but their rhetoric is no music to the people living on the border.

Punjab has four districts of Tarn Taran, Amritsar, Gurdaspur and Pathankot taken out of the erstwhile Lahore division. During the pre-1947 days all these districts plus Ferozepore and Fazilka were very wealthy business and residential pockets, but now due to their location

on the border, they are a part of the theatre of war and all these districts have become underdeveloped. For the past sometime, the crown jewel of this belt Amritsar has been experiencing a boom in Golden Temple driven tourism. Its airport until the last month of 2018 was the fastest growing large airport in India. But the flight disruptions of February 27, 2019, due to the heightened tension on the border, have dealt a severe blow to the freshly developing tourist economy. For one day all flights to Amritsar from Singapore, Kuala Lumpur, Bangkok, Dubai, Doha, Ashgabat, Tashkent, Birmingham and Manchester were disrupted. Traffic was resumed later. At present hotel occupancy in Amritsar is down by at least 20% (as reported by the Amritsar Tribune). 200% duty imposed on imports from Pakistan has killed all trade at Wagha/Attari border. Since there is no imminent chance of a dialogue between the neighbors, Punjab's border area economy is heading for another downturn. We do not want war to break out in Punjab, but the ground realities are engineered to create war like situation on the border of Punjab.

How China can be punished for its Masood Azhar slight

If indeed Pulwama has changed India, then let us see some signs of that in India's China policy, in the next few days, not weeks. Soft-peddalling on China is no longer an option. India needs to take some really hard decisions - and fast.

Regardless of the spin Indian diplomats put on it - and no matter how much anyone tries to play down China's veto (for the fourth time) on designating the Pakistani jihadi terrorist, Masood Azhar, as an international terrorist by the UN Security Council - the fact is that this was a blatantly unfriendly act by a country that has proved, once again, that it is anything but a friend of India.

To not put too fine a point on it, China is an openly hostile country which shamelessly supports and defends Pakistani terrorists who attack India, and then, with a forked tongue, speaks of peace and friendly relations with India.

Therefore, India's mealy-mouthed reaction - not naming and shaming China for placing a 'technical hold' and merely expressing 'disappointment' over the bailout given by China to Pakistan and to the terrorist Masood Azhar - is emblematic of the pusillanimity that has allowed China to cock a snook at India.

Until Pulwama, Masood Azhar was a major irritant in the India-China relationship. India didn't like the Chinese obstruction in including Azhar in the UN sanctions list, but in the interest of the larger relationship with China, India was willing to put Azhar on the side. But after Pulwama, Azhar has become an embodiment of the fact that proscribing jihadist terrorism is now a 'core interest' of India. A strong, unambiguous signal needs to be sent that anyone who plays games on this issue will be rubbing India the wrong way because India can no longer afford to look the other way.

On terrorism, there can be no bargaining - no diplomatic quid pro quo of the "You back BRI, we ban Masood Azhar" type. Countries negotiate and make deals on many things - but not on core interests.

The point, however, is that unless India makes it clear that there will be serious consequences for whoever tries to protect Pakistani terrorists, the phrase 'core interest' loses all meaning.

The question is whether India is now ready to acquaint China with these 'consequences' or will carry on with business as usual.

The Chinese are, of course, being disingenuous when they seek more discussions and evidence for sanctioning Azhar. It is indeed quite rich of China, a country which has interned over a million Muslims in concentration camps simply because of how they look, what they wear, whether or not they pray and what they say, to demand evidence against a self-confessed terrorist.

Evidence is not - and never was - an issue. The issue is geo-politics, geo-strategy and geo-economics. And India has failed to leverage its strengths in this domain to force the Chinese hand.

In other words, India has failed to impress on China that the benefit it derives from its economic and strategic relationship with Pakistan is not worth the economic and strategic cost of antagonizing India. Until India does this, it is quite pointless to expect China to deliver on India's concerns.

In a sense, India has not only underplayed its strengths and not exploited opportunities that have come its way to change the Chinese calculus, but worse, it has not even signaled the costs attached to Chinese obduracy on Azhar. For instance, at a time when most Western countries have virtually banned the Chinese telecom giant Huawei from entering the 5G space, what prevents India from keeping the Chinese company out of the 5G trials on security grounds?

Many other Chinese companies linked to the Communist party or the Chinese state can be eased out from a variety of contracts on security or other grounds. Taking a leaf from China's book, India doesn't have to indulge in any bombast while taking these steps - all it needs to do is speak with the same forked tongue that the Chinese use while crossing India's path, but making sure the message is delivered loud and clear.

For decades, India has tended to take the China-Pakistan relationship as being set in stone and therefore assumed that it is a mug's game to expect China to do anything that goes against the interests of its 'Iron Brother'. While it is true that China has strong strategic interests and now, increasingly economic interests in Pakistan, the fact is also that China's economic stakes in India outweigh its interest in Pakistan - and India's strategic options, if it chooses to exercise them, can cause more damage to China than any advantage it hopes to get out of Pakistan.

The total trade between India and China is over five times the trade between China and Pakistan.

India is one of the biggest trading partners of China and the surplus China enjoys in its trade with India surpasses the total investment it seeks to make in the China-Pakistan Economic Corridor (CPEC).

At a time when China's unfair, restrictive and predatory trade practices are being questioned world over, a trade war with the US

already underway, the Chinese economy slowing down quite fast, and the debt balloon becoming dangerously big, the last thing China would want is losing the Indian market.

Forget about WTO and other international regimes limiting our options; there are a number of ways of staying within the four corners of WTO rules and still placing barriers that make trade with China difficult and unprofitable. This is a leverage that India can use. Of course, it won't be costless for India, but then, there are no costless options anyway if 'core interests' have to be protected and advanced. If India keeps looking for costless options and is not ready to pay a price for its security and stability, then it might as well close shop and go to sleep.

The economy is just one leverage that can be deployed. On the strategic plane, India needs to give up its traditional caution, even reluctance, and move towards aligning itself more closely with the US and its other allies like Japan and Australia, and also rope in some other countries spooked by growing Chinese assertiveness - for instance, Vietnam and Indonesia - to contain China in the entire Indo-Pacific region. Why can't India revise its stand on the Quad and take the lead to energize and formalize this into something substantial? Politically, India can deepen its engagement with Taiwan - and start voicing concerns over the treatment of Muslims in China.

That China will be chary of taking any step that could drive a wedge between it and Pakistan is also an assumption that needs to be re-evaluated. More than anything else, this has become an alibi for China in our minds and the sooner we debunk it, the better it is for us. It might have been true at a time when Pakistan had two suitors - USA and China - vying for its attention and affection. But today, Pakistan's almost total dependence on China, not just for military equipment and strategic support but also for economic bailouts, means that Pakistan cannot and will not do anything that riles China.

After all, concubine states always avoid getting into a tangle with their masters.

To put it plainly, China's backing for Masood Azhar isn't so much a function of wanting to be on Pakistan's right side but more a function of wanting to extract something big from India in exchange for something that China considers trivial.

There is probably also a political angle in the latest move by China. Its 'all-weather friend' Pakistan has a lot invested in seeing the back of Prime Minister Narendra Modi after the General Elections - sanctioning Azhar at this time would raise Modi's stock even more in the eyes of the Indian electorate, and that's the last thing Pakistan would want to see.

By vetoing Azhar's designation as a global terrorist, China has tried to influence and interfere in the Indian elections.

This should serve as a wake-up call for all those in the ruling dispensation who were going all gaga over the ephemeral and amorphous 'Wuhan spirit' - while that 'spirit' has now gone up in smoke, Modi should use this opportunity to start turning the screws on China. Graft: Zia approaches SC against doubling jail term

DHAKA (TIP): Bangladesh's jailed former Prime Minister Khaleda Zia on March 14 filed a plea in the Supreme Court, challenging a High Court verdict that enhanced her punishment to 10 years imprisonment from five years in a corruption case.

In the petition, Zia, 73, prayed to the SC to suspend her punishment and grant her bail in the Zia Orphanage Trust corruption case. The Appellate Division is yet to fix any date for hearing the petition.

The Bangladesh Nationalist Party chief is serving a 10-year term in a special structure of the old Dhaka Central Jail. Her party suffered a miserable defeat in the December 30 elections bagging only six seats in 300-seat Parliament. The ex-premier's conviction on a charge of "moral turpitude" debarred her from contesting the polls.

"The lower court sentenced Zia to five years in jail in the case, but the High Court passed an order doubling the jail term in the case (and) therefore we filed the appeal seeking stay order on effectiveness of her punishment and her bail," Zia's lawyer Kaisar Kamal said. He claimed that the HC "unfairly, unjustly and unreasonably" enhanced Zia's punishment while she did not commit any corruption. — PTI

Radical Maoist party workers hold protest against govt's ban; torch bus in Nepal

KATHMANDU (TIP): A passenger bus carrying a wedding procession was torched by the workers of a radical Maoist party in Western Nepal protesting against the government's move to ban their party.

The cadres of CPN-Maoist led by Netra Bikram Chand, a faction of the previous Maoist party, torched the bus after the passengers were taken out of the vehicle in Badaipur of Kailali district, police said.

The bus was completely damaged in the incident. Three persons were taken into police custody while they were trying to stop vehicles.

Major cities of Nepal were partially affected as the CPN-Maoist enforced a nation-wide strike after the government decided to put a ban on the party.

The Nepal Communist Party was formed after the then Maoist Party broke-off into groups.

The government after a Cabinet meeting on March 10 banned the radical Maoist party after it carried out a series of bomb attacks in the capital Kathmandu.

The government said that the Chand-led group was engaged in criminal activities by detonating bombs at infrastructure projects and disturbing peace and security.

The announcement was made after the government's efforts to hold talks with the party failed.

One person was killed and two others injured last month when the Communist Party of Nepal, led by the former Maoist guerrilla, detonated a bomb outside the office of a telecom company in Kathmandu.

Maoist rebels fought an armed insurgency against state security forces between 1996 and 2006 that killed more than 16,000 people. A peace accord was signed in November 2006. PTI

Afghan journalist injured in bombing; 10 troops killed

KABUL (TIP): An Afghan journalist, who has long received death threats, was seriously injured in a bombing in the country's south, while in the western province of Farah, the Taliban stormed an army checkpoint and killed 10 soldiers, officials said on March 13.

Also in Farah, a local official was gunned down outside his home on Wednesday, a councilman said.

The attacks were the latest violence in war-torn Afghanistan even as the Taliban and the US concluded another round of negotiations held in Qatar, with both sides reporting progress in the talks.

Radio and TV journalist Nesar Ahmad Ahmadi was wounded when a sticky bomb attached to his car exploded as he was heading to work in Helmand province.

Omar Zwak, the Governor's spokesman, said the attack happened on Tuesday in Lashkar Gah, the provincial capital.

Ahmadi had a leg wound and was transferred to Kabul for further treatment, the spokesman said.

He runs the Sabahoon radio station and is also a reporter for Sabahoon TV in Helmand.

No one immediately claimed responsibility for the attack in Helmand, the Taliban heartland.

Afghan journalists are often targeted in attacks.

In January, the Afghan Journalist Safety Committee said in its annual report that it had recorded a total of 121 cases of violence against journalists and media workers in 2018.

It also said 17 journalists and media workers were killed last year, once again placing Afghanistan as the world's most dangerous country for journalists.

The International Federation of Journalists and its Afghan affiliate



condemned the attack on Ahmadi in Helmand and called for an immediate investigation.

In the attack in western Farah province, the Taliban stormed an army checkpoint along the main highway in Gulistan district on Tuesday, killing 10 soldiers, said Abdul Samad Salehi, a member of the provincial council.

Reinforcements were sent and the area was retaken and brought under control but five or six other troops remain missing, Salehi added.

Taliban spokesman Zabihullah Mujahid claimed responsibility for the attack in Farah.

On March 13, also in Farah, Mohammad Salim Farahi was shot and killed near his home in the provincial capital, Farah city.

He was an engineer and the head of the public works department, said Salehi.

Despite intensified negotiations between the US and the Taliban to end the 17-year was

in Afghanistan, the insurgents have been carrying out near-daily attacks across the country, mainly targeting the government and security forces and causing staggering casualties.

The nearly two weeks of talks in Qatar produced two draft agreements between the Taliban and the US government on a "withdrawal timeline and effective counterterrorism measures," American envoy Zalmay Khalilzad wrote on Twitter.

The Taliban also issued a statement, saying "progress was achieved" on both of those issues.

However, the Taliban have consistently refused to talk with the government in Kabul, describing it as a US puppet.

The talks concluded late Tuesday. It wasn't immediately clear when the next round of talks would take place. — AP

Pak elected dy chairman of OIC body

ISLAMABAD (TIP): Pakistan has been elected deputy chairman of the general body of the Parliamentary Union of Organisation of Islamic Cooperation (OIC), an influential grouping of 57 countries, majority of which are Muslim-dominated.

According to an official announcement, Pakistan was elected deputy chairman of the general body of the Parliamentary Union of the OIC member States (PUIC) on Monday in Rabat, Morocco, the Dawn newspaper reported.

The PUIC is composed of parliaments of member states of the OIC and was established in Iran on June 17, 1999, with its head office situated in Tehran. The PUIC conference also adopted two resolutions presented by Pakistan related to Kashmir.

The election of Pakistan to the forum comes after External Affairs Minister Sushma Swaraj attended the inaugural plenary of the 46th session of the Council of Foreign Ministers (CFM) of the OIC in Abu Dhabi on March 1. She was the first Indian minister to address the OIC meeting. — PTI

Two terrorists arrested in Pakistan

PESHAWAR (TIP): Two terrorists and three accomplices were arrested by the security forces on March 11 during an intelligence-based operation in Pakistan's northwest region, an official statement said. The forces conducted operation in Mansehra district of Khyber Pakhtunkhwa province during which the terrorists were arrested, Pakistani military's media wing the Inter-Services Public Relations (ISPR) said.

The terrorists arrested were wanted in cases of targeting police, military convoys, target killings of law enforcers and attack on Imambargahs, the statement said. — PTI

Malaysia Airlines could be sold or shut down: PM

Kuala Lumpur (TIP): Malaysia Airlines may be sold or shut down, Malaysia's leader said on Tuesday, the latest bad news for a carrier that has been in crisis since suffering the loss of two planes. The 71-year-old airline has been on the ropes since 2014 when Flight MH370 disappeared and MH17 was shot down by a Russian-made missile over war-torn Ukraine. With the carrier teetering on the brink of bankruptcy, sovereign wealth fund Khazanah stepped in to take it over several years ago and major reforms were instituted, including cutting thousands of staff. But it has continued to fare poorly and its performance was blamed in large part for a set of poor financial results released by Khazanah last week. Responding to questions about the airline's future, Prime Minister Mahathir Mohamad told reporters in parliament: "I think it is a very serious matter, to shut down the national airline. -AFP

Over 100 Malaysian schools shut after toxic waste dump

KUALA LUMPUR (TIP): Over 100 schools in Malaysia have been closed after the dumping of toxic waste into a river caused hundreds of people to fall ill, including many children, authorities said.

A lorry is believed to have dumped the waste in southern Johor state last week, sending hazardous fumes across a wide area and causing those affected to display symptoms of poisoning such as nausea and vomiting.

Over 500 people, many of them school pupils, have received medical treatment after inhaling the fumes, with over 160 admitted to hospital, according to official news agency Bernama.

It was unclear what type of poisonous gas had been emitted near the industrial town of Pasir Gudang.

Education Minister Maszlee Malik initially ordered the closure of 43 schools in the area Wednesday, but later announced that figure had more than doubled.

"The ministry of education has decided to close all 111 schools in the Pasir Gudang area immediately," he said in a statement.

"The education ministry is requesting that all parties take precautions."

Three men were arrested earlier this week over the toxic waste dumping. One is expected to be charged in court soon and could face up to five years in jail if found guilty of breaking environmental protection laws. — AFP

US Democrats Introduce 'Dream and Promise Act' to Protect Immigrant Families



WASHINGTON (TIP): On March 12, Democratic lawmakers in the US House of Representatives introduced Dream and Promise Act of 2019 (H.R. 6) to address the crisis faced by Deferred Action for Childhood Arrival (DACA) beneficiaries and immigrants with Temporary Protected Status (TPS) and Deferred Enforced Departure (DED) as a result of the Trump Administration's actions.

"It is imperative that we support the more than one million Dreamers in the United States, including more than 75,000 LGBTQ young people," said Human Rights Campaign's Government Affairs Director David Stacy. "The Dream and Promise Act of 2019 will provide a pathway to citizenship for them, permanently protect TPS recipients, and provide a sustainable framework that addresses immigration without allowing this debate to further harm our friends, neighbors, and loved ones. Congress must pass this bill and live up to our nation's human rights obligations."

In 2017, the Trump Administration eviscerated protections for Dreamers when the decision was made to rescind the DACA program. Although court injunctions have so far permitted Dreamers to renew, their status remains in limbo. This bill would provide a pathway to citizenship for eligible Dreamers who entered the U.S. under the age of 18 and who were continuously present in the U.S. for 4 years prior to the date of the bill's enactment. Dreamers would be provided conditional permanent resident status and would need to fulfill an education, employment or military track to adjust to permanent resident status. Additionally, the Dream and Promise Act would secure permanent residency for people with TPS and DED. After 5 years, those permanent residents would be eligible to apply to become citizens. On average, TPS recipients have lived in the United States for 20 years, building a new life for themselves and their families.

The bill also helps make postsecondary education more affordable for low-income undocumented students by giving them eligibility for federal financial assistance—such as work-study and student loans—and making it less burdensome for states to offer in-state tuition.

Indian American Zain Jaffer Files Wrongful Termination Lawsuit against Former Company

SAN FRANCISCO (TIP): Indian American Zain Jaffer, the founder of leading video adtech company Vungle has filed a lawsuit against the firm, seeking \$100 million in damages.

Jaffer was removed from his role as CEO of the company in 2017. Jaffer said he was wrongfully removed from the position in the wake of his arrest for felony assault, lewd act upon a child, and other related charges. Later, the San Mateo County District Attorney's office dismissed all charges against Jaffer but Vungle did not reinstate him as CEO. His lawsuit alleges that Vungle violated California Labor Code Section 432.7, which prohibits employers from terminating employees because of an arrest that did not result in a conviction.

US to Establish Six Nuclear Power Plants in India

WASHINGTON (TIP): US and India have agreed to strengthen bilateral security and civil nuclear cooperation, including building six US nuclear power plants in India, according to a joint statement. The agreement came after the 9th round of the India-US Strategic Security Dialogue held in Washington DC on March 13, 2019.

Foreign Secretary Vijay Gokhale led the Indian delegation while Andrea Thompson, Under Secretary of State for Arms Control and International Security, led the U.S. delegation. The two sides exchanged views on a wide range of global security and non-proliferation challenges and reaffirmed their commitment to work together to prevent the proliferation of weapons of mass destruction and their delivery systems and to deny access to such weapons by terrorists and non-state actors. The United States reaffirmed its strong support of India's early membership in the Nuclear Suppliers Group.

Vijay Gokhale also called on Ambassador John Bolton, National Security Advisor to the U.S. President on 13 March.

Both underlined the importance of Pakistan taking tangible and irreversible action against terrorist groups based in territories under its control and denial of safe haven for these groups to launch cross-border attacks. Other issues including

Afghanistan and bilateral matters were also discussed.

Earlier, on March 12, Gokhale and the U.S. Under Secretary of State for Political Affairs David Hale held Foreign Office Consultations. They exchanged views on building convergences in the Indo-Pacific and agreed to work with each other and regional partners to promote inclusivity, stability, peace and prosperity in the region.

Both sides called on Pakistan to meaningfully address the concerns of the international community on terrorism, including cross-border terrorism.

On the other hand, Indra Mani Pandey, Additional Secretary for Disarmament and International Security Affairs, Ministry of External Affairs, Government of India, and Dr. Yleem D. S. Poblete, U.S. Assistant Secretary of State for Arms Control, Verification and Compliance, co-chaired the third round of the India-U.S. Space Dialogue, where they discussed trends in space threats; respective national space priorities; and opportunities for bilateral cooperation.

WASHINGTON (TIP): During his meeting with US Secretary of State Michael R. Sikh Grandmother in California alleged of drowning newborn grandson

BAKERSFIELD, CA (TIP): A Sikh grandmother has been alleged of drowning her newborn grandson and burying him in the backyard of a Bakersfield home in California.

Beant Kaur Dhillon, 43, was arrested February 26, and has been charged with felony first-degree murder, assault of a child with force causing great bodily injury, resulting in death.

According to Bakersfield Police Department, the shocking crime occurred November 12, 2018. Dhillon and her 23-year-old nephew Bakhshinderpal Singh Mann allegedly found that Dhillon's teenage daughter had given birth to a baby boy in the bathroom of their family home. Dhillon admitted to police that she then drowned the baby to prevent family shame due to the age of her daughter. They buried the baby in the backyard of their home on Shining Crag Avenue, near Stine Road and Panama Lane.

Singh was also arrested and charged with felony accessory to murder and felony child abuse but was released on bail. Dhillon has pleaded not guilty to all charges. She is scheduled for a hearing on March 13.

Indian American Former Cisco Director Charged with \$9.3 million Fraud

SAN FRANCISCO (TIP): Prithviraj R. Bhikha, a former employee of Cisco Systems, Inc. (Cisco), was charged with defrauding the company out of \$9.3 million, announced United States Attorney David L. Anderson and Federal Bureau of Investigation Special Agent in Charge John F. Bennett. The criminal complaint was unsealed March 4 following Bhikha's arrest on Friday, March 1, 2019, at the San Francisco International Airport.



ownership interest in the overseas entities. The affidavit alleges that Cisco wired approximately \$6.5 million to one of these entities and approximately \$2.8 million to another. The affidavit also alleges more than \$8.5 million was wired from bank accounts associated with these two overseas entities to U.S. bank accounts either controlled jointly by Bhikha and his wife or by his wife alone.

According to an affidavit filed by a special agent of the Federal Bureau of Investigation, Bhikha, 50, of San Francisco, was employed until mid-2017 by Cisco as a director in its global supply unit in San Jose, Calif. That unit was in charge of working with suppliers and vendors to obtain parts for Cisco products. In or about 2013, Bhikha is alleged to have begun advocating within Cisco for the approval of a new project, of which he would be in charge, the goal of which was for Cisco to retain third-party vendors to negotiate savings with manufacturers on small parts used in Cisco products. The complaint affidavit alleges that Bhikha devised, participated in, and executed a scheme to defraud Cisco by establishing overseas business entities, then directing and approving Cisco contracts to these entities pursuant to the aforementioned project, and failing to disclose his

The complaint affidavit also alleges that, when Cisco employees became suspicious regarding one of Bhikha's overseas entities in 2016, Bhikha and another Cisco employee worked together to create documentation to send to Cisco employees regarding that company. The other Cisco employee is also alleged to have asked a third party to pose as the CEO of the overseas entity in a meeting with Cisco employees in July 2016. Bhikha is charged with one count of wire fraud, in violation of 18 U.S.C. § 1343.

Bhikha made his initial appearance in federal court before U.S. Magistrate Judge Joseph C. Spero. Magistrate Judge Spero released Bhikha on a \$3,000,000 bond and scheduled his next court appearance for March 18, 2019, for preliminary hearing or arraignment. If convicted, Bhikha would face a maximum sentence of 20 years' imprisonment, and a fine of \$250,000, plus restitution if appropriate.

"We not only reduced our debt by USD 24 million but also increased our investment in the infrastructure in the amount of 36 million USD for the multidimensional development of our city, its roads, traffic signals, water and electricity supply, safe neighborhoods,

US renews push for nuclear plants in India

NEW DELHI (TIP): The US is once again pushing ahead with its long-stalled plan for a lucrative business deal with India for setting up six nuclear power plants. The latest thrust came during a visit to Washington of an Indian delegation led by Foreign Secretary Vijay Gokhale when the US State Department ensured that the subject remained in the top half of the agenda.

It was in 2005 that India promised six nuclear plants each to the US, France and Russia in exchange for ending India's isolation from mainstream nuclear trade after its 1974 nuclear tests.

Since then, only the Russian project is up and running while the French are grappling with land acquisition headaches in the backyard of Shiv Sena in Maharashtra.

The Americans were allotted the more conducive Andhra Pradesh but their plans went into a tailspin due to a series of disagreements capped by Toshiba-Westinghouse filing for bankruptcy.

Abhinandan's debriefing over, on sick leave

NEW DELHI (TIP): The debriefing of Wing Commander Abhinandan Varthaman, who was captured by Pakistan last month and returned to India two days later, has been completed by the Indian Air Force and other agencies and he is going on sick leave for a few weeks now, news agency ANI reported, quoting sources in the Indian Air Force.

The 35-year-old pilot was captured by Pakistani forces on February 27 after an air combat between the Indian Air Force and the Pakistani Air Force, the first in nearly half a century.

Tensions between India and Pakistan escalated last month after a suicide bombing attack on a CRPF convoy in Jammu and Kashmir's Pulwama district by Pakistan-based Jaish-e-Mohammed terror group that killed 40 soldiers.

India then carried out "non-military, pre-emptive" air strikes on a Jaish terror training camp in Pakistan's Balakot on February 26.

The next day, after an aerial combat between the two countries, the Indian Force Pilot was captured. His MiG -21 Bison fighter plane was shot down when he was chasing Pak jets in Jammu and Kashmir and crossed over to Pakistan-occupied Kashmir (PoK). He ejected safely and was taken into custody by the Pakistan Army.

ED says middleman can turn approver in Agusta case

NEW DELHI (TIP): The Enforcement Directorate (ED) told a Delhi court today that it has no objection if Rajeev Saxena, an alleged middleman, is allowed to turn approver in the AgustaWestland money-laundering case.

Special Judge Arvind Kumar reserved for March 25 the order on whether to allow him to turn approver and become a witness in the case.

ED's Special Public Prosecutors DP Singh and NK Matta submitted that Saxena's turning approver would be useful for the agency in the case. The court had granted bail to Saxena on a plea moved by his lawyer Shivani Luthra, after the agency did not oppose the application.

6 Dead, 32 injured as foot overbridge collapses near CST railway station in Mumbai

MUMBAI (TIP): At least six people were killed and 32 injured as a major portion of a foot overbridge near the Chhatrapati Shivaji Maharaj Terminus (CSMT) railway station in Mumbai collapsed on Thursday evening.

An eyewitness said when the bridge collapsed, there was a red light at the nearby signal, and that is why the death toll was not more. Another eyewitness said the overbridge was being used despite repairs being carried out this morning.

The bridge collapse, on the busy Dadabhai Naoroji Road, was the third in less than 18 months in the maximum city. On July 3, 2018, a pedestrian pathway of Gokhale Bridge over Andheri railway station in suburban Mumbai had collapsed, killing two and injuring five others.

Nine months before that, in 2017, 23 people were killed in a stampede when the Elphinstone Bridge had collapsed.

Thursday's collapse happened around 7.30 pm when a major portion of the bridge caved in, officials said. Some motorists who were passing beneath the bridge when it came down, were among those injured.

The six who died include two female nurses from Gokuldas Tejpal Hospital, both of who were heading to work for the night shift. They were identified as Apoorva Prabhu (35) and Ranjana Tambe (40). The others were identified as Zahid Shiraj Khan (32), Bhakti Shinde (40), Tapendra Singh (35) and Mohan Kaygunde (55).

Senior police officials, the fire brigade and a team of the National Disaster Response Force were rushed to the site of the accident. The pedestrian bridge, which was demolished after the collapse, connected the railway station to the Azad Maidan police station, the Times of India building and a school.

Apart from public and private ambulances, people at the spot also helped in rescue operations and were seen carrying the injured

to the hospitals.

A 45-member team from the National Disaster Response Force and the Mumbai Fire Brigade were also sent. Rescue operations went on for over an hour as many were trapped under the debris, officials said.

Prime Minister Narendra Modi said he was deeply anguished by the loss of lives due to the accident. "My thoughts are with the bereaved families. Wishing that the injured recover at the earliest. The Maharashtra Government is providing all possible assistance to those affected," he tweeted.

Maharashtra CM Devendra Fadnavis, announced a probe and said the guilty will be punished. He said that the bridge was audited last year and was found to be structurally sound. He has announced a compensation of

Rs 5 lakh for the kin of the dead and Rs 50,000 for the injured.

Maharashtra minister and BJP leader Vinod Tawde said that the bridge only had "minor defects" and it was not considered "risky". He said it will be probed why the bridge was not closed despite repairs being undertaken.

Congress president Rahul Gandhi offered condolences to the families of those killed in the incident and prayed for speedy recovery to the injured, even as his party demanded the ouster of Railway minister Piyush Goyal, saying he was criminally culpable.

Party leader Murlidhar Deora also held the BJP and Shiv Sena responsible for the collapse, and demanded that the auditors who cleared the bridge be booked for murder.

India seeks visa-free access for 5,000 pilgrims per day to Kartarpur shrine

ATTARI (TIP): India on Thursday sought visa-free access from Pakistan for 5,000 pilgrims per day to the historic Sikh shrine in Kartarpur.

This was conveyed to the Pakistani delegation at a meeting here to discuss the opening of a planned corridor for pilgrims between Punjab's Gurdaspur district and Kartarpur Sahib across the border.

From our side, we have pressed for at least 5,000 pilgrims per day to be allowed to visit the holy Sikh shrine in the initial phase, S C L Das, Joint Secretary in the Ministry of Home Affairs, told reporters.

This was the first meeting between an Indian and a Pakistani delegation since tensions between the two countries spiked after the terror attack in Pulwama, followed by retaliatory air strikes.

Das said Delhi wanted access for both Indians and people of Indian origin to the shrine, located where Sikhism's founder Guru Nanak Dev spent the last years of his life.

We have also strongly urged them to allow



the visit of pilgrims for all seven days a week without any break, he said after the meeting.

India emphasised that the corridor should be absolutely visa-free, Das said. There should not be any additional encumbrances in the form of any documentation or procedure, he

added.

India also wants Pakistan to allow devotees who want to travel on foot to the shrine across the border.

A statement earlier said the first meeting between officials of India and Pakistan to discuss the modalities for opening the Kartarpur corridor was held in a "cordial environment".

The Indian delegation was led by S C L Das, Joint Secretary in the Ministry of Home Affairs. The Pakistani team was headed by Mohammad Faisal, Director General (SA & SAARC) of its Ministry of Foreign Affairs, the statement said.

"Both sides held detailed and constructive discussions on various aspects and provisions of the proposed agreement and agreed to work towards expeditiously operationalising the Kartarpur Sahib Corridor," the statement said.

Rahul taunts Modi as China once again blocks anti-Azhar move



NEW DELHI (TIP): Congress president Rahul Gandhi on Thursday taunted Prime Minister Narendra Modi's "brand of diplomacy" after China again blocked the UNSC resolution designating JeM chief Masood Azhar as a global terrorist saying the PM is scared of his Chinese counterpart.

"Weak Modi is scared of Xi. Not a word comes out of his mouth when China acts against India. NaMo's China Diplomacy: 1. Swing with Xi in Gujarat 2. Hug Xi in Delhi 3. Bow to Xi in China," Gandhi tweeted accusing the PM of failed outreaches to Chinese President Xi Jinping.

Other Congress leaders, too, joined Gandhi in questioning the PM after China's continuing blockade of India's move at the UNSC. Former minister Manish Tewari took a swipe at the PM saying, "This is some muscular diplomacy."

Tewari tweeted "@narendramodi rocked on a swing with President Xi, @narendramodi withdrew Indian forces first in Doklam, @narendramodi travelled to Wuhan to release new spirits-Wuhan spirit & China rebuffs is on Masood Azhar third time 2016, 2017 & 2019. Some Muscular Diplomacy ain't it Timothy!"

Azhar's JeM recently claimed responsibility for the Pulwama terror attack leading to the Indian Air Force attacking and destroying its terror bases in Pakistan's Balakot in unprecedented cross-border strikes, the first after 1971. The Pulwama attack had killed 40 CRPF men marking a shift in the Indian policy of strategic restraint in the face of Pakistan-sponsored terror. *Source: The Tribune*

WHY IS RAHUL IN 'CELEBRATORY MOOD' OVER CHINA'S AZHAR DECISION, ASKS BJP

NEW DELHI (TIP): The BJP on Thursday dubbed as "celebratory" Congress chief Rahul Gandhi's remarks in which he attacked Prime Minister Narendra Modi saying he was "scared" of Chinese President Xi Jinping after Beijing blocked designation of JeM chief Masood Azhar as global terrorist.

The party also asked why he had not made any comment when China had blocked the move on the same grounds in 2009 when the Manmohan Singh-led UPA government was in power.

"Why is Rahul Gandhi in a celebratory mood when the country stands pained with this attitude of China," BJP leader and Union minister Ravi Shankar Prasad told a press conference, claiming that Gandhi with his comments is seen to be "in close proximity with Azhar Masood".

The BJP's reaction came after Gandhi questioned Prime Minister Narendra Modi's silence on China again blocking the UN resolution on Azhar. Gandhi had tweeted, "Weak Modi is scared of Xi. Not a word comes out of his mouth when China acts against India. NoMo's China diplomacy: 1. Swing with Xi in Gujarat. 2. Hug Xi in Delhi. 3. Bow to Xi in China."

Prasad said India has tried to mend fences with China, an apparent reference to Modi's outreach to the country, but it will remain steadfast in its fight against terrorism.

He noted that the proposal to list Masood as a global terrorist for the first time was backed by three permanent members of the UN Security Council and co-sponsored by other members and claimed that it was a big "diplomatic victory" for India as it showed that the world stands with it on its fight against terrorism.



This is the fourth time that such a move was made in the UN and blocked by China on "technical" grounds, he said, adding that similar moves were also made in 2009, 2016 and 2017.

Rahul Gandhi's tweets must be "headline news" in Pakistan be circulated in JeM office with much merry, Prasad said, adding that it will perhaps make him happy.

The Union minister said Gandhi had spoken about meeting Chinese ministers and that the Chinese embassy in India had wanted to see him off- permission for which was denied by the Indian government- when he flew for his Mansarovar pilgrimage last year. "If you enjoy such good relations with China, then you should have used your proximity to persuade the country to back the proposal in the UN," he said, attacking Gandhi. Quoting from a book, Nehru- The invention of India, written by Congress MP Shashi Tharoor, Prasad said it has been written that India's first prime minister played a role in China becoming a permanent member of the UN Security Council.

India under Modi will continue to fight a decisive battle against terrorism, he asserted, adding that the BJP is "pained" if the Congress and Gandhi are happy with the Chinese action. *Source: PTI*

'Modi hai to Mumkin Hai': BJP slogan for LS polls

NEW DELHI (TIP): The Bharatiya Janata Party (BJP) has chosen "Modi Hai to Mumkin Hai" (Modi makes it possible) as its slogan for the summer's Lok Sabha election on the back of Prime Minister Narendra Modi's image as a doer, finance minister Arun Jaitley said.

In a Facebook post, Jaitley added that Modi has demonstrated his indefatigability by working round the clock over the past five years, achieving results that wouldn't otherwise have been possible.

Modi has proved to be a quick learner, adapting easily to foreign policy, economic and strategic issues, Jaitley said in the Facebook post. The Prime Minister's clarity and determination have facilitated quick decisions making even in complicated matters, he added.

"Many India observers across the world have marvelled at India's pace of taking decisions and implementing them. The BJP, therefore, has chosen an effective slogan for the forthcoming elections "Modi Hai to Mumkin Hai" - 'Modi makes it possible', the finance minister said.

The Congress, meanwhile, targeted the PM over the slogan. "The government lies and misleads the Supreme Court — Modi hai to mumkin hai. The PM and his minister hide their degrees — Modi hai to mumkin hai. Economic data is kept away from public — Modi hai to mumkin hai. There are 8 crore unemployed Indians because Modi hai to mumkin hai. Farmers are in distress because Modi hai to mumkin hai. ISI inspects our defence installations because Modi is there. The list is endless. However, this is typical RSS game. Focus the entire campaign on Modi and establish him as the alibi in the sure-shot wipeout that the BJP will face on May 23," Congress spokesperson Pranav Jha said.

Priyanka Gandhi's jeans DP sparks Twitter scrutiny

NEW DELHI (TIP): Congress General Secretary Priyanka Gandhi Vadra's change of display picture on Twitter — from a sari-clad look to one in a pair of jeans — got the social media world talking. Gandhi joined Twitter over a month ago and has 2,56,000 followers. On Wednesday, she changed her Twitter profile picture the one in which she was in a maroon sari with a long-sleeved blouse. Her new avatar flaunted jeans and a blue shirt. The change in the profile picture got Twitterati talking.

"Priyanka Vadraji's make-up for election campaign, change the jeans and wear the sari, leave the English and try to make fool in Hindi. Husband is under investigation for list of scams and herself talks about country. Sheer shameless. All her rallies must be boycotted," a user said. "Gandhiji always wore one type of clothes. But what about you. Sometime jeans and top, other times sari. Not confident about your clothing? Do you think people can be fooled by wearing sari," another added.

Gandhi did not just invite trolls, there were quite a few compliments that came her way, as well. "Finally a woman politician wearing jeans in Twitter DP, in public...Priyanka, takes it a notch higher," one user wrote, while another commented: "A tight slap to all who criticised her for wearing sari only at the time of elections... Plain, simple and just her..... Take that Bhakts?"

Will first decide objection by Centre on Rafale papers: SC

NEW DELHI (TIP): The Supreme Court today said it would first decide on the preliminary objections raised by the Centre and then go into the facts of the Rafale fighter jet deal case.

A Bench headed by Chief Justice Ranjan Gogoi wrapped up the hearing on preliminary objections by the Centre that the review petitioners in the Rafale jet deal case cannot rely on privileged documents obtained illegally.

The top court asked the petitioners seeking a review of its order to focus on the preliminary objections regarding admissibility of the leaked documents.

"Only after we decide the preliminary objection raised by the Centre, we will go into the facts of the case," said the Bench, also comprising Justices SK Kaul and KM Joseph.

At the outset, Attorney General KK Venugopal, appearing for the Centre, claimed privilege over documents pertaining to the fighter jet deal with France and told the Supreme Court that no one can produce them in the court without the permission of the department concerned.

Venugopal referred to Section 123 of the Evidence Act and provisions of the RTI Act to buttress his claim. He said no one can publish documents related to national security.

Advocate Prashant Bhushan, one of the petitioners seeking a review, opposed the submission and said the Rafale deal documents, which the AG says are privileged, have been published and are already in public domain.

Former Union minister Arun Shourie, one of the review petitioners,



submitted that he was thankful to the Centre and the AG for saying in their affidavit that these are photocopies, proving the genuineness of these documents.

Bhushan said provisions of the RTI Act say public interest outweighs other things and no privilege can be claimed except for documents which pertain to intelligence agencies. There is no government-to-government contract in buying Rafale jets as there is no sovereign guarantee extended to India by France in the Rs 58,000-crore deal, Bhushan said. He also said the Press Council of India Act provides provisions for protecting sources of journalists. *Source: PTI*

Haunted Files: Scientific Racism and Eugenics

The Sheen Center in collaboration with The American Slavery Project (ASP) on February 22 presented in two sessions, an evening of theater that re-creates through audience interaction, performance, and talkback the history of scientific racism and eugenics in America.

Eugenics is the Progressive Era movement of white Protestant "experts" that sought to eliminate a range of marginalized peoples and

elevate Northern Europeans as the norm. The movement pushed these goals through immigration restriction, sterilization, institutionalization, and controlled breeding. Its legacies continue to have a lasting impact on our country today, even with its dark ties to the atrocities of the Nazi regime.

In 1904, a young black infant named Hazel is left on a doorstep. She is taken in by a family from whom she later runs away. Thus begins an odyssey of arrests, institutionalization, and medical intervention - all in an effort to cure her of "immorality."

In this immersive evening of theater, Hazel shares her story and so does the field worker who "treats" her. Taken from the actual records of the Eugenics Field Office, Hazel's story is only one of many that took place during the little-known era of scientific racism in America that are captured in the Haunted Files.

The Eugenics Records Office was the Long Island epicenter of the American eugenics movement. In spring 2015, the Asian-Pacific-American Institute at NYU creatively reimagined the Eugenics Records Office in the exhibit "Haunted Files: The Eugenics Record Office." The American Slavery Project was invited to examine the records and created a piece as part of the exhibit programming. ASP writers had imagined the lives of the field worker and the patient and woven the stories of these two women together in a duologue, shedding light on the history of scientific racism in America.

The first session featured a post show panel with Adam Cohen, author of *Imbeciles: The Supreme Court, American Eugenics, and the Sterilization of Carrie Buck*; Noa Fuller and Jack Tchen, co-curators of the original "Haunted Files" exhibition; and Judy Tate, co-founder of The American Slavery Project.

The Asian Pacific American (A-P-A) Institute's "Haunted Files" can be accessed at www.hauntedfiles.org.

This site features a digital representation of Haunted Files: The Eugenics Record Office (ERO), an immersive recreation of the Long Island epicenter of American eugenics. Here, are available thousands of reproduced files from the Eugenics Record Office, from field reports on mixed-race "Mongrel Virginians" to interviews with the incarcerated "criminally insane," inviting visitors to immerse themselves in the movement's chilling, bureaucratic web of research, politics, and propaganda.

At this site, an extensive sampling of the ERO's files, which are housed permanently at the American Philosophical Society, and Haunted Files' associated installations and programs can be explored.

The theatrical event took place in two sessions at the Loreto Theater and the Haunted Files Exhibition was in Studios A & B, each in the Sheen Center for Thought and Culture.

Despite having been raised nominally Catholic, Milano is now a pro-abortion activist who joined the Left's chorus of outrage against Supreme Court justice Brett Kavanaugh and the Covington Catholic High School students who attended this year's March for Life.

Mythological Significance

To his great ire, his son, Prahald began to worship, Lord Vishnu. To get rid of his son, Hiranyakshyap asked his sister, Holika to enter a



blazing fire with Prahald in her lap, as she had a boon to enter fire unscathed. Legend has it that Prahald was saved for his extreme devotion for the lord while Holika paid a price for her sinister desire. The tradition of burning Holika or the 'Holika dahan' comes mainly from this legend.

Holi also celebrates the legend of Radha and Krishna which describes the extreme delight, Krishna took in applying colour on Radha and other gopis. This prank of Krishna later, became a trend and a part of the Holi festivities. Mythology also states that Holi is the celebration of death of Ogress Pootana who tried to kill infant, Krishna by feeding poisonous milk to it.

Another legend of Holi which is extremely popular in Southern India is that of Lord Shiva and Kaamadeva. According to the legend, people in south celebrate the sacrifice of Lord of Passion Kaamadeva who risked his life to revoke Lord Shiva from meditation and save the world.

Also, popular is the legend of Ogress Dhundhi who used to trouble children in the kingdom of Raghu and was ultimately chased away by the pranks of the children on the day of Holi. Showing their belief in the legend,

children till date play pranks and hurl abuses at the time of Holika Dahan.

Cultural Significance

Celebration of the various legends associated with Holi reassure the people of the power of the truth as the moral of all these legends is the ultimate victory of good over evil. The legend of Hiranyakashyap and Prahald also points to the fact that extreme devotion to god pays as god always takes his true devotee in his shelter.

All these legends help the people to follow a good conduct in their lives and believe in the virtue of being truthful. This is extremely important in the modern day society when so many people resort to evil practices for small gains and torture one who is honest. Holi helps the people to believe in the virtue of being truthful and honest and also to fight away the evil.

Besides, holi is celebrated at a time of the year when the fields are in full bloom and people are expecting a good harvest. This gives a people a good reason to rejoice, make merry and submerge themselves in the spirit of Holi.

LATHMAAR HOLI

In what is known as the hub of holi in India - Barsana, Holi is known as Lathmaar Holi. Sounds violence?? There is more violence than the name signals off. The stick is in the hands of the women on this day and the men need to work a lot to save themselves from the immensely charged up womenfolk.

The birth place of Lord Krishna's beloved Radha, Barsana celebrates Holi with extreme enthusiasm as Krishna was famous for playing pranks on Radha and gopis. In fact, it was Krishna who started the tradition of colours by first applying colour on Radha's face.

Womenfolk, of Barsana it seems, after thousands of centuries want to take a sweet revenge of that prank of Krishna. Even men have not left their mischief and are still eager to apply colour on the women of Barsana.

Following the tradition, men of Nandgaon, the birthplace of Krishna, come to play Holi with the girls of Barsana, but instead of colours they are greeted with sticks.

Completely aware of what welcome awaits them in Barsana, men come fully padded and try their best to escape from the spirited women. Men are not supposed to retaliate on the day. The unlucky ones are forcefully led away and get a good thrashing from the women. Further, they are made to wear a female attire and dance in public. All in the spirit of Holi.

The next day, it is the turn of men of Barsana. They reciprocate by invading Nandgaon and drench the womenfolk of Nandgaon in colours of kesudo, naturally occurring orange-red dye and palash. This day, women of Nadagow beat the invaders from Barsana. It is a colourful site.

Hola Mohalla

Holi gets this joyful name in the state of Punjab. The festival is celebrated in an entirely different manner, its meaning and significance also shifts a little here.

Hola Mohalla is actually an annual fair that is organised in a large scale at Anandpur Sahib in Punjab on the day following the festival of Holi. Practise of holding a fair of this kind was initiated by Guru Gobind Singh, the tenth Sikh guru. Purpose of the fair was to physically strengthen the Sikh community by holding military exercises and mock battles. The festival is celebrated for three consecutive days, in which members of Sikh community display their physical strength by performing dare-devil acts like bareback horse-riding, standing erect on two speeding horses, Gatka (mock encounters), tent pegging etc. This is followed by music and poetry competition to lighten the charged up atmosphere.

A number of durbars are also held where Sri Guru Granth Sahib is present and kirtan and religious lectures take place. This helps strengthening the soul of community. On the last day a long procession, led by Panj Pyaras, starts from Takth Keshgarh Sahib, one of the five Sikh religious seats, and passes through various important gurdwaras like Qila Anandgarh, Lohgarh Sahib, Mata Jitoji and terminates at the Takth.

For people visiting Anandpur Sahib, langars (voluntary community kitchens) are organized by the local people as a part of sewa (community service). Raw materials like wheat flour, rice, vegetables, milk and sugar is provided by the villagers living nearby. Women volunteer to cook and others take part in cleaning the utensils. Traditional cuisine is served to the pilgrims who eat while sitting in rows on the ground.

Dulandi Holi

Holi receives this name in the state of Haryana. Here, bhabhi - the brothers wife gets an upper hand on the day of holi. And, devar's - husband's younger brothers need to watchout. The bhabhi's on this day get a social sanction on Holi to beat their devars and make them pay the price of all the pranks they played on them for the entire year. Bhabhi's roll up their saris in the form of a rope in a mock rage, and give a good run to their devars.

In the evening, devars are supposed to bring sweets for their dear bhabhi. Besides, there is also a tradition of breaking the pot of buttermilk hung high in the street by forming a human pyramid.



Rangpanchami

People of Maharashtra commonly know this festival of colours by the name of Rangpanchami as the play of colours is reserved for the fifth day here. Locals of Maharashtra also know Holi as Shimga or Shimgo.

The festival is particularly popular amongst fisher folk. They celebrate it in on a large scale and revel in the festivities by singing, dancing and merry-making. This special dance provide them means to release all their repressed feelings, needs and desires. People also utter sound through their mouths in a peculiar fashion by striking their mouths with the back of their hands.

Basant Utsav

Holi by the name of Basant Utsav is celebrated with fervour in the state of West Bengal. The tradition of Vasantotsav, meaning Spring Festival was started by poet and Nobel laureate Rabindranath Tagore at Shantiniketan, the University he founded. What is appreciated is the grace and dignified manner in which Vasant Utsav is celebrated in West Bengal as compared to boisterous Holi witnessed in most parts of India. Boys and girls joyfully welcome Spring, the season of hope not just with colours but with songs, dance, chanting of hymns in the serene ambiance of

Shantiniketan. Anybody who got a chance to witness this elegant way of celebrating Holi in Bengal remembers it with fond memory for the rest of his life.

Phagu Purnima

Phagu Purnima is another name for Holi where Phagu means the sacred red powder and Purnima or Pune is the full moon day, on which the festival ends.

At some places like Bihar, Holi is also known as Phagwa as it is celebrated in the later part of the month of Phalgun and the early part of Chaitra in the Hindu calendar. This corresponds to the English months of March-April. The concept of New Year (Samvatsar) varies in the different provinces of our country. In some provinces, the month commences from the 'Krishna-Paksha' on the other hand in some provinces it commences from 'Shukla-Paksha'. For the former, the year ends on 'Purnima' of the month of Phalgun. The new years begins next day - Chaitra, 1st day of the Krishna Paksha. For them on this day the last year has died. For this reason in some provinces like Bihar and UP. Holika dahan is also called 'Samvatsar Dahan'. On this day all the bitterness and evil memories of the last year are burnt in the fire and the New Year is begun with a celebration.

It concludes with the UK-India Awards, a star-studded show celebrating people and organisations who, with their worldwide influence, are creating new frontiers for the UK-India partnership.

Ethiopian crash: black boxes arrive in Paris for analysis

PARIS/ADDIS ABABA (TIP): Two black boxes from the Boeing 737 MAX airplane that crashed in Ethiopia arrived on March 14 in Paris for expert analysis, officials said, as regulators around the world awaited word on whether it was safe to resume flying the jets.

A spokesman for France's BEA air accident investigation agency said the flight data and cockpit voice recorders would be handed over to the agency later in the day.

Their data are critical to finding out what caused the brand new aircraft to plunge to the ground shortly after taking off from Addis Ababa on Sunday.

Following the lead of other global aviation regulators unnerved by the second crash involving a 737 MAX in less than five months, the US Federal Aviation Administration (FAA) issued orders on Wednesday for the planes to be grounded.

Boeing, which maintained that its planes were safe to fly, said in a statement that it supported the FAA move.

"Boeing has determined - out of an abundance of caution and in order to reassure the flying public of the aircraft's safety - to recommend to the FAA the temporary suspension of operations of the entire global fleet of 371 737 MAX aircraft." The FAA along with the National Transportation Safety Board, the Ethiopian civil aviation authority, and Boeing, have been investigating the crash at the site, some 60 km (around 40 miles) outside the Ethiopian capital.

On Thursday morning in Addis Ababa, grieving relatives of some of the 157 victims of Sunday's air disaster boarded buses for a three-hour journey to the crash site. Others described their visit on Wednesday to the arid farmland where the passenger jet crashed. (Reuters)

Venezuela seeks to restore power amid looting; China offers help

CARACAS / MARACAIBO, VENEZUELA (TIP): President Nicolas Maduro's government scrambled on Wednesday to return power to western Venezuela following heavy looting in the country's second largest city, while China offered to help the OPEC-member nation end its worst blackout on record.

Power had returned to many parts of Venezuela after a nationwide outage last week, with the country's main port terminal of Jose, which is crucial for oil exports, resuming operations. The government said people could return to work on Thursday, following several consecutive public holidays due to the lack of electricity.

School will remain suspended for 24 more hours, Information Minister Jorge Rodriguez said in a state television broadcast on Wednesday, adding that power supply had been broadly restored but problems remained in some areas with transformers that had been "sabotaged."

The ruling Socialist Party blamed the outage on U.S. sabotage, accusing President Donald Trump of being responsible for several cyber attacks on Venezuela's main dam. "Our position is the same: the conditions are not ripe for mediation or dialogue," said opposition legislator Fernando Sucre, adding that there had not been talks with Norway. "The agony of the Venezuelan people has increased because of the electricity disaster, and it cannot keep being extended." Reuters

Hit by an arrow, mobile phone dies saving Australian man

MELBOURNE (TIP): An Australian man had a lucky escape while confronting a man armed with a bow outside his home, as a loosed arrow pierced the mobile telephone he was holding to take a photograph of the incident, Australian police said on March 14.

The 43-year old man had returned on Wednesday to find the man, who was known to him, waiting outside his home in Nimbin, a small east coast town around 150 kilometres (93 miles) south of Brisbane.

"The resident held up his mobile phone to take a photo of the armed man who then engaged the bow and was ready to fire," a police statement said.

"It's alleged the man fired the arrow at the resident, which pierced through the man's mobile phone causing the phone to hit him in the chin. It left a small laceration that didn't require medical treatment."

A 39-year old man was arrested at the scene and charged, police said. Reuters

British lawmakers back Brexit delay

LONDON (TIP) : British lawmakers voted overwhelmingly on March 14 to seek a delay in Britain's exit from the European Union, setting the stage for Prime Minister Theresa May to renew efforts to get her divorce deal approved by parliament next week.

Lawmakers approved by 412 votes to 202 a motion setting out the option to ask the EU for a short delay if parliament can agree on a Brexit deal by March 20 — or a longer delay if no deal can be agreed in time.

The vote makes it likely that the March 29 departure date set down in law, which May has repeatedly emphasised, is likely to be missed, although it is unclear by how long. The short delay envisaged in the motion could last until June 30, but the longer extension is not currently time-limited.

It would require unanimous approval from the other 27 EU members, whose leaders meet in a summit next Thursday. May hopes the threat of a long delay will push Brexit supporters in her Conservative Party and members of the Democratic Unionists, the small Northern Irish party that props up her minority government in parliament, to back her deal at the third attempt.

A new vote on May's deal is likely next week, when those lawmakers must decide whether to back a deal they feel does not offer a clean break from the EU, or reject it and accept that Brexit could be watered down or even thwarted by a long delay.

Her spokesman said ministers had agreed to "redouble their resolve" to secure a deal.

Earlier on Thursday, lawmakers voted by 334 to 85 against a second referendum on EU membership. Few opposition lawmakers backed the measure and even campaigners for a "People's Vote" said the time was not yet right for parliament to vote on it.

The government narrowly averted an attempt by lawmakers to seize the agenda on March 20 with the aim of forcing a discussion of alternative Brexit options — possibly limiting May's options when she takes her case for delay to the EU.

Thursday's vote does not mean a delay is guaranteed; EU consent is needed, and the default date for Britain to leave if there is no agreement is still March 29. May's spokesman said the government was still making preparations for a no-deal exit.

Her authority hit an all-time low this week after a series of parliamentary defeats and rebellions. But she has made clear her deal remains her priority, despite twice being overwhelmingly rejected, in January and again on Tuesday.

May's spokesman said earlier on Thursday that she would put that deal, struck after two-and-a-half years of talks with the EU, to another vote "if it was felt that it were worthwhile". — Reuters

Millennial women are letting men take care of the money

Marielle Schurig spoke to a group of women at a wellness event at Lululemon Athletica Inc.'s store in New York's Flatiron district, after they'd sweat it out together in a yoga and circuit-training class. Following her remarks, attendees lined up for an hour to talk to her about their finances.

The women told Schurig, 31, an account vice president at UBS Financial Services Inc., that they let their spouses or partners decide on money matters. Despite investing hours in self-care, many of the self-proclaimed feminists admitted that they had taken a back seat in their own financial affairs.

That's not uncommon: 59% of women age 20 to 34 defer investing and financial planning to spouses, according to a survey by UBS Group AG that was released Wednesday. The Swiss bank found that younger women are more likely than earlier generations to give such leeway to their partners.

"I was really surprised to see that," Schurig said in an interview at UBS's office in New York. "You see women fighting for equal rights and equal opportunities, for respect in the workplace and at home. There's all these women running for political office. We continue talking about breaking glass ceilings. But once we make the money and get those positions, what are we doing with it?"

UBS Global Wealth Management polled 3,652 women globally with a minimum of \$250,000 in investable assets. Millennial women cite other responsibilities as being more urgent than investing and financial planning, according to the



study. And younger women often don't include financial health as a factor in their well-being, said Schurig, a regular at SoulCycle.

"Women will spend a lot of time researching the best skin care, makeup product - they're not sitting down and examining their financial life," she said. "It'll be hard for us to be fully equal with men if we're not on the same financial page as them."

CHEESE AND GARLIC PITA WEDGES

Ingredients

- 1 whole wheat pita bread or 1 pizza base
- 6 tbsp melted butter
- 2 flakes of garlic - crushed (½ tsp)
- 3 tbsp chopped fresh basil or 1 tsp oregano
- ½ cup grated mozzarella or pizza cheese
- A pinch of salt & pepper

Method

- Slit pita bread/pizza base horizontally from the centre to get 2 thin rounds.
- Cut each pita bread/pizza base round equally into 8 wedges (triangular pieces). This way you have 16 pieces in all.
- Combine butter, garlic, basil, salt and pepper, brush over inner/cut side of bread wedges, then sprinkle with mozzarella cheese.
- Place in single layer on oven trays.
- Bake in a hot oven for 5-6 minutes at 200°C or until crisp.



KEEMA SAMOSA

Ingredients

- Mutton mince ½ kg, ginger 1" piece, garlic - a few flakes
- Garam masala 1 ½ tsp, coriander leaves chopped 2 tbsps, Mint leaves chopped 2 tbsps, Onion finely chopped 1 no, Green chilies cut fine 4 nos, Thick curd 1 tbsp, Maida 300 gms, Oil for frying, Salt to taste To taste

Preparation

- Make a stiff dough with the maida, 4 tablespoons oil and salt. Make 20 medium sized balls of this dough.
- Roll thin round chappatis of the balls. Heat a tava and roast the chappatis on one side only.
- Make all the chappatis in the same way.
- Now cut each chappati into two pieces and keep them covered.
- Using a little water make a thick paste of 2 tablespoons maida and keep aside. Make a paste of ginger and garlic
- Heat oil in a frying pan and fry the onions, chilies and ginger and garlic paste.
- Now add the mince meat, salt and cook on a low flame till done.
- Add the garam masala, curd, coriander and mint leaves and cook for some more time.
- Remove from the flame and let it cool.
- Make a cone of each half chappati and fill with the mince.
- Then seal the edges with the flour paste.
- Make samosas with the rest of the chappatis in the above manner.
- Heat oil well and deep fry the samosas till golden brown.
- Serve hot with pudina chutney.

SOON, NANO-BOTS MAY HELP DIAGNOSE, TREAT CANCER

Scientists have designed a nanorobotics system that may be used to study the properties of cancer, and help improve diagnosis and treatment of the deadly disease.

The nano-bot, described in the journal *Science Robotics*, is a set of magnetic 'tweezers' that can position a nano-scale bead inside a human cell in three dimensions with unprecedented precision.

"Optical tweezers—using lasers to probe cells—is a popular approach," said Xian Wang, a PhD candidate at the University of Toronto in Canada.

The technology was honoured with 2018 Nobel Prize in Physics, but Wang said the force that it can generate is not large enough for mechanical manipulation and measurement he wanted to do.

The system Wang designed uses six magnetic coils placed in different planes around a microscope coverslip seeded with live cancer cells.

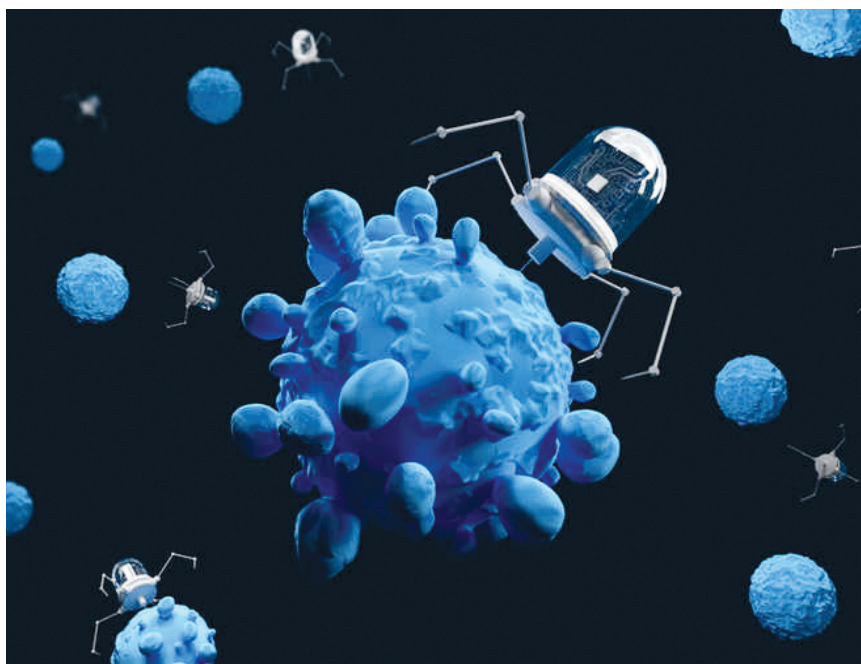
A magnetic iron bead about 700 nanometres in diameter—about 100 times smaller than the thickness of a human hair—is placed on the coverslip, where the cancer cells easily take it up inside their membranes.

Once the bead is inside, Wang controls its position using real-time feedback from confocal microscopy imaging.

He uses a computer-controlled algorithm to vary the electrical current through each of the coils, shaping the magnetic field in three dimensions and coaxing the bead into any desired position within the cell.

"We can exert forces an order of magnitude higher than would be possible with lasers," said Wang.

In collaboration with Helen McNeil and Yonit Tsatskis at Mount Sinai



Hospital in the US and colleagues, the team used the robotic system to study early-stage and later-stage bladder cancer cells.

Previous studies on cell nuclei required their extraction from cells. The researchers measured cell nuclei in intact cells without the need to break apart the cell membrane or cytoskeleton. They were able to show that the nucleus is not equally stiff in all directions.

The researchers also measured exactly how much stiffer the nucleus got when prodded repeatedly, and determine which cell protein or proteins may play a role in controlling this response.

This knowledge could point the way toward new methods of diagnosing cancer, researchers said.

"We know that in the later-stage cells, the stiffening response is not as strong," said Wang.

"In situations where early-stage cancer cells and later-stage cells don't look very different morphologically, this provides another way of telling them apart," he said.

"You could imagine bringing in whole swarms of these nano-bots, and using them to either starve a tumour by blocking the blood vessels into the tumour, or destroy it directly via mechanical ablation," said Professor Yu Sun from the University of Toronto.

"This would offer a way to treat cancers that are resistant to chemotherapy, radiotherapy and immunotherapy," Sun said.

Green tea may cut obesity risk, other health disorders: Study

Green tea may reduce the risk of obesity and a number of inflammatory biomarkers linked with poor health, a study conducted in mice suggests.

Mice fed a diet of two per cent green tea extract fared far better than those that ate a diet without it, according to the study published in the *Journal of Nutritional Biochemistry*.

The finding has prompted an upcoming study of green tea's potential benefits in people at high risk of diabetes and heart disease.

The benefits seen in the study appear to stem from improved gut health, including more beneficial microbes in the intestines of the mice and less permeability in the intestinal wall—a condition typically called "leaky gut" in people.

"This study provides evidence that green tea encourages the growth of good gut bacteria, and that leads to a series of benefits that significantly lower the risk of obesity," said Richard Bruno, the study's lead author and a professor at The Ohio State University in the US.

Negative changes in the gut microbiome have been previously linked to obesity, and green tea has been shown to promote healthy bacteria.

The team wanted to explore whether there was an argument for green tea preventing obesity, inflammation and other factors connected to poor metabolic health, Bruno said in a statement.

The results of studies looking at obesity management so far have been a real mixed bag.

"Some seem to support green tea for weight loss, but a lot of other research has shown no effect, likely due to the complexity of the diet relative to a number of lifestyle factors. Our goal is to figure out how it prevents weight gain," Bruno said. "This will lead to better health recommendations," he added.

Green tea has a rich history in Asian countries and has been increasingly embraced in the West, in part for its potential health benefits.

Catechins, anti-inflammatory polyphenols found in green tea, have been linked to anti-cancer activity and lower risk of heart and liver disease.

The researchers devised an experiment that examined green tea's effects in male mice fed a normal diet and a high-fat diet designed to cause obesity.

Female mice are resistant to diet-induced obesity and insulin resistance, a precursor to diabetes, so they were not included.

Blood holds key to liver regeneration, study suggests

The liver is the only organ in the body that can regenerate. A recent study shows that the blood-clotting protein fibrinogen may hold the key as to why some patients who undergo a liver resection, a surgery that removes a diseased portion of the organ, end up needing a transplant because the renewal process doesn't work.

"We discovered that fibrinogen accumulates within the remaining liver quickly after surgery and tells platelets to act as first responders, triggering the earliest phase of regeneration. But if fibrinogen or platelets are inhibited, then regeneration is delayed," said James Luyendyk, lead author of the study published in the *Journal Blood*.

Platelets are blood cells that help form clots and stop bleeding. When they receive information from fibrinogen, they go into action and accumulate in the remaining part of the liver to help restore it, increasing the chances of a fully functional liver and successful recovery.

Using samples from patients undergoing liver resection and a comparable model in mice, Luyendyk and his team noticed that when fibrinogen was low, the number of platelets in the liver decreased.

"This shows that fibrinogen deposits are extremely important and directly impact regeneration in both mice and humans," Luyendyk said.

According to Dafna Groeneveld, co-author of the study, their finding demonstrates that fibrinogen levels could be a predictive marker for doctors, too.



"Measuring this protein in liver resection patients may help us determine in advance whether the organ will regenerate successfully or if it will become dysfunctional," she said.

Researchers suggest that these findings could lead to new treatments that would help doctors correct low levels of the protein by using fibrinogen concentrates that can be administered during surgery.

NASA MIGHT USE COMMERCIAL ROCKETS FOR MOON MISSION

NASA is likely to use a commercial rocket to launch its Orion crew capsule around the Moon next year, instead of the agency's future multibillion-dollar Space Launch System (SLS), administrator Jim Bridenstine said.

The change may occur, as it becomes increasingly likely that the SLS may not be ready to fly the crew capsule by June 2020, the Verge reported on Wednesday.

During a Senate hearing on Wednesday, Bridenstine said that "we need to consider, as an agency, all options to accomplish the objective", of sending the Orion crew capsule around the Moon.

"Some of those options would include launching the Orion crew capsule... on a commercial rocket," he said.

NASA has long planned to send the Orion crew capsule on a three-week trip around the Moon on a mission dubbed Exploration Mission 1, or EM-1. The flight is meant to serve as the debut launch of the SLS, which has been in development for the last decade and will be the most powerful rocket available when it's ready.

83 supermassive black holes found in early universe

Astronomers have discovered 83 quasars powered by supermassive black holes 13 billion light-years away from the Earth, from a time when the universe was less than 10 per cent of its present age.

"It is remarkable that such massive dense objects were able to form so soon after the Big Bang," said Michael Strauss, a professor at Princeton University in the US.

"Understanding how black holes can form in the early universe, and just how common they are, is a challenge for our cosmological models," Strauss said in a statement.

This finding, published in *The Astrophysical Journal*, increases the number of black holes known at that epoch considerably, and reveals, for the first time, how common they are early in the universe's history.

In addition, it provides new insight into the effect of black holes on the physical state of gas in the early universe in its first billion years.

Twitter rolling out redesigned camera on its app

Microblogging site Twitter is rolling out the redesign of its camera feature that would now allow users to capture media and overlay location, hashtag or some words on a coloured label.

The app would now show media in a larger, more immersive format in the feed with the imagery appearing before the text in tweets, TechCrunch reported on Wednesday.

The redesign reflects on the company's plans on focusing on offering more visual content clicked on real-time lens.

"Tweet it! Our updated camera is just a swipe away, so you get the shot fast. Rolling out to all of you over the next few days," the app tweeted.

For now, no stickers, filters, light enhancements or other creative tools have been added on the Twitter Camera app and it remains unclear whether or not would such features would be included on the micro-blogging site's camera.



FACEBOOK DENIES CYBER ATTACK AS WHATSAPP, INSTAGRAM SUFFER OUTAGE

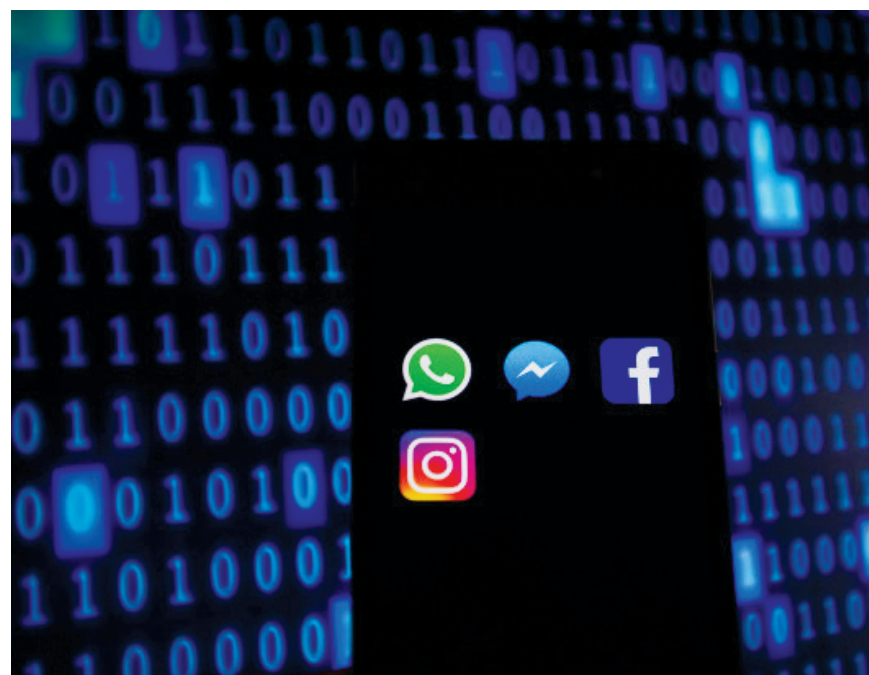
Facebook ruled out a cyber attack on its products Whatsapp, Instagram and Messenger, which suffered service outage for hours on Wednesday.

Users across the globe experienced problems sending messages on Facebook's messaging apps Messenger and Whatsapp. The social networking giant's image-sharing website Instagram also suffered service disruptions.

After users reported about the inconvenience faced by them on the websites and mobile apps, Facebook took to Twitter to respond, "We're aware that some people are currently having trouble accessing the Facebook family of apps. We're working to resolve the issue as soon as possible." The tech major confirmed that the problem was not related to a Distributed Denial of Service (DDoS) cyber attack.

"We're focused on working to resolve the issue as soon as possible, but can confirm that the issue is not related to a DDoS attack," Facebook informed the users, who believed the service disruption could be a "cyber attack".

Although the users could open Facebook and Instagram mobile apps,



they experienced troubles uploading posts, say reports. Internet users made their way to Twitter to complain about the hours-long service disruption with hashtags such as "#FacebookDown", "#InstagramDown" and "#Whatsapp".

Meanwhile, the social media outage became the butt of jokes on Twitter. Several Facebook users took to the micro-blogging website to tickle their funny bone with satirical comments, jokes and memes. *Source: IANS*

Google's Gboard gets offline AI dictation feature



Google is adding an Artificially Intelligent (AI) offline dictation feature on its Gboard keyboard for Pixel smartphones that would allow users to speak out emails and texts even without an Internet connection.

"We're happy to announce the rollout of an end-to-end, all-neural, on-device speech recognizer to power speech input in Gboard which is always available, even when you are offline," Johan Schalkwyk, Speech Team, Google wrote in a blog post on Tuesday.

Google has designed the feature to work at the character level.

"As you speak, it outputs words character-by-character, just as if someone

was typing out what you say in real-time. It is exactly as you'd expect from a keyboard dictation system," Schalkwyk said. To increase use-parameters of the speech recognition feature, Google said it has hosted the new model on device in order to avoid the latency and inherent unreliability of communication networks. For now, the on-device Gboard speech recogniser has been made available in American English language on all Pixel devices.

"We are hopeful that the techniques presented here can soon be adopted in more languages and across broader domains of application," Schalkwyk added.

Instagram adds option to turn off notifications

Facebook-owned photo-messaging app Instagram is giving users more control over their notifications by rolling out an option that would mute app notifications for a chosen period of time—much like WhatsApp's mute feature.

Called 'Pause All', the feature would switch off notifications for anywhere up to eight hours, Social Media Today reported on Wednesday.

"The option was spotted by social media expert Matt Navarra who initially spotted the same in testing last month. Given the amount of time we now spend on social media, it's good to have an option to shut it down completely every now and then," the report said.

The feature has so far been rolled out on iOS and the beta app on Android.

"Instagram is particularly well-known for driving obsessive behaviour among younger users. Being able to shut it off for periods will help people distance themselves from the online world," the report added. *Source: IANS*



BOEING WORKS TO MANAGE A CRISIS WITH UNKNOWN COSTS

When Boeing's Dreamliner was grounded in 2013, it took more than \$20 million and three months to fix the problem. The crisis over its 737 Max jet could be even harder to manage, given the incalculable reputational risk after two fatal crashes.

The short-term costs such as a software fix to the plane are likely to be manageable for Boeing, but the bigger financial unknown is whether airlines lose confidence in the Max, the company's best-selling jet. Some 4,600 planes are on order, accounting for around \$550 billion in future revenue.

Since the second crash, in Ethiopia on Sunday, shares of Boeing have dropped nearly 11 percent.

"Reputationally and financially, this is painful," said Richard Aboulafia, vice president of analysis at Teal Group Corp., a consulting firm.

With all of the Max planes now grounded around the world, Boeing's first priority is developing a fix. Boeing has been working with American regulators to roll out a software update and new training guidelines in the months since the first crash, off Indonesia in October. The update is expected by April, but a final solution could take more time depending on what investigators determine happened in the Ethiopia disaster.

The longer it takes to find a solution, the higher the price tag. The battery fix for the Dreamliner jets amounted to \$465,000 per plane, according to Carter Copeland, an analyst at Melius Research. Based on those costs, he estimates that Boeing could spend nearly \$1 billion to resolve issues with the 737 Max fleet. Airlines, which have 350 of the planes in their fleets, have also begun to demand compensation for their losses during the grounding. It costs an

A pilot shortage for one. A cash crunch for another. And now the Boeing Max crisis. As Indian airlines ground plane after plane, passengers can expect to pay a lot more.

Airfares for domestic travel may rise by 20 percent heading into the annual school break, a prime time for families to travel, according to an online booking firm. "At least 50 planes are out of action owing to multiple reasons," said Sharat Dhall, chief operating officer of the business-to-consumer segment at Yatra Online Pvt Ltd. "That's an eight percent reduction of domestic airline capacity."

Meanwhile, Indians just keep flying more. The sector recorded 46 straight months of double-digit growth through to June 2018, according to International Air Transport Association, keeping it on course to becoming the third-largest domestic aviation market by 2024.

estimated \$1 million to lease a replacement jet for three months.

"It's quite obvious that we will not take the cost related to the new aircraft that we have to park temporarily," said Bjorn Kjos, the chief executive of Norwegian Air, which had to take 18 of the planes out of service after an order

from European regulators on Tuesday. "We will send this bill to those who produce this aircraft."

Boeing could also face lawsuits from the families of passengers who died in the disasters. The Dreamliner had battery problems but never crashed.

Industrial output growth of China falls to 17-year low

BEIJING (TIP): Growth in China's industrial output fell to a 17-year low in the first two months of the year and the jobless rate rose, pointing to further weakness in the world's second-biggest economy that is likely to trigger more support measures from Beijing.

But a mixed bag of major data on Thursday also showed property investment was picking up, while overall retail sales were sluggish but steady, suggesting the economy is not in the midst of a sharper slowdown.

China is ramping up assistance for the economy as 2019 growth looks set to plumb 29-year lows, but support measures are taking time to kick in. Most analysts believe activity may not convincingly stabilise until the middle of the year.

Premier Li Keqiang last week announced hundreds of billions of dollars in additional tax cuts and infrastructure spending, even as officials vowed they would not resort to massive stimulus like in the past, which produced swift recoveries in China and strong reflationary pulses worldwide.

Merger of Radiant, Max Healthcare gets CCI nod

NEW DELHI (TIP): The Competition Commission of India (CCI) has cleared the proposed deal between KKR-backed Radiant Life Care and Max Healthcare.

The companies announced the proposed merger in a joint statement in December 2018. The combined entity will be valued at Rs 7,242 crore, according to the statement.

In a tweet on Tuesday, the fair trade regulator said it "approves proposed combination of Max Healthcare Institute Limited, Radiant Life Care Private Limited and Kayak Investments Holding Private Limited (affiliate of KKR & Co. Inc.)."

According to the joint statement, the deal will see KKR becoming the majority shareholder, while Radiant Life Care promoter Abhay Soi will lead the combined company as chairman. Max Healthcare promoters led by Anajit Singh would step down, it added.

Premji pledges 34% Wipro shares for philanthropy

BENGALURU (TIP): IT czar and Wipro chairman Azim Premji has earmarked 34% of Wipro shares worth Rs 52,750 crore (\$7.5 billion) for his philanthropic activities, a statement said on Wednesday.

"Azim Premji has increased his commitment to philanthropy, by irrevocably renouncing more of his personal assets and earmarking them to the endowment, which supports Azim Premji Foundation's philanthropic activities," the city-based Foundation said.

With his new commitment, Premji's total contribution to the philanthropic endowment corpus is Rs 145,000 crore (\$21 billion), which includes 67% of economic ownership of Wipro Ltd, it said.

The Foundation works in the education sector, aiming to improve the quality of public schooling system, and supports other non-profit organisations working in the field through multi-year financial grants.

"Currently the field work in education is spread across Karnataka, Uttarakhand, Rajasthan, Chhattisgarh, Puducherry, Telangana and Madhya Pradesh, along with some work in the northeastern states," the statement said.

As many as 150 not-for-profit organisations working for the marginalised sections across the country have received the grants from the Foundation over the past five years.



US aims to cut Iran oil exports to under 1 mn bpd from May

WASHINGTON (TIP): The United States aims to cut Iran's crude exports by about 20 per cent to below 1 million barrels per day (bpd) from May by requiring importing countries to reduce purchases to avoid US sanctions, two sources familiar with the matter told Reuters.

US President Donald Trump eventually aims to halt Iranian oil exports and thereby choke off Tehran's main source of revenue. Washington is pressuring Iran to curtail its nuclear program and stop backing militant proxies across the Middle East.

The United States will likely renew waivers to sanctions for most countries buying Iranian crude, including the biggest buyers China and India, in exchange for pledges to cut combined imports to below 1 million bpd. That would be around 2,50,000 bpd below Iran's current exports of 1.25 million bpd.

"The goal right now is to reduce Iranian oil exports to under 1 million barrels per day," one of the sources said, adding the Trump administration was concerned that pressing for a complete shutdown of Iran's oil in the short-term would trigger a global oil price spike.

Washington may also deny waivers to some countries that have not bought Iranian crude recently, the sources said.

The US reimposed sanctions in November after pulling out of a 2015 nuclear accord between Iran and six world powers.



Those sanctions have already halved Iranian oil exports.

To give time to importers to find alternatives and prevent a jump in oil prices, the US granted Iran's main oil buyers waivers to sanctions on the condition they buy less in the future. The waivers are due for renewal every six months.

"Zeroing out could prove difficult" one of the sources said, adding a price of around \$65 a barrel for international benchmark Brent crude was "the high end of Trump's crude price comfort zone."

HINDU DEITIES & THEIR MEANING

Ganapati, the Remover of Obstacles

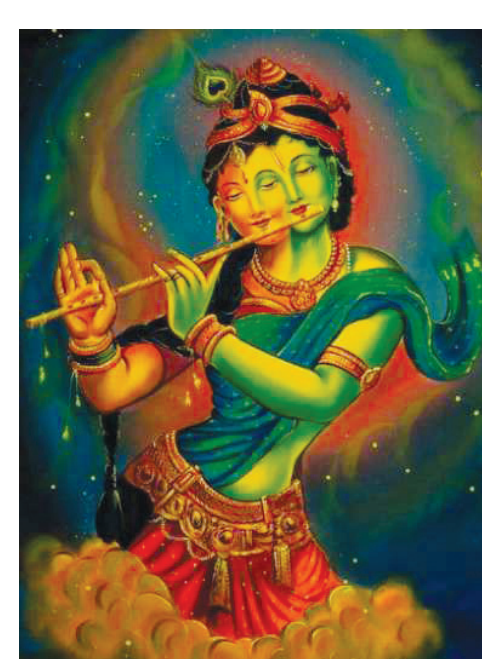
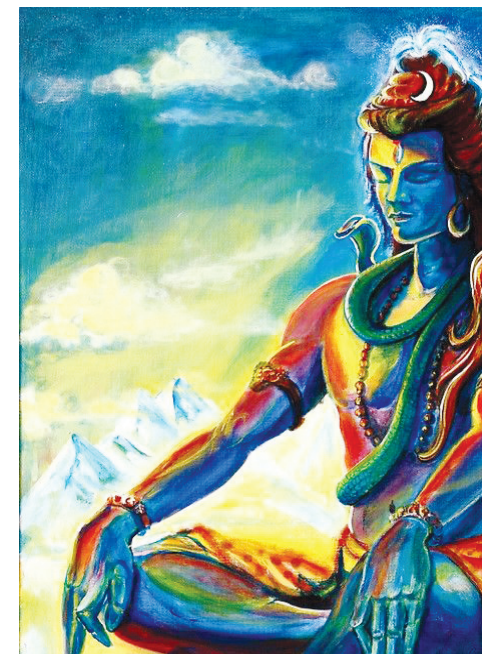

Avatars of Vishnu

The literal meaning of the word avatar is “descent,” and it’s usually understood to mean divine descent. Avatars are savior forms of a god that descend to earth to intervene whenever help is needed to restore dharma (moral order) and peace. Two of Vishnu’s ten avatars are Rama and Krishna.

Rama

Rama is one of the most beloved Hindu gods and is the hero of the Hindu epic called the Ramayana. He is portrayed as an ideal son,



brother, husband, and king and as a strict adherent to dharma. Millions of Hindus derive satisfaction from reading and recalling Rama’s trials and tribulations as a young prince who was exiled from his kingdom for 14 years.

Krishna

If one Hindu god’s name is known and recognized throughout the world, it is Krishna. Hindus identify Krishna as the teacher of the sacred scripture called the Bhagavad Gita and as the friend and mentor of prince Arjuna in the epic the Mahabharata.

For his devotees, Krishna is a delight, full of playful pranks. But most of all, Lord Krishna’s promise to humanity that he will manifest himself and descend to earth whenever dharma declines has sustained Hindu belief in the Supreme Being over thousands of years.

Saraswati, the Goddess of Learning

Saraswati is the consort of Brahma the Creator and is worshipped as the goddess of learning, wisdom, speech, and music. Hindus offer prayer to Saraswati before beginning any intellectual pursuit, and Hindu students are encouraged to offer prayers to her during the school/college term and especially before and during examinations.

Lakshmi

Lakshmi is the goddess of good fortune, wealth, and well-being. As the consort of Vishnu, she plays a role in every incarnation. (She is Sita, wife of Rama; Rukmini, wife of

Krishna; and Dharani, wife of Parashu Rama, another avatar of Vishnu.)

Durga Devi

Durga Devi is a powerful, even frightening goddess who fights fiercely in order to restore dharma (moral order). Yet, while Durga is terrifying to her adversaries, she is full of compassion and love for her devotees.

Indra, the lord of the gods

Indra wields a thunderbolt and is a protector and provider of rain.

Surya, the sun

Surya is a golden warrior arriving on a

chariot pulled by seven white horses.

Agni, the fire god

Agni holds a special place in Hindu fire ritual to this day as the sacrificer (the priest who performs the ceremony); the sacrifice (the ritual fire and the offerings made into it); and the witness to all rites.

Hanuman, the monkey king

Hanuman is featured in the great Hindu epic the Ramayana. He earned his path to deification by performing feats of strength, devotion, and courage while helping Rama (an avatar of Vishnu) in countless exciting incidents.

REMEMBERING BHAGAT SINGH, RAJGURU, SUKHDEV ON THEIR MARTYRDOM DAY

The nation pays tributes to freedom fighters on March 23 who made the supreme sacrifice so that generations after them could breathe the air of freedom. It was on this day that Bhagat Singh, Sukhdev and Rajguru were executed, a few hours ahead of schedule, after the trio were sentenced to death in the Lahore conspiracy case

On March 23, 1931, Bhagat Singh, Rajguru and Sukhdev attained martyrdom. One example of the resoluteness of Bhagat Singh and his associates remains inspirational even today. In order to disgrace Bhagat Singh and his associates, the then British Government informed them, 'If you feel that you should be spared from being hanged, then you must apply for mercy.' The spirited answer to that advice, as given by Bhagat Singh, was: "The government says that we should apply for mercy. But why should we do so? Are we thieves or dacoits or goondas? We are political prisoners in this war for freedom. The blood of complete freedom is circulating in every blood vessel of ours. Whatever bold action we did was for the sake of freedom alone! We may not be worshippers of non-violence; our path may not be devoid of atrocities but is it not true that we are freedom-fighters? If the government has even a fraction of justice left within it, it has to treat us as political prisoners. We will never beg for mercy.

We do not intend to face this death sentence by saying 'Do whatever you like but spare us from being hanged'. We dislike even climbing on the foot board meant for hanging. We are brave soldiers and true men! Hence treat us like that by either shooting us with bullets or blast us with cannons. Who wants to face such a feeble sentence as hanging? We request you to respect this last wish of ours!"

Bhagat Singh

As a freedom fighter, he was considered to be one of the most famous revolutionaries of Indian Independence movement. For this reason, he is often referred to as Martyr Bhagat Singh. At such a young age, if anyone was smiling just before being hanged to death, it was Martyr Bhagat Singh. His uncle, Sardar Ajit Singh as well as his father, were both great freedom fighters, so Bhagat Singh grew up in a patriotic atmosphere.

At an early age, Bhagat Singh started dreaming of uprooting the British Empire. Never afraid of fighting during his childhood, he thought of 'growing guns in the fields', so that he could fight the British. The Ghadar Movement left a deep imprint on his mind. Kartar Singh Sarabha, hanged at the age of 19, became his hero. The massacre at Jallianwala Bagh on 13th April, 1919 drove him to Amritsar, where he kissed the earth sanctified by the martyrs' blood and brought back home a little of the soaked soil. At the age of 16, he used to wonder why so many Indians could not drive away a fistful of invaders.

In search of revolutionary groups and ideas, he met Sukhdev and Rajguru. Bhagat Singh, along with the help of Chandrashekhar Azad, formed the Hindustan Socialist Republican Army (HSRA). The aim of this Indian revolutionary movement was now defined as not only to make Bharat independent, but also to create a socialist Bharat.

A brutal attack by the police on veteran freedom fighter Lala Lajpat Rai at an anti-British procession caused his death on 17th November 1928, in Lahore. Bhagat Singh was determined to avenge Lajpat Rai's death by shooting the British official responsible for the killing, Deputy Inspector General Scott. However he shot down Assistant Superintendent Saunders instead, mistaking



him for Scott. Then he made a dramatic escape from Lahore to Calcutta and from there to Agra, where he established a bomb factory.

The British Government responded to the act by imposing severe measures like the Trades Disputes Bill. It was to protest against the passing of the Bill that he threw bombs in the Central Assembly Hall (now our Lok Sabha) while the Assembly was in session. The bombs did not hurt anyone, but the noise they made was loud enough to wake up an enslaved Nation from a long sleep.

After throwing the bombs, Bhagat Singh and his friend deliberately courted arrest by refusing to run away from the scene. During his trial, Bhagat Singh refused to employ any defense counsel.

Despite great popular pressure and numerous appeals by political leaders of Bharat, Bhagat Singh, Sukhdev and Rajguru were accorded the death sentence and hanged in the early hours of 23rd March 1931. Their bodies were cremated on the bank of the Sutlej in Ferozpur. Bhagat Singh was just 23 years old at that time. Old timers say that in many places, not a single hearth fire burned that day.

The last paragraph of the leaflet that he distributed (and wrote) in the Assembly Hall said: "We are sorry that we who attach such great sanctity to human life, we who dream of a very glorious future when man will be enjoying perfect peace and full liberty, have been forced to shed human blood. But sacrifice of individuals at the altar of the Revolution will bring freedom to all, rendering exploitation of man by man impossible. Inquilab Zindabad (Long live the Revolution)."

Sukhdev Thapar

He was an active member of the HSRA, being one of its senior most leaders. He is known to have started study circles at the National College (Lahore), in order to delve



into Bharat's past as well as to scrutinize the finer aspects of the world's revolutionary literature. Along with Bhagat Singh and others he started the 'Naujawan Bharat Sabha' at Lahore. The main aims of this organization were to activate the youth for the freedom struggle, inculcate a rational scientific attitude, fight communalism and end the practice of untouchability.

His letter to Mahatma Gandhi written just prior to his hanging, protesting against the latter's disapproval of revolutionary tactics, throws light on the disparities between the two major schools of thought among Indian freedom fighters at that time.

Shivram Rajguru

He was born in an average middle-class Hindu Brahmin family at Khed in Pune District in 1908. He came to Varanasi at a very early age where he learnt Sanskrit and read the Hindu religious scriptures. He had a great admiration for Shivaji and his guerrilla tactics.

At Varanasi, he came in contact with revolutionaries. He joined the movement and became an active member of the Hindustan Socialist Republican Army (HSRA). Rajguru had a fearless spirit and indomitable courage. The only object of his adoration and worship was his motherland, for whose liberation, he considered no sacrifice too great. He was a close associate of Chandrashekhar Azad and Bhagat Singh and his field of activity was UP and Punjab, with Kanpur, Agra and Lahore as his headquarters.

Rajguru was a good shot and was regarded as the gunman of the party. He took part in various activities of the revolutionary movement, the most important being Saunders's murder. Chandrashekhar Azad, Shivram Rajguru, Bhagat Singh and Jai Gopal were deputed for the job. On 17th December 1928, while Saunders came out of his office and started his motor-cycle, he was shot dead in front of the police headquarters at Lahore by Rajguru.

Senate Rejects by a 59-41 Vote...

"I look forward to vetoing" the resolution, he tweeted. Trump plans to reject the bill, which the Democratic-held House has already passed. In one tweet after the vote, he simply said, "VETO!" In a subsequent message, he said he looks "forward to VETOING the just passed Democrat inspired Resolution," thanking Republicans "who voted to support Border Security and our desperately needed WALL!"

Trump publicly lobbied the GOP to support his declaration in recent days. Republican lawmakers who voted to terminate Trump's action voiced concerns not only about presidents circumventing Congress' appropriations power, but also the prospect of Democratic administrations declaring emergencies on other topics in the future.

Trump declared a national emergency at the U.S.-Mexico border last month to divert \$3.6 billion from military construction funds to build his proposed border wall. The move followed Trump's frustration with lawmakers' decision to allocate only \$1.4 billion of the \$5.7 billion Trump wanted for border barriers in a measure to fund the government through September.

With Trump's expected veto, Congress will not stop the emergency declaration. His administration will still have to defend its legality in court. More than a dozen states and several other groups have challenged the executive action.

Trump has repeatedly argued he has the authority to declare a national emergency. In recent days, he tried to frame it as a vote on whether to support his immigration policies - not on whether he overreached his authority.

Building a border wall was one of Trump's primary promises to voters in his 2016 presidential campaign. Trump repeatedly stated that Mexico, not the United States, would pay for it. Congress has not funded Trump's border wall requests, including during the first two years of the president's term in office when the Republican Party controlled the legislature. Earlier this year, a politically divided Congress provided limited funds to erect new fencing along small sections of the U.S.-Mexico border. Aside from congressional action, the national emergency declaration is being challenged in the federal court system as well.

"Greta Thunberg has launched a mass movement which I see as a major contribution to peace," he added. Manafort is charged in a New York State Supreme Court indictment filed on March 7, 2019, with Residential Mortgage Fraud in the First Degree, Attempted Residential Mortgage Fraud in the First Degree, Conspiracy in the Fourth Degree, Falsifying Business Records in the First Degree, and Scheme to Defraud in the First Degree.[1]

"No one is beyond the law in New York," said District Attorney Vance. Less than a week earlier, Manafort had received a 47-month prison sentence in another federal case lodged by Mueller. Manafort's combined prison time in the Mueller cases totals 7½ years.

CEOs, Actresses among others...

- and served as the CEO of the Key Worldwide Foundation (KWF) - a non-profit corporation that he established as a purported charity. Between approximately 2011 and February 2019, Singer allegedly conspired with dozens of parents, athletic coaches, a university athletics administrator, and others, to use bribery and other forms of fraud to secure the admission of students to colleges and universities including Yale University, Georgetown University, Stanford University, the University of Southern California, and Wake Forest University, among others. Also charged for their involvement in the scheme are 33 parents and 13 coaches and associates of Singer's businesses, including two SAT and ACT test administrators.

Also charged is John Vandemoer, the head sailing coach at Stanford University, Rudolph "Rudy" Meredith, the former head soccer coach at Yale University, and Mark Riddell, a counsellor at a private school in Bradenton, Fla.

The conspiracy involved 1) bribing SAT and ACT exam administrators to allow a test taker, typically Riddell, to secretly take college entrance exams in place of students or to correct the students' answers after they had taken the exam; 2) bribing university athletic coaches and administrators-including coaches at Yale, Stanford, Georgetown, the University of Southern California, and the University of Texas-to facilitate the admission of students to elite universities under the guise of being recruited as athletes; and (3) using the façade of Singer's charitable organization to conceal the nature and source of the bribes.

According to the charging documents, Singer facilitated cheating on the SAT and ACT exams for his clients by instructing them to seek extended time for their children on college entrance exams, which included having the children purport to have learning disabilities in order to obtain the required medical documentation. Once the extended time was granted, Singer allegedly instructed the clients to change the location of the exams to one of two test centers: a public high school in Houston, Texas, or a private college preparatory school in West Hollywood, Calif. At those test centers, Singer had established relationships with test administrators Niki Williams and Igor Dvorskiy, respectively, who accepted bribes of as much as \$10,000 per test in order to facilitate the cheating scheme. Specifically, Williams and Dvorskiy allowed a third individual, typically Riddell, to take the exams in place of the students, to give the students the correct answers during the exams, or to correct the students' answers after they completed the exams. Singer typically paid Riddell \$10,000 for each student's test. Singer's clients paid him between \$15,000 and \$75,000 per test, with the payments structured as purported donations to the KWF charity. In many instances, the students taking the exams were unaware that their parents had arranged for the cheating.

It is further alleged that throughout the conspiracy, parents paid Singer approximately \$25 million to bribe coaches and university administrators to designate their children as purported athletic recruits, thereby facilitating the children's admission to those universities. Singer allegedly described the scheme to his customers as a "side door," in which the parents paid Singer under the guise of charitable donations to KWF. In turn, Singer funnelled those payments to programs controlled by the athletic coaches, who then designated the children as recruited athletes - regardless of their athletic experience and abilities. Singer also made bribe payments to most of the coaches personally. Actresses Lori Loughlin and Felicity Huffman are the high profile parents to be charged in the alleged scam.

Democrat Beto O'Rourke...

by Long Island based Indian restaurateur Harendra Singh. When they are sentenced by United States District Judge Joan M. Azrack, Edward Mangano faces up to 20 years' imprisonment on honest services wire fraud charges and conspiracy to commit honest services wire fraud, up to 10 years' imprisonment for federal program bribery, and up to five years' imprisonment for conspiracy to commit federal program bribery. Edward Mangano and Linda Mangano each face up to 20 years' imprisonment for each obstruction of justice charge, and up to five years' imprisonment for each false statement charge.

Richard P. Donoghue, United States Attorney for the Eastern District of New York, William F. Sweeney, Jr., Assistant Director-in-Charge, FBI, New York Field Office, and Jonathan D. "As found by the jury, Edward Mangano abused his power as a public official by taking bribes and kickbacks from a businessman in exchange for helping him obtain loans worth millions of taxpayer dollars," stated U.S. Attorney Donoghue. "Among the personal benefits received was a lucrative no-show job for Linda Mangano. The defendants tried and failed to cover up their crimes by lying to the FBI and federal prosecutors and will now be held responsible for these crimes. No one is above the law. The Eastern District and the FBI will be relentless in our efforts to root out corruption at all levels of government in New York."

"In a quid-pro-quo wheeling and dealing, Edward Mangano effectively opened the door that unjustly benefitted restaurateur Harendra Singh, sat idly by while public funds were exchanged for favors, and waited patiently in the wings to accept a payout for the plan he put in motion," stated FBI Assistant Director-in-Charge Sweeney. "In Linda Mangano's case, she kept up the ruse with a bogus job as food taster and menu planner at one of Singh's restaurants. Whether they believe it or not, today we've proven they bit off more than they could chew." "Serving the public is an honor, especially when that position is the result of being elected by the people," stated IRS-Criminal Investigation Acting Special Agent-in-Charge Larsen. "Mr. Mangano abused his elected office and the trust of his constituents. Our agents from IRS-CI diligently utilized their investigative expertise to prove these complex financial transactions."

The evidence at trial established that between January 2010 and February 2015, Edward Mangano engaged in schemes to solicit and receive bribes and kickbacks from Singh. In return for the cash and personal benefits he received, Mangano, who served as Nassau County Executive from January 2010 to December 2017, performed official actions to benefit Singh in connection with his businesses. Several weeks after Edward Mangano took office as Nassau County Executive in January 2010, he urged the TOB Supervisor to help Singh obtain financing in order to make required capital improvements at TOBAY Beach and The Woodlands at the TOB golf course, by authorizing the TOB to indirectly guarantee four bank loans totaling approximately \$20 million. Mangano used his official position to ensure that the TOB backed the loans. In April 2010, Singh hired Linda Mangano for a sham job as the purported Director of Marketing for Singh's businesses. On June 8, 2010, the TOB board voted to authorize the town to back Singh's personal loans for the beach and the golf course. Singh paid for five vacations, hardwood flooring, a custom-made office chair, a massage chair and a watch for the Manganos, as well as over \$450,000 in total for Linda Mangano's no-show job.

India suffer 35-run defeat in fifth ODI against Australia, lose series

NEW DELHI (TIP): India's quest to find the right combinations for the upcoming World Cup ended with a 35-run defeat in the decisive fifth ODI against Australia as they lost the series 2-3 here on Wednesday (March 13).

In what was their last game before the showpiece event in United Kingdom, the Indian innings folded for 237, exactly in 50 overs while chasing a 273-run target.

Australia had put on board 272 for nine, built around Usman Khawaja's (100) second hundred of the series.

It was India's first ODI series defeat at home since losing to South Africa in 2015 as their big guns fell silent on the day when the series was on line.

India also became the only side in the world to lose an ODI series twice after leading 2-0.

The home side dropped KL Rahul from the game, tried Rishabh Pant at number four and Vijay Shankar at five in the last-ditch effort to find right batting order.

However, chasing a challenging target on a tricky Feroz Shah Kotla wicket, India were strangled in the middle overs by the Australian spinners.

History too was against India since the hosts have not successfully chased a 250-plus total at the Kotla in the last 37 years. It was way back in September 1982 against Sri Lanka when they overhauled a 278-run target.

On the other hand, Australia, who were trailing 0-2 initially, made a remarkable comeback to grab their first ODI series win in India since 2009.

It is only the fifth instance that a team has won a series after being down 0-2.

The Australian spin trio of Adam Zampa (3/46), Nathan Lyon (1/34) and part-timer Glenn Maxwell (0/34) kept the Indian batsmen on a tight leash.

Only Rohit Sharma (56) could score a half-century, which included two reprieves.

India could not make a flying start, losing last match's centurion Shikhar Dhawan (12) early and managed just 43 runs in the 10 Powerplay overs.

Rohit was again slow off the blocks, hardly rotating the strike but found some elegant boundaries off the pacers.

The assuring presence of skipper Virat Kohli (20) did not last long as he too departed early, caught behind while attempting a cut off Marcus Stoinis. He added 53 runs for the second wicket with Rohit.

India threw Pant (16) in the line of fire by promoting him to number four but the local boy, who desperately required a substantial performance to back his claim for a spot in the World Cup squad, lasted only 16 balls.

He smashed leg-spinner Zampa for a six but was undone by Lyon, who had the left-hander caught at first slip.

Rotating the strike was key on this Kotla wicket but the Australian spinners kept the pressure on India with dot balls.

The extravagance cost both Pant and Vijay Shankar (16) their wickets as they went after Lyon and Zampa respectively.

Reduced to 132 for six inside 30 overs, India were out of the contest and Kedar

Virat Kohli's record is insane, I won't bowl to him: Shane Warne

The debate on whether India skipper Virat Kohli is as good as or better than the legendary Sachin Tendulkar shall not die down any time soon. But former Australia leg-spinner and current Rajasthan Royals brand ambassador Shane Warne has a fun take on this. Asked on and off about the two and who he considers best, Warne says he "would not wish to bowl to either of the Indian batsmen".

Speaking to IANS even as the Royals prepare for the upcoming season of the Indian Premier League, Warne said while Viv Richards was the best ODI batsman he had seen, he would like to judge Kohli once his career is done.

Going back to who he would bowl to, Warne joked that he would rather bowl to someone like former South Africa batsman Daryl Cullinan, known to have been his bunny during their playing days.

Jadhav (44) and Bhuvneshwar Kumar (46) just reduced the defeat margin.

Their 91-run stand off 103 balls, however, showed that there were no demons in the wicket.

Earlier, opener Usman Khawaja, who had not scored a century before arriving to India for this series, hit an exact 100 off 106 balls as he shared two big partnerships at the top of the order to set platform for the visiting side.

Australia were placed comfortably at 175 for one and set for a kill in slog overs, but India came back when Bhuneshwar got rid of Khawaja in the last ball of the 33rd over.

The visitors added only 97 runs in last 17 overs for the loss of seven wickets.

The left-handed Khawaja first raised a 76-run stand with Aaron Finch (27) after his skipper elected to bat in hazy and overcast conditions and followed it up with a 99-run partnership with Peter Handscomb (52).

Khawaja was yet again impressive

"Sachin in the mid '90s and also Brian Lara in the mid '90s were a class above everyone else. Not so much in the later half of their careers, but in that phase of four to five years from 1994-95 they were just a class above.

"Virat and Sachin are two completely different players altogether, but they are great. None (I would wish to bowl to) actually (Warne laughs). To me both are terrific players, I couldn't choose one," he said. "To me we all know Don Bradman was the best batsman and that is unanimous. Outside that, to me Viv Richards was the best player I saw. I would rather bowl to someone else. Bring me Cullinan to bowl to, he is easy.

"To me the best ODI batsman I have seen would be Viv and Virat. Virat's record is just insane--that how good he is. It is just so hard to judge a player when he is playing," he added.

with his footwork, handling the Indian spinners nicely before being caught at shot extra cover by Kohli off Bhuvneshwar.

The left-hander hit 10 fours and two sixes before driving straight to Kohli.

Jadeja then got rid of Glenn Maxwell (1) and Shami sent back Handscomb as Australia lost three wickets in the space of 14 balls.

Jadeja, who replaced Yuzvendra Chahal, made a strong case for himself for inclusion in the World Cup squad with figures of 10-0-45-2.

Jasprit Bumrah was exceptional in his first eight overs giving just 14 runs but Jhye Richradson (29) spoil his figures by creaming off four boundaries from his ninth over, providing one last push to Australian innings.

It turned out to be a forgettable day for chinaman Kuldeep Yadav who bled 74 runs in his 10 overs but he dismissed dangerous Ashton Turner (20) cheaply.

GAVASKAR SLAMS MCC ONE BALL PROPOSAL IN TESTS

MUMBAI (TIP): Former India captain Sunil Gavaskar slammed the MCC's recommendation that single-make balls be used in Test cricket, saying that it would be "unfortunate" if the suggestion, which will take away the challenge of playing in overseas conditions, is considered seriously.

The World Cricket Committee of the Marylebone Cricket Club (MCC), called the custodian of the game's laws, has proposed the use of a standard ball in the inaugural World Test Championship, which takes place after the World Cup in May-July. "Now we are hearing that they (MCC) are taking about standardising the ball, you might as well standardise the pitches, you might as well standardise the bat, you might as well standardise everything... What's the big deal in playing cricket... (there is this) whole idea of going overseas and winning... because you are playing in different conditions," said Gavaskar.

"The (MCC) World Committee is like Cricket Club of India or the National Cricket Club in Kolkata or Madras Cricket Club in Chennai. It is pretty similar to that, the MCC is saying our committee should (be) listened to (more than the) ICC Committee. And unfortunately a lot of people take them seriously," he added. Currently the SG brand ball is used in India, the Dukes brand in England and the West Indies, and Kookaburra in other countries including Australia and South Africa.

SC asks Narasimha to play mediator

The Supreme Court has asked PS Narasimha, amicus curiae in BCCI matters, to also act as mediator for the state associations. The Bench of Justices SA Bobde and AM Sapre asked Narasimha to hear the state associations' concerns and suggest the way forward to the Committee of Administrators. A senior BCCI official said the move has come as a huge relief for the state associations, which now have the option of getting their issues heard. It will also bring to an end the generic affidavits being filed by the CEO in violation of the newly-registered constitution, he added.

New Zealand-Bangladesh Test called off after shootings

NEW DELHI (TIP): The third Test between New Zealand and Bangladesh in Christchurch has been called off on Friday after gunmen opened fire at two mosques in the city, with the police saying there were "multiple fatalities".

The decision was made after discussions between New Zealand Cricket (NZC) and the Bangladesh Cricket Board (BCB). "Our heartfelt condolences go out to the families and friends of those affected by the shocking situation in Christchurch. A joint decision between NZC and the @BCBTigers has been made to cancel the Hagley Oval Test. Again both teams and support staff groups are safe," NZC said in a tweet.

The Bangladesh team had a narrow escape on Friday morning as they were in the vicinity of one of the two mosques where the shootings took place.

The players took to social media to inform fans and family that they were safe and also asked them to pray for the cricketers. Senior batsman Tamim Iqbal tweeted: "Entire team got saved from active shooters!!! Frightening experience and please keep us in your prayers #christchurchMosqueAttack".

Test captain Mushfiqur Rahim wrote: "Alhamdulillah Allah save us today while shooting in Christchurch in the mosque...We r extremely lucky ...never want to see this things happen again....pray for us."

The shootings took place at the Al Noor Mosque and Linwood Masjid. Police Commissioner Mike Bush said they had arrested four people so far but refused to give the number of fatalities.
