

# US-India Business Relations: Willingness is the key, says Panagariya

**NEW YORK CITY (TIP):** Realizing its own interest in "giving ground" in a bilateral relation is the key factor for India's growth, noted economist Arvind Panagariya said while addressing a business delegation from India.

An Indian Chamber of Commerce (ICC) delegation led by President Rudra Chatterjee visited New York on April 26 and attended a business seminar on US-India Business Relations organised by the Indian Consulate, New York. Arvind Panagariya, professor of economics at Columbia University, who served as first vice-chairman of the government of India think-tank NITI Aayog between January 2015 and August 2017 and former Chief Economist at the Asian Development Bank, was the keynote speaker.

Deputy Consul General Mr Shatrukhna Sinha, who moderated the event, highlighted the vast development and progress made by India, especially in the last few years, to become the seventh largest economy in the world and is expected to become the sixth largest this year.

ICC President Rudra Chatterjee, who has already held many had successful meetings with business houses in DC and New York

prior to this event, explained how India and US together can create a 'world class system' for international business collaboration which can also be followed by other countries. In this regard, his additional comment was the "The comfort level of Indians here makes a huge difference. This familiarity is the key to create world class system."

In his keynote speech, Prof Arvind Panagariya detailed how the US-India relationship has transformed to a new level from year 1998 onwards. "Things have gone to a very different level now. That is the eagerness on both sides to build the

relationship stronger. The willingness of India to 'give ground to gain ground' is important as India sees its own interest in doing so. (As an example), India's stand on Iran oil is a good compromise. There is flexibility on US side as well," he said.

Citing the example of growth rate India has achieved in the last 15 years, Prof Panagariya said that in the next 7-8 years India would cross Japan and Germany and become the third largest economy in the world. But for doing so, India needs to open up much wider liberal trade policies, he reminded. Highlighting the priority areas, Panagariya also emphasised on the need

for major reforms including privatization of public sector banks and land acquisition policies.

Mr Sumit Ganguly CEO of Princeton based software company GAVS, shared his experience regarding doing business in the US and offered suggestions to Indian delegates.

Mr Rajiv Khanna, president of Indian American Chamber of Commerce, in his address said that West Bengal deserves to be showcased to the world as 'The investment destination' in India, citing some recent favourable statistics including GDP Growth Rate. Incidentally, ICC is the leading and only National Chamber of Commerce in Eastern and North-Eastern India operating from Kolkata, West Bengal.

The event ended with a Q and A session. While answering a question by Prof. Indrajit S Saluja, Chief Editor of The Indian Panorama, regarding ease of doing business in India (On Ease of Doing Business, we have moved from 133rd position to 77th in the last three years but still lagging behind even countries like Mexico), Prof. Panagariya emphatically answered that in next couple of years, India will jump fifty places from 77 in ease of doing business list.

As the powerhouse behind the initiative, which launched in 2017, she unites leaders to tackle the widespread prevalence of stereotypes that are often perpetuated through media and advertising content.

Philip Thomas, Chairman of Cannes Lions said, "Phumzile's passion and tireless work to improve the lives of women and children around the world and bring about social justice represents the true embodiment of the Cannes LionHeart Award. Through her work on the Unstereotype Alliance she has brought together leaders from business, technology and creative industries to consciously consider how individuals are in communications."

Introduced in 2014, the Cannes LionHeart is an honorary Award presented to a person or organization that has harnessed their position to make a significant and positive difference to the world around us, with particular reference to those who work with brands and the advertising community.

I look forward to what we will do next through this partnership to change the way the world looks at itself and disrupt the social norms that are holding us back. We are thrilled to be working with the advertising community to bring about positive change by influencing the way that both women and men are represented."

An industry-led initiative, The Unstereotype Alliance, convened by UN Women, is a collaboration between industry leaders who have been champions of addressing gender bias. Its members include global brands, advertising agencies and holding companies, associations and organizations dedicated to advancing representation. Since its launch in 2017, the

initiative has worked with members to conduct international research projects providing applicable insights for creating progressive portrayals of men and women from around the world. In addition, Ms. Mlambo-Ngcuka and The Unstereotype Alliance collaborated with Cannes Lions to introduce updated jury guidelines for the judging process, urging jury members to consider whether the work perpetuates negative stereotypes and inequalities.

Ms. Mlambo-Ngcuka will be interviewed on the Debussy stage at 5 p.m. on Friday 21 June as the final session of the content program. She will accept the LionHeart Award at the final Awards Show closing out Cannes Lions 2019. 

## INDIAN AMERICAN ECOLOGIST RECEIVES NSF CAREER GRANT

**CHICAGO (TIP):** Bala Chaudhary, an environmental scientist at DePaul University recently received NSF CAREER grant to study dispersal of mycorrhizal fungi.

Chaudhary, an assistant professor of environmental science at DePaul, is embarking on a deep dive into mycorrhizal dispersal mechanisms with support from the National Science Foundation. The Faculty Early Career Development (CAREER) grant is NSF's most prestigious award in support of early-career faculty who have the potential to serve as academic role models in research and education and to lead advances in the mission of their department or organization. The \$715,000, five-year research grant will support a multifaceted project that combines trait-based ecology, macroecology and physical laws to study dispersal of mycorrhizal fungi.

Chaudhary has been teaching courses in plant biology, environment data analysis and climate change at DePaul since 2016 as an assistant professor in the College of Science and Health. In her lab in the Department of Environmental Science and Studies, Chaudhary examines soil ecological questions, with a focus on mycorrhizal fungi, something she has been studying since her own undergraduate days at the University of Chicago, where she earned a bachelor's degree in biological sciences.

# Indian Doctor Creates History as First Indian President of International Society of Nephrology

**LONDON (TIP):** Dr Vivekanand Jha created history when he took over as the President of the International Society of Nephrology (ISN) April 15 at the conclusion of the World Congress of Nephrology at Melbourne, Australia. He is the first Indian and only the second person from Asia to ascend to the Presidency of ISN in the 59-year history of the organization.

Currently the Executive Director of George Institute for Global Health India and Professor of Nephrology at University of Oxford, Jha is recognized as an expert on the burden of kidney disease and its socio-economic impact on low-middle income countries. Having joined the ISN community as an ISN Fellow, he set up his own laboratory at the Postgraduate Institute of Medical Education and Research, Chandigarh. He

has carried out large scale epidemiological studies, conducted key clinical trials to find treatment for many kidney diseases and conducted basic laboratory research. Working with organizations such as the World Health

Organization, Kidney Disease Improving Global Outcomes and the Declaration of Istanbul Custodian Group, he has helped develop clinical practice guidelines and advocacy papers.

The International Society of Nephrology (ISN) is a global organization of nephrologists and allied professionals dedicated to advancing worldwide kidney health. The ISN has over 10,000 members and over 100 affiliated societies. The mission of ISN is to bridge the gaps of available care through advocacy and collaborations, to build capacity with healthcare professionals via granting programs, education and research and to develop a stronger understanding of how to manage kidney diseases and engage in a collaborative effort to improve prevention, diagnosis and treatment by connecting communities.

## Indian American Honored as UChicago's First Schmidt Science Fellow

**CHICAGO (TIP):** Kasturi Chakraborty, an Indian American PhD student in UChicago, won the Schmidt Science Fellowship, awarded by Schmidt Futures and the Rhodes Trust to excellent emerging scientists to support a year of postdoctoral research in fields substantially different from their current fields of expertise. Chakraborty, a fifth-year in Yamuna Krishnan's laboratory, is the University of Chicago's first Schmidt Fellow.

Born in Kolkata, India, Chakraborty completed a BS in chemistry at St. Stephen's College at the University of Delhi before pursuing an MS in organic chemistry at the University of Pune. Recalling how her father, an organic chemist, built origami models of molecules and how her mother, a clinical psychologist, worked with children suffering from disease, Chakraborty traces her desire to take a chemical approach to studying biological problems to their early influence. This combination of interests led her to the Krishnan lab. "I saw Yamuna was from a chemistry background, and I liked her outlook and what she was doing," says Chakraborty. "In her lab, I went from synthesizing molecules as an organic chemist to working with *C. elegans*."

At the University of Chicago, Chakraborty has focused on the development of DNA nanodevices for the detection of ions in lysosomes to examine how these organelles function. By correlating ionic imbalances with lysosomal disease severity, these tools can enable quantitative detection of disease phenotypes in cells derived from patients. This work has led to several collaborations with Fred Ausubel at Harvard, Dimitri Krainc at Northwestern, and Paschal Kratsios and Lev Becker at UChicago and has resulted in thirteen papers, four as first author.

As a Schmidt Fellow, Chakraborty intends to study host-microbiome interactions in mammalian intestines. In humans, the genome of the communities of bacteria, viruses, and fungi that live in and on the body, known as the microbiome, far exceeds the size of the human genome.

## INDIAN AMERICAN CHICAGO BOOTH PROFESSOR ANIL KASHYAP REAPPOINTED TO BOE'S FINANCIAL POLICY COMMITTEE

**CHICAGO (TIP):** University of Chicago Booth School of Business Professor Anil Kashyap has been reappointed by UK Chancellor of the Exchequer Philip Hammond as an external member of the Financial Policy Committee (FPC) at the Bank of England.

This is Kashyap's second term. The three-year term will begin on Oct. 1, 2019. His first term ends Sept. 30, 2019.

The FPC was created in the wake of the banking crises by the Financial Services Act of 2012 to protect and enhance the stability of the UK's financial system by identifying, monitoring and addressing systemic risks.

Mark Carney, Governor of the Bank of England, said, "I look forward to the FPC benefiting further from Anil's insights from academia, creative thinking and willingness to challenge and to sharpen our communications."

Kashyap is the Edward Eagle Brown Professor of Economics and Finance at Chicago Booth, where he teaches classes on central banking and financial crises. His research focuses on monetary policy, financial intermediation and regulation, and business cycles.

Prior to joining the Chicago Booth faculty in 1991, Kashyap spent three years as an economist for the Board of Governors for the Federal Reserve System. He currently works as a consultant for the Federal Reserve Bank of Chicago and as a research associate for the National Bureau of Economic Research (NBER). He is also a research fellow for the Centre for Economic Policy Research (CEPR).

## Indian National Sentenced to 60 Months for Human Smuggling Conspiracy

**NEW YORK (TIP):** An Indian national was sentenced April 23 for his leadership role in a complex, transnational conspiracy to smuggle aliens from India to the United States for profit, which claimed at least one life and endangered many others.

Yadvinder Singh Sandhu, 61, was sentenced to 60 months in prison followed by three years of supervised release. On Jan. 18, 2019, Sandhu pleaded guilty to one count of conspiracy and 15 counts of smuggling aliens to the United States for profit before U.S. Magistrate Judge Silvia Carreño-Coll of the District of Puerto Rico. District Judge Carmen C. Cerezo accepted the guilty plea and sentenced the defendant. Sandhu was charged in an indictment returned by a federal grand jury in the District of Puerto Rico on March 15, 2017. Sandhu has also used the names "Yadvinder Singh Bhamba," "Bhupinder Kumar," "Rajinder Singh," "Robert Howard Scott" and "Atkins Lawson Howard."

According to admissions in Sandhu's plea agreement, since 2013, Sandhu had a leadership role in a human smuggling conspiracy operating out of the Dominican Republic, Haiti, Puerto Rico, India and elsewhere.

## World's Largest New City planned and to be built by a Korean in New York

**NEW YORK CITY (TIP):** The new city in question will be located in an island named Isla Puna in Ecuador, a South American country where the equator crosses. This island, 22 times the size of Manhattan and 102 times the size of Yodo, will be developed as a four-dimensional, futuristic metropolis with eight million residents.

At present, there is nothing noteworthy in the island other than a few shrimp farms. The planners say that they will develop this island as an autonomous city similar to Hong Kong, tentatively called NSC City, which will issue its own passports to its residents. The city will function as the political, economic and cultural hub of the 18 countries in Central and South America.

A trillion dollars will be needed for such development. The planners foresee that the funds will be easily raised by means of selling the land to be developed. Since this city will be governed autonomously like Hong Kong issuing its own passports and since the benefits it will provide will be jointly shared by all the 18 countries of Central and South America without any concern of interference by the Ecuadorian government, the planners are positive that investors around the world

will pour in.

The costs for construction and materials will be paid by cyber money like bit coins. The acceptability of the cyber money will be supported by collateralization of the City's land. It will also be jointly guaranteed by world-class enterprises participating in the project. Although the bit coins are not issued by governments and are not backed by any guarantees, they still are circulated in the world financial market without any difficulty and are commonly utilized as means of investment. The planners emphasize that the project coins to be circulated in the process of this development would be even much more reliable cyber money in which the investors may comfortably make investment since they are supported by the land on which a city like Hong Kong will be built and since the world-class enterprises will jointly guarantee.

The planners of such a city are AK Construction Co. and A&K Group Development, Inc. based in New York. Steve Choi, representative of those corporations, has been doing the planning and research for the past 20 years at his own expenses. After many turns and twists, on April 25, 2018, the

planners received from the Presidential office of Ecuador an official correspondence containing an affirmative response to the proposed project. (No. PR-CGATC-17247-0 which can be confirmed by linking to the official website of the Ecuadorian government) This has prompted discussions of the progress of the project between the ministers in charge in the Ecuadorian government and the personnel of the A&K Group Development, Inc. We have learned that A&K Group Development, Inc. is presently in the process of selecting enterprises who will participate in the project.



Concurrently with the progress of this project, the planners are also planning to implement infrastructure projects in the 18 countries in Central and South America. It is learned that all these plans have also been submitted to the government of Ecuador.

## DE BLASIO ADMINISTRATION ANNOUNCES ALCOHOL ADVERTISING BAN ON CITY PROPERTY

*A global label: on designating Masood Azhar as global terrorist*

**With Masood Azhar listed as a terrorist, India must work to ensure the mandated sanctions**

Masood Azhar's listing as a designated terrorist by the UN Security Council at long last closes an important chapter in India's quest to bring the Jaish-e-Mohammad chief to justice. He eluded the designation for 20 years, despite his release in 1999 in exchange for hostages after the IC-814 hijack, and his leadership of the JeM as it carried out dozens of deadly attacks in India, including the Parliament attack of 2001, and more recent ones like the Pathankot airbase attack in 2016 and the Pulwama police convoy bombing this year. China's opposition to the listing has long been a

thorn in India's side, given the toll Azhar and the JeM have exacted, and Beijing's veto of the listing three times between 2009 and 2017 had driven a wedge in India-China relations. Despite the frustration over China's last hold on a proposal moved by the U.S., the U.K., and France just weeks after Pulwama, the government has done well to approach Beijing with what the Ministry of External Affairs called "patience and persistence". There is much disappointment, however, over the final listing released by the Security Council, with no mention of Mr. Azhar's role in any of the attacks against India, or

directing the insurgency in Jammu and Kashmir. A specific reference to Pulwama, which was in the original proposal, was also dropped, presumably to effect China's change of mind on the issue. Pakistan's claims of a victory in this are hardly credible; Masood Azhar is one of about twenty 1267-sanctioned terrorists who have Pakistani nationality, and more are based there, which is hardly a situation that gives it cause for pride. It is necessary to recognize that India's efforts and those of its partners in the Security Council have been rewarded with a UNSC designation at its 1267 ISIL and Al-Qaeda Sanctions Committee. The focus must now move to ensuring its full implementation in Pakistan.

But this is easier said than done. Pakistan's actions against others on the 1267 list have been far from effective, and in many cases obstructionist. Hafiz Saeed, the 26/11 mastermind and Lashkar-e-Toiba chief, roams free, addresses rallies, and runs a political party and several NGOs without any

government restrictions. LeT's operations commander Zaki Ur Rahman Lakhvi was granted bail some years ago despite the UNSC sanctions mandating that funds and assets to the sanctioned individuals must be frozen. It will take constant focus from New Delhi, and a push from the global community, to ensure that Masood Azhar is not just starved of funds, arms and ammunition as mandated, but that he is prosecuted in Pakistan for the acts of terror he is responsible for. Azhar and his JeM must lose all capacity to carry out attacks, particularly across the border. Global terror financing watchdog Financial Action Task Force will also be watching Pakistan's next moves closely, ahead of a decision, that could come as early as in June, on whether to "blacklist" Pakistan or keep it on the "greylist". Both financial and political pressure should be maintained on Islamabad to bring the hard-fought designation of Masood Azhar to its logical conclusion.

## AS I SEE IT

The terror strikes in New Zealand and Sri Lanka are only the most recent manifestations of what is rapidly becoming the new normal in this age of fundamentalist terrorism. It has clearly emerged from the ongoing investigations into the attacks in Colombo that the terrorists involved had linkages in India and Indian cities are probably on the radar on the Islamic State.

Ten years after the Mumbai terror attacks, there is broad consensus that the response in November 2008 was slow, laborious and poorly coordinated among the Central and state governments and their various agencies. Coastal security was virtually non-existent; the Marine Police were too few in number to effectively patrol the vast area entrusted to them; they were ill equipped and inadequately trained; and, there was poor coordination between the Coast Guard and the Marine Police. It took far too long to begin flushing-out operations and then to eliminate the nine terrorists who were holed up at three separate locations.

The government needs to review its largely reactive policies and adopt proactive measures to fight terrorism, particularly the variety that emanates from the soil of inimical neighboring countries. The government must formulate a comprehensive approach to fight terrorism, and all organs of the state must come together to implement a national-level counter-terrorism strategy. The government must draw up a strategy that is inter-ministerial, inter-agency and inter-departmental in character.

It must be ensured that the counter-terrorism policy is based on strong but egalitarian laws. India's experiments with POTA, TADA and UAPA have failed to deliver the desired results. Laws must

be just and humane and must not be designed to either be vindictive towards or shield any particular community or religious denomination. The experience of many other countries has proved that it is possible to formulate strong counter-terrorism laws. The US established a powerful Department of Homeland Security following the 9/11 strikes and there has not been a major terrorist attack since then.

One major lacuna in India's approach to counter-terrorism is the gross disconnect between how the Central and the state governments view counter-terrorism. The Constitution must be

amended to move 'law and order' from the State List to the Concurrent List so that the Central government can act on its own initiative when necessary, particularly in the case of externally-sponsored terrorism. And, it is time the government bifurcated the internal security function of the Ministry of Home Affairs into a separate ministry headed by a cabinet minister.

Besides prevention through accurate 'humint' and 'techint' intelligence gathering, successful counter-terrorism requires the effective intelligence penetration of terrorist groups so that their leadership can be systematically

neutralized by an empowered anti-terrorism agency. Comprehensive planning and better stage management are necessary for the real-time elimination of a group of terrorists during a strike while the terrorists are still on a killing spree.

Though the Cabinet Committee on Security (CCS) gave its approval for the establishment of a National Counter-terrorism Centre (NCTC) following the Mumbai terror strikes, seven chief ministers virtually vetoed the NCTC on the grounds that its functioning will undermine the federal structure of India's Constitution and that it must not be placed under the Intelligence Bureau (IB). The opposition came despite then PM Manmohan Singh's assurance that, "It is not our government's intention to alter distribution of power between states and the Centre. The NCTC is to coordinate counter-terror measures, not to infringe on state powers."

The NCTC was opposed despite the fact that its structure approved by the CCS was a watered-down version of the form in which the NCTC had been conceived by then Home Minister P Chidambaram as an organization capable of "preventing a terrorist attack, containing a terrorist attack should one take place, and responding to a terrorist attack by inflicting pain upon the perpetrators."

The NCTC had been envisaged as an umbrella organization, which would exercise control over the other agencies. It was proposed to be placed under the IB and the existing Multi-Agency Centre (MAC) was to be subsumed in it. The NCTC was to be tasked to draw up and coordinate counter-terrorism plans,

## MUSHARRAF'S TREASON TRIAL POSTPONED TO JUNE 12

**ISLAMABAD (TIP):** A special court accepted former Pakistan President Pervez Musharraf's request on May 2 to postpone the hearing of a treason trial against him until after the month of Ramzan owing to his poor health.

A three-member bench headed by Justice Tahira Safdar adjourned the case hearing till June 12 after the former military dictator's counsel Salman Safdar told the court that his client could not travel to Pakistan to attend the hearing due to his medical condition, Geo News reported.

The counsel, in an application on behalf of Musharraf, stated that despite "strong willingness and eagerness to return to Pakistan, life-threatening ailments and medical complications had forced him not to appear before the special court".

"He is ashamed and apologetic for not being able to reach (in time). He is unable to walk," the counsel said, adding that he had spent three days with Musharraf and was "shocked to see that he could barely even speak".

"The doctors have said it is not safe for him to travel in this condition," the counsel said. He then asked the court to postpone the hearing until after Ramzan. — IANS

## 'IMRAN'S CHINA TRIP PLAYED CRUCIAL ROLE'

**ISLAMABAD (TIP):** The "breakthrough" in designating Masood Azhar as a global terrorist came during Pakistan Prime Minister Imran Khan's recent visit to China where the two sides agreed to withdraw their opposition to the latest move to blacklist the JeM chief, a media report said here on May 2.

The US, France along with the UK had moved the proposal to designate Azhar as a "global terrorist" in the UN Security Council's 1267 Al Qaeda Sanctions Committee in February, just days after the deadly Pulwama attack.

A veto-wielding permanent member of the UNSC, China was the sole hold-out in the 15-nation world body on the bid to blacklist Azhar, blocking four attempts since 2009 by placing a "technical hold" and asking for "more time to examine" the proposal.

Hours after sanctions were imposed on Azhar, the Express Tribune, quoting diplomatic sources, reported that Pakistan and China held extensive discussions before making a decision on the Azhar issue. "It is believed that the breakthrough came during the recent visit of PM Imran Khan to China where both sides agreed to withdraw opposition to the latest move after realising that Islamabad's concerns were addressed," the report said. But the source told the paper that the listing does not mean the person should be detained. Another official claimed that authorities were "unaware" of Azhar's whereabouts. The report also claimed that Islamabad agreeing to the designation of Azhar as a global terrorist was a "paradigm shift" in the country's approach. IANS

# King Rama X – from pilot prince to powerful monarch

*Thailand's king marries bodyguard, names her queen*

**BANGKOK (TIP):** Thailand's King Maha Vajiralongkorn Bodindrade Bayavarangkun will be officially crowned as the 10th king of the Chakri dynasty on May 4, after taking the throne following the death of his father, King Bhumibol Adulyadej, in late 2016.

The 66-year-old constitutional monarch had a pre-coronation surprise for his subjects: He married for the fourth time on Wednesday and named his new wife as queen.

During 18 months of his reign so far, Vajiralongkorn, also known by the title King Rama X, has moved to consolidate the authority of the monarchy, including taking more direct control of the crown's vast wealth with the help of Thailand's military government.

In one of his most visible initiatives he has signed up some 5 million Thais to a new volunteer corps, whose members salute a portrait of the king before going out to work on community service projects such as cleaning public spaces.

Devotion to the monarch is an ingrained part of Thai culture that deepened during Bhumibol's 70-year reign. Vajiralongkorn's portrait has replaced or hangs alongside that of his late father in many streets, public



buildings and private businesses.

Public criticism of the king or his family is illegal, with insults to the monarchy punishable by up to 15 years in prison under Thailand's strict lese majeste laws.

Vajiralongkorn was born on July 28, 1952, the second of King Bhumibol and Queen Sirikit's four children and their only son.

After completing primary education in Thailand, he was educated at private schools in Britain and Australia, before attending Australia's Royal Military College Duntroon, in Canberra, and

earning a bachelor's degree in military studies from the University of New South Wales in Australia.

According to the king's official biography, he is a qualified helicopter and fighter pilot and served as a career officer in the Royal Thai Army, where he saw action against communist insurgents in Thailand in the 1970s.

As king, he is now commander-in-chief of the armed forces. Since he ascended the throne, Vajiralongkorn has asserted his authority in several ways, according to analysts observing his public actions. — Reuters

## Sri Lanka to freeze assets of terrorists involved in Easter bombings

**COLOMBO (TIP):** The Sri Lankan authorities are taking steps to freeze the assets of terrorists involved in the Easter Sunday bomb blasts, a media report said on May 2.

The Criminal Investigation Department (CID) is in the process of identifying and compiling the list of assets belonging to those involved in the attacks, police spokesman S P Ruwan Gunasekera was quoted as saying by the Daily Mirror.

Nine suicide bombers carried out the series of devastating blasts that tore through three churches and three luxury hotels, killing 253 people and injuring 500 others.

The details of the attackers and their relatives linked to the bombings was released by the police on Wednesday.

Police identified Mohamed Cassim Mohamed Zahran also known as Zahran Hashmi to have led the team of suicide bombers. Hashmi, the leader of ISIS linked local outfit National Thowheeth Jamath (NTJ), blew himself up in the posh Shangri-La hotel. He came from the Muslim majority area in Kathankudi in the eastern province, Gunasekera said.

His brother Mohamed Nazar Mohamed Azath was the suicide bomber at the Zion church in the eastern town of Batticaloa while his another brother Achchi Mohamed Mohamed Hasthun

was the bomber at the St Sebastian's Church at Katuwapitiya, Negombo, the Western coastal town.

The official said that the CID is taking these steps in line with the Convention on the Suppression of Terrorist Finance Act and the Prevention of Money Laundering Act. On the identification of those involved the country's worst terror attacks, he said that though CID has identified nine terrorists, "further DNA tests will be conducted to ensure proper identification of the suicide bombers who carried out the Easter Sunday attacks and those who were involved in the shoot-out in Kalmarai on Friday."

Six children and three women were among 15 people killed on Saturday when militants linked to the Easter Sunday bombings opened fire and blew themselves up during a fierce gun battle with security forces in the Sri Lanka's Eastern province.

The shootout occurred as the security forces continued their hunt for members of the NTJ that carried out the attacks.

Meanwhile, the special panel appointed by President Maithripala Sirisena to probe the attacks will release its report on May 6. The special panel was appointed to report on the alleged security lapse which paved the way for the local jihadist group NTJ to carry out the attacks. PTI

## PAKISTAN COAST GUARDS SEIZE NARCOTICS OVER \$24M

**ISLAMABAD (TIP):** The Pakistan Coast Guards have recovered narcotics worth over \$24 million during an operation near Jiwan town of Balochistan province, officials said.

Safeer Mehdi, a spokesperson of the Pakistan Coast Guards, told Xinhua news agency that they received a tip-off regarding a possible bid to smuggle high-quality narcotics to some foreign countries.

Acting on the intelligence report, the Coast Guards launched an extensive operation in the area and recovered 350 kg of hashish hidden in the ground at a beach in Jiwan.

The Pakistan Coast Guards handed the drugs to the anti-narcotics force who would later destroy them as per their schedule, Mehdi added.

No arrest was made, but security forces have increased vigilance and monitoring in the area in efforts to get clues of drug peddlers. IANS

## FOUR MEMBERS OF SIKH FAMILY KILLED IN CINCINNATI

**CINCINNATI (TIP):** Four members of a Sikh family have been killed in Cincinnati, Ohio on Sunday, April 28. Three women and a man were fatally shot inside their home in a West Chester apartment complex in Cincinnati around 9:50 p.m. (local time).

The victims have been identified as Hakikat Singh Panag, 59, his wife, Paramjit Kaur, 62, their daughter, Shalinder Kaur, 39, and his sister-in-law, Amarjit Kaur, 58. One of them was an Indian national on a visit to US while others were persons of Indian origin.

India's External Affairs Minister Sushma Swaraj made it clear that it is not a hate crime. "The matter is under investigation by the Police but it is not a hate crime. Our Consul General in New York is coordinating with the concerned authorities and will keep me informed me on this", she wrote on twitter.

"We have just had a conference call with West Chester Township Police Chief Joel Herzog & other detectives on the case. We are working closely with the Police & family" Indian Consulate in New York wrote on Twitter. No arrests have been made yet.

## More Affluent Executives or Celebrities might be charged in Nationwide College Admissions Scam, says report

**BOSTON (TIP):** In March 2019, dozens of people were arrested in a nationwide college admissions scam that facilitated cheating on college entrance exams and the admission of students to elite universities as purported athletic recruits. Athletic coaches from Yale, Stanford, USC, Wake Forest and Georgetown, among others as well as parents and exam administrator were arrested by federal agents in multiple states on March 12 and charged in federal court in Boston. Actresses Lori Loughlin and Felicity Huffman were the high-profile parents charged in the alleged scam.

Now according to a report published in The New York Times, prosecutors are pursuing a new set of parents in the college admissions scandal including some celebrity parents in Los Angeles. The prosecutors have informed some of the parents that they are under investigation and the lead prosecutor conferred with lawyers for at least two of these parents during a trip to Los

Angeles in April, the report says.

William "Rick" Singer, 58, of Newport Beach, Calif., was the mastermind of the racketeering conspiracy and many of his clients were in the Los Angeles area.

According to the charging documents, Singer facilitated cheating on the SAT and ACT exams for his clients by instructing them to seek extended time for their children on college entrance

exams, which included having the children purport to have learning disabilities in order to obtain the required medical documentation. Once the extended time was granted, Singer allegedly instructed the clients to change the location of the exams to one of two test centers: a public high school in Houston, Texas, or a private college preparatory school in West Hollywood, Calif.

It is further alleged that throughout the conspiracy, parents paid Singer approximately \$25 million to bribe coaches and university administrators to designate their children as purported athletic recruits, thereby facilitating the children's admission to those universities.

Hollywood actress Lori Loughlin and her husband designer Mossimo Giannulli have pleaded not guilty in the case while actress Felicity Huffman has admitted to paying a college counselor \$15,000 to arrange for cheating on her daughter's SAT test.


## INDIAN-ORIGIN FAMILY MOWED DOWN BY US WAR VETERAN IN CALIFORNIA

Peoples "intentionally targeted the victims based on their race and his belief that they were of the Muslim faith," Sunnyvale police chief Phan Ngo said.

A 13-year-old girl identified as Dhriti was in coma and fighting for her life after the attack and her father and 9-year-old brother Prakhar were also hurt. Peoples was produced in a San Jose court on April 26 and charged with attempted murder.

After a lot of discussions and keeping the curiosity and excitement about the film in mind we have decided to release the film immediately after the Lok Sabha election results," Singh said in a statement.

"We are now releasing our film on May 24. This is the first time a film will be promoted for only four days. I hope now nobody has any problem with the film and we are hoping for the smooth release this time," he added.

Directed by Omung Kumar, the film also features Boman Irani, Manoj Joshi, Prashant Narayanan, Zarina Wahab, Barkha Sengupta and Darshan Kumaar.

# PM Modi gets clean chit from poll panel on 'Nuclear Button' remark

**NEW DELHI (TIP):** Prime Minister Narendra Modi was given a clean chit by the Election Commission today - his third in three days - for his comment that India too has nuclear weapons and does not care about Pakistan's threats. The comment, the Election Commission said, does not violate the Model Code of Conduct - a set of dos and don'ts for political parties and the government ahead of elections.

Highlighting the party's national security theme at a rally in Rajasthan's Barmer, the Prime Minister had jeered at Pakistan.

"India has quit the policy of being scared of Pakistani threats... Else, every other day they announced, 'We have nuclear button, we have nuclear button'. So what do we have then? Are those being saved for Diwali?" he had said.

His remarks were vehemently panned by the opposition, which said it was "boastful" and "irresponsible".

The Congress's Anand Sharma said such statements "point to the growing desperation" of the BJP. "Prime Minister's boastful claims of being ready for a nuclear missile attack on Pakistan and US intervention are uncalled for and not in interest of national security," he tweeted.

The Election Commission was asked by the Supreme Court today to expedite their decision on the pending complaints against PM Modi and BJP chief Amit Shah. The court has given it time till Monday.

The Congress, whose appeal was being heard by the top court, has contended that altogether, 11 complaints are pending against the Prime Minister and Mr Shah. The Commission, which resolved the third complaint today, has eight more to go.

The Commission has asked for time till Wednesday, saying it has its hands full with conducting the elections and complaints against other leaders, but the court refused a larger window.



## ELECTION COMMISSION GIVES CLEAN CHIT TO RAHUL OVER SPEECH AGAINST AMIT SHAH

The Election Commission has held that Congress President Rahul Gandhi did not violate the model code of conduct during an election speech in Madhya Pradesh where he called his BJP counterpart Amit Shah a "murder-accused".

Giving a clean chit to Rahul Gandhi, EC officials said the "complaint was examined in detail and after examination of the complete transcript of speech sent by the district electoral officer of Jabalpur, the Commission is of the considered view that no violation of the model code of conduct is made out."

Rahul Gandhi made the purported remark during an election rally in Sihora district of Madhya Pradesh on April 23. Attacking the BJP president, Rahul Gandhi reportedly said, "Murder accused BJP chief Amit Shah. Wah, kya shaan hai! (Wow, what a glory!)."

The BJP had complained to the EC about the comment.

The remark had prompted a strong rebuttal from Amit Shah, who questioned the opposition leader's "legal knowledge" and said the "fake" charge was dismissed as "politically motivated" by the court long ago.

"Let me tell you the gist of the order. I was slapped with a fake case and the court has already passed its order that it was a politically motivated allegation and was without any evidence. I don't want to make any comment on the legal knowledge of Rahul Gandhi," he said.

In 2014, a special court discharged Amit Shah in the Sohrabuddin Sheikh and Tulsiram Prajapati encounter killing cases, holding there existed "no case" against him and that he had been implicated for "political reasons".

# 2019 hustings may create history with record polling

**MUMBAI (TIP):** The country may see the highest voter turnout since Independence in the ongoing Lok Sabha polls if the first four rounds, which clocked 67 per cent polling, is any indication says a report.

Last hustings had closed with the highest turnout at 67.6 per cent and if the remaining three phases of the seven-legged election season record more turnouts then this election will create history since Independence, says SBI Research.

Normally, psephologists and political pundits consider a higher voter turnout as an indication of anti-incumbency.

Of the 543 Lok Sabha seats, voting has been completed in 373 seats (69 per cent of the total seats) in the first four of the seven phases, which will end on May 19 after beginning on April 11.

A phase-wise turnout rate indicates that polling in 2019 is more or equal to the 2014 rate, except for the third phase. Overall turnout after the four rounds this time is 67 percent compared to 67.6 percent in 2014.

"If the same trend continues, this year's turnout rate may cross the previous record, and will be the highest since Independence," the report said.

It said though the delayed elections in 1985, the voter turnout was 72 percent, but it was only in Assam and Punjab, and the average turnout of 1984 and in 1985, when only these



two states went to polls, is coming 67.9 per cent.

So far in the ongoing elections, the voter turnout in Andhra, Assam, Gujarat, Karnataka registered highest ever since 1962 or in last 57 years since Independence.

Chhattisgarh has seen a 15 years and Maharashtra a 30 years high in voter turnout. Mumbai registered a voter turnout of 55.1

percent, which is the highest for the city since 1989, the report said.

In Assam, Bihar, UP, Andhra, Kerala, Chhattisgarh, MP (partial) and Rajasthan (partial) the polling percentage of younger voters in the 18-25 age bracket) on an average is more than national average, there is a 3.3 percent increase in voter turnout (additional 4.5 million), it said.

## SC asks EC to consider starting polling at 5 am

The Supreme Court on Thursday asked the Election Commission to pass necessary orders on a plea seeking to begin voting at 5 am instead of 7 am in view of the Ramzan month. It is coinciding with the remaining phases of voting in the general election.

States like Maharashtra where the elderly population is higher than national average has witnessed an increase in voter turnout, though marginally.

In Karnataka and Kerala that are relatively older states (8.6 per cent elderly population, which is much higher than the national average) there is also an increased 1.8 per cent more voting (or 1.1 million), it said.

Women voters who were previously missing from electoral process due to various socio economic reasons, their numbers have come down in 2019 and are also now actively casting their votes. It said in the western states, where poverty is less, are seeing better polling this year than in the past election.

Southern states also have lower levels of deprivation, and with the exception of Tamil Nadu, they have improved their voter turnout, the report said.

# Six surgical strikes under UPA, claims Cong; BJP calls it 'farcical'

**NEW DELHI (TIP):** A war of words broke out between the Bharatiya Janata Party (BJP) and the Congress on May 2 over the issue of 'surgical strikes' and listing of Jaish-e-Mohammed chief Masood Azhar as a UN-designated terrorist.

Former prime minister Manmohan Singh said Indian armed forces received a free hand to respond to external threats during the Congress-led UPA's tenure. Singh termed it "shameful and unacceptable" that the BJP was attempting to gain electoral mileage from military operations.

The Congress, later, came out with a list of six anti-terror surgical strikes carried out during the UPA rule but it never tried to take political advantage from military operations — a claim which was dubbed "fraudulent and farcical" by the BJP.

Earlier in the day, senior BJP leader and Finance Minister Arun Jaitley during a press conference said Azhar being listed as a global terrorist was a great diplomatic victory for India and that Opposition parties were reluctant to celebrate the achievement because they feel they may have to pay a political price for it.

The UN Sanctions Committee on Wednesday had designated Pakistan-based Azhar a global terrorist after China lifted its hold on a proposal to ban him. Jaitley said the Narendra Modi government succeeded in an attempt the country has been making for the last 10 years, "but then they (Opposition) says 'this is trivial, what is big in it'."

"If India wins, Indians win, but there are friends in opposition who are not celebrating it as they may have to pay a political price for it," Jaitley said. "Terrorism shall not be tolerated and this declaration from the UN is noteworthy. It is the result of persistent measures taken by the external affairs ministry, under the leadership of Prime Minister Narendra Modi," said Defence Minister Nirmala Sitharaman who was also present in the press meeting.

Later in the day, the Congress said the UPA government carried out six surgical strikes — Bhattal sector in Poonch (June 19, 2008);

Sharda sector, across Neelam River Valley, in Kel (August 30-September 1, 2011); Sawan Patra checkpost (January 6, 2013); Nazapir sector (July 27-28, 2013); Neelam Valley (August 6, 2013); and one on December 23, 2013.

Congress spokespersons Rajeev Shukla and Ragini Nayak also listed two surgical strikes carried out under the previous BJP-led NDA government of Atal Bihari Vajpayee. These were Nadala Enclave, across the Neelam River (January 21, 2000) and Baroh sector in Poonch (September 18, 2003).

However, the BJP rejected the Congress' claim of six surgical strikes during the UPA tenure. "It is a farcical and fraudulent claim. We have the greatest of respect for our armed forces. Our forces were capable of carrying out surgical strikes across the LoC, inside Pakistan, but they were not allowed to do so when the UPA was in power," BJP national spokesperson GVL Narasimha Rao said in another press conference.

On the other hand, Jaitley, who was responding to the comments made by Singh in an interview, said the UPA government did not act against terrorists after the Mumbai terror attack in 2008 even as security forces were ready to target them. The UPA government, in fact, released 25 terrorists as



a "goodwill gesture" and one of them was later involved in the Pathankot terror attack, he said.

But Nayak's retort was: "When the former prime minister and (a former) army chief say earlier also surgical strikes have taken place and the FM says they were invisible strikes then he is raising questions not just on Vajpayeeji and Manmohan Singhji, but is also casting aspersions on the Army and the remarks made by the army chiefs at that time."

Jaitley also rejected the Congress' stand that it was disappointed that the UN's decision did not make any reference to the Pulwama terror attack and Azhar's role in terrorism in Jammu and Kashmir. The UN's listing and decision are not a "biodata" of Azhar, and they don't have to give details of his each and every activity, the FM said. The core issue is that Azhar has been declared an international terrorist and he and his country will have to bear the consequences, Jaitley said.

BSP chief Mayawati said: "During its previous stint, the BJP not only took out Masood Azhar (of jail) but also left him abroad and now, they are trying to get votes in his name which is condemnable."

## CPI (Maoist) chief 'plotted' Gadchiroli attack

**GADCHIROLI (TIP):** Sources in the Gadchiroli Police have said that Nambala Keshava Rao alias Basavaraj is suspected to have masterminded Wednesday's Naxal attack in which 15 personnel of Maharashtra's Quick Response Team and a civilian were killed.

According to the Gadchiroli Police, preliminary probe into yesterday's attack in which Naxals blew up a private bus using an IED points towards the involvement of Basavaraj, who is the chief of banned CPI(Maoist).

According to sources, the attack was planned by Basavaraj and executed by Naxals from both Maharashtra and Chhattisgarh.

Basavaraj is believed to have instructed local Naxal units of Maharashtra and Chhattisgarh to carry out the attack. Post the incident, Basavaraj is believed to have gone into hiding in Abujhmad forest area of Chhattisgarh.

Following the revelation, Maharashtra Police have established contact with their counterparts in Chhattisgarh to carry out further investigation.

Meanwhile, Maharashtra Chief Minister Devendra Fadnavis informed that the state



Cabinet met this morning and discussed the Gadchiroli attack.

"In today's Cabinet meeting, we discussed the Gadchiroli Naxal attack where our jawans were martyred. The DGP and other officials have gone to the spot. Once they finish their assessment, there will be a detailed meeting. I'll be visiting the spot today," the CM said. As these developments happened, it was reported that Naxal banners emerged near the site of attack in Gadchiroli.

On Wednesday, 15 policemen and the driver of the private bus in which they were travelling were killed when Naxals blew up the vehicle using an improvised explosive device. Police sources also said today that they suspect some locals could have helped the Maoists in carrying out strike.

IED blast took place at Lendhari nallah in Kurkheda area. State Director General of Police Subodh Kumar Jaiswal has refused to call the Naxal attack a result of intelligence failure.

## US commerce secretary Ross to meet Suresh Prabhu on May 6

**NEW DELHI (TIP):** India is looking forward to the visit of US commerce secretary Wilbur Ross next week as an opportunity to discuss several contentious issues, including Washington's withdrawal of benefits under the GSP programme and the ending of exemptions to sanctions on Iranian oil imports.

Ross, who is visiting New Delhi to participate in the Trade Winds Business Forum and Mission, the US commerce department's largest annual trade mission, is scheduled to meet commerce minister Suresh Prabhu on May 6, people familiar with developments said.

"There is a bilateral [between the US and India]," said a commerce ministry official who did not wish to be named.

The people said the visit will allow the two sides to discuss the US sanctions on Iranian oil imports, which kicked in on Thursday, and trade issues such as Washington's impending withdrawal of benefits under the Generalised System of Preferences (GSP) programme.

External affairs ministry spokesperson Raveesh Kumar told a news briefing on Thursday that commercial considerations and "legitimate energy and commercial security interests" will guide India's decisions on future oil imports.

India will get additional supplies from other oil-producing countries based on a "robust plan" drawn up by the petroleum ministry, he added.

## PepsiCo withdraws cases against potato farmers in Gujarat

**NEW DELHI (TIP):** Snacks and beverages maker PepsiCo India Holdings Pvt Ltd has decided to withdraw lawsuits it had filed against nine Gujarat farmers for allegedly growing a potato variety owned by the company without its permission.

The company had registered cases of infringement of proprietary rights against four farmers in April 5 and five in 2018, demanding Rs 1 crore from each in damages. Pepsico, one of the world's largest multinational corporations, had to face widespread backlash from farmers for bringing the lawsuits. Its legal action had sparked outrage among farm activists.

The company had claimed that the farmers had grown potatoes of a variety known as FL2027, which it had developed and registered as a protected strain under the Protection of Plant Varieties and Farmers' Rights Authority. The Gujarat government was involved in talks between farmer groups and the company to settle the matter. "After discussions with the government, the company has agreed to withdraw cases against farmers," Pepsico said in a statement Thursday. The company had pressed charges of infringement of its exclusive rights over the seed variety, which it uses in Lay's crisps, under sections 28 and 64 of The Protection of Plant Variety and Farmers Right Act, 2001.

Farm activists however claimed that section 39 of the Act allows Indian farmers to freely grow, use or sell a proprietary or a protected variety of seed as long as they don't sell it as a "branded" item.

"Pepsico had wrongfully charged the farmers because the same Act gives farmers the freedom to use or grow protected seeds. The Indian legal system governing agricultural innovations offers farmers full freedom, unlike in the US," said Kapil Shah of Jatan Trust.

# CHARLIZE THERON USED TO FEEL LIKE 'LOSER' AFTER WATCHING ROM-COMS






The Centerpiece film is "Photograph" by Ritesh Batra.

# Venezuela tense as Guaido supporters clash with army

CARACAS (TIP): May Day clashes between opposition supporters and Venezuela's armed forces in Caracas left a woman dead and 46 persons injured on Wednesday, with opposition leader Juan Guaido attempting to rally demonstrators against President Nicolas Maduro.

Jurubith Rausseo (27), died at a clinic after being hit by a "bullet in the head during (a) demonstration," the non-governmental Venezuelan Observatory of Social Conflict said on Twitter, condemning her "murder." Human rights organisations and health services reported 46 people injured in Wednesday's clashes, including one person with a gunshot wound.

Tensions in Venezuela have soared since Guaido, who heads the National Assembly legislature, invoked the constitution to declare himself acting president on January 23, claiming Maduro's re-election last year was illegitimate. National Guard troops fired tear gas at stone-throwing protesters attempting to block a highway close to the air base in eastern Caracas where Guaido had tried on Tuesday to spark a military uprising.

second day of confrontations between opposition supporters and Maduro's security services came as the United States said it was prepared to take military action, if necessary, to stem the crisis in the South American nation.

At least one journalist was injured when National Guard soldiers fired rubber bullets at a group of reporters



covering the clashes.

Miguel Ramirez, 17, told AFP at one medical center that he had been shot in the foot while protesting on the highway near the La Carlota air base. "I didn't manage to run and hide," he said.

Guaido rallied his supporters in Caracas in the Labor Day demonstrations, urging them to stay in the streets.

His appeal came despite the apparent failure the day before of a revolt by some soldiers and members of the Bolivarian National Guard who joined his side.

In Tuesday's clashes, one person was killed and dozens injured, according to

human rights monitors. More than 150 people were arrested, the government and human rights organizations said.

UN Secretary General Antonio Guterres warned Venezuela's authorities not to use deadly force against demonstrators, while the US and Russia accused each other of making the crisis worse, evoking Cold War confrontations of the past.

In a phone call with Russian Foreign Minister Sergei Lavrov, US Secretary of State Mike Pompeo accused Moscow of "destabilising" Venezuela. Lavrov, in turn, charged that US interference was "destructive" and "in flagrant violation of international law." — AFP

## Putin fast tracks Russian citizenship for Ukrainians

MOSCOW (TIP): Russian President Vladimir Putin has signed a new decree fast-tracking Russian citizenship for some Ukrainians despite concerns the move will exacerbate the crisis between the countries.

Under a decree published on Wednesday, several categories of Ukrainian nationals will have the right to a simplified nationality process including those who already have Russian residence permits.

Other categories include Ukrainian citizens who were born in Crimea but left the peninsula before Russia annexed it in March 2014.

The fast-track procedure is implemented to protect "rights and human and civil freedoms", said the decree which Putin signed on Monday.

The move comes after a comedian with no political experience, Volodymyr Zelensky, won a landslide victory in presidential elections in Ukraine last month. The Kremlin has not congratulated Zelensky while Putin said Moscow was thinking of making it easier for all Ukrainians to obtain Russian citizenship.

Putin had already signed a decree on April 24 allowing people living in breakaway regions of eastern Ukraine to



receive a Russian passport within three months of applying for one.

President-elect Zelensky, in response, pledged to grant Ukrainian citizenship to Russians who "suffer" under Kremlin rule.

There were hopes bilateral ties might improve under a Zelensky presidency but that is now looking unlikely, analysts say.

Kiev and the West have condemned the Kremlin, accusing Putin of seeking to further destabilise Ukraine, while critics at home say the moves would be a major

burden for the already-struggling Russian economy.

After a pro-Western uprising in Kiev ousted a Kremlin-backed regime in 2014, Moscow annexed Crimea and extended support to Russian-speaking separatists in eastern Ukraine.

Some in Kiev and the West worry that Moscow's offer of citizenship to Ukrainians would give the Kremlin a justification to move troops across the border under the pretext of protecting the interests of Russian nationals. — AFP

## AXED BRITISH DEFENCE SECY DENIES ROLE IN HUAWEI LEAK

LONDON (TIP): Gavin Williamson, sacked as Britain's Defence Secretary by Prime Minister Theresa May for allegedly disclosing plans to allow Chinese telecommunication giant Huawei to help build the UK's 5G network, has denied leaking any information from the National Security Council. His comments have come amid calls for a police inquiry into it. Opposition MPs say there should be an investigation whether the Official Secrets Act had been breached, the media reported.

Williamson was quoted in several newspapers on Thursday as saying he was the victim of a "vendetta" and a "kangaroo court". He told Sky News he "swore on his children's lives" that he was not responsible for the leak.— IANS

## ELDERLY AUSSIE COUPLE SIGN FOR DRUG SHIPMENT AFTER DELIVERY MIX-UP

MELBOURNE (TIP): An elderly couple in Australia were the surprise recipients of an illegal drug shipment after signing for a wrongly delivered parcel containing millions of dollars' worth of methamphetamine, police said on May 2.

The Melbourne couple immediately called police when they discovered bags containing the white powder in the parcel on Wednesday, a police spokesman said. The package contained what police said were 20 kilograms (44 pounds) of methamphetamine with an estimated street value of AU\$ 10 million (US\$7 million). Police subsequently searched a house in another part of Melbourne where they found 20 more kilograms of the drug and arrested a 21-year-old man. He was charged on May 2 with importing a marketable quantity of a controlled drug and was due to appear in court later in the day, police said.

Police asked that the unwitting couple who helped catch the man not be identified by the media out of concern for their safety. AFP

## UK PANEL GRILLS TWITTER, FB OVER ABUSE AGAINST WOMEN

LONDON (TIP): The UK Parliamentary Human Rights Committee has grilled Twitter and Facebook representatives over violent and misogynistic abuse of women users, including women MPs. MP Joanna Cherry accused Twitter "of displaying a pattern of relaxed tolerance to tweets containing violent attacks on women". "There seems to be a pattern of Twitter initially ruling that extremely offensive and violent tweets directed at women in public life are acceptable, and that Twitter only reviews their decision when they are pressed by other figures in public life," The Guardian reported. IANS

# Unwanted sexting can lead to psychological distress


Latest findings draw a link between sexting and psychological distress among young adults.

While sending or receiving nude electronic images may not always be associated with poorer mental health, being coerced to do so and receiving unwanted sexts was linked to a higher likelihood of depression, anxiety, and stress symptoms, a recent study suggests.

As part of the study, the researchers found that receiving unwanted texts and sexting under coercion was also associated with lower self-esteem. Furthermore, males receiving unwanted sexts had poorer mental health outcomes.

The findings of the study were published in the Journal of Cyberpsychology, Behavior, and Social Networking.

"With more of our lives playing out online, sexting and other seemingly private communications may be contributing to an indelible digital footprint. Digital sex is a much-needed

# Bread Biryani

## Ingredients

Basmati rice - 1 cup, Coconut milk - 1 1/2 cup, Green peas - 1/4 cup, Radish - 1/4 cup, grated, Carrot - 1/4 cup, grated, Coconut - 1/4 cup, grated, Onions - 2, chopped, Bread slices - 4, crusts removed, sliced in small pieces, Cashews - 5, Almonds - 5, soaked, peeled, Black pepper powder - 1/2 tsp, Cumin powder - 1/2 tsp, Gasa gasa - 1 tsp, Cardamom - 1, Cloves - 1, Cinnamon - 1, Ginger garlic paste - 1 tbsp, Ghee - 3 tbsp, Curry leaves - few, Coriander leaves - few, Salt as per taste

## Method

- Dry roast and grind the cardamom, cloves and cinnamon to a fine powder.
- Heat little ghee in a pan.
- Fry the basmati rice for 30 to 45 seconds.
- Remove and keep aside.
- Add a little ghee to the pan and fry the bread pieces till crisp.
- Keep aside.
- Grind the almonds, cashewnuts, coconut and gasa gasa to a smooth paste.
- Heat a little ghee in a pressure cooker.
- Add the cinnamon powder, ginger garlic paste, onions, salt and curry leaves.
- Saute well for a minute or two.
- Add the radish, carrot, green peas and ground coconut paste.
- Stir well and add the coconut milk.
- Bring to a boil.
- Add the rice and pressure cook till 2 whistles.
- Add the cumin powder, pepper powder, bread slices, coriander leaves and mix well.

# PANEER SPINACH DAL

## Ingredients

Moong Dal - 500 gms, Tomato - 1, small, finely chopped, Onion - 1, small, finely chopped, Oil - 2 tbsp, Garlic - 2 cloves, crushed, Ginger - 3/4 tsp, grated, Coconut Milk - 750 ml, Paneer - 400 gms, cubed, Spinach Leaves - 200 gms, chopped, Coriander Leaves - handful, Salt as per taste



## Method

- Wash and rinse the dal.
- Boil for 10 to 15 minutes until tender and drain well.
- Heat oil in a pan over medium flame.
- Saute the tomatoes, onions, ginger and garlic for 3 minutes.
- Add the coconut milk and cooked dal to the pan.
- Simmer for 5 to 10 minutes.
- Heat little oil in a nonstick pan.
- Fry the paneer cubes until light golden brown and keep aside.
- Add the spinach leaves to the dal and mix well.
- Cook for 5 minutes and add the fried paneer pieces.
- Simmer for a minute and remove from flame.
- Garnish with coriander leaves.
- Serve as a side dish to naan, roti or fried rice.

# SUFFERING FROM HIGH BP? DON'T TAKE WORK STRESS LIGHTLY

If you are finding it hard to deal with the pressure at the workplace, there is more reason to worry. New research has found that work stress and impaired sleep are linked to a threefold higher risk of cardiovascular death in employees with hypertension.

"Sleep should be a time for recreation, unwinding, and restoring energy levels. If you have stress at work, sleep helps you recover," said study author Karl-Heinz Ladwig, Professor at Technical University of Munich, Germany.

"Unfortunately poor sleep and job stress often go hand in hand, and when combined with hypertension the effect is even more toxic," Ladwig said.

The study included around 2,000 hypertensive workers aged 25-65, without cardiovascular disease or diabetes.

Compared to those with no work stress and good sleep, people with both risk factors had a three times greater likelihood of death from cardiovascular disease, showed the findings published in the European Journal of Preventive Cardiology. People with work stress alone had a 1.6-fold higher risk while those with only poor sleep had a 1.8-times higher risk, the study said.

In the study, work stress was defined as jobs with high demand and low control—for example when an employer wants results but denies authority to make decisions. "If you have high demands but also high control, in other words you can make decisions, this may even be positive for health," said Ladwig.

## NATURAL WAYS TO LOWER YOUR BLOOD PRESSURE

### Walk and exercise regularly

Exercise is one of the best things you can do to lower high blood pressure. Regular exercise helps make your heart stronger and more efficient at pumping blood, which lowers the pressure in your arteries.

### Reduce your sodium intake

Salt intake is high around the world. In large part, this is due to processed and prepared foods. For this reason, many public health efforts are aimed at lowering salt in the food industry.

### Drink less alcohol

Drinking alcohol can raise blood pressure. In fact, alcohol is linked to

16% of high blood pressure cases around the world. While some research has suggested that low-to-moderate amounts of alcohol may protect the heart, those benefits may be offset by negative effects.

### Eat more potassium-rich foods

Potassium is an important mineral. It helps your body get rid of sodium and ease pressure on your blood vessels. Modern diets have increased most people's sodium intake while decreasing potassium intake.

To get a better balance of potassium to sodium in your diet, focus on eating fewer processed foods and more fresh, whole foods.

# Breastfeeding important for brain growth of premature babies

Feeding premature babies mostly breast milk during the first month of life appears to stimulate more robust brain growth, suggests a recent study.

The details were presented in the Meeting Pediatric Academic Societies.

"Our previous research established that vulnerable preterm infants who are fed breast milk early in life have improved brain growth and neurodevelopmental outcomes. It was unclear what makes breastfeeding so beneficial for newborns' developing brains. Proton magnetic resonance spectroscopy, a non-invasive imaging technique that describes the chemical composition of specific brain structures, enables us to measure metabolites essential for growth and answer that lingering question," said Catherine Limperopoulos, Director of MRI Research.

The research-clinicians enrolled babies with low birth weight (less than 1,500 grams) and 32 weeks gestational age or younger at birth in the first week of life. The team then gathered data from the right frontal white matter and the cerebellum - a brain region that enables people to maintain balance and proper muscle coordination and that supports high-order cognitive functions.

The team generated light signatures for key metabolites and calculated the quantity of each metabolite.

- Cerebral white matter showed significantly greater levels of a molecule similar to glucose for babies fed breast milk, compared with babies fed formula.
- And the percentage of days infants were fed breast milk was associated with significantly greater levels of both



water-soluble nutrients.

- "Key metabolite levels ramp up during the time babies' brains experience exponential growth. Seeing greater quantities of this metabolite denotes more rapid changes and higher cellular maturation. Choline is a marker of cell membrane turnover; when new cells are generated, we see choline levels rise," said Katherine M. Ottolini, the study's lead author.
- Already, children's national leverages an array of imaging options that describe normal brain growth, which makes it easier to spot when fetal or neonatal brain development goes awry, enabling earlier intervention and more effective treatment.



## Comfort food leads to more weight gain during stress

Indulging in high-calorie 'comfort' foods when you are stressed can lead to more weight gain than usual, scientists say.

Researchers from the Garvan Institute of Medical Research in Australia discovered a molecular pathway in the brain, controlled by insulin, which drives the additional weight gain.

Using an animal model, the team showed that a high-calorie diet when combined with stress resulted in more weight gain than the same diet caused in a stress-free environment.

"This study indicates that we have to be much more conscious about what we're eating when we're stressed, to avoid a faster development of obesity," said Herbert Herzog, who led the study.

Some individuals eat less when they're stressed, but most will increase their food intake—and crucially, the intake of calorie-dense food high in sugar and fat.

To understand what controls this 'stress eating', the team investigated different areas of the brain in mice.

While food intake is mainly controlled by a part of the brain called the hypothalamus, another part of the brain—the amygdala—processes emotional responses, including anxiety.

"Our study showed that when stressed over an extended period and high calorie food was available, mice became obese more quickly than those that consumed the same high fat food in a stress-free environment," said Kenny Chi Kin Ip, lead author of the study published in the journal Cell Metabolism.

At the centre of this weight gain, the scientists discovered, was a molecule called NPY, which the brain produces naturally in response to stress to stimulate eating in humans as well as mice.

"We discovered that when we switched off the production of NPY in the amygdala weight gain was reduced. Without NPY, the weight gain on a high-fat diet with stress was the same as weight gain in the stress-free environment," said Ip.

"This shows a clear link between stress, obesity and NPY," he said. To understand what might control the NPY boost under stress, the scientists analysed the nerve cells that produced NPY in the amygdala and found they had receptors, or 'docking stations', for insulin—one of the hormones which control our food intake.

Under normal conditions, the body produces insulin just after a meal, which helps cells absorb glucose from the blood and sends a 'stop eating' signal to the hypothalamus feeding centre of the brain.



## PLASMA-SPEWING BLACK HOLE DRAGGING SPACETIME

**A**stronomers have discovered a black hole, almost 8,000 light-years from Earth, pumping rapidly swinging plasma jets into the surrounding universe at a speed so fast that it is dragging spacetime.

The research, published in the journal *Nature*, shows jets from V404 Cygni's black hole behaving in a way never seen before on such short timescales.

The jets appear to be rapidly rotating with high-speed clouds of plasma—potentially just minutes apart—shooting out of the black hole in different directions.

"This is one of the most extraordinary black hole systems I have ever come across," said Associate Professor James Miller-Jones, from the Australia's Curtin University node of the International Centre for Radio Astronomy Research (ICRAR).

Like many black holes, it is feeding on a nearby star, pulling gas away from the star and forming a disk of material that encircles the black hole and spirals towards it under gravity.

## MICROSOFT 365 GETS MORE PRIVACY CONTROLS

**W**ith the aim of helping organisations strengthen their data privacy practices, Microsoft has added new features to 'Microsoft 365' that include controls to automatically expire or revoke access to encrypted emails and data investigation capabilities.

'Microsoft 365' is an integrated bundle of Windows 10, Office 365 and Enterprise Mobility and Security (EMS) solutions by the tech giant, sold on a subscription basis.

"Now with Office 365 Advanced Message Encryption, admins have additional controls to automatically expire or revoke access to encrypted emails through a secure web portal," Rudra Mitra, Partner Director of Microsoft 365 Security and Compliance, wrote in a blog post on Tuesday.

"For example, with Advanced Message Encryption, you can leverage sensitive information types—such as health IDs—and automatically encrypt and expire the message after 30 days, which may be specified by the organisation's internal or external compliance requirement," Mitra added.

The update in Microsoft 365 also allows organisations to quickly delete sensitive information in the event of a data leak.

"In the event of a data leak, you can create an investigation to search and identify impacted content or people then delete the email messages that may contain confidential information to prevent end users from accessing the content," Mitra said.

Microsoft also added new features in Teams, including data loss prevention and information barriers, to help organisations prevent sensitive information unintentionally being shared or leaked when using Teams.



# NETFLIX SAYS ITS NEW HIGH-QUALITY AUDIO IS EQUIVALENT TO A MASTER

**N**etflix announced today that it's bringing "studio quality" sound to its audiences. The company is increasing its audio bitrate up to 640 kbps on devices that support 5.1 surround sound and up to 768 kbps for Dolby Atmos—though you'll need to be a Premium subscriber for that. It's also bringing adaptive streaming, a feature it's long used for video, to your speakers. So, your audio bitrate will be based on network conditions and device performance limitations.

The goal is to make the sound more crisp, more immersive and to "bring the viewer closer to the story." It also helps out users with slower internet connections, since the adaptive streaming can scale down audio quality, instead of stopping the video and forcing it to re-buffer.

According to Netflix, its "high-quality sound feature is not lossless, but it is perceptually transparent." So while the audio will be compressed, you won't notice the difference between what your surround sound system delivers and the studio version—or so Netflix says. Through internal tests, Netflix



determined that, for Dolby Digital Plus, 640 kbps is the point at which additional quality is imperceptible, and for Dolby Atmos, Netflix says the threshold is 768 kbps. Theoretically, bitrates higher than that would only slow devices. Some audiophiles might disagree.

Apparently, the changes were inspired by the Duffer Brothers. When Netflix invited the duo to view *Stranger Things 2* in a living room setting to get a feel for audiences' perspective, they

were less than impressed with the way the audio came across. Netflix boosted the bitrate for the show, and since then, it says it's been working to roll out similar improvements more broadly. Of course, this could just be an easy bullet point to highlight the next time Netflix decides to raise prices.

"The challenge is bringing this to the most members possible," Sean Sharma, Netflix's director of engineering, said during an interview with Engadget.

## Google to let you auto-location tracking data



**I**n yet another bid to address privacy concerns, Google is rolling out a key feature that will allow people to automatically delete their Location History, Web and App Activity data.

Google last year courted controversy when an Associated Press investigation found that many Google services on Android devices and iPhones store users' location data even if the users explicitly used privacy settings to turn it off. In a blog post late Thursday, Google said it is introducing auto-delete controls for users' Location History and Web and App Activity data.

"Choose a time limit for how long you want your activity data to be saved—a three or 18 months—and any data older than that will be automatically deleted from your account on an ongoing basis," announced David Monsees, Product Manager, Google Search.

These controls are coming first to Location History, Web and App Activity and will roll out in the coming weeks.

"You should always be able to manage your data in a way that works best for you," added Marlo McGriff, Product Manager, Google Maps.

The company argued that when users turn on settings like Location History or Web and App Activity, the data can make Google products more useful for them a like recommending a restaurant or helping pick up where they left off on a previous search. "We work to keep your data private and secure, and we've heard your feedback that we need to provide simpler ways for you to manage or delete it," said Google.

## Water found in samples from asteroid Itokawa

**S**cientists, including one of Indian origin, have found water in the samples from the surface of asteroid Itokawa that were collected by the Japanese space probe Hayabusa.

The first-ever measurements of water contained in the samples from Itokawa suggest that impacts early in Earth's history by similar asteroids could have delivered as much as half of our planet's ocean water, said researchers from the Arizona State University (ASU) in the US.

Itokawa is a peanut-shaped asteroid about 1,800 feet long and 700 to 1,000 feet wide.

It circles the Sun every 18 months at an average distance of 1.3 times the Earth-Sun distance.

Part of Itokawa's path brings it inside Earth's orbit and at farthest, it sweeps out a little beyond that of Mars.

"We found the samples we examined were enriched in water compared to the average for inner solar system objects," said Ziliang Jin, a postdoctoral scholar in ASU's School of Earth and Space Exploration.

The team's idea of looking for water in the Itokawa samples came as a surprise for the Hayabusa project.

"Until we proposed it, no one thought to look for water," said Maitrayee Bose, an assistant professor at ASU.

"I'm happy to report that our hunch paid off," said Bose, co-author on the researcher paper published in the journal *Science Advances*.

In two of the five particles, the team identified the mineral pyroxene. In terrestrial samples, pyroxenes have water in their crystal structure.

Bose and Jin suspected that the Itokawa particles might also have traces of water, but they wanted to know exactly how much.

Itokawa has had a rough history involving heating, multiple impacts, shocks, and fragmentation.

These would raise the temperature of the minerals and drive off water, researchers said.

# TRUMP AGAIN GOES AFTER INDIA ON TRADE

## SAYS IT SLAPS 'BIG TARIFFS' ON AMERICAN PRODUCTS

**WASHINGTON (TIP):** US President Donald Trump has criticised India's "big tariffs" on American paper products and the iconic Harley-Davidson bikes, saying the US has been losing billions of dollars to countries like India, China and Japan.

Addressing a Republican political rally in Wisconsin state's Green Bay city on Sunday, Trump alleged that every country has been ripping off America for years.

The President has repeatedly claimed that India is a "tariff king" and imposes "tremendously high" tariffs on American products.

"For so many decades we've been losing tens of billions of dollars to China and Japan, and India, and name any country and we lost, but we're not losing anymore," he said to his cheering supporters.

He said that the US was being charged high tariffs on foreign paper products.

"We charge other countries zero tariffs on foreign paper products, but when Wisconsin paper companies export it abroad... China charged us big tariffs, India charged us big tariffs, Vietnam charge us massive tariffs," Trump said.

He claimed that people of the US demanded a government that puts America first.

"And we're doing that with China, we're



doing that with India, we're doing that with Japan, we're doing it with a great new trade deal, that hopefully will get approved in the house," the President said.

Early this year at a White House event to announce his support for reciprocal tax, Trump had said that he was satisfied with the Indian decision to reduce the import tariff on high-end Harley-Davidson motorcycles from 100 per cent to 50 per cent.

The President said that he called up Prime Minister Narendra Modi on the issue of tariffs on Harley-Davidson motorcycles.

"Look at Harley-Davidson. I met with them three years ago, they would tell me tough to do business in certain kind. I

asked 'How you're doing in India?' and they said, 'Oh, we don't do any business'. They weren't even complaining because so many years.

"So India charged a 100 per cent tariff on Harley-Davidson, but when they send their motorcycles and they may come to us, we charge them nothing," Trump said.

"So I called up Prime Minister Modi, I said unfair, he cut it 50 per cent... But that's not good enough because look, it's 50 per cent to nothing. And what we're doing is changing all of that stuff, changing all of that rapidly," he added.

India is pressing for exemption from the high duty imposed by the US on certain steel and aluminium products, resumption of export benefits to certain domestic products under the Generalised System of Preferences (GSP) programme, greater market access for its products from agriculture, automobile, automobile components and engineering sectors.

On the other hand, the US is demanding greater market access through a cut in import duties for its agriculture goods, dairy products, medical devices, IT and communication items. India has stated that it would be difficult for them to cut duties on IT products.

## India manufacturing, retail top priority: Apple CEO Tim Cook



**CUPERTINO (TIP):** Reiterating that India is an important market for Apple, CEO Tim Cook said the current iPhone manufacturing will see maximum growth in days to come amid the renewed push to open its branded retail stores in the country.

In an earnings call with analysts after declaring its Q2 results late Tuesday, Cook said the company has made some "adjustments in India and have seen preliminary some better results there".

"India is a very important market in the long-term. It's a challenging market in the short-term. But we're learning a lot. "We have started manufacturing there which is very important to be able

to serve the market in a reasonable way. And we're growing that capability there," said the Apple CEO.

Giving an impetus to its India manufacturing plans, Apple has started

the assembling of iPhone 7 at its supplier Wistron's facility in Bengaluru. Taiwanese industrial major Wistron already assembles iPhone 6S in the country. Cook also emphasised on the company's plans to open its branded stores in India.

"We would like to place retail stores there. And we're working with the government to seek approval to do that. And so, we plan on going in there with sort of all of our might," said Cook.

Apple is slowly but steadily strategising its plans to make deeper inroads in a country where over 450 million people use smartphones, mostly Android and from China.

## APPLE LOGS \$58-BN REVENUE, SERVICES HIT RECORD HIGH

### CUPERTINO (TIP):

Riding on the growth in its Services and wearable segments, Apple has posted a revenue of \$58 billion for its second quarter of 2019 — a decline of 5 per cent from the year-ago quarter.



The revenue from iPhones was \$31.05 billion — down from the year-ago quarter but enough to make up over 53 per cent of the entire revenue.

The revenue from Apple's non-hardware business like iCloud, Apple Music and App Store surged to \$11.5 billion this quarter.

"Our March quarter results show the continued strength of our installed base of over 1.4 billion active devices, as we set an all-time record for Services, and the strong momentum of our Wearables, Home and Accessories category, which set a new March quarter record," Apple CEO Tim Cook said in a statement late Tuesday.

This is a good quarter for Apple compared to the last one where the company admitted poor iPhone sales and revised its earnings guidance. The iPhone sales had fallen 15 per cent from the year prior in Apple's first quarter.

## MARUTI SALES SKID 17%

**NEW DELHI (TIP):** The country's largest car maker Maruti Suzuki India today reported 17.2% decline in sales at 1,43,245 units in April.

The company had sold 1,72,986 units in April last year, Maruti Suzuki India (MSI) said in a statement.

Domestic sales declined by 18.7% at 1,34,068 units last month as against 1,64,978 units in the year-ago month, it added. Sales of mini cars comprising Alto were at 22,766 units as compared to 37,794 units in April last year, down 39.8%.

Sales of compact segment, including models such as Swift, Celerio, Ignis, Baleno and Dzire, were down 13.9% at 72,146 units as against 83,834 units in April last year, the company said.



## Amazon's freight service has a truckload of rivals

**LOS ANGELES (TIP):** As Amazon.com Inc targets traditional brokerages that match shippers with truckers, it's also battling a bevy of startups - including Uber Freight and a company funded by the e-commerce giant's founder Jeff Bezos.

The world's biggest retailer made a splash in truck brokerage circles after Freight Waves reported on Friday that Amazon's service, launched in a handful of Northeastern states last summer, was discounting market rates by as much as one-third.

"The analysis suggesting dramatic undercutting of pricing is false," Amazon said in a statement.

The company - which is investing billions of dollars to build an air, sea and land shipping network to contain its own costs - has never been shy about squeezing the companies it seeks to unseat.

Analysts said its fight for a slice of the more than \$700 billion U.S. companies spend on trucking each year could pose a long-term threat to leading truck brokers like C.H. Robinson Worldwide and United Parcel Service.

But, they added, that could be offset by Amazon's penchant for competing with the companies that sell on its site or pay for



its services. "Not all customers will be looking to turn over their confidential supply chain data to Amazon, particularly larger players in the retail and consumer products businesses," Cowen & Co analyst Jason Seidl said in a note.

Investors are betting that technology can transform the fragmented truck brokerage business that ran for decades on personal relationships and telephone calls.

They've poured millions of dollars into startups like Uber,

Transfix and Convoy - the latter of which raised nearly \$270 million from Bezos and other backers.

Anheuser-Busch InBev, Colgate-Palmolive Co and other companies have kicked the tires on those startups, which aim to dominate by building a massive network of shippers and drivers.

Three shippers, who spoke on the condition of anonymity, said Uber Freight is pricing aggressively as it fights for a foothold and its parent Uber Technologies racks up massive losses.

David Uncapher, Owens Corning's director of global transportation until late last year, said Convoy's prices were 5 to 15 percent lower than the company's other brokers, which had far greater geographic reach.

Amazon declined to comment on Convoy, which did not immediately respond to a request for comment.

Skeptics said startups don't have a lock on new technology and noted that Coyote Logistics, the truck brokerage UPS bought for \$1.8 billion in 2015, did a better-than-expected job of holding down the delivery company's costs during the 2018 holiday shipping surge.

He provided them with the virtue of fearlessness, known as abhaya, from all sorts of material entrapment and anxieties. Akshaya Tritiya's festivities have a similar symbolism.

According to Bhagwad Gita, when the results of pious activities are exhausted, people return to this mortal planet again from Swargaloka (heaven). If they have done bad deeds, then they are pushed into the dark regions of hellish planets where they suffer incessantly.

This day, however, also carries Lord Vishnu's blessings. Any pious deed performed on this day is carried forth by the doer and they can reap eternal benefits from it. Akshaya Tritiya generally falls in late April or early May. Mostly it is celebrated on the 108th day of the year. This festival of immortality is equally revered by the Hindu and Jain community and is associated with various traditions and rituals. It is said that any initiative taken on this day awards the person with unending merits throughout their life. This year Akshaya Tritiya falls on May 7.

Did you know that there is another aspect of a Chandan Yatra that's associated with Akshaya Tritiya. The festival of Chandan Yatra is celebrated in Vrindavan and Jagannath Puri, whereby the deities of Lord Krishna and his forms are decorated with huge amounts of sandalwood paste, completely covering his entire body in chandan.

#### History of Akshaya Tritiya

The celebration of every festival in Vedic religion is associated with a story mentioned in the scriptures. The pious day of Akshaya Tritiya, blessed by Lord Vishnu, is loaded with spiritual significance.

#### The starting of Treta Yuga

Every yuga has a starting day and an ending day. The second celestial cycle or Treta Yuga (having a span of 1,296,000 years) started on the auspicious day of Akshaya Tritiya.

#### Commencement of compilation of the Mahabharata

Srila Vyasa Deva started the great herculean task of compilation of the great epic Mahabharata with Lord Ganesha on this day.

#### The appearance day of Lord Parshuram

As per Skand Purana, Lord Parshuram, the son of Mahrishi Jamdagni and Mother Renuka appeared on this day.

#### The meeting of Lord Krishna and Sudama

It is said that on this day, Lord Krishna's Brahmin friend Sri Sudama visited him in Dwarika and offered him a handful of chipped rice as an offering out of unconditional love.

#### Breaking of one year-long fast by Lord Rishabhdeva

According to Jain literature, it is said that Lord Rishabhdeva, the first Jain Tirthankara broke his one-year long fast on this day, which he had been observing by drinking only sugar cane juice.

#### Receiving of Akshaya Patra by the Pandavas

Lord Krishna gave the Pandavas, an Akshaya Patra or an imperishable vessel, during their period of exile. It provided them with a supply of an infinite amount of food.

#### The commencement of 21 days of Chandan Yatra

The devotees in Jagannath Puri and Vrindavan smear the idols' faces with a huge

amount of sandalwood paste. They do that in order to give them relief from the scorching heat of the summer. This is in accordance with the time that occurred with Srinathji of Nathdwara and his dear devotee, Sri Madhvendra Puri.

#### The opening of the doors of Lord Badrinath

On this day, doors of Lord Badrinath are opened and devotees go and worship him.

#### The lotus feet darshan of Sri Bankey Bihari in Vrindavan

Only on this day, there is Mangala Aarti in Sri Bankey Bihari Mandir of Vrindavana and people get a chance to have a darshan of his lotus feet.

#### Significance of Akshaya Tritiya

The day of Akshaya Tritiya holds great significance for the Hindus and Jains. They perform various rituals on this day to keep their mind and heart sacred. Following the advice of the shastras, some people observe fast on this day and worship Lord Krishna with 16 items of puja, called Shodashopchar Puja. People visit temples and offer items such as grains, wheat, rice, clothes, gold, gemstones, water, etc., in charity to the Brahmins and the poor and needy people. Many people organise a big community feast called bhandara and feed people.

It is also a custom to purchase some gold and other valuable items on this day as it is believed that purchasing gold will provide one with the blessings of Goddess Lakshmi and allow prosperity and wealth to flourish at home.

According to astrology, Akshaya Tritiya is considered as the day when the lines of destiny or fate change and, hence, people are advised to propitiate and venerate the deities so as to get their blessings. As per Muhurat Chintamani, the day of Akshaya Tritiya is considered as Swayam Siddha Muhurat. Any auspicious work can be done on this day without worrying about timings. Hence, a lot of weddings and other auspicious ceremonies take place on this day.

**MIDDLETOWN, OH (TIP):** Dalvir Singh from India, age 24, who is addicted to heroin, was taken into custody by Middletown Division of Police in Ohio and charged with 2 counts of Kidnapping, felonious assault for dragging an elderly lady, and grand theft.

On 4-25-2019 at 4:18pm the

Middletown Division of Police received a call that a car with children inside had been stolen at Atrium Medical Center and an elderly lady was injured. We found that Nita Coburn, age 69, had taken another woman to the hospital and her two grandchildren were with her in the back seat. When they got to the emergency room, Nita pulled up close to the door and was helping the other woman into the Emergency Room. About ten seconds after she got out of the car a man, Dalvir Singh, jumped into the driver's seat and took off with the children still in the back; an 8-year-old boy and a 10-year-old girl. The little boy opened the door to escape and the little girl started to jump out also, but the man grabbed the hoodie of the little girl not allowing her to leave. As she tried to get away her little brother grabbed hold of

her and pulled her away from the kidnapper and they both tumbled out of the vehicle as it was moving.

Nita didn't realize the children were able to escape because they flew out of the passenger side and by this time, she was chasing the car on the driver's side. Nita opened the driver's

door to regain control of the vehicle she thought her grandchildren were in, Dalvir slammed the door shut again and locked the door. She hung onto the vehicle panicking because she thought the children were still inside. The vehicle drug her until it accelerated at a high rate of speed and she was forced to let go.

Officers Kirby and Engleka observed the stolen vehicle fleeing the scene on University Blvd. near Nelbar St. It was stopped and Dalvir Singh was taken into custody.

Chief Muterspaw stated, "This little guy is a hero. No question. He pulled his sister out of the car with no concern for his own safety. That is incredible at his age and outstanding work by Officers Kirby and Engleka to find the suspect and take him down without incident. So proud of their work".

## US LAWMAKERS PRAISE AAPI'S GROWING CLOUD IN ADVOCATING FOR EFFECTIVE HEALTH CARE IN US

In his opening remarks, AAPI Legislative Chairman - Dr. Vinod K. Shah, said, "AAPI is once again in the forefront in bringing many burning health care issues facing the community at large and bringing this to the Capitol and to the US Congress. This is an exciting time for Indo-US relations. Each of us, as part of AAPI, the largest ethnic organization, representing over 8,000 Indian American Physicians have a unique role to play in strengthening the relationship between India, the largest democracy and the US, the greatest democracy in the world."

Dr. Vinod Shah, who immigrated to the US 55 years ago, shared his own inspiring personal experiences, as to how he began his career as a cardiologist in a tiny remote region over a half a century ago, and today, he is proud to own and manage a series of large clinical practice serving millions of people across the state of Maryland.

"This immensely successful event, including our partnership with the Indian Embassy, has showcased AAPI's strength relationship building and maintaining ties with our elected officials," said AAPI Legislative Co-Chair - Dr. Sampat Shivangi. He emphasized "AAPI contributions in issues like lowering drug costs, strong advocacy on Immigration reforms, especially for physicians working in rural areas of the US and their long decades of waiting in acquiring Green Cards."

Dr. Shivangi, a veteran of several decades of service to AAPI and to the nation, highlighted the "many important issues that were discussed at the event, including the need to increase in Residency slots, Medicare and Medicaid reimbursements issues. Dr. Sampat Shivangi raised the issue of US-India trade relations, especially President Trump's remarks where he has called India as king of Tariiffs, with several US congressmen. Dr. Shivangi emphasized the importance of public awareness to discuss this issue, among others, to do away with some misgivings, with the help of think tanks and open dialogue with experts on this issue..

In his keynote address, Ambassador Hon Harsh Vardhan Shringala praised AAPI's lobbying efforts on some of the issues affecting the broader Indian American community and other immigrant groups is also a testament to its growth and reach. Being one of the oldest Indian American organizations, it's also among the most influential, as was evident from the number of members of Congress who took time out of their busy schedule to address the group.

"I believe all of you will have an important role to play in contributing to this. All of you in a sense are permanent Ambassadors here. You have an understanding of the US. You have an understanding of India and Indian

society. So based on this understanding and the network that you have you will be in a position to take forward this relationship in different areas," the Indian Envoy said.

Jason Marino - American Medical Association Senior Assistant Director, AMA Congressional Affairs, emphasized the need for more collaborative efforts between AAPI and AMA to have greater voice in healthcare policy making efforts on Capitol Hill.

In a detailed Report on Green Card delays affecting Indian American physicians, the Green Card Backlog Task Force pointed out that there are over 10,000 Physicians waiting for Green Card for decades. AAPI members would like to see the Green Card backlog addressed, which it says has adversely impacted the Indian American community. They stressed the need for bipartisan support to pass the Bill S-948 that will provide Green Cards to those serving in America's under-served and rural communities. The measure has garnered support from leading members of the Congress and seeks to remove the 7 percent cap on Green Cards on every country regardless of their size. It "will address many of the concerns facing the Indian American community," AAPI said in its list of demands.

The bipartisan members of Congress discussed ways to reform health care delivery, to ensure its cost-effectiveness, and the negative effects of defensive medicine, which has driven up the cost of health care. AAPI members told the gathering of both Republican and Democratic congressmen how important it was to increase the number of residency positions to address the upcoming physician shortage.

According to AAPI, there is an ongoing physician shortage, which affects the quality of care provided to American patients. There are patients who face lengthy delays in various specialties, a situation which will worsen over time. Legislation was introduced in previous sessions of Congress that would add 15,000 residency slots, training up to 45,000 more physicians, AAPI points out in its White Paper. "By adding more residency positions today, Congress can train more physicians to treat patients in the future," AAPI stated.

Rep. Steny Hoyer underscored the need for reforming the entire immigration process and make it equitable and fair. "We need to deal with the issue of H-1B and J-1 visas" and expand opportunities for highly skilled foreign workers and students, he told the gathering. "I still believe and always will that the United States will continue to grow. We need the best, the brightest and the bravest", he said.

About India-US relations, Hoyer, affirmed, "I believe it is the most important alliance of this century. We are in the second decade and we have seen incredible progress. I know that will continue", he said referring to shared values including a dedication to the rule of law and democracy.

Rep. Krishnamurthy, who is a physician himself praised AAPI's leadership's lobby Day for all Americans.

## UN DESIGNATES MASOOD AZHAR AS GLOBAL TERRORIST

Grateful to many countries who supported us i.e. the USA, UK and France and also several others in the council & outside the council; Would like to thank permanent representative of Indonesia", he said.

In a huge diplomatic victory for India and a blow to Pakistan, Masood Azhar was named a global terrorist by the UNSC 1267 Al-Qaeda Sanctions Committee on Wednesday, May 1 after China lifted its hold on a proposal in this regard by the United States, United Kingdom and France.

The US described this as 'Victory for American diplomacy'.

"Congrats to our team @USUN for their work in negotiating JEM's Masood Azhar's #UN designation as a terrorist. This long-awaited action is a victory for American diplomacy and the international community against terrorism, and an important step towards peace in South Asia", US Secretary of State Mike Pompeo tweeted.

'Imran's China trip played crucial role'

The "breakthrough" in designating Masood Azhar as a global terrorist came during Pakistan Prime Minister Imran Khan's recent visit to China where the two sides agreed to withdraw their opposition to the latest move to blacklist the JeM chief, a media report said here on Thursday.

The US, France along with the UK had moved the proposal to designate Azhar as a "global terrorist" in the UN Security Council's 1267 Al Qaeda Sanctions Committee in February, just days after the deadly Pulwama attack.

A veto-wielding permanent member of the UNSC, China was the sole hold-out in the 15-nation world body on the bid to blacklist Azhar, blocking four attempts since 2009 by placing a "technical hold" and asking for "more time to examine" the proposal.

Hours after sanctions were imposed on Azhar, the Express Tribune, quoting diplomatic sources, reported that Pakistan and China held extensive discussions before making a decision on the Azhar issue. "It is believed that the breakthrough came during the recent visit of PM Imran Khan to China where both sides agreed to withdraw opposition to the latest move after realising that Islamabad's concerns were addressed," the report said.

But the source told the paper that the listing does not mean the person should be detained. Another official claimed that authorities were "unaware" of Azhar's whereabouts. The report also claimed that Islamabad agreeing to the designation of Azhar as a global

terrorist was a "paradigm shift" in the country's approach.

An official said Khan had made a public commitment that Pakistan's soil would not be used against any country. (PTI)

## TRUMP PROPOSES NEW RESTRICTIONS FOR ASYLUM SEEKERS

Trump has signed a Presidential Memorandum April 29 to ensure legitimate asylum-seekers can access asylum while more efficiently processing and removing illegal migrants who are not eligible and who do not qualify.

"The biggest loophole drawing illegal aliens to our borders is the use of fraudulent or meritless asylum claims to gain entry into our great country", said Trump.

### The President is directing his Administration to propose regulations to:

Streamline the court proceedings for aliens who pass initial fear determinations.

Adjudicate all asylum applications in immigration courts within 180 days of filing.

Require fees for asylum applications and work permit applications.

Bar aliens who have entered or attempted to enter the country illegally from receiving provisional work permits prior to being approved for relief.

Immediately revoke the work authorization of aliens who receive final removal orders.

The President is directing the Secretary of Homeland Security to reprioritize the assignment of immigration officers to improve the integrity of credible fear adjudications, strengthen law enforcement, and enforce removal orders from immigration judges.

According to White House statistics, US immigration system has reached a breaking point as we continue to see an overwhelming surge of migrants, with more than 100,000 arriving at our border in March alone. As a result of loopholes in United States immigration law, migrants claiming fear are often released into communities across the United States, where they often remain indefinitely. In order to remain in the country, they often fail to show up to court hearings, fail to file an asylum application, or fail to comply with removal orders once their claims have been denied.

The White House further states that illegal migrants with meritless claims have used the asylum system to enter the US illegally and remain here indefinitely.

On average, out of every 100 aliens subject to expedited removal who claim a fear of persecution, only about 12 will

ultimately be granted asylum. Around half of all aliens who make a credible fear claim and are subsequently placed in removal proceedings do not actually apply for asylum.

The number of aliens who do not show up to court and are ordered removed in absentia has soared, with 17,200 removal orders issued in absentia in the first quarter of fiscal year (FY) 2019.

## MASSIVE SIKH DAY PARADE TAKEN OUT IN NEW YORK CITY

## INDIA GOVERNMENT REVISES POLICY ON CONSULAR SERVICES TO ASYLEES

of asylum-seekers, according to a report published in Times of India.

It is a big relief to Persons of Indian Origin (PIOs), mainly Sikhs, who have taken asylum in foreign countries as this will help the asylum-takers get consular services including visa and OCI services at their local Indian missions, as long as they are not on central black list approved by the home ministry.

Many of the beneficiaries will be asyleeshailing from Punjab who had taken asylum in countries like Canada and the US, citing fear of religious pursuit back home during the crackdown on pro-Khalistan movement. They had been facing problems in getting visa and OCI benefits in their respective Indian missions that maintain local black lists comprising names of such asylum-takers in addition to the central black list.

According to the report, the Modi government, acknowledging the sensitivities of many Sikh asylum-takers and their family members who have not been able to visit their native places or relatives even years after the end of Sikh militancy, has now issued instructions to all missions/posts abroad to abolish local black lists. The missions have been asked to provide all asylees and their family members, whose names do not figure in the central black list, consular services, including visa services and OCI-related benefits. At the same time, it has directed the missions to continue with the usual checks and due diligence in line with the existing orders.

Sources said the decision reflects the recognition that many of the asylum-seekers were in fact, economic migrants who were forced to pass themselves off as victims of political persecution in order to escape the bleak economic condition then back home.

The Indian Panorama reached out to Ambassador Sandeep Chakraborty, Consul General of India in New York, to verify the TOI report who said details and certain clarifications were awaited from government of India. Once, the picture is clear, he said, he will issue a press note. He also indicated he may invite community leaders to inform them of India government's revised policy with regard to providing consular services to the asylees.

integrate intelligence-gathering and coordinate with all investigating and intelligence agencies.

Though it was never established, the concept had some major lacunae. Unless the NCTC is empowered to conduct counter-terrorism operations like its US counterpart, on which the Indian version was expected to be based, urban terrorism will continue to remain a cause for concern. Without an effective NCTC or a similar organization, the planning and execution of India's counter-terrorism policies will remain mired in systemic weaknesses.

Post-incident investigation is aimed at unravelling the identities of the planners and the plotters and bringing to justice the perpetrators of the incident of terrorism. The National Investigation Agency (NIA) must be reconstituted as it lacks teeth in its present form. It should be re-modelled on the US FBI to give it both preventive and investigative powers. While there is no need to blindly ape any country, there is no harm in learning from the best practices abroad and incorporating them into Indian policies.

India's intelligence coordination and assessment apparatus at the national level and counter-terrorism policies remain mired in the days of innocence. We are now living in the age of 'new terrorism' that is far more violent and diabolical than before and policies must keep pace with the emerging developments. For example, with the Islamic State striving to extend its reach to India, counter-radicalization and de-radicalization policies must be formulated early.

form of chariots, mandapas (cave sanctuaries) and giant open-air reliefs. The famous sculptures of the temple are 'Descent of the Ganges', and the temple of Rivage, with thousands of sculptures to the glory of Shiva.

There are eight rathas at Mahabalipuram, out of which five are named after the 'Pandavas' (five brothers) of Mahabharata and one after Draupadi. The five rathas that can be seen are Dharmaraja Ratha, Bhima Ratha, Arjuna Ratha, Draupadi Ratha and Nakul Sahadev Ratha. These Ratha temples are constructed on the style of the Buddhist viharas and chaityas. The unfinished three-storey Dharmaraja Ratha is the largest. The Draupadi Ratha is the smallest, it is one-storeyed and has an interesting thatch-like roof. The Arjuna and Draupadi rathas are dedicated to Shiva and Durga respectively.

#### Panch Rathas

Panch Rathas is a monument complex at Mahabalipuram. The coastal city along the shores of Bay of Bengal was a major seaport of the ancient Pallava kingdom. It is currently one of the magnificent UNESCO World Heritage sites.

The Panch Rathas are five rock marvels in the monument complex. It is known for its,

times, Dharmaraja Ratha it the most magnificent and tallest of the Five rathas, with three storeys, though most of it remains incomplete.

The shrine is devoted to Shiva and is adorned with one of the best examples of early Pallava art. Very beautiful are the Shiva figures on the corners of structure. Dharmaraja Ratha contains engravings in Pallava Grantha script of the titles of Narasimhavarman I. Inscription mentions that this was created as Shiva temple of Atiyantakama Pallava. Especially fascinating is the sculpture of Lord Shiva in the form of Ardhanariswarar which is half man, half women.

#### Bhima Ratha

The longest of Five Rathas, the 12.8 m long, 7.3 m wide, 7.6 m high structure is built in Gopura style with gabled roof. It is said to be devoted to Anantshayi Vishnu as a large bas relief of Vishnu in the form of Sayanamurti is located inside. The building remains unfinished but fascinating. The sanctuary has a circumambulatory passage around it. Pillars of the shrine are adorned with figures of lions.

#### Arjuna Ratha

The Arjuna Ratha is devoted to Lord Shiva. Shaped like a small wooden shrine, the distinctive style in Southern India, it is an impressive building. Inside the shrine there are no embellishments, but the exterior is has interesting details. The facade is adorned with magnificent sculptures, showing gods and humans.

#### Nakula Sahadeva Ratha

This shrine is devoted to Indra and is associated with elephants. This ratha is the only one which is not placed in a "procession", it stands aside. The roof of this shrine is also shaped like a back of elephant. The relief sculpture of Ardhanariswara adorns the walls whereas columns and pillars are decorated with seated lions.

#### Draupadi Ratha

The Draupadi Ratha is the smallest of Panch Rathas. This shrine is shaped like a thatched hut, with a square roof. It is devoted to goddess Durga and has amazing artwork. The fine carved panel, which shows Durga on a lotus pedestal is marvelous. Outside, above the entrance door, is carved a sea-monster. The most interesting sculpture is Devi Durga standing on a head of the demon Mahishasura.

#### Dharmaraja Ratha

Shaped like a characteristic vimana (tower above the shrine) of Southern India of its

# Mumbai qualify for playoffs

**MUMBAI (TIP):** Mumbai Indians prevailed over Sunrisers Hyderabad in the Super Over to qualify for the IPL playoffs, the win propelling them to the second position in the pecking order.

Needing nine to win in the Super Over, Hardik Pandya hammered Rashid Khan for a six over long off in the first ball and then Kieron Pollard took the side home with three balls to spare. In the one-over eliminator, Sunrisers Hyderabad managed 8/2 with Jasprit Bumrah bagging the wickets of Manish Pandey and Mohammed Nabi.

Mumbai Indians captain Rohit Sharma said, "We are rewarded for some real hard work we have put in throughout the tournament. We played consistent cricket and have the results for it. We were very clear in the mind that we wanted to bat first and put runs on the board. We knew if we could get early wickets, we can put some pressure on them."

## Rs 50cr for IPL aderts

The IPL is considered one of the most popular tournaments in the world but even a top T20 league needs to be promoted and advertised. For this reason, BCCI had budgeted Rs 50 crore for advertisement and promotion of the 12th edition of the league. BCCI in its budget for the 2019 edition of the tournament pegged the expenses on advertising and promotion at Rs 50 crore. Interestingly, the 2018 edition had seen BCCI spending the same amount in promoting the tournament.



## Dhoni, Imran Tahir star as Chennai Super Kings maul Delhi Capitals

Chennai Super Kings (CSK) on Wednesday defeated Delhi Capitals (DC) by a whopping margin of 80 runs at the MA Chidambaram Stadium in Chennai. Batting first, CSK posted a total of 179-4 in 20 overs after a smashing half-century by Suresh Raina and late blitz by MS Dhoni and Ravindra Jadeja. Chasing the 180-run target, DC lost the plot as their batsmen got dismissed in regular intervals and were bundled out for a paltry score of 99 runs.

Suresh Raina roared back to form as he scored a brilliant 59 off 37 balls laced with eight boundaries and a six. Raina left behind his previous scores of 2, 38, 0 and 13 in his last four knocks and played a confident knock at a time when CSK had lost opener Shane Watson for a duck.

MS Dhoni continued his purple patch with the willow as he hammered an unbeaten 44 off 22 balls to help CSK post a competitive target of 179-4 in 20 overs. Dhoni was superbly supported by Ravindra Jadeja who smashed 25 players in 10 balls.

Imran Tahir continued to bamboozle batters as he ripped apart the DC batting lineup to pick up four wickets. Tahir took his wickets tally for IPL 2019 to 21 and is just behind Kagiso Rabada (25) in the Purple Cap race.

# AGE-OLD SECRET OUT: SHAHID Afridi WAS NO TEEN SENSATION

**NEW DELHI (TIP):** One of cricket's greatest mysteries has finally been solved...sort of.

Shahid Afridi, as many fans have long suspected, is not as young as official records have had it all these years. Afridi himself has made the revelation in his autobiography Game Changer released in India and Pakistan this week. In a chapter in which he describes his call-up to the senior Pakistan team in October 1996, Afridi writes that he was born in 1975. Though he doesn't give a month or day, that makes him, potentially, five years older than what he is: official records, including ESPNcricinfo's player profile pages record his date of birth as March 1, 1980.

Afridi debuted in an ODI tri-series tournament in Nairobi, and, most famously, hit a 37-ball hundred the first time he batted in international cricket. That record stood for over 17 years and was even more outrageous for the fact that it had been achieved by a 16-year-old. Except, now we know, he wasn't.

Yet Afridi only deepens the confusion in his book with the following line: "Also, for the record, I was just nineteen, and not sixteen like they claim. I was born in 1975. So, yes, the authorities stated my age incorrectly." If he was born in 1975, that would make him 20 or 21 at the time of the innings and not 19 as he writes.

He had arrived in Nairobi from the



Caribbean, where he was playing in an Under-19 series for Pakistan - which now suggests that he wasn't really under 19 at the time. Afridi has long retired from the international game though the admission adds a retrospective gloss to his performances in the PSL this season, where he played eight games for Multan Sultans and took 10 wickets conceding just 6.74 runs per over - all as a 43- or 44-year-old. The year 1975 would also mean that he was 34 or 35 when he suddenly retired from Test cricket in 2010, having returned after a four-year absence from the format - as captain - and staying for just one Test. It also means that when he finally played his last game for Pakistan at the 2016 World T20, he was not 36 but 40 or 41. Fans will recall another public admission of a real age, from a contemporary and team-mate of Afridi. After leading Pakistan to a memorable World T20 win in 2009, Younis Khan announced his retirement from the format, saying that he was 34 and "too old for this kind of cricket". By his official records, Younis was 31 at the time he made the statement; in fact, the number on his ODI shirt - 75 - was the real year of his birth, the same, incidentally, as Afridi's.

## ICC RANKINGS

### INDIA NUMBER 1 TEST SIDE, ENGLAND LEAD IN ODI

**NEW DELHI (TIP):** Virat Kohli's India continue to be the number 1 Test side while England have retained their top position as the ODI-side after the annual update today in which series results from 2015-16 are removed, and outcomes from 2016-17 and 2017-18 are weighted at 50 per cent.

India's lead over New Zealand in the MRF Tyres ICC Test Team Rankings has narrowed from eight to two points and England remain at the top of the MRF Tyres ICC ODI Team Rankings with their gap over India reduced to just two points in an expanded table.

**TEST RANKINGS:** India were on 116 points and New Zealand on 108 before the update but India's 3-0 win over South Africa and 2-1 win in Sri Lanka being purged as part of the 2015-16 season sees them losing three points while New Zealand's two 2-0 defeats to Australia being removed sees them gain three points.

In the only change of positions on the table, England have overtaken Australia to fourth position and are on 105 points. Australia are on 98 points after dropping six points as they had won four of the five series in 2015-16, no more part of the calculations. In another significant movement, the gap between seventh-placed Pakistan and eighth-placed West Indies has trimmed from 11 to two points.

**ODI RANKINGS:** England have retained the No. 1 ranking but to go into the World Cup as the top-ranked side, they will need to beat Ireland in an upcoming one-off ODI and then beat Pakistan 3-2 or better in a home series, or lose to Ireland but then beat Pakistan 4-1 or better.

South Africa have overtaken New Zealand into third position while another change in positions sees the West Indies moving ahead of Sri Lanka to seventh place. No team has dropped out of the top 10, thus ensuring that the World Cup will see the 10 top-ranked sides in action.

Three of the four teams awarded ODI status at the end of the World Cricket League Division 2 will join the rankings once they have played the requisite eight qualifying matches. However, PNG join the rankings immediately having played several ODIs prior to April 2018. The Netherlands, who already had ODI status, will need to play two more ODIs to achieve a ranking.

### Olympics champ Semenya loses at CAS, must reduce testosterone

**CAPE TOWN (TIP):** Olympics 800m champion Caster Semenya lost her appeal against rules that mean female athletes with high natural levels of testosterone must take medication to reduce it.

The Court of Arbitration for Sport (CAS) ruled the regulations were necessary for athletes with differences in sexual development (DSDs) to ensure fair competition.

But it also voiced concern about how the new rules, which cover events ranging from 400m to a mile, would be implemented by the International Association of Athletics Federations (IAAF), the sport's governing body.

Testosterone increases muscle mass, strength and haemoglobin, which affects endurance. Some competitors have said Semenya's higher levels of the hormone give her an unfair advantage.
