Trump launches 2020 re-election bid at a massive rally in Florida; promises to 'Keep America Great'

WASHINGTON (TIP): President Donald Trump has officially launched his 2020 re-election bid and appealed to his supporters to give him four more years to realize his unfinished agenda for the country, whose economy he boasted, has become the "envy of the world" under his watch.

Kick-starting his election campaign at a jam-packed rally in Florida on Tuesday, June 18, Trump coined a new slogan, "Keep America Great" and warned that opposition Democrats want to "destroy" the country.

"Tonight I stand before you to officially launch my campaign for a second term as President of the United States," Trump told supporters. "I promise you I will never ever let you down." The 73-year-old real estate investor-turned-politician, who became

reports, in those letters, Imran and Qureshi, while congratulating Modi and Jaishankar, renewed calls for resumption of dialogue to resolve all outstanding issues, including Kashmir.

No communication on H-1B visa cap received from US, says India



NEW YORK / NEW DELHI (TIP): According to a media report, the US is considering restrictions on H-1B visa that allow foreign professionals to work in that country.

However, India has not received any communication from the US on its reported decision to consider caps on H-1B work visa for nations that mandate storing of data locally, the Indian Foreign Ministry said on Thursday, June 20.

India had last year mandated payment firms to store customer data exclusively in the country without creating mirror sites overseas.

Indian American Receives Leaders for a New Chicago award

CHICAGO (TIP): Viveka Ray-Mazumder, manager of youth organizing and the KINETIC program at Asian Americans Advancing Justice | Chicago, who works to mobilize, coordinate, and encourage civic engagement and grassroots organizing among Asian American and immigrant youth in Chicago, has been named recipient of Leaders for a New Chicago award.

Last week, Chicago's Field Foundation, in partnership with the MacArthur Foundation, granted a total of \$700,000 worth in grants to 14 different individuals and their organizations as part of the Foundation's 2019 Leaders For a New Chicago project. The Leaders for a New Chicago award recognizes a range of established and emerging leaders who work across boundaries to build a Chicago that is responsive and equitable to all.

Viveka works with students in several public high schools to discuss the history and importance of Asian American voting in Chicago and will work with these young people on voter education and registration efforts in their communities. Prior to joining Advancing Justice | Chicago, she was a legal advocate for the Transformative Justice Law Project of Illinois, and an organizing intern with Herstory Writers Workshop in New York. Viveka holds a B.A. in Sociology from Middlebury College, where they led numerous workshops and trainings for students, staff, and faculty relating to issues of identity and social justice.

Indian American Pennsylvania Physicians Acquitted of Drug Charges

PENNSYLVANIA (TIP): Two Indian American physicians from Pennsylvania, have been acquitted of drug charges.

After an eight-day trial, Dr. Krishan Kumar Aggarwal of Moon Township and Dr. Cherian John, of Coraopolis, Pennsylvania, were found not guilty of drug charges, United States Attorney Bill Powell announced.

"The jury returned not guilty verdicts against Dr. Aggarwal and Dr. John. Notwithstanding the verdict, we remain steadfast in our intention to prosecute matters which we believe, based upon the evidence, support prosecution. Indian American UMass Chemistry Professor Honoured with Mahoney Life Sciences Prize

BOSTON (TIP): University of Massachusetts Amherst Professor of Chemistry Sankaran "Thai" Thayumanavan has been awarded the 2019 Mahoney Life Sciences Prize for his high-impact innovation of a way medications can deliver proteins into a cell body-by "shrink-wrapping" them.

Thayumanavan is recognized for his paper "Shrink-Wrapped Proteins as Next Generation Biologics," published in Journal of the American Chemical Society. At the Innovation & Entrepreneurship Showcase held in the Life Sciences Laboratories Conference Center on April 29, Thayumanavan was formally

presented the award, and gave a talk explaining his research, followed by a lively round of questions from the audience.

Established by alumni Richard '55, '83G, Robert '70, and William Mahoney '55, the \$10,000 Mahoney Prize recognizes researchers from the College of Natural Sciences whose work significantly advances connections between academic research in the life sciences and industry. The prize is bestowed annually to a faculty member who is principal author of a peer-reviewed paper about original research that has translatable applications to society.

Indian origin Kumar Iyer appointed New UK Foreign Office Chief Economist

LONDON (TIP): Kumar Iyer has been appointed by the UK Government as FCO Chief Economist and will take up his new role in July. Kumar Iyer also joins the FCO Management Board, making him the first Indian-origin member of the department's management board.

As FCO Chief Economist he will lead the FCO's Economics Unit which provides in-house economic analysis input into foreign policy formulation, and also develops economics capability within the FCO through the Economics and Prosperity Faculty of the Diplomatic Academy.

"I think living abroad during my early childhood gave me a sense of the world as a bigger place and I developed an interest in international issues that has always stayed with me. The role is a real privilege and marries my love of

economics with my interest in global diplomacy", said Iyer.

Born in London, Iyer spent a number of his childhood years living in India before returning to the UK aged 11 and living in Stoke-on-Trent. In addition to English, he grew up speaking Hindi and Tamil, which came to be useful when he was posted to India as British Deputy High Commissioner and Director General for Economics, Trade and Commercial Affairs in South Asia in 2013.

After leaving academia for consultancy, Kumar joined the Prime Minister's Strategy Unit as Deputy Director at the height of the global financial crisis during Gordon Brown's tenure as Prime Minister. He then moved to HM Treasury where his team was responsible for overall strategy and coordinated the Budget and Autumn Statements before joining the FCO.

Indian American IT professional in Iowa Committed Suicide, Says Police

DES MOINES, IOWA (TIP): Indian American IT professional Chandrasekhar Sunkara committed suicide by shooting himself while his wife and two sons were killed inside their home in Iowa, West Des Moines police who is probing the case, came to this conclusion after forensic autopsies were conducted. Chandrasekhar "Chandra" Sunkara, 44 was found deceased in his West Des Moines home Saturday June 15 morning along with his wife Lavanya Sunkara 41 and two sons - a 15-year-old boy and a 10-year-old boy. Police say other family members, two adults and two children, were staying as guests at 900 block of 65th Street where all four lived. When the victims were discovered, one of the survivors ran outside looking for help. He found someone walking through the neighborhood and that person called 911.

"West Des Moines police continue their investigation into the Sunkara family deaths on June 15th. Forensic autopsies were conducted June 16th. The State Medical Examiner's Office has determined the causes of death for all four family members to be gunshot wounds. The manners of death for Lavanya Sunkara and the two boys are homicide. The manner of death for Chandrasekhar Sunkara is suicide.

Officials are working with surviving family members to provide support. Investigators are continuing to review evidence and conduct interviews", West Des Moines police said in a release.

"This tragedy will impact family, friends, co-workers, anyone that new this family" said Sergeant Dan Wade. "We are continuing to work through this investigation. We will follow through until we have answered as many questions as the evidence allows. We are confident, though, that there is no continuing threat to the community." Chandra was a civilian employee in the Technology Services Bureau (TSB) of Iowa Department of Public Safety, where he served as an IT professional.

Indian American Senator Vin Gopal Introduces Bill to Empower Students in Fight against Climate Change

OCEAN TOWNSHIP, NJ

(TIP): Following a report that at least 9 New Jersey cities are likely to be underwater within the century due to rising sea levels caused by climate change, State Assembly Members Eric Houghtaling and Joann Downey joined New Jersey Senator Vin Gopal to introduce legislation this month that would require schools to teach students about climate change as part of the science curriculum in middle and high school.

"Earth's climate is now changing faster than at any point in the history of modern civilization, and as a clear result of human activity," said Gopal (D-Long Branch).

"We've already seen indications of its progression as hurricanes have grown increasingly severe while floods and blizzards have devastated huge parts of our state's infrastructure. Climate change is not somebody else's problem - it's an enormous and direct threat to New Jersey's economy and our residents' quality of life. To fight back, our children will need to know exactly what we're facing, how we got here, and how we can reverse the effects before it's too late."

Vin serves as Senate Majority Conference Leader and Chairman of the Military and Veterans' Affairs Committee. He also serves as Vice-Chair of the Senate Higher Education Committee and as a member of the Health, Human Services, and Senior Citizens Committee.

Upakar Foundation announces Bob and Mani Narasimhan Scholarship

The scholar will receive \$8,000 over four years, if academic excellence is maintained in higher education.

Bob and Mani Narasimhan believed strongly in the importance of education. Bob studied at Banaras Hindu University, McGill University and the Indian Institute of Science. Mani was a teacher and became Vice Principal of the Naval School in Chanakyapuri, New Delhi. They encouraged their children Shekar and Chitra to study, and so both were educated at premier institutions in India. In creating this scholarship,

Shekar and Chitra said "Bob and Mani loved to travel and taught us that giving back was everything. As their children, we feel privileged to institute a memorial scholarship in their memory. May their ideals live on through the Scholars who receive this Upakar Scholarship in their names."

Upakar was founded in 1997 in the Washington DC metropolitan area to address the very real need of Indian Americans who cannot afford a four-year college education. According to 2015 data from the Pew Research Center, as much as 12% of the Indian American population lives below the poverty line. Upakar's philosophy is that education is the key to advancement in today's global economy. Upakar Scholarships play an important role in empowering Indian American students by providing a 4-year commitment of financial assistance throughout their undergraduate study.

In the last 20 years, Upakar has awarded 158 scholarships for over \$625,000 to students who meet the criteria. A Scholar must be a U.S. citizen or permanent resident with a minimum unweighted high school GPA of 3.6 and who was born in India or has at least one Indian-born parent. Financial need is determined by the family's adjusted gross income. Upakar scholarships are renewable up to 4 years based on performance.

Upakar scholarship applications deadline for 2018-19 has passed. The submission deadline was April 30, 2019.

Nassau Seeks Input on Expected Contract Concerning Expansion of Participation Among Minority, Woman, and Service-Disabled Veteran Owned Businesses in Government Procurements

Effort designed to increase future capacity of businesses to win County contracts Ahead of 7/19 submission deadline, County to hold info session on 6/28

MINEOLA, NY (TIP): As part of her Administration's continued efforts to open doors and create opportunities for all residents to participate in County government, Nassau County Executive Laura Curran, June 20, announced a "Request for Expressions of Interest" (RFEI) as a precursor to a full Request for Proposals (RFP) for a Disparity Study and Consultant Services which the County intends to issue later this summer.

Thanks to a concerted push by County Executive Curran and with bipartisan Legislative support, Nassau County's capital budget provided \$500K for a Disparity Study to gather data about the availability and utilization of Minority, Woman, and Service-Disabled Veteran Owned Businesses (MWBEs/SDVOBs) in the County. The RFEI seeks input from governmental partners, community stakeholders and experts on capacity building in the crafting of the County's RFP.

Nassau County will hold an information session for interested parties on Friday June 28, 2019 from 10:00-11:30 am (details to be posted on Friday June 21st). RFEI responses of up to 5 pages will be due July 19, 2019. The County will incorporate comments from the RFEI process into its final RFP.

"When it comes to doing business with Nassau County, we are setting a new standard of transparency and inclusion," said County Executive Laura Curran. "However, we still have so much more potential to tap into, and this effort will help Nassau get the data we need to set meaningful participation goals and help build capacity amongst our minority, women and service-disabled veteran businesses.

"We crafted our draft RFP in a forward-looking way, with an emphasis on supporting participation in County procurements as well as county-wide opportunities with our municipal subdivisions," said Evelyn Tsimis, Deputy County Executive for Economic Development. "But rather than simply issue an RFP to hire a consultant, we want to first get input from a wide array of experts and stakeholders to make sure we get robust participation in the effort and that we get it right."

"We have an estimated 40,000 minority-owned businesses in the County, but we don't have comprehensive information on what goods and services they can offer, or how they are faring in neighboring markets," said Dr. Regina Williams, Acting Executive Director of the Office of

Minority Affairs. "This is a vital step Nassau County is taking to identify where we are falling short and provide a roadmap for positioning our MWBE/SDVOB businesses for greater success in winning County contracts."

As outlined in the RFEI, the primary objectives of the draft Disparity Study and Consultant Services contract are to: determine the extent to which there exists a disparity between the availability of qualified MWBEs and SDVOBs and their utilization by County agencies. Determine whether County contracts should be subject to race, gender and or service-disabled veteran status conscious remedial programs supported by State law.

Establish the basis by which the County will determine overall Countywide goals for the participation of MWBEs and SDVOBs in County contracts.

Gather insight concerning where the County is falling short in making maximum use of MWBE/SDVOBs; suggestions on ways to incubate these businesses; review of the current County MWBE/SDVOB program (including any applicable certification requirements) and strategies for better matching capacity with demand.

*Fed's signals***The dovish turn from major central banks indicates the threat of a global slowdown**

The days of monetary policy normalization in most advanced economies may well be over. The U.S. Federal Reserve, after a two-day policy meeting that ended on Wednesday, held its federal funds rate unchanged in the 2.25% to 2.50% range and simultaneously signaled its readiness to ease policy by dropping a reference to being 'patient' on borrowing costs. Fed Chairman Jerome Powell suggested that the central bank may look at cutting interest rates in the near future in order to tackle the various threats to U.S.

economic growth. In particular, he noted the uncertainty on the trade front and its potential to impact the U.S. and other economies. With U.S. President Donald Trump and Chinese President Xi Jinping set to meet at the G-20 summit in Japan this month, the Fed's decision at the conclusion of its next meeting on July 31 could well hinge on the outcome of the Trump-Xi talks. The dovish stance of the Fed comes just a day after Mario Draghi, the President of the European Central Bank, hinted that the ECB may resort to rate cuts and bond purchases if inflation failed to rise. Whether these major central banks will back their rhetoric with action remains to be seen. However, the change in their tone is clear. The

Federal Reserve had begun its policy normalization process in 2015, sending several emerging market currencies into crisis. But just a few years into normalization, and with real interest rates barely above zero, central banks are already talking about a possible cut in rates if the economy demands it.

This dovish turn indicates the growing threat of a global economic slowdown due to increasing trade tensions between the U.S. and China. It may also be a sign that central banks are yielding to increasing pressure exerted by politicians like Mr. Trump, who has been vocal in his criticism of the Fed. The important question, however, is not whether central banks will cut interest rates but whether the resultant rate cuts would be enough to boost the global economy. This is particularly so at a time

when trade wars have led to increasing restrictions on the movement of goods and services. Further, with real interest rates in advanced economies currently not far above zero, central banks may have to look beyond rate cuts and explore other unconventional policy measures to directly inject money into the economy. But even that may not ensure success as the effectiveness of monetary policy has been decreasing with growing debt levels. The shift to an easing cycle internationally will of course make it easier for the Reserve Bank of India to cut rates aggressively without worrying about the effect of such reductions on the rupee. Boosting growth, however, may require a new round of structural reforms.

Why social media needs to be regulated

The big social media platforms are not only monopolies in themselves but also the equivalents of a public square, albeit a digital one. The big five of the virtual civilization are now akin to public utilities and must be regulated as such. The argument, therefore, that they do not bear responsibility for content on their platforms is both dubious and disingenuous.

It has been almost a month since the results of the General Election 2019 were announced. The time has come to seriously evaluate the role played by social media in spreading disinformation and hate speech in the election season. To do so it is imperative to first understand the structure of the social media platforms and for that, it is necessary to go back to the invention of the telephone itself.

The telephone was invented by Alexander Graham Bell in 1875. Using tuned metal reeds, wire and magnets, he and his colleagues were able to harmonize a sending telephone with a receiver and reproduce sound. On March 10, 1876, Bell transmitted the first sentence, "Watson, come here, I want you", through his contrivance. And, the communications revolution has not looked back since then.

The telephone essentially is a platform that people still use to communicate with each other. Every telephone user has a number that he or she uses - that number is supposed to be linked to an identity. If the telephone network is misused for the purposes of making crank, anonymous or abusive hatemongering calls, the same can be invariably tracked to the miscreants.

However, with the advent of calling cards that could be used from landline phones and later mobile telephony - the ubiquitous SIM cards - these networks are also abused. But the problem is not insurmountable.

Telephone companies do not take responsibility for content transmitted over their networks, claiming that they are primarily network providers and how the subscriber uses the system is not their responsibility. With various value-added

services getting added to the original voice transmission capacity over the past three decades, this paradigm also requires a revisit. Telecom operators globally should be made vicariously liable in certain instances when their networks become catalysts of mass social and economic disruption.

By the 1970s, scientists conceptualized the Transmission Control Protocol and Internet Protocol, or TCP/IP, a communications template that set benchmarks on how data could be conveyed between manifold networks. ARPANET embraced TCP/IP on January 1, 1983, and from thereon began the interlinking of networks that became the modern Internet.

The online world then took on a more discernible shape in 1990, when computer scientists developed the World Wide Web. While frequently confused with the Internet itself, the Web is essentially the most conjoint ways of accessing data online in the shape of websites and hyperlinks. It is the web that aided the propagation of the Internet among the masses. It functions as a critical tread in assembling the titanic trove of information that most of us now use on a daily basis. The social media platforms like Facebook, WhatsApp, Twitter, Tik-Tok and a multitude of others are the flora and fauna of this World Wide Web.

These social media platforms allow people to register themselves for using their services bereft of any tangible verification. As a consequence a number of individuals, companies, political parties, intelligence structures, non-state actors, terrorist groups and even governments abuse this anonymity in order to spread disinformation, abuse hate and vitriol that has serious implications including and not limited to interference in the sovereign and even democratic functioning of states, causing conflagrations, cyber warfare and interdiction of critical infrastructure to name but a few of the nefarious uses of this framework in the ether. This does not include the vicious dark net that requires very specific browsers to access.

Notwithstanding as to whether the content in question is positive or negative, social media platforms claim that they neither have control over it nor can they verify it. They take no responsibility for allowing dissemination of content, irrespective of its portentous repercussions.

Their rationale is that they are platforms and not content providers; therefore, they cannot and should not be expected to regulate content governed as they are there by the principles of free speech. They are also incorporated in jurisdictions that have strong freedom of expression laws that they hide behind to insulate themselves from lawsuits that could make them liable for what gets transmitted over their platforms. However, the big social media platforms are not only monopolies in themselves but also the equivalents of a public square, albeit a digital one. The big five of the virtual civilization are now akin to public utilities and must be regulated as such. The argument, therefore, that they do not bear responsibility for content on their platforms is both dubious and disingenuous.

Recently, Assistant Attorney-General Makan Delrahim of the US Department of Justice and its anti-trust chief in a speech in Israel even alluded to the historic anti-trust actions against Standard Oil, AT&T and Microsoft and stated that there is no need for new anti-trust laws. Those on the books suffice for the new digital arena also, thereby implying that there is a case to

break up these humongous digital monopolies.

India has over 34 crore users who consume social media in over a dozen languages. Facebook is the preferred vehicle of this consumption. It has a serious disinformation problem, particularly during elections and in disturbed geographies. During the election season and in turbulent regions, posts with incendiary consequences are routinely shared, especially through the encrypted WhatsApp platform.

While social media platforms may remove certain pages and delete certain users in response to an outrage, it is at best selective and at worst glaringly deficient in dealing with hate speech as I experienced firsthand during the recent elections. Though social media platforms claim that they have editorial filters, at a practical level they are virtually redundant.

The effects of such content, circulated by social media in India, cannot be downplayed nor dismissed arbitrarily. In a society as disparate as ours, the cohesion we enjoy cannot be taken for granted in the face of unregulated technologies that people are not trained to use.

In the context of the human, political, economic and even existential threats that manifest, it is irresponsible for social media outfits to refrain from taking responsibility for their content, especially when their actions undermine the very principles they profess as sacrosanct. An appropriate legal architecture to counter the enormous socio-political problem with its attendant national security implications should be the single biggest national security priority for us as a country.

What a \$5 trillion economy would look like

First, Indians should feel empowered by the economy. We know that currently they do not feel so. India is placed very low in the United Nations' World Happiness Report. Happiness, best understood as a sense of well-being, is directly related to empowerment, or being able to undertake the functionings we value. This is, in the first instance, related to being educated and experiencing good health. We are in India facing an education sector that is broken down and the majority are battling with almost non-existent public health infrastructure. The private sector has some worthy initiatives in these areas but they await an effective public presence on a gigantic scale. So, the first attribute of the valuable economy would be access to quality health and education for all.

At the meeting of the Governing Council of the NITI Aayog, middle of June, Prime Minister Narendra Modi announced the target of a \$5 trillion economy for India by 2024. It is necessary to think big when seeking to make a difference, for transformation does not come from modest plans. Hopefully, the Prime Minister will also use the drive to growth to place India's official statistics on a firmer footing, so that we can be sure that economic policymaking is based on reality. However, getting the numbers right will not ideally end the task. What this task is may be illustrated by a question that was asked some years ago when a high-speed expressway connecting the polar extremities of one of our States had been proposed. A wit had asked what we would hope to find once we have reached our destination.

A similar question can be asked of plans for growing the economy. What would we like to see in the proposed \$5 trillion economy? Moreover, unlike in the case of an expressway, which can always be built by simply borrowing money and ideas from the global market, a quantum leap in the size of the economy is not so easily achieved. It will require design, funding and governance.

Without investment

The importance of funding, and to an equal extent design, may be seen in the failure of the quite sensible aspiration, 'Make in India'. Though technically applicable to every sector, it was clearly focused on manufacturing. Articulated very early on in Mr. Modi's first term (2014-19), and accorded a certain prestige in the pronouncements that followed, it played out as a damn squib. One of the reasons for this was the absence of commensurate investment outlay. To raise the share of manufacturing in the economy from its present 16% to 25%, an ambition declared by both the United Progressive Alliance and National Democratic Alliance governments, requires a scaling up of investment. This did not come about.

Whether this was due to the corporate sector, Mr. Modi's chosen vehicle, not having the wherewithal or due to it not being convinced of the plan is beside the point. Investment there must be and if the private sector is, for whatever reason, not coming forward to invest, then the government must. This is no more than accounting, but Mr. Modi's government seems to be unfavorable to this diagnosis, perhaps on ideological grounds. Remember 'minimum government'?

A small digression should clarify matters. The first attempt to make in India was in the 1940s. Finance Minister Shanmukham Chetty's first budget speech had identified increasing "internal production" as the economic priority. And this was achieved quite soon. Along with the quickening of the economy as a whole, the share of manufacturing had risen, the mocking epithet 'Hindu rate of growth' notwithstanding. This had not emerged as part of the moral victory of an

oppressed people. The reason was that it had resulted from a surge in investment, led by the government. That resources could have been mobilized on such a scale in so short a time in an economy devastated by colonial rule is testimony to the availability of the three ingredients - design, resources and governance - necessary when contemplating a move to the next level, which is what aiming at a \$5 trillion economy amounts to.

The wish list

While lauding the efforts of leaders of early independent India, however, we would do well to remember their follies. Principal among them was the failure to articulate, possibly even adequately imagine, the contents of the economy that was being raced towards. If this is repeated now, a moment of triumphalism different in character but nevertheless there, it would amount to not having learned the lessons of history. Something missing from "internal production" and 'Make in India' is the difference these intentions would make to the lives of Indians. At least in the 1940s, the priority was to get the economy moving in the first place. This is no longer the issue. Today the economy must be evaluated in terms of how much it contributes to the ease of our living. So what would be some of the characteristics of a valuable economy?

First, Indians should feel empowered by the economy. We know that currently they do not feel so. India is placed very low in the United Nations' World Happiness Report. Happiness, best understood as a sense of well-being, is directly related to empowerment, or being able to undertake the functionings we value. This is, in the first instance, related to being educated and experiencing good health. We are in India facing an education sector that is broken down and the majority are battling with almost non-existent public health infrastructure. The private sector has some worthy initiatives in these areas but they await an effective public presence on a gigantic scale. So, the first attribute of the valuable economy would be access to quality health and education for all.

The second attribute of a valuable economy would be equality of opportunity. For over three decades now income inequality has been rising in India. According to some measures, India is today more unequal than China,

itself a society widely perceived as highly unequal. Now some part of inequality of opportunity is related to unequal distribution of income but a part of it is not. Gender inequality manifested as women having less opportunity in life is not going to go away with a re-distribution of income along class lines or across social groupings. India is a serious outlier in this regard, and becoming richer as a society may do little to change the status quo. Shockingly, a sex ratio, already unfavorable to women, has shown a secular worsening since 1947. Inequality in India can only be ended by equalizing capabilities across individuals. Concerted public action via education is the means to this outcome. Income transfers, pushed relentlessly by policy entrepreneurs, evade the issue altogether.

Conserving nature

Finally, an economy, whatever its size, cannot be meaningfully evaluated independently of the extent of presence in it of natural capital. Till now, by referring to the imperative for growth, to eradicate poverty, any effort to conserve nature has not just been ignored but treated with derision, by both right and left. This is no longer a credible political stance. Two-thirds of the world's most polluted cities are in India, when we accept less than a fifth of its population. Air pollution shortens lives and lowers productivity, reducing the capacity to earn a living when alive. The poor are the most affected as they cannot afford to live in gated communities that somehow manage to commandeer scarce natural resources. Some part of environmental depletion in India is due to the pursuit of unbridled growth.

This implies that any improvement in the life of the majority would require a re-alignment of the growth process so that it is less damaging. This would very likely require that we have slower growth but the process can be configured to channel more of it towards poorer groups. We may end up in a situation of less tangible goods in the aggregate than otherwise but one in which more people are happier than in the past. Such an economy is more valuable.

Nepal Army Chief, China Defence Minister discuss plans to upgrade military ties

BEIJING/KATHMANDU (TIP): Nepal Army chief General Purna Chandra Thapa on June 20 met China's Defence Minister General Wei Fenghe and discussed plans to upgrade the military ties between the two neighbouring countries.

Thapa is on a week-long official tour to China. He arrived in Beijing on June 16 on the invitation of China's Peoples Liberation Army (PLA).

During the meeting, Wei said recent years have seen continuous advancement of the China-Nepal comprehensive cooperative partnership with ever-lasting friendship under the guidance of the leaders of both countries, the state-run Xinhua news agency reported.

China highly appreciates Nepal's firm adherence to the "one China" policy, he said, apparently referring to the Tibet and Taiwan issues.

Beijing has been investing heavily in the land-locked Himalayan nation in recent years, rapidly increasing infrastructure connectivity with the rail and road links.

Nepal also signed a transit treaty with China to use Chinese ports for its foreign trade in a bid to reduce dependence on Indian ports.

Under the "one China" policy, Nepal for its part has been cracking down hard on Tibetans crossing into India through Nepal to meet their spiritual leader Dalai Lama.

Wei stated the Chinese military's willingness to work with the Nepalese side to maintain sound development momentum of bilateral military ties, step up long-term planning and top-level design of military cooperation and promote continuous consolidation, deepening and upgrading of the ties between the two militaries, the report said.

Thapa expressed Nepal's appreciation towards China's long-term support and help, saying the Nepalese armed forces were willing to step up cooperation with China in various areas and contribute to deepening the Nepal-China friendship.

On June 19, he met the member of the Central Military Commission of China, Li Zuocheng, at the PLA headquarters in Beijing.

During the meeting, an agreement was signed under which the PLA would provide heavy mechanical bridge, explosive ordinance disposal equipment and rescue kits, worth 150 million Yuan, to Nepal under the humanitarian assistance and disaster management, Defence Ministry sources said in Kathmandu.

The Chief of Army Staff of the Nepal Army also inspected the military structures of the PLA and visited various tourist destinations including the Great Wall.

Stop arresting me, it will create fear: Pak ex-President Zardari

ISLAMABAD (TIP): Pakistan's former President Asif Ali Zardari, appearing in Parliament on Thursday for the first time after being arrested in a corruption case, called for an end to his arrest, saying it would not make a difference rather create fear among the people.

Zardari, who is in the custody of the anti-corruption body National Accountability Bureau (NAB), appeared before the house after the National Assembly Secretariat issued a production order to attend Parliament session.

He said that it is time to stop the accountability and arrests, and move forward, Geo News reported.

The 63-year-old co-chairman of the Opposition Pakistan Peoples Party and husband of the country's first woman prime minister Benazir Bhutto was arrested by the NAB from his house last week in a multi-million dollar money laundering case, hours after the Islamabad High Court rejected his bail plea.

A seemingly disappointed Zardari said that putting him behind the bars would not make any difference.

"My arrest will not make a difference. It will only strengthen the party. However, it will create fear among the common man that if Zardari can be arrested then they can also be arrested," he said.

According to the production order, the NAB is directed to produce Zardari at the



"commencement of each sitting of the National Assembly before the Sergeant-at-Arms at the Parliament House, Islamabad, who shall, after the conclusion of the sittings deliver him into your custody accordingly".

Commenting on the current economic situation, he said that there would be protests if the country's economic situation continues to deteriorate.

The former president said that the government should avoid taking steps that could trigger countrywide protests and create a situation that would no longer be in control of the political parties.

"They should think about this and the forces that brought them into power should also think about the

consequences," Zardari said.

Criticising the budget presented by the government last week, he said that the budget raised government salaries but it also increased taxes.

"There is fear among the businessmen. If you have more than Rs 500,000 in your cheque book, then you receive a notice to give an explanation for it. There is no doubt that this budget was not made by them," he said.

"If we are receiving money from the IMF, why are the people crying? Why are the industries crying?" Zardari asked.

The current economic situation was an issue for everyone and that the government and opposition should sit together to discuss the issues affecting the economy, he added.

Last week after his arrest, Zardari was admitted to a hospital in Rawalpindi after a drop in his sugar level and blood pressure.

Zardari and his sister Faryal Talpur are two of the main accused in the money laundering scandal which utilised fake bank accounts to channel illegally gained funds out of Pakistan.

According to the NAB, the duo made transactions of Rs 150 million through alleged fake bank accounts.

Zardari, the 11th President of Pakistan from 2008 to 2013, has denied any link with the fake accounts. He has said the allegation was part of a vilification campaign by the ruling Pakistan Tehreek-e-Insaf party to malign opposition leaders. PTI

Khaleda Zia gets six-month bail in defamation cases

DHAKA (TIP): A Bangladesh court on June 17 granted a six-month bail to former Prime Minister Khaleda Zia in two defamation cases filed against her.

Justice Muhammad Abdul Hafiz and Kashefa Hussain passed the order after hearing a bail petition filed by Khaleda's lawyers. However, the Bangladesh Nationalist Party (BNP) chief cannot be released from the jail as she is convicted in two other graft cases.

AB Siddique, president of Bangladesh Jananetri Parishad, a pro-Awami League organisation, filed the cases against Zia on charge of hurting the religious sentiment of the Muslims and for making derogatory comments on Bangabandhu Sheikh Mujibur Rahman.

He filed one case on October 21, 2014 claiming that on October 14 of the same year, Zia at a programme in Engineers Institution in Dhaka said "the ruling party's professed secularism was nothing but a sham", adding that her remarks hurt sentiments of Muslims. In another defamation case filed on January 25, 2017, Siddique claimed that Zia at a programme said Sheikh Mujibur Rahman had not wanted independence of Bangladesh, rather he had wanted to be the Pakistan PM. The former PM

landed in jail on February 8, 2018, after being convicted in a corruption case involving Zia Orphanage Trust. — IANS

Pakistani climber killed, Italians injured by avalanche

ISLAMABAD (TIP): A Pakistani climber was killed who was part of a joint expedition of Italian and Pakistani members after being caught in an avalanche on a mountain in remote northern Pakistan, a mountaineering group said on June 17.

Reports state that people of the joint expedition were also injured.

Pakistan's Alpine Club said the incident took place on Monday when four Italian and three Pakistani mountaineers were descending a peak in the Ishkoman Valley.

Pakistan's military was dispatching a helicopter to rescue the climbers, who have multiple injuries, it said.

The four Italian climbers involved are expedition leader Tarcisio Bellò, Luca Morellato, David Bergamin and Tino Toldo.

Sri Lanka launches first satellite 'Ravana-1'

COLOMBO: Sri Lanka's first satellite 'Ravana-1', designed and developed by two local engineers, was successfully launched into orbit this week from the International Space Station along with two other BIRDS 3 satellites from Japan and Nepal. The 1.05-kg satellite is expected to fulfil five missions, including the capturing of pictures of Sri Lanka and surrounding regions. It will have a minimum lifespan of one-and-a-half years but was expected to be active for up to five years. PTI

Pakistan's 'heaviest' man shifted to hospital for treatment

LAHORE (TIP): Pakistan's heaviest man, who weighs over 330 kg, has been shifted to a military hospital here after the wall of his house was broken by emergency service personnel with the help of the army.

Noorul Hassan, 55, a resident of Sadiqabad district of Punjab province, some 400kms from Lahore, is suffering from extreme obesity.

On Tuesday, personnel from the Rescue 1122 had to break the wall of his house to take him outside as he was too big to pass through the main gate of his house. (PTI)

Bera Amendment passed in House to Counter Proliferation of Biological Weapons and Diseases

WASHINGTON (TIP): An amendment introduced by Indian American Rep. Ami Bera (D-CA), which increases funding to help partner nations prevent the proliferation of biological weapons, and detect and respond to deadly diseases, passed June 18 in the House of Representatives with strong bipartisan support (381-46). The amendment would restore a \$15 million cut to the Cooperative Biological Engagement Program and adds an additional \$5 million funding to this vital program.

"Recent news of Ebola spreading from the Democratic Republic of Congo to Uganda is a reminder of how easy it is for deadly diseases to spread quickly," said Rep. Bera, M.D. "This amendment strengthens the ability of partner countries to detect and respond to the spread of dangerous diseases before they become a threat to the United States."

The amendment was included in the Labor, Health and Human Services, Education, Defense, State, Foreign Operations, and Energy and Water Development Appropriations Act, which passed the House.

As a doctor, Congressman Bera has always been a strong supporter of American leadership in global health. In March 2019, Rep. Bera led a bipartisan letter urging Congress to sustain global health security funding. In May 2018, Rep. Bera successfully urged the Administration to halt short-sighted Ebola funding cuts. He also led efforts by the Foreign Affairs Committee to address the global Zika epidemic and has pushed Congress to do more to stop future outbreaks.

Rep. Bera is Chairman of the House Foreign Affairs Oversight and Investigations Subcommittee.

List Al Jazeera as 'foreign agent': US senators to Trump admn

WASHINGTON (TIP): A group of influential US lawmakers has urged the Trump administration to get Al Jazeera listed as a "foreign agent", saying the state-owned media company of Qatar has "inherently engaged" in political activities and sought to influence public opinion in America.

The US requires all agencies, individuals and organisations controlled or funded by international governments to be registered with the Department of Justice under the Foreign Agents Registration Act (FARA) which aims to restrict the spread of propaganda inside America.

In a letter to the justice department, nine powerful Republican Senators sought information on any steps taken to determine whether the popular television news network from the Middle East should be registered as a "foreign agent". In the past, China's state-run Xinhua news agency and Russian television Russia Today (RT) have been asked to register as an agent of foreign government by the justice department.

International media outlets registered in the US as agents of foreign governments include RT, China Daily, NHK Cosmomedia, and KBS Korean Broadcasting System.

"Qatar's officials have said that government-controlled media is a form of 'soft power'. As such, one can reasonably infer that Al Jazeera is a messaging tool for the Qatari government and on its behalf has engaged in inherently political activities and sought to influence public opinion in



the United States," the lawmakers wrote.

"When the available evidence is taken as a whole, it appears that Al Jazeera's broadcasts, including AJ+, mirror the policies and preferences of the Qatari government, which, together with the state funding and other indicia of agency, demonstrate that Al Jazeera and its media subsidiaries act as alter egos of the Qatari government in ensuring dissemination of the government's viewpoints," they said.

The signatories include Senators Tom Cotton, Chuck Grassley, John Cornyn, Todd Young, Marco Rubio and Ted Cruz, and Representatives Mike Johnson and Lee Zeldin. The justice department recently required international

broadcasters of Russian-owned RTTV America to register under the law as well as Chinese government-owned media outlets Xinhua and China Global Television Network. The lawmakers alleged that news articles have reported activities in which Al Jazeera Media Network is engaged that raise legitimate questions about whether it should register as a foreign agent.

In a statement, the Al Jazeera Media Network said the network, its channels and its platforms, including AJ+, operate with editorial independence while receiving public funding and, in this respect, are similar to most global media organisations, including the BBC, CBC, and Deutsche Welle. PTI

Topics of discussion included diversity and cultural sensitivity training for TSA officers, perceptions regarding discrimination in the TSA screening process, and the use of facial recognition technology by the TSA and at airports generally. At the close of the

US religious waiver leads to many Sikh youths joining military

WASHINGTON (TIP): The waiver granted by the US administration has allowed more children from the minorities to join the US military. At least 14 Sikh youths have been granted this waiver.

Lt. Col Kamal Kalsi was the first to be granted the religious waiver in 2010 and it was one of the biggest changes that took place in the past 10 years.

Another Indian American, Manav Singh Sodhi, 17, has been preparing to head to a boot camp for his military training, especially because he can keep his beard and turban.

The other 13 Sikh recruits are from all around the US, Kalsi said.

"It took me a year and a half and a lot of trouble-organizing, getting 50 Congressional signatures, etc.-just to get me and Capt Tejdeep Singh Rattan, the waiver," Kalsi said about his experience.

Sodhi, a graduate of Kings Park High School on Long Island, New York City, will shortly be on his way to bootcamp. "He wants to be where the action is, he wants to join the artillery," Kalsi said.

In a press release from the Sikh American Veterans Association (SAVA), an organization founded by Kalsi, he said: "As the first Sikh-American in over a generation to receive a religious accommodation in the military, I feel it's important to take it forward and help open doors for Sikhs, Muslims, Jews, Hindus and other religious minorities."

Sodhi's accommodation to maintain his religiously mandated beard and turban while in uniform "bodes well for our community when we can become part of the fabric of this country," said Kalsi.

There are currently over 60 Sikh males serving in the US Army with

their turbans and beards, according to SAVA.

"I wanted to join the Army ever since I was a kid. My great-grandfather served in the Army and I wanted to follow in his footsteps. My father and mother inspired me to follow my dreams and never give up, no matter what. And that's exactly what I did," Sodhi is quoted as saying in the press release.

"When I was a child, my mother took

me to an event at City Hall where I met Lieutenant Colonel Kalsi for the first time, and he was in his army uniform with his turban and beard. That was a life-changing moment for me because I realized then that I can freely practice my religion and serve my country too," Sodhi is quoted as saying.

Lt Col Kalsi said the new recruit and his mother did not wish to give any press interviews but had forwarded some of his comments for the press.

Trump pulls back from launch of military strikes on Iran after initial approval

WASHINGTON (TIP):U.S. President Donald Trump approved military strikes on July 21 against Iran in retaliation for the downing of an unmanned \$130-million surveillance drone, but pulled back from launching the attacks, the New York Times said.

Trump had initially approved strikes on a handful of targets such as radar and missile batteries, the paper cited senior administration officials involved in, or briefed on, the deliberations, as saying.

The strikes were set to take place just before dawn on Friday to minimize risk to the Iranian military or to civilians, it added.

Planes were in the air and ships were in position, but no missiles fired, when the order to stand down came, it cited one senior administration official as saying.

The abrupt reversal put a halt to what would have been Trump's third military action against targets in the Middle East, the paper added, saying Trump had struck twice at targets in Syria, in 2017 and 2018.

However, it is not clear whether attacks on Iran might still go forward, the paper said, adding that it was not known if the cancellation of strikes had resulted from Trump changing his mind or administration concerns regarding logistics or strategy.—Reuters

Oil prices jump 6% as Trump says Iran made 'very big mistake'

NEW YORK (TIP): Oil prices jumped on June 20 on rising US-Iran tensions, with gains accelerating on a cryptic tweet by US President Donald Trump after Iranian forces shot down a US spy drone.

"Iran made a very big mistake!" Trump tweeted in his first public reaction to the strike.

Near 1505 GMT, US benchmark West Texas Intermediate climbed 6.3 per cent to USD 57.13 a barrel, while Brent futures in London gained 4.7 per cent to USD 64.69 a barrel. — AFP

California Governor apologises to Native Americans

LOS ANGELES (TIP): California Governor Gavin Newsom has apologised to Native Americans for violence and other wrongdoings they suffered during the state's history and called their mistreatment genocide. The Democratic Governor called for the creation of a Truth and Healing Council to produce a report before the end of 2024 on the historical relationship between the state and Native Americans. Reuters

SAALT demands Investigation into Indian Girl's Death at US Border

WASHINGTON (TIP): South Asian Americans Leading Together (SAALT), a national, nonpartisan, non-profit organization that fights for racial justice and advocates for the civil rights of all South Asians in the United States, is sending a letter of inquiry to Customs and Border Protection Commissioner, Kevin K. McAleenan, demanding an investigation into 6-year-old Indian girl Gurupreet Kaur's death in Arizona desert and information about her mother and the other migrants in their group.

Lakshmi Sridaran, Interim Co-Executive Director of SAALT said, "U.S. border militarization, forced migration, and rejection of migrants attempting to cross at ports of entry have created an environment where a childlike Gurupreet,



can die in the desert, alone. Until this system is completely defunded and a new one is created that upholds the dignity of all migrants - we will continue to see unspeakable tragedies, notwithstanding the countless deaths that go undocumented. While ICE and CBP have experienced unprecedented surges in their budgets, their treatment of migrants has plunged to new lows. "

Gurupreet's body was found by U.S. Border Patrol agents in a remote desert

outside the Lukeville, Arizona point of entry on Wednesday, June 12th, just days before her seventh birthday.

She died of heat stroke in the Arizona desert where temperatures were 108 degrees Fahrenheit, according to U.S. Border Patrol and the Pima County Office of the Medical Examiner (PCOME).

Gurupreet and her mother were reportedly among a group of five Indian nationals who were dropped off by migrant traffickers in a remote area on the U.S.-Mexico border. Her mother and another woman went in search of water, leaving Gurupreet with two others from the group. Gurupreet's mother was found by a U.S. Border Patrol agent 22 hours later. Four hours after that, Border Patrol agents found Gurupreet's body.

TDP plunges into crisis as 4 Rajya Sabha MPs join BJP

NEW DELHI (TIP): In a jolt to the Telugu Desam Party (TDP), four of its six Rajya Sabha MPs Thursday joined the Bharatiya Janata Party (BJP) in the presence of working president J P Nadda in New Delhi.

"I assure them that the BJP believes in politics of positivity and inclusiveness," Nadda said while welcoming the TDP members.

TDP MPs C M Ramesh Y Satyanarayana Chowdary, T G Venkatesh and Garikapati Mohan Rao also wrote to Rajya Sabha Chairman M Venkaiah Naidu announcing their decision to merge with the BJP. The development comes at a time when TDP chief Nara Chandrababu Naidu is on holiday in Europe with his family.

"For the sake of development of my Rayalaseema region I want to join BJP. The BJP also wants to increase its members in Rajya Sabha so I have agreed. It will take some time. Obviously, I will quit TDP," Venkatesh, who hails from Kurnool, told The Indian Express. Venkatesh said he was speaking for himself and was not aware of the plans of his colleagues.

The drama unfolded shortly after 2 pm when the four MPs submitted a letter to Rajya Sabha chairman Venkaiah Naidu expressing their desire to join the BJP. The four are likely to escape anti-defection laws as they have a 2/3rd majority among the six TDP MPs in Raja Sabha. Sources said that Ramesh and Chowdary made the first move and then got Venkatesh and Mohan Rao on board to avoid the anti-defection laws.

While Ramesh is currently being probed by the Income-Tax, Chowdhary, who served as union minister till 2018, is under the CBI and Enforcement Directorate

scanner in connection with a bank fraud case.

TDP AP president Kala Venkat Rao said that party chief Naidu sent him a message condemning the BJP's efforts to woo its MPs. However, sources in the TDP said that both Ramesh and Chowdary are extremely close to Naidu and they may have already informed him about their plans.

The TDP suffered a humiliating defeat in assembly and Lok Sabha elections in Andhra Pradesh. The party was reduced to just three MPs in Lok Sabha. On Wednesday, TDP leader in Lok Sabha Galla Jayadev and party whip K Rammohan Naidu, while declaring their support for newly elected Speaker Om Birla, said that they would extend full cooperation to the Narendra Modi Government. This is contrary to the anti-Modi stand taken by the TDP prior to the elections.

THEY HAD PERSONAL AGENDAS, SAYS CHANDRABABU NAIDU

The development is a big blow to

Naidu, coming close on the heels of his party's humiliating defeat in the recent Lok Sabha and assembly polls. The former Andhra Pradesh chief minister is on vacation in Europe as the fresh crisis hit his party. He spoke to his party leaders over phone as they sought to put up a brave front, saying that such troubles are not new to the organisation.

"All my life, I have strived for the good of people and will continue to do so regardless of being in power or not," Naidu later said in a tweet. "TDP MPs joining BJP today is the result of my fight for AP's rights. They had their own personal agendas to address."

Naidu also held a teleconference with his MPs and told them not to worry. He described as false statements made by the four MPs blaming Naidu for the defection. "They did it for their own personal reasons and personal gains," Naidu reportedly said, adding that the MPs had no right to merge the party legislature as they are neither the party president nor any authority.

ARMY COMMANDERS WHOSE BASES BREACHED IN TERROR ATTACKS MAY HAVE TO LEAVE

NEW DELHI (TIP): Commanders who were in charge of the Uri brigade, the Sunjuwan military camp and the Nagrota army base in Jammu and Kashmir when their establishments were stormed by terrorists in past years may have "to go home", the government has decided, seeking to take action against the senior leadership for security lapses that may have aided the attacks.

The government has communicated its recommendation to the Indian Army, a senior official in the security establishment said, requesting anonymity because he is not authorised to speak to the media.

Essentially, the government wants these officers to put in their papers and retire. The officers will still be eligible to receive all the benefits that are due to them, he added.

"The army was communicated that commanders should put in their papers days after the new government was sworn in," said a second official in the security establishment, who also did not want to be named. The decision comes less than a month after the Bharatiya Janata Party-led National Democratic Alliance (NDA) was sworn in for a second successive term in office after winning a commanding majority in the April-May general elections. A total of 36 army personnel died in the three attacks, two of which — on the Uri brigade and the Nagrota base — took place in 2016, and the third — on the Sunjuwan camp — last year.

A group of terrorists sneaked into the Brigade Headquarters in Uri, killing 19 soldiers, on September 18, 2016. Seven soldiers, including an officer, died when terrorist stormed the 14 Corps Artillery Brigade located in Nagrota on November 29, 2016. Eleven soldiers were killed when terrorists attacked the Sunjuwan camp on February 10, 2018.

The Uri attack prompted the Indian Army to carry out cross-border "surgical strikes" on terrorist camps on 28 September, 2016, an action that sparked fears of war between India and Pakistan. *Source: HT*

Brain fever claims 136 lives in Bihar, 600 affected

PATNA (TIP): Brain fever has afflicted more than 600 children across 16 districts of Bihar of which 136 have lost their lives since the beginning of this month, the state health department said on Thursday. According to statistics released by the department, the total number of Acute Encephalitis Syndrome (AES) cases registered across the state since June 1 was 626, and the total number of deaths caused by the same has mounted to 136.

Muzaffarpur district has bore the maximum brunt, accounting for 117 deaths so far. Besides, deaths have been reported from districts like Bhagalpur, East Champaran, Vaishali, Sitamarhi and Samastipur.

The department also said that among the various complications that are covered under the umbrella term AES, hypoglycemia or very low blood sugar level was the most prevalent as it has afflicted 520 children and accounted for 110 deaths.

Experts have blamed the high incidence of hypoglycemia on a toxin found in unripe litchi fruit, which is believed to be consumed by malnourished children from underprivileged backgrounds.

PREZ KOVIND ENDORSES 'ONE NATION, ONE POLL', LAYS DOWN ROADMAP WITH FOCUS ON TRIPLE TALAQ, NRC

NEW DELHI (TIP): The idea of 'one nation one election' got its strongest endorsement from none other than the President of India, who in his address to the parliamentarians of the newly elected 17th Lok Sabha on Thursday said simultaneous polls were the need of the hour.

"One nation – simultaneous elections' is the need of the hour, which would facilitate accelerated development, thereby benefitting our countrymen. With such a system in place, all political parties, according to their respective ideologies, will be able to better utilise their energy towards development and public welfare," President Ram Nath Kovind said.

"I urge all members of Parliament to seriously ponder over this development-oriented proposal of 'one nation - simultaneous elections'," he added.



The President also talked about India having "amply demonstrated both her intent and capabilities, first through surgical strikes and then through air strikes" following the Pulwama attack in February. "In future too, all possible steps will be taken to ensure our security," he said. Speaking in the central hall of the Parliament, Kovind talked about the Narendra Modi government's plans to make India a \$5 trillion economy by 2024, and of the government's efforts to "to create strong, secure and inclusive India."

In his joint address to members of both houses of the Parliament, the President talked about the achievements of the past government, highlighting events like the designation of Jaish terror group chief Masood Azhar as a global terrorist. He also talked about the path that the country should take in days to come by emphasising on the need to eradicate 'triple talaq', which is one of the 10 ordinances that the new Modi government is likely to introduce in the lower house of Parliament.

"To secure equal rights for every sister and daughter in the country, eradication of social evils like 'Triple Talaq' and 'Nikah-Halala' is imperative. I would urge all the members to cooperate in these efforts to make the lives of our sisters and daughters better and dignified," Kovind said.

Yoga is above region and faith, says Modi as he leads mega event in Ranchi

RANCHI (TIP): Prime Minister Narendra Modi on Friday led at least 40,000 people in a mass session of exercise and meditation in Jharkhand's capital Ranchi as millions across the country stretched and bend on the fifth edition of International Yoga Day.

The Prime Minister has been tweeting videos of various asanas since early June urging people to gear up for the International Yoga Day, which is being celebrated on a global scale since 2015.

"I thank people across the world for joining the International Day of Yoga celebrations. World over, the first rays of the Sun are being welcomed by dedicated yoga practitioners, it's a beautiful sight. I urge you all to embrace yoga and make it an integral part of your daily routine," Modi said as he addressed people at the Prabhat Tara ground.

"We all know the importance of yoga very well. It has always been an important part of our culture. But now we all have to take the practice of yoga to another level," he said.

"Now, I have to take the journey of modern yoga from the cities to the villages, to the poor and tribal's house. I have to make yoga an integral part of the life of the poor and tribal. Because it is poor who gets the most pain due to illness," he said.

As he stressed on the importance of yoga, the Prime Minister said the physical and spiritual discipline is ancient as well modern and that for centuries its essence has remained the same of "healthy body, stable mind and spirit of oneness."

DEATH TOLL IN KULLU BUS ACCIDENT RISES TO 44, OVER 30 IN HOSPITAL

SHIMLA (TIP): In a tragic incident, at least 44 people died and 34 others were injured after an overloaded bus fell into a deep drain in Himachal Pradesh's Kullu district on Thursday, officials said.

Prima facie, it seems that the accident was caused due to negligent driving and overloading, Banjar Patwari Sheetal Kumar said.

The toll in the accident has touched 44 and the injured are undergoing treatment at the Banjar Civil Hospital and the Kullu district hospital, Additional SP of Kullu Rajkumar Chandel said.

Most of the victims were residents of various areas in Kullu district.

The private bus (bearing registration number HP 66-7065) fell into the over 300-metre-deep nullah (drain) near the Dhoth Morh in Banjar tehsil of the district, Kullu Superintendent of Police Shalini Agnihotri said, adding the vehicle was en route Gada Gushaini.

Some of the severely injured passengers have been shifted to PGI Chandigarh, he said.

Himachal Pradesh Governor Acharya Devvrat and Chief Minister Jai Ram Thakur expressed grief over the tragic accident. In their condolence messages, they prayed for peace to the departed souls and strength to the bereaved family members, an official spokesperson said.

The chief minister has ordered a magisterial inquiry into the incident, the official said, adding that Thakur also asked the administration to provide best possible medicare to the injured passengers.

Meanwhile, state Transport Minister Govind Singh Thakur left for Kullu from Shimla after learning about the accident.

The Kullu district administration announced an immediate relief of Rs 50,000 to the kin of each of the deceased and the injured.

Talking to PTI, Piyush Tewari, founder of SaveLIFE Foundation said, "It's a shame that mass-casualty bus crashes have become a norm in India, especially in hilly states like Himachal Pradesh."

"The state government must immediately order a summary audit of all roads, and engineers and contractors responsible for missing basic installations like crash barriers must be booked for causing countless deaths and injuries," he said.

the CM of the state, it added.

Ashok Gehlot met the Congress President on his birthday yesterday at the party headquarter and urged him to remain the party chief in the interests of his country and people. Gehlot said, "Rahul Gandhi took the fight against the Narendra Modi government for the last five years on issues of unemployment and youths."

Gehlot had earlier been the general secretary in-charge of the organisation for the party before he became the Rajasthan chief minister.

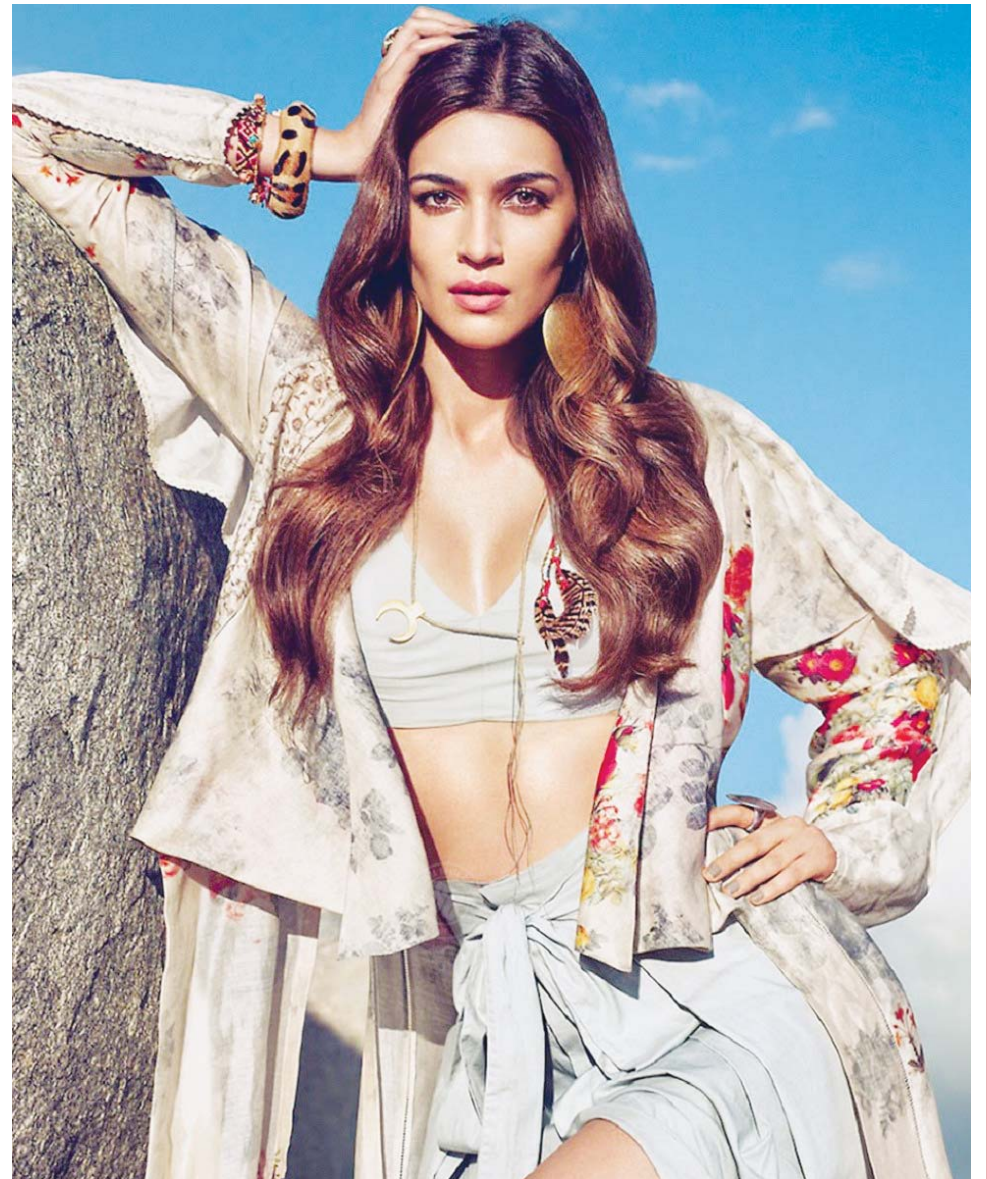

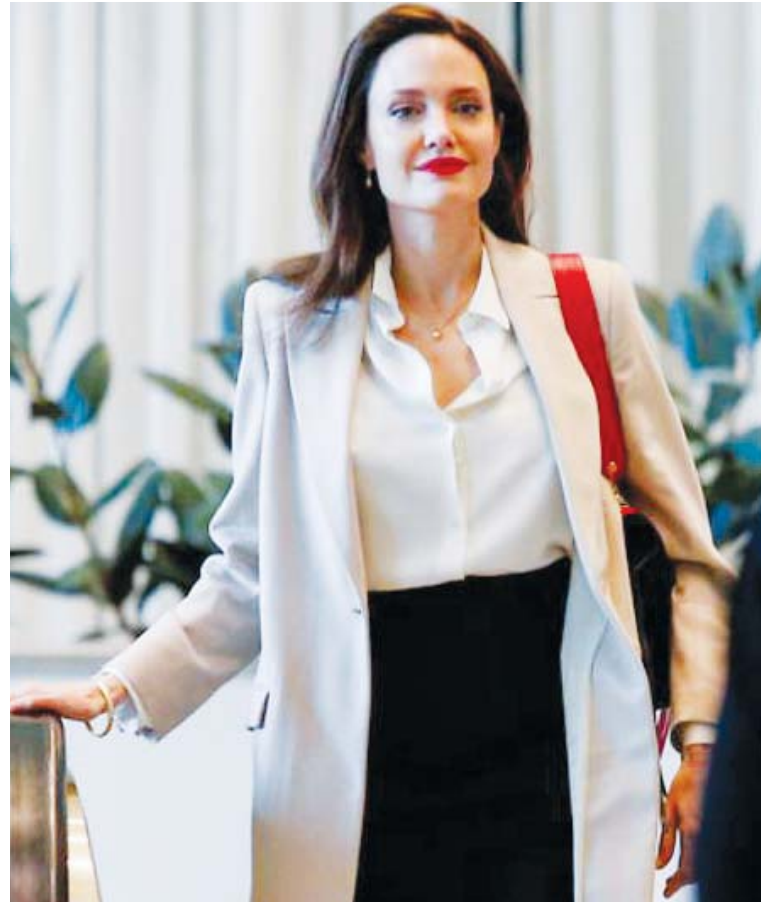

Xi, Kim to create 'bright future' of bilateral ties

PYONGYANG/BEIJING (TIP): Chinese President Xi Jinping and North Korean leader Kim Jong Un agreed here on June 20 to work together to create a "bright future" of inter-party and inter-state relations at a new starting point in history, the state-run news agency reported.

Xi became the first Chinese head of state to visit Pyongyang in 14 years and the fifth since the two nations established diplomatic relations in 1949. The two leaders held summit talks. "The China-North Korea friendship is a strategic choice made by the two sides with a long-term and overall perspective and will not waver due to changes in the international situation," Xi said. Kim said he fully agreed with "the insightful analysis and future plan Xi made on bilateral relations and that it was an unwavering policy of the DPRK's party and government to carry forward the DPRK-China friendship from generation to generation". — IANS

Iran shoots down American drone amid tensions

TEHRAN (TIP): Iran's Revolutionary Guards shot down a US drone on June 20 amid heightened tensions between Tehran and Washington over its collapsing nuclear deal with world powers, American and Iranian officials said, though they disputed the circumstances of the incident.

The Guard said it shot down the drone over Iranian airspace, while two US officials told The Associated Press that the downing happened over international airspace in the Strait of Hormuz. The different accounts could not be immediately reconciled.

Previously, the US military alleged that Iran had fired a missile at another drone last week that was responding to the attack on two oil tankers near the Gulf of Oman. The attacks come against the backdrop of heightened tensions between the U.S. and Iran following President Donald Trump's decision to withdraw from Tehran's nuclear deal a year ago. — AFP

NZ opens gun buyback after mosque killings

WELLINGTON (TIP): New Zealand opened a gun buyback scheme on Thursday aimed at ridding the country of semi-automatic weapons similar to those used in the Christchurch mosque attacks that killed 51 Muslim worshippers. PM Jacinda Ardern vowed in the hours after the March 15 killings that New Zealand's gun laws would be tightened and her government has expedited the change in just three months. "The buyback and amnesty has one objective—to remove the most dangerous weapons from circulation following the loss of life at Al Noor and Linwood mosques. PTI

China admits to hosting Taliban chief peace negotiator for talks

BEIJING (TIP): China on June 20 for the first time acknowledged that it recently hosted Afghan Taliban's chief peace negotiator Mullah Abdul Ghani Baradar for talks as part of its stepped-up efforts to enlarge its strategic role in Afghanistan and efforts to restore peace in the war-torn country.

Mullah Baradar, one of the four top commanders who formed the Taliban in 1994, was released from jail last year by the Pakistan government. He is believed to be the highest ranking Afghan Taliban prisoner freed so far.

After his release from the jail, Mullah Bardar has been holding talks with US Representative for Afghanistan Reconciliation Zalmay Khalilzad.

China, a close ally of Pakistan, has been trying to iron out differences between Pakistan and Afghanistan. Afghanistan accuses Pakistan of providing safe haven to the Afghan Taliban, Haqqani network and other militant groups, which carry out attacks in the war-torn country.

The "head of Taliban political office in Doha, Bardar, visited China", Chinese Foreign Ministry spokesman Lu Kang told the media here on Thursday. "During his visit, the Chinese officials exchanged views with him on the peace and reconciliation process as well as the



fight against terrorism," he said.

Bardar was told about the constructive role being played by China in peace and reconciliation process in Afghanistan, Lu said.

"We always support the Afghan-led and Afghan-owned extensive and inclusive peace and reconciliation as well as the internal dialogue among the Afghans. So, we have made the position clear with the Taliban chief negotiator,"

he said.

Asked what the Taliban wants to end civil war in Afghanistan, Lu said: "I believe the relevant parties in Afghanistan who are committed to peace talks hope to resolve the internal situation in Afghanistan and achieve sustainable peace and reconciliation". "China is trying to promote the dialogue of Afghans. Another issue is the joint fight against terrorism," he said. — PTI

Britain suspends new Saudi arms licences linked to Yemen

LONDON (TIP): The British government said on June 20 it would suspend issuing new Saudi licenses for the sale of arms that might be used in the Gulf kingdom's bombing campaign in Yemen.

International Trade Secretary Liam Fox announced the decision in parliament after a British court ordered the government to "reconsider" the sales because of their humanitarian impact.

"We disagree with the judgement and will seek permission to appeal," Fox said.

"While we do this, we will not grant any new licenses to Saudi Arabia and its coalition partners which might be used in the conflict in Yemen." Shares in Britain's BAE Systems defence and aerospace giants lost almost three percent of their value within an hour of the government's announcement.

Britain's Court of Appeal had earlier on Thursday ruled that the government broke the law by failing to properly assess whether the arms it sells to Riyadh violated its commitment to human rights. Judge Terence Etherton said the UK government "must reconsider the matter" and weigh up future risks. The government had "made no concluded assessments of whether the Saudi-led coalition had committed violations of international humanitarian law in the past, during the Yemen conflict, and made no attempt to

do so," Etherton ruled.

Prime Minister Theresa May's office said she was "disappointed that the court found against the government on one ground" and would seek an appeal.

Thursday's ruling was part of a long-running court battle that the UK-based Campaign Against Arms Trade (CAAT) non-profit first launched against the British government in December 2015.

The UK High Court had ruled in July 2017 that the arms exports were "lawful".

The Court of Appeal reversed that decision on June 20. Britain accounts for 23 per cent of arms imports to Saudi Arabia and last year signed a multi-billion-pound preliminary order with Riyadh for 48 Eurofighter Typhoon fighter jets. Government figures analysed by CAAT show that Britain has licensed nearly 5 billion pounds (USD6.4 billion) in weapons to the kingdom since the Saudi-led campaign began in 2015.

The London court judge stressed that Thursday's decision "does not mean that licences to export arms to Saudi Arabia must immediately be suspended".

Fox made no references to existing arms sales contracts and did not imply that all exports to Britain's traditional Middle East ally would halt.

"This judgement is not about whether the decisions themselves were right or wrong, but whether the process in reaching those decisions was correct," Fox said in parliament. AFP

Former South African president Zuma called to graft inquiry

JOHANNESBURG (TIP): Former South African president Jacob Zuma was on Thursday called to give evidence next month at a judicial inquiry into alleged corruption during his nine years in office.

The commission headed by Judge Ray Zondo is investigating a web of deals involving government officials, the wealthy Gupta family and state-owned companies during Zuma's presidency.

Zuma has been scheduled to appear at the inquiry between July 15 to 19 "to enable him to give his side of the story", the commission said, after he was implicated by other witnesses in alleged corruption.

It added in a statement that Zuma had not confirmed whether he would appear on the scheduled dates, despite six weeks of discussions with his lawyers.

It said it had refused his request to be given questions in advance.

Zuma, who was forced to resign last year under a cloud of corruption scandals, allegedly accepted monthly bribes from a security firm, according to one witness at the Zondo commission.

Zuma, 77, has also been charged with 16 counts of graft linked to an arms deal from before he became president. He is seeking to have the case thrown out. — AFP

Congo declares measles epidemic after it kills more than Ebola

DAKAR (TIP): Democratic Republic of Congo's government has declared an epidemic of measles, which the latest health ministry figures show has now killed at least 1,500 people, more than a hundred more than have died of Ebola.

While health officials have focused on the hemorrhagic Ebola virus in Congo's east, about 87,000 suspected measles cases have been reported across the country so far this year, more than the 65,000 recorded in the whole of last year.

Congo's health ministry announced the measles figure when it declared the epidemic on June 18.

Medical charity Doctors Without Borders (MSF) said on Tuesday that 1,500 deaths from measles had been recorded in the first five months of 2019, the highest since 2012, which was the deadliest measles epidemic of the last decade.

Ebola has so far killed 1,390 people in Congo's North Kivu province, the latest Congo health ministry figures show.

MSF called for "a massive mobilisation of all relevant national and international organisations in order to vaccinate more children and



treat patients" affected by measles.

The health ministry said its vaccination campaign would target a further 1.4 million infants, and that 2.2 million had been vaccinated in April.

Health officials say comprehensive vaccination programmes are the only way to prevent measles spreading out of

control, but say ill-informed opposition can sometimes scupper such plans.

The United Nations children's fund (UNICEF) launched a campaign #VaccinesWork in April to counter a backlash against vaccination by some parents in different parts of the world. — Reuters

'Credible proof' against Saudi crown prince in Khashoggi case

GENEVA (TIP): There is "credible evidence" linking Saudi crown prince Mohammed bin Salman to the murder of journalist Jamal Khashoggi, a UN expert said on Wednesday, calling for sanctions on the prince's personal foreign assets.

The allegation regarding Prince Mohammed's possible direct role in Khashoggi's execution last October was detailed in a new report by the UN special rapporteur on extrajudicial or arbitrary executions, Agnes Callamard.

Callamard, an independent human rights expert who does not speak for the United Nations, also called on UN Secretary General Antonio Guterres to initiate a formal criminal investigation into the case. Khashoggi, a Washington Post contributor and critic of Prince Mohammed, was murdered at the Saudi consulate in Istanbul on October 2.

Blaming the murder inside the consulate on rogue agents, Saudi prosecutors have absolved the crown prince of responsibility. But Callamard said her inquiry had "determined that there is credible evidence, warranting further investigation of high-level Saudi Officials' individual liability, including the Crown Prince's". — AFP

26 injured after powerful earthquake jolts Japan



TOKYO (TIP): At least 26 people were injured after an earthquake measuring 6.7 on the Richter scale struck Japan's northwestern region, causing landslides and power outages in some areas, authorities said on June 19.

Seventeen people were injured in Yamagata prefecture, four each in Niigata and Miyagi prefectures, and one in Ishikawa Prefecture, according to the Kyodo News Agency.

There were no reports of missing people, the Fire and Disaster Management Agency said.

The Japan Meteorological Agency (JMA) warned of potential collapses of buildings and more landslides as there is a chance of more quakes of similar levels hitting Yamagata and Niigata prefectures facing the Sea of Japan over the following week while rain is expected in parts of the region on June 19.

The earthquake occurred at 10.22 p.m. on June 18 at a depth of about 14 km, with its epicenter located off Yamagata,

according to the meteorological agency. A tsunami warning was issued but lifted hours later.

A 10 cm tsunami was observed in the city of Niigata with smaller ones in other locations including Sakata and Wajima.

Multiple landslides occurred in Tsuruoka, according to the Yamagata prefectural government.

Some vehicles were trapped in mud as the temblor caused soil liquefaction in parts of Tsuruoka, and the roof over a sumo ring at an elementary school in the city collapsed, according to the local governments.

Over 9,200 houses in Niigata and Yamagata prefectures were hit by power outages but electricity services were restored by 6.44 a.m. on Wednesday, according to Tohoku Electric Power Co.

East Japan Railway Co. said the quake caused some delays to its bullet train services Tuesday, affecting around 10,000 people. It began Wednesday's services normally. — IANS

It's Johnson vs Hunt in UK PM race

LONDON (TIP): Brexit campaigner Boris Johnson and Jeremy Hunt, once an opponent of leaving the European Union who has now promised to exit with a deal, are the final two in the race to replace Prime Minister Theresa May.

Despite a series of scandals in the past and criticism about his attention to detail, Johnson has dominated the race since May announced a month ago that she would step down after failing to get her Brexit deal ratified by parliament. In a fifth and final ballot of Conservative lawmakers, which eliminated Environment Secretary Michael Gove, Johnson was again way out in front: he won 160 out of 313 votes against Hunt's 77. One ballot paper was rejected.

Johnson, 55, who served as London mayor for eight years, has cast himself as the only candidate who can deliver Brexit on October 31 while fighting off the electoral threats of Nigel Farage's Brexit Party and Jeremy Corbyn's Labour Party.

Johnson has increased his share of the vote of Conservative lawmakers at each of the four ballots so far: 114 out of 313 votes in the first ballot on June 13, 126 on June 18, 143 on Wednesday, and 157 and 160 on Thursday. Gove was third with 75. Interior minister Sajid Javid was knocked out in the fourth round earlier on June 20. Now around 160,000 Conservative Party grassroots members will vote on who will be their leader — and Britain's next PM — by the end of July. — Reuters

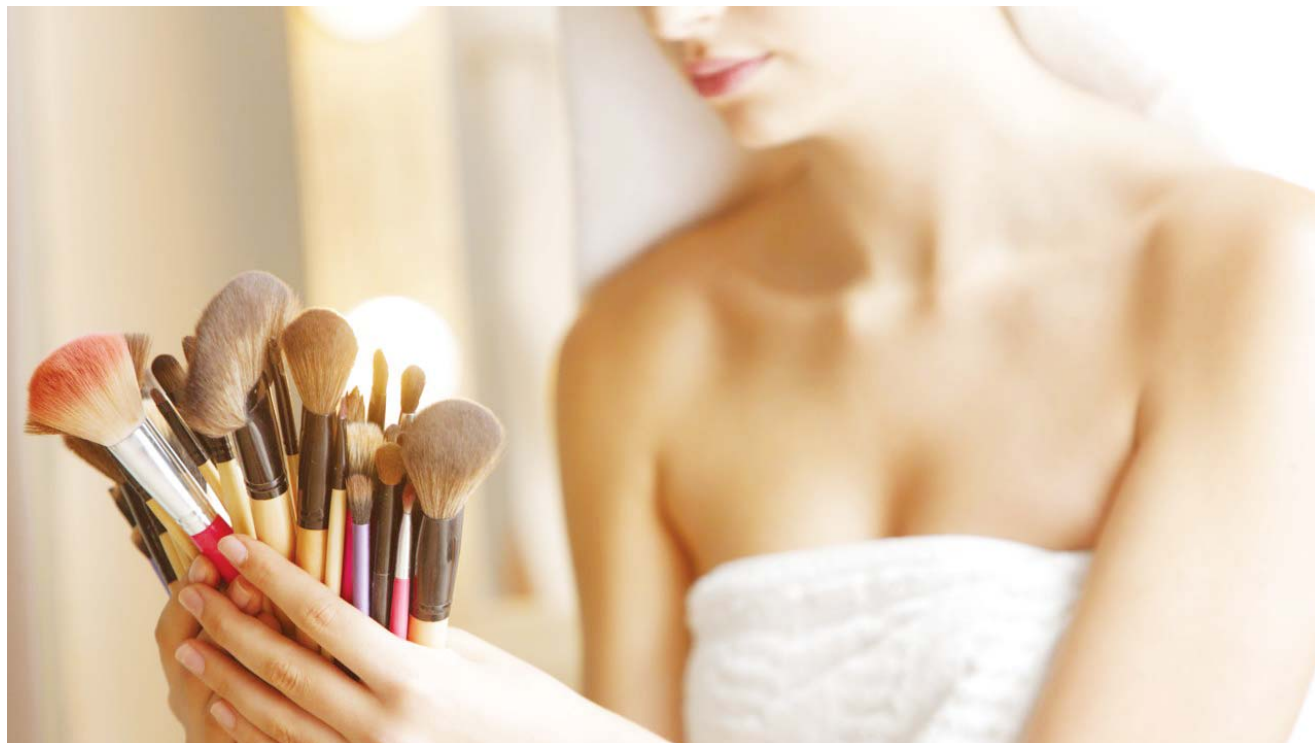
Einstein's relativity document gifted to Nobel museum

STOCKHOLM (TIP): The Nobel Museum in Stockholm has been gifted Albert Einstein's first paper published after he received the Nobel Prize in 1922 and discussing his then still controversial relativity theory. Swedish businessman Per Taube bought the handwritten two-page document at an auction for 1.2 million krona (110,000 euros) in December last year. He has now made good on his promise to gift the manuscript to the Nobel Museum, which will put it on display in a glass frame this autumn. The paper, written in November 1922 while Einstein was attending conferences in south-east Asia, was published a month later by the Prussian Academy of Sciences. AFP

China's former Interpol chief pleads guilty to bribery

BEIJING: Former Interpol chief Meng Hongwei pleaded guilty at a trial in China on Thursday to accepting \$2.1 million in bribes, a remarkable fall from grace for the former vice minister of public security. The verdict will be announced at a "select date or time", said court in northern China in a statement, without specifying further. AFP

KADAI CHICKEN

INGREDIENTS

- 1 kg chicken, washed, cleaned and cut into big pieces
- 4 tablespoons oil
- 1/2 cup onion, sliced
- 1 1/2 cups tomatoes, peeled and sliced
- 2 tablespoons fresh coriander leaves, chopped,
- 1 tablespoon ginger paste
- 1 tablespoon garlic paste
- 4 teaspoons garam masala powder
- 2 bay leaves
- 4 whole red chillies
- 2 teaspoons coriander seeds
- 1 teaspoon red chili, powder, salt

METHOD

- Grind coriander seeds and whole red chillies into a coarse powder.
- Heat oil in a kadai.
- Add bay leaves.
- After about 30 seconds, add onions and saute till they turn light golden brown.
- Add ginger-garlic paste.
- Saute for 2 minutes on medium flame.
- Add the above coarse powder.
- Stir well.
- Add tomatoes and cook till they are fully cooked.
- Add chicken pieces, salt to taste and red chilli powder.
- Mix well.
- Cover the kadai.
- Cook till the chicken becomes tender.
- Sprinkle garam masala powder over the chicken.
- Garnish with coriander leaves and onion rings.
- Serve hot with rotis or parathas.

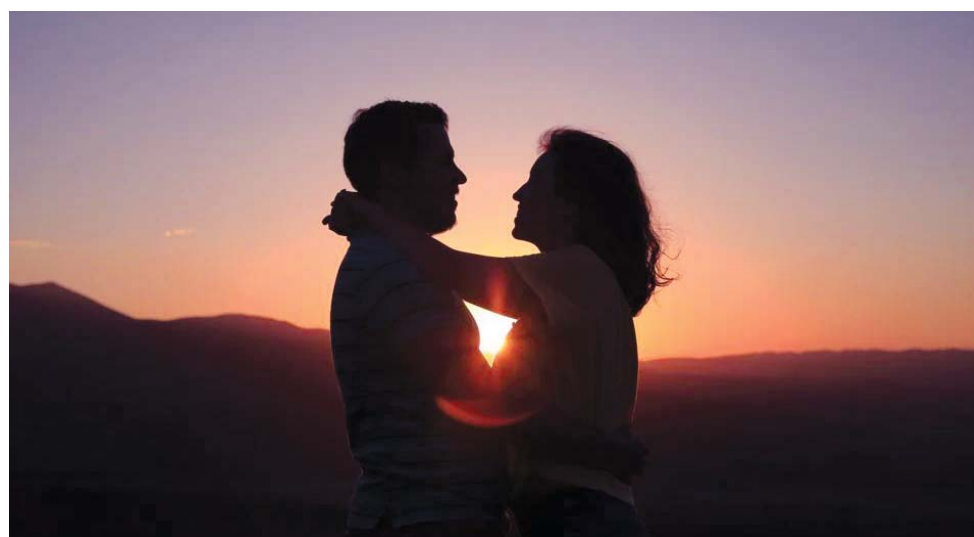
PORN RUINS WOMEN'S INTIMATE EXPERIENCES WITH MEN

Consuming porn instigates body-related insecurities in women that might not only reduce their interest in engaging in intimate activities with their partners but also negatively affect their arousal, a study suggests.

Researchers have explored the association between pornography and intimate partner experiences among heterosexual women and revealed that there was a complex relationship between the two.

Published in the Journal of Women's Health, the study reveals that thinking of pornographic material during intimate experiences with a heterosexual partner among women might give rise to insecurities about appearances and thus reduces the enjoyment of the intimate acts.

For the findings, the research team surveyed 706 heterosexual women aged



18-29 in the US, associating the consumption of pornography with sexual preferences, experiences and

concerns. The researchers reported that while most women in the study sample had seen pornography, fewer than half

used it for masturbation.

Those women who used it at higher rates for masturbation tended to rely more on pornographic scripts during sex to achieve and maintain arousal and were more likely to prefer pornography to sex with a partner. "The researchers demonstrate a clear difference between the role of pornography in sexual experiences of women compared to men," said Susan G Kornstein from Virginia Commonwealth University in the US.

"Whereas the relationship tends to be more direct in young heterosexual men and just viewing pornographic material is associated with reduced sexual intimacy and satisfaction, women make the material part of their personal sexual experience and carry the pornographic script into their intimate partner experiences," Kornstein said.

WHILE CHOOSING, TEXTURE OF FOOD MATTERS TOO

Not just the taste and smell, but food's texture also affects whether it is eaten, liked or rejected, recent findings suggest.

As part of the study, researchers found that people are better at detecting even minor differences in consistency because their tongues can perceive particle sizes.

The research included 111 volunteer tasters who had their tongues checked for physical sensitivity and then were asked their perceptions about various textures in chocolate.

"We've known for a long time that individual differences in taste and smell can cause differences in liking and food intake - now it looks like the same might be true for texture," said John Hayes, associate professor of food science.

According to the researchers, these findings, published in Scientific Report, may have implications for parents of picky eaters since the texture is often a major reason food is rejected.

The perception of food texture arises from the interaction of a food with mechanoreceptors in the mouth, Hayes noted. It depends on neural impulses carried by multiple nerves.

Despite being a key driver of the acceptance or rejection of foods, he pointed out, oral texture perception remains poorly understood relative to taste and smell, two other sensory inputs critical for flavor perception.

One argument is that texture typically is not noticed when it is within an acceptable range, but that it is a major factor in rejection if an adverse texture is present, explained Hayes.

For chocolate specifically, oral



texture is a critical quality attribute, with grittiness often being used to differentiate bulk chocolate from premium chocolates.

"Chocolate manufacturers spend lots of energy grinding cocoa and sugar down to the right particle size for optimal acceptability by consumers," he said. "This work may help them figure out when it is good enough without going overboard."

Researchers tested whether there was a relationship between oral touch sensitivity and the perception of particle size. They used a device called Von Frey Hairs to gauge whether participants could discriminate between different amounts of force applied to their tongues. When participants were split into groups based on pressure-point sensitivity - high and low acuity - there was a significant relationship between chocolate-

texture discrimination and pressure-point sensitivity for the high-acuity group on the center tongue. However, a similar relationship was not seen for data from the lateral edge of the tongue.

Chocolate texture-detection experiments included both manipulated chocolates produced in a pilot plant in the Rodney A. Erickson Food Science Building and with two commercially produced chocolates. Because chocolate is a semi-solid suspension of fine particles from cocoa and sugar dispersed in a continuous fat base, Hayes explained, it is an ideal food for the study of texture.

Researchers suggest that these findings suggest that texture-detection mechanisms, which underpin point-pressure sensitivity, likely contribute to the detection of particle size in food such as chocolate. *Source: ANI*



PERSONAL CARE PRODUCTS HARMFUL FOR CHILDREN

Personal care products like shampoo, lotion, nail polish and cologne may send one child to the hospital every two hours due to poisoning and chemical burns, according to a US study published on Monday.

Researchers at the Nationwide Children's Hospital found that 64,686 children younger than five years of age were treated in US emergency departments for injuries related to personal care products from 2002 through 2016.

The study, published in the journal Clinical Pediatrics, found that most injuries from these products occurred when a child swallowed the product (75.7 per cent) or the product made contact with a child's skin or eyes (19.3 per cent).

These ingestions and exposures most often led to poisonings (86.2 per cent) or chemical burns (13.8 per cent), researchers said.

"When you think about what young children see when they look at these products, you start to understand how these injuries can happen," said Rebecca McAdams, a senior research associate at Nationwide Children's Hospital.

"Kids this age can't read, so they don't know what they are looking at. They see a bottle with a colourful label that looks or smells like something they are allowed to eat or drink, so they try to open it and take a swallow.

"When the bottle turns out to be nail polish remover instead of juice, or lotion instead of yogurt, serious injuries can occur," McAdams said.

The top three product categories leading to injuries were nail care products (28.3 per cent) hair care products (27.0 per cent), and skin care products (25.0 per cent), followed by fragrance products (12.7 per cent).

Nail polish remover was the individual product that led to the most number of visits to the emergency room (17.3 per cent of all injuries).

Of the more serious injuries that required hospitalisation, more than half were from hair care products (52.4 per cent) with hair relaxers and permanent solutions leading to more hospitalisations than all other products.

Also of concern, is the ease of access to these products, researchers said.

"Children watch their parents use these items and may try to imitate their behaviour. Since these products are often stored in easy-to-reach places and are not typically in child-resistant containers, it can be easy for kids to get to and open the bottles," said McAdams. *Source: PTI*

ANTI-MALARIA DRUG MAY PREVENT HEREDITARY HEARING LOSS: STUDY

A widely-used anti-malaria drug may help prevent hearing loss caused by heredity and genetic disorders, a study has found.

Researchers from Case Western Reserve University in the US conducted a study on zebrafish with a commonly used anti-malarial drug called artemisinin.

They found that the drug can help sensory cells of the inner ear recognise and transport an essential protein to specialised membrane using established pathways within the cell, which will help improve and restore hearing.

The ability to hear depends on these proteins reaching the outer membrane of the sensory cells in the inner ear which may be hindered due to certain types of mutations in the protein due to hereditary disorders, which prevent it from reaching those membranes.

The sensory cells of the inner ear



are covered by hair-like projections, called hair cells, on the surface.

These hair cells convert vibrations from sounds and movement into electrical signals

that are conveyed through the nerves and translated in the brain into information for hearing and balance. *Source: PTI*

RESEARCHERS BUILD AI SYSTEM TO CONNECT VISION, TOUCH



INSTAGRAM TESTING WAY OF RECOVERING HACKED ACCOUNTS

To offer more assurance in recovering hacked accounts, Facebook-owned messaging app Instagram is testing a new in-app account recovery process.

To control cases where the hackers alter username and contact data linked to the accounts, Instagram is offering a safeguard which would prevent any username from being claimed for a "period of time" after account changes, whether it is a hack or a voluntary change.

As part of the new test process, for recovery, users are being asked to fill in their personal information such as their original email address or phone number and later send them a six-digit code to the contact information of their choice, Engadget reported on Sunday.

The new method is intended to ensure account recovery even if the hacker alters the username and contact information linked to the account.

With this process, the photo-messaging app also intends to prevent hackers from using email or phone number codes to take over accounts from different devices, the report said.

For now, details on the wider availability of this in-app remains unclear, although the username lockdown has been made available to all Android users now which is being deployed to iOS users as well.

Rare supernova explosion 'gifted' Earth with gold, platinum: Study

An overlooked star explosion far away in space may have given the Earth the gift of precious heavy elements such as gold and platinum, a study claims.

The research from University of Guelph in Canada and Columbia University in the US overturns our understanding of how heavy elements appeared on our planet.

According to the research published in the journal Nature, some 80 per cent of the heavy elements in the universe likely formed in collapsars.

Collapsars are a rare but heavy element-rich form of supernova explosion from the gravitational collapse of old, massive stars typically 30 times as weighty as our Sun. Using supercomputers, the researchers simulated the dynamics of collapsars, or old stars whose gravity causes them to implode and form black holes.

Under their model, massive, rapidly spinning collapsars eject heavy elements whose amounts and distribution are "astonishingly similar to what we observe in our solar system," said Daniel Siegel, from University of Guelph.

Most of the elements found in nature were created in nuclear reactions in stars and ultimately expelled in huge stellar explosions.



A team of researchers at the Massachusetts Institute of Technology (MIT) have come up with a predictive Artificial Intelligence (AI) that can learn to see by touching and to feel by seeing.

While our sense of touch gives us capabilities to feel the physical world, our eyes help us understand the full picture of these tactile signals.

Robots, however, that have been programmed to see or feel can't use these signals quite as interchangeably.

The new AI-based system can create realistic tactile signals from visual inputs, and predict which object and what part is being touched directly from those tactile inputs.

In the future, this could help with a more harmonious relationship between vision and robotics, especially for object recognition, grasping, better scene understanding and helping with seamless human-robot integration in an assistive or manufacturing setting.

"By looking at the scene, our model can imagine the feeling of touching a flat surface or a sharp edge", said Yunzhu Li, PhD student and lead author from MIT's Computer Science and Artificial Intelligence Laboratory (CSAIL).

"By blindly touching around, our model can predict the interaction with the environment purely from tactile feelings," Li added.

The team used a KUKA robot arm with a special tactile sensor called GelSight, designed by another group at MIT.

Using a simple web camera, the team recorded nearly 200 objects, such as tools, household products, fabrics,



and more, being touched more than 12,000 times.

Breaking those 12,000 video clips down into static frames, the team compiled "VisGel," a dataset of more than three million visual/tactile-paired images.

"Bringing these two senses (vision and touch) together could empower the robot and reduce the data we might need for tasks involving manipulating and grasping objects," said Li. The current dataset only has examples of interactions in a controlled environment.

The team hopes to improve this by collecting data in more unstructured areas, or by using a new MIT-designed tactile glove, to better increase the size and diversity of the dataset.

"This is the first method that can convincingly translate between visual and touch signals", said Andrew Owens, a post-doc at the University of California at Berkeley.

This app turns smartphone into robot to perform boring jobs



A smartphone app that allows a user to easily programme any robot to perform a mundane activity, such as picking up parts from one area and delivering them to another, has been developed by scientists, including one of Indian origin.

The app developed by researchers at Purdue University in the US could dramatically bring down the costs of building and programming mobile robots. The setup could also take care of household chores, they said.

"Smaller companies can't afford software programmers or expensive mobile robots," said Karthik Ramani, from Purdue University.

"We've made it to where they can do the programming themselves, dramatically bringing down the costs of building and programming mobile robots," he said.

Using augmented reality, the app allows the user to either walk out where the robot should go to perform its tasks, or draw out a workflow directly into real space. The app offers options for how those tasks can be performed, such as under a certain time limit, on repeat or after a machine has done its job. After programming, the user drops the phone into a dock attached to the robot.

While the phone needs to be familiar with the type of robot it is "becoming" to perform tasks, the dock can be wirelessly connected to the robot's basic controls and motor. The phone is both the eyes and brain for the robot, controlling its navigation and tasks.

"As long as the phone is in the docking station, it is the robot. Whatever you move about and do is what the robot will do," Ramani said.

GOOGLE STREET POWERS AI TOOL TO MONITOR ROAD INFRA

The fully-automated system is based on AI-powered object detection to identify street signs in the freely available images.

Published in the journal of Computers, Environment and Urban Systems, the study shows the system detects signs with near 96% accuracy, identifies their type with near 98% accuracy and can record their precise geo-location from the 2D images.

"The proof-of-concept model was trained to see 'stop' and 'give way' (yield) signs, but could be trained to identify many other inputs and was easily scalable for use by local governments and traffic authorities," said the study lead author Andrew Campbell from RMIT University in Australia.

Municipal authorities spend a large amount of time and money monitoring and recording the geo-location of traffic infrastructure manually, a task which also exposes workers to unnecessary traffic risks.

"By using free and open source tools, we've developed a fully automated system for doing that job, and doing it more accurately," Campbell said.

After Maruti, Renault India could exit diesel segment

NEW DELHI (TIP): After Japanese major Suzuki's announcement to put a hard stop on diesel engines on all its models on sale in India under Maruti Suzuki, French carmaker Groupe Renault is looking at a similar strategy globally and India could be just one of the markets to fall under that.

Speaking to journalists after the global unveil of the Renault Triber in New Delhi, Groupe Renault CEO, Thierry Bolloré told media that the Triber being petrol-only is an "indication of the company's future powertrain approach for the Indian market."

Bolloré said that diesel is naturally decreasing in terms of proportions of Renault's sales globally and while there has been a massive drop in diesel demand after 2015, the current trend is of regulatory approach that countries are following worldwide.

"All the regulations are designed to push the car industry forward with respect to EVs and let's see what happens in the Indian market. As a consequence to the dieselgate, we have already limited the production of diesel in Europe," Bolloré said.

"We have invested and pushed very hard to make our diesel lines to produce gasoline," he added.

"We are going towards massive electrification of our cars, not only BEVs, but also hybrids. Plug-in hybrids and conventional hybrids are going to play a crucial role in compensating for the range that is still a challenge with full electrics," said Bolloré.

"While we are already selling FCEVs in Europe that run on hydrogen, but the big problem right now is of hydrogen fuel stations."

Today, fuel cell technology is quite difficult for passenger cars because of the costs and secondly,



hydrogen is being produced through gas and that in itself isn't a clean way but is set to improve in the future. "But, batteries too are making tremendous progress and it would be highly difficult for FCEVs to match the value proposition offered by BEVs," said Bolloré.

"On the other hand, the application of mini fuel-cells as range extenders will bring the best balance of cost and range for customers. EVs and FCEVs are just not on the same horizon," he added.

With shared mobility seeing greater attention from passenger vehicle OEMs in India with the recent examples being partnerships between Mahindra-Ola, Hyundai-Revv and Ford-Zoomcar, Renault believes it could also be party to the

new trends of a shared mobility ecosystem.

"We have a worldwide team taking care of new mobility solutions and also alliances in terms of platforms and we are piloting autonomous-driven Zoe cars. From all this experimentation, we have come to a global business plan and we will put shared services in Paris and we have ten global cities already targeted," said Bolloré.

"Our business models cater to the needs of these cities and alongside, we are able to make money. Now, as we know what the model is, we can tweak that model with local adaptations. So, there could be possibilities of having such a shared scenario in India as well," he concluded.

THE WORLD NOW HAS THREE PEOPLE WORTH MORE THAN \$100 BILLION EACH

Bernard Arnault, Europe's richest person, just joined Jeff Bezos and Bill Gates in the world's most exclusive wealth club with a fortune of at least \$100 billion.

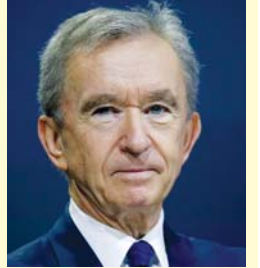
Arnault, chairman of LVMH, entered the ranks of centibillionaires Tuesday as the luxury-goods maker climbed 2.9% to a record 368.80 euros a share. His net worth has increased almost \$32 billion this year, the most on the 500-member Bloomberg Billionaires Index.

France's multimillionaires have added the most wealth among European members of Bloomberg's ranking in 2019, with Arnault, Kering SA's Francois Pinault and cosmetics heir Françoise Bettencourt Meyers tacking on more than \$40 billion between them. Meanwhile, the brothers behind the Chanel brand, Gerard and Alain Wertheimer, saw their fortunes soar \$9.8 billion this week after the Parisian fragrance and fashion house reported its 2018 results.

Arnault's fortune of \$100.4 billion now equals more than 3% of France's economy, underscoring the wealth gap in his native country, where protesters have agitated this year for more benefits paid for by the rich. Even amid growing trade tensions, Chinese consumers' appetite for Louis Vuitton handbags and Hennessy cognac has bolstered results for LVMH, the owner of Dom Perignon Champagne and Tag Heuer watches. The company's shares have surged 43% this year, the third-best performer on France's CAC 40 Index. Arnault, 70, and his family are among luxury tycoons who pledged more than \$650 million in April for the reconstruction of Notre Dame Cathedral after the landmark church was ravaged by fire. He controls about half of Paris-based LVMH through a family holding company and also owns a 97% stake in Christian Dior, the fashion house founded three years before his birth in 1949. Arnault entered the luxury-goods market by acquiring a textile group that owned Christian Dior. He sold all of the company's other businesses and used the proceeds to buy a controlling stake in LVMH in 1988.

Gates, the Microsoft Corp. co-founder, has donated more than \$35 billion to the Bill & Melinda Gates Foundation. Amazon.com Inc.'s Bezos, meanwhile, saw his net worth drop \$40 billion earlier this year after reaching a divorce settlement with MacKenzie Bezos.

EU court declares Adidas three-stripe trademark invalid

LUXEMBOURG (TIP): Adidas has failed in an attempt to broaden trademark protection for its three-stripes symbol in the European Union as rivals seek to muscle into the market for striped shoes and clothing.

Adidas had tried to establish a wider trademark for "three parallel equidistant stripes of equal width applied to the product in whichever direction".

The German sporting goods company has trademark protection for its slanted three-stripe logo.

"The verdict does not affect our ability to use and protect the three stripes," a spokeswoman said.

The sporting goods industry has seen a rise in trademark and patent disputes as the biggest players try to differentiate their products and justify premium pricing.

High-profile cases have included



Adidas clashing with Skechers USA and Nike taking on Puma.

Wednesday's ruling could erode the value of the Adidas brand, currently worth \$14.3 billion, according to David Haigh, chief executive of consultancy Brand Finance.

"The name is more important but the recognizable three stripes are also a major contributor to recognition," he said.

US PUSHES FOR CONDITIONALITY IN IMF 6 BILLION DOLLAR BAILOUT PACKAGE TO PAK

WASHINGTON (TIP): Amidst reports that the IMF has reached a multibillion-dollar bailout package with cash-strapped Pakistan, the United States is seeking "conditionality" in the new financial aid from the global lender.

Pakistan last month reached an agreement with the Washington-headquartered International Monetary Fund (IMF) for a USD 6 billion bailout package aimed at shoring up its finances and strengthening a slowing economy as tries to overcome a ballooning balance-of-payments crisis.

The US has serious reservations over global lenders like the IMF providing a bailout to Pakistan to pay off Chinese debts.

"There is a discussion about the conditionality what we think would be appropriate for an IMF package to Pakistan," according to Senior State Department official (South and Central Asian Affairs) Alice G Wells.

Responding to questions from lawmakers during a Congressional hearing last week,



she told House Foreign Affairs Subcommittee for Asia, the Pacific and Nonproliferation that while the US has not seen the IMF package yet, there has been an agreement reached between the IMF and government of Pakistan.

"But certainly, we have communicated our strong views and Secretary (Mike) Pompeo has also done so publicly on the need for any package to include a real structural reform to reinforce..." Wells said when Congressman Brad Sherman said it looks like that the IMF loan is going through.

KABIR JAYANTI

Sant Kabirdas (1440-1518 circa) was a famous poet, saint and social reformer of India. His writings have greatly influenced the Bhakti movement. Kabir Panth which is a religious community recognizes him as its founder and its members are known as Kabir Panthis, the followers of Saint Kabirdas.

His writings include Bijak, Sakhi Granth, Kabir Granthawali and Anurag Sagar. The major part of Kabir's work was collected by the fifth Sikh Guru, Guru Arjan Dev, and incorporated into the Sikh scripture Guru Granth Sahib. The hallmark of Kabir's work consists of his two line couplets, known as Kabir Ke Dohe.

The birth anniversary of Sant Kabir is observed on Jyeshtha Purnima as per Hindu lunar calendar.

Rituals during Kabir Jayanti

On the occasion of Kabir Jayanti, the followers of this great saint dedicate the day completely in his remembrance. On this day they recite poems of Sant Kabir Das and take lessons from his teachings. Various meetings and satsangs are held in different places. Sant Kabir Das is still alive in the heart of his followers or devotees who follow his sermons in his poems and two-line couplets known as 'Kabir ke Dohe'. On Kabir Jayanti this day is elaborately celebrated in Varanasi, his birthplace. Religious sermons are held at Kabirchaura Mutt where religious and spiritual leaders preach his teachings to the common man. Special festivities are observed on Kabir Jayanti at various temples of Kabir in different parts of the country. In some places a procession called as 'Shobhayatra' is taken out that culminates at Kabir temple.

Significance of Kabir Jayanti

According to the legends, Kabir Das was born to Muslim parents in the state of Uttar Pradesh. He turned to spirituality at a very tender age and he called himself as Lord Ram's as well as Allah's child. He did not believe in any religious discrimination and readily accepted all the religions. Sant Kabir Das propagated that there is the presence of same Supreme Being in all religions. Sant Kabir Das was a highly acclaimed poet of his time. His writings significantly influenced the Bhakti movement. Some of his famous writings include 'Sakhi Granth', 'Anurag Sagar', 'Bijak' and 'Kabir Granthawali'. A religious community known as 'Kabir Panth' was founded by him and the members of this forum are referred as 'Kabir Panthis', implying the followers of Kabir Das. He was admired by individual of all faiths and his teachings are still alive and passed from generations.

Kabir Das, a mystical poet and great Saint of India, was born in the year 1440 and died in the year 1518. According to the Islam the meaning of the Kabir is The Great. Kabir Panth is the huge religious community which identifies the Kabir as the originator of the Sant Mat sects. The members of Kabir Panth are known as the Kabir panthis who had extended all over the over north and central India. Some of the great writings of the Kabir Das are Bijak, Kabir Granthawali, Anurag Sagar, Sakhi Granth etc. It is clearly not known about his birth parents but it is noted that he has been grew up by the very poor family of Muslim weavers. He was very spiritual person and became a great Sadhu. He got fame all over the world because of his influential traditions and culture.



It is considered that he got all his spiritual training from his Guru named, Ramananda, in his early childhood. One day, he became a well known disciple of the Guru Ramananda. The house of the Kabir Das has accommodated students and scholars for living and studying his great works.

There is no clue of the birth parent of the Kabir Das but it is considered that he was cared by a Muslim family. He was founded in Lehartara, a small town in Varanasi by the Niru and Nima (his care taker parents). His parents were extremely poor and uneducated but they very heartily adopted the little baby and trained him about their own business. He lived the balanced life of a simple house holder and a mystic.

Kabir Das Teaching

It is considered that he got his spiritual training came from the Ramananda, guru of the Sant Kabir. In the starting Ramananda was not agreeing to accept Kabir Das as his disciple. Once upon a time, Sant Kabir Das had lie down on the ladders of the pond and reading the mantra of Rama-Rama, in the early morning Ramananda was going for taking bath and Kabir come down below his feet. Ramananda felt guilty for that activity and then Ramananda was forced to accept him as his disciple. It is believed that Kabir's family is still living in the Kabir Chaura in Varanasi.

It is the photo of the Saint Kabir Math in the Varanasi where saints are busy in the singing Kabir Ke Dohe. It is the place of giving real education of life to the people.

Kabir Matha

Kabir matha is located at the Kabir Chaura, Varanasi and Lahartara, Varanasi in the back passageways.

Neeru teela was the house of his parents the Neeru and Neema. Now it has become the accommodation for students and scholars who study Kabir's work.

Philosophies

Sant Kabir was prejudiced by the existing religious mood of that time like Hinduism, Tantrism as well as the personal devotionalism mixed with the imageless God of Islam. Kabir Das is the first Indian saint who has coordinated the Hinduism and Islam by giving a universal path which could be followed by both Hindus and Muslims. According to him every life has relationship with two spiritual principles (Jivatma and Paramatma). His view about the moksha that, it is the process of uniting these two divine principles. His great writing Bijak has huge a collection of poems which makes clear the Kabir's general view of the spirituality. Kabir's Hindi was a dialect, simple like his philosophies. He simply followed the oneness in the God.

He has always rejected the murti puja in Hinduism and shown the clear confidence in bhakti and Sufi ideas.

His Poetry

He had composed the poems in a concise and simple style resonating the admire for factual guru. After being an illiterate he had written his poems in Hindi mixing with Avadhi, Braj, and Bhojpuri. He was insulted by some people but he never attended.

Legacy

All the poems and songs credited to the Sant Kabir are existing in the several languages. Kabir and his followers are named according to his poetic response such as banis and utterances. The poems are called variously as dohe, saloka and sakhi. Sakhi means to be memorizes and to remind the highest Truth. The memorizing, performing, and pondering over these utterances comprises for the Kabir and all his followers a way to the spiritual awakening.

Kabir Das: A Hindu or Muslim

It is considered that after the death of Kabir Das, Hindus and Muslims had claimed for getting the dead body of Kabir Das. Both of them wanted to do the funeral of dead body of the Kabir Das according to their own customs and traditions. Hindus stated that they want to burn the body as he was a Hindu and Muslims said that they want to bury under the Mohammedan rites as he was a Muslim.

But, when they removed the sheet from the dead body they found only some flowers at that place. hey distributed the flower between each other and completed the funeral according to their own traditions and customs. It is also considered that when they were fighting, the spirit of Kabir das came to them and said that, "I was neither a Hindu nor a Mohammedan. I was both. I was nothing. I was all. I discern God in both. There is no Hindu and no Mussalman. To him who is free from delusion, Hindu and Mussalman are the same. Remove the shroud and behold the miracle!"

A temple of Kabir Das is made at the Kabir Chaura in the Kashi which has now become the great pilgrimage place for the people all over India as well as outside India. And a mosque of him was built by the Muslims over the grave which has become the pilgrimage for Mohammedans.

Responding officers located an imitation pistol inside of the suspect's bag. The suspect was apprehended.

On Saturday, June 8, 2019, 38-year-old Aftabjit Singh, of No Fixed Address, was arrested and charged with Possession of Prohibited Weapon.

Indian American Massachusetts Restaurant Owner Pleads Guilty to Conspiracy to Defraud IRS

BOSTON (TIP): A Denham, Massachusetts, resident pleaded guilty June 6 in Boston to conspiring to defraud the United States by impeding the lawful functions of the Internal Revenue Service (IRS), announced Principal Deputy Assistant Attorney General Richard E. Zuckerman of the Justice Department's Tax Division.

According to court documents, Ayaz Ali Shah co-owned and operated a carry-out restaurant called "New York Fried Chicken and Pizza" that conducted business in Dorchester, Massachusetts. The indictment alleges that Shah, together with his co-defendants, Muhamad Siuyab Khan and Khurshed Jehan Badshah, conspired to defraud the United States from 2009 through 2014. The co-defendants each owned twenty percent of the business, but during the five-year period charged in the indictment, Shah and his co-conspirators allegedly agreed to underreport the business's gross receipts, cost of goods sold, and net profit, and to report these false amounts on Shah's 2012 and 2013 individual tax returns.

The indictment against Khan and Badshah remains pending.

Chief United States District Judge Patti B. Saris scheduled Shah's sentencing for Sept. 19, 2019. Shah faces a maximum sentence of five years in prison on the conspiracy charge. He also faces a period of supervised release, restitution and monetary penalties.

Indian Origin Former Healthcare Executive Pleads Guilty to Bribing Arkansas State Senator

SPRINGFIELD, MO (TIP): A former executive of Preferred Family Healthcare, Inc., pleaded guilty in federal court June 12 to his role in a conspiracy to bribe an Arkansas state senator to influence public policy for the benefit of the charity and its executives.

Robin Raveendran, 63, of Little Rock, Arkansas, pleaded guilty before U.S. Magistrate Judge David P. Rush to a federal information that charges him with one count of conspiracy to commit bribery concerning programs receiving federal funds.

Raveendran worked for Preferred Family Healthcare (formerly known as Alternative Opportunities, Inc.) from 2014 to 2017 as a director of operations, executive vice president, and analyst. Prior to his employment with the charity, Raveendran was employed by the state of Arkansas as director of program integrity for the Arkansas Department of Human Services, Division of Medical Services, and then as business operations manager with the Office of the Medicaid Inspector General.

By pleading guilty, Raveendran



admitted that he participated in a conspiracy to bribe then-Arkansas State Senator Jeremy Young Hutchinson, who is charged in a separate case, in order to influence and reward Hutchinson in exchange for Hutchinson taking legislative and official action favorable to Preferred Family Healthcare and its executives.

According to today's plea agreement,

Preferred Family paid funds to Alliance for Health Care (also known as Alliance for Health Care Improvement), a private association formed in early 2014 by Raveendran, Hutchinson, and Milton "Rusty" Cranford, an Arkansas lobbyist and Preferred Family executive. Alliance was formed to advocate for issues relevant to health care providers at the Arkansas state legislature and in state departments.

Raveendran then directed Alliance funds to Hutchinson, the plea agreement says, in exchange for Hutchinson holding up agency budgets; initiating legislative audits; sponsoring, filing, and voting for legislation, including shell bills; and pressuring and advising other public officials to perform official action on behalf of Preferred Family.

Raveendran admitted that he and others concealed evidence of the bribes by falsely describing such unlawful payments as being solely for attorney's fees and legal retainers. Under federal statutes, Raveendran is subject to a sentence of up to five years in federal prison without parole.

Indian Student sentenced to 60 months in prison for 'Tech Support' Fraud Scheme

NEWPORT (TIP): A college intern from India who led a group of college students in Newport in their participation in a "tech support" fraud scheme that duped close to two dozen individuals out of nearly a million dollars was sentenced June 10 in federal court in Providence to 60 months in federal prison and ordered to re-pay his victims, announced United States Attorney Aaron L. Weisman, Newport Police Chief Gary T. Silva, and Homeland Security Investigations (HSI) Special Agent in Charge Peter C. Fitzhugh.

The Newport-based operation was tied to a large-scale telemarketing operation based in India.

Bishwajeet Kumar Jha, 21, and several other interns from the same college in India who were in the United States on hospitality industry internships defrauded a number of individuals of their retirement savings. The victims ranged in age from 58 years-old to 93 years-old and were duped out of between \$1,180 dollars and \$174,300 dollars. Over approximately three-months, the conspiracy defrauded individuals of at least \$937,280.

The victims, who believed that they had purchased technology support, were led to believe that money had been erroneously refunded to their bank accounts by the tech support company. The victims were asked to return the erroneous refund and directed to send

the money to the defendant and others. Some of the victims were told to send the money overseas.

The scheme was interrupted by Newport Police on November 20, 2018, when, as part of the investigation, detectives executed a court-authorized search of the residence of Jha and the other members of the conspiracy.

During the court-authorized search, Newport Police seized numerous items related to the operation of the telemarketing scheme. A subsequent investigation by members of the Newport Police Department and HSI agents determined that after the co-conspirators operating in Newport shared some of the proceeds of the scheme, large sums of money garnered from the scheme were transferred to a bank account in California. From there, the majority of funds were transferred internationally to India, China, and Singapore.

"The Department of Justice takes very seriously and will advocate for the imposition of substantial criminal penalties for targeting vulnerable, especially elderly, victims through the commission of federal crimes such as this," said United States Attorney Aaron L. Weisman. "Investigations like this one by the Newport Police Department and Homeland Security Investigations show the strength of law enforcement working together to identify and hold accountable those whose mission it is to steal, and in

some instance bankrupt, the elderly and most vulnerable in our community."

Newport Police Chief Gary T. Silva commented, "This type of criminal activity is disturbing. Those who prey on citizens, particularly those citizens who are vulnerable, are deliberately calculating in their persistent efforts to defraud honest people. This investigation and successful prosecution of those responsible should provide notice to others contemplating similar acts that law enforcement and prosecutors are committed to actively bring to justice those responsible."

"Today's sentence is fitting and appropriate in light of the serious nature of the charges this defendant was convicted of," said Peter C. Fitzhugh, Special Agent in Charge, U.S. Immigration and Customs Enforcement's Homeland Security Investigations, Boston. "HSI remains strongly committed to investigating those who wrongly believe they can exploit the generous nature of our immigration system to scam Americans via financial fraud schemes."

At sentencing, U.S. District Court Judge John J. McConnell, Jr., sentenced Jha to 60 months in prison. A restitution order will be issued by the Court at a later date.

Jha will face deportation proceedings upon completion of his term of incarceration.

Trump launches 2020 re-election bid...

the 45th President of the United States of America in 2017, told a crowd of 20,000 Republican supporters that the economy of the US under him has become "the envy of the world". Florida is a key battleground state and one that Trump narrowly won in 2016. Trump said his victory three years ago was a "defining moment in American history" and vowed to maintain his "America First" policy as he touched the hallmarks of his 2016 campaign, hardline immigration policies and defense spending.

He said the country had made significant progress during his presidency and all that was at risk if he were to be defeated in the presidential elections next year. Unveiling the theme of "Keep America Great", Trump in his roughly 80-minute speech, exuded confidence of winning the general elections. In his 2016 election campaign, he popularized the slogan "Make America Great Again". Addressing his supporters who filled the Orlando's Amway Center, brimming with enthusiasm for the President, Trump said, "We're going to keep on going. We're going to keep on fighting and we're going to keep on winning, winning, winning".

Amidst chants of "four more years" from his supporters, Trump announced his 2020 re-election campaign to complete his unfinished agenda. In his speech, Trump accused Democrats of pushing socialism and vowed, "America will never be a socialist country". "New campaign, same broken promises. Voters heard nothing new tonight. It's been the same thing for the past two and a half years. One broken promise after another," said Democratic National Committee Deputy War Room Director Daniel Wessel. (Source: PTI)

India dismisses Pak media reports...

The Indian prime minister and the foreign minister responded to the letters, with some reports claiming that New Delhi had shown its willingness to enter into a dialogue with Islamabad. In response to queries regarding replies to congratulatory messages by PM and FM of Pakistan, an Official Spokesperson from Ministry of External Affairs said, that Prime Minister Narendra Modi made it clear that Pakistan has to build a terror free environment first for normal and cooperative relations between two neighbors.

"As per the established diplomatic practice, PM and EAM have responded to the congratulatory messages received from their counterparts in Pakistan. In their messages, they have highlighted that India seeks normal and cooperative relations with all neighbors, including Pakistan. In his message, PM said, "For this, it is important to build an environment of trust, free of terror, violence and hostility." EAM also emphasized the need for an 'atmosphere free from the shadow of terror and violence', the MEA statement said. After India's External Affairs Ministry spokesperson issued the rebuttal and insisted that New Delhi's position remained the same, Pakistan's Foreign Office played down the hype over the letters and termed it a diplomatic practice for the leadership to congratulate new officeholders and for them to respond. Islamabad's Foreign Office spokesperson Dr Muhammad Faisal also issued a clarification later, cautioning against media speculations.

India has not been engaging with Pakistan since an attack on the Air Force base at Pathankot in January 2016 by a Pakistan-based terror group, maintaining that talks and terror cannot go together. The latest letter

controversy suggests that the chances of any meaningful talks between the two countries in the near future are far away.

No communication on H-1B visa cap...

Some US firms are opposed to this as it would require them to make an additional investment. Irked by such requirements, the US is considering restrictions on H-1B visa that allow foreign professionals to work in that country, according to a media report.

At a media briefing on the upcoming visit of US Secretary of State Michael Pompeo from June 25 to 27, Ministry of External Affairs spokesperson Raveesh Kumar said no communication has been received on the issue from the US. "We have not heard anything officially from the US government. We continue to reiterate and engage with the US government on this matter," he said.

The Reserve Bank of India (RBI) in April last year asked payment firms to ensure their data are stored exclusively on local servers, setting a tight six-month deadline for compliance. That deadline was said to have been missed by some foreign firms, including credit card giants Visa and Mastercard. Sources in the commerce ministry said no communication on the visa cap has been received from the US.

IT industry body Nasscom cautioned that any move by the US to limit visas for tech workers will weaken American companies that depend on these work permits to fill skills gaps and put jobs at risk. Nasscom also highlighted that Indian nationals accounting for a large chunk of approved H-1B visas is a "testimony" to their skill-set, and pointed out that a "vast majority" of these visas were being sponsored by global and US multinational companies.

The statement came after a report said US was mulling 10-15 per cent cap on H-1B visa for nations that compel foreign companies to store data locally. Such a move gains significance amid a row between the US and India over trade and tariffs. Nasscom, which represents Indian IT majors like TCS, Infosys, and Wipro as well as smaller tech firms, noted that there is no official confirmation yet on the development from the US government on the matter and that it is awaiting clarity from official channels.

"If US policy makes it more difficult to hire advanced tech workers, it will only weaken the US companies that depend on them to help fill their skills gaps, put jobs at risk, creating pressure to send technology services abroad," Nasscom said in a statement. Such a move, if implemented, would have a major impact on the over USD 150 billion Indian IT sector that gets a lion's share of its revenues from the North American market. Indian IT firms use H-1B visas to send staff to client locations in the US.

However, increasing visa scrutiny over the past few years has compelled Indian IT services companies to ramp up local hiring in the US. Nasscom said in April this year, the number of unfilled jobs stood at 7.5 million in the US. Of these, 67 per cent - or 2 in every 3 jobs - required specific technical skills. "It is this very unmet technical requirement that skilled immigrants, including workers on H-1B visas, have helped meet in the US... The US' global leadership in technology has been made possible, in part, by its ability to attract the most talented workers from around the world," the statement said. Acknowledging that Indian nationals accounted for a majority of all approved H-1B visas in FY2017, Nasscom said this is a "testimony" to their skill-set. "Only a small share of these Indian nationals is employed by Indian companies.

Go back in time at the Toda Huts

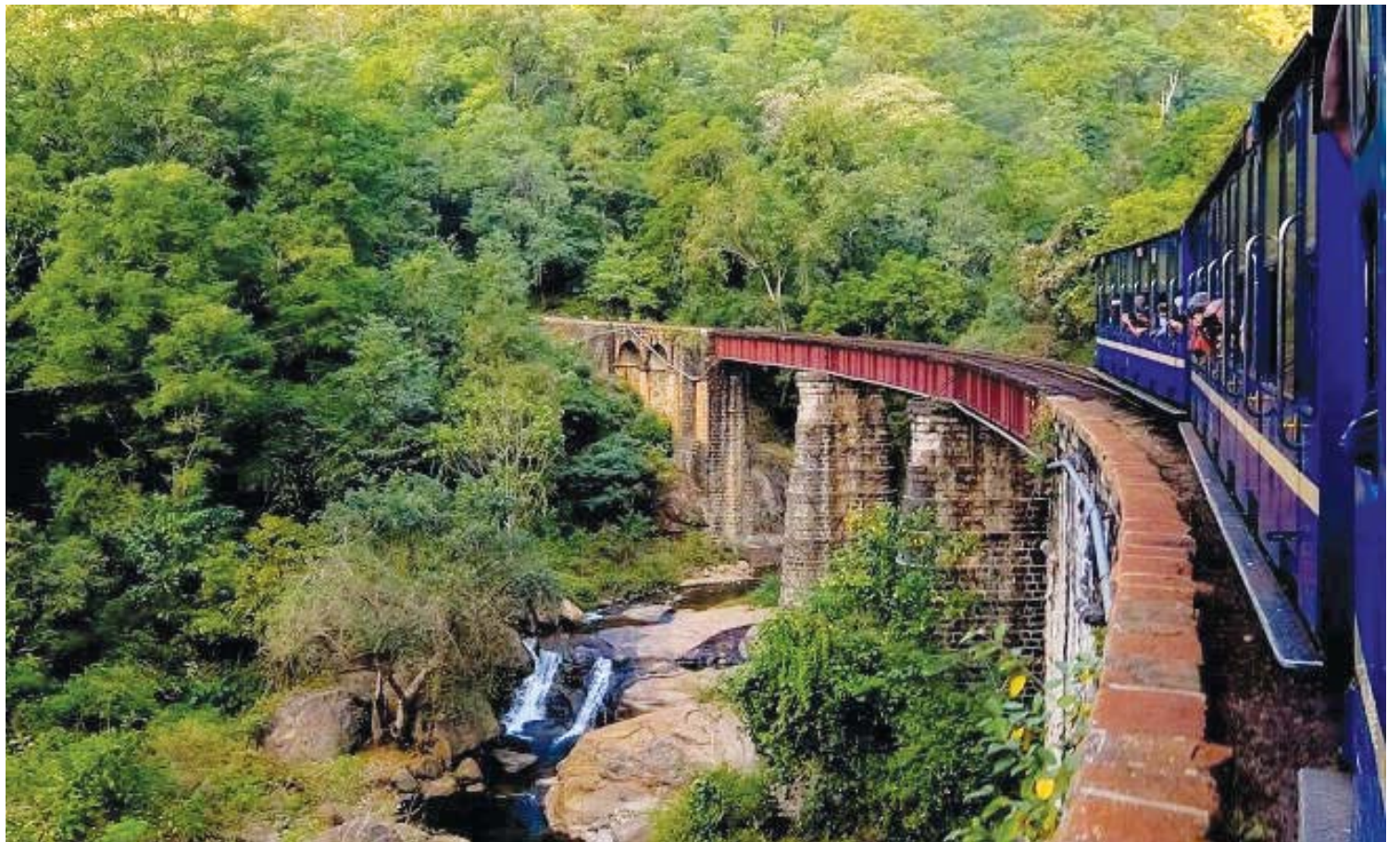

Take a speedboat ride at the Pykara

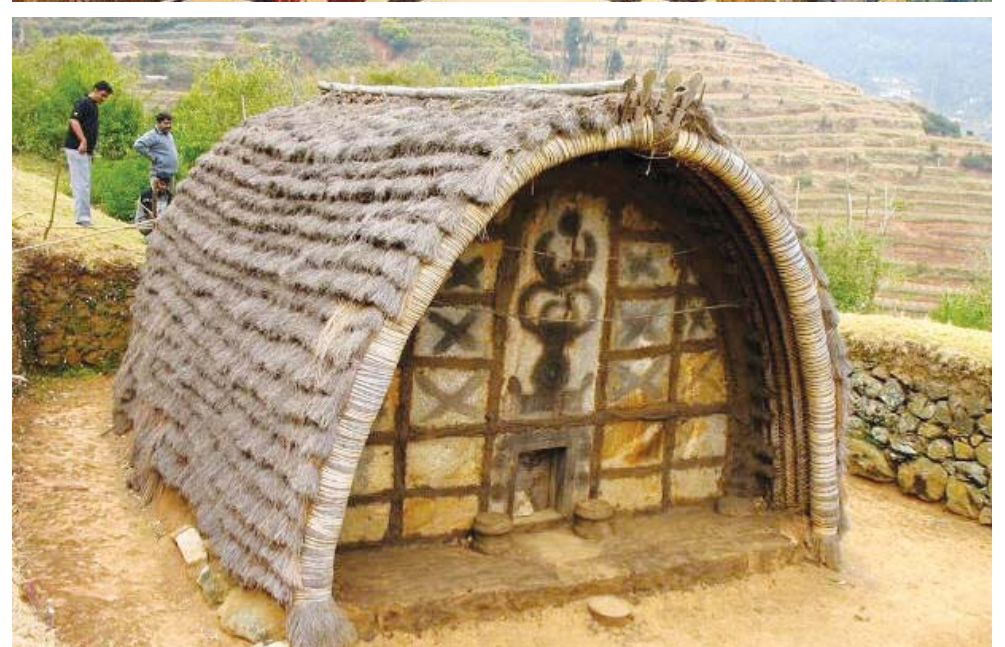
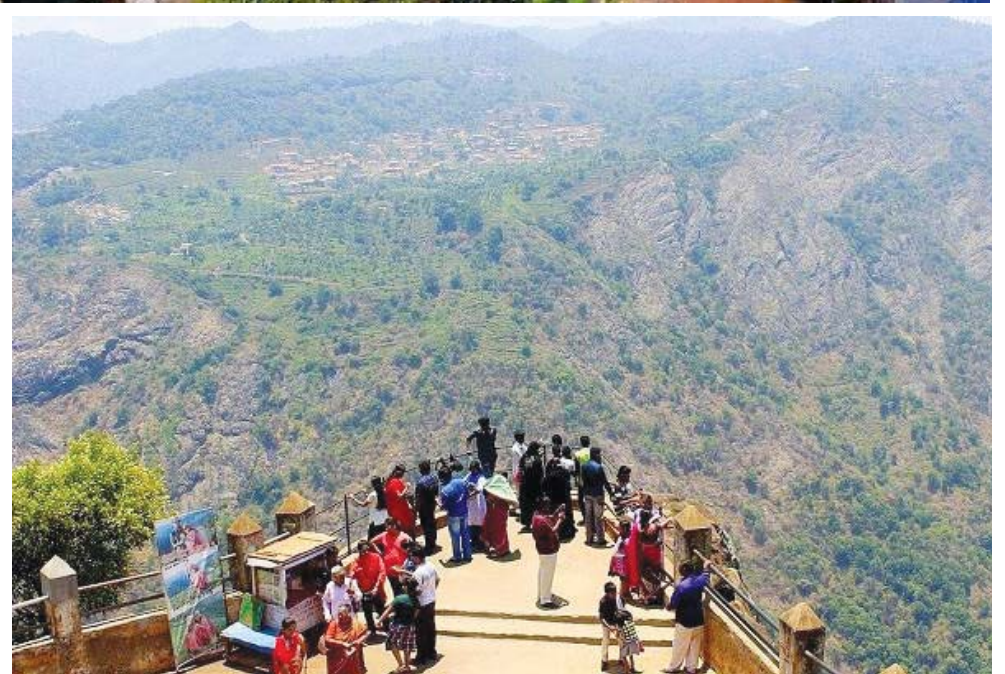

Shikhar Dhawan ruled out of World Cup 2019, Rishabh Pant in as replacement



SOUTHAMPTON (TIP): Team India's World Cup campaign suffered a major jolt on Wednesday as opener Shikhar Dhawan was ruled out of the tournament due to a thumb injury. Rishabh Pant has been brought in as a replacement of Shikhar Dhawan. The opener suffered a hairline fracture during his match-winning 117-run knock against Australia at The Oval on June 9.

"Shikhar Dhawan has a fracture at the base of the first metacarpal of his left hand. He will remain in cast until mid-July which rules him out of ICC World Cup. We have requested Rishabh Pant as the replacement," said Team India Manager Sunil Subramaniam.

In the absence of Shikhar Dhawan, KL Rahul had opened India's innings with Rohit Sharma



against Pakistan. Rahul was impressive in that match scoring 57 and sharing a record 136-run stand for the 1st wicket.

India has had a great start to their World Cup campaign. They have won against South Africa, Australia, and Pakistan while the game against New Zealand was washed out. India faces Afghanistan next on June 22 before they take on West Indies, hosts England, Bangladesh, and Sri Lanka.

With six centuries, Shikhar Dhawan is one of India's most prized assets in ICC tournament. He has scored three tons each in Champions Trophy and in World Cup. Along with Rohit Sharma and Virat Kohli, Dhawan forms a formidable top-3.

What perhaps prompted the team management to finally make an

announce Dhawan's injury was the fact that even Bhuvneshwar Kumar sustained an injury during the Pakistan match.

India would have had only 13 players to choose from against Afghanistan if Pant was not brought in as a replacement. Bhuvneshwar is out of three matches with a hamstring niggle.

"Bhuvneshwar is being assessed by team physio Patrick Farhart," team's trainer Shankar Basu said.

The International Cricket Council (ICC) has confirmed that the Event Technical Committee of the Men's Cricket World Cup 2019 has approved Rishabh Pant as a replacement player for Shikhar Dhawan in India's squad for the remainder of the tournament, a statement from the global body said.



WARNER TAKES AUSTRALIA CLOSER TO SEMIFINALS

NOTTINGHAM (TIP): Australia moved closer to World Cup semifinals after David Warner inspired the defending champions to a comfortable 48-run win over a combative Bangladesh with his second century of the tournament.

The left-handed opener contained his natural aggressive self before swinging his arms freely to build a 166-run knock, which steered Australia to a mammoth 381 for five, their second highest score in World Cup. Warner, who had hit a hundred against Pakistan as well, added 121 runs with his skipper Aaron Finch (53) in a risk-free opening partnership and then raised a 192-run stand with Usman Khawaja (89).

He completed his 16th ODI hundred, his sixth 150-plus knock, which came off 147 balls with 14 hits to fence and five over the ropes.

The stage was set to go after the bowlers and Glenn Maxwell produced a 10-ball 32, which had three sixes and two fours. Maxwell was run out after a mix-up with Khawaja, who sent his partner back sensing risk and was caught behind minutes later to miss out on a hundred. Faced with a daunting task to chase down the massive target, the 'Tigers', as expected, took the fight to the rival camp but ended up with 333 for eighth in stipulated overs. Mushfiqur Rahim (102 not out), Mahmudullah (69), Tamim Iqbal (62) and in-form Shakib Al Hasan (41) gave their all in the chase but the effort still proved insufficient though the total was their best ever in ODIs.

England vs Afghanistan - List of records broken during the game

England secured a 150-run win against Afghanistan at the Old Trafford to climb to the top of the points table. Skipper Eoin Morgan's sensational hitting in the second half led England to a record total of 397/6. Morgan walked in at 164/2 in the 30th over and struck a record 17 sixes and four fours on his way to 148 in only 71 deliveries. With a mountain to climb, Afghanistan stuck to playing full 50 overs and were successful in it. They finished with 247/8 but became the first side to be virtually out of the tournament.

The six-hitting cameo

The 17 sixes Eoin Morgan has hit in this game are the most by any player in an ODI inning. As many as three players hit exactly 16 sixes prior to Morgan. Rohit Sharma was the first to achieve this feat during his first of the three ODI double centuries that came against Australia in the 2013 Bangalore ODI.

AB de Villiers in the 2015 Johannesburg ODI against the Windies and Chris Gayle during the 2015 World Cup against Zimbabwe also hit 16 sixes in an innings. The seven sixes that Morgan hit off Rashid Khan in this game are also the most by any player against a particular bowler in an ODI.



A game of sixes

The 25 sixes England hit during their innings are the most by any team in an ODI inning. England broke their own record which they set by hitting 24 sixes during the Grenada ODI over the Windies this year. The previous most number of sixes hit by a team in a CWC game was 19 by Windies in 2015 against

Zimbabwe.

A total of 33 sixes were hit during this game by both sides; the most in a World Cup match. The 2015 Quarter-Final between New Zealand and Windies witnessed a total of 31 sixes.

Morgan's quick-fire ton

Eoin Morgan's 57-ball century is now the fastest century for England in the

World Cup. The previous fastest was recorded by Jos Buttler in 75 balls against Pakistan earlier in this tournament. Overall, Morgan's hundred is the 4th fastest century in World Cup history.

Rashid Khan records the worst CWC spell ever

Rashid Khan conceded 110 runs in the nine overs he bowled; the most by any player in a World Cup game. Martin Snedden conceded 105 runs in the 12 overs he bowled against England in the 1983 World Cup. Australia's Mick Lewis (113) in the 2006 Johannesburg ODI and Wahab Riaz (110 runs) in the 2016 Nottingham ODI also against England are the only players to have conceded as many runs as Rashid in a Men's ODI game.

The record total

England record their highest total in the World Cup in this game as they surpassed the total of 386/6 which they recorded against Bangladesh in this tournament only.

Overall, the total of 397/6 is the 6th highest total for any team in the World Cup.
