report. The motion failed 49 to 51, with Senators Susan Collins and Mitt Romney joining all 47 Democrats.

Leaders from both parties settled on a schedule for the remainder of the trial, with a plan to bring it to a close on Wednesday. Earlier in the day, the House managers and Mr. Trump's lawyers made their final pleas, debating for several hours whether to consider hearing from witnesses.

The Senate will return at 11 a.m. Eastern on Monday for a few hours of closing arguments, and senators will have a chance to give floor speeches on Tuesday. The final vote, on whether to remove Mr. Trump from office, will take place at 4 p.m. on Wednesday.

However, Trump's acquittal is a foregone conclusion, given the arithmetic of votes in the Senate. It is thumbs up for Republicans and Trump.

Amongst them, three Indian-Americans, namely, Romesh T. Wadhwani, Prof S.P. Kothari and Dr. Prasanta Kumar Pattanaik were listed for the Padma Shri award while one Indian-American, Dr Jagdish N. 
## Thousands Fill Streets of America during India's Republic Day Celebration to Protest CAA and NRC

# India's 71st Republic Day Celebrated across USA with Full Fervor and Enthusiasm

This was followed by singing of patriotic songs by the students of Gandharva School of Music, Richmond.

Republic Day was celebrated on January 26 at the Permanent Mission of India in New York where the Permanent Representative of India to the United Nations Ambassador Syed Akbaruddin unfurled the Indian national flag. Excerpts from President's address to the nation on the eve of the Republic Day were read out by Ambassador Akbaruddin who in his address praised the work of the PMI staff and spoke of the challenging task ahead for them. The gathering, mostly the staff of the PMI, and some guests, were accorded a reception.

The Consulate General of India, New York celebrated the 71st Republic Day of India on Sunday, January 26, 2020 in the Consulate premises with full fervor and enthusiasm. Despite cold weather, a large number of members of Indian diaspora and friends of India numbering 250 attended the event. As is customary, a Flag Hoisting Ceremony was held in the morning in the Consulate Ball Room. Consul General Sandeep Chakravorty unfurled the national flag and the national anthem was sung. Consul General conveyed his greetings to the gathering and read out the address of the President of India.

In his speech, President Ram Nath Kovind hailed the Indian diaspora for enhancing India's image before the world community. "Another source of pride for our country has been our diaspora. During my visits abroad, I have observed that Indians have not only brought prosperity to their adopted lands, they have also enhanced India's image before the world community. Many of them have made great contributions in a wide variety of endeavors", he said.

Prior to joining the United Nations, she was The Asia Foundation's Deputy Country Representative for Maldives and Sri Lanka and has held positions as the Poverty and Policy Advisor for the United Kingdom's Department for International Development (DFID) in India and Vietnam.

She holds a master's degree in Development Management from the University of Wales, UK and is the author of numerous policy papers on South and South-East Asia.

## Indian American John Kapoor Sentenced to 66 Months in Prison

**BOSTON (TIP):** The founder of Insys Therapeutics, John Kapoor, was sentenced Jan 23 in federal court in Boston for orchestrating a scheme to bribe practitioners to prescribe Subsys, a fentanyl-based pain medication, often when medically unnecessary.

John Kapoor, 76, of Phoenix, Ariz., was sentenced by U.S. District Court Judge Allison D. Burroughs to 66 months in prison, three years of supervised release, and ordered to pay forfeiture and restitution to be determined at a later date. The government recommended a sentence of 15 years in prison. In May 2019, Kapoor was convicted by a federal jury of racketeering conspiracy along with four other Insys executives. "Out of pure greed, Insys executives, from John Kapoor on down, bribed doctors to prescribe this powerful and highly addictive narcotic to people who did not need it." *(Read full story on www.theindianpanorama.news)*


# Three Indian Americans Awarded 2020 Churchill Scholarships

**NEW YORK (TIP):** Three Indian American students are among 15 students who have won the Churchill Scholarship 2020. They are MIT Senior Mehtaab Sawhney, a senior from Commack, New York, Duke University senior Azim Dharani, and Vinay Ayyappan - a Johns Hopkins senior majoring in biomedical engineering.

Awarded by the Winston Churchill Foundation of the United States, the scholarship supports science, mathematics, and engineering students from the United States as they complete a master's degree program at Cambridge. The scholarship is valued at about \$60,000 and includes living and travel stipends as well as tuition for the program, which ranges in length from nine months to one year. Students are selected based on their academic achievements, extracurricular interests, and dedication to research.

Mehtaab Sawhney will graduate this February with a BS in mathematics and a minor in computer science. At Cambridge, he will undertake Part III of the Mathematics Tripos master's degree before returning to the U.S. to enroll in a mathematics PhD program. He aspires to become a professor of mathematics specializing in combinatorics.

Sawhney completed his first year of undergraduate studies at the University of Pennsylvania and then transferred to MIT. At MIT, he has contributed to more than a dozen published or submitted academic papers, a rare feat for an undergraduate student. Sawhney continued to work on math problems in the Math Olympiad, International Science and Engineering Fair, and then eventually the Putnam Mathematical Competition (where he was an honorable mention in both 2016 and 2018). He volunteers his time with the U.S. Mathematical Olympiad and the U.S.

Team Selection Test as a grader and reviewer.

Dharani, a senior Angier B. Duke scholar from Lewisville, Texas, is completing a major in chemistry and minors in computational biology and classical archaeology. He is the 22nd Duke undergraduate to receive this honor. At Duke, most of Dharani's research focused on developing metal-binding, prostate cancer-targeting drugs with Professor Katherine Franz. Outside of Duke, he has pursued computational chemistry research at the Sloan-Kettering Cancer Center and the D.E. Shaw Research Institute. Dharani is a Goldwater Scholar and a member of Phi Beta Kappa and has received the American Association for Cancer Research Undergraduate Fellowship. He is a teaching assistant for introductory chemistry and serves as the co-president for the Undergraduate Research Society, for which he develops programs to help underclassmen get involved with research.

Vinay Ayyappan a Johns Hopkins senior majoring in biomedical engineering is a research assistant for

three professors in the School of Medicine: Kristine Glunde, radiology and cancer imaging professor; Anthony Leung, oncology professor; and Ishan Barman, associate professor of oncology, radiology, and radiological science. Ayyappan, who received a Goldwater Scholarship in 2019 and is a two-time recipient of the Astronaut Scholarship. Working in the lab of Cambridge radiologist Ferdia Gallagher, Ayyappan will perform human trials of hyperpolarized magnetic resonance imaging-a cancer imaging technique developed by Gallagher that is 10,000 times as sensitive as traditional imaging methods. Ayyappan's interest in researching cancer progression dates back to high school, when a close friend and teacher were both diagnosed with the disease. In addition to his work in the classroom, Ayyappan serves as the president of the Johns Hopkins chapter of Engineering World Health and volunteers at the Johns Hopkins Children's Center, where he spearheaded a project to help patients keep up with schoolwork through the help of Johns Hopkins undergraduates.

## Indian American Charged with Murder of Three Teen Boys

**RIVERSIDE (TIP):** On Jan. 23, 2020, the Riverside County District Attorney's Office charged a Corona area man of Indian origin with three counts of murder and three counts of attempted murder in the weekend crash that killed three 16-year-old boys and injured three other teens.

According to findings, Anurag Chandra, had intentionally driven his vehicle into the car after he got irritated with the teens playing 'ding-dong ditched' on his door. He is facing three murder charges and three attempted murder charges, said Riverside County District Attorney's Office said. Along with the attempted murder and murder charges, the DA's Office has filed a special circumstance allegation of multiple murders.

## Indian American Shivani Patel Sentenced in Connection with Embezzling Over \$3 Million

**BOSTON (TIP):** The former executive assistant of a Waltham-based technology company was sentenced Jan 28 in connection with a fraud and embezzlement scheme that netted over \$3 million. Shivani Patel, 38, of Vineyard Haven, was sentenced by U.S. District Court Judge Leo T. Sorokin to four years in prison, five years of supervised release, and ordered to pay restitution of \$3,819,366 and forfeiture of \$3,076,369. In October 2019, Patel pleaded guilty to one count each of bank fraud, money laundering and filing false tax returns. As an executive assistant to the chief financial officer, Patel's duties included retrieving incoming mail containing customer checks made payable to her employer, recording the checks into the payment system and depositing the checks into her employer's bank account.

## Indian American Neurologist Sentenced to 24 Months in Prison

**NEW ORLEANS, (TIP):** U.S. Attorney Peter G. Strasser announced that Anil Prasad, M.D., age 63, a resident of Covington, Louisiana was sentenced on January 28, 2020 by U.S. District Judge Jane Triche Milazzo to 24 months' imprisonment followed by (3) three years of supervised release, with the condition that the first 12 months of supervised release be served on home confinement in connection with his guilty plea to conspiracy to unlawfully distribute controlled substances and conspiracy to commit health care fraud. In addition, Prasad, agreed to pay \$1,657,461.15 in restitution to the Medicare and Medicaid programs.



# Eminent Ophthalmologist VK Raju Underscores Importance of Prevention of Childhood Blindness, at the Centennial Celebrations of Rotary Club of Calcutta

KOLKATA / NEW YORK (TIP): "Childhood blindness is one of the tragedies in the world. 70% of childhood blindness can be prevented or treated with today's available technology and resources", West Virginia based eminent ophthalmologist Dr. VK Raju said at the Centennial celebrations of Rotary Club of Calcutta, the oldest Rotary Club in West Bengal, January 2020.

Dr. Raju was invited as keynote speaker to speak on avoidable childhood blindness. "80% of our learning is through vision. Screening the children for vision problems is essential", he said.

"3.5 million premature babies are born each year in India. More and more of these babies are surviving because of neonatal care. They must be screened for Retinopathy of Prematurity to prevent blindness. This is one of the most cost-effective health interventions," said Dr. Raju.

The Eye Foundation of America which Dr. Raju founded and is heading now has gifted a retinal camera to screen these babies. The Rotary Club of

Calcutta and Priyamvada-Aravind Eye Hospital in Kolkata will collaborate to do this service even if the parents cannot afford.

The Rotary Club of Calcutta honored Dr. VK Raju for his passionate commitment to prevention of avoidable childhood blindness and for his enormous work across the world.

## About Dr. VK Raju

Dr. VK Raju received his medical degree from Andhra University, India and Residency and Fellowship in UK. He is a fellow of the Royal College of Surgeons and a Fellow of the American college of Surgeons.

V.K. Raju, MD, FRCS, FACS is a clinical professor of ophthalmology at West Virginia University, WV, USA and practicing ophthalmologist at Regional Eye in Morgantown, WV, USA. In 1977, work began on what is now known as the Eye Foundation of America. With Dr. Raju's guidance, the Eye Foundation of America's work has grown. To date, the Eye Foundation of America has

performed over 3 million vision screenings in rural areas of over 30 countries. Through the Eye Foundation of America, over 350,000 sight-saving surgeries have been performed at no cost. Over 700 medical professionals, including many residents and ophthalmologists, have been trained to identify and treat eye diseases.


Dr. Raju remains highly involved as the Founder and President of the Eye Foundation of America to this day, returning to India every few months to participate in educational programs, vision screening camps, and surgeries.

His insatiable drive to improve the lives of others has also resulted in the recent culmination of another lifelong goal. The construction of another eye hospital is underway with wings devoted to specialties including ocular oncology, pediatric ophthalmology, and the retinopathy of prematurity, a disease affecting premature babies.

Dr. VK Raju has received awards from American Academy of Ophthalmology four times for his teaching, research and

international service. A partial list of awards include Doctor Nathan Davis International award of Excellence in Medicine by American Medical Association Foundation, Lifetime Achievement Award from WV State Medical Association, the President's Lifetime Achievement Award from President Barack Obama, Mahatma Gandhi Pravasi Samman award for Achievement in Medicine, House of Lords, London. He also received the Martin Luther King, Jr. Achievement Award from West Virginia University. Raju has published over 100 scientific articles, 17 book chapters, and 2 books. Still, he will tell you, "My work is only beginning."

When terrorism became too difficult to predict, the focus turned to radicalisation, a term introduced after 9/11 to describe "what goes on before the bomb goes off". Since 2002, eight of the nine regions in the world experienced an increase in terrorism. The November 2008 terrorist attacks in Mumbai perpetrated by the Lashkar-e-Taiba, wherein 166 people were killed, revealed how deadly violence can be unleashed by a few individuals.

It has been seen that rigid, dogmatic convictions, along with condemnation beliefs, lead to a path of destroying the other. Last year, when the fidayeen suicide attack on a convoy of the CRPF in Pulwama took place, it revealed how a youth with a history of minor grievances can be indoctrinated. Prisons have been found to be fertile grounds for radicalisation. Imprisonment may increase a prisoner's susceptibility to new and radicalizing ideas or beliefs; referred to as a cognitive opening.

The threat from radicalisation remains underestimated and understudied in India. There is also no official Indian policy on radicalisation and de-radicalisation. Statements about opening up of de-radicalisation camps, as a solution to the radicalisation problems have been made recently. The focus is yet to turn to understanding about the philosophy of radicalisation, its precursors, process nodes and the potential of de-radicalisation.

Radicalisation is a process with multiple reinforcing pathways of developing extremist beliefs, emotions, and behaviors. People become increasingly motivated to use violent means against members of an out-group or symbolic targets to achieve behavioral change and political goals. Radicalisation develops gradually over time and may occur at individual, group or mass public levels. It also involves changes in attitudes, beliefs, behavior, ideals, goals, ideology, and willingness, which become extreme. Those extreme aspects are related to political, social, religious, ideological, economic or societal issues.

Research in this critical area continues to shed new light. Different models have been suggested, and it is clear that feelings of discrimination can evoke radical thoughts and actions. The New York Police Department Study of 2007 has explained various stages of the process of radicalisation-pre-radicalisation, self-identification, indoctrination and jihadization stages. The first stage occurs when

individuals are placed in environments that lead to being receptive to extremism. The drivers can be either intrinsic or extrinsic. Commitment is constantly calibrated and re-calibrated.

Be it the left wing extremism, right wing, North-East insurgency, Kashmir militancy or the separatist Khalistan movement, the perceptions of injustice play an important role in pushing someone to extremism and the radicalisation process. Many individuals who join radical groups do so because they have the feeling that they have not received the treatment they deserve. In order to better deal with feelings of relative deprivation and injustice, experts suggest empowering individuals by helping to increase their perceptions of efficacy and self-esteem, and fostering the creation of a strong self-identity.

De-radicalisation is a process in which people reject the ideology they once embraced. This is a step further than disengagement, characterized by a change in behavior (leaving the radical group, stopping violence) without giving up. Individual disengagement and de-radicalisation programs cannot be looked at in isolation. It has been argued by Daniel Koehler, Director of the German Institute on Radicalisation and De-radicalisation Studies, that when an individual has a "cognitive opening" and an environment that supports personal reflection, then de-radicalisation can be initiated. Detained former Tamil Tigers underwent a de-radicalisation programme in Sri Lanka that addressed the educational, vocational, spiritual, recreational, psychosocial, and socio-cultural/familial aspects of an individual's life when transitioning back into society. The most developed programs at the prison level have been in Saudi Arabia and Singapore. Yemen is the best example how not to do it since the government showed little interest in after-care. Former extremists often ended up being the victims of police harassment. The focus should be on reform and rehabilitation of individuals.

Looking for one's own identity forms a part of every normal development process from child to adulthood. Studies have pointed out that many individuals enter extremist groups during adolescence. Not only is there more thrill-seeking, but also increased efforts to maximize short-term pleasures. Peer pressure and unfamiliar situations can make adolescents less capable of logical reasoning than adults. Internet remains an active vector for violent radicalisation.

At the primary level, what are the chances of parents identifying the personality changes? Angry, alienated youth can be easily ideologically driven. Radicalisation leads in adopting a (new) identity or self-image. Personal growth is also an important push factor.

While interviewing one such radicalized person in

a prison, I found that there was existential angst that had pushed the person towards radicalisation. In prison, opportunity for reflection and finding new meaning in life, by being redirected towards more positive goals, such as a meaningful job or education, can take place. The longing to reestablish good relationships with family members, and to start own family can work to pull away from radicalisation.

The European Union approach focuses on supporting families in preventing radicalisation and in de-radicalisation. Many parents and teachers are uncertain of how to deal with signs of radicalisation. Educating and equipping them becomes essential to recognize vulnerable individuals who are at risk or are in the early stages of radicalisation. Focus should be to train and educate professionals, and to stimulate disengagement and de-radicalisation.

At the primary level, the government needs to reinvest in educational institutions. The aim should be to decrease prejudice, stereotyping and discrimination and to increase knowledge about democracy. Collective sports and citizen programs based on exchanges have been found helpful.

Prof Theo Gavrielides recently led a three-year study in the UK. More than 3,000 young people and professionals in schools, youth prisons, universities, migrant centers, and online were interviewed. The research found that when young people were encouraged to develop a talent or pastime, the radicalisation process was successfully challenged.

There are links between extremism, social exclusion and radicalisation. Sociological interventions to prevent or counter extremist behaviors are needed. The success of Kerala and Maharashtra programs of de-radicalizing indicates how community-based programs may work in vulnerable states. Let us not forget that disaffected youth with no real job prospects and limited futures are vulnerable. The war on terror is to be countered more in the human mind, and requires different skills and tactics.

The state Thruway Authority proposed the first toll increases for the newly opened Gov. Mario M. Cuomo Bridge, with the cost growing from \$4.75 to \$5.75 by 2022 for E-Z Pass users. The news has been well received, without anybody feeling unhappy over the increase. The Thruway Authority has given ample notice to users of the Bridge.

While nobody will mind this increase, the present structure of "violations fee" being imposed by Bridges and Tunnels

Authority of NY/NJ is a worrisome issue. At present, a violation fee of \$100.00 is imposed for a delay in a payment, regardless of the amount of toll. It is ridiculous to be imposing \$100.00 "violation fee" on a toll bill of \$1.25.

Many did not get to know what the "violation fee" is. Public is largely unaware of the fee. In the first place, the Thruway Authority should have first publicized any penalty it proposed

to impose for late payment of tolls. Secondly, the penalties should have been reasonable, not the way these are that a toll of \$1.25 invites a "violation fee" of \$100.00.

On behalf of the people who have been hit hard by the unreasonable and unjust "violation fee", we urge Governor Cuomo to order discontinuation of the imposition of the present "Violation fee". Also, Governor is requested to waive the "Violation fee" imposed on all toll

# Had Gandhi lived longer, he would've made it count

**Gandhi would have concerned himself with the trauma that followed Partition. His healing touch would have been crucial in settling the millions of refugees and addressing the key question of Hindu-Muslim amity, the proper resolution of which at that time would have perhaps avoided the latter-day conflicts in the country.**

In a letter to his friend Acharya Satish Chandra Mukherjee, Gandhi wrote, "May you attain the full span of 125 years, which I may not attain for lack of equanimity prescribed for it in the Gita... I am trying hard to reach that state."

That was not to be. An assassin's bullets cut short his holy life, a few months after India attained independence. He was in good health and fully active. It can be reasonably assumed that he would have lived a decade or even more. If that were so, it would be an interesting mind game to guess what he would have engaged himself with and how that would have impacted the course of our national regeneration.

Gandhi (1869-1948) in all likelihood would have been awarded the Nobel Peace Prize in 1948, as Rajinder Singh in his book on the subject has discussed. Though that would have made hardly any difference to Gandhi; he would have perhaps used the money for constructive activities dear to his heart. 'The Disobedient Indian', as noted political philosopher Ramin Jahanbegloo writes in a book of this name, discussing the Gandhian philosophy of resistance, would have encouraged those "struggling for democratic swaraj to increase peace and nonviolence in the public realm."

Being a pragmatist par excellence, he would have allowed the government to be run by Nehru, Patel, Azad, Ambedkar and others - with his role being largely confined to dotting the i's and crossing the t's. Gandhi knew their mind and of the way the Constitution was shaping up. As long as the government ran as per its letter and spirit, Gandhi wouldn't have perhaps interfered much. It can be surmised that, being a man of


action, he would have devoted himself to the following main, but broadly interconnected, issues.

He would have concerned himself with the trauma that followed Partition which even he could not avert. Gandhi's healing touch would have been crucial in settling the millions of refugees and simultaneously addressing the question of Hindu-Muslim amity, the proper resolution of which at that point of time would have perhaps avoided the latter-day conflicts within the country and without. Being incapable of hatred, Gandhi alone had the moral authority and stature to negotiate this vexed problem at a time when the passions were raw.

He would have perhaps worked steadfastly to reforming Hinduism from within, as Swami Vivekananda and others had sought to do earlier. Pre-Independence, he waged a relentless battle against the evil of untouchability. Regarding it as a greatest blot on Hinduism which "has sinned in giving sanction to untouchability," he had once said, "If it is proved to me that this is an essential part of Hinduism, I for one would declare myself an open rebel against Hinduism itself." While untouchability has been abolished by law, it may still take time for it to be erased entirely from the psyche of many an individual. I would love to guess, based on Gandhi's belief that pure Hinduism brooks no inequality, that he would have started working against oppressive casteism, widely prevalent even today, the brunt of which is borne by a very large segment of our population. He once said, "I do not believe in caste in the modern sense. It is an excrescence and a handicap on progress." Gandhi alone could have made a decisive impress in this direction.

Local self-government associated with decentralized planning would have been the cornerstone of our development model. In our anxiety for centralized planning - which was indeed necessary at that phase of our development - the ideas of panchayati raj were largely neglected. Even decades after constitutional amendments, progress in this front has been painfully slow. Issues of poor health and sanitation, low levels of literacy, high infant mortality, degradation of environment, and subordination of women, especially in villages, could have been much better addressed through local self-governance. This has largely been an area of darkness which Gandhi would have illuminated.

He would have fought relentlessly for universal primary education and basic health for all, demanding much higher budgetary allocations for these sectors. To impute that in the first few Plan periods these sectors did

not receive any attention would be simplistic, but relative neglect there was, mainly because there was no constituency developed in our electoral democracy to demand such universal services. Had Gandhi lived, he would have created a national consensus on this score. The establishment of IITs, large public sector undertakings for core sectors, multi-purpose projects on major rivers and national-level scientific laboratories was crucial, as Nehru envisioned. Gandhi would have ensured at least equal priority accorded to meeting basic health and education needs for all citizens. A drastic reduction of poverty, the attainment of a much higher level of human development indicators and containment of unsustainable migration from rural to urban areas would have been a reality if the bottom-up approach of planning had been practiced from the early fifties.

As Gandhi's "harmonious vision was directed towards a true revolution of values", as Jahanbegloo reminds us, he would have committed to gender justice and protection of the environment. "If non-violence is the law of our being, the future is with the women." He would have also been critical of the powerful state seeking to undermine dissent, as he believed, "Discontent is a very useful thing. As long as a man is contented with his present lot, so long is it difficult to persuade him to come out of it. Therefore, it is that every reform must be preceded by discontent." We may well remember it, as long as we know such discontent is for sustained public good and not accompanied with violence.

## A Happy Impression

**A**s we look around us, we find folks amidst us who are simply amazing and unique.

In 2019, I had the fortune to meet a few but let me share my experience with one person Pravin Chandra, who works at our office as a cleaner.

We are in the Stone business and import different kinds of natural stones such as granite, marble and various types of artificially made engineered stones.

The stones are susceptible to breakages and hence a large amount of packing materials is used to bind and hold them together in containers.

They are in the form of wooden logs nailed to hold the stones firmly and plastic sheets to prevent scratches. The constant movement of trucks and forklifts provided additional challenges in our ability to maintain the level of hygiene we desired.

I still recollect the first day when Pravin walked into our office on a colleague's recommendation and he could barely speak Hindi let alone English.

At 60+ his age not exactly working to his advantage, his trait and demeanor none of which suggested that he would be able to do even a reasonable job of maintaining such a large space. More so considering the mess at the warehouse, and the amount of debris we collect in the form of wood, sawdust and plastic every single day.

It was perhaps, sheer desperation to find someone on that particular day as we had to fire the last person at that job and the mess was piling up, that we went ahead and Pravin became part of our Company.

I still recollect the first day as I took him around and curiously watched his

reaction as we approached the subject of cleaning the washrooms, the office and maintaining the 80000 sft warehouse. I hardly expected him to accomplish all the above but if he could manage some portions of his duties, it would be commendable.

He seemed unperturbed and his expression hardly changed. This of course, reinforced my confidence that he would probably last for a week or so.

That week, I hardly got a chance to interact with Pravin as he would report to the warehouse supervisor but would occasionally catch a glimpse of him pushing the small cart to accumulate and transport the debris into dumpsters. It was the middle of winter and he would be dressed in a flimsy T-shirt chewing on his tobacco. Upon asking, he came with "the work keeps me warm".

Lo and behold, this man transformed our warehouse within a fortnight.

Since the inception of the Company, we had never arrived at this level of hygiene. I couldn't believe my eyes one day, when I walked into the warehouse as every nook and corner was devoid of dust. He would barely acknowledge any

compliment except with a nod and as a man of very few words, he largely communicated in mono syllables. Pravin needed no compliments or motivation. He motivated others and believed in challenging his limits.

Once I had called him to my office, complimented him for the excellent work and attempted to tip him with a \$50 bill. He simply shrugged and proudly refused. His reaction "Kyu?", meaning "why?" and I was not sure how to handle that. His heart full of pride, his expression hardly changed as he turned around and walked away.

I tucked the \$50 bill back into my wallet. Pravin Chandra still works at our office. Most days, as I park outside the office, I catch a glimpse of Pravin pushing the handcart ahead of him chewing on his tobacco. I make a feeble attempt to catch his eye but he hardly ever acknowledges me, all focus on the task ahead of him. I mutter a silent good morning.

Pravin Chandra was busy and that department of our Company was in able hands.

## FLASH FLOODS KILL NINE IN INDONESIA

**MEDAN (TIP):** Flash floods and landslides have killed at least nine people and forced thousands into temporary shelters on Indonesia's Sumatra island, the local disaster agency said January 30.

Torrential rain in North Sumatra this week sparked the disaster, with most victims drowning or hit by logs swept away in the current, the agency added.

The event was part of the Visit Nepal Year 2020 campaign of the Nepal Tourism Board. Models from various parts of the world participated in the show. PTI

## Die in factory fire

**LAHORE (TIP):** At least 11 people, including two women and minors, were killed in a fire caused by an explosion of a gas cylinder at a perfume factory in Shahdara area of Lahore on January 28.

Two others were critically injured in the incident. The fire that engulfed the whole building caused its roof to collapse and damaged the structure located adjacent to it. PTI

## Shah Rukh's Pak cousin dies

**Peshawar (TIP):** Noor Jehan, a cousin of Bollywood superstar Shah Rukh Khan, passed away in Peshawar, a media report on January 28 quoted a family member as saying.

Jehan's younger brother, Mansoor Ahmed, confirmed the news of her death to Geo News, saying she had been fighting cancer for some time.

Jehan, a paternal cousin of the leading Indian film actor, resided in Mohallah Shah Wali Qatala area close to Peshawar's Qissa Khwani Bazaar. Mian Zulfiqar, a former town council member and Jehan's neighbour, also confirmed her death, the report said without giving her age. — PTI

# Pakistan govt dismisses reports of four-fold pay hike for Imran Khan

**KARACHI (TIP):** The cash-strapped Pakistan government has dismissed as "baseless" reports of Prime Minister Imran Khan getting a near-four-fold hike in salary, according to media reports.

The clarification was issued after news reports claimed the prime minister's gross salary would be increased from Rs 2,01,574 to around Rs 8,00,000.

"At a time when the prime minister was carrying out a campaign to slash the government's expenditures, the propagation of such a baseless and concocted news report was unfortunate," the Prime Minister's Office spokesperson was quoted as saying by Dawn News.

Khan recently said he could not manage his household expenses from his official salary, the report said.

"We have reduced the expenses of the Prime Minister House by 40 per cent. I live in my own home, pay my own expenses. My (official) salary is not enough to cover the expenses of my own household," Khan said.

He has also claimed that his foreign visits have cost the exchequer 10 times less than his predecessors.

Khan said his visit to Switzerland earlier in the month for the World Economic Forum was the "cheapest" by a Pakistani state leader.



Khan said his trip was sponsored by two businessmen.

According to The News, Khan earned Rs 1,96,979 after deductions, as per his February 2019 pay slip.

The Pakistan government has been implementing austerity measures to improve the country's finances. In July last year, Pakistan registered a currency reserve of less than USD 8 billion—enough to cover only 1.7 months of imports.

In August 2018, Pakistan approached the International Monetary Fund for a bailout package after the Khan government took over.

The IMF formally approved the USD 6 billion loan to Pakistan in July 2019, citing "significant" economic challenges.

Pakistan has so far received billions in financial aid packages from friendly countries like China, Saudi Arabia and the UAE during the current fiscal year.

## 5 mountaineers to attempt winter Everest climb

**KATHMANDU (TIP):** Three Spanish mountaineers and two Germans are embarking on a daring mission to climb Mount Everest, the world's highest peak, in winter—a feat that has not been done since 1993.

Alex Txikon, Oscar Cardo, Jonatan García headed to Everest Base Camp on Sunday, ready to start their climb next week, the director of Outware Treks & Expeditions, Pemba Sherpa, told Efe news. "The team of Sherpa, also known as Icefall doctor, has opened the route up to Camp I (6,000 m) that passes through the Khumbu Icefall," he said.

The trio has already climbed Mt Ama Dablam (6,812 m) as part of acclimatisation training.

The Khumbu Icefall, located between Everest Base Camp and Camp I, is the most treacherous section of the route, where giant slabs of ice loom and sometimes break off.

"As the Spanish have completed their acclimatisation on Mt Ama Dablam, they will not begin their climb as soon as they reach the Everest Base Camp," said Sherpa. "They will not use supplemental oxygen." It will be the trio's third attempt at the challenge after failed attempts in 2016 and 2017.

In 2017, the climbers reached Camp IV (8,000 m), but had to return due to the weather.

"Their luck this year, obviously, will

depend on the weather. Until today (Sunday), whether in the Everest region is good," said Sherpa. He said that in winter the days are shorter and the nights longer and cold, making climbing harder. Everest witnesses some of the strongest winds at this time of the year, with temperatures regularly reaching -36 degrees Celsius. It can drop as low as -60 C. Winter climbing permits last until the end of February.

Besides the Spanish trio, German climbers Jost Kobusch and Hug Daniel are also tackling the slopes of Everest, Rabin Neupane, the director of Satori Adventures, told Efe.

The pair has moved down to Base Camp at 5,380 m after reaching Camp II (6,400 m) as part of their acclimatisation, Neupane said.

The Germans are not using climbing aids, such as ropes and ladders, and are also without supplemental oxygen.

"They have not announced the date to climb, but are waiting the right time that's good weather window," said Neupane. The last winter ascent, according to Nepal's Tourism Department records, was completed by Japan's Shinsuke Ezuka on December 20, 1993. Krzysztof Wielicki of Poland first climbed Everest in the dead of winter on February 17, 1980. The peak sees the highest number of climbers during the spring. — IANS

## Two Rohingya women killed as Myanmar army shells village

**YANGON (TIP):** Two women, one pregnant, were killed and seven other people injured after Myanmar troops shelled a Rohingya village on February 1, according to a lawmaker and a villager, two days after the UN's highest court ordered the country to protect the minority.

Maung Kyaw Zan, a national member of Parliament for Buthidaung township in northern Rakhine state, said shells fired from a nearby battalion hit Kin Taung village in the middle of the night. Government troops have been battling ethnic rebels in the state for more than a year.

"There was no fighting, they just shot artillery to a village without a battle," he told Reuters by phone, adding it was the second time this year that civilians had been killed.

The military denied responsibility, blaming the rebels who they said attacked a bridge in the early hours of the morning.

More than 730,000 Rohingya Muslims were forced to flee northern Rakhine state in 2017 after a military crackdown that the U.N. has said was executed with genocidal intent.

More recently, the region was plunged into further chaos by fresh fighting between the military and the Arakan Army, a rebel group that recruits from the mostly Buddhist majority in the state. Reuters

San Francisco, Houston, Indianapolis, Minnesota, Detroit, Wichita, Bay Area, and Seattle. Citizenship Amendment Act (CAA) would be providing a path to Indian citizenship for Hindu, Sikh, Buddhist, Jain, Parsi, and Christian religious minorities from the neighboring

Muslim majority countries of Pakistan, Bangladesh and Afghanistan. Protesters called it violative of the secular Indian constitution as it excludes Muslims. CAA coupled with a plan to implement a nationwide counting of citizenship (National Register of Citizens or NRC) by Modi government has triggered

widespread protests in the USA as well.

In New York people from all age groups, backgrounds, castes, and religions gathered in front of Indian Consulate on Jan 26 during the Republic Day celebration. The New York protest was part of nationwide protests and marches organized by the recently formed Coalition to Stop Genocide - a broad coalition of Indian Americans and US-based civil rights organizations such as

the Indian American Muslim Council, Hindus for Human Rights, Equity Labs, Shri Guru Ravidass Sabha of New York, Black Lives Matter and the Jewish Voice for Peace.

Washington, Houston, San Francisco and Chicago witnessed the similar protests. Over several hundred people assembled outside the Indian Consulates and chanted slogans against CAA. The largest gathering of anti-CAA protestors was reported from Chicago where Indian Americans gathered in large numbers and formed several mile-long human chains. In Washington DC, more than 500 Indian Americans marched from a park near the White House to the Gandhi Statue in front of the Indian Embassy.

Across the protest locations, protesters waved hundreds of Indian national flags and sang patriotic Indian songs, including India's national anthem and saare jahan se achchha, the iconic song penned by poet Iqbal. In several places, protesters publicly read out the Preamble to the Indian constitution and raised banners against Prime Minister Modi, Home Minister Amit Shah, the ruling Bharatiya Janata Party (BJP) and its ideological parent, the Rashtriya Swayamsevak Sangh (RSS).

## NEW FORM 1040-SR, ALTERNATIVE FILING OPTION AVAILABLE FOR SENIORS

### TAX TALK

**WASHINGTON(TIP):** The Internal Revenue Service wants seniors to know about the availability of a new tax form, Form 1040-SR, featuring larger print and a standard deduction chart with a goal of making it easier for older Americans to read and use.

The Bipartisan Budget Act of 2018 required the IRS to create a tax form for seniors. Taxpayers age 65 or older now have the option to use Form 1040-SR, U.S. Tax Return for Seniors. Form 1040-SR, when printed, features larger font and better readability.

Taxpayers who electronically file Form 1040-SR may notice the change when they print their return. More than 90% of taxpayers now use tax software to prepare and file their tax return.

Taxpayers born before Jan. 2, 1955, have the option to file Form 1040-SR whether they are working, not working or retired. The form allows income reporting from other sources common to seniors such as investment income, Social Security and distributions from qualified retirement plans, annuities or similar

deferred-payment arrangements.

Seniors can use Form 1040-SR to file their 2019 federal income tax return, which is due April 15, 2020. All lines and checkboxes on Form 1040-SR mirror the Form 1040, and both forms use all the same attached schedules and forms. The revised 2019 Instructions cover both Forms

1040 and 1040-SR.

Eligible taxpayers can use Form 1040-SR whether they plan to itemize or take the standard deduction. Taxpayers who itemize deductions can file Form 1040-SR and attach Schedule A, Itemized Deductions, when filing a paper return. For those taking the standard deduction, Form 1040-SR includes a chart listing the standard deduction amounts, making it easier to calculate. It also ensures seniors are aware of the increased standard deduction for taxpayers age 65 and older.

Married people filing a joint return can use the Form 1040-SR regardless of whether one or both spouses are age 65 or older or retired.

Both the 1040 and the 1040-SR use the same "building block" approach introduced last year that can be supplemented with additional Schedules 1, 2 and 3 as needed. Many taxpayers with basic tax situations can file Form 1040 or 1040-SR with no additional schedules.

## SOCIAL SECURITY LAUNCHES NEW CAMPAIGN TO FIGHT SCAMMERS

**WASHINGTON (TIP):** The Social Security Administration launched a new Public Service Announcement (PSA) campaign to continue warning people about the ongoing nationwide telephone impersonation scheme. The PSAs feature a message from Social Security Commissioner Andrew Saul. Social Security and its Office of the Inspector General (OIG) continue to receive reports about fraudulent phone calls from people falsely claiming to be Social Security employees. The scammers mislead victims into making cash or gift card payments for help with purported identity theft, or to avoid arrest for bogus Social Security number problems.

"I want every American to know that if a suspicious caller states there is a problem with their Social Security number or account, they should hang up and never give the caller money or personal information. People should then go online to [oig.ssa.gov](http://oig.ssa.gov) to report the scam call to Social Security," said Commissioner Saul.

People should also be on the lookout for a new version of this scam. Fraudsters are now emailing fake documents in attempts to get people to comply with their demands. Victims have received emails with

attached letters and reports that appear to be from Social Security or the OIG. The letters may use official letterhead and government jargon to convince victims they are legitimate; they may also contain misspellings and grammar mistakes.

Social Security employees do occasionally contact people--generally those who have ongoing business with the agency--by telephone for business purposes. However, Social Security employees will never threaten a person, or promise a Social Security benefit approval, or increase, in exchange for information or money. In those cases, the call is fraudulent and people should just hang up.


Generally, the agency mainly calls people who have recently applied for a Social Security benefit, someone who is already receiving payments and requires an update to their record, or a person who has requested a phone call from the agency. If a person is not in one of these situations, they normally would not receive a call from the agency.

### Social Security will not:

- Tell you that your Social Security number has been suspended.
- Contact you to demand an immediate payment.
- Ask you for credit or debit card numbers over the phone.
- Require a specific means of debt repayment, like a prepaid debit card, a retail gift card, or cash.
- Demand that you pay a Social Security debt without the ability to appeal the amount you owe.
- Promise a Social Security benefit approval, or increase, in exchange for information or money.

If there is a problem with a person's Social Security number or record, in most cases Social Security will mail a letter. If a person needs to submit payments to Social Security, the agency will send a letter with instructions and payment options. People should never provide information or payment over the phone or Internet unless they are certain of who is receiving it.

## AIR INDIA PLANE WITH 324 INDIANS EVACUATED FROM WUHAN LANDS IN DELHI

**NEW DELHI (TIP):** Air India's jumbo B747 plane, evacuating 324 Indian nationals from the novel coronavirus-hit Wuhan in China, landed here on Saturday morning, officials said.

The plane reached Delhi around 7.30 am, they said.

There were five doctors from Ram Manohar Lohia (RML) Hospital and one paramedical staff on board, said an Air India spokesperson.

The evacuees from Wuhan comprised three minors, 211 students and 110 working professionals, the spokesperson said.

The Army has set up a quarantine facility in Manesar near Delhi to keep those evacuated from China's Hubei province.

Officials said they would be monitored for any signs of infection for two weeks by a qualified team of doctors and staff members.

"With 324 passengers, special flight has taken off for India from Wuhan. It may reach Delhi at 7.30 am," said the Air India spokesperson at 1.19 am on Saturday.

The flight had departed from Delhi airport at 1.17 pm on Friday to evacuate Indian nationals from China, where more than 250 people - none of them Indian - have died due to novel coronavirus.

On Friday evening, the Air India spokesperson had stated that another special flight might take off from Delhi airport on Saturday to evacuate Indians from Wuhan.

The death toll from the novel coronavirus outbreak in China has risen to 259 with total confirmed cases surging to 11,791 amid stepped-up efforts by a number of countries to evacuate their nationals from Hubei province, the epicentre of the virus, officials said on Saturday.

## Jamia shooting: Delhi court sends gunman to 14-day protective custody

**NEW DELHI (TIP):** The 17-year-old youth who fired at students of the Jamia Millia Islamia university during an anti-Citizenship Amendment Act (CAA) protest on Thursday, was sent to 14-day protective custody by a Delhi court on Friday.

The youth was earlier produced before the Juvenile Justice Board, PTI reported.

Delhi Police sources told NDTV the shooter showed "no remorse for his actions", that he had been influenced by social media, TV coverage and WhatsApp videos, and he wanted to create panic at Shaheen Bagh. "He did not know how to get to Shaheen Bagh. An auto driver dropped him off at Jamia and told him he could not go to Shaheen Bagh as the road is shut. He told him to walk it," a police officer told NDTV.

On Thursday, protesters and police personnel faced off near the university after the youth fired a pistol at a group of anti-CAA protesters, injuring a student before walking away while waving the firearm over his head shouting "yeh lo aazadi".



# India to grow 6-6.5% next year: Economic Survey

**NEW DELHI (TIP):** India's economic growth is expected to "strongly rebound" to 6.6 per cent in 2020-21 from 5 per cent estimated in the current fiscal, the Economic Survey said on Friday, adding that the government with a strong mandate has the capacity to expedite reforms.

The Economic Survey 2019-20 tabled in Parliament said there are tentative signs of bottoming out of slowdown in manufacturing activity and global trade, which will have a positive impact on growth in the next fiscal.

The government's thrust on affordable housing, Make in India, reduction in corporate tax rate, and improvement in ease of doing business, besides others factors, will help in boosting economic growth, it said.

However, it has also cautioned that continued global trade problems, escalation in US-Iran geopolitical tensions, and weak economic recovery in advanced economies are the downside risk which have the potential to drag down the growth.

"On a net assessment, it appears that the upside risks should prevail, particularly when the government, with a strong mandate, has the capacity to deliver expeditiously on reforms.

"GDP growth of India should strongly rebound in 2020-21 and more so on a low statistical base of 5 per cent growth in 2019-20," said the survey tabled by Finance Minister Nirmala Sitharaman.

On a net assessment of both the downside/upside risks, it said "India's GDP growth is expected to grow in the range of 6 to 6.5 per cent in 2020-21."

On 2019-20 GDP, it said the estimate of 5 per cent growth suggests an uptick in expansion in the second half of 2019-20.

The survey also stresses that deceleration in GDP growth can be understood within the framework of a slowing cycle of growth. The financial sector has acted as a drag on the real sector.

The survey said that the uptick in second half of 2019-20 would be mainly due to 10 positive factors like picking up of Nifty India Consumption Index for the first time this year, an upbeat secondary market, higher FDI flows, build-up of demand pressure, positive outlook for rural consumption,

rebound of industrial activity, steady improvement in manufacturing, growth in merchandise exports, higher build-up of foreign exchange reserves and positive growth rate of GST revenue collection.

The document also emphasised that merger of public sector banks may increase the financial strength of the merged entities, lower the risk aversion and result in lowering of lending rates.

Further, as the implementation of GST further settles down, the increased unification of the domestic market may reduce business costs and facilitate fresh investment.

Reforms in land and labour market may further reduce business costs, said the survey, presented a day before Sitharaman's Union Budget 2020-21.

## 4 DELHI GANG RAPE CONVICTS GET A REPRIEVE, JUDGE CANCELS DEATH WARRANT

**NEW DELHI (TIP):** Just 12 hours before the four men who raped a 23-year-old in 2012 were to be led to the gallows at Tihar, a Delhi court on Friday stayed the black warrant for their execution. This was the second time that their execution was put off by the judge. This time, the judge did not issue a fresh warrant for their execution.

Several hours earlier, Judge Dharmender Rana had heard the lawyer of the convicts seek cancellation of the death warrants since the four were yet to exhaust their legal options. One mercy petition is still pending before the President.

A little after 5 pm, the judge emerged from his chambers to deliver his one-line verdict. "Execution Order Stayed Till Further Orders," he said.

In the written order that was made available later, the judge ruled that seeking redressal of one's grievances through procedures established by law is the hallmark of any civilized society.

"The courts of this country cannot afford to adversely discriminate any convict, including death row convict, in pursuit of his legal remedies, by turning a Nelson's eye towards him" the judge underscored.

The convict's lawyer had cited the prison manual which says that in a case where more than one person has been handed over the death penalty, the execution cannot take place unless all the convicts have exhausted their legal options.

## PREZ CALLS CAA HISTORIC, DRAWS OPPN PROTESTS

**NEW DELHI (TIP):** Hailing the new citizenship law as "historic" and a fulfilment of Mahatma Gandhi's wish, President Ram Nath Kovind today deprecated violence in the name of protests, saying it weakened the society and nation, remarks that came amid protests against the contentious law.

The President's glowing reference to the Citizenship (Amendment) Act in his address to a joint sitting of Parliament drew protests from Opposition members, many of whom wore black bands, with some shouting "shame shame", while BJP MPs thumped benches in support. The President said the government enacted the CAA in tune with the wishes of Mahatma Gandhi who had said that Hindus and Sikhs who did not wish to live in Pakistan could come to India.

Delivering his 70-minute address in Hindi which marks the start of the Parliament's Budget session, Kovind pointed out that mutual discussions and debates strengthen democracy. "Any kind of violence in the name of protests weakens the society and the nation," he said. Condemning the religious persecution of minorities in Pakistan, he urged upon the global community to take a note of it.

He said doing away with Articles 370 and 35(A) had paved the way for speedy development of Jammu and Kashmir and Ladakh. Elections were held for about 4,400 panchayats and 300 Block Development Councils, while 24,000 houses were constructed under the Pradhan Mantri Awas Yojana in Jammu and Kashmir, he said.

# COV TOLL HITS 213, WHO DECLARES EMERGENCY

**BEIJING (TIP):** The death toll in China's coronavirus epidemic spiked to 213 and total infections reached 9,692, the government said on Friday as the World Health Organisation (WHO) declared the outbreak that has spread to more than a dozen countries, including India, as a global health emergency. The death toll rose to 213, mostly of elderly people, after 43 new deaths all but one in Hubei, the epicentre of the outbreak, China's national health authorities said, adding that 1,982 new cases had been confirmed, bringing the total to 9,692.

About 20 countries, including India, the UK, US, South Korea, Japan and France, have reported confirmed cases of the virus in travellers coming from China. The WHO, which held an emergency meeting in Geneva on Thursday, declared the outbreak a global health emergency, a rarely used designation that could lead to improved international co-ordination in tackling the disease. "Our greatest concern is the potential for the virus to spread to countries with weaker health systems," WHO chief Tedros Adhanom Ghebreyesus said as he announced the virus as a Public Health Emergency of International Concern. — PTI



## Nations should not overreact: China

# Britain cuts loose from EU

## PM Johnson hails dawn of new era for country

**BRUSSELS (TIP):** The EU's three chiefs hailed Britain's departure from the bloc on Friday as "a new dawn for Europe", warning London would not keep the benefits of membership when it leaves.

Charles Michel, Ursula von der Leyen and David Sassoli — the presidents of the EU Council, European Commission and European Parliament, respectively — used an open letter published in European newspapers to say they would do "everything in their power" to make the new relationship with Britain a success.

The three EU leaders made clear they would not roll over easily or allow Britain to "have its cake and eat it", insisting Britain could not have full access to the EU market unless it agrees to follow European labour, taxation and environmental rules. "How close that partnership will be depends on decisions that are still to be taken," they wrote.

"This is the moment when the dawn breaks and the curtain goes up on a new act. It is a moment of real national renewal and change," Downing Street said in a read-out of Prime Minister Boris Johnson's address to the nation. — Agencies

## In Egypt, 12-year-old girl dies after genital mutilation

**CAIRO (TIP):** A 12-year-old girl died this week in southern Egypt after her parents brought her to a doctor who performed female genital mutilation, a criminal practice that remains widespread in the region, according to a judicial statement.

The girl's death in the province of Assiut prompted Egypt's public prosecutor to order the arrests of her parents and the physician who performed the procedure, also known as female circumcision, said the statement released late January 29 by the prosecutor's office.

## Russian strikes kill 10 civilians in Syria's Idlib

**ARIHA (SYRIA) (TIP):** Russian air strikes near a bakery and a medical clinic in Syria's rebel-held Idlib region killed 10 civilians on Thursday as government forces kept up a ground offensive.

The government and its allies have upped their deadly bombardment of the last major rebel bastion, slowly chipping away at it from the south.

Rebel-held territory has shrunk to just over half of Idlib province, along with slivers of neighbouring Aleppo and Latakia, following a series of government gains. — AFP

## German nurse accused of poisoning babies with morphine

**FRANKFURT AM MAIN (TIP):** A nurse in Germany has been arrested on suspicion of poisoning five premature babies with morphine, police said on January 30, adding that the infants had survived.


The woman was taken into custody on Wednesday after investigators found a syringe containing breast milk and traces of morphine in her locker at Ulm university hospital in southern Germany.

The babies, who were between one day and one month old and staying in the same hospital room, all suddenly developed breathing problems "at almost the same time" in the early hours of December 20, Ulm police chief Bernhard Weber said.

"Only because of the immediate action taken by the staff could the five lives be saved," he told a press conference.

Doctors do not expect the infants to suffer any lasting harm.

The young nurse taken into custody has yet to be formally charged but faces five counts of attempted manslaughter, Ulm prosecutor Christof Lehr said at the same press conference. She denies poisoning the babies, he added. Hospital staff initially suspected the infants had caught an infection, "but this could be ruled out after urine tests", police chief Weber said. AFP


Cyrus and Hemsworth got married in December 2018 with *The Hunger Games* star filing for divorce just months later in August.

"That's how I started, and that's one of my biggest passions in the world," she said at the time. "I love to use my voice."



## SAD TO SUPPORT BJP IN DELHI ASSEMBLY POLLS

**NEW DELHI (TIP):** The BJP and its oldest ally, Shiromani Akali Dal (SAD), seemed to have made up on Wednesday. BJP president J.P. Nadda went over to SAD chief Sukhbir Singh Badal's residence here for what was a patch-up meeting after the two parties fell out over the seat-sharing for the Delhi Assembly election.

Addressing a press conference with Badal, Nadda said: "One of the oldest constituents of the BJP-led NDA, the SAD has always been at the forefront of serving society. A strong coalition between the BJP and the SAD will remain intact." He also thanked the SAD for deciding to support the BJP in Delhi, though its sitting MLA Manjinder Sirsa had been denied ticket. The SAD had supported the Citizenship (Amendment) Act in Parliament, but has consistently been stating — both in the House and outside — that the Muslims should be added to the list of communities under the Act.

When talks broke down between the BJP and the SAD over seat-sharing, Sirsa alleged that this was one of the reasons for the pact being broken.

### Backing for CAA

At the press conference, Badal, however, clarified: "We never broke our alliance with the BJP. We were just considering the possibility of contesting separately. We have supported the CAA from the beginning and have consistently raised the issue of persecuted Sikhs in Pakistan and Afghanistan with the NDA government."

The SAD had been given three seats in Delhi in the last three elections, but was kept out of the alliance this time, with the Janata Dal (United) getting two seats and the Lok Janshakti Party one.

## 'Kejriwal Ka Guarantee Card' promises pollution-free city

**A**am Aadmi Party (AAP) national convener Arvind Kejriwal launched the "Kejriwal Ka Guarantee Card", a 10-point shorter election manifesto of the party.

The card promises to make Delhi "pollution-free" and has fixed an aim to reduce air pollution by three times. It also promises to introduce "mohalla marshals" for women's safety.

The card also promises 11,000 buses and to increase Metro train lines to over 500 km.

"This is my guarantee to people of Delhi for the next five years. The manifesto will be launched later and it will have more things specific for students, teachers among others. This will be for everyone," he said. "Opposition is saying many of our schemes will be only till March 31, so this is our guarantee that these schemes will continue for the next five years," he added. "24 hour electricity will continue. 200 units of free electricity will continue," he said.

The Model Code of Conduct has come into effect in Delhi after Chief Election Commissioner Sunil Arora's announcement on Monday. He also said that 90,000 policemen will be deployed for the smooth conducting of Delhi election. There are 13,750 polling stations in Delhi.

There are 58 general category seats, 12 for SC and none for STs in Delhi assembly. According to the chief electoral officer (CEO) Delhi Ranbir Singh, there are a total of 1,46,92,136 (1.46 crore) voters in Delhi comprising 80.55 lakh males and 66.35 lakh females.

## BJP OFFERS CHEAP FLOUR, 2-WHEELERS

**T**he Bharatiya Janata Party (BJP) promised bicycles and electric scooters to disadvantaged girls who stay in school and make it to college, wheat flour (instead of grain) at Rs2 per kg to families from the economically weaker section (EWS), a new Yamuna riverfront, and insurance and health check-ups for cows, in its poll manifesto released on Friday.

The BJP also promised a comprehensive strategy to combat air, noise and water pollution in "mission mode". From installing air purifiers at traffic junctions to setting up charging stations for electric vehicles, the party listed measures which it said it will take to tackle air pollution, which has emerged as an annual health crisis in the winter months.

The Sankalp Patra (vision document) was silent on the subsidies in electricity and water bills currently given by the ruling Aam Aadmi Party (AAP), which is seeking to stay in power in the national capital.

Releasing the party's manifesto for the February 8 Delhi elections, Union road transport and highways minister Nitin Gadkari said that air and water pollution were two main concerns in the city.

The party's 48-page vision document promised Rs10,000 crore investment in infrastructure, 10,000 new buses, the creation of nine boards and commissions for the effective implementation of projects and welfare schemes for infrastructure development in unauthorised colonies and urbanised villages, and welfare schemes for traders and women.

## Is Congress in sleep mode?

**A**s star campaigners of AAP and BJP are making headlines and churning controversies in an all out attempt to woo voters, the third major participant in the poll race is missing in action. The rival leaders are firing salvos clocking overtime but the question that many are asking is, where is the Congress party?

Its manifesto is still at the printers, the campaign in cold storage and the party in sleep mode.

Better late than early?

Knowing that it is facing two highly charged up opponents, what is the Congress waiting for?

Well, the man in the thick of things, PC Chacko does not agree that the Congress has been slow. He, instead, feels that the BJP is overdoing it.

"The candidate offices are in order and committees are in place, we will roll out our star campaigners from 1st February to 6th of February. That is when the election campaign will be at its peak. We are on time. In fact, the BJP is desperate and overdoing it while [Delhi Chief Minister Arvind] Kejriwal is a marketing guru. He is just marketing lies," Chacko told India Today TV. He is the Delhi in-charge of the Congress. Wonder where the star campaigners are!

Congress president Sonia Gandhi is likely to address two rallies. Former Congress president Rahul Gandhi and Congress general secretary Priyanka Gandhi Vadra would be participating in roadshows covering almost seven to ten constituencies a day.

This is the second time when Priyanka Gandhi will campaign in Delhi. She had campaigned for late Sheila Dikshit during 2019 Lok Sabha election calling herself 'Dilli ki ladki' (the girl from Delhi).

# Will Modi magic beat Kejriwal's governance?

**NEW DELHI (TIP):** Who will win the Delhi Assembly election 2020? Will Arvind Kejriwal-led Aam Aadmi Party (AAP) retain power on its claim of work on electricity, health, schools, and water, etc.? Or the Bharatiya Janata Party (BJP) will turn the table in the name of 'Modi, Mandir and persecuted Hindu minorities in Afghanistan, Bangladesh and Pakistan'?

This we will get to know on February 11. The Election Commission of India (ECI) has announced the schedule for the 11th Delhi Assembly Election. 1.46 crore voters of Delhi will cast their votes on February 8 to decide who will govern the national capital. Will the AAP retain power? Can the BJP end its dry-run in Delhi after 21 years? What is the role of the Congress party in this Assembly election?

## DECISIVE NATURE OF DELHI VOTERS

This needs a careful reading of the Delhi voters' mood, as elections in Delhi at different levels produce different outcomes. Since the inception of the AAP in Delhi election 2013, the electoral fight became triangular. However, the choices of Delhi voters mostly very decisive when it comes to choose their government except 2013 polls- be it Assembly, Lok Sabha or MCD.

What is significant is that since the emergence of the AAP in Delhi, the Congress party has become a distant third party in the state which ran Delhi continuously 15 years between 1998 and 2013.

Second, that the AAP gained against the Congress mostly as the BJP's vote share has been continuously stagnant between 32 and 36 per cent in last three Assembly elections. The minimum for the BJP in Delhi Assembly was 32 per cent votes in 2015.

The third takeaway is that small parties and independents have been getting less attraction of voters in Delhi. In the last few elections, Assembly or Lok Sabha, the aggregate vote share of three major parties - AAP, BJP and Congress - has been more than 95 per cent of votes.

At the same point, who Delhi gives the mandate, they give 'chhappad phad ke'. In the last Assembly election, the AAP won 67 out of 70 seats, the BJP managed to win only 3 seats and the Congress was not able to open its account.

However, in the last Lok Sabha election 2019, the BJP was leading in 65 out of 70 Assembly segments while the Congress was leading in only 5 Assembly segments and the AAP was not leading in even a single Assembly segment.

Even in terms of vote share, it is totally surprising how Delhi's voters behave very decisively and one sided in different elections. The AAP had 54 per cent of votes in Delhi Assembly election in 2015 but the vote share reduced to 18 per cent in the 2019 Lok Sabha election. On the other hand, the BJP's vote share in 2019 Lok Sabha jumped 25 per cent from the 2015 Assembly election.

## KEJRIWAL AND HIS CHALLENGE

The vote swing of Delhi voters makes Delhi election interesting till the last moment. As one of the recent survey on Delhi governance done by the prestigious institution Lokniti-CSDS suggested a very high level of satisfaction with the performance of the Arvind Kejriwal government in the state.



86 per cent of the total respondents said they are either fully satisfied (53 per cent) or somewhat satisfied (33 per cent) with Kejriwal. This satisfaction level not only comes from the Arvind Kejriwal's personal popularity as the chief minister but also comes from the benefits of the different welfare schemes like free water charge, low price of electricity, implementation of Mohalla Clinic and improvement in school infrastructure, etc.

However, the fight for the Delhi Assembly election 2020 is not very easy for the AAP if we look the declining vote share of the party after the 2015 Assembly election.

The vote share of the AAP has been declining since the 2015 Assembly election. Just two years back in the 2017 MCD election, the AAP lost 28 per cent votes after getting a huge mandate in 2015.

And this decline continued in the recent Lok Sabha election 2019, when the AAP's vote share further declined to 18 per cent.

On the other hand, the BJP gained a massive vote share in 2019 Lok Sabha from its past performance in the Delhi Assembly and MCD election which helps them not only to win all seven parliamentary seats but also to get a lead in 65 assembly segments.

In the meantime, the performance of the Congress was not spectacular in these three elections. However, the party's performance directly impacts the performance of the AAP.

In these three elections, the Congress' vote share has been increasing and it mainly comes at the expense of the AAP. Except the BJP in Delhi which got more than 30 per cent of votes in each election since 1990s, the base vote of the AAP and Congress has been fluctuating from election to election. If the BJP holds its cadre vote and the Congress get the substantial share of votes then the outcome of the Delhi Assembly election 2020 would be very interesting.

## THE 2020 BATTLE IN DELHI

To make the Delhi election triangular, the Congress either needs to maintain its vote share of Lok Sabha 2019 (23 per cent) or improve from there. However, it seems unlikely due to two reasons - first, due to lack of a credible face (leader) and weak organisation of Congress in Delhi when it comes to choose the state government and second, due to the decisive nature of Delhi voters as they always go with the leading party. One of the significant points is that after the 2019 Lok Sabha election, the BJP was not able to maintain its performance in the state Assembly elections. In the recent Assembly elections in Haryana and Jharkhand, the BJP lost around 20 per cent of votes from the 2019 Lok Sabha election, within a span of a few months. Also, since Gujarat election 2017, the BJP has not been able to get the majority in a single state. This shows the BJP's weakness to perform in the state Assembly.

In the name of Modi, the party has been able to maintain its base vote around one-third in the state Assembly but when you have to fight against another strong state leader like Kejriwal, the party needs to gain an additional 5 to 10 per cent of votes from its base vote to win the election. Will Modi, the Ram Mandir verdict and implementation of the CAA (as the BJP campaigns on these three issues) get additional votes for the party in this election to defeat the AAP? Only time will tell.

## Husbands cause more stress for wives than kids

## CHAMPAGNE TRIFLE

### Ingredients

Chocolate Cake - 200 gms (readymade)  
Strawberries - 1/2 cup, chopped  
Champagne - 3/4 cup (or Sparkling water for a non-alcoholic version)  
Water - 1/4 cup  
Eggs - 2  
Sugar - 50 gms  
Corn Flour - 1 1/2 tsp  
Vanilla Extract - 1/2 tsp



### Method

Cut the cake into small pieces. Combine the champagne, water, eggs, sugar, corn flour and vanilla extract in a bowl. Whisk well. Heat a pan of water over medium flame. Place the bowl over the water, but ensure the bowl does not touch the water. Whisk well until thick and remove from flame. Allow it to cool. Add some of the cake and strawberries to a champagne glass (or any serving bowl). Top up with the champagne custard and keep it in the fridge if required.

# CORONAVIRUS: MYTHS ABOUT THE VIRUS BUSTED

As the coronavirus outbreak spreads, authorities are rushing to dispel myths about the disease spreading online.

2019-nCoV emerged in southern China in December, but in the last few weeks has spread to other countries and begun killing people.

Having started in a country with little media freedom and a history of covering up the spread of infectious diseases - such as the closely-related SARS virus from 2002/3 - it's not surprising people have rushed to fill the perceived information gap with half-truths and false information.

Here's what's true and what isn't.

## The virus jumped to humans via bat soup

Genetic testing has suggested the virus, like SARS, jumped from humans from bats (perhaps via snakes, according to one study).

A video that did the rounds online last week supposedly showing a woman eating bat soup in outbreak epicentre Wuhan, despite the outbreak, was held up as proof. Critics noted at the time there was nothing to suggest the video was legit, particularly as the woman was wearing summer clothing at a time when Wuhan was experiencing near-zero winter temperatures.

It's since emerged the video was shot four years ago in Palau.

"It was turned over by some accounts sponging of the heat and fanning out malicious panic," travel writer Wang Mengyun - the woman in the clip - wrote in a blog post.

While it's believed the virus made the leap from animals to humans in a food market in Wuhan, it's not yet clear exactly where it happened, or how. It took several years to trace the origin of the SARS virus to a remote cave.

## You can get the virus from eating noodles, fortune cookies and Red Bull

A social media post claiming the virus can be caught by eating food from China, or popular with Chinese communities, prompted Australian health authorities to issue a rebuttal.

The badly-spelled post claimed the disease was "starting to spread in the greater Sydney region" and products such as rice, Mi Goreng noodles, ice tea, Red Bull, onion rings and wagyu beef were infected with "corona's virus".

The post cited the fake 'The Bureau of Diseaseology Parramatta', claiming air tests showed the virus was circulating at train stations.

A spokesperson for NSW Health - which definitely exists - said nothing in the post was true.

"NSW Health has been made aware of a social media post that is being widely circulated warning people to not consume certain foods or visit certain locations in Sydney," a spokesperson told AFP.

"This post has not originated from



NSW health or any entity relating to us. Further, there is no such entity as the 'Department of Diseaseology Parramatta'. NSW Health would like to assure the community that the locations mentioned in this post pose no risk to visitors, and there have been no 'positive readings' at train stations."

None of items mentioned in the post have been recalled by the NSW Food Authority either.

## The virus was created in a lab and patented in 2015

Some conspiracy theorists have put a Stephen King spin on the virus' origin story. They claim, much like in the horror author's epic novel The Stand, 2019-nCoV was engineered in a lab. One, who also claims you can cure virus by drinking a bleach solution (more on that below), suggested a UK research institute funded by the Bill and Melinda Gates Foundation is behind it. Their motive? Money of course, as nations rush to buy the inevitable vaccine, which they claim will only spread the disease further.

The UK-based facility singled out, Pirbright, decried the "misinformation" in a post on its site. It said not only does it have nothing to do with studying human coronavirus strains, the patent cited by the conspiracy theorists was in relation to a vaccine it is working on to "prevent respiratory diseases in birds and other animals", and was not funded by the Gates Foundation.

Fact-checking site Snopes says the confusion - assuming it's not deliberate misinformation - appears to stem from the word 'coronavirus', which has become synonymous with the current outbreak despite being a family with many members - SARS was one, for example.

"Social media users sharing what they believe to be patents for the new virus, a member of the coronavirus family, are in fact sharing separate patents for avian infectious bronchitis virus and SARS," Snopes said.

Fake news sites like InfoWars

have also claimed the Gates eerily predicted 65 million deaths by coronavirus just three months ago. The truth is a simulation run by the Johns Hopkins Center for Health Security and the Gates Foundation in October suggested it was possible an outbreak could kill that many people, "but we explicitly stated that it was not a prediction", John Hopkins said.

"Instead, the exercise served to highlight preparedness and response challenges that would likely arise in a very severe pandemic... Although our tabletop exercise included a mock novel coronavirus, the inputs we used for modeling the potential impact of that fictional virus are not similar to [2019-nCoV]."

## Unorthodox cures

A bleach solution known to fraudsters as 'Miracle Mineral Solution' has been touted as a cure for 2019-nCoV. Jordan Sather - the guy above who claimed the virus was patented in 2015, and also a believer in the bizarre debunked QAnon conspiracy mega-theory - told followers to use it.

"I'm going to have to get home, and MMS the whole state," he said in a video. "MMS the whole sh\*\*\* out of everything."

As did another QAnon account known as @chiefpolice2, who has nearly 18,000 followers on Twitter.

"PROTECT YOURSELF. Get the 20-20-20 spray," he told followers, calling the virus part of an "evil depopulation agenda" that will only escalate when the vaccine is released.

Sather pointed to a 2005 study which showed the SARS virus could be killed by the key ingredient found in MMS, chlorine dioxide - but failed to mention that study only looked at its effects outside the body, not inside it. Coronavirus is also not the same as SARS.

Genesis Church, the scammers behind the 20-20-20 spray, claim it can cure not just coronavirus, but also cancer, arthritis, diabetes and autism.



## LUNGS MAY HAVE NEAR 'MAGICAL' POWER TO REPAIR DAMAGE IF YOU STOP SMOKING, SAY SCIENTISTS

Lungs have the near 'magical' ability to repair damage caused by tobacco as long as you give up smoking, according to scientists.

Lung cell mutations caused by smoking which can lead to cancer were originally thought to be permanent.

But findings published in the journal Nature revealed some cells are able to escape the damage caused by the chemicals in tobacco and can then repair the lungs.

"We were totally unprepared for the finding," Dr Peter Campbell, from the Sanger Institute, told BBC News.

"There is a population of cells that, kind of, magically replenish the lining of the airways", he added, "One of the remarkable things was patients who had quit, even after 40 years of smoking, had regeneration of cells that were totally unscathed by the exposure to tobacco."

## 'Magically replenish'

The regeneration was even seen in smokers who had smoked a pack a day for 40 years before giving up the habit.

Chemicals found in tobacco damage lung cells by mutating the DNA, gradually turning them from healthy to cancerous.

Dr Kate Gowers, one of the researchers who is based at University College London, referred to these as "mini time bombs" which were "waiting for the next hit that causes them to progress to cancer."

However, scientists found in 5 out of 6 ex-smokers, 20 to 50 per cent of the cells had a low level of mutation which was similar to the profile of non-smokers of the same age range.

These almost normal cells had longer versions of DNA structures called telomeres, which can suggest they have not undergone many divisions.

And so researchers have speculated these healthy cells may have come from previously dormant stem cells but it remains unclear.

Around 47,000 people are diagnosed with lung cancer every year in the UK, according to NHS figures.

## NEST THERMOSTATS WILL WARN OF PROBLEMS WITH YOUR AC OR FURNACE

You might not have to wait until your home is frigid to find out that there's a problem with your furnace. Google has started testing a Nest thermostat feature that sends email alerts when the device detects unusual patterns in your HVAC system. If it's taking an oddly long time to warm up your house, you might get a notice well before there's a full-fledged breakdown.

People in a handful of cities (Atlanta, Boston, Denver, Las Vegas and San Diego) will also get help contacting professionals through Handy, so you might not have trouble booking a service appointment.

HVAC warnings aren't completely new. Users have received alerts for more immediate problems. However, Google is now focusing on symptoms that may take a long time for humans to spot. In a sense, it's offering a peek at a future where your smart home does more to anticipate problems and help fix them before it's too late.

# SCIENTISTS CREATE ROBOTS THAT 'SWEAT' LIKE HUMANS TO STOP OVERHEATING

**R**obots have been created by scientists that 'sweat' like humans during demanding tasks to stop them overheating.

Robotic technology is advancing every day and machines are being given more demanding tasks that generate more heat as a by product.

This heat could cause the robot to malfunction if it doesn't cool down, which prompted researchers from Cornell University to look at how humans get cool.


They developed a technique that allows machines to 'sweat' off cooling liquid stored around the component responsible for moving and controlling the system.

It is still an early prototype with a number of problems including the sweating process causing the robot to struggle to move.

The team, which includes a scientist from Facebook's reality lab, are hopeful it will eventually be a more reliable alternative to bulky cooling systems in use today.

Traditional actuators, the component responsible for moving and controlling a mechanism or system, are rigid and include fans and radiators.

This limits robots and mechanisms to bulky, solid objects, which goes against a trend to create more fluid and soft forms of robots.



Traditional cooling components take up valuable space inside electronics and add a lot of weight, according to Thomas J Wallin from Facebook reality lab.

'Additionally these components are conventionally made from rigid materials that are incompatible with fully soft robots.

'So to realise the numerous advantages of soft robots, we wanted to explore a thermo regulatory strategy that was compatible with soft polymeric materials.'

They created finger-like fluidic actuators that are made of hydrogels, a type of material that can hold a large amount of water and act as heat reservoirs.

Each of these fingers feature a

bottom layer with an internal channel for water flow and a top layer dotted with micropores.

At low temperatures below 86 degrees Fahrenheit, the pores remained closed.

When the temperature rises, the top layer expands, dilating the pores and allowing pressurised fluid from the bottom layer to 'sweat' out of the pores.

In testing the sweating actuators cooled off about six times faster than their non-sweating counterparts when exposed to wind from a fan.

However, it will be a while before they start appearing in mainstream technology, as the team haven't been able to find a way to replenish water lost during operation.

## How to use your Fitbit to monitor your blood oxygen levels

**E**arlier this month, Fitbit quietly rolled out blood oxygen monitoring to five of its devices: the Versa, Versa 2, Versa Lite, Ionic, and Charge 3. (Interestingly, this is a feature that Apple said its Apple Watch is capable of doing, but which has yet to be released for that device.)

Why is this important? Because your blood oxygen levels indicate how well oxygen is distributed throughout your body, which is important for making sure your organs are functioning properly.

Monitoring your oxygen levels is helpful during both exercise (to see how your body adjusts during an intense HIIT workout or a long hike, for example) and sleep (when it could help with early detection of underlying health issues). So far, Fitbit has only made blood oxygen monitoring available under the sleep portion of its app, and presents the data at a generalized level, so don't expect to see exact, hour-by-hour levels of oxygen in your bloodstream.


Here's how you can access it.

### Make sure app is up to date

If you own one of the five Fitbit devices that received this feature, make sure your app is updated with the most recent software version. To check:

Open up the Fitbit mobile app and tap on the upper left corner of your avatar.

Select the Fitbit device you want to update. If there is an Update icon on



this main page, that means an update is available. If you don't see one, it is likely that the app is already up to date, or hasn't received it over the air just yet.

To update, make sure that your Fitbit device is paired, is located close to your phone, and has enough battery to run the update. Ideally, you should leave your Fitbit on its charging dock, as updates can take anywhere from a few minutes to an hour depending on the last time you updated the device and on your internet connection speeds.

### Set it and forget it

After the update, you don't need to do much else to enable blood oxygen monitoring. Simply wear your Fitbit to sleep. The data should be available to you under the Sleep section of your Fitbit app when you wake up.

To view it, open the mobile app and look at your daily summary. Sleep should be one of the categories of data tracked while you're wearing the Fitbit. If you scroll down past the hours tracked and sleep stages, you should see a section called Estimated Oxygen Variation. Keep

in mind that the feature is still in its roll-out stages, so if you don't see it yet, keep wearing your Fitbit to sleep and checking back.

If you do not see your sleep tracking information on your app's home screen at all:

Scroll to the bottom of your Today tab and click the black Discover button.

Tap "Health & Fitness Stats" and select "Sleep" to manually open the section.

### Making sense of the data

The Estimated Oxygen Variation is presented as a chart that tells you how much variation occurred in the hours you were asleep. This is how your body is distributing oxygen in your bloodstream. You'll notice Fitbit is choosing to generalize the data presented by indicating whether there is a big or small variation in your blood oxygen level. (There are many reasons for this, one big one being that Fitbit does not want this data to be used for medical diagnoses.)

If you notice consistent, big variations in your sleep, talk to a medical professional to get further testing done. Underlying causes could be anything from depression, high blood pressure, sleep apnea, or just a very tiring week — so before you freak out about seeing those big variations, monitor your levels for a few weeks before talking to your doctor.

# Global markets come down with coronavirus

MUMBAI/HONG KONG (TIP):

A glimmer of hope for recovery in global growth this year after the US and China reached a temporary truce in their trade war seems likely to be derailed as the deadly coronavirus quickly spread to 19 countries and now threatens to escalate further.

Investors around the world rushed to dump equities and flocked to safer havens, fearing that the coronavirus could slow down global growth.

The outbreak that began in the central Chinese city of Wuhan has killed 107 people in China and infected more than 4,500 globally. The World Health Organization called the outbreak an emergency for China, but stopped short of designating it a global emergency.

"The Wuhan coronavirus poses a significant downside risk to the near-term Asia-Pacific economic outlook in 2020 if the epidemic continues to escalate in coming weeks," Rajiv Biswas, Asia-Pacific chief economist at IHS Markit, wrote in a recent report to clients. "The extent and duration of this negative shock to regional economic growth will depend on how quickly the Wuhan virus epidemic can be brought under control."

The MSCI World index, which captures large and mid-cap representation across 23 developed markets, has fallen 1.3% in the past 10 days. The sell-off has been sharper in the MSCI Emerging Markets index, which shed 3.57%, while India's benchmark Sensex lost nearly 2% during the period. On Tuesday, the Sensex fell 0.46% to 40,966.86 points.



According to analysts, investors in India have reacted to the concerns related to coronavirus as well as worries about fiscal slippages.

"Though Indian markets have declined in tandem with global peers, Union budget will steer equities ahead. Any unfavourable announcement in the budget may deter sentiment and result in some sell-off," said an analyst on condition of anonymity.

Companies including Honda Motor Co. Ltd and Nissan Motor Co. Ltd are evacuating workers from the affected area, while theme park operators, movie theatres, retailers and restaurant chains are suspending or curtailing operations to protect workers.

While it is too early to assess the full impact on China, where national holidays have been extended and the central city of Wuhan has been locked down, it is clear the virus is hurting

consumption and tourism. The city of 11 million has been locked down in a bid to stem the spread of the virus, leaving roads empty and millions of people isolated and idle. Economists are still running the numbers on how that will hurt economic growth. Many are benchmarking the spread and severity of the coronavirus against the SARS (Severe Acute Respiratory Syndrome) outbreak in early 2003.

During the SARS crisis, close to 800 people in 17 countries died of the previously unknown respiratory illness that originated in southern China.

During SARS, Asia-Pacific airlines lost 39 billion revenue passenger kilometres or around 8% of annual traffic in 2003, according to the International Air Transport Association (IATA). Global cost from SARS was estimated at \$33 billion, or 0.1% of world GDP in 2003.

## Reliance launching new road project to counter plastics pushback in India

NEW DELHI (TIP): Reliance Industries, India's largest petchem player, is launching a project to use plastics in road construction, amid growing concerns over pollution in the country of 1.3 billion whose major cities are often plagued with smog and litter.

India, which uses about 14 million tonnes of plastic annually, lacks an organized system for management of plastic waste, leading to widespread littering.

Prime Minister Narendra Modi is urging India to end consumption of single-use plastics by 2022.

But Indians should focus on fighting pollution, not plastics, executives at Reliance, whose chairman is Asia's richest man Mukesh Ambani, said during a launch event on Tuesday.

The company will seek to work with India's highway authority and individual states to potentially supply a plastics-infused mix to make some of the thousands of kilometers of roads Modi wants to build to upgrade India's creaking infrastructure.

Light plastics, the type used as carry bags or snack wrappers, are typically not viable to recycle and so end up in landfills, street corners or oceans. Reliance wants to shred these plastics and mix them with bitumen, a formula the conglomerate says is cheaper and longer-lasting.

"(This) can be a game-changing project both for our environment and our roads," Vipul Shah, the COO of



the petrochemicals business, said at a company petchem plant in the western state of Maharashtra.

Shah was coy on details, saying Reliance had yet to work out the financial fine print in what he stressed would be a philanthropic endeavour.

Reliance's announcement comes as campaigners such as Greta Thunberg ramp up pressure on businesses to help tackle climate change.

"It is happening internationally and now has started percolating to India too, though it's at a very early stage," said Sunil Dahiya, an analyst at the Center for Research on Energy and Clean Air.

"Corporates and industries are a big source of all kinds of pollution in India, so much more serious thoughts, policies and actions are required from them," he added.



## STARBUCKS' RESULTS TOP ESTIMATES BUT CORONAVIRUS SLOWS SALES

It was a happy holiday at Starbucks, but the company's sales momentum could start to slow due to the coronavirus outbreak in China.

Starbucks said it had intended to raise its full-year earnings guidance Tuesday, but uncertainty about China put that on pause. Starbucks said it has already closed more than half of its stores in China due to coronavirus.

China's 4,292 Starbucks stores brought in 10% of the company's revenue during the October-December period, so the closure will affect earnings, the company said. But it's not yet clear how much of an impact there will be. Starbucks had expected full-year revenue growth in the 6% to 8% range and same-store sales growth of 3% to 4%.

"We remain optimistic and committed to the long term growth potential in China," Starbucks President and CEO Kevin Johnson said in a conference call Tuesday with analysts.

Starbucks shares fell 1.6% to \$87.20 in extended trading following the earnings report.

## AHEAD OF TRUMP'S FEB VISIT, 'LIMITED' INDIA-US TRADE DEAL ON THE CARDS

NEW DELHI (TIP): After months of hard negotiations, India and the US have moved closer to a trade deal that will include New Delhi's commitment to extend greater market access in medical devices and agriculture. But an agreement on Washington's demand for a sharp cut in or abolition of import duties on seven ICT products, including mobile phones worth over Rs 10,000, is still elusive, a source told FE. So a 'limited deal' could be signed during US President Donald Trump's expected visit to India in February, just three months after New Delhi pulled out of the Beijing-dominated RCEP trade pact.

While the quantum of incentives involved in the deal is unclear, it could cover products with total annual bilateral trade of around \$10 billion. A limited deal was supposed to be signed during Prime Minister Narendra Modi's visit to the US in September last year but a lack of consensus stalled it.

## Airbus faces record USD 4 billion fine after bribery probe

Airbus faces a record \$4 billion fine and lower 2019 profits after unveiling a preliminary deal with French, British and U.S. authorities following a crippling three-year probe into allegations of bribery and corruption over jetliner sales.

The deal, believed by anti-corruption experts to be the largest ever in a bribery case, ends an almost four-year crisis that led to a sweeping management overhaul and delayed plans to redeploy the plane giant's cash surplus. If approved by courts, the deal is expected to allow Airbus to avoid criminal charges that risked banning the company from public contracts in the United States and European Union – a massive setback for one of Europe's top defence and space firms.

The European planemaker has been investigated by French and British authorities for suspected corruption over jet sales dating back over a decade. It has also faced U.S. investigations over suspected violations of export controls.

Saraswati Puja is celebrated on Basant Panchami or Vasant Panchami that marks the beginning of the spring season. Basant means spring and Panchami means "the fifth day", so Vasant Panchami literally means the fifth day of the spring season. The day is also celebrated as Saraswati Puja and the goddess of wisdom and knowledge, Saraswati, is worshipped on this day. Popular in Bengal, Odisha and North Indian states like Uttar Pradesh, Bihar, Rajasthan, Madhya Pradesh, Basant Panchami and Saraswati Puja day is an auspicious one. According to drikpanchang.com, Vasant Panchami Muhurat is 10:45 am to 12:34 pm. The Panchami Tithi Begins at 10:45 am on January 29 and Panchami Tithi Ends at 1:19 pm on January 30, 2020.

On Saraswati Puja, women get ready in bright yellow sarees and men wear traditional kurtas and offer flowers and prasad to the goddess. On this day, children worship Goddess Saraswati, who is the deity of music, culture and learning.

### Rituals & Tradition

# VRINDAVAN: LORD KRISHNA'S CHILDHOOD ABODE

One of the oldest cities on the banks of Yamuna, Vrindavan is considered to be one of the most important places of pilgrimage for the devotees of Krishna. It is said that Lord Krishna had spent his childhood in Vrindavan. The name of the city has been derived from Vrinda (meaning basil) and van (meaning grove) which perhaps refer to the two small groves at Nidhivan and Seva Kunj. Since Vrindavan is considered to be a sacred place, a large number of people come here to abandon their worldly life.

The city of Vrindavan hosts hundreds of Lord Krishna and Radha temples scattered throughout, the most famous ones being Banke Bihari temple, ISKCON temple. The vibrant surroundings perfectly depict the playful and benevolent nature of Lord Krishna. Located along the waters of River Yamuna, the numerous temples set amidst the thick woods and lush greenery of Vrindavan are the major attractions here. Also known as Vrindavan, this city derives its name from the groves of Brinda and Vana meaning forest.

## Places to See in Vrindavan

### Govind Dev temple

The Govind Dev Temple in Vrindavan, built in the 16th century by Raja Man Singh is an excellent example of medieval Indian architecture. The building of this temple is closely associated with the famous Vaishnavite preacher and poet, Rupa Goswami. It is an astonishingly beautiful seven storey temple dedicated to Govind Dev, another name for Lord Krishna. The temple has an imposing facade, looking like a European cathedral because of the pillars and colonnades. It is made of red sandstone and is currently in a state of considerable decay, with the main puja related activities having shifted to a smaller temple behind the main structure.

### Krishna Balaram Temple (ISKCON)

The Krishna Balaram Temple was established in 1975 under the aegis of ISKCON, an international Krishna Consciousness religious group. The Krishna Balaram Temple is one of the most beautiful temple complexes in the city of Vrindavan and is seen as the spiritual and religious center of the worldwide Hare Krishna movement. It has three temples within the complex, one belonging to Sri Gaura Nitai, one to Lord Krishna and Balaram and the third to Sri Radha and her milkmaids, Vishaka and Lalita. The temple is alive through the year with its many celebrations commemorating every aspect and step of Lord Krishna's life.

### Bankey Bihari Temple

The Bankey Bihari Temple of Vrindavan is one of the most auspicious temples in the town, established in the Mughal times by Swami Haridas, the guru of Tansen, the famed court singer of the Mughal emperor Akbar. The temple earns its name from the bent



posture of the Krishna idol within the main chamber, an idol with a history. This idol is supposed to have been made according to the image of Lord Krishna that Swami Haridas saw in a dream. The temple is one of the most thronged sites in town and during the Jhulan Utsav, the temple administration brings out many gold and silver swings for the jhulan rituals with a lot of pomp.

### Madan Mohan Temple

The Madan Mohan Temple is one of the oldest temples in the town of Vrindavan and it sees many pilgrims visiting all through the year. It is a site that is closely linked to the life of Sri Chaitanya Mahaprabhu, one of the most important personalities within the Vaishnavite thought. Situated near the Kali Ghat, the Madan Mohan Temple is said to have been built by one Kapur Ram Das from Multan on the advice of Sanatan Goswami, a saint and follower of Chaitanya Mahaprabhu. The original idol of Madan Mohan had been shifted to Karoli, Rajasthan, under the rule of the Mughal king, Aurangzeb and now a replica of the original image is worshipped at the temple.

### Shahji Temple

The Shahji Temple, built in the mid-nineteenth century by the two brothers from Oudh, Shah Kundan Lal and Shah Phundan Lal, is another important and prominent temple in the town of Vrindavan. The temple is dedicated to the deity Sri Thakur Radha Raman Ji and receives a steady flow of pilgrims all across the year. One of the main attractions of this temple is one of the richly carved verandahs, which has the portraits of the two founders and their families beautifully carved into the floor - an unusual characteristic of a Hindu temple. The temple also has many rich carvings over the walls and ceilings inside.

### Rangaji Temple

Built in 1851, the Rangaji Temple is one



of the more unusual temples of Vrindavan because of its South Indian style architecture with an impressive gopuram. The deity in the temple is called Sri Ranganatha and is represented as sleeping on the Shesh Nag. The imposing Dhwajastambha within the temple premises is very famous. The

temple sees a great influx of tourists during the Brahmotsav in spring, where devotees pull the ropes of the chariot of the god. The annual Jalvihar festival is also another main attraction of the Rangaji Temple, when devotees from all over the country participate in the ritual bathing of the idol.

## Four Indian Americans among...

Professor of Marketing at the University of Southern California and the Walter H. Stellner Distinguished Professor of Marketing at the University of Illinois. He was also on the faculty of Columbia University and MIT.

Also known as "Jag," Dr. Sheth has published more than 350 research papers and books in various areas of marketing, including consumer behavior, multivariate methods, competitive strategy, relationship marketing and more recently, marketing for emerging markets.

Dr. Sheth is an American Psychological Association Fellow and past President of the Association for Consumer Research (ACR). He is also a Fellow of the American Marketing Association and the Academy of Marketing Science. Among his past and present accolades, Dr. Sheth was the recipient of the Viktor Mataja Medal from the Austrian Research Society in Vienna (1977) and the 1989 Outstanding Marketing Educator Award from the Academy of Marketing Science. In 1991 and again in 1999, Dr. Sheth was also recognized as the "Marketing Educator of the Year" by Sales and Marketing Executives International (SMEI).

Dr. Sheth is the recipient of all top four academic awards bestowed by the American Marketing Association (AMA). These include the PD Converse Award for Marketing Theory (1998), Charles Coolidge Parlin Award for Marketing Research (2004), the Richard D. Irwin/McGraw Hill Marketing Educator Award (2004) and the William L. Wilkie "Marketing for a Better World" Award (2014). In 1996, he was elected to be the Distinguished Fellow of the Academy of Marketing Science. Subsequent honors include the Outstanding Leadership Award by the AMA Foundation in 2002 and the Global Innovation Award and Marion Creekmore Award, both from Emory University. Over the last 3 decades, Dr. Sheth has received more than 30 awards as a thought leader in marketing, consumer behavior and emerging markets.

Prof S.P. Kothari is the Gordon Y Billard Professor of Accounting and Finance at the MIT Sloan School of Management. Previously, he served as global head of equity research for Barclays Global Investors (BGI), responsible for research supporting BGI's active equity strategies, from 2008-09. The actively managed equity portfolio had in excess of \$100 billion in assets, and the research team was comprised of approximately 50 PhDs based in San Francisco, London, and Sydney.

Earlier, Kothari was Head of the Department of Economics, Finance, and Accounting at the MIT Sloan School of Management. This department included approximately 75 professors and lecturers and an administrative staff.

Kothari's highly cited research focuses on financial reporting and valuation, asset allocation, explaining the diversity in international accounting practices, use of employee stock options for compensating executives and accounting for stock options, evaluating investment performance, and corporate uses of derivatives for hedging and speculation. The American Accounting Association (AAA) honored his work with the 2014 Notable Contributions to Accounting Literature Award. For the past 17 years, Kothari has served as an editor of the Journal of Accounting & Economics, a world-renowned academic research journal in accounting. He is an expert on economic policy issues in India and has written numerous opinion-page editorials in The Economic Times.

Mr. Kothari has spent nearly two decades at MIT, both as a professor and as an administrator. He has also been

Co-Chair of the Board of Governors Asia School of Business, Kuala Lumpur; faculty director of the MIT-India Program, and editor of the academic publication Journal of Accounting & Economics. In 2008, he served as global head of equity research for Barclays Global Investors, where he was responsible for research supporting the firm's active equity strategies and for managing a team of approximately 50 PhDs based around the world.

Prasanta Kumar Pattanaik, is emeritus professor at the Department of Economics at the University of California, a research associate for the Oxford Poverty & Human Development Initiative, and a fellow of the Human Development and Capability Association. Along with Amartya Sen and Kenneth Arrow, Pattanaik is an advisory editor for the journal Social Choice and Welfare. Pattanaik received his degree in economics from Utkal University, Odisha, India. He then went on to study for his master's and doctorate, both in economics, at the prestigious Delhi School of Economics University of Delhi. Pattanaik studied under, the Nobel Prize winning economist, Amartya Sen and his "leadership role" in the study of social choice theory has been acknowledged by Sen.

Romesh T. Wadhwani founded the Symphony Technology Group in 2002, which now a revenue of \$2.5 billion annually. Earlier, Dr. Wadhwani founded Aspect Development, Inc., where he was chairman and CEO until 1999 when the company was purchased by i2 Technologies. For nearly a decade, he grew Aspect Development into a leader in business-to-business e-commerce, culminating in the merger of Aspect with supply chain software company, i2 Technologies. This was one of the largest enterprise software mergers. Following the merger with i2, Dr. Wadhwani served as vice chairman of i2 and a member of the i2 Board of Directors. For the 10 years prior to founding Aspect, Dr. Wadhwani was founder, chairman, and CEO of Cimflex Teknowledge Corporation, a company specializing in products and systems for computer-integrated manufacturing. In the decade prior to that, he was founder, chairman, and CEO of a company specializing in information systems for energy management. In addition, he has been a director on the boards of several companies and organizations. Last year, Wadhwani ranked at number 261 of the Forbes list of 400 richest Americans and at number 667 in Forbes list billionaires. Wadhwani moved from Karachi to India during India's partition with his family at young age. He received a bachelor's degree from the Indian Institute of Technology, Bombay, and master's and Ph.D degrees in electrical engineering from Carnegie Mellon University. He established the Wadhwani Foundation for economic development in emerging economies, with an initial focus on India. In 2012, he inaugurated a new research center at the National Centre for Biological Sciences (NCBS) in Bengaluru, named after his late mother, Shanta Wadhwani.

## Indian American Arvind Krishna...

The executive changes, as well as the addition of Krishna and Whitehurst to IBM's board of directors, are effective April 6. Rometty, in a prepared statement, called Krishna the right CEO for IBM's next era.

"Through his multiple experiences running businesses in IBM, Arvind has built an outstanding track record of bold transformations and proven business results, and is an authentic, values-driven leader. He is well-positioned to lead IBM and its clients into the cloud and cognitive era," she said in her statement. Rometty also praised Whitehurst as a seasoned leader who positioned Red Hat as the leading open source enterprise IT software solutions and services provider. "[He] has been quickly expanding the reach and benefit of that technology to an even wider audience as part of IBM," she said in her statement.

Rometty in 2012 became IBM's chairman, president, and CEO, and in the last seven-plus years led IBM to acquire 65 companies, including its \$34-billion acquisition of Red Hat, and develop strong cloud and AI capabilities.

However, she also presided over a time of financial difficulties for IBM. The company's annual revenue peaked in 2011 at just shy of \$107 billion. However, the revenue decline has been moderating, and IBM in the fourth fiscal quarter of 2019 broke a five-quarter streak in revenue declines with revenue of \$21.8 billion, up 0.1 percent over fourth fiscal quarter 2018. # India win another super over thriller, take 4-0 lead

**WELLINGTON (TIP):** Virat Kohli inflicted more Super Overs misery on New Zealand as he helped India to a second successive victory in sudden death to win the fourth T20I. New Zealand have lost four limited-overs matches in Super Overs in the last six months, including the ODI World Cup final against England last year and the previous T20I match against India in Hamilton.

Needing 14 to win the match after Tim Seifert (8) and Colin Munro (5) gave New Zealand a total of 13/1 in the Super Over, KL Rahul hit the first ball from Tim Southee for six and the next for four before he was caught by Scott Kuggeleijn at deep midwicket. Kohli then bunted two runs down the ground and hit Southee for four to take India to 16/1 and a 4-0 lead in the series.

## Chase gone awry

The hosts had appeared to be cruising to victory in the regulation 20 overs on 159/3 and needing seven runs from the final six balls bowled by Shardul Thakur. But they lost four wickets in the over to finish on 165/7.

Seifert had put New Zealand in a position to win the game as he combined with Ross Taylor (24) in a 62-run partnership that was broken in the final over. Seifert was then run out for 57, while Daryl Mitchell was caught and Mitchell Santner run out on the final ball attempting the second



run that would have given New Zealand the win.

Opener Colin Munro had earlier scored 64 but threw his wicket away after some lazy running led him being run out from a direct hit by Kohli after he took a relay throw from the outfield from Thakur. New Zealand captain Kane Williamson was ruled out of

today's match owing to a shoulder injury. Pacer Tim Southee led the Black Caps in his absence.

## Pandey power

India had scored 165/8 in their 20 overs, with Manish Pandey superbly marshalling the tail and scoring his third half-century in T20Is, finishing on 50 not out.

## Indian hockey superstar Rani Rampal bags 'World Games Athlete of the Year' award

**LAUSANNE (TIP):** India women's hockey captain Rani Rampal on Thursday won the 2019 World Games Athlete of the Year award. The prize, which is voted for by the public, is given for outstanding performance, along with social commitment and fair behaviour.

"It is my privilege and honour to win this award," said Rani. "The award goes to my team and my country. It is always nice when your country recognises your effort. It is even better when the international sports community recognises it. Thank you so much to everyone who voted for me. 2019 was a great year for our team because we qualified for the 2020 Tokyo Olympic Games. As a team we want to make 2020 a great year!"

The 25-year-old Rani has been part of the Indian women's hockey team since she was 15 years old and has made 240 appearances for the national team thus far. Rani played an integral role in the team's successful qualification for the 2020 Tokyo Olympics, playing a key role in midfield and scoring what turned out to be the winning goal in the




second leg of their Olympic qualifier against the US in

November. Apart from that she was the player of the tournament in the FIH Women's Series Finals in Hiroshima, among other highlights of 2019 for her and the team.

International Hockey Federation (FIH) CEO Thierry Weil said: "On behalf of FIH and the global hockey community, I would like to extend our warmest congratulations to Rani for having been voted The World Games Athlete of the Year 2019. This is an acknowledgement of her outstanding performances - together with her teammates - of her dedication to hockey and of her leadership. This prestigious Award is also a great recognition for hockey globally."

He added: "We are working hard for and look forward to having Hockey 5s as a demonstration sport at The World Games 2021."

There were initially 25 nominees, male and female, which were reduced to 10 in the final round of public voting. Among her rivals to the title were karate star Stanislav Horuna of Ukraine, Canadian powerlifting champion Rhaea Stinn and Janja Garnbret, a sport climbing star from Slovenia.



## NEERAJ CHOPRA QUALIFIES FOR OLYMPICS WITH THROWS OF 87.86M

**POTCHEFSTROOM (TIP):** Star javelin thrower Neeraj Chopra has qualified for the Tokyo Olympics with a throw of 87.86m at the Athletics Central North East meeting, returning to action after recovering from an elbow injury, here.

The 22-year-old Indian, who missed the entire 2019 season due to the injury, breached the Olympic qualification mark of 85m with his effort during the international event on Tuesday.

"I'm happy with the result as I went in to the competition with mindset to warm-up for the season. Once I did well with the first three throws (all being above 80m), I decided to push a bit harder in the fourth attempt," said Neeraj, the Asian Games and Commonwealth Games gold medallist.

Another Indian in fray, Rohit Yadav threw 77.61m.

Neeraj had missed the IAAF World Championships, the Diamond League and the Asian Championships while recovering from the injury.

His last major international competition was the 2018 Jakarta Asian Games where he won gold with a national record of 88.06m.

The Indian had undergone a surgery in May 2019 to treat the injury. He was expected to compete at the National Championship late last year but the AFI didn't give him clearance, allowing him more time to heal.

## Djokovic powers past Federer into Australian Open final

**MELBOURNE (TIP):** Novak Djokovic shattered the hopes of ailing rival Roger Federer Thursday to sweep into a record eighth Australian Open final and move closer to his 17th Grand Slam crown.

In the 50th instalment of one of sport's greatest rivalries, the Serb shrugged off a tentative start to reinforce his recent dominance, showing no mercy to the Swiss maestro in a 7-6 (7/1), 6-4, 6-3 win.

He will play either fifth seed Dominic Thiem or seventh-ranked German Alexander Zverev in Sunday's final, but it will take a monumental effort to prize another title from the 32-year-old.

Of the seven Melbourne finals Djokovic has made, he has won them all.

If any extra motivation was needed, winning on Sunday will see the Serb reclaim the number one ranking after Rafael Nadal was sent packing in the last eight.
