Trump identifies India, 20 other nations as major drug transit or major illicit drug-producing countries

**WASHINGTON (TIP):** US President Donald Trump has identified India along with 20 other nations as major drug transit or illicit drug-producing countries and asserted that his administration is taking the fight to criminal organizations engaged in narcotics substances and their enablers on an unprecedented scale.

In his presidential determination, Mr. Trump also designated Bolivia and the regime of Nicolas Maduro in Venezuela as having failed demonstrably during the previous 12 months to adhere to their obligations under international counter-narcotics agreements.

A country's presence on the foregoing list is not necessarily a reflection of its government's counter-narcotics efforts or level of cooperation with the United States, Mr. Trump said.

A Biden administration will have no tolerance for terrorism in South Asia and it will place a high priority on strengthening U.S.-India ties, his campaign has asserted.

"We believe that India and the United States are natural partners, and if elected, our administration will place a high priority on continuing to strengthen the U.S.-India relationship," it said in a written response to a series of questions asked by the Hindu American Political Action Committee.

The committee recently sent a series of questions to the campaigns of former Vice President Joe Biden and President Donald Trump as part of its decision-making process to endorse either of

## Donald Trump contradicts CDC on vaccination

Reiterates that vaccine distribution could start in October, calls facemasks a 'mixed bag'



President Trump and CDC Director Dr. Redfield hold divergent views

**WASHINGTON (TIP):** U.S. President Donald Trump on Wednesday contradicted the director of the Centers for Disease Control and Prevention (CDC) Robert Redfield on the efficacy of masks and the schedule for vaccine availability. Mr. Trump told reporters at the White House that Dr. Redfield had probably not understood the question on vaccine distribution correctly at a Senate hearing earlier on Wednesday.

## COVID-19 vaccine by early 2021, says Health Minister

India is among the few countries globally that have succeeded in isolating the virus, he said.

**NEW DELHI (TIP):** Union Health Minister Harsh Vardhan told Rajya Sabha on Thursday, September 17, that there is a possibility of a vaccine for COVID-19 to be out by early next year and that the government is aiming to bring down India's mortality rate for the coronavirus to less than 1% from the current 1.64%.

The Minister said that the Science and Technology Ministry, Indian Council of Medical Research (ICMR), and drug companies, were working together to find a solution. "Vaccines can come in future. Extensive planning is underway

to execute how to manage the scenario," Dr. Vardhan said.

He said there are three vaccine candidates that have reached Phase 1, 2 or 3 levels. "Under the Prime Minister, an expert group is studying this. We expect by the beginning of next year, we can have a vaccine in the country. In this regard, we are also coordinating with WHO (World Health Organization) and global organizations," he said. He claimed that India is among the few countries globally that have succeeded in isolating the virus.

them before the November 3 presidential election.

"A Biden-Harris administration will have no tolerance for terrorism in South Asia - cross-border or otherwise. Our administration will work to strengthen India's capabilities as a defense and counter-terrorism partner," the Biden campaign said.

"During the Obama-Biden administration, the U.S. and India strengthened their cooperation to fight terrorism in each of our countries and across the region, and if we are elected, the Biden-Harris administration will continue and build on this effort," it said.

Expressing concern about dangerous conditions for religious minorities in South Asia and elsewhere, Mr. Biden said if elected, his administration will renew America's commitment to standing as a beacon of hope for refugees around the world, including those fleeing religious persecution and seeking the freedom to worship as they choose.

Noting that the U.S. is fundamentally a nation of immigrants, he said he is committed to immigration reform that provides a roadmap to citizenship for nearly 11 million undocumented immigrants - including more than 500,000 from India.

"We will remove the uncertainty for Dreamers by reinstating the DACA programme and explore all legal options to protect their families from inhumane separation. All of this is in direct opposition to Trump's actions," the campaign said.

A Biden-Harris administration will work with the Congress to increase the number of visas awarded for permanent, employment-based immigration - and promote mechanisms to temporarily reduce the number of visas during times of high U.S. unemployment, it said.

"We will also exempt from any cap recent graduates of PhD programs in STEM fields in the U.S... We believe that foreign graduates of a U.S. doctoral programme should be given a green card with their degree and that losing these highly trained workers to foreign economies is a disservice to our own economic competitiveness," it said.

Critically, Vice President Biden believes that we need to reform our high skilled temporary visas support to establish a wage-based allocation process and establish enforcement mechanisms to ensure they are aligned with the labor market and not used to undermine wages, and, as part of that reform, he supports eliminating the limits on employment-based green cards by country, which have kept so many Indian and Hindu families in waiting for too long, the campaign said.

Ajay Bhutoria, national finance committee member of Biden campaign, said in a statement that a Biden-Harris administration will celebrate Hindu holidays, as was done in the Obama-Biden administration, which celebrated Diwali at the White House, the Vice President's residence at the Naval Observatory, and at the Pentagon.

"This election year Biden recognized Holi and Ganesh Chaturthi. In doing this, our hope is to showcase how Hindu-Americans are, in every way, Americans and that we are all bound by common values and aspirations, and that this may help to minimize the kinds of misunderstandings about Hinduism that cause bullying," he said.

Mr. Bhutoria said the Biden campaign made history in its outreach to the Hindu-American community. Mr. Biden became the first major-party presidential nominee to respond to a questionnaire for the Hindu-American community, he said.

Mr. Biden's a response to real concerns in the community, addressing the unique challenges facing Hindu students to the importance of reforming the immigration system to how to help small businesses recover from COVID-19, Mr. Bhutoria said. (Source: PTI)

He said countries such as Afghanistan, India, The Bahamas, Belize, Burma, Colombia, Costa Rica and the Dominican Republic among others are a major drug transit or illicit drug producing nations.

Mr. Trump alleged that the most complicit kingpin in this Hemisphere is the Venezuelan dictator, Nicolas Maduro.

In Colombia, President Ivan Duque and his government remain strong partners of the United States, and Colombian police and military forces have shown great bravery and

commitment by targeting high-level drug traffickers, interdicting drug shipments, and manually eradicating coca, he said.

Nevertheless, coca cultivation and cocaine production remain at unacceptably high levels, Mr. Trump added.

Mr. Trump expressed concern that coca cultivation and cocaine production remain near historical highs in Peru, another longstanding U.S. ally.

"Peru is a valued law enforcement partner of the US and has demonstrated continuous commitment to fighting all aspects of the drug trade," he said.

He said Mexico must also clearly demonstrate its commitment to dismantling the cartels and their criminal enterprises and do more to protect the lives of Mexican and American citizens threatened by these groups.

The Mexican government should acknowledge the alarming trend of fentanyl production inside its territory, he said. (Source: PTI)

Coronavirus cases in the U.S. are soaring with over 6 million infections and around 200,000 deaths. The President faces a tough contest for re-election in November and has proclaimed a vaccine would be available by the end of the year. Dr. Redfield, testifying with other officials at a U.S. Senate committee hearing on the government's pandemic response, had told Senators that it would probably take until the "late second quarter, third quarter 2021" for the vaccine to be "fully available" to the American public so people could "get back to regular life".

Rebutting the Opposition parties' criticism on the number of COVID-19 positive cases crossing 50 million, the Minister said that the active cases were less than 20%.

He also patted the government's back, claiming that the country's recovery rate of 78%-79% is one of the highest in the world. Deaths in India due to the coronavirus pandemic are less than many nations in Europe, he said. Citing the examples of Spain and Brazil, the Minister said the mortality rate in those countries was over 11 times that of India. "We want to bring the mortality rate to less than 1%. We have 50 lakh cases right now, but out of these, only 10 lakh are active cases in the country right now," Dr. Vardhan said.

Currently, India is only second to the U.S. in the world in testing, which the government plans to improve, he said.

Replying to a query from Congress leader Anand Sharma on the basis of the government's claims that the lockdown had reduced the number of cases by 14-29 lakh, Dr. Vardhan said that the government had derived the figures from the findings of five scientific bodies, including the Boston Consulting Group, PHFI (Public Health Foundation of India), and the Ministry of Statistics and Programme Implementation. "These bodies did five studies and based on that we prepared this data," Dr. Vardhan said.

Replying to another query on the use of the BCG vaccine for COVID-19, he said six clinical trials had been registered and the ICMR was a part of this study. (Source: The Hindu)

# India's Foreign Secretary Shringla takes a broad overview of 'Indian Diplomacy during the Pandemic' in his lecture


India's Foreign Secretary Harsh Vardhan Shringla on 4 September 2020 delivered a major foreign policy lecture on "The Broad Canvas of Indian Diplomacy during the Pandemic," during a virtual event organized by Indian Council of World Affairs, one of India's premier and oldest foreign policy think tanks.

The scale and spread of the event covered the length and breadth of India, with participants from 28 states and 4 union territories. With 2000 registered participants, the lecture was attended by a diverse array of distinguished think-tanks and eminent academics, including deans and vice chancellors of prestigious universities and research centers.

The Foreign Secretary's lecture was a broad overview of Indian foreign policy. He described the fundamental impulses that underlie it in a rapidly changing international environment. He also spoke about its contemporary challenges and direction.

The Foreign Secretary pointed out that the current pandemic has affected every facet of India's national life and its external policies. It has been an enormous economic shock. It is also likely to have serious geopolitical repercussions.

The pandemic has exposed the deficiencies of globalization. The

Foreign Secretary said that India is an advocate of globalization that is human-centric. He also spoke about the Prime Minister's vision of "Atmanirbhar Bharat." Atmanirbharta is not about inward-looking withdrawal from a globalized world. Instead, it aims to strengthen India's position as a prime participant in global supply chains and as a major player in global trade and innovation. The Foreign Secretary said

that India is committed to multilateralism. He referred to India's forthcoming tenure as a non-permanent member of the UN Security Council. He also referred to India's forthcoming presidencies of G-20, BRICS and SCO. These are testimony to India's enhanced global standing, providing India an opportunity to project its priorities and participate in generating global solutions. India's first priority remains

its neighborhood. Its Neighborhood First policy reflects this central focus.. India's engagements with ASEAN countries under Act East and with the Indian Ocean Region in line with Security and Growth for All in Region (SAGAR) vision have also strengthened. India's Think West outreach to West Asian countries, and its engagements with African countries have intensified.

Terrorism continues to remain a growing threat, while non-traditional challenges in space, cyber-space and biological domains are complicating the security landscape.

India takes its development partnerships very seriously. It is committed to working its partners in the spirit of sabka saath, sabka vikas.

During the pandemic, India established that it was a responsible member of the international community through its actions in supplying drugs such as Hydroxychloroquine and Paracetamol. These are investments it has made in the future. It has built on its reputation as the "pharmacy of the world."

He drew attention to the fact that serving the diaspora and Indians abroad is one of India's highest priorities. More than 1.2 million Indians have returned home to India under the Vande Bharat Mission, the largest repatriation exercise of this nature undertaken in recent history.

## NJ based Staffing company to pay \$345,000 to resolve H-1B violations

**Kickerline:**A probe found that from January 2014 through June 2018, many of the company's H-1B workers were not paid the required wage in regular intervals at the required wage rate throughout their period of employment

**NEW JERSEY (TIP):** A New Jersey-based staffing company has agreed to pay \$345,000 to settle allegations that it has violated immigration and employment regulations concerning continuous employment and wage requirements of workers it had brought to the U.S. on H-1B visas.

The H-1B visa is a non-immigrant visa that allows U.S. companies to employ foreign workers in specialty occupations that require theoretical or technical expertise. H-1B visas are most sought after among Indian IT professionals.

The U.S. Immigration and Customs

Enforcement's (ICE) Homeland Security Investigations (HSI), the Department of Labor and the U.S. Attorney for the District of New Jersey ordered Savantis Solutions to pay \$345,000 to resolve allegations against H-1B related violations.

Savantis, formerly known as Vedicsoft Solutions, has a presence in India as well. The company is involved in consulting, technology and staffing, utilizing primarily foreign nationals in the U.S. pursuant to H-1B visas.

A probe found that from January 2014 through June 2018 many of Savantis' H-1B

workers were not paid the required wage in regular intervals at the required wage rate throughout their period of employment, the ICE said in a statement on Monday, September 14.

The company also failed to properly pay many of its H-1B workers in conformance with their applications to the federal government and federal regulations, it said.

Savantis improperly recruited H-1B workers by having them submit a security deposit prior to submitting their application, the statement said.

The \$345,365 in restitution will be used

to pay back wages plus interest to employees and former employees of the company, it said.

However, the statement did not mention how many employees were covered by this settlement and how many would receive the pending wages and interest.

"Savantis cooperated in the investigation of the matter and undertook compliance efforts in response. Pursuant to the agreement, the company is also required to hire an outside law firm to serve as a monitor to ensure ongoing and continued compliance with the relevant rules and regulations for the next three years," the statement said.

# Indian-Origin Author among Six others on Booker Prize 2020 List

**LONDON (TIP):** Dubai-based Indian-origin author Avni Doshi is among the six authors shortlisted for the 2020 Booker Prize for her debut novel "Burnt Sugar".

The shortlist was unveiled virtually in London on Tuesday, September 15, after judges re-evaluated the 13 longlisted novels published in the UK or Ireland between October 2019 and September 2020 to whittle down the shortlist for the GBP 50,000 literary prize in November.

"This utterly compelling read examines a complex and unusual mother-daughter relationship with honest, unflinching realism - sometimes emotionally wrenching but also cathartic, written with poignancy and memorability," the judges said of Avni

Doshi's entry.

Avni Doshi, born in the US and now living in Dubai, has previously spoken about the long journey to her first novel, which was released in India last year as 'Girl in White Cotton' and for its UK release in July.

The rest of the shortlist includes Diane Cook for "The New Wilderness", Zimbabwean writer Tsitsi Dangarembga for the third novel in her trilogy - 'This Mournable Body', Maaza Mengiste for "The Shadow King", Douglas Stuart for "Shuggie Bain" and Brandon Taylor for "Real Life".

Literary heavyweight and former double Booker winner Hilary Mantel, in the running for her final installment in her series set in King Henry VIII's 16th century England "The Mirror and the Light", failed to make the shortlist cut.

"The shortlist of six came together unexpectedly, voices and characters resonating with us all even when very different. We are delighted to help disseminate these chronicles of creative humanity to a global audience," said Margaret Busby, literary critic and chair of the 2020 judges.

"As judges, we read 162 books, many of them conveying important, sometimes uncannily similar and prescient messages," she said.

"The best novels often prepare our societies for valuable conversations, and not just about the inequities and dilemmas of the world - whether in connection with climate change,

forgotten communities, old age, racism, or revolution when necessary - but also about how magnificent the interior life of the mind, imagination and spirit is, in spite of circumstance," she said.

The organizers said that readers of the chosen books will travel to India to unpick an unsettling mother-daughter relationship redefined by dementia with Avni Doshi's entry; explore the tender story of a mother's battle to save her daughter in a dystopian city made inhospitable by the climate crisis; witness a woman confronting the realities of life and morality in Zimbabwe as she descends into poverty.

They will uncover the extraordinary tales of the African women who went to war during Italy's 1935 invasion of Ethiopia; find humanity and humor in the harsh realities experienced by a marginalized family in 1980s Glasgow; and question what "real-life" is in a fresh take on the campus novel, which offers a nuanced account of racism and homophobia.

Gaby Wood, Literary Director of the Booker Prize Foundation, said: "Every year, judging the Booker Prize is an act of discovery. What's out there, how can we widen the net, how do these books seem when compared to one another, how do they fare when re-read? These are questions judges always ask themselves, and each other."

"This year there has perhaps been more discovery than usual, both in the sense that debut novels are in the

majority and due to the fact that the judges themselves were surprised to find that was the case. Why were they surprised? They were focusing on the books," she said.

"No one wins the Booker Prize because of who they are. A book wins because of what it does. What has transpired is a testament to the judges' faith in - among other things - first fictions: they have found these writers to have much to say, and found them to have said it in a way that became even richer on second reading."

The Booker Prize for Fiction is open to writers of any nationality, writing in English and published in the UK or Ireland. The shortlist of six books will be announced on September 15, with each shortlisted author receiving 2,500 pounds and a specially bound edition of their book at the prize ceremony scheduled for November.

The 2019 Booker Prize for Fiction was won jointly by "The Testaments" by Margaret Atwood and 'Girl, Woman, Other' by Bernardine Evaristo. First awarded in 1969, the Booker Prize is recognized as the leading prize for literary fiction written in English.

The rules of the prize were changed at the end of 2013 to embrace the English language "in all its vigor, its vitality, its versatility and its glory", opening it up to writers beyond the UK and Commonwealth, providing they were writing novels in English and published in the UK.

## Indian-Origin London Mayor Candidate Geeta Dropped Over Anti-Semitism Remarks

**LONDON (TIP):** An Indian-origin entrepreneur-activist was on Monday dropped as a prospective London mayoral candidate to contest against Sadiq Khan next year after her past antisemitic comments came to light.

Geeta Sidhu Robb, the founder of organic food and juice products firm Nosh Detox, had been shortlisted as the Liberal Democrat candidate to take on Labor's Khan but was instead suspended from the party after a 1997 General Election footage revealed her making anti-Jewish remarks.

"I apologize profusely for my actions in the 1997 General Election campaign. My behavior caused offence and hurt and I am deeply sorry," said Sidhu Robb.

"There is no room for any form of racism or antisemitism in society and as such I very much regret my conduct at that time. It is in no way an excuse, but the context was that I was on the receiving end of a consistent racist campaign and, wrongly, retaliated as I did," she said.

## Indian-Origin Man gets Life for Brutally Murdering his Partner in UK



**LONDON (TIP):** A 23-year-old Indian-origin man who stopped a police officer in the street and made comments implicating himself in an attack on his estranged partner has been sentenced to life imprisonment for her brutal murder by a UK court.

Jigukumar Sorthi was sentenced to serve a minimum of 28 years behind bars before being considered for parole after he was found guilty of the murder of 21-year-old Bhavini Pravin, who was found stabbed at her home in the city of Leicester in March.

"This was a horrific, brutal and merciless killing. You took the life of a beautiful, talented young woman, just 21 years of age," Justice Timothy Spencer told Jigukumar Sorthi at the sentencing hearing at Leicester Crown Court on Wednesday.

During a murder trial earlier this month, the jury heard how he had felt jilted by Bhavini Pravin after she broke off plans for their wedding ceremony.

At around 12.30 pm on March 2, Jigukumar Sorthi went to her home and once inside they talked for a few minutes before Jigukumar Sorthi stabbed her multiple times and left the property.

Leicestershire Police and East

Midlands Ambulance Service personnel were called to the address where the victim was pronounced dead.

Less than two hours after the incident, Jigukumar Sorthi approached an officer outside Spinney Hill Police Station in Leicester and made admissions implicating himself in the stabbing of Bhavini Pravin.

A post-mortem examination was carried out and concluded Bhavini Pravin died as a result of multiple stab wounds.

"Bhavini was a young woman who had the rest of her life to look forward to. She was a gentle caring soul and came from a close and very private family.

# Indian American NY based celebrity chef Vikas Khanna for Asia Game Changer award

**NEW YORK (TIP):** New York based India-American Michelin-starred chef Vikas Khanna has been chosen for the prestigious 2020 Asia Game Changer Award for feeding millions across India amid the covid-19 pandemic through a massive 'FeedIndia' drive.

The Asia Game Changer Awards, launched by the Asia Society - a US-based non-profit organization - in 2014, identify and honor true leaders who make a positive contribution to the future of

Asia.

Asia Society's 2020 Asia Game Changer Awards honorees were chosen for their responses to the year's twin traumas of COVID-19 and racially motivated violence.

In partnership with Citi, Asia Society annually honors game-changing leaders from a broad geographic range and varied backgrounds, it said. "This year's honorees have saved lives, changed lives, and lifted spirits all across the globe."

Khanna, 48, is the only Indian among the six honorees including Korean boy band BTS, noted US cellist Yo-Yo Ma, Japanese-American tennis star Naomi Osaka, producer of Oscar-winning Korean film 'Parasite' Miky Lee and business leaders and philanthropists Joe and Clara Tsai.

The six will be honored at a virtual event in October featuring a special message by New York Governor Andrew Cuomo, a performance from Yo-Yo Ma, and a special moment to honor frontline health care workers in the US and Asia.

"I have always looked up to Asia

Society for connecting East & West. Today, I am proud to be awarded #AsiaGameChangers Award 2020," Khanna tweeted.

"Humbled to be in the company of @BTS\_twt, @naomiosaka, @YoYo\_Ma, @JoeClara #MikyLee," he wrote

"By September 23rd, we complete 175 Days of #FeedIndia and also cross 40 Million+ Meals(Cooked and Dry Ration) Working 24/7, best to our abilities to ensure that kitchens are running in our homeland," Khanna wrote in another tweet. The Asia Society noted "Khanna has been feeding people since he was a child. But not until 2020 did it become a matter of life or death."

"In April, while quarantining in his Manhattan apartment, Khanna, host of MasterChef India, monitored news out of his homeland and watched, with horror and helplessness, as a virus-fueled humanitarian crisis unfolded."

"Millions of Indians needed food. Khanna desperately wanted to help, but how? Khanna turned to Twitter, where he has more than 2.3 million followers,

and issued a heartfelt plea for information on communities in need," the Society said in its citation.

"I wanted to show that solidarity still exists," he was quoted as saying. Khanna received a torrent of responses, and #FeedIndia was born.

Khanna partnered with India's National Disaster Relief Force for logistical and on-the-ground support and his movement soon received aid from grain companies, tech firms, and offers of industrial kitchen space in Mumbai.

By late-August #FeedIndia had delivered more than 30 million dry food packets and cooked meals to hundreds of cities throughout India.

"I feel like the past 30 years ... have prepared me for this moment," Khanna said. "This has been the most gratifying [time] in my culinary career."

Past awardees include PepsiCo's former CEO Indra Nooyi, South Delhi Deputy Police Commissioner Chhaya Sharma, and co-founder and CEO of non-governmental education organization Pratham, Madhav Chavan.

## Indian Americans favor Biden despite big shift towards Trump

**Kamala Harris' historic nomination, Modi-Trump rallies give political clout to Indian origin voters**



The report, which has survey results of 260 Asian Indian registered voters, regardless of party affiliation, found that some of the issues at the top of the list for Indian Americans in this election included education, jobs and economy, health care, and the environment. The report also chronicles the rise of the Indian American electorate as one of the fastest growing minority groups in the US, with significant numbers in "battleground" states.

"Indian Americans are positioned to make a difference in several swing states that may be close in this election, such as Florida (87,000), Pennsylvania (61,000), Georgia (57,000), Michigan (45,000), and North Carolina (36,000), and perhaps even Texas, which has 160,000 Indian-American voters," said Dr. Karthick Ramakrishnan, professor of public policy and political science at UC Riverside, and founder of AAPI Data. "Given Senator Kamala Harris's historic vice-presidential nomination, as well as highly publicized rallies that President Trump and Prime Minister Modi held together, high turnout could make a huge difference in this election."

Currently, there are 1.8 million Indian Americans in the US who are eligible voters. About 310,000 Indian green card holders remain in a backlog for citizenship as of 2019, and another 310,000 Indian

residents in the US are in a backlog to obtain their green cards. In addition, Indian American political engagement extended to several areas, with a fifth of Indian American registered voters saying they contacted their representative or government official in the US this year.

As many as 74 percent had discussed politics with family and friends, and a quarter of those surveyed had donated to a candidate, political party or campaign this year. As many as 54 percent of Indian Americans identified as Democrats, 16 percent as Republicans, and 24 percent as Independents.

In 2016, 46 percent of Indian American voters identified as Democrat, 35 percent were Independent or Other, and 19 percent identified as Republican. Both Democratic and Republican parties have conducted outreach to Indian Americans in this election, with 56 percent of Indian American registered voters surveyed saying they had been contacted by the Democratic party in the past year, and 48 percent saying they had been contacted by the Republican party. This is a marked increase from 2016, when only 31 percent of Indian Americans said they had been contacted by a political party compared to 44 percent of White voters and 42 percent of Black voters. In addition, several hundred Indian American candidates also are running for office in record numbers at federal, state and local levels. "Given the Indian diaspora's increasing political importance in the US, it's no surprise they are being courted by both sides of the aisle," said Rangaswami. "It's great that both major political parties have begun to realize just how critical it is to reach out to Indian Americans - our impact is only going to increase over time."

**Indian-Origin UK Minister Alok Sharma Unveils UK's Investment to Tackle Dangers by Space Debris**

The seven projects will develop new sensor technology or artificial intelligence (AI) to monitor hazardous space debris. # Punjab Tourism under Vande Bharat Scheme

**D**ue to Covid - 19 pandemic crisis and the resultant shutdown and curfew has hit every segment of economy.

The worst hit segment was of travel and tourism. Now the government wants to revive the tourism industry. The Indian Government has proposed a new scheme called Vande Bharat, under which people from different states will tour various parts of India.

Punjab's tourism is still in its infancy, though it has immense potential, but it remains mostly untapped. Somehow, or rightly too, the name Punjab has been synonymous with excellence in agriculture and preponderance of small-scale industry. Now Vande Bharat program encouraged by the central government hopefully will open a new avenue for Punjab tourism.

This state consists of several princely states like Patiala, Nabha, Jind (Sangrur) Malerkotla, Faridkot and Kapurthala and each of the princely states has its own distinct architectural flavor depending on the tastes of its rulers and the people they have been hanging around with.

Patiala is known for its massive buildings constructed primarily in Rajput style of Rajasthan. Some high-tickethistoric restoration work is going on in Patiala. If after the restoration work is completed, which is in full swing and Patiala is clubbed with Sangrur, the two can make a world of difference in tourism. Sangrur has a mostly marble twelve acre "Baradari Building", which is an architectural masterpiece and has been repaired too. In addition the heritage Darbar Hall in Sangrur is another asset to be seen by heritage lovingtourists. Malerkotla, located close by, has distinctly Islamic Architecture. Faridkot is influenced by European (British) and Indian (Mughal) architectural styles, its drawback is that it is quite far away from both Patiala and Amritsar and protracted litigation has ruined its chances of attracting tourists. Patiala is being fast tracked for tourism, but so far it lacks high-end hotels, for which it depends on Chandigarh and Zirakpur.

Jagatjit Palace Kapurthala is by and large influenced by French Architecture. Kapurthala has a beautiful mosque built in Moroccan style of Islamic architecture. Being located very close to Amritsar, Kapurthala can attract hordes of tourists, if added to the already booming Amritsar tourism circuit. But its most magnificent Jagatjit Palace needs to be allowed to be visited by the army authorities, who run a Sainik School in Jagatjit Palace Kapurthala. Kapurthala has some high-class hotel accommodation, for the rest it can piggyback on Amritsar's huge hotel industry.

Since highly durable stones like Marble, granite, limestone and

sandstones in various colors and hues are not native to Punjab state, most of the construction in Punjab is based on London's favorite brick masonry laid with lime or mud mortar. Such buildings are never long lasting like the Marble marvels of Jaipur and of the other cities of Rajasthan. Punjab's royal brick buildings need frequent repairs. That is why most of the architectural masterpieces of Punjab needed repairs more often. Some were repaired in recent past and some badly need restoration.

The only well maintained and well looked after architectural treasure of Punjab is itsprimary tourist attraction,known as the Golden Temple in Amritsar. Even it is built with small bricks laid in lime mortar, but it is covered with an external layer of marble and during the reign of Emperor Ranjit Singh, it was covered with gold plates on the exterior as well as the interior. Gold is impervious and it does not corrode, therefore the sanctum sanctorum of the Golden Temple does not need frequent expensive repairs. To an outsider, it always looks new and shining. In addition, the SGPC and the devotees meticulously take care of its daily cleanliness.

Due mostly to word of mouth, the name and fame of the Golden Temple in the past decade or so has reached not only all the parts of India but Europe, Australia, New Zealand and North and South America too. The domestic and foreign tourists have found a well-

meaningprimary tourist attraction in the Golden Temple, at par with the Eiffel Tower and Arc De Triumph of Paris, Taj Mahal of Agra and the Lake Palace of Udaipur. The broad and spacious "Parikarma" of the Golden Temple, built with fine Makrana marble, can accommodate more than one hundred thousand tourists at a time. The artwork "Nakkashi" on the interior of the sanctum sanctorum is matchless. The centuries old universally available tradition of free kitchen is another attraction. Prior to the Covid - 19 generated lockdown and shutdown, the Golden Temple was hosting between one hundred to two hundred thousand pilgrims on daily basis. The number has gone down to a trickle now, I don't know when the milling crowds will return back to the Golden Temple, because Covid - 19 is still with us. There are plenty of cheap hotels around it.

Only a stone's throw away from the Golden Temple is the historic "Jallianwala Bagh", where a brutal unprecedeted massacre of patriots took place on 13th of April in 1919. This nine-acre park has recently been rehabilitated by a grant from the central government. On a daily basis twenty to fifty thousand tourists have been visiting this memorial garden.

Just a few yards from the "Jallianwala Bagh is the "Partition Museum" associated with the bloodshed at the time of division of the country in 1947. It is also located in a century old historic

British style landmark building. This museum is also quite popular with the tourists.

Close to the "Partition Museum" are some of the most popular vegetarian eating places of Amritsar. These are not expensive, but are unbelievably delicious, nevertheless. The Durgiana Temple is not too far away from the Golden Temple and is another big place of tourism value. Near the Amritsar Junction Railway Station is the historic "Fort Gobindgarh", which houses the replicas of Emperor Ranjit Singh's "Zamzama Cannon" and the "Kohinoor Diamond". At one time both were housed in Fort Gobindgarh. The other tourist hot spots in Amritsar include the eighty acres plus historic "Ram Bagh" (also known as the Company Bagh") and the "Maharaja Ranjit Singh Panorama" depicting some of the main events of the

life of the Sikh emperor.

In the evenings, to cap off the day's events, there is a magnificent patriotic event enacted by the Border Security Force of India called "Retreat" at the Attari/Wagha international border. This lively and entertaining event lasts till dusk and leaves a fine taste in the mouth of the visitor. On the second day the tourists can visit "Harike Wildlife Watching Place", which can be reached from any place within Amritsar within one hour. Or the tourists can visit the historic buildings of Kapurthala. The finest building in Kapurthala is the 112-year-old Jagatjit Palace. The other visitable buildings are the "Moorish Mosque", the "Darbar Hall" within the old district courthouse. Among the modern worth seeing buildings are the "Science City" and the "Rail Coach Factory Kapurthala". The pilgrims can visit the Gurdwaras associated with the life of Guru Nanak Dev ji in Sultanpur Lodhi only seventeen miles (29 kilometers from Kapurthala). The Vande Bharat visitors will enjoy the tourism of Punjab. Amritsar is well linked to the world by air, train and road. There are plenty of star category and low budget hotels in Amritsar. During the past half a decade, Amritsar has attracted dozens of star category hotels, including some five-star ones, more were coming up, when Covid - 19 lockdown crippled everything. Punjab welcomes Vande Bharat tourists with open arms.

# Model that predicted the last 25 of 27 Presidential Elections correctly has Trump Winning by 362 Electoral Votes

**S**tony Brook Professor Helmut Norpeth is doubling down on his "Primary Model," which has correctly predicted 5 out of the past 6 elections since 1996 and every single election but two in the past 108 years.

"The primary model gives Trump a 91 per cent chance of winning in November," Norpeth said. "This model gets it right for 25 of the 27 elections since 1912, when primaries were introduced."

The two elections the model failed to predict were the 1960 election of John F. Kennedy and the 2000 election of George W. Bush.

We are still seven weeks out from the election, but if all you did was look at the polls, you might be discouraged about the chances of reelection for President Trump. Most of the polls have him behind Biden and not looking good. But of course as we know, polls are not particularly accurate and 2016 is a perfect example of that, especially when many seem to be slanted or often agenda-driven. Most of these polls are sponsored by the mainstream media that puts out fake news.


It is hard to know how the pandemic, not to mention the riots and chaos being propagated by the radical left,

are going to affect the election. If you blame the party in power, that might adversely affect Trump and that is what the polls may be showing. But if you see that he is far better to bring the economy back and is already doing that, if you see that voting for Biden and Democrats would open the door for even greater destruction and chaos from the radical left, then it would seem that that should push those in the middle toward Trump. I personally know folks in the middle or who were liberals who could not stand Trump but now not only will be voting for him but pushing for him. Because they are so outraged at what has been happening on both those fronts and the Democratic reaction to it all. WILL THAT "SILENT MAJORITY" be speaking in November for Trump?

In May, Stony Brook professor Helmut Norpeth said his model was predicting that Trump would win. Now he is doubling down on the prediction, even after the pandemic and riots.

Norpeth's model is based upon performance in presidential primaries and that enthusiasm or the lack thereof as the strongest indicator of the ultimate outcome. If in fact that is the measure, then there is no question that Trump trounced Biden big time in terms of enthusiasm. Trump has had record turnout of folks in the primaries even when he was the guaranteed winner. Biden in the early primaries had real trouble until South Carolina and is still objectionable than Bernie Sanders, albeit not by much. It would be really hard to say that anyone is enthusiastic about Biden.

What favors Trump in 2020 as well as the cycle of



presidential elections operating for nearly 200 years, as illustrated by the snapshots since 1960. After one term in the White House the incumbent party is favored to win reelection unlike the situation when it has held office for two or more terms.

Norpeth's model predicted Trump's victory nine months before the election in 2016 and he predicts Trump will win by an even wider margin than he did then, 362 electoral votes versus 304 he had then. If you thought they cried then, just wait if that happens in November, the meltdowns are going to be historic.

# Not the Third World War but the Nobel Peace Prize

**D**uring the closing month leading the nation to the polls to elect the 45th President of the U.S.A., in October 2016, it wasn't just the presidential candidate Hillary Clinton but, there were other Democrats also who were pointing to the threatening language of Donald Trump to prove that he was not up to the Chief Commander's responsibilities, using it as an electioneering strategy to defeat him. It did not work.

# Communal peace is a pre-requisite for progress

**E**xperience in the post-Independence period has demonstrated that, other things being equal, meaningful growth and development is achieved when there is political stability and public order is maintained in the country. Domestic entrepreneurs and foreign companies shall make investments and be able to function profitably only if peace and normalcy prevail. For securing such an environment, it is imperative that the governance apparatus works with speed and efficiency, law and order is maintained, corruption is controlled and the well-being and safety of all our people is safeguarded. Also, as was the case in the Delhi incidents, such occurrences create an irreparable divide among people of different religions who had been living happily together, in the same clusters and colonies, for decades past. Sadly, the communal virus, once it gets into the societal bloodstream, is extremely difficult to eradicate.

It is singularly unfortunate that efforts have also been made to inject the cancer of discord and divisiveness in educational institutions. In the recent past, two universities in the Capital witnessed unprecedented violence, besides irreparable disruption of academic schedules. Instead of providing the best opportunities to the student community and tapping India's youthful demographic profile to achieve rapid economic gains, efforts are being made to misdirect the youth for electoral advantages.

The numerous and far spread communities which comprise our vast population represent religious, linguistic and cultural differences that make India a land of unbounded diversities. These differences were sensitively recognized by the founding fathers of our Constitution when they set out the rights and privileges of citizens and the Directive Principles of State Policy. In their public speeches and statements, political leaders invariably refer to the several thousand years of our country's civilizational past and express rightful pride in pointing to the enormous strength we draw from our 'unity in diversity'. However, it appears that, as a people, our sensitivities to the manifold diversities in our society have been getting progressively dimmed. This erosion is due to certain political parties creating divisiveness among the castes and religions of our people to secure electoral gains.

our traditional forbearance of the differences in race, religion, language and culture.

Today, we have Mizo, Naga and Manipuri youth working in the mountains of J&K and in the deserts of Rajasthan, and Punjabis and Haryanvis working in Kerala and the Andamans. This is a most welcome development as it helps to promote cultural integration. It is our duty to educate our children about the background and cultures of the people they have never seen before. They must learn to respect not only their religions, cultures and languages, but also the eating habits, clothing styles and even the hair-cut patterns of the many new faces we are getting to see and meet every day.

Our polity must recognize the dangers which lie ahead if the faults in the functioning of the governance apparatus are not remedied soon. Taking stock of the existing failures and the arising challenges, the executive and the legislature must urgently commence discharging their true constitutional roles. And the judiciary should not wait anymore to fully regain its supreme responsibility to defend, protect and fearlessly enforce the Constitution. The very long pending electoral reforms, which are required to remedy the many ills from which our democratic framework is suffering, must be implemented with the highest priority. Side by side, the polity must accept the need for self-purification, a thorough cleaning up of the entire administrative machinery and reforming the functioning of the multitudinous minions of the state.

It shall require enormous political will and unflinching determination to carry through the required reforms, without which we cannot deliver satisfactory governance to the people of India. One hopes that our polity will muster courage and pick up the gauntlet.

**W**ith over 51 lakh cases and around 84,000 deaths so far, India is bearing the brunt of the novel coronavirus. The much-awaited Covid peak seems nowhere in sight, while herd immunity is also a distant dream. No wonder the country is desperate to have a potent vaccine at the earliest. The tie-up between Russian Direct Investment Fund and Indian pharma giant Dr Reddy's Laboratories to conduct Phase 3 trials of the Sputnik V vaccine has raised hopes that, if all goes well, the all-important shot will be available in India later this year. Subject to successful trials and the Indian drug

regulator's approval, 10 crore doses will be supplied. Phase 1 and Phase 2 clinical trials of Sputnik V have demonstrated 'no serious adverse effects and a stable immune response in participants', according to a research paper published earlier this month in *The Lancet*. However, these two phases had just 70-odd participants - too small a sample size to arrive at definitive conclusions. It's the result of Phase 3, in which thousands of people are involved to ascertain the efficacy and safety of the vaccine over a period of a few months, that

matters the most.

After the Indian Council of Medical Research caused a stir by setting an improbable deadline (August 15) for an indigenous vaccine, the government is understandably wary of jumping the gun. Union Health Minister Harsh Vardhan said in Rajya Sabha on Thursday that the coronavirus vaccine will be made available in the country by the start of next year. India is the manufacturing partner of Covishield, a vaccine candidate developed jointly by the University of Oxford's Jenner

Institute and AstraZeneca. British-Swedish pharma major AstraZeneca had to suspend global trials recently after a participant in the UK showed a serious side-effect. However, Oxford has stated that the trial illnesses may not be due to the vaccine shot, even as trials have resumed in Britain, Brazil and South Africa. Under the circumstances, the Russian vaccine could be India's best bet to save millions of lives, provided the notorious Indian red tape is not allowed to impede the process.

# Can the United States Renegue on the Payment Due to the WHO?

**COVID-19 came from Wuhan in China in late December 2019. It is widely believed that China is responsible for the creation and spread of Coronavirus which has snuffed out 197 K lives in the US, ad 942K lives worldwide (as on September 16). The Virus has shaken the world economies, including America's. President Trump has accused WHO of not warning member states of a public health crisis in time and delaying the information to help China cover-up its misconduct. - EDITOR**

POTUS has accused WHO's Director-General Dr. Tedros Adhanom Ghebreyesus ("Dr. Tedros") of being ethically compromised, or worse, and "China-centric" in his performance - such that the early alarm system that the WHO is responsible to trigger to warn member states' leaders of a public health crisis was not "rung" timely, but delayed to help China cover-up its misconduct - and promised, as a punishment, to withhold Dues-payment to the WHO. The United States is the single largest member state-contributor to WHO's budget, be it assessed or voluntary "dues." Even, as the Bill and Melinda Gates Foundation is the largest private donor.

The short answer is "yes." The long answer is "yes; but, it will cause consternation."

In violation of Truth in Labeling laws and WHO's unethical behavior, China has successfully mis-labeled the "Wuhan Virus" aka the "China Virus" into a neutered "Coronavirus" or "Covid-19" - unlike a century ago, when it was the Spanish Influenza, so-named as it originated in Spain. Today, China admits - a point of sharp dispute - that it came from the Wuhan Wet Market on or about December 30, 2019, even as nobody doubts that "Wuhan" is in China. Many believe it escaped due to poor protocols from the Virology Lab in Wuhan prior to December 2019, as Patient Zero was admitted on December 1, 2019 in Wuhan hospital. The protein make-up of the virus taken from Patient Zero is different than the ones identified by China as coming out of the Wet Market and given to WHO and others in mid-January 2020. For greater detail, see my Open Letter to POTUS, dated April 14, 2020. China has to-date not turned over Patient Zero's genome, which is different than the one they did turn over in late January 2020.

President Trump was infuriated with WHO for having failed to sound the alarm on or about December 1, 2019 and thereby caused so many Americans to get sick or die - when they didn't have to but for the WHO's complicity in covering up China's mis-deeds. The early and timely alarm is the primary reason for WHO's existence, and had it performed properly, all nations' leaders would have timely shut down their borders and blocked Chinese visitors in December 2019 to limit the infection. Trump acted rightfully, as every homeowner would, in refusing to pay the Home Alarm company after a group of intruders came into the house illegally and no alarm went off causing great loss to life, limb and property.

So, let us look at WHO: it has a governing body - World Health Assembly ("WHA") - which meets annually in Geneva, composed of its 194 member states. It has an Executive Board, that effectuates the mandates of the WHA. The WHA appoints the Director General of the WHO, currently, the embattled Dr. Tedros. A look at the binding Ethical Principles of the WHO underpins President Trump's frustration and desire to punish China, the place of origin of the virus, as well as all aiders and abettors, none more important that Dr. Tedros who refused to sound the alarm timely in December 2019 and who to-date has not secured Patient Zero's genome - even as vaccines are being developed - based upon the genome of the virus that was subsequently released by China as a "cloaking device" - to cloak the virus Patient Zero was infected with.

## "WHO is firmly committed to the following ethical principles:

**INTEGRITY:** To behave in accordance with ethical principles, and act in good faith, intellectual honesty and fairness.

**INDEPENDENCE AND IMPARTIALITY:** To conduct oneself with the interests of WHO only in view and under the sole authority of the Director-General, and to ensure that personal views and convictions do not compromise ethical principles, official duties or the interests of WHO.

**RESPECT:** To respect the dignity, worth, equality, diversity and privacy of all persons.

**PROFESSIONAL COMMITMENT:** To demonstrate a high level of professionalism and loyalty to the Organization, its mandate and objectives."

Well, a calm reading and the WHO and its DG Dr. Tedros would stand charged for violating these binding ethical codes: for he lacks "integrity," "accountability," Independence and Impartiality" of a fiduciary, "Respect" of all those who needlessly got sick or died because he wouldn't sound the alarm timely, and "Professional Commitment."

That the world - people and governments - need a world health organization is obvious. This one has failed, and failed shamelessly by embracing Corruption instead of Honor. I have proposed that it be replaced and the UN Charter be amended. A new "UN Security Council" be created in place and stead of the Trusteeship Council, called the "UN Pandemic Council," and it have 12 Permanent Members, and either 9 or 13 Rotating Members. It would have Responsibility to Protect ("R2P") jurisdiction, and it can also have OPCW jurisdiction for chemical warfare, as Wuhan Virus is biowarfare, and each can create a global public health crisis. The P12's Veto power would not be individualized, but require a group of 4-member states. Humanity has embedded its Hope into the United Nations - which celebrates its 75th year for its many achievements, including, the Cuban Missile crisis and no WW III. We need to strengthen multilateralism, so humanity is better served by governments - as Abraham Lincoln at Gettysburg told us we must.

That America has suffered so much - even the dastardly attack on Pearl Harbor killed less than 2400 American. # India should consider withdrawing from the United Nations

**2020** is the 75th birthday of the U.N., founded in 1945 by the victors of World War II. The victors, U.S.A., France, U.K., Republic of China, and the Soviet Union automatically made themselves permanent members of the Security Council with a veto power. Just compare the maps of 1945 and 2020. The geopolitics of 1945 is totally obsolete today. The present U.N. does not represent the realities of the geopolitics of today. The Security Council is the most unrepresentative and undemocratic organization.

The Charter of the U.N. begins with the sentence: "WE, THE PEOPLE OF THE WORLD...."

Therefore, it is only logical that the Security Council should represent the PEOPLE OF THE WORLD.

The world has a population of 7.8 billion. Out of this, the Security Council does not represent 5.81 billion. A minority of 1.99 billion (25%) is represented: China 1.39 billion (20%); USA 330 million; Russia 144 million; UK 65 million; France 67 million. Thus 75% of the world population is not represented. If India is admitted two thirds of the world would be represented. **THUS, THE SECURITY COUNCIL IS THE MOST UNDEMOCRATIC ORGANIZATION, AS OF NOW.**

Today, the U.K. and France have each a population of approximately 65 million, representing 1/10th of India's population. Both are from Western Europe. Why should two countries represent Western Europe with a population of 300 million? Furthermore, in 1945 the colonial powers of the U.K. and France represented many colonies in Asia, Africa and other parts of the world. Without amending the charter, both the U.K. and France were allowed to continue as permanent members of the Security Council when they stopped representing former colonies representing large population.

The Peoples Republic of China was established in 1949. The victor, Mao-Tso-Tung defeated Chiang-Ki-Sheik, head of the Republic of China, who took refuge in the island of Formosa, now known as Taiwan.

Although the People's Republic of China represented the largest population of any country in the world, it was excluded by the U.N. It is a political joke that Taiwan, representing less than 10 million people was allowed to continue as member of the Security Council for almost 30 years without amending the Charter. The Soviet Union represented several Eastern European and Central Asian countries in 1945. After the Cold War ended in 1989, the Soviet Union was disintegrated resulting in many countries winning their own

independence. Thus, the remaining Russia with 140 million people was allowed to continue as a permanent member of the Security Council without amending the Charter.

India has been an outstanding leader and contributed maximum during the formative years of the U.N. from 1945 to 1965. India's record of performance in the General Assembly, the Trusteeship Council and the Economic & Social Council is most outstanding.

### **INDIA'S MAJOR CONTRIBUTIONS TO THE U.N.**

1. The Trusteeship Council was entrusted with the responsibility of decolonization of former Trust territories and colonies. India's chief delegate, V. K. Krishna Menon's speech on Decolonization was published in two full pages by the NEW YORK TIMES in 1946 (See the internet). Krishna Menon represented the Interim Government of India. He was the Chairman of the Indian Delegation till 1962.
2. KOREAN WAR: Krishna Menon's formula was applied and Armistice was signed. President Eisenhower praised India's leadership in bringing the Korean war to an end.
3. SUEZ CRISIS: Krishna Menon negotiated with Egypt, U.K. and France in solving the Suez Canal crisis resulting from Egypt nationalizing Suez Canal. Here again, President Eisenhower credited Indian leadership.
4. France did not want to give up its colonies - Tunisia, Algeria, and Morocco and walked out of the U.N. Krishna Menon negotiated and brought them back resulting in decolonization.
5. Krishna Menon championed the decolonization of colonies in Africa, Asia and elsewhere and succeeded in obtaining independence for the colonies.
6. Krishna Menon spoke on behalf of the Peoples Republic of China to correct its misrepresentation by Taiwan.
7. Just like the Security Council, the Western powers wanted to create a new international Atomic Energy Agency, a private club of nuclear powers then. Krishna Menon challenged this concept and negotiated hard resulting in the new International Atomic Energy Agency of all members of the UN.
8. Krishna Menon was responsible to admit 16 new members in 1956 as a package deal.
9. India was an active member of the Capital Development Committee that created U.N.D.P. Similarly, India was very active in creating almost all Specialized Agencies including the World Bank, IMF, WHO, UNICEF, UNESCO, ITU, ICAO, ILO, UNCTAD, FAO, WMO, and others. Indian diplomats participated very actively in preparatory committees.
10. 11 American fliers were shot down by Communist China during the Korean War. Krishna Menon went to China to negotiate release of these prisoners. President Eisenhower invited Krishna Menon to the oval office to thank him personally.
11. India was the first member to contribute to Peace Keeping Force. India continued to contribute substantial peace keeping force in the Middle East, Africa, and Asia. General Inderjit Rikhi served as Military Adviser to the Secretary General.

Any serious scholar of the U.N. or any active U.N. diplomat should be able to recognize the major contributions of V.K. Krishna Menon, Defence Minister of India. American and international media has covered India's contributions.

### **INDIA CANNOT BE ADMITTED AS A PERMANENT MEMBER WITHOUT AMENDING THE CHARTER IS A POLITICAL JOKE!**

We know the Security Council, without amending the Charter has admitted Russian Federation by political agreement. Similarly, after decolonization of former colonial countries, the U.K. and France were allowed to continue as members representing the same region (Western Europe) and a population of 130 million people. Therefore, India should not

accept the flimsy argument that India cannot be admitted without amending the Charter.

**U.S.A., U.K., FRANCE, AND RUSSIA HAVE OFFICIALY AND PUBLICLY SUPPORTED THE ADMISSION OF INDIA AS A PERMANENT MEMBER. INDIA IS YET TO CAPITALIZE THIS UNITED SUPPORT**

India received 184 votes in the UN General Assembly this year in favor of admitting India as a temporary member. Based on this strength, India should try to get a resolution approved by two thirds of the majority of the U.N. General Assembly to admit India as a permanent member based on the support of four members of the U.N. Security Council and major contributions of India to the U.N. India must take the initiative to achieve this. So far, Indian diplomats unfortunately have left it to China to postpone or not decide. It is time India capitalizes on the united support of 4 permanent Security Council members.

India should not be surrendering to China even at the U.N. India should not and cannot accept the status quo after 75 years of the U.N. It is not up to China to decide the rights of 1.3 billion people of India.

### **AGGRESSIVE INDIAN DIPLOMACY REQUIRED**

Apparently, the Indian diplomacy succeeded in enlisting the support of 184 out of 193 members of the General Assembly for temporary membership. Aggressive Indian diplomacy should be employed at all capitals of the world seeking support for admission as a permanent member of the Council. Once India has a resolution approved by two thirds of the U.N. General Assembly, then it is easier for the US, UK, France, and Russia to pressure China not to veto admission of India. American diplomacy has succeeded in getting cooperation of China before sanctions against North Korea resolution was adopted. India must continue to use diplomacy and pressure on the USA, UK, France, and Russia for admission of India as a permanent member.

Before India is admitted, India should not be wasting its time in discussing the admission of the enemies of World War II, Germany and Japan.

Unlike his predecessors, Prime Minister Modi should even consider withdrawing from the U.N. if India is not admitted as a Permanent Member with a Veto power. The honor of India and its 1.3 billion people is at stake.

# India targets U.S. Christian leaders for deportation?

**I**ndia's future is intrinsically linked with the Non-Resident Indians' (NRIs) population. NRIs have a history with India's independence struggle. Some of India's great leaders, like Gandhi and Nehru, and many others have come from the NRI ranks. We are also profoundly grateful for the Gadar movement's sacrifices that gave a huge impetus to the freedom struggle. India is a country with one of the largest Diasporas that not only connects with the Indian motherland but also enriches it through foreign currency remittances and technology transfers.

However, at the end of the day, the NRIs are primarily economic refugees searching for a better life and opportunities. Although the popular notion is that the World requires our expertise, I still believe we need the World more than they need us. The NRIs provide a visible face for India that has garnered more attention and respect for the Indian culture and traditions worldwide. In Western Countries, India's soft power is displayed every day, whether it is the cuisine, yoga, or various philosophies that have roots in the ancient land. The country is more appreciated for its diversity and coexistence, while people like Gandhi are celebrated icons of such ideas in the West.

We, as Indians, also demand freedom and opportunities wherever we go. One of our top priorities has been to build places of worship and exercise that freedom without any prejudice or hindrance. We are also quick to react to anyone who denigrates our religious symbols and demand an apology and often restitution. We invite scores of our religious leaders from India for temporary visits and others on religious visas on a long-term basis. Even in diplomatic postings, we are placing religious scholars to familiarize our faith with the western folks who have shown some level of curiosity. It is also known that large sums of money are collected and sent to India from NRIs and other generous Americans attracted to some of these famous religious personalities.

However, it appears that what is good for the goose is not so for the gander. While we demand our way around, American Christian leaders are being deported directly from India's airports just because they are Christians. Several months ago, nine leaders from the New York Council of Christian churches headed by Rev. Peter Cook, who traveled to India with valid visas, were denied entry at the Chennai airport in a shocking display of bad faith. And after subjugating them to a grueling 12-hour questioning, they were deported back to the United States. 'The team was there to

meet some people and learn,' said Rev. Cook, who is also the Executive Director of the New York State Council of Churches. They were even denied the basic courtesy of making a phone call to their would-be hosts. According to one of the team members, the chief of the immigration at the airport went as far as to pronounce, 'we don't want Christians to come here!'

The ill-treatment of the Christian leadership by the officials is not just limited to American Christians but includes leaders from other countries as well. Considering that India, which has 30 million of its citizens living abroad and more at home are looking for opportunities around the World, what the Modi government has done to a Spanish Nun who lived in India for five decades and serving the poor is deeply shameful. Sister Emedina, 86 years old, a member of the Daughters of Charity, was denied the renewal of her visa and was told by the Government that she had ten days to leave the country. She flew August 20, 2019, from New Delhi to Spain. This shocking behavior is from a country that grumbles when America reduces the number of H-1B visas!

**T**he case of Pastor Bryan Nerren was highlighted by President Trump recently as one of his successful interventions to get American citizens held by foreign countries. It is a case of not only deportation but also arrest and confiscation of Nerren's funds and travel documents. Senator Alexander and Senator Blackburn of Tennessee have worked hard on this case as well. Let me quote from a letter sent earlier by a multi-faith group to President Trump, highlighting the plight of this American Pastor that shows Religious persecution is not restricted to Indian citizens only. "In October 2019, police arrested U.S. Pastor Bryan Nerren in Bagdogra airport in India. The police arrested him on the grounds of failing to declare funds, this followed after the officers in New Delhi interrogated him, asking him if he was Christian and if the money was for Christians or Hindus,

they cleared him at the airport in New Delhi only to have him re-arrested in Bagdogra. The Pastor was compliant and said he would fill out the customs form and pay the penalties if any, but was instead arrested, with the authorities confiscating Pastor's funds and the passport. The boldness of the authorities' arrest and discrimination of a U.S. national because of his faith - shows that actors of religious persecution in India, afforded government impunity, further embolden state and non-state extremists to continue their discriminatory and abusive actions towards non-Hindus".

John Prabhudoss, the Chairman of the Federation of Indian Christian Associations of North America, was a victim himself of deportation despite having a valid visa on the grounds that he had visited Kandhamal, Orissa, where Hindutva extremists staged the anti-Christian riots. Those riots resulted in the deaths of hundreds, including a Catholic Priest and the raping of a Nun in broad daylight. Thousands of homes of Christians were destroyed by rioters. Four others who visited the Kandhamal area Mr. John Hutcheson, an associate of Green Tree Global based in North Carolina, Ms. Virginia Farris, a former U.S. Diplomat and the current Foreign Policy Advisor to the U.S. Catholic Bishops Conference, along with Ms. Erin Weston and Ms. Valerie Payne officials of Jubilee Campaign USA, were also put on the blacklist by the Indian Government. Deportation of Mr. Prabhudoss on his subsequent visit to India, though he is of Indian origin, is a prime example of selective punishment for a Christian immigrant to the USA who is unjustifiably denied entry to his motherland just because he empathized with the plight of the fellow Christians.

First volume of Barack Obama's memoir "A Promised Land" coming on November 17



**NEW YORK (TIP):** The first volume of former President Barack Obama's memoir is coming out November 17, two weeks after Election Day. It's called "A Promised Land" and will cover his swift and historic rise to the White House and his first term in office.

The publication date for the second volume has not yet been determined.

"I've spent the last few years reflecting on my presidency, and in 'A Promised Land' I've tried to provide an honest accounting of my presidential campaign and my time in office: the key events and people who shaped it; my take on what I got right and the mistakes I made; and the political, economic, and cultural forces that my team and I had to confront then - and that as a nation we are grappling with still," Obama said in a statement Thursday.

"In the book, I've also tried to give readers a sense of the personal journey that Michelle and I went through during those years, with all the incredible highs and lows. And finally, at a time when America is going through such enormous upheaval, the book offers some of my broader thoughts on how we can heal the divisions in our country going forward and make our democracy work for everybody - a task that won't depend on any single president, but on all of us as engaged citizens." Obama's book, like his previous ones, will be released by Crown. The 768-page book is the most anticipated presidential memoir in memory, as much or more because of the quality of the writing than for any possible revelations.

He has been called the most literary president since Abraham Lincoln and has already written two highly praised, million-selling books: "Dreams from My Father" and "The Audacity of Hope," both of which have been cited as aiding his presidential run in 2008 and making him the country's first Black president.

Even with a substantial list price of USD 45, "The Promised Land" is virtually guaranteed to sell millions of copies. But it will face challenges far different from most presidential memoirs, and even from former first lady Michelle Obama's blockbuster book, "Becoming," which came out two years ago. Because of the pandemic, the former president will likely be unable to have the spectacular arena tour that Michelle Obama had.

Barack Obama also may find his book coming out at a time when the November 3 election is still undecided and the country is far more preoccupied with who the next president will be than with events of the past. (Agencies)

# Biden says he trusts vaccines and scientists, not Trump

**WILMINGTON (TIP):** Joe Biden has said while he trusts what scientists said about a potential coronavirus vaccine, he doesn't trust US President Donald Trump.

His comments come as the debate over a vaccine - how it will be evaluated and distributed when it's ready - has taken center stage in the presidential race with seven weeks to go until the November election.


Trump and Biden have been trading accusations that the other is undermining public trust in a potential coronavirus vaccine. Biden has expressed concerns that the vaccine approval process could be politicized while Trump and his allies counter that such comments from Biden and other Democrats are turning off the public to a potentially lifesaving vaccine when it's released.

Biden, speaking in Wilmington, Delaware, after being briefed by public health experts about a potential vaccine, cited Trump's "incompetence and dishonesty" surrounding the distribution of personal protective equipment and coronavirus testing.

"The US can't afford to repeat those fiascos when it comes to a vaccine," he said.

"I trust vaccines, I trust scientists, but I don't trust Donald Trump," Biden said, adding: "And at this moment, the American people can't, either."

On Wednesday, September 16 evening, Trump raised new questions about the administration's rollout of a vaccine when he publicly contradicted

the director of the Centers for Disease Control and Prevention, who said at a congressional hearing earlier Wednesday that a vaccine wouldn't be broadly available to most Americans until the summer of 2021.

Trump said CDC Director Robert Redfield had misspoken and that the US could start distributing a vaccine starting in mid-October.

"I think he made a mistake when he said that. I think it's just incorrect information," Trump said of Redfield's comments. "When he said it, I believe he was confused." He said he called Redfield after his testimony. "I think he

just made a mistake. He just made a mistake. I think he misunderstood the question, probably."

For his part, Biden has said he would take a vaccine "tomorrow" if it were available but that he would want to "see what the scientists said first".

His running mate, Kamala Harris, has said she wouldn't trust Trump to be honest about the safety of any potential vaccine and worries that experts and scientists would be "muzzled" by the president because he's so eager to get a vaccine approved by his stated goal of Election Day. (Agencies)

## Trump will not attend UN General Assembly

**WASHINGTON (TIP):** U.S. President Donald Trump will not attend next week's UN General Assembly gathering in person, his chief of staff told journalists aboard Air Force One Thursday, September 17, according to a pool report.

The decision marks an about-face for Mr. Trump, who last month said he wanted to deliver his speech in the General Assembly hall in New York, even if other world leaders are staying away due to the coronavirus pandemic.

White House Chief of Staff Mark Meadows ended the debate once and for all, telling reporters en route to Wisconsin, where Mr. Trump was to hold a campaign rally, that he would not physically attend the General Assembly's 75th session, which will take place mainly by videoconference due to the health crisis.

The main part of this year's UNGA, when world leaders take turns to give speeches, runs through the week starting September 21 and ends on September 29.

In opening remarks Tuesday, Secretary-General Antonio Guterres emphasized this year's focus on the global response to the coronavirus pandemic plus "peace and security, disarmament, human rights, gender equality and sustainable development." (Agencies)

## US envoy leading second recent high-level visit to Taiwan

**TAIPEI / NEW YORK (TIP):** A senior US State Department official arrived in Taiwan on Thursday, September 17 afternoon to begin a three-day visit that has already drawn a

warning from China. US Undersecretary of State Keith Krach is due to meet Taiwan's President Tsai Ing-wen and other senior officials, the island's foreign ministry said Thursday, September 17. Krach is the highest-level official from the State Department to visit the island in decades.

His visit follows the high-profile visit in August of US Health Secretary Alex Azar, who was the highest-level US Cabinet official to visit since a break in formal ties between the US and Taiwanese government in 1979, when the US accepted the "one-China policy" with Beijing as its government. However, the US has maintained unofficial ties with Taiwan since the official diplomatic break and is the island's most important ally and provider of defense equipment.

# US law firm files class action suit against HDFC Bank for misleading claims

**NEW YORK (TIP):** As per the suit, bank officials "engaged in a plan, scheme, conspiracy and course of conduct, pursuant to which they knowingly or recklessly engaged in acts, transactions, practices and courses of business which operated as a fraud and deceit", resulting in the losses to investors.

A law firm in the US has filed a class action suit against HDFC Bank, claiming damages for the losses incurred by investors because of "materially false and misleading" representations made by India's largest private sector lender.

The suit by Rosen Legal specifically names the bank's managing director and chief executive Aditya Puri, his chosen successor Sashidhar Jagdishan and company secretary Santosh Haldnakar, who are the defendants in the suit, as per a copy of the complaint uploaded on the website.

The complaint did not mention the exact quantum of the damages sought, though it maintained that may be thousands of investors would have suffered. HDFC Bank could not be immediately reached for comment.

As per the suit, bank officials "engaged in a plan, scheme, conspiracy and course of conduct, pursuant to which they knowingly or recklessly engaged in acts, transactions, practices and courses of business which operated as a fraud and deceit", resulting in the losses to investors. The allegations pertain to the vehicle finance vertical, where the bank later acknowledged to have

found some improprieties which resulted in some executives being acted against.

The bank had inadequate disclosure controls and procedures and internal control over financial reporting, maintained improper lending practices in the vehicle financing making the operations unsustainable and all this was likely to have a materially negative impact on its financial condition and reputation, it alleged.

"The bank's public statements were materially false and misleading at all relevant times," the suit claims.

The defendants "knew that the adverse facts" had not been disclosed and were being "concealed from the public", it said, adding "the positive representations being made were then materially false and misleading. The individual defendants are liable for the false statements and omissions pleaded herein".

The period during which the losses are alleged to have happened to the investors is between July 31, 2019 and July 10, 2020 which is referred to as the "class period".

"Throughout the class period, defendants made materially false and misleading statements regarding the bank's business, operational and compliance policies," it alleged.

After the initiation of probe by the law firm, the bank had termed the move as a "frivolous" one and asserted that it has been transparent in all its disclosures.

According to reports, the bank used to bundle vehicle tracking devices along with auto loans sold by it, resulting in an additional cost to the borrower, and also concerns over privacy.

There was speculation over the circumstances under which its head of the unit left the office, but the bank later clarified that it was a scheduled retirement.

The HDFC Bank American Depository Receipt was trading 0.81% down at \$50.05 at 2115 hours IST on the NYSE. The scrip shed 0.94% to close at ?1,083.25 apiece on the BSE earlier in the day. (Source: PTI)

## US charges 5 Chinese hackers, Indian Govt network affected too

**WASHINGTON (TIP):** The US Justice Department has charged five Chinese citizens with hacking over 100 companies and institutions in the US and abroad, including Indian Government networks, and stealing valuable software data and business intelligence.

Deputy US Attorney General Jeffrey Rosen on Wednesday announced three indictments had been unsealed in the matter that collectively charge five Chinese nationals with computer hacking and charge two Malaysian nationals for helping some of those hackers.

The Malaysian nationals were arrested on Sunday and the Chinese nationals have been declared fugitive, according to a Justice Department statement. Rosen severely criticized the Chinese Government.

"The Department of Justice has used every tool available to disrupt the illegal computer intrusions and cyberattacks by these Chinese citizens. Regrettably, the Chinese Communist Party has chosen a different path - to make China safe for cyber criminals so long as they attack computers outside China and steal intellectual property helpful to Beijing," the Deputy Attorney General said.

In 2019, conspirators compromised Government of India websites as well as virtual private networks and database servers supporting the Government of India. (Source: PTI)

## Shooting outside Wisconsin senior apartments leaves 4 hurt

**MAYVILLE, WIS (TIP):** A shooting outside a senior living apartment complex in a small Wisconsin town left four people wounded, including the suspected shooter, law enforcement said Thursday, September 17.

Life saving measures were performed at the scene after the shooting Wednesday evening in Mayville, and all four were taken by air to trauma centers, the Wisconsin Department of Justice said.

Spring Glen Apartments matches the location of the shooting provided by the Dodge County Sheriff's Office. Authorities have not said if any residents of the senior living complex were involved or hurt in the attack.

A message left at a possible number for the apartment building wasn't immediately returned Thursday.

Mayville is a town of 5,000 people about 80 kilometers northwest of Milwaukee. Mayor Rob Boelk did not immediately respond to an Associated Press call for comment Thursday, but he told the Fond du Lac Reporter that the suspected shooter is in critical condition.

It has been a "troubling and disturbing night," Boelk said.

Mayville Common Council member Dale Tollner said his ward includes the apartment building. He said no one has told him anything about the shootings. He said the building sits across the street from a McDonald's and a family-style restaurant.

He described the area as "small-town, not rough at all." The DOJ's Division of Criminal Investigation and Mayville police are leading the investigation with help from the sheriff's office, the State Patrol, and police departments in Horicon, Lomira and Theresa.

Mayville police referred questions to the DOJ. DOJ spokeswoman Gillian Drummond said she could offer no additional details. (Agencies)

## Dubai suspends AI flights for 15 days for flying covid patients twice

Air India Express flights to Dubai airports have been temporarily suspended for 15 days, starting from September 18 until October 3, for allegedly ferrying coronavirus positive patients to Dubai twice during the last couple of weeks. Air India Express has also been penalised to bear all medical and quarantine expenditures of the coronavirus patients who had been ferried to Dubai.

Dubai Civil Aviation Authority has stopped Air India Express from flying to Dubai for 15 days, starting today, alleging that two coronavirus positive passengers flew on board the flights to Dubai on two separate occasions despite having Covid-19 positive test reports.

As per the UAE government rules, each passenger travelling from India needs to bring original coronavirus-negative certificate from RT-PCR test done 96 hours prior to the journey.

## NCB unearths Bollywood drug trail

The Narcotics Control Bureau (NCB), Mumbai team led by Zonal Director Sameer Wankhede has detained one Rahil Vishram with 1 kg charas (cannabis). NCB also seized Rs 4.5 lakh cash from Rahil Vishram's residence. According to the NCB, Rahil Vishram is directly connected to other peddlers who have been named in the Sushant Singh Rajput death case.

Rahil Vishram was detained following an operation that was carried out on Thursday and went on till Friday morning. Rahil Vishram is said to be a leading dug supplier Bollywood.

Zonal Director Sameer Wankhede and his team, investigating the case related to Rhea Chakraborty and others, found details of Rahil Vishram who is connected directly to the network, and conducted a raid and search at his residence in Versova, Mumbai.

The NCB team has seized high-quality Hashish (cannabis) also known as Malana Cream from Himachal Pradesh. The high-value 1 kg narcotic drug could be worth over Rs 3 to 4 crore. The NCB team has also seized Rs 4.5 lakh cash from Rahil Vishram's residence. During primary interrogation, Rahil has revealed that his boss is associated with the film industry and is one of the biggest suppliers of high-end Malana Cream to Bollywood celebrities. NCB has now launched a manhunt to nab Rahil's boss.

Wankhede and his team are currently following leads provided by Rahil Vishram to nab his boss. Sources have said that Rahil Vishram and his boss's arrest would be a major blow to narcotics operations and drug supply chain in Bollywood.

# India's coronavirus cases rise to 52 lakh with 96,424 new infections

**NEW DELHI (TIP):** India's COVID-19 tally raced past 52 lakh with 96,424 people testing positive in a day while the number of people who have recuperated from the disease rose to 41,12,551 on Friday, according to the Union Health Ministry data.

The total coronavirus cases mounted to 52,14,677 while the death toll climbed to 84,372 with the virus claiming 1,174 lives in a span of 24 hours, the data updated at 8 am on September 18 showed.

The COVID-19 case fatality rate due to the coronavirus infection has further dropped to 1.62 per cent.

There are 10,17,754 active cases of COVID-19 in the country which comprises 19.52 per cent of the total caseload, the data stated.

India's COVID-19 tally had crossed the 20-lakh mark on August 7, 30 lakh on August 23, 40 lakh on September 5 and it went past 50 lakh on September 16.

According to the ICMR, a cumulative total of 6,15,72,343 samples have been tested up to September 17 with 10,06,615 samples being tested on Thursday, September 17.

As of September 18, India has 10,17,754 active coronavirus cases, 41,12,551 'discharged' cases, and the total death toll stood at 84,372. India has recorded 52,14,678 coronavirus cases so far. The coronavirus recovery rate in the country stood at 78.64 per cent along with a case fatality rate (CFR) of 1.63 per cent, the data provided by the Union Ministry of Health shows.

The five most affected states have reported 60 per cent of the active Coronavirus cases. However, there are 13 states and UTs that have reported less than 5000 active cases, according to the Ministry of Health and Family Welfare.



The Central government stated that it is proactively supporting high caseload States/UTs. Several Central teams have been deputed for providing support. Capacities of ICU doctors have been built up through teleconsultation by AIIMS, New Delhi and active steps are being taken to ensure adequate Medical Oxygen in health facilities.

In the last 24 hours (Sept 17 and 18), Maharashtra reported 24,619 coronavirus cases, Karnataka 9,366, Tamil Nadu 5,560, Uttar Pradesh 6,029, Delhi 4,432, Mumbai 2,389, West Bengal 4,183, Odisha 4,241, and Madhya Pradesh 2,391. Three states have recorded the highest single-day spike in Coronavirus cases in the last 24 hours. These are Gujarat (1,379), Kerala (4,351), and Chhattisgarh (3,809).

Overall, states with the most number of active coronavirus cases are Maharashtra (2,97,506), Karnataka (1,01,645), Andhra Pradesh (90,279), Uttar

Pradesh (67,002), Tamil Nadu (46,633), Chhattisgarh (37,470), Kerala (32,775), Odisha (32,405), Delhi (30,914), Telengana (30,443), and West Bengal (24,147).

Among the states, Maharashtra (30,883), Tamil Nadu (8,559), Karnataka (7,536), Andhra Pradesh (5,105), Delhi (4,839), Uttar Pradesh (4,690), West Bengal (4,123), and Gujarat (3,256) have reported the maximum number of deaths.

Maharashtra has shown a 7-day average growth of 2.13 per cent, Andhra Pradesh 1.68 per cent, Tamil Nadu 1.13 per cent, Uttar Pradesh 2.13 per cent, and Delhi 1.95 per cent.

India has also been ramping up coronavirus tests. So far, 6,15,72,343 samples have been tested up to September 17 for COVID19. Of these, 10,06,615 samples were tested on September 17, as per details provided by the Indian Council of Medical Research (ICMR).

## Indian lawyer or Queen's Counsel: India invokes Commonwealth to ensure justice to Jadhav



**NEW DELHI (TIP):** After being stuck on the issue of who will represent Kulbhushan Jadhav in the civilian court in Pakistan, India has invoked the Commonwealth grounds to end the debate over the appointment of his counsel. India on Thursday called for the appointment of an Indian lawyer or a Queen's Counsel for the death row prisoner, Kulbhushan Jadhav, so that he receives a fair trial in his death sentence review.

Ministry of External Affairs Spokesperson Anurag Srivastava said the government of Pakistan has not been able to fulfill its obligations on the implementation of the ICJ judgment in letter and spirit.

"The Government of Pakistan has not been able to fulfill its obligations on implementation of the ICJ judgment in letter and spirit," MEA spokesperson Anurag Srivastava said.

"It has not yet addressed the core issues, which includes the provision of

all documents related to the case, providing unconditional and unimpeded consular access to Kulbhushan Jadhav and appointment of an Indian lawyer or a Queen's Counsel to ensure a free and fair trial," he added.

Queen's Counsel is a barrister or advocate, appointed Counsel to the UK Crown on the recommendation of the Lord Chancellor. Queen's counsels are

recognised in almost all courts around the world.

Has India managed to solve two problems with this proposal given that Harish Salve has defended the Kulbhushan Jadhav case on consular for India at the International Court of Justice?

This comes after Pakistan had objected to an Indian defending Kulbhushan Jadhav in Pakistani courts which, according to Pakistan's Attorney General, is not allowed as per their Constitution.

On September 10, during a briefing, Pakistan foreign office spokesperson, Zahid Hafeez, had insisted that they have been adhering to the ruling of the ICJ in letter and spirit.

"India has responded to Pakistan on the matter of Commander Kulbhushan Jadhav, offer for consular access stands and we are working on a reply, last time, too, we gave India an unimpeded uninterrupted consular access," he said.

## PM Modi thanks Trump for birthday wish, says India-US friendship good for humanity

**P**rime Minister Narendra Modi Friday, Sept 18, thanked US President Donald Trump for the birthday wish and said the friendship between India and the US is strong and is a force for good for the entire humanity.

"Thank you @POTUS @realDonaldTrump for your warm wishes. The friendship between our nations is strong and is a force for good for the entire humanity," the Prime Minister tweeted in response to Trump's tweet in which he praised Modi as a "great leader and loyal friend".

"I would like to extend best wishes and a very happy 70th birthday to the Prime Minister of India, @narendramodi. Many happy returns to a GREAT LEADER and loyal friend!" Trump tweeted on Thursday.

Trump also posted a photograph of him and First lady Melania Trump with PM Modi at the 'Namaste Trump' event. The two leaders had their hands raised and clenched before a 125,000-strong crowd who had gathered to welcome the US president on his first India visit at the Motera cricket stadium in Ahmedabad in February this year.

### Pulwama-like attack averted, 52 kg explosives found, says Army

**T**he Indian Army on Thursday, Sept 17, said that it averted a major attack in Jammu and Kashmir by discovering 52 kilograms of explosives, not far from the site of the 2019 Pulwama terror attack.

The Army said in a statement that the explosives were found in a joint search operation launched in the morning in Garikal in Pulwama. "During the search op [operation], a dug-in syntax tank was spotted," Defence Spokesperson Colonel Rajesh Kalia said. "Detailed search led to recovery of 416 packets of explosives, each packet of 125 g [grams] making a total of 52 Kgs, were recovered."

The spokesperson added that the Army also recovered 50 detonators from a second water tank.

"We have averted another Pulwama-type attack," an unidentified Army official told PTI. The official added that the explosives are called "Super-90" or S-90 in short. In February 2019, forty Central Reserve Police Force personnel were killed after an explosive-laden car driven by a suicide bomber rammed into their bus in Pulwama. Last month, the National Investigation Agency had filed a chargesheet in the case. Nineteen people, including Jaish-e-Mohammad chief Masood Azhar and his brother Rauf Asghar, were named in the chargesheet.

## Forces trying to mislead farmers, farm bill will lead to more profits: PM

**N**EW DELHI (TIP): Hailing the passage of three farm sector bills in Lok Sabha, Prime Minister Narendra Modi on Thursday, Sept 17, described these proposed legislations as historic and asserted that they will rid farmers and the farm sector of middlemen and other bottlenecks.

With ruling BJP ally Shiromani Akali Dal joining the opposition in protesting these bills, Modi asserted that many forces are trying to "mislead" farmers and assured the farming community that minimum support price (MSP) and government procurement of their produce will continue along with a lot of other options for them.

These reforms will provide new opportunities to farmers to sell their produce and will lead to increased profits for them, he said.

Modi also urged farmers and those associated with the agriculture sector to listen to Agriculture Minister Narendra Singh Tomar's reply to the discussion on these bills.

"These agriculture reforms will provide new avenues to farmers to sell their produce which will increase their profits. Agriculture sector will benefit from modern technology and our farmers will also be empowered," the prime minister said in a series of tweets.

Many forces are trying to mislead farmers, he added, while assuring them



of the benefits of these reforms.

Lok Sabha on Thursday passed the Farmers Produce Trade and Commerce (Promotion and Facilitation) Bill and the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Bill, 2020, that the NDA government has proposed in Parliament during the ongoing monsoon session, replacing the ordinances issued by it earlier.

It has already passed Essential Commodities (Amendment) Bill.

The three bills will now be tabled in Rajya Sabha and become laws after the Upper House also passes them.

They will replace ordinances promulgated by the Union government.

The two bills were passed by voice vote in Lok Sabha earlier in the evening amid protests by opposition parties with SAD chief Sukhbir Singh Badal also vehemently opposing them, calling these measures as anti-farmers.

The SAD's lone member in the Union Cabinet Harsimrat Kaur Badal quit the government, accusing it of not taking

farmers on board.

### Cong MPs burn copies of farm bills

Congress MPs from Punjab burnt copies of the farm bills proposed by the government inside the Parliament complex on Thursday, Sept 17, even as the party staged a protest in front of Mahatma Gandhi's statue.

The Congress is opposed to the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill, 2020, and the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Bill, 2020, that the NDA government has proposed in Parliament during the ongoing monsoon session, replacing the ordinances issued by it earlier.

Congress MPs Jasbir Singh Gill, Ravneet Singh Bittu, Gurjot Singh Aujla and Amar Singh burnt copies of the bills and said they will oppose the proposed legislations tooth and nail. They also wore black robes, saying "I am a farmer and farm labourer and don't betray me".

"We will oppose these bills from Parliament to panchayats. We also appeal to all MPs to vote against the bills, hearing the inner voice of their conscience for the sake of 'zameer and zameen' (conscience and land)," Gill said.

## China's words and actions don't match, no power can stop patrolling at LAC: Rajnath

**N**EW DELHI (TIP): Underlining that there is a mismatch between what China says and does, Defence Minister Rajnath Singh told Rajya Sabha on Thursday, Sept 17, that India will not back down from taking "any big and tough step" in its interest, and that there will be no change in the "traditional and well-defined" patrolling pattern of Indian soldiers along the Line of Actual Control in Ladakh.

"No power in the world can stop Indian soldiers from patrolling," he said.


Making a statement in the House on the situation in Ladakh, two days after he made a similar statement in Lok Sabha, Singh said the government wants to assure 130 crore people of the country that it will not let India "bow down" its head. At the same time, he said, it does not want to bend anyone else's head.

Citing operational reasons for not giving detailed replies to questions from members, Singh, responding to a query from Congress leader and former Defence Minister AK Antony, said there will be no change in the patrolling pattern of Indian soldiers.

With all Opposition parties backing the government, the Congress, which had been demanding a full-fledged discussion on the issue, did not register any protest.

Singh also agreed to Chairman M Venkaiah Naidu's suggestion that he consider meeting some prominent leaders in his chamber and brief them on the ground situation.

Earlier, the Defence Minister briefed the House on how and when the present crisis began, and the diplomatic and military steps taken by India to resolve the issue.



## Court orders FIR against ex-minister Arun Shourie for Udaipur hotel sale

**N**EW DELHI (TIP): A special CBI court has said that one of the grandest palace-hotels in Rajasthan's Udaipur was sold at a huge loss and former Union Minister Arun Shourie should be charged for it and investigation re-launched in the case, a media report said on Thursday, Sept 17.

According to a NDTV report, the special CBI court wants the case to be reopened and has asked for criminal case against Shourie, former bureaucrat Pradeep Baijal and hotelier Jyotsna Suri.

Hotel Laxmi Vilas Palace was valued at over Rs 252 crore but was sold for Rs 7.5 crore to hotelier Lalit Suri, the report quoted the court as saying. At the time of this sale, Shourie was Disinvestment Minister in the Atal Bihari Vajpayee government.

"I have not seen the order, advocates will examine the order and then we will decide what to do next," NDTV quoted Shourie as saying on the special CBI court order. "Advocates will examine the order and then we will decide what to do next."

The grand-palace hotel in question is one of the famous five-stars hotels on the banks of lake Fateh Sagar in Udaipur.


Last year, the CBI had filed a closure report saying there was no evidence in this case and concluded that evidence worth launching prosecution was not found in the entire process of disinvestment of M/s Laxmi Vilas Palace Hotel, Udaipur, NDTV reported.

Rejecting the closure report, the special court in Jodhpur has ordered to reopen the case, relaunch the investigation and file charges against Shourie.



**S**et in Australia's Northern Territory, "In My Blood It Runs" follows Dujuan, a young Aboriginal boy with a spiritual connection to, and vast knowledge of, his cultural ancestry. At home in Alice Springs, Dujuan is surrounded by his loving family, which includes his mother, his two brothers, and his maternal grandmother Nana Carol, with whom he has a special bond.

At the time of filming in Australia's Northern Territory, one hundred percent of children in juvenile detention were Aboriginal. The prejudice that Aboriginal people face in Australia mirrors the experience of African Americans in America, and the film intercuts footage of protestors carrying signs with statements like "Hands off Aboriginal Kids" at a Black Lives Matter march in Melbourne, the state capital of Victoria, Australia.

In an early scene, Dujuan is at his western school being taught how Australia was "discovered", however, he knows that Aboriginal people were there first and that his history is absent from the teaching. That theme of being torn between two worlds, and the painful legacy of colonization is present throughout.

"I was born a little Aboriginal kid. That means I had a memory, a memory about Aboriginals. I just felt something. A memory. History. In my blood it runs," Dujuan says in an opening voice over.

## Nepal's coronavirus tally nears 60,000

KATHMANDU (TIP): Nepal's number of coronavirus cases neared 60,000 on Thursday after 1,246 new infections were detected in a single day, the health ministry said.

Jageshwar Gautam, spokesperson for the Ministry of Health and Population, said that 1,246 new COVID-19 cases were reported while conducting 10,641 tests across the country in the past 24 hours.

With this, the total number of people infected with COVID-19 has reached 59,573, he said.

The number of coronavirus patients currently undergoing treatment is 16,241.

Four people have died of COVID-19 in the country, taking the total number of fatalities to 383.

The national capital Kathmandu on Thursday reported 618 new COVID-19 cases in the past 24 hours.

A total of 42,949 people have recovered from the disease. "Of the total coronavirus infections, 72 per cent have recovered," he said. PTI

## Earthquake strikes Nepal, no casualty reported

KATHMANDU (TIP): An earthquake measuring 6 magnitude struck Nepal on Wednesday morning, the country's seismological centre said, and tremors caused by the quake were felt in the capital, Kathmandu.

The European-Mediterranean Seismological Centre measured the magnitude at 5.3.

Police said they had received no reports of casualties or damage from the quake so far.

The epicentre of the quake was Ramche, about 100 km (62 miles) east of Kathmandu, near the border with China's Tibet region. Reuters

## Pak passes Bill to check terror funding

ISLAMABAD (TIP): Pakistan's Parliament has passed a Bill aimed at bringing more control and transparency in the registration and regulation of cooperative societies to check terror financing as part of the country's efforts to escape from being blacklisted by the global money laundering and terrorist financing watchdog. The Paris-based Financial Action Task Force (FATF) put Pakistan on the grey list in June 2018 and asked Islamabad to implement a plan of action to avoid being blacklisted. — PTI

## Pak to introduce legislation to curb rape, child abuse

**Such incidents ruin the lives of victims and their families also have to suffer, says Imran Khan**

ISLAMABAD (TIP): Pakistan Prime Minister Imran Khan has said that his government would soon introduce a three-tier legislation providing for registration of sex offenders, exemplary punishment for rape and child abuse and effective policing.

Khan made the announcement while addressing a joint sitting of parliament after passage of a number of Financial Action Task Force-related bills on Wednesday.

"Such incidents ruin the lives of victims and their families also have to suffer," he was quoted as saying by the Dawn newspaper.

Khan was referring to the gang-rape of a French-Pakistani woman in front of her three children near a highway in Lahore on September 9 which sparked widespread outrage.

One of the suspects wanted in the case was arrested on Monday and confessed to his crime.

Noting that the main suspect in the gang-rape case was a history-sheeter, Khan said that global data indicated that such criminals were repeat offenders and therefore maintaining their data was important. He said the legislation



being prepared would not only provide for exemplary punishment for rape and child abuse offences, but would also contain provisions for registration of sex offenders and effective policing, the report said.

He admitted that only a very small percentage of such cases were reported to police in the country.

Even after the arrest of offenders in rape and child abuse cases, their conviction is not easy in absence of proper prosecution and concrete evidence. For this reason, the bill being prepared would also provide for witness protection, he said. PTI

## Myanmar army probes 'wider patterns' of abuse against Rohingya

DHAKA (TIP): The Myanmar military has said it is investigating "possible wider patterns of violations" before and during a 2017 crackdown in Rakhine State that the United Nations has said was executed with genocidal intent against Rohingya Muslims.

More than 7,30,000 Rohingya fled to Bangladesh that year following the launch of a sweeping security campaign that refugees said included mass killing, gang-rape and arson.

The army has denied genocide, saying it was carrying out a legitimate operation against Rohingya militants, but says it has court-martialed some troops over incidents in certain villages though details on the perpetrators, their crimes, and sentences have not been released.

The military, in a statement carried in state media on Tuesday, acknowledged for the first time a possible broader pattern of abuses.

It said the military-run Office of the Judge Advocate General had reviewed a report by a government-backed commission that accused soldiers of committing war crimes and had expanded the scope of its investigations in response.

The office was "investigating possible wider patterns of violations in the region of northern Rakhine in 2016-2017", the military said in the statement.

"Allegations regarding villages in the

Maungdaw area are included in the scope of this wider investigation," the military said, referring to a district on the border with Bangladesh that was a focus of its security operations in 2017.

It provided no more details and an army spokesman did not answer telephone calls by Reuters seeking

further comment.

The announcement follows reports last week that two Myanmar soldiers have been taken to the Hague to appear as witnesses or face trial after confessing to killing dozens of villagers in the north of Rakhine State and burying them in mass graves. Reuters

## COVID-19 antibody treatment may cut hospitalisation risk

Raising hope of Covid-19 treatment at an early stage, an antibody therapy has been found to quickly reduce SARS-CoV-2 viral load in newly infected patients and cut hospitalisation risk, US-based pharmaceutical company Eli Lilly said, while revealing interim results of a clinical trial.

The Phase 2 study of the BLAZE-1 clinical trial evaluated LY-CoV555, a SARS-CoV-2 neutralising antibody, for the treatment of symptomatic Covid-19 in the outpatient setting, the company said.

The trial enrolled mild-to-moderate recently diagnosed Covid-19 patients across four groups -- placebo, 700 mg, 2800 mg, and 7000 mg.

Analyses of viral data demonstrated that LY-CoV555 improved viral clearance at an earlier time point -- day 3 -- and reduced the proportion of patients with persistently high viral load at later time points.

Most study hospitalisations occurred in patients with underlying risk factors -- age or body mass index (BMI) -- suggesting a more pronounced treatment effect for patients in these higher-risk groups.

Ongoing studies will seek to confirm this finding, the drugmaker said.

## Family, friends major source of infections: French Health Minister

Gatherings of family are a major source of COVID-19 infections, French Health Minister Olivier Veran said on Thursday, adding the spread of the disease had accelerated in the last weeks.

"If everyone reduced his number of social contacts, this would help reduce the spread of the virus", he said during a press conference.

Five people out of 100 tested for COVID-19 are today positive, versus one in a 100 at start of summer, Veran also said.

France is to implement extra measures to curb the COVID-19 epidemic in the cities of Lyon and Nice, the health minister said, adding to the three other regions deemed as virus "red zones" where additional measures are already in place. The minister, Olivier Veran, did not say what those measures would be, but that local officials in Lyon and Nice would have until the weekend to submit their plans for extra measures to the government in Paris. France has this month seen a resurgence in the number of virus cases, surpassing the daily record reached earlier this year.

# Global coronavirus cases cross 30 million mark; US worst-hit, India second

**Deaths have increased to more than 944,000, according to the Johns Hopkins University.**

The overall number of global coronavirus cases has crossed the 30 million mark on Friday (September 18, 2020), while the deaths have increased to more than 944,000, according to the Johns Hopkins University.

As of Friday morning, the total number of cases stood at 30,065,728 and the fatalities rose to 944,604, the University's Center for Systems Science and Engineering (CSSE) revealed in its latest update.

The US is the worst-hit country with the world's highest number of cases and deaths at 6,674,070 and 197,615, respectively, according to the CSSE.

India is currently in second place in terms of cases at 52,14,677, while the country's death toll soared to 84,372.

In terms of cases, Brazil ranks third (4,455,386), and is followed by Russia (1,081,152), Peru (744,400), Colombia (736,377), Mexico (684,113), South Africa (655,572), Spain (625,651), Argentina (601,713), France (454,266), Chile (441,150), Iran (413,149), the UK (384,083), Bangladesh (344,264), Saudi Arabia (328,144), Iraq (307,385), Pakistan (303,634), Turkey (298,039), Italy (293,025), Philippines (276,289), Germany (269,048), Indonesia (232,628), Israel (175,256), Ukraine (170,373), Canada (142,879), Bolivia (128,872), Qatar (122,693), Ecuador (122,257), Romania (108,690), Kazakhstan (107,056), Dominican Republic (106,136), Panama (104,138) and Egypt (101,641), the CSSE figures showed.

The other countries with over 10,000 deaths are the Brazil (134,935), Mexico (72,179), the UK (41,794), Italy (35,658), France (31,103), Peru (31,051), Spain (30,405), Iran (23,808), Colombia (23,478), Russia (18,996), South Africa (15,772), Argentina (12,460), Chile (12,142) and Ecuador (10,996).

### US Plans Millions of Cheap, Fast COVID-19 Tests

US manufacturers are sharply increasing production of cheap, fast, but less accurate - COVID-19 tests, aiming for 100 million per month by year end that will enable schools and workplaces to significantly expand testing. Manufacturing and government sources tell Reuters that more than half a dozen so-called antigen tests will likely be authorized by the end of October. US regulators in recent months have authorized antigen tests from Abbott Laboratories, Becton Dickinson & Co, Quidel Corp and LumiraDX.

### Latin American Nations Want More Time to Join WHO Vaccine Plan

Brazil and several other Latin American countries have informed the World Health Organization (WHO) they need more time to sign up for its global COVID-19 vaccine allocation plan known as COVAX, officials say. Countries have until today midnight to formalize legally binding commitments to COVAX, a mechanism for pooled procurement and equitable distribution of eventual vaccines. A representative for the GAVI Alliance, the COVAX secretariat that will handle the requests for an extension, said by email that details of which nations have joined COVAX so far will only be made public after the deadline.

### Canada Clamps Down on Partygoers

Canada's most populous province of Ontario clamped down on big parties, unveiling steep fines for breaches of strict limits on the number of people attending social gatherings to try to prevent a second wave of Covid-19 outbreaks. Organizers of private gatherings of more than 10 people inside homes and more than 25 outside will face a fine of up to Can\$10,000.

### France Not to Buy Vaccine Through WHO's COVAX Scheme

France will provide funding for an initiative led by the World Health Organization to buy potential COVID-19 vaccines, but will not source shots through the programme, an official at the French health ministry said. The decision by one of the U.N. agency's biggest supporters is a big blow to its strategy aimed at uniting governments around the world to fight the coronavirus pandemic together.

### China Sees Surge in Imported Cases

China says imported coronavirus cases surged to 32 on September 17. Thirteen of the newly confirmed cases reported today were in the northern province of Shaanxi, whose capital Xi'an is a major industrial center. The eastern financial and business hub of Shanghai reported 12. China has gone more than a month without reporting any cases of locally transmitted coronavirus cases within its borders.

### Australia Looks Set to Ease Border Limits

The Australian government is expected to announce today an increase in the number of citizens able to return home, while one state said it would partially reopen its borders given a general downward coronavirus infection trend. Prime Minister Scott Morrison is seeking to raise the cap on the number of people allowed into Australia each week by 2,000 from next Friday, after a National Cabinet meeting later in the day where states will be asked to boost quarantine capacity.

## First case-free day for New Zealand in 5 weeks

**WELLINGTON (TIP):** New Zealand has reported no new confirmed cases of the coronavirus for the first time in more than five weeks as hopes rise that an outbreak discovered in Auckland last month has been stamped out.

September 17 report also marked the fourth consecutive day without any cases of community transmission.

All recent cases have been found among quarantined travellers returning from abroad.

Authorities have still not pinpointed the origin of the August outbreak, which they believe was imported. Auckland was temporarily placed into lockdown as the country continued its strategy of trying to completely eliminate community spread of the virus. New Zealand has reported a total of just over 1,800 cases and 25 deaths. AP

## Italy: 70 migrants on ship awaiting OK to land jump into sea

**MILAN (TIP):** More than 70 migrants on a rescue ship awaiting permission to dock in southern Italy jumped into the sea in frustration Sept 17 and were picked up by Italian authorities off Palermo, a Spanish humanitarian group said.

The group's ship, which is also called Open Arms, had been carrying some 280 migrants and refugees rescued last week in the central Mediterranean as they tried to reach European shores in flimsy boats. Video showed the migrants who jumped wearing life jackets.

Ten of the Open Arms migrants had also needed to be rescued on Sept 15 after they jumped into the sea off Sicily's southern coast, when they were informed that nearby Malta had refused them entry, the NGO said. The ship then headed for Palermo, on Sicily's northern coast, where it awaited instructions on where to disembark its passengers.

On Sept 10, Italy allowed 27 migrants who had spent some 40 days aboard a Danish tanker to be brought to land aboard an Italian humanitarian rescue ship. The tanker had rescued them from the central Mediterranean after their vessel sank. Humanitarian groups complain that the European Union is abandoning migrants making the dangerous sea crossing from North Africa. They say that the EU is instead bolstering the Libyan Coast Guard, with the goal of preventing migrants from departing the lawless country where many complain they have faced torture. Maltese Foreign Minister Evarist Bartolo, said on Sept 17 that his small island nation is unable to take in any more migrants. AP

## UK defends planned Brexit deal breach as Biden slams move

**LONDON (TIP):** The British government struggled Thursday to overcome American opposition to its plans to breach the Brexit withdrawal agreement with the European Union, after Democratic presidential candidate Joe Biden became the latest U.S. politician to express alarm.

Prime Minister Boris Johnson's move to break parts of the EU divorce deal relating to Northern Ireland has triggered fears it could undermine the 1998 Good Friday peace accord that ended decades of violence between Irish nationalists and British unionists.

"We can't allow the Good Friday Agreement that brought peace to Northern Ireland to become a casualty of Brexit," Biden tweeted.

"Any trade deal between the U.S. and U.K. must be contingent upon respect for the Agreement and preventing the return of a hard border. Period," he wrote.

Britain and the EU jointly promised in the Brexit agreement to ensure there are no customs posts or other obstacles on the Northern Ireland-Ireland border. The open border is key to the stability that underpins the peace settlement.

British Foreign Secretary Dominic Raab is in Washington this week, and has been trying to assuage American concerns that a pending government bill would undermine Northern Ireland peace, if passed by lawmakers.

He is meeting U.S. politicians including House Speaker Nancy Pelosi,



who has warned that Britain won't secure a much sought-after trade deal with the United States, if it undermines the peace accord.

Raab insisted the U.K. has an "absolute" commitment to the Good Friday Agreement. He described Britain's planned law as "precautionary" and "proportionate." Johnson argues the law is intended to be an insurance policy against unreasonable behavior by the European Union that could threaten the unity of the U.K. by disrupting trade between Northern Ireland and the rest of the U.K.

The bloc has demanded the U.K. drop the plan by the end of September or face legal action.

The bill, which began its journey through Parliament this week, has also

caused an uproar in Britain.

Five former British prime ministers have criticised Johnson's willingness to break international law, and the government's top legal civil servant and most senior law officer for Scotland have both resigned.

In an attempt to quiet unease among lawmakers from Johnson's Conservative Party, the government late Wednesday offered a compromise that would require Parliament to vote before the government took any actions that broke international law.

The U.K. withdrew from the EU's political institutions on January 31 but remains in a tariff-free transition period until the end of the year while negotiators work out the terms of a future trade relationship. --AP

## Poland's president appoints daughter as unpaid advisor

**WARSAW (TIP):** Poland's President Andrzej Duda has appointed his 25-year-old daughter, Kinga, to be an unpaid adviser on social issues.

The president stressed on Twitter late Wednesday that his daughter was working as a volunteer and "does not receive any remuneration".

The appointment nonetheless raised some allegations of nepotism by critics of Duda and the ruling right-wing party that backs him, Law and Justice.

Kinga Duda, a lawyer, has already been dubbed by presidential critics as "Poland's Ivanka Trump", a reference to President Donald Trump's daughter, who plays a key role in the US administration. Kinga Duda has for the most part not played a visible role in the presidency of her father, who won his first five-year term in 2015 and was re-elected in July. However, she seized the nation's attention with an election night speech in July in which she called for all people in society to be respected despite their differences. It was seen as an attempt to soften her father's image.

During his campaign, Duda spoke out repeatedly against the movement for greater civil rights for lesbians, gays, bisexual and transgender people.



He called the LGBT rights movement an "ideology" more dangerous than communism, and said at one point that LGBT people "are not people".

Kinga Duda struck a very different message, saying all people should feel safe and accepted.

"Nobody deserves to be hated, absolutely nobody," she told her father's

supporters on election night.

LGBT rights activists say they have seen a sharp rise in the number of hate crimes targeting LGBT people in recent months, and have widely denounced Kinga Duda's appeal as an act of hypocrisy.

The presidential website says she was appointed in August. AP

# Germany apologises for past military anti-gay discrimination

**BERLIN (TIP):** Germany's defence minister has apologised for decades of discrimination against gay service people in the military until a change of policy in 2000.

A study commissioned by the defense ministry and being presented on Thursday documented "systematic discrimination" in the Bundeswehr — the military of West Germany and since 1990 of reunited Germany — from 1955 until the beginning of the new millennium.

"I very much regret the practice of discrimination against homosexuals in the Bundeswehr, which stood for the policy of that time," Defence Minister Annegret Kramp-Karrenbauer said in a statement.

"I apologise to those who suffered because of it," Kramp-Karrenbauer said she wants to advance legislation to rehabilitate those affected.

The study said that "same-sex orientation was viewed as a security risk in the Bundeswehr until the turn of the millennium and made a career as an officer or noncommissioned officer impossible."

The study on discrimination in the military is the latest move in Germany to address past anti-gay discrimination.

In 2017, parliament voted to annul the convictions of thousands of gay men



under a law criminalising male homosexuality that was enforced enthusiastically in post-World War II West Germany.

The legislation was introduced in the 19th century, toughened under Nazi rule and retained in that form by democratic West Germany, which convicted some 50,000 men between 1949 and 1969. Homosexuality was decriminalised in 1969 but the legislation wasn't taken off the books entirely until 1994.

Lawmakers approved compensation for men who were convicted. Payments

were later extended to people who were put under investigation or taken into investigative custody but not convicted.

A federal court decided in 1970 that homosexuality was no longer a disciplinary offense for soldiers unless there was a "service connection", the new study said. That was interpreted strictly to start with and gradually loosened.

The study cited a 1984 letter from the defence ministry's personnel department which said an officer "who says that he has homosexual tendencies" must be given "an assignment in which is he no longer the immediate superior of predominantly younger soldiers".

Then-Defence Minister Rudolf Scharping ended official discrimination in 2000 — "after initial hesitation, against the expressed will and persistent resistance of the military leadership of the armed forces," the study said — after an officer who had been removed from his post as a commander took his case to Germany's highest court.

He issued a paper stating that "homosexuality does not constitute grounds for restrictions in terms of assignment or status and thus also is not a suitability criterion to be examined separately". — AP

## More than 30 killed in militia attacks in western Ethiopia

**ADDIS ABABA (TIP):** Armed militia men killed more than 30 people in the Metakal zone of Ethiopia's Benishangul-Gumuz region, a senior opposition leader told Reuters on Sept 17, the latest security headache for reformist Prime Minister Abiy Ahmed's government.

The attacks, whose victims included women and children, happened on September 6-13, said Desalegn Chane, a senior member of new political party the National Movement of Amhara (NAMA).

"Farmers and members of their families were kidnapped (and) brought to an elementary school in the area where they were handcuffed and shot one by one," Desalegn said.

Abiy said a meeting on Sept 17 of the federal and regional authorities had "evaluated the sporadic security incidents that have been occurring, particularly in the border areas".

"The 29 hostages taken in Benishangul-Gumuz region have been released," Abiy wrote on Twitter, adding the attackers are "groups aimed at overturning the reforms journey".

Benishangul-Gumuz is a region bordering Sudan.

The Ethiopian Human Rights Commission said hundreds of civilians were displaced as a result of the violence and asked regional authorities to launch an investigation.

"There have been at least two rounds of killings of civilians, and hundreds of civilians have also been displaced," the commission said in a statement. In June last year, men in camouflage uniforms killed more than 50 people and injured 23 in the same area. Reuters

## New Zealand economy in deepest recession as Q2 GDP shrinks

**WELLINGTON (TIP):** New Zealand fell into its deepest economic slump on record in the second quarter as its battle against the coronavirus pandemic paralysed business activity, official data showed on Sept 17.

Gross domestic product contracted a seasonally adjusted 12.2% quarter-on-quarter, its sharpest quarterly contraction on record and largely in line with forecasts of a 12.8% decline from economists polled by Reuters. GDP fell 12.4% year-on-year.

The Reserve Bank of New Zealand had forecast a quarterly and annual GDP decline of 14% in its August statement. Growth has been hit by a standstill in economic activity as a strict nationwide coronavirus lockdown in April and parts of May forced almost everyone to stay at home and businesses to shut. Reuters

# ByteDance says China will have to approve its US TikTok deal



**Trump has said he would ban TikTok in the US as early as Sunday if ByteDance does not comply amid the US concerns**

An outright sale of TikTok's operations or technologies was not included in ByteDance's proposal to the United States, Chinese state media reported on Thursday citing a separate statement from the company.

ByteDance declined to comment when asked about this by Reuters.

When asked about ByteDance's comments regarding the need for China's approval, the Chinese Foreign

Ministry on Thursday urged the United States to respect the principles of the market economy and fair competition and to stop politicising normal economic and trade cooperation.

China late last month updated its export control rules to give it a say over the transfer of technology such as TikTok's user recommendation algorithm to foreign buyers.

Reuters has reported that the Oracle deal would not require ByteDance to apply to Chinese authorities for an export licence for TikTok's algorithm.

ByteDance and its founder Zhang Yiming have faced public criticism in China for seeming to give in to US pressure after it was reported it was contemplating a sale of TikTok's US operations to Microsoft Corp. Some netizens said they would stop using Douyin, ByteDance's Chinese version of TikTok.

"ByteDance, as it works to find a solution to keep TikTok's US business alive, is walking a tightrope between the demands of the US government on the one side and the expectations of both the Chinese government and public on the other," said Mark Natkin, managing director at Marbridge Consulting.

"It can't afford to make any missteps along the way." Reuters

Goodness of protein and fibre both. It is very moist and yummy. Paired with Coconut chutney, it completes any meal of the day. I love to have it for breakfast. You can prepare coconut chutney in advance and in 10 min you can prepare batter and cook it in a steamer or microwave while getting ready for your day. I found it Convenient dish for my breakfast in terms of cooking. Moreover it is healthy and nutritious too. It has protein, carbs and fibre and healthy fats.. If you skip curd and add lemon juice instead for the fermentation, it is Vegan too. As we all know coconut oil is heart healthy. The tempering of chutney as well as batter is done with coconut oil. And that makes it a perfect breakfast to start a perfect day. So what are we waiting for? Let us start with this nutritious dish.



## We need

**For Idli:** 1 (100 gm) cup Moong dal( yellow lentil), ½ cup thick curd, 1 cup chopped vegetables of your choice. 1 tsp Mustard seeds ( Rai ), 2 Tbsp chopped Curry patta, ½ Tsp Baking Soda, 1" Ginger piece, ¼ tsp Black pepper, Salt to taste.

**For Tempering Idli:** 2 Tsp Coconut oil, 1 Tsp Mustard seeds, A pinch of Asafoetida, (Hing), For Coconut Chutney, 1 cup Fresh grated coconut, 5 pieces Cashew nuts, ½ " Ginger piece, 2 pieces Tamarind, 7 to 8 curry leaves, Salt to taste.

**For tempering Chutney:** 2 Tsp Coconut Oil ( or any ), 1 Tsp Mustard seeds ( Rai ), 2 to 3 Red chillies Whole, 3 to 4 Curry Leaves.

**Method for preparing Coconut Chutney:** To a grinder add coconut, cashew nut, ginger, tamarind, curry leaves and salt to taste. Also add ¼ cup water. Grind to a fine paste. Add more water if required to adjust the consistency. Take out in a serving bowl. Heat a small pan. Add coconut oil to it. When oil is warm add mustard seeds( rai ). When it starts spluttering, add whole red chillies . When the chillies are roasted add curry patta to the pan. When curry patta starts wilting, switch off the flame. Pour this tempering over the coconut chutney. It is ready to serve with steaming idlis.

**Method for preparing Idli:** Wash moong dal( yellow lentil) till the water runs clear. Soak it overnight or at least for two hours. Chop finely all the vegetables of your choice. Here I have taken carrot, capsicum and beans. To this add chopped curry leaves. In the morning drain all the water from the lentil . Take a grinder jar. Add yellow lentil, ginger, salt and black pepper powder. Grind to a paste. Don't add water, instead add curd if required to grind the dal.

Take out this batter in a bowl and add all the chopped vegetables and curd. Add salt. Mix well. Take a small pan and heat it. Add 1 tbsp coconut oil or any oil of your choice. When heated add 1 tsp mustard seeds (rai) . When it starts spluttering add it to the dal batter. This adds taste and Softness to the idli. Add Baking soda and leave for 10 minutes.

Meanwhile Take a deep vessel( according to the size of the idli stand). The stand should fit in the vessel. Add water to it and put the vessel or steamer on a high flame. The level of water should be lower than the idli stand. Grease idli mould. Now fill the batter in the idli mould and keep in the vessel / steamer to steam. Keep the flame on low.

It will take 15 minutes to cook idlis. Take a toothpick and insert it in idli. If it comes out clean, it means the idli is cooked . Switch off the flame and take the mould out of the steamer. Let it rest for 3 to 4 minutes. Take out idlis from the mould and serve hot with coconut chutney.

**Tips:** For soft and spongy idlis don't forget to temper it with hot oil and mustard seeds. The batter should be of cake batter consistency. If by chance you have put extra water in the batter, nothing to worry just add 2 to 3 tbsp of semolina ( sooji ) to it. Let it rest for 5 minutes. The sooji will soak extra water.

# 2 MINUTES OF AEROBIC EXERCISE DAILY WILL KEEP YOUR MIND SHARP

**R**esearchers in Sweden have found that even two minutes of aerobic exercise can have a positive effect on brain function in young adults.

According to a recent review, published in the journal Translational Sports Medicine, just opting for a single exercise workout has positive effects on learning and memory in young adults.

Previous studies have shown that physical exercise improves mental health and cognitive function.

"Exercise makes you smart. The purpose of this systematic review was to evaluate the current literature examining the acute effects of a single exercise workout on learning and memory functions in young adults," said study author Peter Blomstrand from the Jonkoping University in Sweden.

For the findings, the research team included 13 relevant studies for the review.

The types of exercise that were studied involved walking, running, and bicycling in individuals between 18 to 35 years of age.

Investigators found that aerobic exercise for two minutes to one hour at moderate to high intensity improved attention, concentration, and learning and memory functions for up to two hours.



They noted that the results may have important education-related implications.

The researchers said there was a connection between exercise and "learning ability," which suggests that exercising before you work or study could be beneficial -- though

they said more research was needed to identify "optimal exercise strategies".

"This systematic review shows that aerobic, physical exercise before encoding improves learning and memory functions in young adults," the study authors wrote.

## Foods that are damaging your heart

### Diet Soda

Sugary sodas are fairly well-known as bad news. It's no secret that these are on the warning list of beverages that aren't great for your heart. Because of this, some may rightfully assume that a diet soda is a safer option.

### Cold Cuts/Deli Meat

The bad news is that deli meat (or cold cuts) has been proven to greatly increase your risk of heart disease. 
added sugars.

## Eyesight problems rising among kids

**W**ith children spending more time on computers and mobile phones for online classes and gaming, cases of eye sight problems are on the rise.

Children and teens between the ages of 6 and 18 years have been found to be suffering from convergence efficiency, computer vision syndrome, reflective errors and other eye sight problems.

According to rough estimates, nearly 40 per cent children have complained of various eye and vision related problems in recent weeks.

Majority of the children are being diagnosed with convergence insufficiency -- a condition in which the eyes are unable to work together when looking at nearby objects. This condition causes one eye to turn outward instead of inward with the other eye, creating double or blurred vision, said Anil Rastogi, a well-known ophthalmologist.

Children working long hours on computers and smart phones usually complain of itching or burning in eyes, watering, loss of retention power, besides headache and eye pain, Rastogi added.

Shikha Kumar, another ophthalmologist, said that since the national lockdown, most children have been found to be spending eight to 10 hours on electronic devices.

"They are either attending online classes, or watching cartoons or television and playing video games. Parents feel that this is the best way to keep them occupied but this prolonged exposure to electronic devices is playing havoc with their eyesight," she pointed out.

Doctors say that children are being diagnosed with computer vision syndrome where they complain of pain, redness, dryness, blurring of vision, double vision and other head and neck sprains.

Besides, cases of reflective errors in terms of myopia and hypermetropia have also surfaced among children.

Doctors suggest eye exercises, frequent breaks from TV/computer/ mobile phone screens to prevent permanent damage to the eyes.

## A wearable device provides at-home ozone therapy for patients

**R**esearchers at Purdue University have created a portable, wearable device for at-home ozone therapy to patients.

Ozone therapy is an anti-microbial treatment that requires patients to travel to clinical setting for treatment by trained practitioners.

A breathable patch is applied to the wound and connected to a small, battery-powered, ozone-generating device, Purdue said in a statement.

The ozone gas is transported to the skin surface at the wound site and provides a targeted approach for wound healing.

The team worked with Purdue Research Foundation to patent the technology, the statement read.

This type of treatment kills the bacteria on the surface of the wound or diabetic ulcer and accelerates the healing process.

The low-cost innovation comes as an increase in life-threatening, antibiotic-resistant infections has resulted in challenging wound complications and limited choices for effective treatments, Purdue said.

## AR glasses can enhance hearing in noisy places, Facebook says

**F**acebook Reality Labs Research said it is working on developing technology to help people hear better in noisy environments using augmented reality (AR) glasses.

The AR glasses will be able enhance people's hearing abilities to a level where they will be able to hear better in noisy places such as restaurants, coffee shops, and concerts.

Facebook says, the audio team has a two-fold mission to create virtual sounds that are perceptually indistinguishable from real ones, and to redefine human hearing. They are doing this by working on audio presence and 'perceptual superpowers'.

Audio presence is experiencing virtual sound as real. And perpetual superpower technology reduces unwanted background noises.

Research Scientist Pablo Hoffmann has developed an always-on audio calibration system that works with a pair of headphones with strategically placed microphones. The microphones record sounds in a room from a listener's perspective. When the audio recording is played back, it feels real that the listener virtually cannot distinguish it from the real thing.

The team is also working on telepresence technology - the ability to feel present in a location other than your own, in real time. By using a modified virtual reality (VR) headset and a pair of headphones, an array of 32 microphones captures the sounds in a room and delivers spatialised audio directly to a wearer's headphones, Facebook noted.

# Scientists discover possible signs of life on Venus

**T**he discovery of Phosphine gas on Venus as a potential sign of life on the glittering planet has made many scientists and astronomers ecstatic, but on the contrary to it, a significant question arises whether we are alone in this solar system or is there any form of life substantially existing elsewhere.

Delving into facts produced by the research so far, it becomes quite essential to take those weird happenings on the planet next door with a pinch of salt. Here we note some significant observations regarding the planet based on the inferences drawn from the research.

- With the onset of this new discovery, some overhyped notions of human existence, in future, on Venus may come into foray, but it is indeed a fact that Venusian atmosphere is completely hellish and untenable for human existence. Generally, day temperatures reach as high as 460 degree Celsius, with Sulphuric acid clouds hanging in the air. Despite the claims, that around 3 billion years ago, the oceans on Venus evaporated and disappeared as prevalence of heat trapping gases grew.
- Phosphine gas is generally toxic with a garlic-like smell and is found
- in the bodies of living beings on earth. It is quite impossible to produce artificially. Its hazardous ramifications are such that, it's used by terrorists as a chemical agent in warfare.
- As per the research, this gas has been detected on the clouds of Venus, away from the surface of the planet, which may throw some light towards the existence of microorganisms producing it in a conducive environment.
- The information cited in 'The Atlantic' claims that this gas was



first discovered on Venus from the Earth by Jane Greaves, an astronomer of Cardiff University, through telescope based in Hawaii. The astronomer observed the pattern produced by the light emitted from the gas in the Venusian atmosphere and was able to infer such a conclusion. Much skepticism still lies ahead of the scientists who claim that the amount of gas used in the findings is not enough and a consistently rigorous approach has to be made in order to reach an incisive result.

## World's smallest and lightest full-frame mirrorless camera with IBIS announced



**S**ony A7C has just been announced and is touted as the 'world's smallest and lightest' full-frame camera. Despite the smaller footprint compared to the Sony A7 III, it still features a 24.2-megapixel sensor, in-body image stabilisation (IBIS), and 4K video recording. It also supports advanced shooting modes such as S-Log, HLG picture profiles, and real-time eye-autofocus (Eye AF).

The Sony A7C will be available in late October for \$1,800 (roughly Rs. 1,32,000). It will also be available with the FE 28-60mm F4.5-6 zoom lens for about \$2,100 (Rs. 1,54,160).

The Sony A7C features a 24.2-megapixel full-frame CMOS sensor, in a magnesium alloy body. It has a native ISO range of 100-51,200, burst shooting of up to 10fps, and 5-axis IBIS. It features 693 phase detection autofocus (PDAF) points

with support for Eye AF for both humans and animals. The camera measures 124.0mm x 71.1mm x 59.7mm and weighs about 509g. Sony has managed to cram in the NP-FZ100 high-capacity battery, which promises up to 740 images on one charge (when using the LCD display).

The Sony A7C has a 3-inch rear, touchscreen LCD display with a 921K dot resolution. You also get an OLED viewfinder (EVF) with a 2.36 million dot resolution but with a lower magnification of 0.59x, compared to the A7 III. The camera also has built-in Wi-Fi, Bluetooth, and NFC. There's a USB Type-C port too, which can be used to charge the battery while it's in the camera. It has a single SD card slot. The A7C can shoot video up to 4K 30fps or 1080p 120fps.


## Cosmic rays may soon stymie quantum computing

**Q**ubits, the logic elements of quantum computers, are coherent two-level systems that represent quantum information. Each qubit has the strange ability to be in a quantum superposition, carrying aspects of both states simultaneously, enabling a quantum version of parallel computation. Quantum computers, if they can be scaled to accommodate many qubits on one processor, could be dizzyingly faster, and able to handle far more complex problems, than today's conventional computers.

But that all depends on a qubit's integrity, or how long it can operate before its superposition and the quantum information are lost -- a process called decoherence, which ultimately limits the computer run-time. Superconducting qubits -- a leading qubit modality today -- have achieved exponential improvement in this key metric, from less than one nanosecond in 1999 to around 200 microseconds today for the best-performing devices.

But researchers at MIT, MIT Lincoln Laboratory, and Pacific Northwest National Laboratory (PNNL) have found that a qubit's performance will soon hit a wall. In a paper published in Nature, the team reports that the low-level, otherwise harmless background radiation that is emitted by trace elements in concrete walls and incoming cosmic rays are enough to cause decoherence in qubits. They found that this effect, if left unmitigated, will limit the performance of qubits to just a few milliseconds.

Given the rate at which scientists have been improving qubits, they may hit this radiation-induced wall in just a few years. To overcome this barrier, scientists will have to find ways to shield qubits -- and any practical quantum computers -- from low-level radiation, perhaps by building the computers underground or designing qubits that are tolerant to radiation's effects.



## Govt may defer Air India sale

The government may defer the planned sale of Air India by up to three years until the turbulence caused in the aviation industry by the Covid-19 pandemic eases, two persons aware of the development said. Another option under consideration is sweetening the deal by reducing the Air India debt liability that a prospective buyer of the airline would assume.

Experts engaged in the process of divesting Air India have pointed to the lukewarm response by investors to the existing offer on the table and suggested that the government consider extending the October 30 deadline for submission of bids, reduce the debt liability of Rs 23,286 crore or allow bidders to place a value on the government's equity stake and say how much how much debt they would assume, the two persons said on condition of anonymity.

## New Zealand economy in deepest recession

New Zealand fell into its deepest economic slump on record in the second quarter as its battle against the coronavirus pandemic paralysed business activity, official data showed on Thursday, Sept 17.

Gross domestic product contracted a seasonally adjusted 12.2% quarter-on-quarter, its sharpest quarterly contraction on record and largely in line with forecasts of a 12.8% decline from economists polled by Reuters. GDP fell 12.4% year-on-year.

The Reserve Bank of New Zealand had forecast a quarterly and annual GDP decline of 14% in its August statement. Growth has been hit by a standstill in economic activity as a strict nationwide coronavirus lockdown in April and parts of May forced almost everyone to stay at home and businesses to shut.

## Flipkart may list overseas by 2021

Flipkart may go public as early as next year at a valuation of \$40-45 billion, a person familiar with the development said, as India's largest online retailer benefits from accelerated adoption of digital platforms for shopping and payments by customers because of the coronavirus pandemic.

Flipkart would look at an overseas listing, either in the US, where its parent Walmart Inc. is based, or another country, the person said on condition of anonymity. Walmart had in 2018 acquired a majority stake in Flipkart for \$16 billion, valuing the Bengaluru-based company at \$21 billion. At that time, Doug McMillion, president and CEO of Walmart, said that Flipkart will go public within four years of closing the deal. "The IPO should be done at no less a valuation than that at which Walmart invested in the Indian e-commerce firm," Walmart had then said in a regulatory filing.

# US broke trade rules by putting tariffs on China, finds WTO

The World Trade Organization found that the United States breached global trading rules by imposing multibillion-dollar tariffs in President Donald Trump's trade war with China, a ruling that drew anger from Washington.

The Trump administration says its tariffs imposed two years ago on more than \$200 billion in Chinese goods were justified because China was stealing intellectual property and forcing US companies to transfer technology for access to China's markets.

But the WTO's three-member panel said the US duties broke trading rules because they applied only to China and were above maximum rates agreed to by the United States. Washington had not then adequately explained why its measures were a justified exception, the panel concluded.

"This panel report confirms what the Trump administration has been saying for four years: the WTO is completely inadequate to stop China's harmful technology practices," US Trade Representative Robert Lighthizer said in response.

China's Commerce Ministry said Beijing supported the multilateral trading system and respected WTO rules and rulings, and hoped Washington would do the same.

The decision will have little immediate effect on the US tariffs and is just the start of a legal process that could take years to play out, ultimately leading to the WTO approving retaliatory measures if it is upheld - moves that China has already taken on its own.

The United States is likely to appeal Tuesday's ruling. That would put the case into a legal void, however, because Washington has already blocked the appointment of judges to the WTO's appellate body, preventing it from convening the minimum number required to hear cases.

The WTO panel was aware it was stepping into hot water. It noted that it had looked only into the US measures and not China's retaliation, which Washington has not challenged at the WTO.



"The panel is very much aware of the wider context in which the WTO system currently operates, which is one reflecting a range of unprecedented global trade tensions," the 66-page report concluded.

The panel recommended the United States bring its measures "into conformity with its obligations", but also encouraged the two sides to work to resolve the overall dispute.

"Time is available for the parties to take stock as proceedings evolve and further consider opportunities for mutually agreed and satisfactory solutions," it said.

During a two-year trade war with Beijing, Trump threatened tariffs on nearly all Chinese imports - more than \$500 billion - before the two countries signed a "Phase 1" trade deal in January. Extra tariffs are still in place on some \$370 billion worth of Chinese goods, and \$62.16 billion in duties have been collected since July 2018, US Customs data <https://www.cbp.gov/newsroom/stats/trade-show>.

## ADB paints gloomy picture of developing Asian economies



**MANILA (TIP):** Developing economies in Asia will contract in 2020, the first such downturn in nearly 60 years, the Asian Development Bank said in an update to its forecasts.

The update of the ADB's outlook estimates the regional economy will contract 0.7% this year, recovering to 6.8% growth in 2021.

Conditions could deteriorate further, however, if the Covid pandemic worsens significantly, the regional lender said.

Asia's status as a production base for many medical products, digital devices and optical equipment helped to cushion the blow to trade from the pandemic downturn, the report noted.

Nonetheless, the downturn is the worst since the early 1960s, the report said.

"This has set back efforts to life

hundreds of millions of people in our region out of poverty," said the ADB's chief economist, Yasuyuki Sawada.

Indian economy will shrink by 9% this fiscal, the ADB predicted saying growth outlook remains highly vulnerable to either a prolonged outbreak of the pandemic or a resurgence of cases. This will be the first time in four decades that the Indian economic growth will contract.

The bank said developing economies in Asia will contract in 2020, the first such downturn in nearly 60 years.

## Over 1,600 Indian companies received USD 1 billion FDI from China during Apr 2016-Mar 2020

More than 1,600 Indian companies have received foreign direct investments worth USD 1 billion from China during the April 2016 to March 2020 period, according to government data.

The data was provided in a written reply to the Rajya Sabha on Tuesday to a question on whether it is a fact that large scale investments have been made by Chinese agencies in Indian companies, specially the start-ups.

Over 1,600 companies received USD 1,020.25 million (USD 1.02 billion) Foreign Direct Investment (FDI) equity inflows from China for the April 2016 to March 2020 period, as per the data.

These companies were in 46 sectors. Out of them, the automobile industry, printing of books (including litho printing industry), electronics, services and electrical equipment received more than USD 100 million FDI each from China during the said period.

The automobile industry received the maximum FDI from China at USD 172 million. The services sector attracted such funds worth USD 139.65 million, the data showed.

In the written reply, Minister of State for Corporate Affairs Anurag Singh Thakur said the corporate affairs ministry does not maintain information regarding the investment made by Chinese agencies.

He said the Ministry of Commerce & Industry has informed that FDI Data Cell compiles and maintains the data of FDI reported through equity inflow in the country.

The relevant data for the April 2016 to March 2020 period was provided along with the written reply.

Indian and Chinese troops are engaged in a standoff along the Line of Actual Control (LAC) in eastern Ladakh.



The entire Mahabharata is peopled with rishis, munis, acharyas (preceptors), sages, and teachers of rajadharma (dharma of kingship) to the kings and of ethical ways of living to the common people. While distinctions can be made between rishis, munis, acharyas, upadhyayas, and others, they all have one function in common and that is teaching. Apart from them, there are other sages and also rajarishis (royal sages) such as Bhishma Pitamah and King Janaka. Vidura does not count himself in this category as he was born of the union of Rishi Vyasa and a domestic maid or a dasi but he is the wisest and is said to represent Dharma himself. Apart from the male rishis there are also female ascetics or rishikas such as Shandili, Sulabha, and Madhavi, who teach by example. King Janaka's wife, the princess of Kosala, delivers important lessons of life to her husband when she counsels him that running away from one's dharma or duties is not ascetic virtue.

Then there are the ordinary people, who seemingly lead very ordinary lives like the unnamed housewife, the grocer Tuladhara and the meat seller Dharmavyadha, all of whom become evolved enough to be able to teach even an ascetic what a truly virtuous life should be. Thus, the Mahabharata makes the point that true knowledge or wisdom can come from those belonging to any section of society and yet, those whom we look up to, can also fail sometimes. These are the rishis. There are several prominent and exalted rishi families descending directly from the intellectual sons or manasputras that Brahma created first. The rishis reiterate the basic concepts and assert that the only path to liberation and self-mastery is control over the senses. Without this control destructive emotions such as anger, lust, greed, arrogance, and egoism overpower and make the person helpless. This is, however, easier taught than done as the rishis themselves find it hard to maintain control over their senses. Immersed in the world of greed for power and wealth or motivated by desire, they sometimes even use their knowledge to cause greater destruction than ordinary mortals are capable of as they can curse and grant boons through powers acquired by their ascetic practices. What the Mahabharata shows is that power without wisdom is dangerous. Ironically therefore, we see many rishis and sages themselves become unscrupulous wielders of power, destroying wantonly, because they have no control over themselves and they give in to sensual pleasures. One reason for this could be that they get too involved in the world and develop too many vested interests. They are unable, therefore, to watch the affairs of the world with detachment as witnesses. The redeeming factor however, is that having reached a level of understanding, the rishis, who get caught in the web, are more often than not able to gather themselves in good time.

As Sri Krishna explains, those who realize the eternal Truth are neither reborn at the time of creation, nor are they 'disturbed' at the time of dissolution. The total material substance, called Brahman, is the source of birth and the Supreme Godhead, that is Krishna himself, impregnates it. All species of life are made possible by birth in this material

nature of which he is the seed-giving father. Material nature consists of three modes - goodness, passion and ignorance or sattva, rajas and tamas. When the indestructible one or the eternal living entity comes in contact with nature, he becomes conditioned by these modes. Sliding down from the level of sattva to rajas and tamas, is easy but staying steadfast in sameness is the one defining qualification of a 'realized one'. # Indian Physicians Achieve Novel Alternative Success in Pandemic

**High-Flow-Nasal-Cannula Therapy gives better curative support than Ventilator in Covid-19 patients**


**O**n one side, India's Covid cases cross 5 million, the second country in the World after the US to record 5 million patients, and on another end , the availability of Ventilators' and beds in COVID centers are shrinking in many states of the country causing serious alarming situations specially lifeline OXYGEN.

Probably for the first time in India, Physicians affiliated to Jaipur's Institute of Respiratory Diseases and Rajasthan Hospital have successfully tried to replace ventilator treatment by a High Flow Nasal Canula (HFNC) Therapy that gives a better curative support to Covid patients. Though HFNC treatment needs more oxygen supply than from ventilators.

HFNC is a type of oxygen treatment normally provided to patients with Pneumonia, heart failure and sleep apnoea (temporary cessation of breathing, especially during sleep). It is different from a ventilator as the patient is conscious and there is no intubation in the patient's lungs. Thus, the complications of ventilator are bypassed and patient breathes himself or herself which prevents muscle atrophy. Many cases respond to HFNC and putting the patient on ventilator can be avoided.

WHO Clinical Guidelines on COVID-19 (March 13/2020) also recommended application of HFNC in chosen and needy patients.

HFNC is useful in COVID-related acute respiratory distress syndrome (ARDS)

patients as the alternative to the ventilator support system.

When contacted Dr Sheetu Singh, Associate Professor at the Institute of Respiratory Disease (SMS Medical College), told TIP, "The number of COVID-19 pneumonia cases have seen a rapid surge in India. This has led to more patients presenting at hospitals with requirement for oxygen. As the lungs get increasingly involved with the virus and the ongoing inflammation, the patients find increasing difficulty in breathing. The first step is to supplement oxygen by nasal prongs or face mask. These devices can provide maximum of 15L/min of oxygen at up to 99% concentration. If the patient does not maintain saturation or develops increase in respiratory rate the patient has to be switched to either Bi-Level Positive Airway Pressure (BIPAP). BIPAP helps in some cases but the oxygen that is supplemented with it is

still limited".

As per the treatment style, HFNC provides warmed and humidified oxygen at a rate of 60-80 Liter/minute with FiO<sub>2</sub> ranging from 21-100 percent. The oxygen has to be warmed to body temperature of 37-degree Celsius and humidified so as not to cause cooling and drying of mucous membrane of the lungs.

Dr Sheetu explained, "This high rate of oxygen flow not only provides oxygen supplementation to oxygen deprived patients with COVID-19 but also splints open the alveoli in the lungs. HFNC has been found useful in patients of COVID-19 who are not maintaining saturation on nasal cannula or mask. Also it has been found to be superior to BIPAP or noninvasive ventilators. Thus, HFNC is a boon and prevents patients from going on ventilators, which have poor outcomes".

HFNC is different from BIPAP or

noninvasive ventilator because it provides high flow oxygen along with pressure which relieves the air hunger of the patient. BIPAP uses a tight fitted face mask which may be uncomfortable to the patient and discourages the patient from clearing the secretions from the lungs. HFNC is more comfortable to patient and secretion clearance can be done easily as it requires only nasal cannula, she said.

Dr Virendra Singh, Chest Expert of Rajasthan Hospital & Editor of Lung India journal, claimed that HFNC was being useful in children suffering from Pneumonia, but in adult patients it was taken up for the first time in the country specially in COVID-19 patients. This substitute of oxygen supply (HFNC) was beneficial in previous epidemics of MERS and SIRS-CoV1, he who is a senior member of the state's Covid Medical Experts Team, added.



The Badminton World Federation (BWF) has postponed the Thomas and Uber Cup Finals in Denmark to next year following withdrawals by many teams due to the Covid-19 pandemic.

India had announced both the men's and women's squads for the prestigious event which was scheduled to be held in Aarhus from October 3 to 11.

However, after Indonesia and South Korea joined Thailand, Australia, Chinese Taipei and Algeria in pulling out due to Covid-19, the sport's governing body held a virtual emergency council meeting on Sunday.

"The Badminton World Federation, in full consultation and agreement with local host Badminton Denmark, has made the tough decision to postpone the Thomas & Uber Cup Finals 2020 in Aarhus, Denmark," BWF said in a statement.



**Indian-American appointed NBA basketball assistant coach for Memphis team**

Memphis Grizzlies, an American professional basketball team, which competes in the NBA, has hired an Indian-American as its assistant coach. Sonia Raman joins Vin Bhavnani (Oklahoma City Thunder) and Roy Rana (Sacramento Kings) as the only coaches of Indian origin in the National Basketball Association.

Raman becomes the 14th female assistant coach in the history of the NBA and the 10th among current coaching staffers in the league. She becomes the seventh female coach to be hired as an assistant in the league since the beginning of the 2019-20 season.

According to ESPN's Adrian Wojnarowski, she replaces Niele Ivey, another women's assistant coach who left for a head coaching position at the University of Notre Dame.

"She has a high basketball IQ and a tremendous ability to teach the game, as well as a strong passion for the game," head coach Taylor Jenkins said.

# Carey, Maxwell lift Australia to dramatic win in 3rd ODI

**S**uperb centuries from Alex Carey and Glenn Maxwell inspired Australia to a dramatic three-wicket victory over England on Wednesday, Sept 16, as the touring side clinched the one-day international series 2-1.

The pair put on 212 runs for the sixth wicket after Australia had slumped to 73-5 chasing a stiff target of 303 runs in the final game of the series.

Jonny Bairstow scored 112 as England recovered from losing their first two wickets to the opening two balls of the game to score 302 for seven in their 50 overs after winning the toss.

Australia lost their first five wickets cheaply but fought back brilliantly to win with two balls to spare against the world champions and inflict their first home one-day series defeat for five years.

England got off to the worst possible start as Jason Roy drove a thick outside edge to backward point and Joe Root was trapped lbw by Mitchell Starc off the first two balls of the innings.

Bairstow set about engineering a recovery, however, and England quickly pushed the run rate above six an over.

A 114-run partnership for the fifth wicket between Bairstow and Sam Billings (54) provided the backbone of the innings and Chris Woakes also contributed a rapid half century to take England past the 300-run mark.

Woakes then took the first two wickets of the Australia innings before Root, with his part-time off spin, nicked out David Warner and Mitchell Marsh cheaply to remove the tourists top order.

When Marnus Labuschagne was run out in the 17th over, Australia were reeling on 73-5.

Carey and Maxwell fought back, however, dragging Australia right back into the match with lusty hitting and leaving them needing 21 runs off the last 18 balls for victory.



They looked like throwing a winning position away when Maxwell top-edged spinner Adil Rashid and was caught by Tom Curran for 108 off 90 balls and 10 balls later Carey was caught by Mark Wood at third man off Jofra Archer for 106.

Australia needed 10 runs off the final over which England captain Eoin Morgan bravely entrusted to Rashid. Starc smacked a six off his first ball and hit another boundary to win the game, bringing a crowded summer of international cricket to an exciting conclusion.

England had a busy three-month window into which they crammed six tests and 12 limited-overs internationals all played behind closed doors in a bio-secure bubble because of the COVID-19 pandemic.

**England all-rounder David Willey tests +ve for COVID-19**

England all-rounder David Willey has tested positive for COVID-19, the player announced on social media on Thursday, Sept 17.

The 30-year-old Willey last played for England in the ODI series against Ireland in August.

"Thank you for all the kind messages. My wife and I received positive Covid test results," Willey tweeted.

The Yorkshire player said he was "gutted to be missing the remaining (group) games" of the domestic T20 league Vitality Blast.

"Even more devastated that having been in contact with the other three lads Sat morning (before we had symptoms) means they're at risk and unavailable too," he wrote.

Yorkshire earlier announced that Willey, Tom Kohler-Cadmore, Josh Poysden and Matthew Fisher would miss their remaining Vitality Blast group games.

## Austria's Dominic Thiem claims US Open title

**A**ustria's Dominic Thiem finally claimed his first Grand Slam title with a stunning comeback to beat Germany's Alexander Zverev 2-6 4-6 6-4 6-3 7-6(6) in a brutal and nerve-jangling US Open final on Sunday, September 13.

The 27-year-old world number three, beaten in his first three Grand Slam finals, started as favourite but appeared to have blown his golden chance as he fell two sets behind.

Thiem, who had dropped only one set en route to the final, looked stifled by nerves early on but gradually broke the shackles to hit back from a break down to take the third.

Zverev faltered on serve at 3-4 in a high-quality fourth set allowing Thiem to take the contest to a decider.

A limping Thiem trailed 5-3 in a tense decider but Zverev could not close it out and the Austrian summoned some incredible baseline winners to take it into a tiebreak.

A gut-wrenching climax saw Thiem squander two match points from 6-4 with forehand errors but he would not be denied and set up a third match point with a passing shot before Zverev fired



wide after four hours and two minutes.

"I wish there were two winners today, we both deserved it," Thiem, the second Austrian to win a Grand Slam title after Thomas Muster's 1995 French Open title, said on court after a tearful speech from his crestfallen 23-year-old opponent.

Thiem had lost the last two French

Open finals to Rafa Nadal and this year's Australian Open final to Novak Djokovic.

This time he started as the favourite but needed to become the first player to win a Grand Slam title from two sets down since Gaston Gaudio at the 2004 French Open to end his wait.


