## Trump says he supports larger coronavirus relief package

WASHINGTON (TIP): U.S. President Donald Trump said on Thursday, Oct 15 he was willing to support a comprehensive COVID-19 coronavirus relief package larger than \$1.8 trillion to make a deal with Democrats and get a bill passed.

"I would," he said during a telephone interview with Fox Business News. "Absolutely, I would. I would say more. I would go higher. Go big or go home."

He went on to say that he had directed Treasury Secretary Steven Mnuchin to make an offer over the \$1.8 trillion package previously supported by the White House but said Mnuchin "hasn't come home with the bacon."

## If elected, 11 million immigrants to get citizenship, promises Biden

WASHINGTON (TIP): Democratic presidential candidate Joe Biden has vowed to provide citizenship to 11 million illegal immigrants if voted to power in the November 3 presidential election. Biden identified this as one of his priorities in addition to beating the coronavirus pandemic, rebuilding the economy and figuring out how to restore American leadership around the world.

At a virtual fundraiser on Wednesday, October 14, Biden said there is a need to deal with what's going on at the border. "We're going to have to deal with the immigration crisis," he said.

Donald Trump has been calling for the deportation of illegal immigrants.

Meanwhile, Democratic vice-presidential nominee Kamala Harris has cancelled her travel plans through Sunday as a precaution after one of her staff members tested Covid positive.

# India fares poorly in hunger index


**Country has the highest prevalence of 'wasted children'; even Bangladesh and Pakistan score better**

**NEW YORK (TIP):** India has the highest prevalence of wasted children under five years in the world, which reflects acute undernutrition, according to the Global Hunger Index 2020. The situation has worsened in the 2015-19 period, when the prevalence of child wasting was 17.3%, in comparison to 2010-14, when it was 15.1%.

Overall, India ranks 94 out of 107 countries in the Index, lower than neighbors such as Bangladesh (75) and Pakistan (88). 2020 scores reflect data from 2015-19. The Index, which was released on Friday, is a peer-reviewed report released annually by Concern Worldwide and Welthungerhilfe.

It uses four parameters to determine its scores. India fares worst in child wasting (low weight for height, reflecting acute undernutrition) and child stunting (low height for age, reflecting chronic undernutrition), which together make up a third of the total score.

Although it is still in the poorest category, however, child stunting has actually improved significantly, from 54% in 2000 to less than 35% now. Child wasting, on the other hand, has not improved in the last two decades, and is rather worse than it was decade ago.

India has improved in both child mortality rates, which are now at 3.7%, and in terms of undernourishment, with about 14% of the total population which gets an insufficient caloric intake.

In the region of south, east and south-eastern Asia, the only countries which fare worse than India are Timor-Leste, Afghanistan and North Korea.

**Pandemic effect**

Globally, nearly 690 million people are undernourished, according to the report, which warns that the COVID-19 pandemic could have affected

the progress made on reducing hunger and poverty.

"The world is not on track to achieve the second Sustainable Development Goal - known as Zero Hunger for short - by 2030. At the current pace, approximately 37 countries will fail even to reach low hunger, as defined by the Global Hunger Index Severity Scale, by 2030," says the report. "These projections do not account for the impacts of the COVID-19 pandemic, which may worsen hunger and undernutrition in the near term and affect countries' trajectories into the future ... COVID-19 has made it clearer than ever that our food systems, as they stand, are inadequate to the task of achieving Zero Hunger."

Trump said he would not accept "goodies" in the Democrats' proposal.

House Democrats, led by Speaker Nancy Pelosi (D-CA), have been pushing for a \$2.2 trillion package that would include funding for state and local governments, schools, and coronavirus testing and tracing, among other priorities.<sup>2</sup>



## Indian American Couple's Campaign for Joe Biden

**SACRAMENTO(TIP):** A Silicon Valley-based Indian-American couple has released a digital graphic campaign in Hindi, urging their community members to support and vote for Democratic presidential candidate Joe Biden and his running mate Kamala Harris.

The campaign titled "Trump Hatao America Bachao" and "Biden Harris ko jitao , America ko aagebadao", was launched in 14 Indian languages on Monday, October 12 said Biden supporters, Ajay and Vinita Bhutoria.

The focus of the campaign on the battle ground States where every vote matters and Indian-Americans can play an important role in the election results, Bhutoria said in a statement.

Battle ground States of Pennsylvania, Wisconsin, Michigan, Minnesota, along with three southern states Florida, Georgia, North Carolina, as well as Arizona collectively have 127 electoral votes.

In 2016 Trump had a narrow win in Michigan, Wisconsin, Pennsylvania.

# Indian American co-founded company and University of Houston partner for COVID-19 vaccine

**HOUSTON (TIP):** The University of Houston (UH) has joined hands with an Indian American co-founded biotech company, AuraVax Therapeutics, to develop a 'differentiated-approach' vaccine against aggressive respiratory diseases, such as COVID-19.

AuraVax, however, has the option to exclusively license a new intranasal vaccine technology developed by its Indian-American co-founder, Navin Varadarajan, M.D. Anderson Professor of Chemical and Biomolecular Engineering at the University of Houston.

"A safe and durable vaccine is urgently needed to tackle the COVID-19 pandemic that has infected millions of people and caused over 620,000 deaths globally," Varadarajan stated.

"We plan to stop COVID-19, a respiratory virus, at its point of entry - the nasal cavity - and we believe our intranasal platform is a differentiated approach that will lead to a vaccine with increased efficacy to create sustained immunity to COVID-19," he said.

Based on pre-clinical experiments, Varadarajan reports his technology not only elicits a mucosal immune response, but also systemic immunity, according to the UoH.

Varadarajan is targeting the spike

proteins, which allow infections to penetrate host cells, in his study. The professor also prefers proteins because of their ability to induce strong immune responses, flexibility and scalability, and the absence of infectious particles, as per an UoH statement.

AuraVax describes its vaccine administration platform as 'next-generation', one which could be administered at home.

"We are excited to be collaborating with the University of Houston and look forward to future success by advancing the development of this novel intranasal

vaccine platform to address a multitude of respiratory viruses, starting with COVID-19. We plan to stop COVID-19, a respiratory virus, at its point of entry -- the nasal cavity -- and we believe our intranasal platform is a differentiated approach that will lead to a vaccine with increased efficacy to create sustained immunity to COVID-19," said Varadarajan.

"AuraVax, being created by an UoH professor, is the ideal partner for us, and what better cause than to advance the creation of a vaccine to COVID-19, arguably the primary challenge facing our generation. The partnership has my wholehearted support," said Amr Elnashai, University of Houston vice president for research and technology transfer.

"The race for more effective ways of vaccinating against COVID-19 and other respiratory diseases has led to a broad and extensive focus on various protective mechanisms of action. Based on pre-clinical work, our technology not only elicits a mucosal immune response, but also systemic immunity. We believe AuraVax has a competitive advantage given the immune responses and a supply chain that is well-suited for widespread distribution and self-administration distribution," said Dr Varadarajan.

## Indian American Organization AAPI released Coffee table book

innumerable hours of their family time for the sake of AAPI," Dr. Suresh Reddy said. Dr. Ranga Reddy had his Training in Anesthesiology at State University of New York (SUNY). He started his career at St. Louis University School of Medicine as an Assistant Professor in the Department of Anesthesiology

He later on, moved to Springfield, Illinois to join practice in Memorial Medical Centre, where he served as the Chairman of the Department of Anesthesiology. Dr. Ranga Reddy served AAPI in various capacities including as its President and as a member of the Board of Trustees.

During his presidency "One Member One Vote" policy was introduced for electing the leaders making the process truly democratic. In order to comply with AAPI's 501 (3) C status, AAPI's

Political Action Committee was replaced with Legislative Affairs Committee.

He led efforts to create AAPI's Patron Trustee Membership to support AAPI Charitable Foundation and raised over \$600,000 during his Presidency. In India, Dr. Ranga Reddy started an AAPI Charitable Clinic in a remote village called Ellayapalle to provide medical services to the indigenous people.

He promoted "Adopt the Primary Health Care Center of Your Native Place" in Andhra Pradesh. He co-sponsored a water project with Nandi Foundation to supply clean water to the villagers. Dr. Ranga Reddy was invited to the White House in 1995 by President Bill Clinton on behalf of AAPI Leadership.

He is the recipient of the AAPI Distinguished Service Award, Distinguished Public Service Award by American Telugu Association and Leadership Award by the Association of International College of Physicians. "This is an excellent historical review of AAPI by Dr. Ranga Reddy," said Dr. Anupama Gotimukula, President-Elect of AAPI.

"Over the past 37 years, AAPI has grown and is now the largest ethnic medical society in the US, representing the interests of over 100,000 Indian American physicians and Fellows," noted Dr. Sudhakar Jonnalagadda, current President of AAPI.

**CHICAGO (TIP):** It was tough and challenging for the pioneer physicians of Indian origin to establish practice and find suitable job opportunities when they started coming to the US in the early 1960s and the 1970s.

So recalled Dr. Ranga Reddy, who has chronicled the history of American Association of Physicians of Indian Origin (AAPI) in a coffee table book released during the mini convention of the association Chicago last month.

"The journey to the land of opportunities was tough and challenging," said Dr. Reddy, Chair, AAPI History Task Force & Past President, 1997-98, according to an AAPI media release. "Faced with instances of overt as well as subtle discrimination in Residency recruitment and License Reciprocity, physicians of Indian Origin organized themselves in several states to fight the unfair treatment."

"It was a passion for history" that made this historic moment a reality, said Dr. Ranga Reddy, a medical graduate of Kurnool Medical College, where he had obtained MBBS and M.S Degrees. Consul General of India in Chicago, Arun Kumar, along with Dr. Suresh Reddy, Immediate Past President of AAPI released the book. The first copy of the book was presented to Dr. Ranga Reddy.

## 72% Of Indian Americans Support Joe Biden, says Survey

**NEW YORK (TIP):** Nearly three-quarters of Indian Americans plan to vote for Democratic presidential candidate Joe Biden in the U.S. election next month, believing the country is headed in the wrong direction under President Donald Trump, according to a survey on Wednesday.

Indian Americans, the second largest immigrant group in the United States, make up less than 1% of registered voters for the Nov. 3 election. But both parties have reached out to the community in case they become important in the event of a close vote.

The Indian community is also in the spotlight after Biden picked Senator Kamala Harris, the daughter of an Indian immigrant, as his running mate. Harris is the first Black woman and Asian American in history to make the presidential ticket for a major party.

The survey found 72% of registered

Indian American voters supported Biden for president compared to 22% for Trump. The rest either chose "others" or said they did not intend to vote.

The survey, a collaboration between the Carnegie Endowment for International Peace, Johns Hopkins SAIS, and the University of Pennsylvania, covered 936 Indian Americans.

It was conducted between Sept. 1 and Sept. 20 in partnership with YouGov with an overall margin of error of +/- 3.2%.

The Indian community has traditionally supported the Democratic Party, but strong personal ties between Trump and Indian Prime Minister Narendra Modi have raised expectations of a shift.

In an effort to win support from Indian-American voters, Trump hosted a 50,000-person "Howdy Modi" rally in

Texas with PM Modi last year. PM Modi returned the favor in February, organizing a 110,000-attendee rally for Trump in India.

There has been speculation the Indian community in the U.S. may not favor a potential Biden presidency, fearing he may be tougher on India on issues such as human rights and civil liberties that activists say are increasingly at risk under PM Modi.

Still, the survey showed little erosion in support for Biden.

"The big takeaway from these numbers is that there is scant evidence in the survey for the widespread defection of Democratic voters toward Trump," said Milan Vaishnav from the Carnegie Endowment for International Peace, Devesh Kapur from Johns Hopkins and Sumitra Badrinathan in their assessment.


Voters who were polled listed the economy and healthcare as their top two concerns in the lead-up to the vote. U.S.-India ties were near the bottom of the list.

Harris's run for vice president has galvanized Indian Americans to turn out to vote, especially the Democrats.

About 49% of respondents indicated that Harris's nomination made them more enthusiastic about Biden's candidacy while just 15% said it made them less enthusiastic.

Harris is born to an Indian mother and a Jamaican father who both emigrated to the United States in their youth to study.

## Indian American police officer Sandeep Singh Dhaliwal Honored

Commissioner Adrian Garcia, who hired Dhaliwal, said, "I was honored to commemorate a section of the Beltway 8 as 'Deputy Sandeep Singh Dhaliwal Memorial Tollway' to honor one of HC's finest who paid the ultimate sacrifice."

"We miss our friend and teammate," said Harris County Sheriff Ed Gonzalez. "It's a loss that we feel every day," he said.

Garcia as former county sheriff had allowed Dhaliwal to wear a beard and turban, Sikh articles of faith, while serving - becoming one of the first law enforcement agencies to do so in the

country, Chronicle said.

The new policy was borne from an incident just before Garcia took office as sheriff when a Sikh had been wrongly arrested.

Garcia met with the incensed community and during his remarks, told them new policies and training will be there, but that wouldn't transform the department.

"What will change us is you encouraging your sons and daughters to join the Harris County Sheriff's Office so that we can change from within," he was quoted as saying.

"Who would know that Sandeep would be in that audience with his father who had been a policeman in India, and look to him and tell him he wanted to be in law enforcement," the former sheriff said.

It set off a chain of events that would change the fiber of the department. Later, he would see a Sikh in a magazine wearing his turban and beard in a US military uniform.

"It set me off. How could the US military do this and not us?" Garcia asked himself. After an internal debate, he gathered his legal team, staff, commanders, and members of the community and worked to craft what is now known as the Accommodations Policy. # The Indian American Impact Project has a political action committee

## Around 70 Indian Americans running for the office

**NEW YORK (TIP):** While media attention is focused on vice presidential candidate, Kamala Harris, Indian American have made great strides in politics since they started coming to the US in the early 1960s to emerge as an influential community much beyond their numbers.

GOPIO chapters in the New York area (Manhattan, New York, Connecticut and Central Jersey) in collaboration with IMPACT Project organized an interactive Zoom session, celebrating Indian American community's emerging political leaders in the Northeast US on Oct. 8.

Moderated by Raj Goyle, former member of Kansas State Assembly and Co-Founder, IMPACT (New York), the session showcased several Indian American leaders from the Northeast, with the audience from around the US, on how they developed interest in public service, their challenges and the sense of pride and achievement in what they have accomplished.

Describing himself as a pioneer in US politics, Goyle said, "When I had joined politics, I did not know much of politics. I was one of the first to be elected to any State Assembly. And I am proud to be part of the new generation of PIOs/NRIs in politics."

Joining politics after working as a policy analyst and civil rights attorney, Goyle has served two terms in the Kansas House of Representatives, making him the first Asian American elected to office in Kansas' history. He is currently the CEO of Bodhala, a leading legal technology firm.

In his opening remarks, Dr. Gautam Mukunda at The Center for Public Leadership, Harvard Kennedy School, Cambridge, traced the rise of Indian Americans starting with Dalip Singh Saund, the first Indian American to be elected to the US Congress in the 1950s.

Pointing to Indian American candidates running for State elective offices in the Northeast among the speakers, he said, "Every one of you gives me hope. People in the United States believe that Indian Americans are capable of becoming leaders in the nation."

Connecticut State Rep. Raghib Allie-Brennan, seeking re-election in the 2nd District said he got interested in entering

politics, through his "commitment to environment after Hurricane Katrina devastated the nation."

Losing the election the first time by 260 votes did not deter him from contesting again to win convincingly the second time. "It was the desire to give back to the society that prompted me to enter politics and serve the people," he said.

New York State Senator Kevin Thomas, running from Senate District 56, said, he is "proud of the community he has come to represent. My constituents sought change and they got the change by electing me."

During his short term in the New York Senate, Thomas said, he has been successful in bringing in much needed funding to serve the diverse needs of his constituents with several new programs. He urged everyone to vote in the Nov. 3 election and make "our voices heard."

Ohio State Representative Niraj Antani, running for Ohio State Senate District 6, noted he is the second Indian American ever elected to a statewide office and the only Republican of Indian Origin to be elected.

"I work hard to reach across the aisle and cooperate with people in both the Parties to legislate."

Sharing his early days and inspiration to enter politics, he said, "My parents worked hard to live the American dream. There is a need for us to be at the decision-making table."

"Everyone is able to realize the dream. We stand on your shoulders, to carry on

the Indian values."

Now serving his third term in the Ohio House, Antani was the youngest Indian American elected official in the US. Jeremy Cooney from Rochester, New York, is running for State Senate District 56 to create new and good paying jobs, improve schools and provide access to quality healthcare for all.

"I am from India. I was adopted as a young child. My commitment is to give back to the community," he said. "We cannot control the politics of DC but can serve the inclusive New York state."

Born in an Indian orphanage, Jeremy was adopted by a single-mother and grew up in the South Wedge neighborhood of the City of Rochester.

After losing his mother to dementia and brain cancer, Jeremy has devoted his career to serving the community that helped raise him from the YMCA to all levels of government.

New Hampshire State Rep. Latha Mangipudi, who is running again from 35th District for a fifth term, spoke about the challenges in becoming a female, non-White elected official from a White majority state.

"It was a very slow and gradual journey after I had come to the US to pursue higher studies in the 1980s."

"I am a woman, Brown colored, first generation Indian and very vocal in expressing my views," said Mangipudi. Inspired by Mahatma Gandhi's message of non-violence.

Rupande Mehta from New Jersey,

running from Senate District 25, said, "My story is a story of dreams. Coming from Mumbai, seeking freedom, I am running for office because representation matters."

If elected she will be the first person of South Asian origin to be elected from his District.

Describing her story as "simple," New Jersey State Rep. Raj Mukherji from 33rd District said, "it's premature to say we have arrived. Our community's vote matters. We are proud to be Brown community."

Kesha Ram, Burlington, Vermont, running from Senate Chittenden District, said she entered politics because "I got engaged with the community for long, where we care for each other."

One of the youngest ever to be elected to State Assembly at the age of 21, she said, she had left active politics, but now she is back to run for the Senate seat.

"As a daughter of a Punjabi from India, I try to listen and follow up. Ninety percent of what we communicate is through body language. "I strive to make people comfortable," which helps the Indian American win people's hearts.

The Indian American Impact Project, has a political action committee called the Indian-American Impact Fund.

Collectively known as "IMPACT," it was founded by Raj Goyle and Deepak Raj, Chairman of Pratham USA and founder of the Raj Center on Indian Economic Policies at Columbia University.

Deepak Raj noted there are as many as 70 Indian Americans are running for office in the upcoming elections around the nation.

"This is our time," said Raj. "Across the country, a record number of Indian-Americans are running for office. We can't leave it to chance that they will win on their own. We owe them our support - and we have a plan to help them run, win, and lead."

GOPIO Chairman Dr. Thomas Abraham, the coordinator of the event, underscored the need for Indian Americans to come together and help elect candidates from the community across the nation.

Shivender Sofat, President of GOPIO Manhattan, wished all the Indian American candidates' success and offered wholehearted support of the Indian American community.

**NEW YORK (TIP):** The Indian Consulate at New York has issued the following press release to the effect that Cox & Kings Global Services (CKGS), the existing service provider located at 235 West, 23rd Street, New York 10011 for providing outsourcing services for Visa, OCI, Renunciation, Passport and Global Entry Programme (GEP) (Website: [www.in.ckgs.us](http://www.in.ckgs.us)) will shut down its operations at close of business on October 14, 2020. The new service provider, VFS Global would commence its operations from November 02, 2020.

In the interim, October 14 onwards, the Consulate will provide direct limited services only in emergencies.

In this context, it may please be noted that applicants can only submit applications on the CKGS website before the above deadline. Applicants must ensure that the documents are shipped to CKGS with suitable pre-paid return envelope in a manner to ensure it reaches CKGS by October 16, 2020. Any applications received after October 16, 2020 at CKGS will be returned to the applicants without processing.

With effect from October 14, 2020 and till VFS Global commences its operations on November 02, 2020, the Consulate General of India, New York will provide services in emergency cases directly. Applicants falling under CGI, New York jurisdiction are advised to follow the instructions given below to avail emergency services.

- (i) **VISA:** Emergency visa will be issued to the eligible categories allowed to travel to India as per the advisories issued by the Government of India. Applicants for emergency visa may write an email to [visa.newyork@mea.gov.in](mailto:visa.newyork@mea.gov.in) or through PRAMIT dashboard available on our website [www.indianinnewyork.gov.in](http://www.indianinnewyork.gov.in) explaining the exigency. The Consulate thereafter will inform you of the next steps.
- (ii) **PASSPORT:** For emergency passport services, applicants are requested to send an email to [passport.newyork@mea.gov.in](mailto:passport.newyork@mea.gov.in) or through PRAMIT dashboard available on our website [www.indianinnewyork.gov.in](http://www.indianinnewyork.gov.in). Once the request has been approved by the Consulate, the applicant will be informed of the procedure for initiating application process. The approved applicants may send the completed form by postal mail to Consulate along with return pre-paid envelope for further processing.
- (iii) **OCI:** All OCI services will remain suspended till the new service provider takes over on November 02, 2020.
- (iv) **ATTESTATION SERVICES:** Miscellaneous Consular services such as Power of Attorney, Birth Certificate, PCC etc. shall be continue to be accepted by postal mail. # The Tribune, true voice of people

I am really saddened by an unsavory controversy in social media about The Tribune, an organization with which I have remained associated for more than 40 years. I strongly believe that institutions are much bigger than individuals. Individual come and go but institutions stay. Pressures from both the State and the militants notwithstanding, it stood by its avowed principle of staying apolitical. Curfews and censorships failed to deter from its path of reporting the developments.

As the voice of people, the credibility of The Tribune remained unquestionable. Its readers would vouch for its stories. Unlike many other media organizations, The Tribune continued to distinguish itself with its editorial supremacy. While the management generally thrived upon its past laurels, members of the editorial staff took the challenges, including threats not only to their lives but also their families, in their stride to uphold the professional values.

Besides the professional challenges, The Tribune also had to compete with market forces as some of the leading national media houses also started their

editions from Chandigarh. While editorially The Tribune was ahead of its impending challenges, the management was still basking in the glory of monopoly era.

While the professional competitions were trying to make dents in strongholds of The Tribune, the management was slow to react. Issues about limited visibility of The Tribune publications at popular public spots like Railways Stations, Bus Stands, Airports, Hotels and Libraries were overlooked.

It is pertinent to mention that The Tribune not only faced challenges from strong rival national publications but also had to support two of its sister publications that even after more than 40 years are still dependent upon the mother publication for their survival. While the Punjabi and the Dainik Tribune have struggled throughout, many other vernacular newspapers that came to the region much later have scripted success stories. Some blame must go to the trade unions that have generally been dominated by the loss bearing sister publications.

It may sound strange but is true that while the employees of The Tribune were required to work and support for the Dainik and Punjabi editions as well, wage structures of the new publications, though in much lower category under the Wage Board guidelines, were brought at par with the mother publication.

Incidentally, the City pull outs started in late 90s became self-supporting within a couple of years of

their launch. I had the distinction of leading the launch of Chandigarh Tribune that became number one among all City pull outs. And all members of the City team, including its desk staff, worked in total unison to make this experiment successful even after the usual management impediments.

For any newspaper to grow, editions are launched to expand the paper's base in the region. Therefore, it was only logical that The Tribune launched its J&K and Uttarakhand editions.

While doing so, The Tribune Trust left it to the editorial section to decide on the number of pages/paginations. Historically, The Tribune has been a big paper in J&K even when it was published from Lahore. So the Trust rightly decided to bring out an edition for the people of J&K. Unfortunately, the edition has had to be closed owing to the failure of the business side, especially the circulation and advertisement departments. While HT and TOI are viable in Uttarakhand and Daily Excelsior and Greater Kashmir in J&K, The Tribune was rendered non-viable because of the declining advertisement and circulation revenue from the main edition in the past 6-7 years. The paper was unable to subsidize the J & K edition and had to close it.

Handpicked associates of a former GM, who are now on important positions, have been using the employees' union and the website to attack the editorial section and the Trust to divert attention from their own failures and to deflect blame.

While everyone has a right to criticize any individual or a group, but an attempt to tarnish the image of this great institution, The Tribune, and its editorial team, is both unwarranted and deplorable.

In her article Let Them Eat Bread: The Theft That Helped Inspire 'Les Misérables' which appeared in the 'npr'(National Public Radio) in March 2017,Nina Martyris wrote:

"On a bitterly cold day in February 1846, the French writer Victor Hugo was on his way to work when he saw something that affected him profoundly. A thin young man with a loaf of bread under his arm was being led away by police. Bystanders said he was being arrested for stealing the loaf. He was dressed in mud-spattered clothes, his bare feet thrust into clogs, his ankles wrapped in bloodied rags in lieu of stockings."

"It made me think," wrote Hugo. "The man was no longer a man in my eyes but the specter of la misère, of poverty." In his novel, Hugo portrays the family's

circumstances in these few, short lines: "A very hard winter came. Jean had no work. The family had no bread. No bread literally. Seven children!"

Jean Valjean is sentenced to five years' hard labor for stealing a loaf of bread! He attempted to escape four times, and each time his sentence was lengthened by three years; he also received an extra two years for once resisting recapture during his second escape. After nineteen years in prison, he was released, but by law had to carry a yellow passport that announced that he is an ex-convict, an outcast. Hugo uses that loaf to attack society's criminal indifference to poverty and hunger and to highlight the injustice of the penal system.

'Les Misérables' should have awakened mankind's conscience, but one must ask oneself if it has succeeded in doing that. As former US President Dwight Eisenhower said, "Every gun that is made, every warship launched, every rocket fired, signifies in the final sense a theft from those who hunger and are not fed, those who are cold and not clothed".

As the humanitarian organization Mercy Corps puts it, "Hunger and malnutrition are the biggest risks to health

worldwide - greater than AIDS, malaria and tuberculosis combined. Globally, food deprivation still claims a child's life every three seconds and nearly half of all deaths in children under five are attributable to undernutrition". Eveyone.org, another charity organization says "Every hour of every day, 300 children die because of malnutrition. It's an underlying cause of more than a third of children's deaths - 2.6 million every year". There is an urgent need to take action on war footing against such a situation.

Thus, the announcement by the Norwegian Nobel Committee on October 9 that the World Food Programme(WFP) has been awarded the Nobel Peace Prize in 2020 is indeed most welcome. The award has been given for its efforts to combat hunger, for its contribution to bettering conditions for peace in conflict-affected areas and for acting as a driving force in efforts to prevent the use of hunger as a weapon of war and conflict.

The World Food Programme(WFP) has indeed been doing God's work by providing food aid through the UN system since 1961. Its website mentions: "Every day too many men and women across the globe struggle to feed their children a nutritious meal. In a world where we produce enough food to feed everyone, 690 million people still go to bed on an empty stomach each night. Acute food insecurity affected 135 million people in 55 countries in 2019. Even more - one in three - suffer from some form of malnutrition".

Since its establishment, the WFP has responded to natural disasters and conflicts around the world. Currently, it is working in a number of countries, and it faces its severest challenges in three conflict-torn countries, namely Yemen, Afghanistan and South Sudan.

Announcing the Nobel Peace Prize, the Chairperson of the Committee, Berit Reiss-Andersen said at a news conference: "The World Food Programme plays a key role in multilateral co-operation in making food security an instrument of peace". She also said that with this year's award, the committee wanted to "turn the eyes of the world to the millions of people who suffer from or face the threat of hunger".

In 2015 the global community adopted the 17 Global Goals for Sustainable Development to improve people's lives by 2030. Goal Two is 'Zero Hunger' which pledges to end hunger, achieve food security, improve nutrition and promote sustainable agriculture. Achieving this goal is the priority of the WFP; if present trends continue, the number of people affected by hunger will surpass 840 million by 2030, or 9.8 percent of the global population.

It may be mentioned that India has enjoyed steady economic growth and has achieved self-sufficiency in grain production in recent years. Despite this, high levels of poverty, food insecurity and malnutrition persist. The WFP's website mentions that it has been working in India since 1963, with work transitioning from food distribution to technical assistance since the country achieved self-sufficiency in cereal production. It also says something that should prick our conscience: "India is home to a quarter of all undernourished people worldwide, making the country a key focus for tackling hunger on a global scale. In the last two decades, per capita income more than tripled, yet the minimum dietary intake fell. The gap between rich and poor increased during this period of high economic growth".

Coronavirus has further multiplied the challenges which India faces. In the second week of April 2020 itself, the International Labour Organization (ILO) had said that about 400 million workers from India's informal sector are likely to be pushed deeper into poverty due to Covid-19. There is no doubt that during the past six months, poverty in the country has worsened; so too, has hunger. The Government as well as many NGO's are grappling with the colossal problem of feeding millions of impoverished people who have lost even their means of earning a livelihood.

We, as individuals, also have a great responsibility. In such trying times, the words of Mother Teresa should guide us: " If you cannot feed a hundred people, then feed just one."

Basham spoke with Joseph Cotto about his new data. Pollwatch had a good thread summarizing the interview. Democracy Institute's poll had a sample size of 1500 voters, where Trump leads Joe Biden by one point. He also noted that the "shy Trump" vote is very much alive and will be bigger this time. Suburban white women and urban black women are the two groups that are most likely to fall into the shy category for the 2020 cycle. That latter part should shake Democrats to their core. And as for Florida, a state that Biden must carry, it could already be out of his reach. Basham notes Trump cannot fall asleep at the wheel, but things are becoming more comfortable for him in the Sunshine State. And based on some recent polling from the state, it looks like the tide has shifted solidly in favor of Trump.

The outcome of Election Day 2020 would seem to be a foregone conclusion if the latest national and battleground polls are

any guide as to whether President Trump will win in his reelection bid.

However, the GALLUP poll has just released the results of a new survey that suggests President Trump might have a better shot than you would think.

Most Americans responded positively to the survey question asking whether they feel better off now than they did four years ago.

Trump's odds of winning reelection seem to be growing slimmer by the day though, it is worth remembering that we have also seen this movie play out before. This is not the first time that Trump has been in this predicament.

## DOES OHIO PROVIDE A MODEL FOR PRESIDENTIAL VICTORY?

No Republican has won the Presidency without winning Ohio. Franklin D Roosevelt in 1944, and John F Kennedy in 1960 won without winning Ohio. President Trump won Ohio by 8 points in

# 15 killed in Pakistan terror attack

**ISLAMABAD (TIP):** Eight soldiers and seven civil security personnel were killed in a terrorist attack in Pakistan's Balochistan province, police sources said.

The incident took place on October 15 in Ormara area, when a group of militants ambushed and attacked a convoy of the Frontier Corps (FC) and Oil and Gas Development Company Limited (OGDCL), and fled the scene, the sources told Xinhua news agency.

"Two vehicles of OGDCL were being escorted by three FC vehicles on their way to Karachi when they were attacked by the militants who used sophisticated weapons in the offensive," the sources added.

The vehicles were also burned and destroyed by the militants following the attack.

Paramilitary troops and personnel from the Pakistan Navy reached the attack site and shifted the bodies to a nearby naval base.

A search operation to arrest the fleeing militants was launched in the area.

Baloch Raji Ajoi Sangar (BRAS), an



outlawed organization formed with the coalition of several extremist outfits of the province, claimed responsibility for the attack.

The same outfit killed some 14 personnel of the navy in an attack launched in the same area in April 2019.

Condemning the attack, Prime Minister Imran Khan sought a solicited report into the incident and directed the concerned authorities to make every possible effort to identify and bring the perpetrators of the attack to justice.

## Bangladesh okays death penalty for rapists

**DHAKA (TIP):** Bangladesh's Cabinet on October 12 approved an increase in the maximum punishment in rape cases to death from life imprisonment after a series of recent sexual assaults triggered protests on streets and in social media.

Cabinet spokesman Khandaker Anwarul Islam said President Abdul Hamid was likely to issue an ordinance amending the Women and Children Repression Prevention Act because Parliament was not in session. Details of the amendment were not immediately available, but Islam said the Cabinet agreed to a proposal that trials in rape cases be completed in a speedy manner. Under the current law, the maximum punishment in rape cases is life imprisonment, except for cases in which the victim dies, when capital punishment is allowed.

Law Minister Anisul Huq said the President was expected to issue the ordinance on Tuesday. A series of violent sexual attacks in recent weeks has triggered protests in the capital, Dhaka, and elsewhere. Local human rights groups say rapes have surged in the country. Ain-o-Salish Kendra, a women's rights group, said 889 rapes, including many gang rapes, occurred between January and August. At least 41 victims died, it said. Rights groups say many more cases remain unreported because of fears of harassment by influential people. Bangladesh's judicial system is painstakingly slow and cases often take years to finish. Protests broke out in recent days after a video of a group of men stripping and attacking a woman in a southeastern district went public through Facebook. AP

## Pak to celebrate Guru Nanak's 551st birth anniversary from November 28-30



**ISLAMABAD (TIP):** Pakistan will celebrate the 551st birth anniversary of Sikh faith's founder Guru Nanak Dev from November 28 to 30, the Foreign Office said on October 15.

Every year, a large number of Sikh pilgrims from India and different parts of the world gather at the Gurdwara Janamasthan Nankana Sahib, the birth place of Guru Nanak, in Pakistan's Punjab province to mark his birth anniversary. However, the COVID-19 pandemic is likely to affect festivities this year.

Addressing a media briefing here, Foreign Office Spokesperson Zahid Hafeez Chaudhri said that the 551st birth anniversary of Guru Nanak would be celebrated from November 28 to 30.

He said that Pakistan reopened the Kartarpur corridor on July 29, but India has not yet opened from its side.

The corridor – which allows Indian pilgrims to undertake visa-free travel to the historic Kartarpur Sahib gurdwara – was closed on March 16 due to the COVID-19 pandemic.

India has said a decision to re-open the

Kartarpur corridor would be taken in accordance with the protocols relating to COVID-19 and easing of restrictions.

Chaudhri expressed the hope that India will review its decision in view of the upcoming 551st birth anniversary of Guru Nanak.

The corridor links Dera Baba Nanak shrine in Gurdaspur in India to Gurdwara Kartarpur Sahib in Pakistan – the final resting place of Guru Nanak.

In response to a question about the construction of a bridge on the Ravi river, Chaudhri said that Pakistan has already started the construction work on its side of the bridge, but "India has not yet provided engineering design of its side of the bridge".

Kartarpur Sahib Gurdwara is located in Pakistan's Narowal district across the river Ravi, about four kilometres from the Dera Baba Nanak shrine.

In November last year, the two countries threw open the corridor linking Dera Baba Sahib in Gurdaspur in India and Gurdwara Kartarpur Sahib in Pakistan, in a historic people-to-people initiative. PTI

## Emergency in Thailand amid massive protests

**BANGKOK (TIP):** Thailand declared a new state of emergency for the capital on October 15, a day after a student-led protest against the country's traditional establishment saw an extraordinary moment in which demonstrators heckled a royal motorcade.

After the pre-dawn declaration, riot police moved in to clear out demonstrators who after a day of rallies and confrontation had gathered outside Prime Minister Prayuth Chan-o-cha's office to push their demands, which include the former general's stepping down, constitutional changes and reform of the monarchy.

Several top leaders of the protest movement were taken into custody. The police said they had made 22 arrests.

The text of the emergency declaration said it was needed because "certain groups of perpetrators intended to instigate an untoward incident and movement in the Bangkok area by way of various methods and via different channels, including causing obstruction to the royal motorcade."

The royal family is considered sacrosanct and a pillar of Thai identity. — AP

## Oli sparks speculation by keeping defence ministry with himself in Cabinet reshuffle

**KATHMANDU (TIP):** Nepal's Prime Minister KP Sharma Oli has reshuffled his Cabinet, keeping the key defence portfolio with himself, in a bid to strengthen his grip within the fractious ruling party and to allow smooth functioning of his government. Oli has inducted three new ministers, including Finance Minister Bishnu Poudel, and changed the portfolio of Deputy Prime Minister and Defence Minister Ishwor Pokharel. However, the dissident faction of the ruling Communist Party of Nepal led by executive chairman Pushpa Kamal Dahal 'Prachanda' was not satisfied with Oli's latest move, which they considered as one-sided, a source close to the ruling party said.

Oli and Prachanda, bitter political rivals, have been trying to shore up their base within the party in recent months. The finance ministry had remained vacant for some time and the nomination of Poudel, who is also the general secretary of the ruling party, to the department was a normal phenomena, the party source said. However, Oli's move to relieve Pokharel from the defence ministry and retain the portfolio with himself has sparked speculation in the Nepalese political spectrum and the media. PTI

## Senate Committee to vote on Barrett Supreme Court nomination on Oct. 22

**WASHINGTON (TIP):** The U.S. Senate Judiciary Committee on Thursday scheduled a vote for Oct. 22 on the nomination of Judge Amy Coney Barrett to the Supreme Court.

The vote was set by the majority Republicans on the committee after Democrats attempted to delay the process by invoking a committee rule requiring two members of the minority party to be present to conduct business.

"I want to take official note of the fact that I am the only member of the minority that is here, and so we cannot conduct business until that second member of the minority arrives," Sen. Richard Durbin (D-IL) said.

Committee Chairman Lindsey Graham (R-SC), however, said the panel would proceed with its business. "If we create this problem for you in the future, you're going to do what I'm going to do which is move forward on the business of the committee," he said.

The exchange came on the final day of Barrett's nomination hearings, at which experts invited by Democrats and Republicans commented on the nominee's qualifications.

The Judiciary Committee is all but certain to approve Barrett's nomination, which will clear the path for a full Senate vote.

"She'll come out of committee next Thursday ... and we'll go to the floor with her on Friday the 23rd and stay on it until we finish," Senate Majority Leader Mitch McConnell (R-KY) said to reporters in Kentucky. After being asked if the Senate would approve her nomination, he replied, "We have the votes."

## US weekly jobless claims rise to 898,000



**WASHINGTON (TIP):** The number of Americans who filed initial claims for unemployment insurance rose to 898,000 during the week ended October 10, the Labor Department said on Thursday, October 15.

The number of people claiming benefits in all unemployment programs during the week ended September 26 was 25.29 million, the Labor Department said.<sup>1</sup> There were 1.42 million people claiming benefits across all programs during the comparable week in 2019.

This week's initial claims figure is 53,000 higher than the previous week's.

During the week ended October 10, some 372,891 people in 51 states and territories filed initial claims for

Pandemic Unemployment Assistance (PUA), which provides unemployment benefits to workers ineligible for standard unemployment benefits.

During the week ended September 26, a total of 11.17 million individuals in 51 states and territories were claiming the benefit, the Labor Department said.

In that same week, 49 states reported a total of 2.78 million people claiming Pandemic Emergency Unemployment Compensation (PEUC), which provides an additional 13 weeks of unemployment benefits to those who have used up their standard unemployment benefit.

PUA and PEUC will expire by December 26 if not extended by Congress.

## No benefit of Remdesivir in reducing COVID deaths: WHO study

**NEW DELHI / NEW YORK (TIP):** Widely prescribed antiviral drug Remdesivir has shown little or no benefit in reducing COVID-19 deaths, the world's largest trial on the efficacy of four repurposed drugs on COVID-19 mortality reveals ten months into the pandemic outbreak.

Interim results from the WHO Solidarity Trial, which studied re-purposed anti-viral drugs Remdesivir, Hydroxychloroquine, Lopinavir, and Interferon-?1a found none of these helped reduce deaths in COVID patients.

The trial ran through March 22 to October 4, 2020 and followed 11,266 patients in 405 hospitals across 30 countries in all six WHO regions.

"These drug regimens appeared to have little or no effect on hospitalized COVID-19 patients as indicated by overall mortality, initiation of ventilation and duration of hospital stay. No study drug appreciably reduced initiation of ventilation in those not already ventilated," said the pre-print of the study published today.

Authors said the chief aim of the trial was to help determine whether any of four re-purposed antivirals could at least moderately affect in-hospital mortality and whether any effects differed between moderate and severe disease. "For each of these 4 repurposed non-specific antivirals, several thousand patients have now been randomized in various trials. The overall findings suffice to refute early hopes based on smaller or non-randomized studies that any will substantially reduce inpatient mortality, initiation of ventilation or hospitalization duration," the researchers note.

Indian expert K Srinath Reddy, one of the study authors, told The Tribune, "This was the world's largest trial on Remdesivir and three other repurposed drugs. None showed any benefit in reducing deaths. Of the 2743 patients who were given Remdesivir, 301 died and in the control group of 2708 patients who were given other treatments, 303 died. So, there was no impact on mortality reduction." US-based Gilead Sciences, the makers of Remdesivir, however, issued a statement today, saying, "The emerging data appear inconsistent with more robust evidence from multiple randomized, controlled studies published in peer-reviewed journals validating the clinical benefit of Remdesivir."

- Democratic presidential nominee Joe Biden said President Trump had bungled the U.S. response to the COVID-19 coronavirus pandemic and said the country needed a national approach to handle it.<sup>2</sup> "He missed enormous opportunities and kept saying things that weren't true," Biden said about the president at a town hall event hosted by ABC.
- President Trump leads former Vice President Biden in South Carolina 49% to 41%, according to a New York Times/Siena College poll published on Thursday.<sup>3</sup> South Carolina Republican Sen. Lindsey Graham leads his Democratic opponent Jaime Harrison by 6 points, according to the poll, which has a 4.5-point margin of error.
- The campaign of Democratic presidential nominee Joe Biden raised \$383 million in September. Biden said the donations came from 5.5 million donors at an average of \$44.4 In August, Biden raised \$364.5 million.

## YouTube cracks down on QAnon conspiracy theory

**NEW YORK (TIP):** YouTube on Thursday, October 15, said it would prohibit content promoting conspiracy theory QAnon that targets an individual or group, becoming the latest media giant to crack down on the online phenomena.

YouTube announced in a blog post that it was updating its harassment and hate speech policies to ban "content that targets an individual or group with conspiracy theories that have been used to justify real-world violence."

QAnon is an unfounded conspiracy theory that claims the existence of a cabal of child sex predators in which prominent Democrat lawmakers and Hollywood elites are involved. It has been identified by FBI officials as a potential motivator of domestic terrorism.

Facebook and Twitter have also taken action against the conspiracy theory. YouTube said it will begin enforcing the new policies immediately, "and will ramp up in the weeks to come."

YouTube in 2019 updated its policies to reduce the visibility of certain videos in search results and recommendations, resulting in an 80% drop in non-subscribed recommendations to channels related to the conspiracy theory, the company said.

Ambassador complimented the TiE members and entrepreneurs for driving technology and innovation.



Republicans accuse Twitter, Facebook of unfair censorship of New York Post story about Hunter Biden



**NEW YORK (TIP):** Twitter and Facebook were subject to public scrutiny on Wednesday, Oct 14 and Thursday, October 15 over their handling of two New York Post stories about Hunter Biden, son of Democratic presidential candidate Joe Biden.

The stories reference emails the newspaper says it recovered from a laptop that purportedly belonged to Hunter Biden. The story says the emails detail Hunter Biden's business dealings in Ukraine while his father was vice president.

The claims have not been verified, and the Biden campaign denied central elements of the stories.

Twitter prevented users from posting links to the stories due to the inclusion of private information such as email addresses and other "hacked materials."

Facebook limited the distribution of the story in its news feed. It later said this was part of its "standard process" to allow third-party fact-checkers to review it and decide whether or not it should be regarded as misinformation.

"Never before have we seen the censorship of a major outlet's reporting," said Senator Ted Cruz (R-Texas).

After Republican members of the House Judiciary Committee posted a copy of the New York Post article on their website, Twitter blocked users from posting the link.

The new service provider is VSF Global, likely to start operations from November 2. In the interim, October 19 onwards, the Embassy of India will provide direct limited services only in emergencies.

"In this context, the following may kindly be noted:-

- Applicants can only submit applications on the CKGS website before the above deadline.
- Applicants must ensure that their documents are shipped to CKGS with suitable pre-paid return envelopes in a manner to ensure it reaches CKGS by 1700 hours Eastern Standard Time on Friday, 16 October 2020.
- Any applications received after 1700 hours

Eastern Standard Time on Friday, 16 October 2020 will be returned to the applicants without processing.

(iv) Applicants must ensure that they receive back the processed documentation from CKGS as it will not be possible for CKGS or the Embassy to take care of any returned envelopes. The responsibility is that of the applicant.

With effect from 19 October 2020 and till M/s VFS Global - the new outsource service provider takes over operations (expected from 02 November 2020), the Embassy of India will provide direct limited services only in emergencies. Applicants are advised to keep in mind consular jurisdiction as well as the emergency contact information of the Embassy/Consulates in USA and submit an application to the relevant office.

## Even Pak handled Covid better than India: Rahul

**NEW DELHI (TIP):** Congress leader Rahul Gandhi took a dig at the centre on Friday Oct 16, over IMF's projection that the Indian economy is set to contract by a massive 10.3 per cent this year, saying it was another "solid achievement" by the government.

Gandhi took a swipe at the government on Twitter by tagging a chart that showed IMF growth projections for 2020-21 for Bangladesh, Myanmar, Nepal, China, Bhutan, Pakistan, Sri Lanka, Afghanistan and India.

The chart showed that the Indian economy is projected to contract by a massive 10.3 per cent this year, the highest contraction among the countries mentioned.

"Another solid achievement by the BJP government. Even Pakistan and Afghanistan handled Covid better than India," Gandhi tweeted with the chart.

## Woman has right to stay at estranged in-laws' home: SC



**Domestic violence in the country is rampant and every day some women encounter violence in some form or other, the Supreme Court said**

Section 2(s) cannot be read to mean that shared household can only be that household which is household of the joint family of which husband is a member or in which husband of the aggrieved person has a share".

The court also rejected the man's appeal that his son had no share in the property at the posh New Friends Colony area of Delhi.

The judgment dismissed an appeal filed by one Satish Chander Ahuja challenging a Delhi High Court judgment of 2019, which ruled that his daughter-in-law Sneha Ahuja had the right of residence even though she was in the process of divorce from her husband Raveen Ahuja.

Satish Ahuja had also appealed that his son had no share in the house as the property was his self-earned.

Interpreting the provisions of Section 2 (shared household) and Section 17 (right of residence) under the Domestic Violence Act, the judges said: "The definition of shared household given in

# India's Covid-19 tally rises to 7.37 million; recoveries at 6.4 million

**NEW DELHI (TIP):** With 63,371 fresh cases of the coronavirus disease (Covid-19) and 895 related deaths in the past 24 hours, India's tally went up to 7,370,468, rising by more than 100,000 since the beginning of this month, according to the Union health ministry on Friday, October 16.

India has been reporting around 66,000 new Covid-19 cases daily since October 12 and even witnessed 55,342 infections on October 13, official data shows. Deaths have also been fewer with 816 succumbing to the viral disease on October 12 and 680 fatalities on Thursday. The number of deaths have been sustained below the 1,000 mark since the last 17 days.

The health ministry said on Friday that the country continues to have one of the lowest deaths per million population due to the coronavirus disease compared to other countries across the world. It also said that at least 22 states and Union territories have lower deaths per million population than the national average, which is currently at 80. "Some States/UTs are performing better and reporting much lower deaths/million population than the national average," the ministry posted on Twitter.

There are 804,528 active cases of the coronavirus disease and the death toll in the country, which is the second worst-hit in the world, has gone up to 112,161, the



health ministry's dashboard showed at 8am. There have been 6,453,779 recoveries so far with 70,338 people cured of the respiratory disease in the last 24 hours. This has taken the national recovery rate to 87.56%.

"India is reporting a progressively high increase in the recoveries and a

persistent decline in the percentage of active cases. As a result, the doubling time of the infection has sharply improved. It is now almost 73 days (72.8 days). This indicates a substantial fall in the daily New Cases and the consequent increase in time taken to double the Total Cases," the health ministry said.

## India rejects China's stance on border infra and Ladakh

**NEW DELHI (TIP):** India on Thursday, October 15, called on China to work for complete disengagement at friction points on the Line of Actual Control (LAC), while rejecting Beijing's contention that infrastructure development and troop deployments by New Delhi were the root causes of tensions at the border.

External affairs minister S Jaishankar, participating in the Bloomberg India Economic Forum online, made it clear that New Delhi wasn't to blame for the standoff in the Ladakh sector that has entered its sixth month. Acknowledging the gravity of the situation, he pointed out India and China had built their relationship and expanded cooperation over the past 30 years "predicated on peace and tranquillity along the border".

"If that underlying peace and tranquillity is disturbed, if the agreements which the two sides signed are not honoured, then clearly that is the primary cause of the disruption," Jaishankar said. He added: "If you disturb the foundation of this relationship, you cannot be impervious to the fact that it will have consequences...that problem...was not created on our side."

China's foreign ministry had on Monday cited India's infrastructure development and troop deployments as the root causes of tensions. It also said India should refrain from actions that could escalate the situation.

The external affairs ministry also

dismissed China's stance on not recognising Arunachal Pradesh state and the Union Territory of Ladakh, saying both regions are an integral part of India and Beijing has no locus standi to comment on such internal matters.

The remarks by external affairs ministry spokesperson Anurag Srivastava reflected the stalemate in efforts to end the Ladakh standoff, and the lack of progress in disengagement of troops at friction points after several rounds of diplomatic and military talks.

Srivastava said India was creating infrastructure that improved the lives of its people. "The government gives careful and specific attention to improvement of infrastructure for the development of border areas in order to facilitate economic development of these areas, as also to meet India's strategic and security requirements," he said.

PM Modi, Shah likely to hold 15-20 rallies in poll-bound Bihar

**NEW DELHI (TIP):** Prime Minister Narendra Modi is expected to address an election rally at Aarah in Bihar either on October 23 or 24, sources said. It is expected he may hold around 12 rallies with Chief Minister Nitish Kumar, the face of the NDA, they added. Leaders said BJP candidates have asked for four more rallies of the Prime Minister for which a final decision of the PMO is awaited. Apart from the Prime Minister, Union Home Minister Amit Shah is also likely to hold "15 to 20" rallies in the three-phased elections.

### Exit poll ban applies to astrologers, analysts

When there is a ban on exit polls, prediction of poll results in the media by astrologers, tarot readers and analysts is a violation of the electoral law, the Election Commission said on Thursday, Oct 15.

The EC's advisory, re-issued ahead of the three-phase elections in Bihar beginning later this month, asked the media, both electronic and print, to "refrain" from airing and publishing such programmes during the prohibited period to ensure free, fair and transparent polls.

The advisory was first issued on March 30, 2017 in which the poll watchdog cited Section 126A of the Representation of the People Act.

### Kerala gold smuggling case accused linked to Dawood: NIA

In a major development in the Kerala gold smuggling case, the NIA has found links between one of the accused and India's most wanted underworld don Dawood Ibrahim Kaskar and his gang.

The National Investigation Agency probe has revealed that one of the accused visited Tanzania, where the 1993 Mumbai accused has vast networks, to launch his diamond business and to smuggle firearms.

The submissions were made by the anti-terror probe agency in a Special NIA court here on Wednesday.

"KT Ramees and M Sharafuddin visited Tanzania on several occasions and met one of Dawood's close aide Feroze 'Oasis' and discussed ways to smuggle firearms into the country," an NIA official related to the probe told IANS. The official said that Ramees visited Tanzania first in 2016 to start a diamond business there. He then also smuggled one kilo gold from Tanzania to the UAE in 2017.

Ramees was caught with 13 smuggled revolvers at the Kozhikode airport in November 2019.

## TRP probe: Freeze on rating news channels for 8-12 weeks

**NEW DELHI (TIP):** Broadcast Audience Research Council (BARC), the industry body that measures Television Rating Points (TRPs), has suspended the publication of weekly individual ratings of news channels for "eight to 12 weeks", days after Mumbai Police began investigating a "racket" of fraudulent manipulation of TRPs.

Five persons, including two former employees of Hansa, the agency that calculates the ratings for BARC, have been arrested. At least three channels — Arnab Goswami's Republic, Box Cinemas, and Fakt Marathi — are allegedly involved in the racket, according to police.

In a statement, BARC said that "[i]n the light of the recent developments, BARC Board has proposed that its Technical Committee (Tech Comm) review and augment the current standards of measuring and reporting the data of niche genres, to improve their statistical robustness and to significantly hamper the potential attempts of infiltrating the panel homes".

This exercise, BARC said, would cover "all Hindi, Regional, English News and Business News channels with immediate effect" — and that it would "cease publishing the weekly individual ratings for all news channels during the exercise". The process is "expected to take around 8-12 weeks including validation and testing under the supervision of BARC's Tech Comm", the statement said.

TRPs are a measure of TV-watching



behaviour, and one of the main things advertisers look at while choosing channels. News Broadcasters' Association (NBA), the representative body of private news channels, welcomed the BARC announcement, and said it should use the period to "completely overhaul its systems and restore the credibility of the information it collects about What India Watches".

The BARC statement quoted its board chairman Punit Goenka as saying: "Given the most recent developments, the BARC Board was of the opinion that a pause was necessitated to enable the industry and BARC to work closely to review its already stringent protocols and further augment them to enable the industry to focus on collaborating for growth and well-natured competitiveness".

### GST COMPENSATION

#### Govt softens stand, to borrow for states

**NEW DELHI (TIP):** The Union finance ministry on Thursday, Oct 15, said that the Rs 1.1 lakh crore estimated shortfall in Goods and Services Tax (GST) compensation cess will be borrowed by the central government and "passed on to the states as a back-to-back loan", allaying concern of states that they would have to pay higher interest rates if they approach the market individually.

The Centre's move, detailed in a statement from the finance ministry, is likely to put to rest, for now, the controversy over the compensation cess shortfall that had caused a major split in the GST Council, with no consensus being reached after three meetings. It also keeps the concept of fiscal federalism, the core of GST, alive.

The finance ministry statement added that the borrowing would "not have any impact on the fiscal deficit of the Government of India" and "be reflected as capital receipts of the state government as part of the financing of the respective fiscal deficits".

As a result, this borrowing doesn't go into what is called general government borrowings (the debt of the Centre and the states).

"It appears that the loan is treated as capital receipts of the state governments, which will have some positive impact on state finances, but we need to see the fine print," said the finance minister of one of the dissenting states, requesting anonymity.

The minister said it is prudent for the government to borrow the entire amount to get a better rate, but there are other concerns — the Centre should have borrowed the entire shortfall and repay from the compensation cess fund as the financial position of most of the states.

## Farooq Abdullah, Mehbooba Mufti, other J&K political parties team up for restoration of Article 370

**NEW DELHI (TIP):** The key political leaders of Jammu and Kashmir, including National Conference patriarch Farooq Abdullah, his arch-rival Mehbooba Mufti of the People's Democratic Party and Sajjad Lone, came together on October 15 evening to fight for the restoration of Article 370 and resolution of Kashmir. The freshly minted "People's Alliance for Gupkar Declaration" comes more than a year after the Centre ended the special status of Jammu and Kashmir granted under the constitution and bifurcated the state into two Union Territories.

Most of the political leaders in Kashmir Valley have been in custody for long — it was part of the preventive measures against backlash taken by the Centre last August, a day before making the huge announcement in parliament.

Abdullah, 82, was released in March, days before the nationwide lockdown was announced. Mehbooba Mufti was released on Tuesday.

"Our battle is a constitutional battle, we want the Government of India to return to the people of the state the rights they held before 5th August 2019," Abdullah said. "We shall struggle for restoration of what was snatched from



Jammu Kashmir and Ladakh," he added.

Abdullah also said the alliance seeks a dialogue between all stakeholders for resolution of Kashmir.

The National Conference chief had convened the meeting at his home to chalk out the future course of action on "Gupkar Declaration" with regard to the special status of Jammu and Kashmir.

The Gupkar Declaration was signed on August 4, 2019, after an all-party meeting at the Gupkar Road residence of

Abdullah. It marked a resolution of attending regional parties and the Congress to protect Jammu and Kashmir's special constitutional status and fight against any move to dilute it.

Two days later, the Centre ended the special status of the state granted under the Article 370 of the Constitution and bifurcated it into two Union Territories.

This August, the political parties had met again, and vowed to fight for restoration of the special status of Jammu and Kashmir.



**B**elly of the Beast" presents a decade long, infuriating contemporary legal drama invoking the weight of the historic stain and legacy of eugenics.

When an unlikely duo discovers a pattern of illegal sterilizations in women's prisons, they wage a near impossible battle against the Department of corrections. Filmed over seven years with extraordinary access and intimate accounts from currently and formerly incarcerated people, Belly of the Beast exposes modern-day eugenics and reproductive injustice in California prisons.

The pastoral farmlands surrounding the Central California Women's Facility, the world's largest women's prison, help conceal the reproductive and human rights violations transpiring inside its walls. A courageous woman who was involuntarily sterilized at the facility teams up with a radical lawyer to stop these violations. They spearhead investigations that uncover a series of statewide crimes, primarily targeting women of color, from inadequate access to healthcare to sexual assault to illegal sterilization.

Together, with a team of tenacious heroines, both in and out of prison, they take to the courtroom to fight for reparations. But no one believes them. As additional damning evidence is uncovered by the Center for Investigative Reporting, a media frenzy and series of hearings provide hope for some semblance of justice. Yet, doctors and prison officials contend that the procedures were in each person's best interest and of an overall social benefit. Invoking the weight of the historic stain and legacy of eugenics, "Belly of the Beast" presents a decade long, infuriating contemporary legal drama.

# RHEA CHAKRABORTY TO SUE RUMOUR MONGERS AND MEDIA FOR DEFAMATION

**R**hea Chakraborty will take legal action against rumour mongers and the media for spreading false information and defaming her in connection with Sushant Singh Rajput's death case. A statement issued by Rhea Chakraborty's lawyer, Satish Maneshinde, said that a list of people will be forwarded to the CBI who made false claims on TV and electronic media.

The statement read, "We will be forwarding a list of people to CBI who made fake and false claims on TV and Electronic Media, including carrying mobile recording and fake stories on SSR case with particular reference to Rhea Chakraborty to go after them and record their statements. We will request CBI to take legal proceedings against them for misleading the investigations. -- Adv Satish Maneshinde (sic)."

Rhea has now written a letter to the Central Bureau of Investigation (CBI) officer Nupur Prasad, requesting them to take action against her neighbour, who claimed in a few TV interviews that she saw Sushant Singh Rajput and Rhea together on June 13.

"I was Interrogated for more than 5 days by the CBI in connection with the death of Sushant Singh Rajput. During the investigation, several media channels carried false and bogus stories without any material to substantiate these patently false and fabricated claims in order to achieve their own ends.

"I say that one such person, Mrs Dimple Thawani, made patently false and bogus allegations against me knowing them to be false, to mislead the investigation in the above case. The allegation was that the late Sushant Singh Rajput had dropped me to my residence in his car on the 13th of June 2020, which is utterly false."

## Aditya Narayan to tie the knot with Shweta Agarwal



## Indian American attorney Ronak Desai named 'rising star' by National Law Journal

WASHINGTON (TIP): The National Law Journal has recognized prominent Indian American attorney Ronak Desai as one of its DC "Rising Stars." The award recognizes the region's 40 most promising lawyers age 40 and younger, "who have wielded influence in their practice areas in the D.C. area and beyond," and is conferred upon "innovators who develop unique practice niches, secure wins for clients, and demonstrate strong leadership qualities."

Selected from hundreds of nominees, Desai's impactful work in the white collar, anticorruption, India, and congressional investigations spaces along with his "sustained pro bono work and commitment to public service," earned his inclusion on the coveted list.

Desai is a longtime Indian American community leader who has fast emerged as an influential next-generation practitioner and scholar in the legal and foreign policy fields. In addition to his private sector work at some of the

country's most exclusive law firms, Desai also spent two years as counsel to the U.S. Congress. In 2014, Representative Elijah Cummings appointed Desai as legal counsel to the high-profile House Select Committee on Benghazi. The pioneering congressman passed away in October 2019.

With 22 offices around the world, the firm generated over \$1.2 billion in revenue last year. Paul Hastings consistently ranks among the top 10 on The American Lawyer's "A-List" of law firms.

Desai named Herrington as one of his greatest mentors in legal practice in his interview with the NLJ, along with DC Circuit Chief Judge Sri Srinivasan, and former U.S. Ambassador to India Richard Verma.

"Ronak is an outstanding lawyer who combines a razor-sharp legal mind with a natural affability. [He] is respected by clients and adversaries in equal measure," Herrington said to media.

The view was echoed by opposing counsel Desai has worked with on Capitol Hill, who said Desai was "deeply

respected by both sides of the aisle for not just for his high-caliber work and brilliance, but also for his reputation as someone you can trust and work with even in this highly partisan environment."

Desai's clients similarly heaped praise on him, with one calling him the "gold standard." Another stated that "no matter how complex the [case] becomes, [Ronak] handles it with unparalleled skill, grace, and sophistication," adding that every client should want Desai "firmly on their side."

Kwame Manley, a former federal prosecutor and Global Chair of Paul Hastings' award-winning White-Collar Defense practice, said "Ronak is a superstar. He has achieved tremendous success for his clients so early in his career. We are excited about his continued excellence at [the firm]."

Desai's award from NLJ comes less than a year after he received the "Rising Star" award from DC's South Asian Bar Association (SABA). The honor recognizes "a talented individual within...the community, who...has been practicing for fewer than 10 years, and has achieved prominence and distinction in their respective field while demonstrating a strong commitment...to the South Asian community."

Cook County Circuit Court Judge Sanjay Tailor told the American Bazaar, "whether it's assisting clients with the minefields of India's regulatory environment, navigating the complexities of Congressional investigations, or bringing media and public pressure to bear on the Sureshbhai Patel case, Ronak does it all and does it with customary aplomb." He noted that "there are few who are able to successfully employ their skills [in the service of so many] on such a wide

breadth of issues. His portfolio is endless."

Several other Indian Americans were also named members of this year's "NLJ DC Rising Stars" class. They include: Sandeep Nandivada, a government contracts attorney at Morrison and Foerster; Kapil Pandit, an investment management attorney at Akin Gump Strauss Hauer & Feld; and Alka Pradhan, an eminent international humanitarian law and human rights attorney with the Guantanamo Bay Military Commissions Defense Organization.

Pradhan is one of the country's most respected lawyers in this realm and was the subject a glowing New York Times Magazine profile feature spotlighting her work in December 2017.

Pradhan and Desai both overlapped during their undergraduate studies at the Johns Hopkins University in Baltimore, where Desai was elected Phi Beta Kappa. Originally hailing from Orange County, California, Desai earned joint public policy and law degrees (M.P.P./J.D.) from the Harvard Kennedy School of Government and Harvard Law School, from which he graduated magna cum laude and received the Dean's Scholar Prize.

Outside his legal practice at Paul Hastings, Desai is an associate at the Lakshmi Mittal and Family South Asia Institute at Harvard University, a Law and Security Fellow at New America, and an Asia 21 Leader at the Asia Society. He also serves as pro bono General Counsel and board director to the Partnership for a Secure America (PSA), a foreign policy think tank that promotes bipartisanship on Capitol Hill.

# COVID-19 CRISIS

Singapore and Hong Kong agree on bilateral travel bubble

**S**ingapore and Hong Kong have agreed on a bilateral air travel bubble, which will exempt travellers from the mandatory quarantine upon arrival, as the rate of coronavirus infection declines in both regional aviation hubs.

To avail the flights, travellers will have to test negative in the polymerase chain reaction (PCR) test for COVID-19, Singapore's Ministry of Transport (MOT) on Thursday, Oct 15.

Travellers under the bubble will not be subject to mandatory quarantining, the MOT release said, adding that there will be no restrictions on travel purposes and no need for a controlled itinerary.

The air travel bubble will have dedicated flights, separate from local travel.

The MOT said the bubble can be "scaled by adjusting the number of dedicated flights upwards or downwards, or even suspended, in line with the latest developments and COVID-19 situation in the two cities".

"Both our cities have low incidence of COVID-19 cases and have put in place robust mechanisms to manage and control COVID-19," said Transport Minister Ong Ye Kung.

"This has given us the confidence to mutually and progressively open our borders to each other," Channel News Asia quoted the minister as saying.

**GENEVA/ZURICH (TIP):** The World Health Organization (WHO) on Wednesday, Oct 14, warned against any complacency in the coronavirus death rate, saying with the increasing number of cases, mortality would also rise.

New cases are hitting 100,000 daily in Europe. Nearly 20,000 infections were reported in Britain, while Italy, Switzerland and Russia were among nations with record case numbers.

While deaths globally have fallen to around 5,000 per day from April's peak exceeding 7,500, WHO Chief Scientist Soumya Swaminathan said caseloads were rising in intensive care units.

"Mortality increases always lag behind increasing cases by a couple of weeks," Swaminathan said during a WHO social media event. "We shouldn't be complacent that death rates are coming down."

More than 38 million people have been reported infected globally and 1.1 million have died.

Despite the global push for a COVID-19 vaccine, with dozens in clinical trials and hopes for initial inoculations this year, Swaminathan reiterated that speedy mass shots were unlikely.

Two candidates, from Johnson & Johnson and AstraZeneca's U.S. trial, are paused on safety concerns, while manufacturing billions of doses of an eventual successful vaccine will be a colossal challenge demanding hard decisions about who gets inoculated first.

"Most people agree, it's starting with health care workers, and front-line workers, but even there, you need to

# Global coronavirus cases top 38.9 million, 1,099,629 deaths

The overall number of global coronavirus cases has topped 38.9 million, while the deaths have soared to more than 1,099,629 on Friday, October 16.

The US is the worst-hit country with the world's highest number of cases and deaths at 7,977,097 and 217,754, respectively, according to the CSSE.

India comes in second place in terms of cases at 7,307,097, while the country's death toll soared to 111,266.

The other top 15 countries with the maximum amount of cases are Brazil (5,169,386), Russia (1,346,380), Argentina (949,063), Colombia (936,982), Spain (921,374), Peru (856,951), France (850,997), Mexico (834,910), South Africa (698,184), the UK (676,455), Iran (517,835), Chile (486,496), Iraq (416,802), Bangladesh (384,559), and Italy (381,602), the CSSE figures showed.

Brazil currently accounts for the second highest number of fatalities at 152,460. The countries with a death toll above 10,000 are Mexico (85,285), the UK (43,383), Italy (36,372), Spain (33,553), Peru (33,512), France (33,146), Iran (29,605), Colombia (28,457), Argentina (25,342), Russia (23,350), South Africa (18,309), Chile (13,434), Ecuador (12,306), Indonesia (12,268), Belgium (10,278) and Iraq (10,086).

control its Covid outbreak, as infections hit record daily highs in Germany, the Czech Republic, Italy and Poland. France slapped a 9 pm curfew on many of its biggest cities and Londoners faced new travel restrictions as governments imposed increasingly tough measures.

The Czech Republic, Belgium, the Netherlands, Spain, France and Britain are among the countries causing particular concern. The head of the World Health Organisation's Europe

office urged governments to be "uncompromising" in controlling the virus.

"These measures are meant to keep us all ahead of the curve and to flatten its course," Dr Hans Kluge said, while wearing a mask. Kluge cited epidemiological models that suggested if 95% of people wear masks and follow other social distancing measures, Europe could avoid about 281,000 deaths by February.

define which of them are at highest risk, and then the elderly, and so on," Swaminathan said.

"A healthy young person might have to wait until 2022." The WHO has said letting infection spread in hopes of achieving "herd immunity" is unethical and would cause unnecessary deaths. It urges hand-washing, social distancing, masks and -- when unavoidable, limited and targeted restrictions on movements -- to control disease spread.

"People talk about herd immunity. We should only talk about it in the context of a vaccine," Swaminathan said. "You need to vaccinate at least 70% of people ... to really break transmission."

## WB approves \$12bn for Covid vaccines

The World Bank has approved USD 12 billion in financing to help developing countries buy and distribute Covid-19

vaccines, tests, and treatments, aiming to support the vaccination of up to 1 billion people.

The USD 12 billion "envelope" is part of a wider World Bank Group package of up to USD 160 billion to help developing countries fight the Covid-19 pandemic, the bank said in a statement late Tuesday.

The World Bank said its Covid emergency response programmes were already reaching 111 countries. Citizens in developing countries also need access to safe and effective Covid vaccines, it said.

"We are extending and expanding our fast-track approach to address the Covid emergency so that developing countries have fair and equal access to vaccines," said bank's president David Malpass in the statement.

"Access to safe and effective vaccines and strengthened delivery systems is key to alter the course of the pandemic and help countries experiencing catastrophic economic and fiscal impacts move toward a resilient recovery," he said.

The International Finance Corporation, the private sector lending arm of the World Bank is investing in vaccine manufacturers through a \$4 billion Global Health Platform, the statement said.

## UK fines British Airways for failures in 2018 data hack

**LONDON (TIP):** Britain's information commissioner has fined British Airways 20 million pounds (\$25 million) for failing to protect personal data for some 4,00,000 customers, the largest fine the agency has ever issued.

The ICO said in a statement on Friday that the airline was processing personal data without adequate security measures. It also noted that it did not detect a 2018 cyber attack for two months.

Information Commissioner Elizabeth Denham said says BA's "failure to act was unacceptable and affected hundreds of thousands of people, which may have caused some anxiety and distress as a result".

Under the European Union's General Data Protection Rules imposed in 2018, organisations face fines of up to 20 million euros (\$23 million) or 4% of annual global turnover — whichever is greater — for the most serious violations. — AP

## BIGGEST World War Two bomb found in Poland explodes while being defused

**WARSAW (TIP):** The biggest World War Two bomb ever found in Poland exploded under water on Tuesday as navy divers tried to defuse it.

More than 750 people had been evacuated from the area near the Piast Canal outside the town of Swinoujscie where the Tallboy bomb used by Britain's Royal Air Force (RAF) was found.

It weighed nearly 5,400 kg, including 2,400 kg of explosive.

"The deflagration process turned into detonation. The object can be considered as neutralised, it will not pose any more threat," Second-Lieutenant Grzegorz Lewandowski, the spokesman of the 8th Coastal Defense Flotilla, was quoted as saying by state-run news agency PAP.

"All mine divers were outside the danger zone." Swinoujscie contains a liquefied natural gas (LNG) terminal but a spokesman for the town's mayor told PAP no one was injured and no infrastructure had been damaged.

The Piast Canal connects the Baltic Sea with the Oder River on Poland's border with Germany. The bomb was dropped by the RAF in 1945 in an attack on the German cruiser Lutzow. Reuters

## It's time to prepare for no-trade deal Brexit: UK PM Johnson

**LONDON (TIP):** Prime Minister Boris Johnson said on Friday it was now time to prepare for a no-trade deal Brexit in 10 weeks as the European Union had refused to negotiate seriously, adding that unless Brussels changed course there would be no agreement.

A tumultuous "no deal" finale to the United Kingdom's five-year Brexit crisis would sow chaos through the delicate supply chains that stretch across Britain, the EU and beyond - just as the economic hit from the coronavirus pandemic worsens.

At what was supposed to be the "Brexit summit" on Thursday, the EU delivered an ultimatum: it said it was concerned by a lack of progress and called on London to yield on key sticking points or see a rupture of ties with the bloc from Jan. 1.

"I have concluded that we should get ready for January 1 with arrangements that are more like Australia's based on simple principles of global free trade," Johnson said.

"With high hearts and with complete confidence, we will prepare to embrace the alternative and we will prosper mightily as an independent free trading nation, controlling and setting our own laws," he added.

Johnson's remarks, which follow an EU demand that London make further concessions, may push Brexit towards chaos, though he still left open the possibility that the EU could change course and offer Britain a better deal.

"Unless there is a fundamental change of approach, we're going to go for the Australia solution. And we should do it with great confidence," he said.

Asked if he was walking away from talks, Johnson said: "If there's a fundamental change of approach, of course we always willing to listen, but it didn't seem particularly encouraging from the summit in Brussels."

In Brussels, an EU official and a diplomat told Reuters the bloc was still preparing for more trade talks in Britain next week.

"He didn't say they will leave the negotiating table. So it's all just rhetoric. He didn't say they won't keep on talking. So they will," the diplomat said.

The EU official said bloc's EU's Brexit



negotiating team was "already packing for an intense week in London", adding: "On the whole Australia deal/Canada deal revival...it's just not serious."

### STERLING PLUNGE

Sterling dropped sharply after Johnson's remarks that businesses, hauliers and travellers should get ready for a clean break from Europe.

At 1101 GMT, the pound was down 0.1% against the dollar at \$1.2882, having been up at \$1.2962 before Johnson spoke. It was down 0.2% versus the euro.

Britain formally left the EU on Jan. 31 this year, but a transition period, which ends on Dec. 31, means it remains in the EU single market and customs union.

The two sides have been haggling over a deal that would govern trade in everything from car parts and salmon to Camembert and medicines when that informal membership ends.

### "NO DEAL" ON WTO TERMS

A so-called "Australia deal" means that the United Kingdom would trade on World Trade Organization terms: as a third country like Australia, tariffs would be imposed under WTO rules.

"It's becoming clear the EU don't want to do the type of Canada deal that we originally asked for," Johnson said. "It does seem curious that after 45 years of our membership they can offer Canada

terms they won't offer us."

EU officials have said Britain, with the world's 6th largest economy and geographically next door to Europe, poses a much bigger competitive challenge than distant Canada and so cannot be offered a similar accord.

Johnson had repeatedly asserted that his preference is for a deal but that Britain could make a success of a no-deal scenario, which would throw \$900 billion in annual bilateral trade into uncertainty and could snarl the border, turning the southeastern county of Kent into a vast truck park.

The EU's 27 members, whose combined \$18.4 trillion economy dwarfs the United Kingdom's \$3 trillion economy, say a deal is still possible but that Johnson must give ground.

German Chancellor Angela Merkel, Europe's most powerful leader, said after the summit that compromise would be needed for a deal.

"In some areas, things have progressed well. In others, much work remains to be done. We have asked the United Kingdom to remain open to compromise, so that an agreement can be reached," Merkel said.

"This of course means that we, too, will need to make compromises. Each side has its red lines," she said, adding that the top EU objectives were to safeguard peace in Ireland and protect the bloc's single market. Reuters

## North Korea's nuclear, missile programmes 'serious threat' to security

**WASHINGTON (TIP):** US Defence Secretary Mark Esper on Wednesday said North Korea's nuclear and missile programmes pose a global threat, after Pyongyang's unveiling of previously unseen intercontinental ballistic missiles at a predawn military parade.

The appearance of a new intercontinental ballistic missile (ICBM) during a weekend parade in North Korea captivated many Western analysts. But officials in South Korea were far more concerned by the display of new multiple launch rocket systems (MLRS) and fast, maneuverable short-range missiles that

would be ideal for striking targets in the South. Speaking before the start of a meeting with South Korean Defence Minister Suh Wook at the Pentagon, Esper said: "We agree that North Korea's nuclear and ballistic missile programs remain a serious threat to the security and stability of the region and the world."

"The United States remains committed to the security of the Republic of Korea," Esper said. He added, however, that South Korea and the United States must find a more equitable way of sharing defence costs so it "doesn't fall unequally on the American taxpayers." US President Donald

Trump, who has touted his relationship with North Korean leader Kim Jong Un, has repeatedly said Seoul should pay for a larger share of the cost of US military forces deployed in the South. Some 28,500 American troops are deployed in South Korea, in what is seen as a deterrent to Pyongyang that also sends a message to China about US influence and capability in Asia. Separately, US Secretary of State Mike Pompeo, citing a lack of ICBM tests by Pyongyang last year, told reporters on Wednesday there was a reduced risk to the United States from North Korea due to Trump's policy of engagement. AP

# Racial tensions rise in South Africa over farm killing

**SENEKAL (SOUTH AFRICA) (TIP):**

A tense standoff between white farmers and Black activists gripped the South African town of Senekal Friday, as two men accused of killing a white farm manager were to appear in court.

More than 100 police patrolled the area in front of the courthouse in the Free State province and used barbed wire to separate the rival groups.

Sekwetjie Mahlamba and Sekola Matlaletsza were to appear in the court on charges of killing Brendin Horner, 21, on October 1.

About 250 white farmers gathered to protest the killing, charging that police do not adequately protect white farmers. In an earlier court hearing last week, a group of white farmers stormed the court and burned a police vehicle.

The country's leftist opposition party, the Economic Freedom Fighters, mobilized about 1,000 of its supporters to challenge the white farmers in front of the court.

They sang songs and shouted slogans calling for South Africa's land to be returned to Black residents. Many were dressed in the EFF party's red uniforms and berets.

EFF leader Julius Malema came to Senekal on Friday was expected to speak to his supporters after the court hearing.

While most white farmers and organisations representing them have called for farm killings to be made a priority crime, the government insists



that white farmers are not being targeted, saying the violence is a result of South Africa's relatively high crime rate.

South Africa has one of the highest crime statistics in the world, with a murder rate of just over 58 deaths a day.

The country's official crime statistics indicate there were 49 farm killings in the 2019/2020 financial year.

President Cyril Ramaphosa, in his weekly letter to the nation Monday, condemned Horner's killing, but said the farm killings were part of the bigger crime problem.

"Those people who think that farm attacks affect just a small part of our

population are wrong. The farming community is an integral part of our economy," wrote Ramaphosa.

The Senekal murder has also raised the controversial issue of land ownership in the country.

A great deal of South Africa's best farmland is owned by white farmers, as a result of the eviction of Black farmers when the country was ruled by a white minority.

Although South Africa now has majority rule, land ownership remains a contentious issue, with parties like the EFF urging the government to seize white-owned land without compensation and return it to Black families. AP

# Vatican trial for sex abuse in pope's youth seminary opens

**VATICAN CITY (TIP):** A trial opened on Wednesday in the Vatican's criminal tribunal for two priests, one accused of sexually abusing an altar boy in the Vatican's youth seminary and the other of covering it up.

The charges read aloud in the courtroom marked the first time the Vatican had publicly detailed its case against the two men, one of whom was himself a young seminarian at the time of the alleged abuse, 2007-2012, while the other was the then-seminary rector.

The case concerns the closed world of the St. Pius X youth seminary, a palazzo inside the Vatican walls just across the street from where Pope Francis lives and the criminal tribunal itself.

The seminary, which is run by a Como, Italy-based religious association, serves as a residence for boys aged 12 to 18, who serve as altar boys at papal Masses in St. Peter's Basilica.

According to the indictment, the Rev. Gabriele Martinelli, 28, is accused of abusing his authority as a more senior seminarian to force the victim into "carnal acts" of sodomy and masturbation, using violence and threats.

The former seminary rector, the Rev.



Enrico Radice, is charged with having helped Martinelli avoid investigators by telling the Como bishop that the victim's allegations were baseless and telling Vatican prosecutors that he knew of no sexual misconduct in the seminary.

Neither Martinelli nor Radice have responded publicly to the accusations. The next hearing was scheduled for October 27, when both defendants are

expected to take the stand.

The charges suggested that Radice's alleged cover-up went beyond what was previously known and put into question Martinelli's very ordination.

Prosecutors say Radice not only helped Martinelli evade investigators in the years prior to becoming a priest, but also falsified a letter from the Como bishop announcing Martinelli's imminent ordination. AP

# Race hate crimes spike in England, religious crimes down

**LONDON (TIP):** Racially aggravated attacks registered a spike in hate crimes recorded in England and Wales in 2019-2020 even as religious hate crimes showed a downward trend, according to official UK Home Office statistics released on Tuesday. There were 105,090 hate crimes recorded in the past year, which marks an increase of 8 per cent on the previous year, with race hate crimes rising by around 4,000. "As in previous years, the majority of hate crimes were race hate crimes, accounting for around three-quarters of offences (72 per cent or 76,070 offences). These increased by 6 per cent between 2018/19 and 2019/20," notes the Home Office report. "Religious hate crimes fell by five per cent (to 6,822 offences), down from a peak of 7,203 in the previous year. This was the first fall in religious hate crimes since 2012-13," it said. In 2019-20, where the perceived religion of the victim was recorded, 50 per cent of religious hate crime offences were targeted against Muslims (3,089 offences), with the next most commonly targeted group being Jewish people, who were targeted in 19 per cent of religious hate crimes (1,205 offences). PTI

# French police shoot dead man who slit teacher's throat

**PARIS (TIP):** French police on Friday shot dead a man who minutes earlier had killed a middle school teacher by slitting his throat in the street in a suburb of Paris, police said on Friday.

France's anti-terror prosecutor said it was investigating the attack, which took place in Conflans Sainte-Honorine, a suburb north-west of Paris.

The suspected attacker was spotted by a police patrol while carrying a knife a short distance from the scene of the attack.

The police shot the suspect dead, according to a police spokesman.

A police source said that witnesses had heard the attacker shout "Allah Akbar", or "God is Great". The police spokesman said that information was being checked.

Another police source also said the victim had been decapitated in the attack, but this was not confirmed.

France has over the past several years seen a series of violent attacks carried out by Islamist militants.

Late last month, a man who emigrated to France from Pakistan used a meat cleaver to attack and wound two people outside the former offices of satirical magazine Charlie Hebdo. Reuters

# WASHING HAIR AFTER COLORING: ALL YOU NEED TO KNOW

Experimenting with your hair color can be a fun way to shake up your look or get through a downtrodden period of style. While it's much cheaper than a new wardrobe, it's still an investment and you'll want to make sure the amazing color lasts for as long as possible. Washing your hair is often framed as the main cause of color fading, but it turns out the secret to washing your hair after dyeing isn't when - it's just that.

"A lot of people believe that it takes a few days for the color to set in your hair after you dye it - that's really just a myth," said Sydney Palmer, hair color specialist at Estetica Salon & Spa in St. Paul, MN. "Hair color is not setting in any more than it is when you wait to wash it off."

Jade Kromer, hair color specialist at Juut Salon Spa in Minneapolis, MN, agrees. "Wash your hair right after you dye it, that's really not the problem," she told POPSUGAR. "Focus more on the products you use than the time between shampoos."

It's less about getting the dye set in your hair than about preventing it from leaching out. Each strand of hair is surrounded by the cuticle, which traps the color. Washing your hair, especially in hot water, is at risk of opening your cuticles and bleeding the paint out. Palmer recommended washing colored hair in cooler water: "This will keep your



hair cuticle closed and your hair color trapped in the strands of hair. Warm water makes the cuticles more likely to open and let the color out, which is why the color fades so quickly."

If a cold shower doesn't sound appealing to you, you can also wash your hair less frequently and try to avoid steaming hot water. If you choose a so-called "fashion color" for your hair, e.g. B. bright pink, orange or purple, Kromer recommends washing only once a week and using dry shampoo in the meantime. These colors typically

require hair bleaching, which makes the cuticles more porous and therefore more likely to leak color in the shower.

If all you have is highlights or lowlights instead of full hair color, you can be a little more casual about the water temperature, Palmer said. Less pigment in the hair means the water temperature is less important. In addition to the number of times you wash your hair and the temperature, what you wash it with can make a huge difference in how long your color lasts.

### Here We go


- Dry roast the vermicelli in a non stick pan till it is slightly pink. Keep aside

# ANTIBIOTICS CAN BE AS EFFECTIVE AS SURGERY IN SOME APPENDICITIS CASES

**W**hat do you do when you have an appendicitis attack? If your first thought is an appendectomy, you're in good company. It's been the standard treatment for a long time.

But it's not always the only option.

Antibiotics can eliminate or delay the need for appendectomy, at least in some cases, according to research published in the New England Journal of Medicine (NEJM).

It's not a new treatment. But preliminary outcome results from the largest clinical trial to date on the subject give doctors and their patients more to consider.

The Comparison of the Outcomes of antibiotic Drugs and Appendectomy (CODA) trial involved 1,552 appendicitis patients in 25 hospitals across 14 states.

Participants in the nonblinded, noninferiority trial were randomized to have an appendectomy or get a 10-day course of antibiotics first.

Antibiotics were administered intravenously for at least 24 hours before switching to oral medication.

The primary outcome was a 30-day health status. Secondary outcomes included appendectomy for those in the antibiotics group



and complications through 90 days.

Of those who had antibiotic treatment, 30 percent ended up having an appendectomy within 90 days. The risk for complications and appendectomy was higher for people with an appendicolith, which is a calcified deposit in the appendix.

Those in the antibiotics group returned to the emergency room

more often. But overall time in the hospital was similar between the two groups. People treated with antibiotics missed less time from work or school.

All in all, antibiotic treatment was found to be noninferior to appendectomy.

Additional results of the CODA trial will be shared over the next 2 years.

## As you get older, you need to drink more water

**A**s you get older, you need to drink more water. That's the advice from a new study published in The Journal of Physiology.

The researchers from the University of Ottawa point out that hydration is key in regulating body temperature and helping fight off a host of other health problems.


The researchers said that dehydration doesn't reduce heat loss or increase body temperature in older adults during exercise as it does in younger people, which may seem on the surface like a beneficial response.

But that means that when older people exercise, their bodies don't adjust the rate of sweat loss to prevent further dehydration.

This results in greater strain on the heart, evidenced by a more pronounced increase in heart rate compared to younger men.

The study featured older men, although the results pointed to all older adults as those affected.

The researchers added that "until recently, however, our understanding of the effects of




dehydration on body temperature regulation came primarily from studies conducted on young adults."

"This is an interesting study, as it delivers new insights into fundamental age-related changes to our physiology," Dr. Scott A. Kaiser, a geriatrician at Providence Saint John's Health Center in Santa Monica, California, told Healthline.

"While changes in the regulation of body heat, sweating, hydration,

and thirst that tend to occur with age are well established, this study probes deeply into the specific changes of underlying mechanisms. In particular, changes in response to dehydration and heat with exercise," he explained.

"It's quite remarkable that, at this point in time, we are still learning such fundamental things about the way our bodies change with age," Kaiser added.

## Scientists record top speed of sound at 36 km/second

The fastest possible speed of sound has been recorded for the first time which is about 36 km per second.

The result is around twice as fast as the speed of sound in diamond, the hardest known material in the world, said the researchers from the Queen Mary University of London, the University of Cambridge and the Institute for High-Pressure Physics in Troitsk, Moscow.

Sound waves can travel through different mediums, such as air or water, and move at different speeds depending on what they're travelling through.

For example, they move through solids much faster than they would through liquids or gases, which is why we are able to hear an approaching train much faster if you listen to the sound propagating in the rail tracks rather than through the air.

Einstein's theory of special relativity sets the absolute speed limit at which a wave can travel which is the speed of light and is equal to about 300,000 km per second.

However, it was not known to date whether sound waves also have an upper-speed limit when travelling through solids or liquids.

## Moon once shared magnetic field with Earth, protecting atmosphere

The Moon played a huge role in the evolution of life on Earth as a new study suggests that our natural satellite once had a magnetic field that helped shield our home planet from harmful solar radiation during a critical early time.

The shared magnetic field situation, with Earth and Moon's magnetospheres joined, could have persisted from 4.1 to 3.5 billion years ago, according to the NASA-led study published in the journal *Science Advances*.

"The Moon seems to have presented a substantial protective barrier against the solar wind for the Earth, which was critical to Earth's ability to maintain its atmosphere during this time," said Jim Green, NASA's chief scientist and lead author of the new study.

# Robot dolphin can replace captive animals at theme parks

**D**arting around the pool as a group of swimmers stands in the shallow end, the dolphin looks much like those that jump through hoops and perform acrobatics at theme parks. But this marine creature is a robot.

"When I first saw the dolphin, I thought it could be real," said a woman who swam with the remote-controlled creature.

Edge Innovations, a US engineering company with an animatronic and special effects division in California, designed the dolphin, which starts at \$3 million to \$5 million.

It hopes that life-like animatronics used in Hollywood movies could one day entertain crowds at theme parks, instead of wild animals held in captivity. Swimmers could dive with robotic great white sharks or even reptiles that filled Jurassic-era seas millions of years ago.


"There are like 3,000 dolphins currently in captivity being used to generate several billions of dollars just for dolphin experiences. And so there's obviously an appetite to love and learn about dolphins," said Edge Innovations founder and CEO Walt Conti.

"And so we want to use that appetite and offer kind of different ways to fall in love with the dolphin." Animatronics may bring back audiences turned off by parks using live animals, said Conti.

Some 20 European countries have already banned or limited the presence of wild animals in circuses.

At Edge's Hayward, California headquarters, its 550-pound (250-kg), 8-and-a-half-foot (2.5-meter) animatronic dolphin with skin made from medical-grade silicone headlined a program for schools in partnership with TeachKind, part of People for the Ethical Treatment of Animals (PETA).

Edge also made the aquatic creatures used in Hollywood

blockbusters "Free Willy," "Deep Blue Sea" and "Anaconda." "The idea of this pilot is really to create a kind of "Sesame Street" under water," said Roger Holzberg, creative director for Edge's animatronic program.

"Those characters taught a generation how to feel about different kinds of aspects of humankind in ways that had never been imagined before. And that's what we dream of with this project."

## Apple enters 5G race with new iPhone 12 range

**A**pple Inc on Tuesday, October 13, launched its next-generation iPhone 12, with faster 5G connectivity that the California company hopes will spur consumers to trade in their old phones and keep its sales booming through the end of the year.

The core of the line-up, the iPhone 12 with a 6.1-inch display, will sell for \$799, while a 'Mini' version with a 5.4-inch screen will be slightly cheaper at \$699. A 'Pro' version with three cameras and a new 3-D 'lidar' sensor starts at \$999, with the largest 'Pro Max' starting at \$1,099 and going up to \$1,399.

The new products will test whether Apple can ride a wave of consumer excitement around 5G wireless data networks, whose speediest variants outstrip their predecessors' data rates multiple times over.

But whether iPhone buyers see a dramatic speed boost will depend heavily on where they are and which carrier they use - what Bob O'Donnell, head of TECHnalysis Research, called "lots of little niggly details that get in the way of delivering on the promise of 5G."

He said Apple may be setting some customers up for disappointment when phones ship but offer only modest speed increases until carriers build out networks.

"I don't feel like Apple clarified that as much as they could have," O'Donnell said.

Apple said all iPhone 12 models

in the United States will support millimetre-wave 5G, the fastest variant of the technology, as well as lower-frequency bands.

Outside of the United States, however, iPhones will lack millimetre wave compatibility, even in countries like Australia and South Korea where carriers are planning to roll out versions of the millimetre-wave technology. Like some cheaper Android devices, iPhone 12 models in those countries will only support lower-frequency versions of 5G.

Apple said it had tested 5G on more than 800 carriers in 30 regions globally. Verizon Communications Inc CEO Hans Vestberg appeared on Apple's live stream presentation to announce that the phones would work with the U.S. carrier's 'ultrawideband' 5G network, designed to alleviate bottlenecks in major cities like New York and Los Angeles, as well as in crowded areas like NFL stadiums.

## IIT Madras researchers develop anti-bacterial, biodegradable food wrapping material

**R**esearchers at Indian Institute of Technology (IIT), Madras have developed a food wrapping material which is not only anti-bacterial but also biodegradable.

According to the team which has also filed a patent for the wrapper, their product can tackle two major problems - prevent packaged food contamination by bacteria as well as reduce the plastic waste generated in the environment when disposing of the wrappers.

"Our idea was to design a food wrap that will address two major issues--solid waste and food contamination during storage due to bacterial growth. We have developed a biodegradable wrapping material with in-built anti-bacterial activity to prevent bacterial growth in stored food. The anti-bacterial compound should be safe for consumption as it is approved by the authorities and does not cause any toxicity," said Mukesh Doble, Professor, IIT's Department of Biotechnology.

"The wrapping material we have developed also degrades at various environmental conditions with the rate of degradation varying from 4 to 98 per cent in 21 days. The wrapping material degraded rapidly in moist conditions when compared to dry ones. Hence, our wrapper is eco-friendly and can play a major role in plastic waste reduction," he added.

The films developed by researchers were made with polymeric blends containing starch, polyvinyl alcohol, cyclic beta glycans (CBG). The composition was optimised to achieve the best film with a smooth texture, flexibility, uniform thickness and good clarity.





## Virgin Atlantic to start flights to Manchester from Mumbai, Delhi

**B**ritish premier carrier Virgin Atlantic on Thursday announced launch of flight services from India to Manchester, which has a sizable population of Indian origin people, starting December 20.

Virgin Atlantic is delighted to announce it will be launching services from Delhi and Mumbai to Manchester as the airline ramps up flying from its home in the north of England, a release said.

Flying three times a week from Mumbai to Manchester, beginning in December, and twice weekly from Delhi, starting in January, these new services will go on sale from October 20 and will complement the airline's existing services from Mumbai and Delhi to London Heathrow, it said.

The airline will operate one of its newest and fuel efficient aircraft, the Boeing 787 Dreamliner, on these new routes, the release added.

Erstwhile carrier Jet Airways used to fly to Manchester, the UK's third-largest airport by passenger volume, connecting Mumbai with the northwest city of England. However, since its collapse in April 2019, the destination remains untapped from India.

## Zomato raises \$52 million from US-based Kora Investments

**F**oodtech unicorn Zomato has raised \$52 million from US-based Kora Investments, continuing efforts to bolster its cash reserves at a time when the food delivery sector is rebounding from the ravages of the Covid-19 pandemic.

The capital was raised as part of an ongoing round that is expected to raise as much as \$600 million. It has seen Zomato raise more than \$270 million so far this year. In September, Zomato closed a \$62 million funding from MacRitchie Investments, a unit of Singapore's Temasek, and an additional \$103 million from US-based hedge fund Tiger Global.

Kora is expected to make a follow-up investment of a larger amount in Zomato in the coming months, said a person aware of the talks. The person did not disclose the size of the next investment. Zomato's current fundraising strategy is to woo more hedge funds for possible investments. Its plan on going public is making it an attractive proposition for these funds since they see faster exits.

# Asian stocks under pressure, dollar in demand amid resurgent virus fears

**A**sian stocks came under pressure on Friday, October 16, as investors sought safe havens, such as the U.S. dollar, fearing that a resurgence in coronavirus cases and a lack of additional U.S. fiscal stimulus would hobble the world economy.

U.S. President Donald Trump's offer on Thursday to raise the size of a fiscal stimulus package to win the support of Republicans and Democrats helped narrow Wall Street losses, though many investors still believe a deal is unlikely before the Nov. 3 election.

"There's a bit of worry there and also at what we're seeing in America and in Europe regarding the virus and how it seems to be taking hold pretty significantly again," said Grant Williamson, investment adviser at Hamilton Hindin Greene in Christchurch, New Zealand.

Stocks struggled to make gains in early Asian trade with Australia's S&P/ASX 200 down 0.02% and Japan's Nikkei 225 futures adding just 0.06%. Hong Kong's Hang Seng index futures rose 0.36%. E-mini futures for the S&P 500 rose 0.04%.

Australia and New Zealand investors were likely to "take a breather" on Friday, especially after New Zealand equities



climbed 6% during October, Williamson said.

On Wall Street, the Dow Jones Industrial Average fell 0.07%, the S&P 500 0.15% and the Nasdaq Composite dropped 0.47%.

An unexpected rise in U.S. weekly jobless claims figures added to worries about a sputtering world economy, especially in the face of a spike in COVID-19 cases in Europe.

Safe-haven demand due to signs of a stalling U.S. economy drove the dollar index <=USD> 0.398% higher after touching a two-week high of 93.91, while the Japanese yen strengthened 0.08%

versus the greenback at 105.38 per dollar.

MSCI's broadest index of Asia-Pacific shares outside Japan closed 0.04% lower.

The euro <EUR=> was down 0.01% to \$1.1705, while a firmer U.S. dollar dragged on sterling <GBP=>, which was last trading at \$1.2902, down 0.09% on the day.

Spot gold was little changed at \$1,908.07 an ounce.

Focus in Asia swings to Canada-China relations after Canada ordered a national security review of Shandong Gold Mining Co Ltd's bid to acquire a gold mine in the Canadian Arctic. It is the latest sign of pushback faced by China's state miners.

In Europe, London will enter a tighter COVID-19 lockdown from midnight on Friday as Prime Minister Boris Johnson seeks to tackle a swiftly accelerating second coronavirus wave.

"The market's on again off again love affair with an impending stimulus torrent masks the fact that investor uncertainty is bristling ahead of an expected choppy period in terms of headline risk, including Brexit, the U.S. election, and perhaps the most horrifying troubles of all, the second wave of the coronavirus that could trigger more intense lockdown worries," said Stephen Innes, global chief market strategist at AxiCorp.

## China raises \$6 billion as US investors overlook political tensions

**C**hina has raised \$6 billion in a dollar bond issue that was offered to US investors for the first time, according to a term-sheet reviewed by Reuters, just weeks before the November 3 election.

The deal, the fifth foreign currency denominated bond since China reinstated its offshore issuance programme in 2017, attracted an orderbook of \$27.2 billion, the term-sheet showed.

China has carried out four dollar deals and one euro deal in the past three years.

The pricing was set at US Treasuries plus 25 basis points for the \$1.25 billion three-year tranche, 30 basis points for the \$2.25 billion 5-year tranche, 50 basis points for the \$2 billion 10-year tranche and 80 basis points for the \$500 million 30-year tranche, the term-sheet showed.

It was the first time China has offered a bond deal to US-based investors who were most active in the longer-dated tranches of the transaction.

US investors, primarily fund managers, were the largest buyers of that bond, picking up 47% of the \$500 million sold, according to the term-sheet.

The rising tensions between Washington and Beijing did not deter US-based investors from participating in the deal, according to one source with direct knowledge of the matter.

The source could not be named because he was not authorised to speak to media.

"We did not see the geopolitical situation scaring people away," he said.

The deal was finalised on Wednesday as signs emerged the political stand-off between the US and China showed no signs of easing.

The US State Department has submitted a proposal for the Trump administration to add China's Ant Group to a trade blacklist, according to two people familiar with the matter, before the financial technology firm is slated to go public in Shanghai and Hong Kong.

## World experiencing deepest recessions since Great Depression: World Bank

**T**he world is experiencing one of the deepest recessions since the Great Depression in the 1930s owing to the novel coronavirus, World Bank President David Malpass has said, terming the Covid pandemic a "catastrophic event" for many developing and the poorest countries. He said given the extent of the economic contraction, there was a rising risk of disruptive debt crises in countries.

So that has got a lot of focus here at the meetings, Malpass told the media on Wednesday at the start of the annual meetings of the International Monetary Fund and the World Bank.

"The recession has been deep, one of the deepest since the Great Depression. And for many developing countries, and for the people in the poorest countries, it is truly a depression, a catastrophic event. It is continuing to add to the ranks of those in extreme poverty," he said.

That is the focus of this meeting and the focus of their actions, he said, adding the World Bank was building as big a growth programme for countries as they can in this fiscal year.

Responding to a question, Malpass said that the world was currently experiencing a K-shaped recovery.

That means the advanced economies have been able to provide support, especially for their financial markets and for people that have jobs that can be done by working from home. But people that are in the informal economy have lost their jobs, and are depending on social protection programmes, he said.

Hence, prayers, chants, 'bhajans' and reading of important religious texts make up a significant portion of this festival. Devotees pay obeisance to this feminine divine energy that is believed to maintain the balance of the universe.

Navratri is one of the most anticipated festivals in India with social and spiritual connotations. Navratri Hindu festival is spread out

over nine consecutive days in the Chaitra and Ashwin months to consecrate the divine aspects of Ma Shakti as Goddess Durga, Goddess Lakshmi and Goddess Saraswati. The festival is associated with their symbolic connotation as epitome of courage, wealth and skill respectively.

Broadly, on the first three days, devotees venerate Goddess Durga as she represents power in its divine form that removes negativity and proclivity towards immoral behavior. She is, invoked as Kumari, Parvati and Kali which are aspects of Ma Durga and represent her adolescence-to-maturity stage. During the next three days, Goddess Lakshmi blessings for material and spiritual prosperity are sought with puja and powerful mantra chantings. Over the next three days, Goddess Saraswati is invoked to seek blessings for erudition and skills in the arts. The devotee puts books and musical instruments near the deity to acquire true knowledge and wisdom to see him/her through this life and beyond. The ninth day of 'Mahanavami', the concluding day of Navratri puja, is considered an auspicious day for conducting pujas such as 'Aparajita' puja and 'Kanya Puja'. The tenth day celebrates the momentous events associated with Lord Rama as well as Ma Durga, who killed the demon 'Mahisasura'.

## Customs & Rituals of Navratri

Customs of Navratri which stand out prominently in terms of strict observance include the following:

On the very first day, barley or 'jowar' seeds are sown in a decorated clay pot and by the tenth day, the tender shoots are distributed among the devotees. A photograph or an idol of the eight-armed Goddess seated on a lion, along with the 'yantra' is installed.

'Kalash Sthapna' is done which involves installing a water pot or 'kalash', sprinkled with holy water and filled with mango leaves and coconut.

The morning 'puja' is performed after a bath, and the day-long fast is broken

after doing the evening puja.

During the puja, 'shankh' is blown, fresh flowers, 'doob' or sacred grass, 'paan' and fruits are offered to the deity, chapters from the sacred 'Durga Saptshati' and 'Chandipath' are recited, followed by 'arti' and prasad distribution.

A very significant ritual is performing 'Kanya Puja' on 'Ashtami' and 'Navami', which involves worshipping nine young girls, in pre-puberty stage, representing the nine forms of goddess Durga. Each girl is treated to a meal comprising puri, sweet bread, halwa, a sweet dish, made of semolina and Bengal gram curry. After washing their feet, the devotees break their fast.

Ayudha or Astra Puja is held on the eighth/ninth day. Tools, vehicles and equipments are worshipped on this day.

Among some communities, it is also considered an auspicious time to initiate learning for children by invoking Goddess Saraswati. Hence, Lalita-puja and Saraswati-puja is done ritually to start formal education of children.

A Garba performance precedes 'aarti' conducted in honor of Maa Durga.

Fasting or 'vrat' from sunrise till sunset is undertaken for night days.

In the Navratri Hindu festival, the devotee should observe abstinence and austerity.

On the eighth day, a 'yagna' is performed with offerings of ghee and til for mental and spiritual cleansing.

Lemon or bhasma or ash is used for cleaning substances for 'abhishek'.

In Gujarat, a garbh-deep or a lamp is lit within an earthen pot with several perforations representing the unison of body and soul.

## Customs of Navratri

Since all the nine days are dedicated to different incarnations of Ma Durga, it is customary to wear colors that symbolize the qualities of the deity. The first day venerates Shailputri Devi who embodies aspects of Brahma, Vishnu and Shiva. On this day, red clothes are worn. The second day is dedicated to Brahmacharini Devi who represents a life of abstinence. Wearing blue colored clothes is considered auspicious on this day. On the third day, Chandraghanta Devi, the bestower of glory and beauty, is invoked. On the fourth day, Kushmunda Devi is worshipped and yellow is the color to honor her. The fifth day is in honor of Skandmata Devi. Grey is the color to be worn on the sixth day and is dedicated to Katyayani Devi, while orange is the color for protection symbolized by Kalratri Devi on the seventh day. On the eighth day, pink clothes are worn to honor Mahagauri Devi. The ninth day is dedicated to Siddhidatri Devi, whose blessings earn devotees all 'siddhis'.

On all these nine days, devotees should meditate on the different forms of Ma Durga and seek her grace.

Some of the Navratri customs carry a lot of significance for married women. This Navratri Hindu festival sees heavy involvement of married women who seek blessings of prosperity and a long married life. Some of the customs of Navratri include showing complete devotion through actions such as doing 'bhajans' and 'japa', eating vegetarian food and staying away from negative influences to be able to soak in the wisdom and inner strength gained thus.

**HOUSTON (TIP):** The Indian Consulate at Houston has issued the following press release to the effect that Cox & Kings Global Services (CKGS), the existing service provider located at 1001 Texas Avenue, Houston TX 77002 for providing outsourcing services for Visa, OCI, Renunciation, Passport and Global Entry Program (GEP) (Website: [in.ckgs.us](http://in.ckgs.us)) will shut down its operations at close of business (1600 hours Central Standard Time) on Wednesday, 14 October, 2020.

The new service provider is VSF Global, likely to start operations from November 2. In the interim, October 19 onwards, the Consulate will provide direct limited services only in emergencies. Applicants residing in the states of Arkansas, Kansas, Louisiana, Oklahoma, Texas, New Mexico, Colorado and Nebraska, covered by the Consulate General of India, Houston.

### "In this context, the following may kindly be noted:-"

- (i) Applicants can only submit applications on the CKGS website before the above deadline.
- (ii) Applicants must ensure that their documents are shipped to CKGS with suitable pre-paid return envelopes in a manner to ensure it reaches CKGS by 1600 hours Central Standard Time on Friday, 16 October 2020.
- (iii) Any applications received after 1600 hours Central Standard Time on Friday, 16 October 2020 will be returned to the applicants without processing.
- (iv) Applicants must ensure that they receive back the processed documentation from CKGS as it will not be possible for CKGS or the Consulate to take care of any returned envelopes. The responsibility is that of the applicant.

With effect from 19 October 2020 and till M/s VFS Global - the new outsource service provider takes over operations (expected from 02 November 2020), the Consulate will provide direct limited services only in emergencies. Applicants residing in the states of Arkansas, Kansas, Louisiana, Oklahoma, Texas, New Mexico, Colorado and Nebraska, covered by the Consulate General of India, Houston, are advised to follow the instructions given below to avail emergencies services:

- (i) **VISA:** Emergency visa to the eligible categories allowed to travel to India as per the advisories issued from time to time by the Government of India. Visa applicants are requested to send an email to: 'visa.houston@mea.gov.in' requesting for emergency visa. On receipt of the documentation checklist, applicants are requested to carefully go through the requirements relating to the different categories of visa before submitting their applications. The Consulate may request additional documentation in certain cases.
- (ii) **PASSPORT:** For emergency passport services, applicants are requested to send an email to: 'passport.houston@mea.gov.in' explaining the reason. Only after approval from the Consulate, the application process must be initiated by the applicant.
- (iii) **OCI:** All OCI services will remain suspended till the new service provider takes over.
- (iv) **MISCELLANEOUS CONSULAR SERVICES:** Request for Miscellaneous Services (Attestation, Power of Attorney, Police Clearance Certificates etc.) can be sent to the Consulate through regular Post/Mail. For procedure related to these services please visit: <https://cghouston.gov.in/pages/Mjk>

# Signs of Quarantine Fatigue and what to do

The survey, comprised of 1,099 employees, found between 22 percent and 35 percent of U.S. workers have experienced symptoms of depression since the pandemic started.

**Techniques to help cope with quarantine fatigue**

Many people initially enjoyed the "break" from routine work schedules, but after months of quarantine, the appeal is lost as feelings of enjoyment start to turn into ones of helplessness. For those afflicted, it begins to feel as if this pandemic will never end. If you think you are suffering the effects of quarantine fatigue, try the following techniques to help combat these feelings.

- Practice relaxation techniques such as meditation, yoga, walks in nature, or anything else that gives you a sense of calmness and happiness. Achieving mindlessness is a great coping technique.
- If anxiety increases, try to focus on deep breathing exercises as a relief mechanism.
- Focus on positivity in ways that bring joy. Try watching comedy movies, reading uplifting books, or listening to fun podcasts and favorite music.

Unfortunately, online scammers and predators have taken note and are using manipulative tactics to prey on consumers. My office has seen an increase in the number of online scams regarding personal finances, as well as complaints about improper behavior towards teenagers and preteens on the internet.

There are simple steps you can take to safeguard yourself and your loved ones, some of which are outlined below:

- o Be wary of any emails requesting money and do not open attachments from unfamiliar senders.

- o Never agree to payment of services or goods with a gift card not issued by that company.
- o Do not provide your personal identifying information (credit card, bank info, etc.) via email.
- o Make sure your social media accounts have privacy settings.

### For Parents:

- o Establish clear guidelines, including time limits for screen use and consequences for inappropriate behavior.
- o Set some ground rules on what types of sites kids can visit and apps they can download.
- o Consider "blackout" periods that require disconnection.
- o Know the platforms. Online enticement happens across all platforms, so be aware of the sites, games, and apps your children frequent. Ask them to show you how they use them.

France stretched their unbeaten run against Croatia to eight games after a late goal by Kylian Mbappe gave the world champions a 2-1 win. The result left France second in the group on 10 points from four games, behind Portugal on goal difference after the European champions brushed aside Sweden 3-0.



## Srikanth sails into Denmark Open quarters

**B**ack in action after a seven-month long coronavirus-forced break, ace Indian shuttler Kidambi Srikanth stormed into the quarterfinals of the Denmark Open with a straight-game win over Jason Anthony Ho-Shue, on Thursday, Oct 15. The fifth seed Indian took 33 minutes to beat his Canadian opponent 21-15 21-14 in the men's singles second round match of the Super 750 tournament, the only event happening this year in Badminton World Federation's calendar.

The BWF was forced to cancel multiple tournaments and postpone the Asia leg and the World Tour Final to January next year due to the COVID-19 pandemic.

Srikanth, a former world No. 1 and currently ranked 14th, will next face the winner of the other second round match between second seed Tien Chen Chou of Chinese Taipei and Ireland's Nhat Nguyen.

The other surviving Indian in the competition, Lakshya Sen will be up against local challenger Hans-Kristian Solberg Vittinghus in his second round later in the day.

**SHARJAH (TIP):** K L Rahul played a captain's knock and Chris Gayle fired in his first game since January as Kings XI Punjab finally ended their five-match losing streak with an eight-wicket win over Royal Challengers Bangalore in an IPL match on Thursday, October 15.

Chasing 172 in a must-win game, the inform opening pair of Rahul (61 not off 49) and Mayank Agarwal (45 off 25) got off to a flying start before Gayle (53 off 45) joined his skipper in the middle to get KXIP close to the finishing line.

Needing seven off the final two overs with nine wickets in hand, KXIP somehow managed to take the game to the last ball with Nicholas Pooran finally hitting the winning six.

Both Rahul and Gayle smashed five sixes each, rendering the opposition attack helpless.

Batting first, skipper Virat Kohli topscored with 48 off 39 balls in his 200th game for RCB before Chris Morris' 25 off 8 in the death overs took the team to 171 for six.

It was a rare all-round effort from KXIP who had failed to close out games earlier in the competition.

Mohammad Shami (2/45) conceded 24 runs in the final over that spoiled his figures after he got rid of Kohli and AB de Villiers but overall it was a much improved bowling effort by KXIP especially in the death overs.

Leg spinner M Ashwin struck twice and pacer Chris Jordan took his first wicket of the tournament.

The run chase was supposed to be straightforward after Agarwal took the opposition to the cleaners in the powerplay before Rahul took over. As usual, the 41-



year-old Gayle, batting at three, took his time early on before going ballistic.

Earlier, KXIP conceded only 25 runs from over 16-19 before Morris and Isuru Udana hammered Shami for three sixes.

Rahul experimented by opening the bowling with Glenn Maxwell (0/28 in 4 overs). He was slog swept by his Australian teammate and close friend Aaron Finch on the final ball.

Other opener Devdutt Padikkal (18) also went for his shots with his best hit of the night being the whip off Shami that went for a six over deep square leg.

However, both Padikkal and Finch could not build on their starts. Padikkal was foiled by a slower one from left-arm pacer Arshdeep Singh to be caught at cover, while Finch missed a fast leg-break from M Ashwin, leaving RCB at 62 for two in the seventh over.

With Kohli looking good at the other end, AB de Villiers was expected to come in at his usual number four spot but with two leg-spinners in operation, left-handed batsman Washington Sundar was sent ahead of the South African.

The move did not work as he struggled to 13 off 14 balls.

KXIP, whose bowling has been the weakest link, did rather well from 11-14 overs conceding just 20 runs to put pressure on the opposition.

RCB needed to move on and southpaw Shivam Dube provided the timely strike, dispatching Ravi Bishnoi to consecutive sixes to amass 19 runs from the over.

Following Dube's dismissal in the 15th over, De Villiers finally joined Kohli for the late assault, which was eventually provided by Morris.

## New Zealand's oldest surviving Test cricketer John Reid dies at 92

**A U C K L A N D (TIP):** New Zealand's oldest surviving Test cricketer and former captain John Reid has died here at the age of 92, the country's cricket board said on Wednesday, Oct 14.

Reid, regarded as one of the world's best all-rounders during his heyday in the fifties and early sixties, captained New Zealand in 34 Tests including, most notably, the country's first three victories.

"He was, and will remain, a household name in this country, having helped pave the way for everything that has come in his wake," New Zealand Cricket chief executive David White said in a statement offering his tributes.

The NZC release, however, did not specify the cause of Reid's death.

"Our thoughts and respect are with his family at this time: wife Norli; children Alison, Richard and Ann, and all his grand-children," White said.

Born in Auckland, and educated in Wellington, Reid played 246 first-class games and scored 16128 runs at 41.35, including 39 centuries, while taking 466 wickets at 22.60.

A hard-hitting right batsman and a seam bowler, he played 58 Tests after making his debut as a 19-year-old in 1949, scoring 3428 runs at 33.28, while taking 85 wickets at 33.35.



## Neymar goes past Ronaldo to become 2nd highest goal-scorer for Brazil

**N**eymar has surpassed Ronaldo to become the second-highest goal scorer for Brazil. Neymar scored hat-trick against Peru in the 2022 FIFA World Cup Qualifier which helped Brazil register a 4-2 win on Tuesday, Oct 13, evening. He has now taken his international tally to 64 in 104 games, two more than Ronaldo who had scored 62 goals in 98 matches for Brazil. Legendary striker Pele leads the chart with 77 goals for Brazil.

In August, legendary Brazil goalkeeper Taffarel had termed Neymar as a superstar. In an interview to FIFA.com, he had said of the Paris Saint Germain striker: "A great player. He plays the game in a beautiful way. He's an incredible dribbler, sets up goals, scores fantastic goals." "He's very important for us. We really hope he can be at his best and help Brazil win another World Cup. He's a superstar," Taffarel added.




