## SPACEX LAUNCHES 4 AMATEURS ON PRIVATE EARTH-CIRCLING TRIP

**NEW YORK (TIP):** It was the first time a rocket streaked toward orbit with an all-amateur crew - no professional astronauts.

SpaceX's first private flight blasted off Wednesday, September 15 night with two contest winners, a health care worker and their rich sponsor, the most ambitious leap yet in space tourism.

It was the first time a rocket streaked toward orbit with an all-amateur crew - no professional astronauts.

The Dragon capsule's two men and two women are looking to spend three days circling the world from an unusually high orbit - 160 km higher than the International Space Station - before splashing down off the Florida coast this weekend.

Leading the flight is Jared Isaacman, 38, who made his fortune with a payment-processing company he started in his teens.

It's SpaceX founder Elon Musk's first entry in the competition for space tourism dollars. Isaacman is the third billionaire to launch this summer, following the brief space-skimming flights by Virgin Galactic's Richard Branson and Blue Origin's Jeff Bezos in July.

Joining Isaacman on the trip dubbed Inspiration4 is Hayley Arceneaux, 29, a childhood cancer survivor who works as a physician assistant where she was

# PM Modi to visit US to attend Quad summit, UNGA debate

IT IS MR. MODI'S FIRST VISIT TO THE US AFTER CHANGE OF GUARD IN WASHINGTON

**NEW YORK (TIP):** Prime Minister Narendra Modi will visit the US to attend Quad Leader's Summit on September 24 and the high-level segment of the United Nations General Assembly (UNGA) on September 25.

Mr. Modi will visit the White House on September 24 to participate in a Quad leaders summit hosted by U.S. President Joe Biden.

The Quad meeting of Mr. Modi, Mr. Biden and the Prime Ministers of Japan and Australia Yoshihide Suga and Scott Morrison is the first in-person meeting of its kind at the White House.

The four leaders will review progress made since their first virtual summit in March, the Ministry of External Affairs (MEA) said. Specifically,

**NEW YORK (TIP):** Prime Minister Narendra Modi, West Bengal Chief Minister Mamata Banerjee and Serum Institute of India CEO Adar Poonawalla have been named among the world's 100 most influential people of

2021 by Time magazine.

The magazine on Wednesday, April 15, unveiled its annual list of 'The 100 Most Influential People of 2021', a global list that includes US President Joe Biden, Vice-President Kamala Harris, Chinese President Xi Jinping, Duke and Duchess of Sussex Prince Harry and Meghan, former US president Donald Trump and co-founder of the Taliban Mullah Abdul Ghani Baradar.

Time's profile of Modi says India has had three pivotal leaders - Jawaharlal Nehru, Indira Gandhi and Modi. "Narendra Modi is the third, dominating the country's politics like no one since them." The profile by CNN journalist Fareed Zakaria accuses the 69-year-old leader of "eroding the rights" of India's Muslim minority and intimidating journalists.

## FINANCIAL BIDS RECEIVED FOR AIR INDIA DISINVESTMENT: TATA SONS AND SPICE JET AMONG BIDDERS

**NEW DELHI (TIP):** Government of India said, September 15, that it has received multiple financial bids for buying national carrier Air India. Meanwhile, a Tata Sons spokesperson told PTI that it has put in a bid for the airline.

"Financial bids for Air India disinvestment received by Transaction Adviser. Process now moves to concluding stage," DIPAM Secretary Tuhin Kanta Pandey tweeted.

The government is seeking to sell 100% of its stake in the state-owned national airline, including Air India's 100% shareholding in AI Express Ltd and 50% in Air India SATS Airport Services Private Ltd.

The stake sale process, which began on January 2020, faced delays due to the COVID-19 pandemic. In April 2021, the government asked potential bidders to put in financial bids.

September 15 was the last day for putting in financial bids.

Tata Group was among the multiple entities that had put in initial expression of interest (EoI) in December 2020 for buying the Maharaja. With previous attempts since 2017 failing to get any significant interest and after receiving

# A Patel at the helm: On change of guard in Gujarat

## THE BJP IS ONCE AGAIN WILLING TO ACCOMMODATE DOMINANT CASTE GROUPS

Effecting the fourth change of guard in a State this year, the Bharatiya Janata Party (BJP) replaced Vijay Rupani with Bhupendra Patel as Chief Minister in Gujarat on Sunday. Though the decision came out of the blue, intrigues that led to it had been gaining momentum for a while. To keep it all under the wraps, the government in Gujarat went so far as arresting and sending to jail a journalist under sedition charges for reporting that a change of guard was on the cards. Patels or Patidars have been the backbone of the BJP in Gujarat, but the elevation of Narendra Modi as Chief Minister in 2001 unsettled the cozy relations between the community and the party. Anandiben Patel succeeded Mr. Modi after he became Prime Minister, but she did not last in office for long. A partial ejection of Patels to accommodate a wider range of caste groups in its tent was the BJP approach under Mr. Modi and Amit Shah, and their national strategy mirrored this Gujarat experiment. The Patels in turn rebelled against the Modi-Shah axis several times in the last two decades. Mr. Rupani was less than impressive in administrative tasks or management of the social coalition. The COVID-19 pandemic exposed his failures starkly. With the Assembly elections looming, the Patels getting more restive, and the Aam Aadmi Party trying to emerge as a more viable opposition than the rudderless Congress, the BJP had to act. The Chief Minister-designate is a first-



time MLA who was elected from the constituency vacated by Ms. Patel. The change also underscores the high command culture that is now entrenched in the BJP.

The return of a Patel at the helm indicates a reversal of the BJP strategy of building coalitions of diverse caste groups under a leader from a marginal caste. Mr. Modi projected himself as a backward class leader in 2014, and subsequent choices in leadership at various levels largely followed this trend. There have been exceptions, such as Yogi Adityanath, a Rajput, who was elected Chief Minister in Uttar Pradesh. Within the party and outside of it, dominant castes have been resenting this and the BJP has now begun to feel the pressure. When it had to replace

veteran warhorse B.S. Yediyurappa, a member of the dominant Lingayat community as Chief Minister in Karnataka, the BJP ensured that his successor was from the same community. The ongoing stand-off between the party and the Jat farmers in U.P. and Haryana is also indicative of the tension between the BJP and a dominant social group. The party's Chief Minister in Haryana, Manohar Lal Khattar, is facing the heat. These communities are bargaining for a bigger share of power in the BJP's Hindutva tent. The BJP is partially acting under pressure, but it may also be feeling more confident of the support of the marginal communities and poorer sections to accommodate its traditional supporters. ## Positive climate: On India engaging the U.S.

### ENGAGEMENT WITH THE U.S. SHOULD HELP INDIA EXPAND MITIGATION, ADAPTATION ACTION

India's front-line position as third highest emitter of greenhouse gases has sharpened focus on its future policy course to mitigate carbon emissions under the Paris Agreement. It has an irrefutable claim to a big part of the remaining global carbon budget, along with other smaller nations with low historical emissions, but room for maneuvering has shrunk in a world facing record temperatures and calamitous weather events. There is escalating pressure for India to commit itself to a date when it can achieve net zero - removing as much GHGs as it emits - on the lines of the goal set by the U.S. and the European Union for mid-century, and 2060 by China. Declaring a net zero plan under the Paris pact is a disquieting prospect since it would impose expensive choices, particularly in energy production. That conundrum has been addressed, at least partially, by

visiting U.S. Special Presidential Envoy for Climate John Kerry, with the promise of financing and technology to make renewable energy the core of future development. Specific areas of cooperation to bring down emissions - in the expansion of transport, buildings and industry - and facilitating funding for 450 GW of renewable energy by 2030 can advance the India-U.S. Climate and Clean Energy Agenda 2030 Partnership. More clarity on the bilateral road map towards emissions reduction may come at the COP26 conference in November. India, meanwhile, needs to get all States to mitigate emissions and help them adapt to climate-linked extreme weather and atmospheric pollution caused by fossil fuels.

At the end of 2020, a year marked by COVID-19 and many destructive storms, the Union Environment Ministry declared that the country had achieved 21% of its 33%-35% target to cut emissions intensity of GDP by 2030, and, similarly, was generating 37.9% of the 40% of power from renewables. Though

encouraging, the immediate challenge lies in coming up with an adaptation framework to help those at highest risk - the millions living in the path of annual cyclones, including residents of populous coastal cities. Raising the ability of city administrations to handle tens of millions of liters of water regularly dumped in just a few days requires planning, funding and political commitment. Making low-cost insurance available for houses against climate-related losses will raise resilience, and lead to audits, encouraging governments to reduce risks. The Paris Agreement can easily fund much-needed urban retrofitting and boost employment. There is also a health imperative. Heat stress has a severe impact, causing higher mortality among the vulnerable elderly. These are growing problems, but they also represent an opportunity to steer post-COVID-19 policies towards benign, green development. For a low-emissions future, policies must put nature at the center.

# 'Jaipur Foot USA at Your Doorstep' Mobile Van for Prosthetics Fitment Flag Off Ceremony

**NEW YORK (TIP):** Jaipur Foot USA organized a virtual event to launch the "Mobile Van for Prosthetics Fitment". The blessing and flag-off was performed by Dr. H R Nagendra, founder Chancellor of Swami Vivekananda Yoga Anusandhana Samsthana, and Padam Bhushan Shri D R Mehta, founder and Chief patron of BMVSS. Mr. Piyush Parikh moderated the event.

The funding to purchase a large van, equip and install the equipment required, and power generator to power the equipment in case the village doesn't have electricity, was provided by Nikhil Mehta and Shri Kanak Goliya, his grandfather. Shri Goliya ji's family has been associated with BMVSS since 1976, and they have been a regular financial contributor to the BMVSS ever since.

The Mobile Van initiative is a unique and

innovative effort to address the prosthetics fitment problem for the people from the lowest economic ladder of our society by Jaipur Foot USA/BMVSS. This van is equipped with men and machines to fit artificial limbs to 7 to 10 people a day. Tomorrow, the mobile van leaves with eight highly qualified prosthetics professionals from BMVSS, Jaipur, to its first destination Vadnagar, honorable PM Shri Narendra Modi's native village. As part of this mission, BMVSS has committed to help a minimum 71 differently abled people, a symbolic number to celebrate Shri Modi ji's 71st birthday. Mehta is not only advisor of Jaipur Foot USA, but he also provides funding for various projects to Jaipur Foot USA every year, and he is the first to offer helping hand in time of need. It is exciting and pleasure to report that Mr. K.K. Mehta also announced that he would provide funding and sponsorship for another Mobile-Van for prosthetics fitment. Mr. Nikhil Mehta has opened an avenue through which many members are motivated and provide funding to expand on what he started.

Dr. Nagendra blessed this project and spoke about the need for giving and Mr. Mehta and BMVSS's contributions to society and humanity. He also requested to organize an artificial limb fitment camp in Bangalore as a first step and establish a permanent center at the University premises to provide year-round help to differently abled people in Karnataka. OP Choudhary requested the blessings from Dr. Nagendra ji and Shri D.R. Mehta ji and offered the vote of thanks to all the dignitaries, members who attended the event. Dr. Deependra Mehta, Secretary, BMVSS, introduced the BMVSS team going to Vadnagar and offered a vote of thanks from the BMVSS team.

## Indian-Origin World-renowned Neurosurgeon helps save Israeli twins conjoined at the head: Report

**JERUSALEM (TIP):** A world-renowned Indian-origin pediatric neurosurgeon in the UK has helped a group of Israeli doctors to successfully operate on a pair of twins conjoined at the head, with the babies now likely to lead normal lives, a media report said.

This is for the first time that Dr. Noor Ul Owase Jeelani, who was born in Kashmir and works at London's Great Ormond Street Hospital, agreed to carry out such a surgery outside the UK when contacted by doctors at Israel's Soroka hospital, according to a report in The Times of Israel (TOI).

He and his colleague, Professor David Dunway, are globally seen as experts on such cases. Mr Jeelani said, "from a doctor's point of view, we're all one" and that medicine transcends all divisions.

"He said that the fact that a Kashmir-born Muslim doctor scrubbed up alongside an Israeli team to help a Jewish family was a reminder of the universal nature of medicine," the report quoted him as saying.

"It was a fantastic family that we helped," Mr Jeelani said, adding, as I've said all my life, all children are the same, whatever color or religion". "The distinctions are man-made. A child is a child. From a doctor's point of view, we're all one," he emphasized. The doctor found the family's delight at the success of the operation "deeply moving".

"There was this very special moment when the parents were just over the moon. I have never in my life seen a person smile, cry, be happy, and be relieved at the same time. The mother simply couldn't believe it, we had to pull up a chair to help her to calm down," Mr Jeelani told the news portal.

Mr Jeelani is said to have also worked for months on the surgery of the Israeli twins. "We've been involved right from the start, talking to the team in Israel and planning it with them over a period of six months," he said.

"This latest surgery fulfills a key objective of our charity, namely, to empower local teams abroad to undertake this complex work, successfully utilizing our experience, knowledge, and skills gained over the past 15 years with our previous four sets of twins," the neurosurgeon stressed.

# Indo-Canadian Jagmeet Singh-led NDP may again play kingmaker

**OTTAWA (TIP):** The New Democratic Party (NDP), led by Punjab-origin Canadian Jagmeet Singh, can again prove to be a "kingmaker" in the country's federal election scheduled for September 20.

As the latest trends indicate a neck and neck fight between Liberals and Conservatives, the party with small but crucial number of seats would be important if both main parties fail to get majority. In 2019, Justin Trudeau's Liberal Party got 157 seats, 13 short of majority in the 338 House of Commons and Conservative got 121 seats. The NDP had won 24 seats. Trudeau formed a minority government with the support of NDP.

Eying to convert his minority government into majority and confident of getting support for his work during the Covid-19 pandemic, Trudeau called mid-term snap polls, but as opinion polls and trends are to be believed, the Opposition is catching up with Liberals over the "high cost" of housing.

Conservative party leader Erin O'Toole is getting support of young voters, whereas the NDP has good base in two thickly populated areas of British Columbia and Ontario and is getting good support from Indian and Asian communities. As per opinion polls, the NDP is expected to increase its seats this time from the previous tally of 24.

The Indian diaspora in Canada is much sought after as a support base as they tend to be high-income professionals and educated. As a group, the people of Indian origin, especially the Sikh diaspora, have become a powerful group and prominent voice in domestic political space.

As many as 47 Punjabi NRIs are in the fray this time. The main issues being raised by the Punjabi NRIs are direct flight ban from India, racism and high housing cost. A political expert claims that many Indo-Canadians stranded in India due to the ban on direct flights will not be able to cast vote and are being deprived of their rights.

### Memorial vandalized

Racial abuse is one of the major issues among the Punjabi diaspora in the election. The Punjabi community in Canada is also upset over the vandalism of the Komagata Maru Memorial situated at Coal Harbor in Vancouver. The incident, reported on August 22, led to resentment among the diaspora.

Sabrina Grover said, "The volunteers were campaigning in an apartment building when they were approached by a man, slapped and spat on. Both my volunteers are unharmed but shaken. This is not right; hateful interaction is unacceptable. I was born and raised in Calgary. This is my home."

NDP leader Jagmeet Singh faced a racist remark while campaigning in Windsor, Ontario. During an event in a park, a man shouted "go back home" from a passing vehicle, while Jagmeet, who was born in Scarborough, Ontario, and raised in Windsor, continued his speech undeterred.

Later, Jagmeet said he doesn't "focus on himself" when such things happen, but he is concerned about the growing level of hate in Canada.

Rachna Singh, an MLA from Surrey Timber Greens and parliamentary secretary for anti-racism initiatives, said, "during the campaign, we have seen candidates' hoardings being vandalized with messages of hate. It's unacceptable and cowardly."

# Indian American Balbir Singh Sodhi, first victim of hate crime post-9/11 attacks, remembered by US lawmakers

**WASHINGTON (TIP):** Top American lawmakers paid rich tributes as they remembered Balbir Singh Sodhi, a Sikh American, who was the first victim of hate crime following the 9/11 terror attacks in which nearly 3,000 people from over 90 countries were killed.

Four days after 9/11, Balbir was killed outside the Arizona gas station he owned. He was the first person in the US to be killed in a supposed act of retaliation for the attacks in 2001.

"Today marks 20 Years Since Balbir Singh Sodhi, a Sikh man, was killed in a hate crime in retribution for the 9/11 attacks. We honor his memory and the memories of all those lost to hate in the two decades since," Senator Robert Menendez said in a tweet.

"Twenty years ago, Sikh American Balbir Singh Sodhi was murdered in the first post 9/11 hate crime. He was shot to death while planting flowers outside his gas station in Mesa, Arizona, by a man who said he wanted to "go out and shoot some towel-heads," said Senator Dick Durbin.

Congresswomen Lois Frankel said

days after 9/11, Balbir, a Sikh man, was killed in 'retribution' for the attacks.

"Today, we honor Balbir's memory and celebrate 20 years of solidarity and advocacy among the communities that continue to persevere against hate and discrimination," she said.

Senator Sherrod Brown said 20 years ago today, Balbir, a Sikh American, was murdered for his appearance.

"His death marked the first deadly post-9/11 hates crime. Today and every day, let's stand united with our Sikh community in Ohio and reject hate and

discrimination," he tweeted.

"Days after 9/11, Sikh American Balbir Singh Sodhi was killed in the apparent first 'retribution' hate crime following the attacks. Today, we honor his memory & remain united in our efforts to fend off all forms of hate & discrimination," tweeted Senator Richard Blumenthal.

"Balbir Singh Sodhi, a turbaned Sikh man, was killed in a hate crime in retribution for the 9/11 attacks 20 years ago today. I stand in solidarity with New Jersey's Sikh community as we honor his memory & the memories of all those lost to hate in the two decades since," said Congressman Donald Norcross.

Balbir's killer Frank Roque is serving life in prison.

As the world marked the 20th anniversary of the September 11 terror attacks recently, Balbir's brother Rana Singh Sodhi said: "We all humans are equal - color, creed and gender. To honor my brother, if you love your neighbors, if you respect people with different color, creed and gender, it will be a big honor to my brother".



## INDIAN AMERICAN COMMENDS US FOR AFGHAN REFUGEES' RESETTLEMENT IN CALIFORNIA

National Asian Pacific American Bar Association last week named Mittal among 2021 Honorees for its Best Under 40 Award along with Puneet V. Kakkar, another Indian American attorney with the US Department of Justice.

The award honors members in the Asian American Pacific Islander legal community under the age of 40 who have achieved prominence in their fields and have demonstrated a strong commitment to the Asian American Pacific Islander community.

Mittal, a Democrat has served as a Deputy Chief at the US Attorney's Office for the Central District of California since 2019, where he has also served as an Assistant US Attorney since 2011.

He was a Field Organizer and Campaign Fellow for the Democratic Congressional Campaign Committee in 2010. Mittal served as a Law Clerk for Amul R. Thapar, the first US federal judge of South Asian descent, at the US District Court for the Eastern District of Kentucky from 2009 to 2010.

# Four Indian Americans Under 40 list in 2021 Fortune 40

Of the four Indian Americans, Young America's Foundation's Raj Kannappan, 30, is responsible for promoting conservative free-market principles among college students around the US, according to Fortune.

The Trevor Project led by Amit Paley, 39, has since 1998 worked to prevent suicide among young queer people via a hotline dedicated just to LGBTQ youth, Fortune notes.

As COO of Investment Banking Division, Goldman Sachs, Akila Raman, 39, is at the heart of the action in a record year of dealmaking and mergers and acquisitions (M&A).

Clubhouse Cofounder Rohan Seth, 37, has been going nonstop since early 2020 with his social media startup that's a cross between talk radio and a group chat, says Fortune.

As director of the Center for Entrepreneurship & Free Enterprise at Young America's Foundation, Raj Kannappan is responsible for promoting conservative free-market principles among college students around the US, according to Fortune.

With a presence on more than 2,000

college and high school campuses, and nearly \$100 million in assets, the group has been quietly funding and supporting campus Republican groups, it says.

They are bringing speakers to colleges and promoting messages of fiscal and social conservatism historically tied to President Ronald Reagan and William F. Buckley.

Kannappan and YAF are also exerting their influence on the legal system. The group has been filing lawsuits against colleges that bar right-wing speakers from campus.

A recent lawsuit against the University of Florida, which repeatedly refused to use school funds to pay speaker fees for controversial Republicans, resulted in the university settling with conservative students for \$66,000 and changing its free-speech rules.

**Amit Paley, 39, CEO and Executive Director, The Trevor Project**

Lesbian, gay, and bisexual youth are more than four times as likely to consider suicide as their straight peers. Since 1998, the Trevor Project has worked to prevent suicide among young

queer people via a hotline dedicated just to LGBTQ youth, Fortune notes.

And since 2017, when Amit Paley took the reins as CEO of the nonprofit, the organization has dramatically increased the number of young people receiving support.

Through a focus on innovation, technology, and research in the understudied field of LGBTQ youth mental health, Paley has expanded the number of staff working to help this vulnerable group and quadrupled the number of youth in crisis the organization serves each month.

Paley also serves on the National Suicide Prevention Lifeline steering committee and the executive committee of the National Action Alliance for Suicide Prevention.

He told Fortune that being involved in the mental health space at large helps him advocate for LGBTQ youth and their specific needs.

The Trevor Project also takes that advocacy seriously at the government level, working to end conversion therapy, oppose anti-transgender legislation, and establish "988" as the number Americans can call (starting next summer) to reach their Suicide Prevention Lifeline.

Since Covid took hold of the world, Paley took the Trevor Project entirely remote for the first time, while dealing with nearly double the volume of calls pre-pandemic.

Many LGBTQ youth, who make up a disproportionate 40% of homeless youth, are stuck in situations that worsen their mental health, like living in homeless shelters or spending more time at home with unsupportive or abusive parents.

During the pandemic, Paley also led the organization in continuing its long-held commitment to intersectional activism, supporting queer Black, Asian American, and Pacific Islander youth during the outrage over George Floyd's death and racist attacks on those in the AAPI community.

**Akila Raman, 39, COO of Investment Banking Division, Goldman Sachs**

Dealmaking and M&A have had a record year-and Akila Raman is at the heart of the action, notes Fortune. Promoted in early February, Raman runs operational strategy for the global investment bank.

She's currently focused on international expansion and growth in new products like ESG. Having started as an intern in 2003, Raman spent most of her time with natural resources companies in sectors such as energy, power, and metals.

She has also prioritized using technology and automation to streamline the workflow and relieve stress among the Goldman investment bankers she oversees.

As the daughter of Indian and Korean

immigrants, Raman hasn't seen many people who look like her on Wall Street, and she's spent years mentoring women and people of color-not just at Goldman but across the industry. "Whenever I leave this place and career, that will be a really cool legacy," she says.

**Rohan Seth, 37, Cofounder, Clubhouse**

Rohan Seth's combination of product and tech chops coupled with an entrepreneurial drive helped get him on Fortune's annual 40 Under 40 list, according to the business magazine.

Since early 2020 when he cofounded Clubhouse, a social media startup that's a cross between talk radio and a group chat, he's helping steer one of the most talked-about consumer apps in recent years at a crucial time in its history.

When the coronavirus pandemic forced people to stay home, the service exploded in popularity. Millions downloaded the app to listen to luminaries like rapper MC Hammer and Tesla CEO Elon Musk.

As an engineering lead at Clubhouse, Seth is responsible for ensuring the app can handle the huge influx of users, the magazine says.

In 2019, Seth created the Lydian Accelerator, a health care nonprofit named after his daughter Lydia that is focused on discovering treatments for rare genetic disorders.

Lydian Accelerator's goal is to uncover the medical treatments that traditional pharmaceutical giants may ignore because of their rarity.

Taking cues from the tech industry, the accelerator aims to open-source and make free the genetic data, processes, and protocols necessary to develop potentially game-changing personalized treatments.

NEW YORK (TIP):The Partap Brothers have been nothing short of an institution when it comes to the Indian classical music, especially Gurmat Sangeet. **Y**ogi Adityanath is presently in his element. He is busy needling the voters who address their fathers as 'abba jaan'! Often in the past, he has gone beyond mere needling, for the Muslims are his 'bete noire'.

Tackling Covid, and now dengue, is not what interests him. These are unnecessary interferences in his 'divine' task of ridding his state of what he considers to be pests, criminals, beef eaters, cow killers and, above all, jihadi terrorists.

In my city Mumbai, I know many Muslims, some at the top end of society and many more at the low end residing in slums. The latter I got acquainted with more intimately when I returned home from Romania where the only Muslims I met were either diplomats or locals who waited at diplomatic dinner tables, including my own. They were in great demand, despite their penchant for sampling the wines, fortunately after the guests had departed.

My friends, largely from the Race Course, do not seem to be too concerned with religion. I am not sure if they prayed, even when their horses were in the race! My humbler friends, who formed the nucleus of the mohalla committees, formed after the 1993-94 riots to foster communal harmony and peace, were busy during most days eking out a living! They could spare no time on hate, like the Yogi seems to have, particularly at election time.

Speaking of elections, due in UP in the next six months, I thought he had spread enough vitriol that appealed to listeners who had no difficulty in blindly accepting the words that emerged from his mouth. Unfortunately, the farmers and Covid-19 have combined to deny him the walk-over he had banked upon.

The resulting uncertainty surrounding the outcome of the 2022 Assembly elections had forced him to fall back on hate and communal division to recover lost ground. Will the ploy succeed? No one can tell at the present moment. But, God forbid if it does, it will not be good for the country. A divided country is a sure recipe for disaster. If the minorities, who constitute 20 per cent of the population, are reduced to second-class status the country will have a sizeable chunk of permanently alienated citizens. And to these the ones in power will have to add a constantly floating number of the temporarily alienated, like farmers of Punjab, Haryana and western UP and castes aspiring to be

downgraded in official rankings in order to corner jobs, besides the political power that comes with sheer numbers.

A communal divide has existed in UP, as it did in Mumbai, for centuries. It was dormant till elections were held and political parties vying for power appeared on the horizon. The accusation against the Congress of appeasement of minorities has found traction with the voting public.

I have often tried to analyze this accusation. The Muslims are one of the three groupings (the two others being the SCs and STs) in our society that are economically and educationally backward. If the Congress or any government of the day had pampered them in the sphere of education or health, I would support that 'appeasement' with my eyes shut. But the Congress party only gave in to demands of concessions to religious beliefs that no secular democratic government should concern itself with.

Religion is a personal belief. It concerns only the believer and his or her understanding of creation and the afterlife. Why should the State get involved? Rajiv Gandhi made his biggest political blunder when he conceded the maulvis' demand to undo the mischief of the Shah Bano judgment. The State should govern justly and fairly without getting involved in religious matters. It should make it a pillar of State policy to keep 'miri' and 'piri' separate.

Yogi Adityanath has stretched credibility by alleging that those who address their fathers as 'abba jaan', the Muslims, were the only community that was provided with rations before 2017, the year he became the CM! Rations from fair-price shops are available to the poor at reduced rates. Since Muslims, SCs and Adivasis are the poorest, community-wise, it may be that Yogi saw more Muslims and Dalits in ration queues before 2017 when he was out on the streets fighting for power. That position would hold firm today also, but Yogi is confined most of the time to his chair in the 'mantralaya' and may not have noticed this. But the damage has been done. People are gullible. They believe what the 'great leaders' tell them!

My friends in UP and my associates in Mumbai who hail from UP tell me that Yogi has a large following in the state. As CM, he has performed creditably in curbing ministerial corruption and keeping senior bureaucrats on their toes. Of course, he has not been able to control low-level corruption in the revenue, police and other departments, but that has not been achieved in any state of India. Yogi created a flutter at the start of his reign by ordering the police to shoot criminals on sight. He has mellowed somewhat as wiser men have counselled him of its dangers.

He has floundered in the fight against Covid. He has been inattentive to the inroads made by dengue. He has obviously not given health infrastructure the attention it needs. This may not affect his fortunes at the hustings because the BJP's counter-propaganda machinery has been tested and proved more than worthy. It can make black into white and vice versa!

What could mar his prospects, though, is the farmers' agitation. The farmers were with him in 2017. They will not oblige this time round unless he mollifies them to an extent, he may find impossible to do. And then, there are also the bodies that floated down the Ganga and landed on the banks of Bihar!

# Two democracies and their vigilante problem

**WHILE IN INDIA, THE WORD SPELLS BAD NEWS, IN THE U.S., AS SEEN IN TEXAS, THE CITIZEN ARRESTER SEEMS HARDLY DIMINISHED**

In the world's largest democracy, the word 'vigilante' evokes unsavory images of goons stopping cattle trucks and lynching drivers, or video filming themselves assaulting men accused of love jihad or beating up couples celebrating Valentine's Day. A vigilante in India is both bad news and a bad word. Vigilantes are anti-democratic. They lack the values of a constitutional democracy. A consensus has emerged in India to demand that the law-and-order machinery comes down heavily on such vigilante behavior.

### **A respectable garb in the U.S.**

So, imagine my shock when I discovered that in the world's oldest democracy, the word 'vigilante' receives only half the opprobrium that we heap on it in India. The other half is suppressed by a law that makes vigilantism respectable. One form of the vigilante, in the United States, is the 'citizen arrester' who enjoys legal status and whose actions are protected by a law that permits him or her to pursue and arrest a person accused of breaking the law. Drawing on a legal convention that comes from the Common Law tradition in England, dating from the 12th Century, a citizen arrester can physically arrest a person, on behalf of the Monarch (now State) who is regarded by them as breaking or evading the law. There are procedures to be followed, and risks involved for wrongful arrest, but assuming that these are adhered to the citizen arrester is regarded as aiding the consolidation of a political system based on the rule of law. Because of its potential for abuse, in legal circles in the U.S., there is a debate on the need to circumscribe the scope, and eligibility, of who can be a citizen arrester.

### **The 'Heartbeat Bill'**

But rather than diminish the place of the citizen arrester, the recent decisions of the Texas legislature are in fact encouraging the practice. Two cases are particularly noteworthy. The first is the latest innovation introduced in Senate Bill 8 (SB8) in Texas, known as the 'Heartbeat Bill', signed into law by the Texas Governor Greg Abbott in May 2021, that seeks to ban abortions after six weeks when the fetus registers a heartbeat. The passage of this law has produced an active debate in the U.S., between pro-abortion and pro-life groups, drawing on medical science, law, bioethics, and women's rights, to refine the different elements of the Roe vs Wade judgment of 1973.

There are five aspects worthy of attention. The first is it deprives women of the right over their own bodies by making abortion illegal after six weeks when many women do not even know that they are pregnant. This in effect means that abortions, when needed, are

unavailable. The second is to include, in the applicability of the law, even women who are victims of rape and incest. Victims are thereby subjected to a second victimization since now they will be compelled to carry the pregnancy to full term or seek termination in the dark alleys beyond the law. The third is to make culpable anyone associated with an abortion after six weeks and this could include the Uber driver who takes the pregnant woman to the clinic, the receptionist, the nurse and the doctor. The fourth is the declining, by the Supreme Court of the USA, in a five versus four vote, to hear the injunction challenging the Texas Anti-Abortion Law.

In her dissenting note, Justice Sonia Sotomayor wrote: 'Presented with an application to enjoin a flagrantly unconstitutional law engineered to prohibit women exercising their constitutional rights and evade judicial scrutiny, a majority of justices have opted to bury their heads in the sand... The Court should not be so content to ignore its constitutional obligations to protect not only the rights of women, but also the sanctity of its precedents and of the rule of law.'

This sandy terrain to which the court retired is, unfortunately, very familiar to us in India. And the fifth, on which I wish to comment here, is the legal device that blocks State officials from enforcing the law but outsources the enforcement to private citizens who can sue abortion providers from performing abortions and are entitled to collect \$10,000 as a civil payout in addition to their legal fees. Such a person can even be someone from outside the state who can show any connection to the abortion. Enter the 'bounty hunter' or 'citizen arrester'.

While each of the five aspects raises important ethical and legal issues I wish to highlight only the fifth since Republicans in Texas have used the legal device - call it a cunning innovation - of empowering and encouraging citizen arresters to perform the job of state officials who are thereby protected from being sued. The effect of this innovation is to deny women the rights given by Roe vs Wade. The case shows the length to which partisan groups in a democracy, even in one as mature as the U.S., will go to overturn settled law and redesign both the public discourse and the institutional order to make it consistent with their religious ideology. Linda Greenhouse commenting on the legislation in her article in The New York Times (September 9, 2021) asked in exasperation: 'Who let God into the legislative chamber?' This is the same question we often ask in India.

### **Voting Reforms**

The second case in Texas concerns the Reforms to the Voting Law in Texas which seek to reverse the gains of

earlier years. SB1, the Bill recently signed by the governor, bans drive through voting, 24-hour voting, and distribution of mail-in applications. It requires new ID requirements for voting by mail, creates new rules for voter assistance, establishes monthly checks, etc. To block the passage of the Bill, the minority Democrats who felt the changes amounted to voter suppression and would disadvantage minority voters, flew out of the State to Washington DC so that the house could not convene for want of a quorum. The Republicans responded by relying on the law to compel voting and thus Speaker Dade Phelan signed warrants authorizing the Sergeant-at-Arms to arrest and produce the missing representatives. The length to which the Speaker went is shocking to our democratic sensibilities. Some representatives stated that they were less worried of being arrested by officials and more by citizen arresters.

In an overview article titled 'Vilifying the Vigilante: A Narrowed Scope of Citizen's Arrest', Professor Ira P. Robbins discusses its historical origins, pitfalls, good application and reform. He argues for the scope of citizen arresters to be restricted to only a small category of people, such as shopkeepers, out-of-jurisdiction police, and private police forces, and being abolished in all other cases. The trend, unfortunately, as shown by Texan laws, SB1 and SB8, is moving in the other way. Because of the opprobrium we have heaped on vigilantes in India, I hesitated to equate them with the citizen arrester till I read the phrase in a letter on SB8, by the Chairman of the U.S. House Judiciary Committee, Jerrold Nadler, to the Attorney General, Merrick B. Garland, to prosecute 'would be vigilantes attempting to use the private right of action established by that blatantly unconstitutional law'. The oldest and the largest democracies, it seems, both have a vigilante problem today.

# Authentic Family Engagement in the 'New Normal' Education System

In the post pandemic 'New Normal' era, undoubtedly, lots of things in our every-day lives are going to change forever. Amongst them, surely, we can expect to see significant changes in the education system and what would those changes be? Virtual Classrooms, Online Coursework and long periods of physical absence from school campus are some of the things that we are already witnessing. But these are not all. During a conversation with journalists at the Education Writers Association (EWA) National seminar, Education Secretary Miguel Cardona provided a glimpse of other fundamental changes when he said that as the education department hits the reset button on things, amongst other changes, they want to see more of 'natural authentic engagement of families' than they do now.

Expanding on that theme and looking deeper, there is no doubt that the role of families in education has shifted as the pandemic has hit the core of parents' relationship to their children's learning and has changed it forever. In America at least, parents have now been forced to engage with children's classwork and homework much more intensely than before. But is this change similar across all ethnic families? In America, which is a country of immigrants, it's very crucial to know the cultural background of the family. The upbringing style of kids in neo-Indian American family, for example, is totally different from a legacy American family.

If we look at the education system in India in comparison to the one here in America, there is a fundamental difference. In Indian families, there is a great deal of parental involvement in almost every aspect of life and education is no exception. Actually, schools play minor roles in Indian society and it is

parents who influence their kids' future more. In America, it's perhaps opposite. And hence many Indian families, after migration find it difficult to adjust to the 'hands-off' education system here, especially if their child has been in the education system in India before migration.

Jaskiran Beri, who recently moved to New York from India with her six-year-old son Kabir, feels that for 'authentic family engagement' factors such as the environment, the background of parents, lifestyle, financial stability, responsibilities, cultural awareness, language skills and more need to be appropriately assessed by the education system, or schools as the case may be.

"I feel Indian parents are more anxious when it comes to their child's education. Even if they don't find time, they depend upon other community members to help their kids. Indian parents usually are a byproduct of the Indian education system, thus, leading them to be much serious, stricter when it comes to academics", says Jaskiran.

But as a new age mother, Jaskiran did not find it hard to get accustomed to the American education system here. "I feel the teachers in US are doing a great job! Ever since my son started his schooling, all the teachers, have always been kind enough to involve me in classroom support activities, craft projects, making those phone calls to talk to me personally in case of if they do not understand something that me or my son would say or do. As a parent, I am always involved with the teacher on emails, so I can communicate freely if need be and vice versa. I believe Covid-19 has taught us all how to take care of anything and everything almost remotely. We have been able to pull it off very well without the engagement on a physical level yet being able to keep in touch via other means. We try to work along on overall skills of my child."

But every recently migrated Indian parent is not like Jaskiran. An educator of Indian origin who works with the Edison (New Jersey) school board (she did not want to be named), says that living and working in the same school district gave her an opportunity to observe certain things that may otherwise go unnoticed. "Edison is typically a township where over 50% of students are from immigrant families of India, and other Asian countries. These last two school years under COVID times, gave me a unique perspective into the family dynamics of the students who are virtual learners. There is a lot of parental involvement here. These are hands-on, very invested in their children's education, type of grown-ups. While students thrive

with such tutelage, sometimes it seems that there is more involvement than necessary. It often ends up being the case where the parents help a bit too much. Sure, that improves grades of the students, but how much they are really learning, remains to be seen."

"Too much parental involvement might lead to other problems like mental health issues too," Dr Mousumi Bose, associate professor at Fairfield University and mother of two girls, points out. "Mental health is more mainstream than any of us would want to recognize. Not just in Indian families but in many others, mental health comes in many forms and strengths. And yes, mental and emotional health discussions should be a part of our daily lives just like we discuss food, studies etc."

Thus, as we see, depending upon cultural and ethnic background of the families, there are enablers and barriers in the way of effective family-school partnerships that are needed to build uniform family engagement practices throughout the American education system.

A Carnegie Corporation of New York report by Karen L. Mapp and Eyal Bergman of the Harvard Graduate School of Education outlines how to reach a more liberatory, solidarity-driven, and equity-focused family engagement practice. "Educators should certainly learn about the research and best practices in family engagement, but they also need to engage in dynamic and interactive experiences with families directly". Interactive forums that promote family voices offer opportunities for unlearning problematic family engagement practices and propagating meaningful dialogue that builds trust and understanding would help, says the report. "By investing in authentic relationships with families and honoring them as children's first teachers, educators invariably learn about children's learning styles, strengths, interests, and values. Educators can then use these "funds of knowledge" to enhance curricular and pedagogical strategies", it adds.

Education is indeed a challenging space now. There are exciting possibilities, however both families and educators definitely have to work together as co-learners and co-developers of their wards to shape future generations. They have to collectively figure out what 'Authentic Engagement' should look like.

# What to expect from this year's UN General Assembly (UNGA)

**NEW YORK (TIP):** This year's United Nations General Assembly could make or break the future of in-person meetings at the gathering in New York City.

After a year of carefully negotiating, adapting and crafting health guidelines, UNGA organizers are hoping to avoid a repeat of last year's first, almost entirely virtual, gathering.

But the threat of the Delta variant in the United States still looms large, and many countries will likely wait until the last minute to confirm their plans as to whether to travel to the UN this month.

Yet a provisional schedule, first obtained by PassBlue and Geneva Solutions, provides insights into which countries may come to New York City and which are not likely to make the trip. The high-level week - the annual general debate - starts on Sept. 21 and lasts until the 27th.

The organization of this year's opening session of the 76th General Assembly has already met some roadblocks. Mark D. Levine, a member of the New York City Council, denounced that the UN (like its host country) isn't requiring that people attending the UNGA be vaccinated to visit New York City, tweeting on Aug. 13: "The UN is not requiring vaccination for participants. This will expose them, and NYC, to serious risk. The UN needs to announce now that vax will be mandatory."

"There is improvement [from last year], but there is also worry," Tijjani Muhammad-Bande, Nigeria's ambassador to the UN and president of the 74th General Assembly, said in an exclusive interview. "The urge is to be cautious, to limit the number that are coming in, they have to come and to still have substantive discussions."

## You're welcome, but please don't come

The US mission to the UN sent a letter to its fellow 192 UN missions on Aug. 16 urging them to send a pre-recorded message to avoid the risk of the week becoming a "superspreader event."

"The United States needs to make clear our call, as the host country, for all UN-hosted meetings and side events, beyond the General Debate, to be fully virtual," the letter says. It also says that "heads of delegation should consider delivering their statements to the UN General Assembly's General Debate by video."

While some countries inferred that the letter was a request to stay home, many of them saw it coming and had planned only small delegations to make the trip, as the General Assembly had already decided that only four delegates, including the head of state or government, could attend the debate in the Assembly Hall during the high-level week.

"The desire is to have an improvement over what we had last year, a hybrid meeting, which allowed one delegate, one person per delegation," Bande said. "The improvement in terms of vaccinations has been clear in the position now, so this desire is not to be fully hybrid, from my standpoint as a member of the assembly, not as President."

"I think many are coming," Vassily Nebenzia, Russia's ambassador to the UN, told journalists in mid-August. "We hear that many delegations will be represented in-person, I believe, including ours."

Estonia Foreign Minister Eva-Maria Liimets didn't see the US letter as an invitation not to come to New York City, but her country is still taking a wait and see approach: "We follow the rules," she said, "but we suggest to have a debate to have the conversation as much as

possible during this week." Estonia is planning to send a team of 10-15 people to Manhattan.

The initial list of speakers, subject to change, for the high-level week of the opening session of the UN General Assembly. "HS" means "head of state"; "HG" is "head of government"; "M" is generally the foreign minister.

While many heads of state and government want to come, many countries are facing several factors affecting their decisions. World leaders tend to travel with an entourage: security, communication, chief of staff, photographers - so it's hard to cut down the team. With only a maximum of four people allowed to sit in the General Assembly Hall during the high-level week for each country, some delegations are trying to figure out how to manage that restriction. One country even said it was trying to "borrow" seats in the Hall of other countries who may not be sending a delegation. Neither the Secretariat nor the office of the President of the General Assembly was able to say if swapping was a possibility.

The UN is supposed to have "bilateral booths" for meetings between delegates inside the headquarters. A June 23 letter sent by the current President of the General Assembly, Volkan Bozkir, says: "Presence of leaders and Ministers in New York for high-level week will result in significant opportunities for bilateral meetings, which will be logistically challenging to accommodate in Midtown, especially for smaller delegations, and difficult to justify from a health perspective when UNHQ itself would have more room than hotels or Missions."

Liimets thinks meetings can be productive while at the UN: "We can use hotels, we can use our offices, and of course we need to brainstorm where to organise the side events," she said. "But I would say that here in New York, there are many appropriate facilities like Bohemia house of the Czech Republic."

## To vax or not to vax?

After City Councilmember Levine complained about delegations' vaccinations status, the UN spokesperson was asked repeatedly how the UN would ensure that UNGA would be held safely in the pandemic without requiring every diplomat attending to be vaccinated.

After much deliberation between the UN and health authorities, the UN is making vaccination mandatory for its own staff members but not for foreign diplomats. While diplomats coming to New York City "should voluntarily disclose" their vaccination status, the UN has decided to go with an "honor system," as disclosing one's vaccination status is only voluntary for foreign dignitaries.

"We're dealing with a very responsible group of people from around the world," Bande said. "Nonetheless, the advice is to continue to state what the circumstance is, for the rules of the UN, as well as the city itself, for the delegations coming into the city have been fully cleared and tested. As to whether we'll need vaccine certificates, I think this is a hugely difficult call to make and discussions should continue."

Everybody inside the UN headquarters must wear a mask and, according to the secretary-general's spokesperson, Stéphane Dujarric, "To align with what's going on here in New York City, people who use . . . the dining facilities on campus will also need to show proof of vaccination."

## Is America back?

While everything remains in flux, the UNGA speakers' list is indicative, for now, as to who is scheduled to come to New York City in person. One is the host country's president. The US is the second country due to speak at the General Assembly but it's unclear whether Joe Biden will attend in person. If he wants to be true to his

"America is back" promise, then he can make the short hop to Manhattan, some diplomats say.

If he does, Biden is likely to come during a difficult time for US foreign policy, amid the 20th commemoration of 9/11 and the controversial withdrawal and evacuation of Afghanistan. When asked about the country's plan, a spokesperson for the US mission said: "We continue to monitor the conditions and health risks in New York and around the world. At this time, we do not have information to announce on travel or the U.S. delegation. As plans come together we will provide you with more information."

Last year, President Donald Trump snubbed the event, sending his video only a few hours before.

## Who's coming so far

Among some of the countries to attend - if the Covid situation doesn't change - are the leaders of the United Kingdom, India, Ireland, Turkey, Switzerland and Moldova. On Sept. 7, France's ambassador to the UN said that President Emmanuel Macron was not coming to UNGA. China's Xi Jinping and Russia's Vladimir Putin are also not expected to attend - and Russia will instead send its foreign minister, Sergey Lavrov, to speak on behalf of Moscow. China's deputy prime minister is also scheduled to show up. Nigeria's President Muhammadu Buhari also plans to come, according to Bande.

## The headliners

**O TURKEY:** One of the most likely leaders to come is Turkey's Recep Tayyip Erdogan, who will be there mainly to inaugurate Turkey's newly renovated mission to the UN - a mission that should be ready by then for a ribbon-cutting ceremony.

**O BRITAIN:** Delegates will also probably hear Prime Minister Boris Johnson's most-likely colorful speech in person. A British diplomat said that for now, Johnson wants to come with Foreign Secretary Dominic Raab to make progress ahead of COP26, which will be held in Glasgow, Scotland, in early November. Johnson's speech is due to be delivered late in the week, on Friday afternoon, Sept. 24, because he is a head of government, not state.

**O INDIA VS. PAKISTAN:** So far, only India's Narendra Modi is supposed to fly to New York City - according to the schedule - and will speak on Saturday, Sept. 25; Pakistan's Imran Khan is not likely to make the trip but will send a pre-recorded video for his speaking slot on Sept. 24.

**O LATIN AMERICA:** Another speaker who could make waves is Peru's recently elected left-wing President José Pedro Castillo, who is scheduled to speak on Sept. 21. Castillo could set the tone on what is to come for the country as he has portrayed himself as aligning with the likes of Venezuela's Hugo Chávez and Bolivia's Evo Morales. Mexico's President Andrés Manuel López Obrador is also scheduled to speak in person, as is Nicolás Maduro of Venezuela, though Obrador is notorious for not traveling much outside the country. President Luis Lacalle Pou of Uruguay is scheduled to attend. For Cuba, Foreign Affairs Minister Bruno Rodríguez Parrilla is expected to attend.

# New bill could help Indians get US Green Card by paying supplemental fee

**EMPLOYMENT-BASED IMMIGRANT APPLICANT WITH A 'PRIORITY DATE THAT IS MORE THAN 2 YEARS BEFORE' CAN ADJUST TO PERMANENT RESIDENCE BY PAYING A SUPPLEMENTAL FEE OF USD 5,000**

WASHINGTON (TIP): Millions of people stuck for years in the employment-based Green Card backlog in the US, including a sizable number of Indians, can hope for a lawful permanent residency in America by paying a supplemental fee if a new House bill is passed into law. The move, if included in the reconciliation package and passed into law, is expected to help thousands of Indian IT professionals who are currently stuck in an agonizing Green Card backlog.

A Green Card, known officially as a Permanent Resident Card, is a document issued to immigrants as evidence that the bearer has been granted the privilege of residing permanently in the US.

According to the committee print released by the US House of Representatives Judiciary Committee, which has jurisdiction over immigration, an employment-based immigrant applicant with a "priority date that is more than 2 years before" can adjust to permanent residence without

numerical limits by paying a "supplemental fee of USD 5,000."

The fee is USD 50,000 for the EB-5 category (immigrant investors). The provisions expire in 2031, the Forbes magazine reported.

For a family-based immigrant who is sponsored by a US citizen and with a "priority date that is more than 2 years before", the fee for getting a Green Card would be USD 2,500.

The supplement fee would be USD 1,500 if an applicant's priority date is not within two years but they are required to be present in the country, according to the committee print. This fee would be in addition to any administrative processing fee paid by the applicant.

However, the bill does not contain permanent structural changes to the legal immigration system, including eliminating country caps for green cards or increasing the annual quotas of H-1B visas. Before becoming law, the provisions would have to pass the Judiciary Committee, the House of

Representatives and the Senate and be signed by the president, the report said.

According to a report in CBS News, if successful, the legalization plan would allow undocumented immigrants who came to the US as children, Temporary Protected Status (TPS) beneficiaries, farmworkers and other pandemic-era essential workers to apply for permanent US residency, or green cards.

Reacting to the bill, David J Bier, Immigration policy analyst at Cato Institute, said, "employment-based applicants can adjust if they have waited 2 years from their priority date... this is almost like abolishing the EB caps for adjustment applicants who can pay \$5K. Awesome!"

"For EB5, it's \$50K fee. Even those who can't afford the fees or who are abroad would benefit from freeing up this cap space for others. It's unfair that the bill maintains the country caps as is, so Indians and Chinese will be the only EB applicants required to pay the \$5K/50K," he said in a series of tweets.

He said that the base caps for diversity, family, and #H1B all remain the same.

"Since H1B is the feeder for most EB, that's basically like keeping the EB cap the same. No reforms to #H2A, #H2B, or other work programs, so nothing to help unskilled workers/address the border," he said. "Basically, this bill will help a few legal immigrants abroad indirectly, but the main purpose is integration of existing immigrants. That's a noble cause, but the immigration/migration part of immigration reform is just left out. No new pathways for workers, same system," he tweeted.

## North American Punjabi Association's Executive Director says that Sikhs are victims of hate crimes post 9/11


MILPITAS, CA (TIP): Sikhs are still victims of hate crimes post 9/11 in the US. Satnam Singh Chahal, executive director, North American Punjabi Association (NAPA), said, "Some hate crimes are in the record of the Federal Bureau of Investigation (FBI), but others go unnoticed as victims choose not to register their case in order to avoid harassment."

Chahal said this has been happening due to the identity crisis. He said community leaders were so busy with infighting that they had no time to think about it.

He said, "In my day-to-day life, I have also become a victim of hate crime, but I always prefer not to register with the law enforcement agencies hoping that change will happen. Parents of school going kids are also sailing in the same boat." He said members of the Sikh community were living under fear and feeling insecure.

Chahal said Simratpal Singh, who belonged to Tarn Taran, died in custody of the US Immigration and Customs Enforcement (ICE) at La Paz County Jail on May 3, 2019, but no Sikh organization other than the NAPA followed up this case.

He urged the Sikh organizations in the US and managing committees of all Gurdwaras to start result oriented campaign to spread the ideology of Sikh Gurus.

## Indian-origin, Sole earner shot in US, kin in dire straits in Punjab

HOUSTON (TIP): Six years ago, Simarjit Singh sold off his 7 kanals to send elder son, Gurjit Pal Singh, to the US. On Monday, September 6, Gurjit (22) was shot by a man here over a game in a casino where he worked.

Resident of Bassi Jaid village near Begowal in Kapurthala, the family is in dire straits as they have lost their only earning member, on whom they had pinned their hopes of a happy future.

Jasraj Singh, Gurjit's 16-year-old brother, who studies in Class XI, says: "The store owner called us to tell my brother had been shot. My aunt's daughter who is also in the US also reached there. We are devastated."

Jasraj's mother hasn't stopped crying since. It was Gurjit's sixth year in the US. He was working at a multi-utility store in Houston, Texas, which had a gas station and a casino within.

Gurjit's father Simarjit works as a milkman to make both ends meet. The family relied heavily on Gurjit's earnings.

"We had sent him after selling off land. He was repaying the debt. Our only earning member is gone. Father sells milk for a living but it merely keeps us afloat," says Jasraj. Their sister is married in Canada.

Speaking about the incident, Jasraj adds: "A man came to the casino around 7.30 pm and returned again at 10.30 pm. He shot my brother in a fit of rage after being told the casino timings were over. He was apparently under the influence of drugs." "We don't believe it's a hate crime," he adds.

## Govt reinstates National Company Law Appellate Tribunal acting chief

The Centre on Thursday, Sept 16, told the Supreme Court that former acting chairperson of the National Company Law Appellate Tribunal (NCLAT) Justice AIS Cheema will be reinstated and allowed to continue in office till September 20. The newly appointed NCLAT chairperson Justice M Venugopal will be asked to go on leave until then, Attorney General KK Venugopal told a Bench led by CJI NV Ramana.

As the controversy over Justice Cheema's premature retirement as acting chairman of the NCLAT got blown over, the CJI thanked the Attorney General for solving the problem. The Bench, however, made it clear that "the instant order has been passed taking into consideration the peculiar facts and circumstances of the present facts and this shall not be treated as a precedent." Justice Cheema had moved the top court against the government's decision to curtail his tenure. He had demanded that at least he should be allowed to work up to September 20 as the officiating chairperson of the NCLAT to enable him to pronounce the judgments prepared by him.

## 214% rise in cases relating to fake news, rumours

INCIDENTS OF circulation of "false/fake news" and rumours, a crime under the Indian Penal Code, saw nearly a three-fold rise in 2020 over 2019, according to the latest National Crime Records Bureau (NCRB) data.

A total of 1,527 cases of fake news were recorded in the pandemic year — a 214 per cent increase — against 486 cases in 2019 and 280 cases in 2018, when the category was first included.

Telangana with 273 cases tops the list of states followed by Tamil Nadu (188) and Uttar Pradesh (166). Hyderabad tops the list of cities with 208 cases, followed by Chennai (42) and Delhi (30).

While addressing fake news has been crucial in containing the spread of the virus, several states labelled those raising an alarm over shortage of beds and oxygen as spreading fake news.

In April, UP Chief Minister Yogi Adityanath said that the stringent National Security Act will be invoked against social media posts on shortage of oxygen. In April 2020, a local BJP leader was booked under sedition after he allegedly posted on Facebook urging people to make donations as there were "no ventilators" in Ludhiana to treat Covid patients.

# 'Sandy desert' is shifting from Western Rajasthan to Eastern region up to NCR: Scientists warn

**JAIPUR (TIP):** Environmental Scientists at Central University of Rajasthan (CUR) have warned that 'Sandy Complex' (sand dunes in desert) formation is changing its pattern and shifting from Western Rajasthan to Eastern Region in due course of decades due to the climate change, urbanization, and depletion of green wall along Aravalli range.

The most threat of shifting of sand dunes is from Palanpur (Gujarat) to NCR (National Capital Region) via western Rajasthan due to degradation of Aravalli hills and illegal mining activities, and that is the most threat to human habitat in eastern region including Jaipur, a research paper of CUR scientists appeared in the 'Journal of Arid Environments' (Elsevier) recently cautioned.

In a project under the United Nations Convention to Combating Desertification, the last decade (2008-2018) has caused more harm and destruction to desert ecology and natural green wall over Aravalli spread from Gujarat to Rajasthan, Dr Laxmi Kant Sharma, senior scientist of Environmental Science at CUR who led the research, told TIP while discussing his research paper.

"It was researched out through scientific parameters that sandy complex has changed its formation pattern from Jodhpur divisions covering

Jaisalmer, Barmer and parts of Bikaner district and heading towards Jaipur, and NCR. However, if green wall on Aravalli hills is not protected in near future, the pattern would move further towards other regions", Dr Sharma said.

"Air pollution in NCR (Delhi) is mostly due to suspended particles (sand) and it is occurring due to rise in sand and windstorms in the arid regions of Rajasthan in the last 10 years. The eco-

sensitive location of the Thar desert needs attention to prevent its vulnerability, otherwise, sandstorms like 'gubar' will be seen in NCR", Dr Sharma maintained in his claim.

An integrated plan and approach are the need of the hour by the respective Development Authority from Central government to the state government to protect the Aravalli range's green wall by monitoring extensive plantation, curbing mining, developing

human resources, irrigation and conventional source of energy for humankind, he suggested in his joint paper.

The Thar Desert is one of the most populous deserts on the globe. It's spread over a 31.7-million-hectare area in which 75% (Covered: Jodhpur, Barmer, Bikaner, and Jaisalmer) of the area is in India and the rest in Pakistan, according to the research paper.

Dr Sharma and his two young scientists Alok Raj and Kritika Somawat have explained and warned about the Thar desert's and its eco-sensitive regions' recent 50-year status under the UNCCD framework using the MEDALUS approach based on geospatial techniques.

It used LANDSAT data for vegetation & LULC; socio-economic (literacy rate, population growth rate), climatic (rainfall, temperature, windspeed and aridity index), and analyzed to evaluate eco-sensitivity of the region. Most of the area was under the susceptible category, which covers 38.14 percent of the total area, followed by critical sensitive, moderately sensitive and less critical and least critical areas.

## Jaishankar meets Chinese counterpart in Dushanbe, discuss LAC

**DUSHANBE, TAJIKISTAN (TIP):** External Affairs Minister S Jaishankar has met with his Chinese counterpart Wang Yi on the sidelines of the Shanghai Cooperation Organisation (SCO) Summit in Dushanbe. The two leaders discussed the disengagement in the border areas.

"Discussed disengagement in our border areas. Underlined that progress in this regard is essential for restoration of peace and tranquillity, which is the basis for the development of bilateral ties," Jaishankar

tweeted. The two leaders discussed the border tensions and disengagement along the Line of Actual Control (LAC) in border areas. They also exchanged views on global developments.

Jaishankar emphasised that India doesn't subscribe to any clash of civilisations theory. It's also essential that China doesn't view its relations with India through the lens of a 3rd country."

"During his meeting with Chinese FM, EAM S Jaishankar underlined that it was

necessary to ensure progress in the resolution of remaining issues so as to restore peace and tranquillity along the LAC in Eastern Ladakh," the Ministry of External Affairs (MEA) said in a statement. During their meeting, EAM S Jaishankar and his Chinese counterpart Wang Yi agreed that "military and diplomatic officials of both sides should meet again and continue their discussions to resolve the remaining issues (along the LAC in Eastern Ladakh) at the earliest, it added.

## Gujarat's cabinet has 24 new faces as CM Patel drops all Rupani ministers

Three days after he became the chief minister of Gujarat, Bhupendra Patel inducted 24 ministers in his cabinet on Thursday, Sept 16. Patel did not retain any of his predecessor Vijay Rupani's ministers. The only old guard is assembly Speaker Rajendra Trivedi who resigned from that post earlier in the day. Trivedi is likely to get a key portfolio. Governor Acharya Devvrat administered the oath to 10 cabinet ministers and 14 ministers of state, including five ministers of state with independent charge. CM Patel was present at the Raj Bhavan ceremony, along with Rupani, whose sudden resignation from the post past Saturday led to the formation of the new ministry.

## Uttarakhand HC lifts stay on Char Dham yatra

The Uttarakhand high court on Thursday lifted its June 28 stay on the Char Dham yatra and directed the state government to conduct the annual pilgrimage with strict adherence to Covid-19 guidelines. The yatra will be open to all. Allowing the resumption of the yatra, a division bench of the court comprising chief justice RS Chauhan and justice Alok Kumar Verma limited the daily number of devotees to the temples, and said they would have to carry negative Covid test reports and vaccination certificates. Putting a cap on the number of devotees visiting the Himalayan shrines, the high court said that only 800 pilgrims for Kedarnath, 1,000 for Badrinath, 600 for Gangotri and 400 for Yamunotri will be allowed per day.

# Three in 5 Indian adults covered with first Covid dose, 20% with both

**NEW DELHI (TIP):** Three in five Indian adults have been covered with at least one Covid vaccine dose and 20 per cent have received both the doses.

New government data show Chandigarh entering the coveted league of states and UTs to have protected their adult population with the first Covid dose.

Health Secretary Rajesh Bhushan today said 62 per cent people aged 18 and above had received the Covid shots, and 20 per cent have received both the doses as the pace of vaccination increases.

As of September 16, 57.86 crore first doses of Covid 19 vaccine have been administered while 18.70 crore people have received both doses.

"Chandigarh is the new addition to the states and UTs where all adults have received at least one dose," Bhushan said.

Commenting on the scale of inoculation the government said that in the first 11 days of September over 11 crore doses have been administered which is double of the doses given through the entire month of May.

The government also said of the 3,651 Pressure Swing Absorption Plants for medical oxygen generation which have been sanctioned, 1,595 have been commissioned so far.

This comes to 43.6 pc — less than half the sanctioned plants.

The government said of the total 3,651 PSA plants sanctioned with 4,751 MT capacity generation when commissioned, 1,491 plants with 2,281 MT have been commissioned with central support and 2,140 with 2,289 MT capacity with the states and other sources (states, urban local bodies,



MPLAD, CSR etc) support.

"Of the 1,595 PSA plants commissioned so far with 2,088 MT medical oxygen generation, 731 (with 1024 MT) PSA plants commissioned are with central resources and 862 plants (1,065 MT capacity) with state and other resources.

The government today asked states to prepare ahead for any potential COVID surge noting that right now the situation is stable with cases reducing even in Kerala but the months of October and November would be critical given the festive season.

"The next quarter will be critical. We advise states and municipal corporations to prepare ahead to ensure

best models of home care and also to prepare infrastructure," Member Health NITI Aayog VK Paul said.

ICMR chief Balram Bhargava suggested four measures to control Covid — rapid vaccination, Covid appropriate behaviour, responsible travel if necessary and responsible festivities.

India saw 30,570 new cases in the last 24 hours, 68 pc of them from Kerala.

As of today 34 districts have over 10 pc positivity and 32 have a positivity rate between 5 to 10 pc.

Overall national positivity rate has been below 3 pc for eleven weeks but 64 districts of concern remain an issue.

## 'Govt May Rob the Media of Its Independence': Madras HC Stays Sub-Clauses of IT Rules

**CHENNAI (TIP):** The Centre's new Information Technology (IT) Rules could rob the media of its independence and the fourth pillar of the democracy may cease to exist, judges of the Madras high court said as they ordered on Thursday, Sept 16, a stay on parts of the government's new regulations, and restrained it from taking action against social media companies for now.

The IT Rules, notified in February, contain a host of new directions and liabilities for social media companies (also known as intermediaries), news websites and streaming content providers (also known as OTT services) such as Netflix and Amazon Prime.

The Madras high court became the third appellate court in the country to stall operations of rules pertaining to the last two — particularly two clauses contained under Rule 9 — subclauses 1 and 3. It also said action under Rule 3 and Rule 7, which deals with social media companies and their safe harbour status, cannot be taken until it decides on the petitions.

The court was hearing two petitions — one filed by Carnatic music vocalist TM Krishna and another by a set of 13 news websites as part of the Digital News Publishers Association (DNPA).

"Prima facie, there is substance to the petitioner's grievance that the oversight mechanism to control the media by (the) government may rob the media of its independence, and the fourth pillar, so to say, of democracy may not at all be there," the court of first bench of chief justice Sanjib Banerjee and justice PD Audikesavalu said, while staying the sub rules.

Sub rule 1 requires digital publishers to adhere to a code of ethics while sub rule 3 provides for a three-tier regulatory mechanism that is ultimately headed by the government.

On July 9, the Kerala high court said the new rules appear to give "excessive powers" to "unreasonably and impermissibly" restrict the freedom of speech and expression of the media, and on August 15, a Bombay

high court bench said these particular provisions were an intrusion into the rights to free speech and beyond the scope of the main law under which the rules have been framed, the Information Technology Act, 2000.

While the operation of these sections virtually amounted to have been put into suspension with the second order — the one by the Bombay high court on August 15 — the new order now covers more ground as it restrains the Centre from taking action by invoking either Rule 3 or Rule 7.


Rule 3 relates to the due diligence that social media intermediaries will need to carry out by ensuring certain types of content, such as those that are defamatory or false, do not stay on their platforms, while Rule 7 lays down the government's power to remove what is known as safe harbour provisions. Safe harbour provisions essentially mean social media companies will not be liable for what users post on their platform.

## PAKISTAN TERRORIST GETS 7 YRS OF RIGOROUS IMPRISONMENT FOR CONSPIRING TO CARRY OUT ATTACKS IN INDIA

**ISLAMABAD (TIP):** A special NIA court here on September 17 sentenced a Lashkar-e-Taiba militant from Pakistan to seven years of rigorous imprisonment for conspiring to carry out terror attacks at different locations in India on the directions of his handlers from across the border.

Mohammad Amir of Karachi was sentenced under the Unlawful Activities (Prevention) Act, the Arms Act, the Explosive Substances Act, the Foreigners Act, the Indian Wireless Telegraphy Act and relevant sections of the Indian Penal Code, an official of the premier investigating agency said.

Amir along with three others had infiltrated into India from Pakistan with weapons, ammunition and other war-like stores with an intention to carry out terror attacks at different locations of India on the directions of their handlers based across the border, the NIA official said.

He was arrested in November 2017 from Magam in Jammu and Kashmir's Handwara, while his three associates were killed in an encounter with security forces the same month, the official said. The NIA filed a charge sheet against Amir in May 2018.

After consideration of evidence brought on record during the probe by the National Investigation Agency, the NIA special court, Patiala House, convicted Amir on April 6.

Pronouncing the quantum of punishment on Friday, Amir was awarded sentences for seven different offences each ranging from two to seven years of rigorous imprisonment and fine, the NIA official added. — PTI

## PAKISTAN COURT ISSUES ARREST WARRANTS OF 'HINDI MEDIUM' STAR SABA QAMAR

**LAHORE (TIP):** A local court in Pakistan on Wednesday issued arrest warrants of 'Hindi Medium' star Saba Qamar in a case registered against her and others for shooting a 'dance video' at a historical mosque in Lahore.

Lahore's magisterial court issued the bailable warrants for Qamar and singer Bilal Saeed for constantly avoiding the court hearings. The court adjourned the hearing till October 6.

Lahore police last year registered a case against Qamar and Saeed under section 295 of the Pakistan Penal Code for alleged 'desecration' of Masjid Wazir Khan in the old city of Lahore.

According to the FIR, both actors had trampled upon the sanctity of the mosque by shooting a dance video and this act also sparked an outrage among the people of Pakistan. The Punjab government had also sacked two senior officers in connection with violation of the mosque's sanctity. PTI

# Afghan Deputy PM Mullah Baradar releases video after death rumours

**KABUL (TIP):** Under intense pressure and questions over his whereabouts, the Taliban's Deputy Prime Minister of Afghanistan Mullah Abdul Ghani Baradar has now released a video message.

"There had been news in the media about my health and death. Over the past few nights, I have been away on trips. Wherever I am at the moment, we are all fine, all my brothers and friends," Baradar said in the clip, ARY News reported.

"The media always publish fake propaganda. Therefore, bravely reject all those lies, and I'm 100 per cent confirm to you there is no issue in the ranks of the Taliban and we have no problem." On the recent visit of Qatari Foreign Minister where he was absent, Baradar said he was unable to meet the visiting Qatari visiting dignitary as he was on a trip.

"Got information of the Qatari Foreign Minister visit to Afghanistan suddenly," he added, the report said.

Speculation intensified about the fate of Baradar when Taliban leaders met with senior delegates from Qatar in Kabul on Sunday, with him conspicuously absent from the meeting, Daily Mail reported earlier.

On September 13, Taliban was forced to deny that Baradar was dead after rumours emerged that he was killed during a gunfight with his political rivals.

The Taliban insisted that Baradar is in Kandahar province meeting with the



group's supreme leader Mawlawi Hibatullah Akhundzada to discuss the country's future now the US has withdrawn.

But the social media rumour mill believes he was actually killed in a gun battle in Kabul's presidential palace that broke out during a meeting with the powerful and ruthless Haqqani family, the report said.

Three members of the Haqqani family were at the summit with Qatar delegates along with other members of the new Afghan government—led by Prime Minister Mohammad Hasan Akhund, the report said.

A major row broke out between leaders of the Taliban over the make-up of the group's new government in Afghanistan

last week, the BBC reported.

The argument between Baradar and a cabinet member happened at the presidential palace, the report said.

There have been unconfirmed reports of disagreements within the Taliban's leadership since Baradar disappeared from public view in recent days.

One Taliban source told BBC Pashto that Baradar and Khalil ur-Rahman Haqqani, the minister for refugees and a prominent figure within the militant Haqqani network, had exchanged strong words, as their followers brawled with each other nearby.

The Taliban sources told the BBC that Baradar had left Kabul and travelled to the city of Kandahar following the row.

## Sri Lankan prisons minister resigns after threatening to kill Tamil prisoners

**COLOMBO (TIP):** Sri Lankan prisons minister Lohan Ratwatte resigned on September 15 after an uproar over his alleged remarks to kill Tamil prisoners during his recent visit to a jail in the island nation's north-central region.


Ratwatte, the Minister of State for Prisons Management, tendered his resignation after outrage from the Tamil political parties, which sought his exit from the Cabinet and arrest over the remarks.

President Gotabaya Rajapaksa has accepted Ratwatte's resignation, presidential spokesman Kingsley Ratnayake said.

Ratwatte went to the Anuradhapura prison in the country's northern central region on September 12 and allegedly forced two prisoners to kneel and threatened to kill them, according to reports.

His act prompted the Tamil parties to condemn his behaviour and call for his resignation.

"We call on the government to immediately remove the state minister for prison management and have him



arrested and charged after an immediate inquiry for allegedly threatening to kill prisoners in Anuradhapura on Sunday, September 12," the Tamil National Alliance (TNA) tweeted.

Galen Ponnambalam, the leader of the Tamil National People's Front, also tweeted and confirmed the incident.

"The TNPF can confirm that on the evening of September, 12 the state minister for prisons had gone to the Anuradhapura prisons, summoned the Tamil political prisoners and had got two of them to kneel in front of him," he said

in a tweet.

Ponnambalam said the minister had threatened to kill Tamil prisoners.

The local media reports alleged that the minister had visited the main prison in Colombo to show the gallows to a group of his friends late at night before heading to the north-central town of Anuradhapura.

He was carrying his personal weapon into the prison, which the prison officials said was an illegal act.

The minister's office has denied any such incident involving him.


The incident and act of the minister has also been condemned by the United Nations.

The UN Resident Coordinator in Sri Lanka, Hanaa Singer-Hamdy, said that it is the duty of the State to protect the rights of prisoners, the Colombo Gazette reported.

"In our work on prison reform and drug rehabilitation, UN Sri Lanka works to strengthen capacities to uphold the rights of all those in custody and condemns any ill treatment of prisoners," Hanaa Singer-Hamdy tweeted on Wednesday. — PTI

# Celebrating Constitution Day

**CONSTITUTION DAY AND CITIZENSHIP DAY IS OBSERVED EACH YEAR ON SEPTEMBER 17 TO COMMEMORATE THE SIGNING OF THE CONSTITUTION ON SEPTEMBER 17, 1787, AND "RECOGNIZE ALL WHO, BY COMING OF AGE OR BY NATURALIZATION, HAVE BECOME CITIZENS."**

Citizens of the United States have celebrated Independence Day and Presidents' Day since the 1870s, and in 2005, the nation began to celebrate Constitution Day. Also known as Citizenship Day, Constitution Day is an American holiday honoring the day 39 delegates to the Constitutional Convention signed the United States Constitution. This historic date was September 17, 1787.

### "I Am an American Day"

In 1939, the New York City news tycoon William Randolph Hearst suggested the creation of a holiday to celebrate American citizenship. Not only did Hearst have a wide readership of his many daily

newspapers, but he had significant political connections, and in 1940, Congress designated the third Sunday in May as "I am an American Day." President Harry Truman presented the resolution, setting aside this date in honor of the American people, especially those who had recently become citizens of the United States.

The holiday quickly gained support and popularity through the efforts of the United States Immigration and Naturalization Service. Additionally, in 1944, Hearst sponsored a 16-minute film titled 'I Am an American', which was featured in American theaters, and subsequently became a top news story. It was an immediate hit. Within 5 years, the governors of the existing forty-eight states had issued state proclamations in agreement with the national holiday.

One of the most significant individuals in the development of the holiday was a Louisville, Ohio resident named Olga T. Weber. In 1952, she petitioned the leaders of the municipality to change the date of the holiday to correspond with the anniversary of the signing of the United States Constitution. Once they agreed to it, she didn't stop there, and took her requests to the State, who also approved. In 1953, Olga went to United States Congress, and both the Senate and the House of Representatives approved her requests. The original resolution was overturned and a new law took its place. After Dwight D. Eisenhower signed it, the "I am an American Day" observation became "Citizenship Day" and moved to September 17.

Louisville, Ohio was the first city in the United States to celebrate Citizenship Day on September 17, 1952.

### Louise Leigh and Constitution Day

Another important figure in the creation of Constitution Day is Louise Leigh. Leigh, after taking a course in Constitutional History with the National Center for Constitutional Studies, was inspired to spread her newfound love of the Constitution throughout the country. In 1997, she founded a nonprofit organization called Constitution Day, Inc. to help encourage recognition of the importance of this national holiday.

Through her efforts, Constitution Day became an official holiday alongside Citizenship Day in 2004 when, with the help of support from Senator Robert Byrd, the "Constitution Day" amendment to the Omnibus Spending Bill passed. In May 2005, the United States Department of Education backed the law when it announced that it would apply to any school receiving federal funds of any kind.

The two allowances of the law were that the head of every federal agency provide each employee with educational materials concerning the Constitution on 17th of September and that each educational institution which receives Federal funds should hold a program for students every Constitution Day.

Constitution Day, along with Independence Day and Presidents' Day, is an important part of the cultural heritage of the United States of America, because it recognizes the value of the American experiment, and the success of a nation of free people whose rights and liberties are protected by a written Constitution.



## OZONE HOLE OVER ANTARCTICA LARGER THAN USUAL, SCIENTISTS SAY

**BERLIN (TIP):** Scientists say the hole in the Earth's protective ozone layer over the Southern Hemisphere is larger than usual this year and already surpasses the size of Antarctica.

The European Union's Copernicus Atmosphere Monitoring Service said Thursday that the so-called ozone hole, which appears every year during the Southern Hemisphere spring, has grown considerably in the past week following an average start.

"Forecasts show that this year's hole has evolved into a rather larger than usual one," said Vincent-Henri Peuch, who heads the EU's satellite monitoring service.

"We are looking at a quite big and potentially also deep ozone hole," he said. Atmospheric ozone absorbs ultraviolet light coming from the sun. Its absence means more of this high-energy radiation reaches the Earth, where it can harm living cells.

Peuch noted that last year's ozone hole also started out unremarkably but then turned into one of the longest-lasting ones on record.

The Montreal Protocol, signed in 1987, led to a ban on a group of chemicals called halocarbons that were blamed for exacerbating the annual ozone hole. AP

# Prince Philip's Will to be secret for 90 years: Court

**LONDON (TIP):** The will of Prince Philip, the late husband of Britain's Queen Elizabeth, will be sealed and remain private for at least 90 years to preserve the monarch's dignity, a judge at London's High Court has ruled.

Philip, the Duke of Edinburgh, who had been married to the 95-year-old British monarch for more than seven decades, died at the age of 99 at his wife's Windsor Castle home to the west of London on April 9.

In keeping with a convention dating back to 1910, Andrew McFarlane, the president of the court's Family Division, said he had agreed Philip's will should be sealed up "and that no copy of the will should be made for the record or kept on the court file".

He also ruled in favour of the request "to exclude the value of the estate from the grant of probate".

"The degree of publicity that publication would be likely to attract would be very extensive and wholly contrary to the aim of maintaining the dignity of the Sovereign," McFarlane said in a ruling published on Thursday.

He said the convention was that



following the death of a senior royal, an application to seal the will was made to the Family Division president, with such hearings and judgments kept private.

However, he said "as is plain from this judgment" he considered it was a "necessary and proportionate intrusion into the private affairs of Her Majesty and the Royal Family to make public the fact that an application to seal the will of HRH The Prince Philip ... has been made and granted in private, and to explain the underlying reasons".

The judge said 90 years should pass from the granting of probate before the

will should be unsealed in private before possible publication, a period he said was "proportionate and sufficient".

He said the first royal whose will was sealed was Prince Francis of Teck, who was the younger brother of George V's wife Queen Mary. He said he was the custodian of a safe containing more than 30 envelopes with the wills of dead royals.

The most recent additions were made in 2002 following the deaths of Queen Elizabeth's mother, Elizabeth, and her sister Princess Margaret, he said. Reuters

## Indian-Origin CEO's Green Submarine Project Wins UK's Clean Maritime Demonstration Competition

**LONDON (TIP):** A green hydrogen-powered under-water transportation submarine system being developed by a company led by an Indian-origin CEO was on Wednesday, September 15, named among the winners of the UK government's Clean Maritime Demonstration Competition.

Dhruv Boruah's Oceanways won backing from the GBP 23-million government-funded research and development (R&D) drive with its concept of a fully automated net positive submarine fleet, powered entirely on green hydrogen, could help cleanse the oceans of toxic pollution by collecting micro plastics on its pilot route between Glasgow in Scotland and Belfast in Northern Ireland.

While transporting cargo shipments, the fleet could secure significant emission savings of 27 tons of carbon dioxide or CO<sub>2</sub> emissions in the first year of operation, with an overall mission to reduce 300 million tons of CO<sub>2</sub> as the fleet grows.

"We would like to thank our Transport Secretary Grant Shapps MP for selecting Oceanways to support the Department for Transport's mission to decarbonize shipping and aid our Prime Minister's commitment to build back better," said Mr Boruah, Founder and CEO of Oceanways.

"Time is running out and it is imperative we don't settle for 1 per cent more efficiency in an existing system,

but instead, radically rethink to create innovative solutions," he said.

The entrepreneur is confident that the autonomous, or driverless, system may well be in a position to transport humans in the future, following its successful use to transport products.

"It's not just JetZero. Oceanways has assembled a world-class team to pioneer SubZero by creating the new market of net positive underwater transport systems with zero-emission cargo submarines as an innovative tool to decarbonize shipping and clean up our ocean," he said. The green submarines are expected to be in use across British waters by 2026 and help address freight traffic challenges, including shortage of drivers. Oceanways says it will be servicing short point to point routes with fast, zero emission delivery. It claims the submarines are superior to a cargo ship in almost every way: "not

only they are weather independent, can reach hard to reach areas and a lot cheaper to build and operate, but it's also quieter, secure, more stable, and cleaner, with zero fumes or pollutants".

"As a proud island nation built on our maritime prowess, it is only right that we lead by example when it comes to decarbonizing the sector and building back greener," said Grant Shapps, the minister who unveiled the prize-winners during the ongoing London Shipping Week in Greenwich.

"The projects announced today showcase the best of British innovation, revolutionizing existing technology and infrastructure to slash emissions, create jobs and get us another step closer to our decarbonization targets," he said.

The government's Clean Maritime Demonstration Competition is supporting the development of innovative technology to propel Prime

Minister Boris Johnson's commitment to have zero emission ships operating commercially by 2025.

Also among the winners is an all-electric charge-point connected to an offshore wind turbine. The charge-points will be able to powerboats using 100 per cent renewable energy generated from the turbine.

This offers potential savings of up to 131,100 tons of carbon dioxide equivalent (CO<sub>2</sub>e) emissions a year - the equivalent of removing over 62,000 cars from our roads. Similar to roadside electric vehicle charge points, these will be operated by semi-automated control, meaning that sailors can moor up by the wind turbine charge point, plug in, charge up, then sail on.

"Through increased investment and closer collaboration with government our industry can rise to the challenge of steering the UK's vessels in a green direction," said Maritime UK chair Sarah Kenny.

"We still have a very long way to go, but today marks an important step towards our journey to net zero," she said. It comes as UK Maritime Minister Robert Courts backed the opening of the UK's so-called greenest cruise terminal. The Horizon Cruise Terminal at the Port of Southampton, southern England, is the first of its kind, using an innovative mix of solar panel roofing and clean energy shore power plug-in charging for ships.

# Another Australian state legalises voluntary euthanasia

**BRISBANE (TIP):** Voluntary euthanasia became legal in a fifth Australian state on September 16, more than 20 years after the country repealed the world's first mercy killing law for the terminally ill.

Queensland's Parliament passed the law with 61 of the state's 93 lawmakers voting in favor.

New South Wales, the nation's most populous state, is now the only state that doesn't allow assisted suicide.

The Northern Territory and Australian Capital Territory do not have the same rights as states and the Federal Parliament has barred them from making such laws.

Queensland's law, which takes effect in January 2023, allows people suffering from a disease or medical condition that is advanced, progressive and terminal to have access to so-called voluntary assisted dying.

Their condition must be expected to cause death within a year, they must have decision-making capacity, and proceed without coercion.

Deputy Premier Steven Miles said the law would ease pain and suffering.

"It has been a very considered debate and ... it's been a very difficult debate," Miles told Parliament.

Opponents argued that due to a funding shortfall for palliative care, the law would put pressure on some patients to end their lives.



"Will this government provide a guarantee that people will get access to quality integrated palliative care services wherever they live in Queensland, when they have a terminal diagnosis, and not just in the last few months of life?" opposition lawmaker Fiona Simpson said.

But Miles said palliative care and voluntary assisted dying are complementary policies which give more options to terminally ill people.

The sparsely populated Northern Territory in 1995 became the first

jurisdiction in the world to legalize doctor-assisted suicide for terminally ill patients. But the Australian Parliament overturned that law in 1997 after four people had been helped to die.

The Federal Parliament does not have the same power over the six states, and Victoria became the first to legalise assisted suicide in June 2019.

New South Wales' Parliament rejected a doctor-assisted suicide bill by a single vote two weeks before the Victorian law was passed. AP



## NEW ZEALAND SAYS AUSTRALIA'S NEW NUCLEAR SUBMARINES MUST STAY OUT OF ITS WATERS

**WELLINGTON (TIP):** New Zealand Prime Minister Jacinda Ardern said on September 16 that Australia's new nuclear-powered submarines would not be allowed in its territorial waters under a long-standing nuclear-free policy.

A new Indo-Pacific security partnership announced by US President Joe Biden, British Prime Minister Boris Johnson and Australian Prime Minister Scott Morrison, will see the United States and Britain provide Australia with the technology and capability to deploy nuclear-powered submarines.

The Indo-Pacific deal is widely seen as a counter to China's growing influence in the region.

"I discussed the arrangement with Prime Minister Morrison last night," Ardern said at a news conference.

"I am pleased to see that the eye has been turned to our region from partners we work closely with. It's a contested region and there is a role that others can play in taking an interest in our region. But the lens we will look at this from will include stability," she said.

However, Ardern said the nuclear-powered submarines would not be allowed in New Zealand waters under a 1984 nuclear-free zone policy.

"Certainly they couldn't come into our internal waters.

"No vessels that are partially or fully powered by nuclear energy are able to enter our internal borders," she said.

Ardern said the new Indo-Pacific grouping does not change the security and intelligence ties of New Zealand, which is a member of the Five Eyes, a post-war intelligence grouping that also includes the United States, Britain, Australia and Canada.

"This is not a treaty level arrangement. It does not change our existing relationship including Five Eyes or our close partnership with Australia on defence matters," she said.

Ardern, who is in her second term in office, has looked to focus on a more independent foreign policy that is not loyal to any major bloc.

Foreign Minister Nanaia Mahuta has said she was uncomfortable with expanding the role of the Five Eyes, drawing criticism from Western allies

# British woman files appeal against Cyprus 'fake rape' conviction

**NICOSIA (TIP):** A British woman convicted for falsely claiming gang rape in Cyprus has filed an appeal to the island's Supreme Court, seeking to clear her name.

The woman received a suspended four-month prison sentence in January 2020 in a case which sparked concern from Britain and activists about her treatment by Cyprus authorities.

Lawyers for the defendant, who cannot be named for legal reasons, and prosecutors presented their arguments before a three-bench Supreme Court in the capital Nicosia on September 17.

The court is expected to issue a ruling within six months.

The woman, then aged 19, filed a complaint in July 2019 that she had been raped by a group of Israeli youths in the holiday resort of Ayia Napa. Days later the complaint was withdrawn, leading to her arrest and subsequent conviction for public mischief.

She maintains she withdrew her complaint under duress after hours of police questioning and without a lawyer present.

"The case is a seminal one for the



protection of human rights in Cyprus, as well as the treatment of those who report sexual offences," said Michael Polack, director of the UK-based Justice Abroad advocacy group assisting a local defence team.

Twelve Israeli youths were detained for questioning but swiftly released after the woman withdrew her accusation.

They were not required to give any

evidence at the woman's trial because the case focussed on whether the woman had misled authorities and given a false statement, rather than the alleged rape itself.

The British government later said it had "numerous concerns" about the judicial process and the woman's right to a fair trial. The woman was not present at Thursday's process. — Reuters

It is also an antioxidant that counteracts the effects of pollutants in the air.

## Tea

**GREEN:** Apart from aiding in weight loss, tea also protects the skin from damage and reactivates dying skin cells.

**FOR YOUR SKIN:** EGCG (epigallocatechin gallate) in the green tea reactivates your dying skin cells. It also protects your skin from the harmful UV rays of the sun. shine."

**FOR YOUR HAIR:** This tea may also be used as a hair rinse, as the tannin in the tea helps to add lustre to your hair. Boil used tea leaves again in enough water. After boiling, cool and strain the water. Then add lemon juice to it and use this as a last rinse after shampoo. Matang says, "Green tea helps in reducing dandruff. It also stimulates hair growth and softens your hair. It contains vitamin C, vitamin E and panthenol, which are used as common ingredients in hair conditioners.

**CHAMOMILE:** Chamomile tea helps you achieve those golden streaks. Steep two chamomile tea bags in two cups of hot water for 5-10 minutes. Then add two tsps of lemon juice to the mixture. Use this as a final rinse on your hair after using a normal shampoo and conditioner. But do not rinse it out. This will help you bring the natural blonde or red tones in

your hair and slightly lighten your hair without looking drastic or fake.

**BLACK:** It helps fight free radicals that fasten the process of ageing of your skin. ## FOOD CORNER

### Doodhi Ka Halwa



#### Ingredients

- Lauki (bottle gourd) 300 gms
- Milk 500 ml
- Sugar 20 gms
- Khoya 5 gms
- Kishmish 2 gms
- Cashewnuts 2 gms
- Saffron 5 strands
- Desi ghee 5 gms
- Cardamom powder 1 gm

#### Method

- Remove the outer skin of bottle gourd (lauki) and grate it.
- Squeeze to remove excess water.
- Heat 3 grams of desi ghee in a handi.
- 4. Add the grated lauki and saute for few minutes till it starts to get translucent.
- Now add milk and stir, till the milk boils and starts reducing.
- Keep stirring as the lauki has to be mashed in the milk and the milk gets completely reduced, this might take 20-30 minutes.
- Now add sugar and stir till the sugar dissolves completely.
- Soak the saffron in luke warm water for 10 minutes and add to the halwa.
- Heat the remaining desi ghee in a small pan and once it is heated, pour over the halwa, mix moderately so that the desi ghee flavor gets infused.
- You can either fry the raisins and cashew nuts or soak them in luke warm water, once done add to the halwa.
- Finish with cardamom powder.
- Serve hot.

## What causes frequent dizziness?

Many of us are familiar with the feeling of feeling dizzy while lying down on bed and then standing up suddenly. There are also times when one experiences dizziness that disrupts their balance. Why does it happen? Dr Pawan Ojha, a senior neurologist at Hiranandani Hospital, Vashi-A Fortis network Hospital, says this could be a sign of 'vertigo'. "Dizziness might imply vertigo, fainting, poor body balance, or even fits. Vertigo is a type of dizziness where you feel like you are spinning. These feelings may last from a few seconds to days and often worsen with movement," he says. According to the doctor, vertigo is commonly caused by "disease of the vestibular system". "The vestibular system inside the inner ear helps in sensing our head position in space relative to the body, and works in an integrated manner with the brain to maintain body position. Vertigo can result from diseases of the vestibular nerve or parts of the brain that deal with body balance."

### How big of a problem is it?

The diseases related to the inner ear and its nerve supply are generally considered less worrisome. 'Benign positional vertigo' often causes the most severe vertigo but can be treated easily, the doctor says. "Another important cause of vertigo is 'vestibular neuritis' which occurs due to viral infection or autoimmune disease of the vestibular nerve, where vertigo, nausea, or vomiting can last up to several days. Meniere's Disease is caused by a build-up of fluid in the inner ear tubes, causing episodic vertigo with ringing in the ears and hearing loss. The exact cause is unclear; a viral infection, an autoimmune reaction or a genetic component could be the trigger," explains Dr Ojha. He adds that vertigo that is caused by a brain disease should be considered worrisome and treated on an urgent basis. "Stroke is an important and serious condition causing dizziness. Apart from this, brain infection, multiple sclerosis, hypothyroidism and other biochemical disturbances can cause vertigo even in the absence of fever."

### Warning signs

If it is a serious cause of vertigo, signs will include severe headache, persistent vomiting and imbalance, double vision, vision problems, sudden hearing loss, or early signs of brain stroke (weakness or numbness in arm or leg, face drooping to one side, trouble while speaking or swallowing). People who are 60+, with diabetes, hypertension, smoking and history of heart disease or brain stroke, should be extra careful, the doctor warns.

## UK health service trials new 'quick, simple' blood test to detect cancers early

Britain's National Health Service (NHS) launched the world's largest trial of a revolutionary new "quick and simple" blood test that can detect more than 50 types of cancer before symptoms appear.

The Galleri™ test, pioneered by healthcare company GRAIL, checks for the earliest signs of cancer in the blood. The NHS-Galleri trial, the first of its kind, aims to recruit 140,000 volunteers in eight areas of England to see how well the test works in the NHS.

"The Galleri test can not only detect a wide range of cancer types but can also predict where the



cancer is in the body with a high degree of accuracy," said Sir Harpal Kumar, the Indian-origin President of GRAIL Europe and one of the UK's leading cancer researchers.

"The test is particularly strong at

detecting deadly cancers and has a very low rate of false positives. We're delighted to partner with the NHS to support the NHS Long Term Plan for earlier cancer diagnosis, and we are eager to bring our technology to people in the UK as quickly as we can," he said.

The first people to take part will have blood samples taken at mobile testing clinics in retail parks and other convenient community locations. "This quick and simple blood test could mark the beginning of a revolution in cancer detection and treatment here and around the world," said Amanda Pritchard, NHS chief executive.

## Researchers create chameleon-like artificial 'skin'

South Korean researchers have claimed that they have developed an artificial skin-like material that can quickly adjust its colours like a chameleon to match its surroundings. The team created the "skin" with a special ink that changes colour based on temperature and is controlled by tiny, flexible heaters. "Combined with the active control system and sensing units, the complete device chameleon model successfully retrieves the local background colour and matches its surface colour instantaneously with natural transition characteristics to be a competent option for a next-generation artificial camouflage," the researcher said in the journal *Nature Communications*.

"If you wear woodland camouflage uniforms in the desert, you can be easily exposed. Changing colours and patterns actively in accordance with surroundings is key to the camouflage technology that we created," Ko Seung-hwan, a mechanical engineering professor at Seoul National University who led the team, told Reuters.

Ko and the team demonstrated the technology - thermochromic liquid crystal (TLC) ink and vertically stacked multilayer silver nanowire heaters - using a chameleon robot with colour-detecting sensors. The skin tried to mimic whatever colours the sensors "saw" around it.

- Plug in your device and make sure you're connected to the Internet.
- Go to Settings General, then tap Software Update.
- Tap "Install Now." If you see "Download and Install" instead, tap it to download the update, enter your passcode, then tap "Install Now."

Apple Watch

- First, make sure that your Apple Watch is compatible with the latest software: watchOS 7 is compatible with Apple Watch Series 3 and later and Apple Watch SE. Upgrading to watchOS 7 requires an iPhone 6s or later running iOS 14 or later.

Next steps:

- Update your iPhone to the latest version of iOS.
- Make sure that your Apple Watch is at least 50 percent charged.
- Connect your iPhone to Wi-Fi.
- Keep your iPhone next to your Apple Watch, so that they're in range.

It could take from several minutes to an hour for the update to complete. You might want to update overnight or wait until you have time.

## Ozone hole over Antarctica larger than usual, scientists say

**BERLIN (TIP):** Scientists say the hole in the Earth's protective ozone layer over the Southern Hemisphere is larger than usual this year and already surpasses the size of Antarctica.


The European Union's Copernicus Atmosphere Monitoring Service said Thursday that the so-called ozone hole, which appears every year during the Southern Hemisphere spring, has grown considerably in the past week following an average start.

"Forecasts show that this year's hole has evolved into a rather larger than usual one," said Vincent-Henri Peuch, who heads the EU's satellite monitoring service.

"We are looking at a quite big and potentially also deep ozone hole," he said.

Atmospheric ozone absorbs ultraviolet light coming from the sun. Its absence means more of this high-energy radiation reaches the Earth, where it can harm living cells.

Peuch noted that last year's ozone hole also started out unremarkably but then turned into one of the

longest-lasting ones on record.

The Montreal Protocol, signed in 1987, led to a ban on a group of chemicals called halocarbons that were blamed for exacerbating the annual ozone hole. Experts say that

while the ozone layer is beginning to recover, it's likely to take until the 2060s for the ozone-depleting substances used in refrigerants and spray cans to completely disappear from the atmosphere. Source: AP

**Big-bang reforms in telecom sector: 4-year loan moratorium, 100% FDI**

The Centre on September 15 approved the much-awaited relief package for the stressed telecom sector that includes a four-year moratorium on payment of dues by telecom companies and allowing 100 per cent foreign direct investment (FDI) under the automatic route.

Announcing the decisions cleared at a Union Cabinet meeting chaired by Prime Minister Narendra Modi, Information Technology and Communication Minister Ashwini Vaishnaw said, "The reforms are deep and broad... structural... will bring in change today, tomorrow and in the future. I do not like to put a number on the package as it is revenue-neutral for the government." He went on to add that the moratorium would not impact the government's revenue. Incidentally, the government announced the package six weeks after Kumar Mangalam Birla resigned from the post of chairman of Vodafone Idea Limited, which was created following the merger of British telecom giant Vodafone's India unit and Birla's Idea Cellular Ltd.

**UN pegs 7.2% growth for India in current year**

India is expected to grow at 7.2% in 2021 but economic growth could decelerate next year, according to a United Nations report which said the recovery in the country is constrained by the ongoing human and economic cost of the Covid pandemic and the negative impact of food price inflation on private consumption. The UNCTAD Trade and Development Report 2021, released here on Wednesday, sounded a cautiously optimistic note to say that the global economy is set for a strong recovery in 2021, albeit with a good deal of uncertainty clouding the details at the regional and country levels over the second half of the year.

**Sensex breaches 59,000-mark for first time**

Market benchmark Sensex scaled the 59,000-mark for the first time on Thursday, Sept 16, as investors remained in risk-on mode following the government's policy support measures for various sectors.

Advancing for the third consecutive session, the BSE index climbed 417.96 points to its new closing peak of 59,141.16. It touched an intra-day record of 59,204.29. Similarly, the broader NSE Nifty surged 110.05 points to finish at its fresh lifetime high of 17,629.50. During the session, it scaled an all-time high of 17,644.60.

**Bad bank to resolve Rs 2 lakh cr stressed loans, says finance minister**

**NEW DELHI (TIP):** Finance Minister Nirmala Sitharaman on Thursday, Sept 16, announced a Rs 30,600 crore government guarantee for National Asset Reconstruction Company Limited (NARCL) for acquiring stressed loan assets, paving the way for operationalisation of the bad bank.

The decision to provide sovereign guarantee for security receipts (SRs) issued by the NARCL was taken at a meeting of the Union Cabinet headed by Prime Minister Narendra Modi on Wednesday.

The Finance Minister in Budget 2021-22 had announced setting up of a bad bank as part of resolution of bad loans worth about Rs 2 lakh crore.

The bad bank or the NARCL will pay up to 15 per cent of the agreed value for the loans in cash and the remaining 85 per cent would be government-guaranteed security receipts. The government guarantee will be invoked if there is loss against the threshold value.

"For the SRs to hold on and to have their value intact, there is a need for government to give the backstop arrangement and that's why Rs 30,600 crore has been cleared by the Cabinet yesterday," she said. This sovereign guarantee would be for a period of 5 years and the NARCL would have to pay a fee for this. "The SRs are getting the backstop through government funding only in as much as to pay the gap between the realised value (resolution/liquidation) and face value of the SRs and this will hold good for five years," Sitharaman said.

The fee for the guarantee will be initially 0.25 per cent, which will progressively increase to 0.5 per cent in case of delay in resolution of bad loans, Financial Services Secretary Debasish Panda said.

NARCL will pay up to 15% of the agreed value for the loans in cash and the remaining 85% will be government-guaranteed security receipts



This will enable speedy disposal of stressed assets and clean up balancesheets of banks for further lending, he explained.

The Finance Minister further said public sector banks (PSBs) would hold 51 per cent stake in the NARCL and 49 per cent in the proposed debt management company — India Debt Resolution Company Ltd.

There would be 16 shareholders for NARCL, including PSBs, private sector banks and NBFCs.

The structure will assist in consolidation of debt, currently fragmented across various lenders, thus leading to faster, single point decision-

making, she said.

"It will incentivise quicker action on resolving stressed assets thereby helping in better value realisation. India Debt Resolution Company Limited (IDRCL) will engage market expertise for value enhancement. This approach will also permit freeing up of personnel in banks to focus on increasing business and credit growth," she said.

In the first phase, Panda said, banks have identified stress loans of about Rs 90,000 crore to be resolved.

The NARCL is intended to resolve stressed loan assets above Rs 500 crore each amounting to about Rs 2 lakh crore.

**Microsoft to buy back up to \$60 bln in shares**

Microsoft Corp said it will conduct an up to \$60 billion share buyback program, raise its quarterly dividend by 11%, and appoint company President Brad Smith as vice chair.

Microsoft said the buyback program has no expiration date and may be terminated at any time, and that it would pay a dividend of \$0.62 per share - 6 cents over the previous quarter.

The U.S. technology giant also called the vice chair position an updated executive role for Smith, who currently leads a team of over 1,500 staff in 54 countries, according to his biography on Microsoft's website.

Smith joined Microsoft in 1993 from law firm Covington & Burling to run corporate and legal affairs operations in Europe. He became general counsel in 2002 and, over the next decade, handled



the resolution of antitrust cases, the biography showed.

Smith will continue to report to Chief Executive Officer Satya Nadella, Microsoft said.

**Microsoft Office 2021 will launch on October 5th**

Microsoft is launching its next

perpetual version of Microsoft Office for commercial customers today, and promising an Office 2021 consumer release on October 5th. Microsoft Office Long Term Servicing Channel (LTSC) for Windows and Mac will be available for commercial and government users today, providing a locked-in time release of Office that doesn't require a subscription.

Office LTSC is designed for businesses in regulated industries where processes and apps can't change on a monthly basis, or for manufacturing plants that rely on Office and want a locked-in time release. It won't ship with the AI- and cloud-powered features that are found in Microsoft 365, and it won't receive new features, either. Microsoft will support Office LTSC for five years, and the company has also committed to another perpetual version of Office for the future.

# Anant Chaturdashi

The Anant Chaturdashi fast holds a great deal of importance in the Hindu religion. The festival is also known by the name of Anant Chaudas. The day commemorates the Lord of numerous avatars, Lord Vishnu.

Coming on the 14th day of the Shukla paksha of the Bhadrapad month in the Hindu Calendar, the festival celebrates the spirit of oneness and a common brotherhood. This year, Anant Chaturdashi falls on September 19.

On Anant Chaturdashi, after paying homage to Lord Vishnu, a thread is being tied onto his arm. This thread could either be a silk thread or cotton one and must have 14 knots in it. The Ganesh Visarjan is also celebrated on the same days as Anant Chaudas. The entire nation celebrates this festival with great zeal and enthusiasm. A lot many processions of the lord are also taken out in the masses to get everyone ringing in the festivity together.

## Anant Chaturdashi as per the Scriptures

- The fast on this festival is observed on the 14th day of the Shukla Paksha, of the Bhadrapad month in the Hindu Calendar. For this condition to be satisfied, the 14th day must start after 2 muhurats from the time of the sunrise.
- If the Chaturdashi date falls after the sunrises two muhurats and ceases before it, then the festival of Anant Chaturdashi is to be celebrated a day prior to this. The whole procession of the festival, the worshipping, the paying homage, the fast, everything must take place in the first half of the day to maintain the auspiciousness of the rituals. If by any chance, you couldnt find time to do it at that phase, itll be better if you do it in the first time frame of the middle phase of the day. The first time frame of the middle phase of the day is from the 7th and the 9th muhurat.

## Anant Chaturdashi Puja Vidhi and Vrat

In the Agni Puran, the importance of observing a fast is being stressed upon. This day commemorates the infinite forms of the Lord Vishnu. This worshipping is done in the noon time, the Pujan Vidhi is mentioned below:

- On this day, after proper bath, take a bow and place a kalash on the Pujan altar.
- Establishment of a kalash which has an Ashtadal lotus made of kush on a vase can be installed, or if you wish you can also use a picture of Lord Vishnu.
- After this prepare a thread by dipping it in vermilion, saffron, and turmeric. It must have 14 knots. Keep this thread in front of the idol of Lord Vishnu.
- Now, worship the thread and the idol of the lord with Shadoshopchar method and chant the mantra thats being mentioned below. After thats being done, you are to tie the sacred thread around your arm.
- The men are supposed to tie it on their left arm and the women are supposed to wear it round their right arm. After this offer food to the Brahmans and accept the prasad with your entire family.

## The Significance of Anant Chaturdashi

As per the mythology, the festival of Anant Chaturdashi has its roots in the epic Mahabharata. The day is being celebrated as the day of Lord Vishnu. The lord created 14 loks, Tal, Atal, Vital, Satal, Talatal, Rasatal, Paatal, Bhi, Bhuva, Jan, Tap, Satya, mah. In order to follow and protect these, he came down to this mortal world in the form of 14 different avatars, which gave him the name of being infinite. He knew he had save his people and his creations, for which these avatars played a major role. Therefore, the day of Anant Chaturdashi has great importance, since you can please the lord of creation himself and be blessed with his choicest blessings. The fast thats being observed on this day also holds a major significance. All this is said to please him and provide you with an eternal life full of bliss and contentment. It is also believed that along with fasting on this day, if any person recites the



Vishnu Sahasranama stotra, all his wishes are fulfilled and he gets what he desires for from the Lord. This fast is done to attain wealth, abundance, and prosperity in ones life. The desire of having ample money, happiness and children etc lures the man to seek the lords blessings on his mortal existence. This fast is prevalent in many states of India. On this day folk tales of Lord Vishnu are heard by the members of the family.

## Legendary tales surrounding Anant Chaturdashi

According to the take in the epic Mahabharata, the Kauravas defeated the Pandavas in gambling with the help of turning against them and going behind their back in the act of deceiving. After this, the Pandavas had to lose their kingdom, their wealth, and all the luxuries and go for a period of exile in the wilderness. In this duration, they had to endure much pains and hardships to get through it. One fine day, Lord Krishna went to greet the Pandavas in the forest. After greeting him with proper respect, the eldest of the Pandavas, Yudhishtira asked him for a way, through which they can come back to the track and get their lost kingdom and wealth back with respect. The Lord upon hearing this, gave him an antidote that could solve all his problems in life and fulfill his hearts desire. This remedy was the fast of Anant Chaturdashi, that commemorates Lord Vishnu who is the sole provider of solace. He advised him to observe this fast and pay homage to Lord Vishnu with his wife and brothers.

After hearing this, Yudhishtira asked Krishna to explain who is Anant. Lord Krishna went in great details to let him know that Lord Anant is another avatar of Lord Vishnu. Lord Vishnu rests in the Chaturmas on the sheshnaag for an infinite time.

Anant lord in the avatar of Vaaman went through the three loks in just 2 pags. No one knows about his start, his end and thats one of the major reason hes called and known by the name, infinite. By worshipping him all the woes and issues that you gave on your life will cease to exist and youll be able to live a life that youve always wanted.

After the tale got ended, Yudhishtira pledged to observe this fast with his family, and after its successful completion he was able to regain his lost kingdom and wealth.



**SEPTEMBER 17, 1787** - At the Constitutional Convention in Philadelphia, delegates from twelve states voted unanimously to approve the proposed U.S. Constitution.

**SEPTEMBER 17, 1862** - The bloodiest day in U.S. military history occurred as General Robert E. Lee and the Confederate armies were stopped at Antietam in Maryland by General George B. McClellan and numerically superior Union forces. By nightfall 26,000 men were dead, wounded, or missing.

**SEPTEMBER 17, 1908** - The first fatality involving powered flight occurred as a biplane piloted by Orville Wright fell from a height of 75 feet, killing Lt. Thomas E. Selfridge, his 26-year-old passenger. A crowd of nearly 2,000 spectators at Fort Myer, Virginia, observed the crash of the plane which was being tested for possible military use. Wright himself was seriously injured.

**SEPTEMBER 17, 1939** - Soviet Russians invaded Eastern Poland, meeting little resistance and taking over 200,000 Poles prisoner. This was done in accordance with the Nazi-Soviet Pact in which the Nazis and Soviets had predetermined how they would divide up Poland.

**BIRTHDAY** - Supreme Court Justice Warren E. Burger (1907-1995) was born in St. Paul, Minnesota. Appointed by President Nixon, he had the longest tenure (1969-86) of any Chief Justice in the 20th Century. In 1973, he voted in the majority on Roe vs. Wade which upheld a woman's right to an abortion. 


## **Radhanagar Beach, Andaman and Nicobar Islands**

**PM MODI TO VISIT US TO ATTEND QUAD SUMMIT, UNGA DEBATE**

they will review the Quad Vaccine Initiative, a plan to manufacture (in India) at least 1 billion COVID-19 vaccines, for distribution in Asia by the end of 2022.

"Hosting the leaders of the Quad demonstrates the Biden-Harris Administration's priority of engaging in the Indo-Pacific, including through new multilateral configurations to meet the challenges of the 21st century," the White House said on Tuesday.

The leaders "will also exchange views on contemporary global issues such as critical and emerging technologies, connectivity and infrastructure, cyber security, maritime security, humanitarian assistance/ disaster relief, climate change and education", the MEA said.

**Free and open Indo-Pacific**

"The summit would provide a valuable opportunity for dialogue and interactions among the leaders, anchored in their shared vision of ensuring a free, open and inclusive Indo-Pacific region," the MEA said. The White House statement also referred to discussions around "promoting a free and open Indo-Pacific".

At the March summit, the leaders discussed China's assertiveness in the Indo-Pacific region and that topic will most likely come up again next week. Afghanistan will also likely be discussed, weeks after the chaotic withdrawal of U.S. troops from Kabul and a Taliban take-over of the country.

There has been speculation on whether Mr. Modi and Mr. Biden will hold bilateral discussions. The Hindu has reached out to the White House for clarification on this. Mr. Modi will travel to New York, where he will address the 76th session of the United Nations General Assembly (UNGA) on Saturday, September 25 morning. Mr. Modi is scheduled to be the first speaker at the U.N. The theme for the general debate is: "Building resilience through hope to recover from COVID-19, rebuild sustainably, respond to the needs of the planet, respect the rights of people and revitalize the United Nations."

The general debate is being held partly virtually this year owing to the COVID-19 situation. Mr. Modi is one of about 109 leaders to address the General Assembly in person, while 60 will deliver virtual addresses, PTI reported.

Arceneaux is set to become the youngest American in space and the first person in space with a prosthesis, a titanium rod in her left leg.

The recycled Falcon rocket soared from the same Kennedy Space Center pad used by the company's three previous astronaut flights for NASA. But this time, the Dragon capsule aimed for an altitude of 575 km, just beyond the Hubble Space Telescope.

Their fully automated capsule has already been to orbit: It was used for SpaceX's second astronaut flight for NASA to the space station. The only significant change is the large domed window at the top in place of the usual space station docking mechanisms.

Isaacman, an accomplished pilot, persuaded SpaceX to take the Dragon capsule higher than it's ever been. Initially reluctant because of the increased radiation exposure and other risks, SpaceX agreed after a safety review.

"Now I just wish we pushed them to go higher,"

Isaacman told reporters on the eve of the flight. "If we're going to go to the moon again and we're going to go to Mars and beyond, then we've got to get a little outside of our comfort zone and take the next step in that direction." Isaacman, whose Shift4 Payments company is based in Allentown, Pennsylvania, is picking up the entire tab for the flight but won't say how many millions he paid. He and others contend those big price tags that will eventually lower the cost.

"Yes, today you must have and be willing to part with a large amount of cash to buy yourself a trip to space," said Explorers Club President Richard Garriott, a NASA astronaut's son who paid the Russians for a space station trip more than a decade ago. "But this is the only way we can get the price down and expand access, just as it has been with other industries before it.

Though the capsule is automated, the four Dragon riders spent six months training for the flight to cope with any emergency. That training included centrifuge and fighter jet flights, launch and reentry practice in SpaceX's capsule simulator and a grueling trek up Washington's Mount Rainier in the snow.

Four hours before liftoff, the four emerged from SpaceX's huge rocket hangar four hours before liftoff, waving and blowing kisses to their families and company employees, before they were driven off to get into their sleek white flight suits. Once at the launch pad, they posed for pictures and bumped gloved fists, before taking the elevator up. Proctor danced as she made her way to the hatch.

Unlike NASA missions, the public won't be able to listen in, let alone watch events unfold in real time. Arceneaux hopes to link up with St. Jude patients, but the conversation won't be broadcast live.

SpaceX's next private trip, early next year, will see a retired NASA astronaut escorting three wealthy businessmen to the space station for a weeklong visit. The Russians are launching an actress, film director and a Japanese tycoon to the space station in the next few months. Once opposed to space tourism, NASA is now a supporter. The shift from government astronauts to non-professionals "is just flabbergasting," said former NASA Administrator Charles Bolden, a former space shuttle commander.

"Someday NASA astronauts will be the exception, not the rule," said Cornell University's Mason Peck, an engineering professor who served as NASA's chief technologist nearly a decade ago. "But they'll likely continue to be the trailblazers the rest of us will follow." (Agencies)

**FINANCIAL BIDS RECEIVED FOR AIR INDIA DISINVESTMENT: TATA SONS AND SPICE JET AMONG BIDDERS**

feedback from potential investors, the government had in October last year sweetened the EoI clause relating to transfer of Air India's debt to the new investor, giving bidders flexibility to decide on the quantum of humongous debt they want to absorb.

As per the Air India EoI floated by the Department of Investment and Public Asset Management (DIPAM) in January 2020, of the airline's total debt of ₹60,074 crore as of March 31, 2019, the buyer would be required to absorb ₹23,286.5 crore. The rest would be transferred to Air India Assets Holding Ltd (AIAHL), a special

purpose vehicle.

Air India has been in losses ever since its merger with domestic operator Indian Airlines in 2007. The airline, which was formed by the Tatas as a mail carrier in 1932, will give the successful bidder control of 4,400 domestic and 1,800 international landing and parking slots at domestic airports, as well as 900 slots at airports overseas.

Besides, the bidder would get 100% of the low-cost arm Air India Express and 50% of AISATS, which provides cargo and ground-handling services at major Indian airports.

**WHAT TO EXPECT FROM THIS YEAR'S UN GENERAL ASSEMBLY (UNGA)**

**O EUROPE:** Smaller countries that are planning to send high-level delegations include Switzerland's President Guy Parmelin, Belgium's Prime Minister Alexander de Croo and Ireland's Taoiseach Micheal Martin. (Ireland is presiding over the Security Council in September.)

o Niger's Mohamed Bazoum, who took office in April and will make his first trip to the city in September with his foreign minister. Nigeria's President Muhammadu Buhari also plans to come, according to Bande.

**O DIGITAL AFRICA:** South African President Cyril Ramaphosa, Rwanda's Paul Kagame and Egypt's Abdel Fatah El-Sisi are planning to each send a pre-recorded video.

**O CANADA:** While Canada's speaker is listed as "head of government" on the provisional schedule, Prime Minister Justin Trudeau has called a snap election for Sept. 21 - the day the high-level week UNGA begins. That means that there could technically be a new government by then (although it's unlikely). Asked who is going to represent Canada, the UN mission said: "Canada's delegation to the 76th session of the UN General Assembly will be confirmed in the days leading up to the high-level week."

**O#WHATSHAPPENINGINMYANMAR:** Competition for who is the authorized permanent representative for Myanmar, whose government was ousted by a military coup in February, will likely seize the spotlight at this year's UNGA. The provisional speaking list indicates that the country is going to be represented by its ambassador, which means, for now, Kyaw Moe Tun. The UN's credential committee has to discuss the matter but may not do so too soon.

o As to who will represent Afghanistan at UNGA is also unclear, as the current ambassador was part of the former Ashraf Ghani regime.

**Women: From 52nd to 6th**

o The low number of women speakers at last year's UNGA has not been forgotten, given that the first woman to speak was 52nd in the lineup. While it looks like the number of women speakers has not risen this year, President Zuzana Caputova of Slovakia is going to be the first woman leader to stand at the General Assembly Hall rostrum, No. 6 on the list, on the morning of Sept. 21.

o Moldova's Maia Sandu, the country's first woman president, is 100 percent coming, according to the country's UN mission, making her first appearance in front of the UNGA as president. (She was previously prime minister.)

o As she is up for re-election on Sept. 25, it is unlikely that Iceland's Prime Minister Katrin Jakobsdottir will come to UNGA, which is probably why the Icelandic speaker on the official list is a minister and has been delegated to Sept. 27.

o While the schedule indicates that New Zealand will be represented in person by the country's head of government, Jacinda Ardern, diplomats say that New Zealand has no appetite to send a high-level delegation this year. In an email, New Zealand's mission to the UN said that "consideration is being given to New Zealand's representation at this year's UNGA. Any announcement will be made in due course."





Tokyo 2020 - Olympic and Paralympic Games - will go down in the annals of Indian sports as a year of consolidation of gains this liberal democracy has made over decades of its participation in these global mega sporting events.

Not many would remember, 2018 was the watershed year. It was at Buenos Aires in the Youth Olympic Games that India started sending out signals of its emergence as a new power in sports.



YOUTH OLYMPIC GAMES

India ended 14th on the medals tally with three gold, nine Silver and one



bronze medal. It was perhaps the first global event conducted under the banner of the International Olympic Committee that India finished a select band of nations with 10 or more medals.

Since then, India has not looked back.

It was "lucky" 13 of Buenos Aires that has provided a new dynamic direction to Indian sports. The Youth Olympic Games not only provide a record number of medals but also projected on the global horizon many new faces.

It was at Buenos Aires that projected young shooters Manu Bhaker and Saurabh Chaudhary. Both were gold medal winners. Indian hockey teams, both men and women, ended with silver medals. Vivek Sagar Prasad and Lalremsiami were members of silver medalist Indian men and women Hockey5 teams that were subsequently inducted into Olympic teams.

The medals trail set in motion at

Buenos Aires climaxed at Tokyo 2020 Olympic Games where India got its first ever medal, a Gold, in track and field besides returning to the victory podium in men's hockey after a gap of 41 years.

The gains were further consolidated at Tokyo 2020 Paralympic Games where India finished 24th with 19 medals, including five gold. Beginning with Buenos Aires, all the IOC events - Youth Olympic Games, Olympic Games and Paralympic Games - have shown India's firm climb up the medals ladder.

The medal winning performances, mostly in individual events, have been acting as a catalyst for aspiring players to take to sports as a career.

Neeraj Chopra (Javelin throw, Tokyo 2020 Olympics), Sumit (Javelin throw in F64 category of Paralympics), Krishna Nagar (Badminton, SH category), Pramod Bhagat (Badminton, SL 3 category), Manish Narwal (Shooting,

Mixed 50 m, SH1 category), and Avani Lekhara (Shooting, SH 1, 10 m Air Pistol) have emerged as the new icons of Indian sports for winning gold medals in Olympics or Paralympic Games.

Shooters Singhraj Adrana and Avani Lekhara won two medals each in Paralympics. Besides a Badminton coach, Pramod Bhagat, a District Magistrate of NOIDA, Suhas Yathiraj, too gave India medals in Badminton. While Bhagat won a gold, Yathiraj lost the gold medal to his French

rival to end with a Silver.

For Avani Lekhara, it was a gold and a bronze. She became the first women shooter to win a medal in the Olympics or Paralympics. Likewise, Harvinder Singh of Kaithal had the distinction of winning the country's first medal in archery in the Paralympics or Olympics.

It may sound as an exaggeration that finally Indian sports have come of an age and the country has been successful to an extent of creating sports temperament. Sports is now being accepted as a respectable profession.

India's progress in some sports and games, especially Badminton, Boxing, Golf, Shooting, Track and Field, Table Tennis, Tennis and Wrestling has been noticeable.

In team sports, hockey remains the top choice,

## England could boycott Ashes Down Under in view of strict bubble life

Top English players could boycott the high-profile Ashes series against Australia starting end of this year as they don't want to be confined to their hotel rooms close to four months due to strict quarantine rules in the country.

According to ESPN Cricinfo, the England and Wales Cricket Board (ECB) are still adamant and have not thought about postponement which has irked the senior players and support staff.

"The prospect of England fielding a significantly under-strength squad in the Ashes would appear to have grown following talks between the team and officials at the ECB," the website reported.

The players have been left disappointed because of ECB's refusal to even countenance a partial or even complete postponement of the tour.

"As a result, they are considering their options. One of those options is understood to be the entire team — including coaching and support staff — taking a collective decision to boycott the tour.

## Manika Batra axed for Asian meet amid feud with TT body

The feud between India women's No. 1 Manika Batra and the Table Tennis Federation of India (TTFI) took a turn for the worse with her omission on Wednesday from the team for the Asian championships to be held in Doha, Qatar from September 28-Oct 5.

Batra, world No. 56 and ranked way ahead of her teammates—fellow Tokyo Olympics participant Sutirtha Mukherjee, the next best Indian player, is No. 97—did not attend the ongoing national camp, which the federation had said was mandatory for selection.

The Delhi player has been training in Pune with her personal coach Sanmay Paranjape, having informed TTFI she will not join the national camp. The other women players chosen are Sreeja Akula, Ayhika Mukherjee and Archana Kamath.

The 2018 Commonwealth Games champion's run-in with TTFI began after she refused to have national coach Soumyadeep Roy in her corner at the Olympics, after her personal coach's accreditation did not allow him to enter "the field of play". Batra reached the third round in Tokyo with no coach courtside.

# Virat Kohli to quit national T20 captaincy after World Cup

DUBAI (TIP): Virat Kohli on Thursday, Sept 16, announced he will step down as India's T20 skipper after the T20 World Cup in UAE but will continue to lead the side in ODIs and Test cricket, a decision that paves the way for Rohit Sharma to captain in the shortest format.

"I've decided to step down as the T20 captain after this T20 World Cup in Dubai in October," the 32-year-old Kohli, who is here to compete in the IPL that resumes on Sunday, said in a statement posted on his Twitter page.

"Understanding workload is a very important thing and considering my immense workload over the last 8-9 years playing all three formats and captaining regularly for last five to six years, I feel I need to give myself space to be fully ready to lead Indian team in Test and ODI cricket," Kohli explained.

For some time, there has been speculation surrounding Kohli's future as white-ball captain especially in the backdrop of Rohit's brilliant track record of winning five IPL titles for Mumbai Indians.


The 34-year-old Rohit is Kohli's deputy in the white-ball formats and is most likely to take up the leadership role when India clashes with New Zealand in a home series in November that will feature three T20 Internationals along with two Test matches.

BCCI Secretary Jay Shah, in a statement issued by the Board after Kohli's announcement, said the body has been in discussion with Kohli for a while now.

"We have a clear roadmap for Team India. Considering the workloads and ensuring that we have smooth transition, Mr Virat Kohli has decided to step down as T20I Captain after the upcoming World Cup," Shah said.

"I have been in discussions with Virat and the leadership team for the last six months and the decision has been thought through.

"Virat will continue to contribute as a player and as a senior member of the



side in shaping the future course of Indian cricket," he added.

Kohli took over India's limited-overs captaincy in 2017, succeeding Mahendra Singh Dhoni.

"I have given my everything to the Team during my time as T20 captain and I will continue to do so for the T20 captain and will continue to do so for the T20 team as a batsman moving forward," he further added.

The decision, Kohli said, was taken after consulting head coach Ravi Shastri, his heir apparent Rohit, BCCI president Sourav Ganguly and secretary Jay Shah.

The T20 World Cup starts on October 17 and Kohli will be under intense pressure to deliver the trophy.

"Of course, arriving at this decision took a lot of time. After a lot of contemplation and discussions with my close people, Ravi bhai and also Rohit, who have been an essential part of the leadership group..." Kohli stated.

"I have also spoken to the secretary Mr Jay Shah and president of BCCI Mr Sourav Ganguly along with the selectors about the same. I will continue to serve Indian cricket and Indian cricket team to the best of my ability," Kohli said.

Kohli has played 90 T20 Internationals scoring 3,159 runs with 28 fifties and captained India in 45 of those games winning 27 and losing 14.

He has a winning percentage of 65.11. "I have been fortunate enough to not only represent India but also lead the Indian cricket team to my utmost capability," the flamboyant star batsman said.

"I thank everyone who has supported me in my journey as the captain of the Indian cricket team.

"I could not have done it without them—the boys, the support staff, the selection committee, my coaches and each and every Indian who prayed for us to win," Kohli said. Source: PTI

# English giants make it count; City, Liverpool wrap up thrilling wins; PSG held by Brugge, Real win

GENEVA (TIP): Lionel Messi, Kylian Mbappe and Neymar lined up together in the near-perfect attack for Paris Saint-Germain and still could not score or deliver a win in the Champions League.

Instead, it was low-key midfielder Ander Herrera who got PSG's goal in a 1-1 draw at underrated Belgian champion Club Brugge.

Though Messi saw a first-half shot strike the crossbar, he was later shown a yellow card for a foul and Mbappe went off because of an injured left ankle.

French forwards flourished elsewhere with Sebastien Haller

scoring four for Ajax in a 5-1 rout at Sporting Lisbon and Christopher Nkunku netting all of RB Leipzig's goals in a 6-3 loss to Manchester City.

The English clubs in action combined for two wins in matches involving 14 goals as Liverpool beat AC Milan 3-2 in the Italians' return to the competition after a seven-season gap. There was just one goal in the games involving the Madrid clubs, and Rodrygo's 89th-minute strike won it for Real Madrid at Inter Milan. Atletico Madrid was held 0-0 at home to Porto. Debutant Sheriff Tiraspol won 2-0 against Shakhtar Donetsk.


