NEW YORK (TIP): Elon Musk tweeted on Friday, May 13, that his \$44-billion cash deal for Twitter Inc was "temporarily on hold" while he waits for the social media company to provide data on the proportion of its fake accounts, says a Reuters report.

Twitter shares initially fell more than 20% in premarket trading, but after Musk, the chief executive of

MAJOR POLITICAL OUTFITS BANKING HEAVILY ON SOUTH ASIANS IN GENERAL AND PUNJABIS IN PARTICULAR

MISSISSAUGA (TIP): As many as 20 candidates of Punjab origin are in the fray for the Ontario provincial elections in Canada for which the polling is scheduled to be held on June 2 for all 123 constituencies.

The three major political outfits - the Liberals, National Democratic Party (NDP) and the Progressive Conservative Party (PC) - are not only banking heavily on South Asians in general and Punjabis in particular, but they have also given "adequate representation" to their communities by fielding them.

In the final list, Liberal Party and Progressive Conservative Party have

THE PURSUIT OF JUSTICE HAS NO LIMITS IN A DEMOCRACY

Chief Justice of India NV Ramana has yet again fastened the people's faith in judiciary and its highest office by underscoring the 'requirement to balance' security interests of the State with civil liberties of its citizens in Wednesday's order putting the sedition law on hold. Section 124A of the Indian Penal Code has no place in a civilized society, as is evident from cases slapped by various state governments against their political opponents - the latest being the Shiv Sena government's case against BJP leaders in Maharashtra. The continuance of a law used by the colonial administration to throttle freedom fighters is itself a matter of shame; and then for Independent India's rulers to misuse this very law to settle political

scores is an assault on the basic tenets of the rule of law. The British had used this law to lock up for life all those who expressed hatred against the alien government. Section 124A is as illegitimate as the colonial rule.

The government's response to the progressive leap taken finally by the CJI, after 75 long years of India's Independence, is disappointing. The applicability and the contextuality of the law are not only within the Supreme Court's remit, but it is entirely a justiciable issue for the apex court. There have been previous instances of judicial transgression into legislative and executive spheres, but not this. Who else but the Supreme Court would decide the merits of a law that governments

love and the Opposition hates? Then for the government to remind the CJI of the Lakshman rekha over this order was most inopportune as the pursuit of justice has no limits in a democracy.

Last year, the SC Bench of Justices Sanjay Kishan Kaul and Hemant Gupta had ordered that dissent is not sedition, while dismissing a petition filed against Farooq Abdullah. Now, the Bench of CJI Ramana, Justices Surya Kant and Hima Kohli has taken the judicial review forward by offering relief to all those who have been incarcerated under this vague and repressive law. It is the Centre's responsibility to ensure that the police do not breach the Lakshman rekha of the spirit of this order.

REFORMING WHO

MORE NEEDS TO BE DONE TO ENHANCE WHO'S ABILITY TO RESPOND TO DISEASE OUTBREAKS

In the third year of the COVID-19 pandemic, Prime Minister Narendra Modi once again brought up the much-discussed issue of reforming the World Health Organization while addressing the heads of countries at the second global COVID-19 summit. That reforms are urgently needed to strengthen the global health body and its ability to respond to novel and known disease outbreaks in order to limit the harm caused to the global community is beyond debate. The long delay and the reluctance of China to readily and quickly share vital information regarding the novel coronavirus, including the viral outbreak in Wuhan, and its stubborn refusal to allow the global agency to investigate, freely and fairly, the origin of the virus have highlighted the need to strengthen WHO. But any attempt to build a stronger WHO must first begin with increased mandatory funding by member states. For several years, the mandatory contribution has accounted for less than a fourth of the total budget, thus

reducing the level of predictability in WHO's responses; the bulk of the funding is through voluntary contribution. Importantly, it is time to provide the agency with more powers to demand that member states comply with the norms and to alert WHO in case of disease outbreaks that could cause global harm. Under the legally binding international health regulations, member states are expected to have in place core capacities to identify, report and respond to public health emergencies. Ironically, member states do not face penalties for non-compliance. This has to change for any meaningful protection from future disease outbreaks.

While Mr. Modi has been right in calling for reforms in WHO, the demand for a review of the health agency's processes on vaccine approvals is far removed from reality. Covaxin is not the first vaccine from India to be approved by WHO, and the manufacturer of this vaccine has in the past successfully traversed the approval processes without

any glitch. The demand for a review of the vaccine approval process is based on the assumption that the emergency use listing (EUL) of Covaxin was intentionally delayed by the health agency, which has no basis. That the technical advisory group had regularly asked for additional data from the company only underscores the incompleteness of the data presented by the company. As a senior WHO official said, the timeline for granting an EUL for a vaccine depends "99% on manufacturers, the speed, the completeness" of the data. To believe that the agency was influenced more by media reports than the data submitted by the company is naive; the media were only critical of the Indian regulator approving the vaccine even in the absence of efficacy data. Also, the rolling submission began in July 2021 after the company had completed the final analysis of the phase-3 data. Any reform in WHO should not dilute the vaccine approval process already in place.

California Sikh faces racial slurs and threats in his neighborhood

SACRAMENTO (TIP): For a first generation Sikh American father, Rouble Paul Claire, Sutter in California has been home for decades. The family has been living in the neighborhood since 1973.

Naturally for most immigrants in America, having lived so long in a place, the country feels like a natural home. However, Claire and his family were in for a rude shock when he found himself confronted with racism in his very neighborhood.

The incidents began surfacing in 2021, when a woman shouted and called Claire a F*cking Hindu and then he woke up to find racial graffiti written on his driveway calling him N*gger.

In 2021, he was accosted by a woman in his neighborhood while at South Butte Market, a local grocery store. The woman shouted and cursed at Claire -including by calling him a "f*cking Hindu"- threatened to "ram" him with her car, and then got in her car and sped towards him in a parking lot, only swerving away at the last moment.

Later that day, another woman connected to the assailant in the first incident wrote the word "Sand N*gger" in chalk on the sidewalk outside Claire's house and in his driveway, and called him "N*gger."

Claire, 66, immediately notified the Sutter County Sheriff's Office (SCSO). But after months of delay and inconsistent responses, he has now retained the Sikh Coalition, a civic service organization providing free legal help to victims of racism.

Claire says, "I have been subject to threats, harassment, and racial slurs - yet almost a full year later, no one has been held accountable."

He adds, "For months after immediately reporting these hateful acts, I sat in silence waiting for action that never came. I did not want to have to take legal action against anyone, but I believe that this failure of justice is unacceptable: No one in our community should have to face this kind of hate and bigotry."

The Sikh Coalition is now urging Sutter County District Attorney's Office (SCDAO) to bring criminal charges in the first case. Simultaneously, Claire has filed a civil suit against officers of the SCSO, Sutter

County, and the individual who threatened him.

Despite repeatedly appealing to the SCSO for help, Claire received little aid. One deputy who responded to the chalking incident used his own water bottle in an attempt to wash away the evidence before taking photos for the office. Another advised him not to drive on his own street to avoid any confrontation.

For months, Claire's requests for action, charges, or even a police report documenting the incidents, repeatedly fell on deaf ears. After the Sikh Coalition was retained, its attorneys met with SCSO Sheriff Brandon Barnes in Dec 2021 and January this year.

In those conversations, Sheriff Barnes acknowledged that his deputies failed to follow proper investigatory protocol in the course of these cases and confirmed that one deputy had received additional training as a result.

Eventually, they also secured a police report detailing Claire's experiences - in which the SCSO recommended criminal charges against the woman who threatened him at the store six months after the incident.

The SCDAO, however refused to press charges aside from minimizing the danger of the altercation and ignoring the hateful slurs and vandalism Claire was subjected to both at the market and at his home.

They cited the amount of time that had elapsed between the incidents and the police finally calling for charges as reason not to move the case forward - despite the fact that this delay was due to the SCSO's failure to

properly investigate and act.

The Sikh Coalition is calling on the SCDAO to bring charges of criminal threats, assault, assault with a deadly weapon against the woman who initially threatened Claire with her car.

The coalition says it also remains extremely concerned about the utter inaction of local law enforcement in response to the racial slurs and graffiti on and around Claire's property - and broader allegations of a pattern of inaction by the SCDAO in cases targeting members of marginalized communities.

"No one deserves to feel threatened in their own community, and law enforcement- both police and prosecutors- simply must do better," said Amrit Kaur Aakre, Sikh Coalition Legal Director.

"Tragically, we have seen time and again that hateful interactions can lead to violent results. The case of Khalid Jabara, killed in Oklahoma in 2016 after months of verbal, bias-based harassment from a neighbor, comes to mind."

"The large Sikh population in this area is only more reason to ensure that all members of this community feel safe and secure," Aakre added.

"It is unacceptable that the law enforcement authorities sworn to protect Claire did so little over such a long time-and then ultimately refused to pursue the justice that he deserves," said attorney Sean Tamura-Sato who is representing the case.

"This civil suit is a first step to remedying that failure, as well as taking legal action against the women who threatened and harassed him, who have faced no consequences whatsoever due to Sutter County's practice of inadequately investigating and prosecuting hate crimes against racial and ethnic minorities," said attorney Gina Szeto-Wong.

Sikhs are members of an independent faith tradition that is the world's fifth largest religion, and California is home to roughly half of the 500,000 Sikhs in the United States.

Sikhs remain among the top five most frequently targeted religious groups in the country for hate crimes and bias incidents, according to the FBI.

Indian-origin man jailed for 20 years for violent robbery in London

LONDON (TIP): An Indian-origin man who was found guilty of a violent robbery in east London has been sentenced to 20 years' imprisonment along with two of his accomplices.

Ajaypal Singh, 28, had pleaded guilty to the charge of possession with intent to supply and possession of a pointed/bladed article and was found guilty of robbery at a trial in November

last year. He was sentenced at Snaresbrook Crown Court on Friday to 20 years, with an extended license period of five years allowing for a further term dependent on conduct.

"This result is the conclusion of a complex investigation into a serious and violent crime that had a significant impact on the local community," said Detective Constable (DC) Darren Warner from the Specialist Crime Command of the Metropolitan Police, who conducted the investigation.

"It also left a family, including a young child, terrified. They will never be able to forget what happened to them that night. I am grateful to the members of the public who came forward to assist the investigation - in the Metropolitan Police we know that we are most effective when we police with the support of the public, working together to tackle those causing the most harm," he said.

Indian-origin accountant jailed for five-and-a-half years in UK for fraud, money laundering

LONDON (TIP): An Indian-origin chartered accountant (CA) has been sentenced to five-and-a-half years of imprisonment by a UK court after being convicted for exploiting a vulnerable victim out of money and assets worth 331,858 pounds.

Sukhvinder Singh, 73, was sentenced on four counts of fraud and one count of money laundering at York Crown Court in north-east England on Thursday. The court heard that the victim, identified only as 'A', has learning, social, and physical disabilities and was targeted and duped by Singh.

"Singh put himself forward as a trusted friend and professional financial adviser for an individual with considerable vulnerabilities. His actions, in diverting money and property for his own personal gain, was a huge breach of trust, and failed to support and protect the victim," said Andrea Thomas, a Senior Crown Prosecutor for the Crown Prosecution Service (CPS) Serious Economic

Organized and International Directorate (SEOCID).

"He may have obtained further assets from the victim but for the work of North Yorkshire police who helped to build a strong and compelling case. Indian American Dr. Arun Majumdar named inaugural dean of Stanford University's new school on climate change and sustainability

STANFORD, CA (TIP): Dr Arun Majumdar, Indian-American material scientist, engineer and professor, has been named the inaugural dean of Stanford University's new school that focuses on climate change and sustainability.

Stanford Doerr School of Sustainability, the university's first new school in 70 years, which aims to accelerate solutions to the global climate crisis, will be launched on September 1, according to Stanford news.

Majumdar, currently the Jay Precourt Provostial Chair Professor, a faculty member of the Departments of Mechanical Engineering and Materials Science and Engineering, and Senior Fellow and former director of the Precourt Institute for Energy, will assume his new position on June 15.

Originally from Kolkata, Majumdar

received his bachelor's degree in mechanical engineering at the Indian Institute of Technology, Bombay, in 1985 and his PhD from the University of

California, Berkeley, in 1989. He was nominated to the position of Under Secretary of Energy in the United States between November 30, 2011 and May 15, 2012 but then the nomination was retracted.

After leaving Washington DC, Majumdar was the vice president for energy at Google, where he assembled a team to create technologies and businesses at the intersection of data, computing, and electricity grid.

Majumdar joined Stanford in 2014. He was the founding director of the Advanced Research Projects Agency - Energy (ARPA-E), and currently serves as the chair of the advisory board to the US Secretary of Energy.

"I am deeply honored and humbled by the opportunity to serve as the inaugural dean," Majumdar said in the release.


BENGALURU (TIP): Dr. Kamaljit S. Bawa, aka Kamal Bawa, a noted, Indian born, conservation biologist and President of the Bengaluru, India-based Ashoka Trust for Research and Ecology and Environment (ATREE) has been elected to the US National Academy of Sciences. Election to the 170-year-old Academy is a recognition of the significant contributions to science by its members, ATREE said in a press release on May 5. Bawa is also an elected fellow of the Royal Society (London) and the American Philosophical Society.

"The election is the reaffirmation of our important work on the ecology, conservation, and management of tropical forests that are declining all over the world but are critical to humanity's well-being," said Bawa.

Biodiversity in tropical forests and other natural habitats is an important source of many ecosystem services and for the mitigation of climate change. ATREE, founded by Bawa is well recognized for its work on assessing and managing biodiversity, climate change, and water. A Distinguished Professor of Biology at the University of Massachusetts Boston, Bawa has done extensive work in the Himalaya for a number of years on a wide range of issues from biodiversity conservation to climate change.

Indian American Kris Kolluri tapped to lead NY & NJ's Gateway Program

NEW YORK (TIP): Kris Kolluri, an Indian American infrastructure management expert, has been tapped to lead New York and New Jersey's Gateway Program, including redevelopment of the Portal North Bridge and a new Hudson River tunnel.

New York Governor Kathy Hochul and New Jersey Governor Phil Murphy jointly announced the nomination of Kolluri as the CEO of the Gateway Development Commission, on May 6.

The Commission is a partnership between New York, New Jersey and Amtrak that coordinates delivery of the Gateway Program with its partner agencies, including the Port Authority of New York and New Jersey and NJ TRANSIT.

Kolluri will be considered by the Gateway Development Commission's Board at its next upcoming meeting, anticipated on May 16, according to a press release from the New York governor's office.

"With his extensive resume, Kris Kolluri brings an extraordinary record

of public service and I am confident he will serve New York and New Jersey well as CEO of the Gateway Development Commission," Hochul said.

"The Gateway Hudson Tunnel is critical to the Northeast corridor serving more than 800,000 passengers daily and is a key component of our plan to build back stronger than ever," she said.

"Moving the Gateway Program, and specifically the Hudson Tunnel Project, forward is critically important for our region, and I am confident that Kris Kolluri's leadership will help us realize these much-needed projects," said Murphy.

"Kris has years of infrastructure management and operations experience, as well as years of government experience, that will be vital as we continue working with our federal partners to get the Gateway Program fully funded and completed."

"I am honored to be nominated by Governors Phil Murphy and Kathy Hochul to be Chief Executive Officer of the Gateway Development Commission. I look forward to meeting the Commissioners and supporting their important work," said Kolluri.

"There is a clear and present opportunity and desire among federal, state, and bi-state partners to advance the Hudson Tunnel Project and the Gateway Program," he said. "In the short term, the HTP is poised to move forward and the Commission has a critical role in overseeing the successful delivery of this project."

Identified as Sareddy Kranthi Kiran Reddy (25), the boy hailed from Annaram village in Miryalaguda Mandal of Nalgonda district.



Revisiting Roe vs Wade

"THE JOB OF A JUDGE IS TO INTERPRET THE LAW MADE BY THE LEGISLATURE, AND APPLY IT TO SPECIFIC CASES, BUT NOT TO MAKE LAW. ROE VS WADE (AND PLANNED PARENTHOOD VS CASEY) CLEARLY MADE LAW, WHICH WAS THE FUNCTION OF THE LEGISLATURE. HENCE IT SHOULD BE REVERSED."

A controversy is raging in America over Justice Alito's leaked draft judgment proposing to overturn the US Supreme Court's verdict in Roe vs Wade delivered in 1973 regarding the right of abortion. It is believed 4 other judges in the court intend to concur with Justice Alito, making it a majority judgment.

I believe Justice Alito's view is correct and would like to give my reasons. Of course, it is only a draft opinion, but knowing the judicial philosophy of the majority judges it is highly likely it will be confirmed in the final verdict.

In Roe vs Wade the US Supreme Court set up a trimester system of pregnancy in women. In the first trimester (the first 3 months of pregnancy) no restrictions could be placed on a woman to abort. In the second trimester, too, abortion was permissible, though the state could put some restrictions e.g., it should be done by qualified medical personnel, in licensed clinics, etc. In the third trimester no

abortion was permissible unless a qualified doctor certified that the life of the woman would be in danger without abortion.

In Planned Parenthood vs Casey, 1992, the right to abortion enunciated in Roe was reiterated, but the trimester system was replaced by the viability test (i.e., at what stage of the pregnancy would the fetus be able to survive outside the woman's womb), and the undue burden test (i.e., does the restriction on abortion place an undue burden on the pregnant woman e.g., taking the husband's consent).

I am not going into the questions as to when does life begin, when is a fetus viable, what are undue burdens, etc.

My simple point is that under the separation of powers theory (that each of the 3 organs of the state have their own spheres of operation and should not encroach into each other's domains), it is for the legislature, not the judiciary, to make laws, and both Roe vs Wade as well as

Planned Parenthood vs Casey made laws.

I am personally in favor of the right to abortion, but then this right should be enacted by the legislature, not created by judges. There is nothing specific in the US Constitution which gives a right to abortion. Some states in America have enacted this right, but others have not.

The rights of people in the US Constitution are mentioned in the Bill of Rights and several Amendments to the Constitution, e.g., the 14th Amendment, but the right to abortion is nowhere contained therein.

Of course, there is a theory of 'unenumerated rights', i.e., there are some rights which though not expressly mentioned in the Constitution can be said to be part of it, but I do not subscribe to this view. To accept it would mean that any judge, according to his whim and fancy, can declare anything as an 'unenumerated right' and enforce it. This would lead to chaos.

In his book, 'The Nature of the Judicial

Process'. Justice Cardozo of the US Supreme Court observed "A judge is not a Knight Errant roaming at will in pursuit of his own ideal of beauty and goodness".

In his dissenting judgment in Griswold vs Connecticut, Justice Hugo Black warned that 'unbounded judicial creativity will make this Court a day-to-day National Convention'.

In Lochner vs New York the celebrated Justice Holmes of the US Supreme Court in his dissenting judgment criticized the majority of the court for becoming a super legislature by inventing a 'liberty of contract' theory thereby enforcing its particular laissez faire economic philosophy.

The job of a judge is to interpret the law made by the legislature, and apply it to specific cases, but not to make law. Roe vs Wade (and Planned Parenthood vs Casey) clearly made law, which was the function of the legislature. Hence it should be reversed.

JUDI TYABJI & SANDI HAWKINS PLAYED PIONEERS

More women of Indian descent preferred federal politics than provincial politics. But Judi Tyabji and Sandi Hawkins were exceptions.

JUDELINE KIM MARY TYABJI, also known as Judi Tyabji, was the first woman of Indian origin to be elected to any legislature in Canada. In 1991, Judi Tyabji was declared successful from the newly created Riding of Okanagan East. Representing Liberals, she defeated a sitting Cabinet Minister and senior NDP leader. She was not only the youngest MLA on record till that time but also the only successful Liberal candidate from the entire interior region of the province. She also had the distinction of being the first legislator to give birth to a child.

Though her first attempt to get into the British Columbia legislature in a byelection from Boundary Similkameen and then re-election in 1996 as a nominee of a party (Progressive Democratic Alliance) she and her second husband Gordon Wilson had floated, were unsuccessful, she remained active on the political front. She subsequently contested municipal elections and won.

Born in Kolkata (then Calcutta) on January 2, 1965, to English and Indian parents, she moved to Canada in mid 70s and graduated from University of Victoria and joined Liberal party. Her father Alan Tyabji was into wine business.

After retiring from politics, she took to writing, broadcasting and print media.

In 1996 when **JUDI TYABJI** failed to get into British Columbia for the second successive time, another woman of Indian descent, Satinder Kaur Ahluwalia, popular

as Sandi Hawkins in provincial politics, was elected on Liberal ticket from Okanagan East. She was re-elected in 2001 in the new riding of Kelowna-Mission, and elected for a third term in 2005.

Before her election to the Legislative Assembly, Ms. Hawkins worked as a registered nurse in general duty, intensive care, management, education and consulting. She set up her own company as a lawyer with an interest in medical-legal issues. She received both her Bachelor of Nursing and her Bachelor of Law degrees from the University of Calgary. Ms. Hawkins had a post-graduate certificate in neuroscience nursing from the Montreal Neurological Hospital. She was recognized as one of the first nurses in Canada to be certified in neuroscience nursing by the Canadian Nurses Association.

A nurse, lawyer and politician, Sindi Hawkins was a warm-hearted woman with a ribald sense of humor who was later diagnosed with leukemia in 2004. Once cancer was detected, she decided not to contest the 2009 elections and died in September 2010 at the age of 52. During her treatment, it was her sister who was the donor twice for bone marrow transfusion.

Hawkins was passionate about high-quality health care and launched her own golf tournament to raise money for cancer. As a result of her public fight with the disease, the B.C. Southern Interior Cancer Centre was renamed the Sindi Ahluwalia Hawkins Cancer Centre.

She ran for the legislature in 1996 and became the first Sikh woman elected in the province's history. She held two ministerial positions, including the head of intergovernmental affairs and minister of health planning. As a member of the cabinet, she fought to increase the number of nurses in B.C. Under her watch, the province expanded medical campuses at the University of Victoria, University of Northern British Columbia and in the University of British Columbia Okanagan.

After Judi Tyabji and Sandi Hawkins, a number of women of Indian descent made a remarkable entry to Provincial politics. In British Columbia, the third woman of Indian origin to make it to the Provincial Parliament was Patty Sahota, also a Liberal.

In Ontario, it was Amrit Mangat who had the distinction of becoming the first Sikh woman to sit in the Provincial Assembly. In Alberta, Leela Aheer was first elected in 2015 and again in 2019. Other women of Indian origin to sit in the Alberta Provincial Assembly are Rakhi Pancholi of NDP and Rajan Sawhney of United Conservative. Rajan Sawhney also happens to be the Minister for Transportation,

She is also the Vice-President of the Sikh Society of Calgary and Director of Guru Nanak Public School.

After Amrit Mangat, a number of South Asian migrant women have been represented in the Ontario Provincial Assembly. They include Dipika Damerla, Indira Naidu Harris, Harinder Malhi, Nina Tangri (Associate Minister in Doug Ford government), Sara Singh, Goldie Ghamari (Parliamentary Assistant), and Doly Begum (from Bangladesh).

In British Columbia, Jinny Jogindera Sims has become the first South Asian migrant to remain Member of Parliament as well as Member of Provincial Parliament and a Cabinet Minister in her province. Rachna Singh, Nikki Sharma and Harwinder Sandhu are among other South Asian migrant women to sit in BC Assembly.

Provinces like Manitoba and Saskatchewan are yet to elect their first South Asian migrant woman MPP or MLA.

Opposition cedes space as Congress in decline

"THE OPPPOSITION SPACE IS SO BADLY FRAGMENTED THAT IT SEEMS INCAPABLE OF REACHING THE CRITICAL MASS NECESSARY TO TAKE ON THE BJP. AT THE HEART OF THE PROBLEM IS THE THINLY-SPREAD-OUT CONGRESS THAT HAS A NOTIONAL PRESENCE ACROSS THE COUNTRY BUT LACKS DEPTH AND GETS QUICKLY UPROOTED. HENCE, IT KEEPS LOSING BASES TO REGIONAL FORCES, SUCH AS THE RECENT LOSS OF PUNJAB TO AAP. ATTEMPTS TO STAY AFLOAT IN THE FACE OF REGIONAL POWERHOUSES HAVE ALSO PRODUCED DISMAL RESULTS AS IN BENGAL AND UP..... RATIONAL THOUGHT DEMANDS THAT THE CONGRESS AND REGIONAL FORCES UNITE. IT NECESSITATES THAT THE CONGRESS PULL ITSELF UP BY ITS BOOTSTRAPS AND TIE UP WITH STRONG REGIONAL PARTIES - RULING OR IN THE OPPOSITION IN THE STATES. BUT THE IRRATIONAL IS HAPPENING. LAST WEEK, RAHUL GANDHI TRAVELED TO TELANGANA, WHERE HE LAUNCHED A SCATHING ATTACK ON CHIEF MINISTER K. CHANDRASHEKAR RAO. KCR, HE TWEETED, HAD SINGLE-HANDEDLY DESTROYED THE DREAM OF THE PEOPLE OF TELANGANA WHEN STATEHOOD WAS GRANTED. HE ALSO SAID THAT TELANGANA WAS NOT RULED BY THE CM BUT BY A 'RAJA'."

It has been a year since two significant states, West Bengal and Tamil Nadu, were won by two big regional parties, the TMC and DMK, even as the Left Front retained Kerala, giving rise to speculation that some kind of national Opposition could be mustered against the BJP in 2024. But a year down the line, after the BJP's recent win in state polls in Uttar Pradesh, Uttarakhand, Goa and Manipur, and the continued disarray in the Congress, the vision of a grand Opposition coalition against the BJP has evaporated. Indeed, one may well say that in 2022, two years before the next General Election, the world's largest democracy is a country without a national Opposition.

This is cause for great concern in Opposition-ruled states: they are owed huge amounts in GST arrears and complain of being deliberately overlooked by the Centre. With inflation skyrocketing, they are coping with increased costs for infrastructure and development schemes even as avenues for raising revenue have shrunk since the roll-out of the GST. While they struggle for funds, both at the party and government levels, the BJP/RSS project of expanding to each part of the country, continues with purpose and is well funded. For instance, the BJP is opening offices in the districts of Tamil Nadu, a state where they have no real presence, yet are investing in the long game.

Opposition states are living through a particularly difficult era as all the niceties of cooperative federalism have been abandoned by the current Central dispensation. The onslaught is pretty ruthless and states not ruled by the national party, complain of being treated as hostile entities with enforcement wings of the Centre routinely used against them. For instance, in Maharashtra, two ministers of the ruling coalition are in jail, while a dozen are being investigated by Central agencies.

As prices soar in India and jobs are not created, in normal times the Opposition should have been emerging with strength and purpose. Instead, political narratives appear to be getting delinked from economic issues. Equally, the Opposition space is so badly fragmented that it seems incapable of reaching the critical mass necessary to take on the BJP. At the heart of the problem is the thinly-spread-out Congress that has a notional national presence across the country but lacks depth and gets quickly uprooted. Hence, it keeps losing bases to regional forces, such as the recent loss of Punjab to AAP. Attempts to stay afloat in the face of regional powerhouses have also produced dismal results, such as getting zero seats in Bengal and one in Uttar Pradesh. And when it comes to Congress vs BJP, even if the Congress wins, the BJP has a high strike rate in

toppling the regimes through defections.

Rational thought demands that the Congress and regional forces unite. It necessitates that the Congress pull itself up by its bootstraps and tie up with strong regional parties - ruling or in the Opposition in the states. But the irrational is happening. Last week, Rahul Gandhi travelled to Telangana, where he launched a scathing attack on Chief Minister K. Chandrashekhar Rao. KCR, he tweeted, had single-handedly destroyed the dream of the people of Telangana when statehood was granted. He also said that Telangana was not ruled by the CM but by a 'Raja'.

It may be recalled that it was the Sonia Gandhi-led Congress that took political decisions that effectively destroyed the party's own bases in erstwhile Andhra Pradesh (the largest chunk of Congress MPs during the decade of UPA rule came from undivided Andhra Pradesh). Central to this success was chief minister YSR Reddy, a pioneer in designing popular welfare schemes (and having links with big business donors). But YSR's death in a plane crash in 2009, led to chaos that in turn resulted in the Congress national leadership taking decisions that in hindsight only finished them off in both Telangana, carved out of the state in 2014, and in Andhra Pradesh where YSR's son Jagan Mohan Reddy, denied power by the Congress, is now in power with his party named YSR Congress.

It's entirely possible that Rahul Gandhi feels compelled to speak up for what remains of his party in those parts; just as he would have been asked to do so by the Congress in Bengal. But surely it is time for the Congress leadership to get a reality check and recognize that 'the party is over' in many parts of India and the only way forward is to make arrangements with regional forces even if that involves giving up on what remains in the debris (the best template actually exists in Tamil Nadu where the Congress is the junior partner in the DMK-led alliance).

The Murky Business of Citations and Proclamations

"AN ELECTED REPRESENTATIVE OF A STATE OR MUNICIPALITY CAN GET A CITATION OR PROCLAMATION FOR A CONTRIBUTION TO HIS/HER ELECTION FUND. THESE REPRESENTATIVES DO NOT HAVE TO UNDERSTAND THE CAUSE, HISTORY OR PURPOSE OR HOW THESE CITATIONS WILL BE USED BY AN INDIVIDUAL OR AN ORGANIZATION IN USA OR IN INDIA."

Indian community organizations and its owners/leaders are quick to grab any opportunity that can bring money to them and undue recognition to a person or event that may not be of any benefit to the community living in USA. The latest fad is getting Citations and Proclamations for individuals including themselves like community service, or to visiting Religious Gurus from India or for celebrations of an event in a state of USA.

For years, a number of India Day Parades are organized in various parts of USA with additions of more joining this rat race. If we take a quick look the only purpose of these Parades is to make a quick name as well as quick money, or monetary favors for the organizers or to dispense monetary favors to the favorite vendors; with the least amount of effort, as well as a chance for them to be close to Bollywood celebrities, local officials and politicians. In nutshell, none of these organizations have anything to do with the rich culture and traditions of India or its 30 states or its religious diversity. All they do is parade themselves, their families, friends, vendors, Bollywood stars, local officials and US politicians in these "Insult India Parades". Some of them being paraded have taken Political Asylum in USA by labeling India as a tormentor state and some are of Pakistani origin.

The other murky business that Indian organizations and its owners/leaders love is conferring "Lifetime Achievement Awards" on individuals for picking up the full or partial tab of the event as w donation to their organization. Basically , this award is given to an individual for taking care of his own business and family!

Yet another manifestation of the murky business for last 3-4 years is getting Citations or Proclamations and it has been spreading very fast in America. An elected Representative of a State or Municipality can get a Citation or Proclamation for a contribution to his/her election fund. These representatives do not have to understand the cause, history or purpose or how these Citations will be used by an individual or an organization in USA or in India. Till 2020 most popular Citation was for a community service to an individual or organization

or for an event organized in honor of a visiting religious Guru from India.

A new chapter on Nov. 28, 2021 was added to this murky business of Citations by Sunil Hali & Nilesh Dasondi the Publisher & CEO of "The Indian Eye" by getting a Citation to the movie maker of The Kashmir Files from Mayor Thomas Lankey of Edison in New Jersey. This duo did the marketing of the film as "Truth Unfold" when in the very first scene of the TKF there is a Disclaimer: "Based on Fiction.". Even if one looked into the background of Vivek Agnihotri the maker of TKF; he has mostly made C-grade erotica and D-grade propaganda films only. He uses the following trick throughout the movie: he lures you with facts - such as the horrific exodus of Kashmiri Pandits - then distorts reality, mocks it, throws around some facts, distorts them, and so on. TKF is nothing but 'hatred, bigotry and untruth made to demonize Muslims & promote radical Hindutva as preached by Modi, BJP, RSS, VHP & other radical organizations. Hindutva has nothing to do with Hinduism.

Not to be left behind, FIA (Federation of Indian Associations) also got a Citation for film maker Agnihotri on Dec 9, 2022 from Rhode Island by using the services of Rep. Brian Kennedy for his yet to be worldwide release film "The Kashmir Files."

Eventually the film was released on March 11, 2022 in India and other countries.

There are 2 more recent examples that these Citations or Proclamations are easily available:

The Consulate has expressed displeasure over the Citation congratulating on Sikh Declaration of Independence. The same Consulate never objected to film maker Agnihotri getting multiple Citations...!!



2. **DARSHAN DAY PROCLAMATION:** Mayor of McKinney City in Texas (USA) gave a Proclamation on the request of Mahesh Chamaria of Hindu Swayamsevak Singh (HSS) aka RSS declaring April 30th, 2022 as "DARSHAN DAY" for Photo Exhibition showing Hindu History...!!



INDIA LOGS 2,858 FRESH COVID-19 CASES IN 24 HOURS; DELHI RECORDS 899 NEW INFECTIONS

NEW DELHI (TIP)

India registered a total of 2,858 new cases in the last 24 hours, marking a 0.6% increase from yesterday. This brings the total caseload to 4,31,19,112.

The top five states which registered the maximum fresh cases are Delhi with 899 cases, followed by Haryana with 439 cases, Kerala with 419 cases, Maharashtra with 263 cases and Uttar Pradesh with 175 cases.

Of the new cases, 76.8% were reported from these five states, with Delhi alone responsible for 31.46% of the new cases. India's active caseload stands at 18,096. In the last 24 hours, the number of active cases has declined by 508.

A total of 11 deaths were reported in the country in the last 24 hours, increasing the total reported death count to 5,24,201.

India's recovery rate now stands at 98.74%. A total of 3,355 patients have recovered in the last 24 hours, which brings the total recoveries to 4,25,76,815 across the country.

India has administered a total of 15,04,734 doses in the last 24 hours, which brings the total tally of doses administered to 1,91,15,90,370. A total of 4,86,628 samples were also tested in the last 24 hours.

Earlier, the Centre for Cellular and Molecular Biology (CCMB) and the Council Of Scientific And Industrial Research (CSIR) developed India's first indigenous mRNA (Messenger RNA) vaccine technology to fight against Covid-19.

NIA arrests Chhota Shakeel's two aides in D-Company case

NEW DELHI (TIP)

The National Investigation Agency (NIA) today said it had arrested two close aides of Pakistan-based gangster Chhota Shakeel for allegedly handling the illegal activities and financial transactions of the crime syndicate controlled by fugitive underworld don Dawood Ibrahim.

The accused, identified as Arif Abubakar Shaikh (59) and Shabbir Abubakar Shaikh (51), were arrested on Thursday, May 12, an agency spokesperson said, adding that the former was arrested from Goregaon West in suburban Mumbai, while the latter was held from Mira Road East in Thane district.

"Both of them were apprehended by a team of the NIA, which is probing the cases against D-Company — Dawood Ibrahim's syndicate," the official said, adding that the duo was closely associated with Shakeel and were involved in the cartel run by Ibrahim.

India bans wheat exports with immediate effect to control rising domestic prices

NEW DELHI (TIP)

India has banned wheat exports with immediate effect as part of measures to control rising domestic prices, according to official notification.

However, the export shipments for which irrevocable letters of credit (LoC) have been issued on or before the date of this notification will be allowed, the Directorate General of Foreign Trade (DGFT) said in a notification dated May 13.

'The export policy of wheat ... is prohibited with immediate effect...', the DGFT said. It also clarified that wheat exports will be allowed on the basis of permission granted by the Government of India to other countries to meet their food security needs and based on the request of their governments.

In a separate notification, the DGFT announced the easing of export conditions for onion seeds.

'The export policy of onion seeds has been put under the restricted category, with immediate effect,' it said.

The export of onion seeds was earlier prohibited.

Official data released this week showed that retail inflation surged to an eight-year high in April due to high prices of fuel and food items.

The ban on exports also comes amid disruption in global wheat supplies due to the ongoing war between Russia and Ukraine which are major exporters of the foodgrain.

India's wheat exports surged to 7 million tonnes, worth USD 2.05 billion, in 2021-22 due to strong global demand. Of



the total wheat exports, around 50 per cent of shipments were exported to Bangladesh in the last fiscal, according to the DGFT data.

The country exported around 963,000 tonnes of wheat this year against 130,000 tonnes in the same period last year.

India was looking to export 10 million tonnes of wheat in 2022-23. The commerce ministry recently stated that India would send trade delegations to nine countries - Morocco, Tunisia, Indonesia, the Philippines, Thailand, Vietnam, Turkey, Algeria and Lebanon - to explore possibilities of boosting wheat shipments. India's wheat purchase have also declined sharply by 44 per cent to 16.2 million tonnes as of May 1 in the current Rabi marketing season due to heavy lifting by private traders and low

arrivals in Punjab and Haryana.

The government had procured 28.8 million tonnes of wheat in the year-ago period. The rabi marketing season runs from April to March. Private players have bought wheat at a price higher than the minimum support price amid increased demand for the grain for export. The Centre has set a target to procure a record 44.4 million tonnes of wheat in the 2022-23 marketing year as against an all-time high of 43.34 million tonnes in the previous marketing year.

Amid lower purchase for the central pool, the Centre has stopped the sale of wheat under the Open Market Sale Scheme (OMSS) to bulk consumers and asked them not to wait for recommencement of the scheme for buying the grain.

Supreme Court refuses to stay delimitation process in J&K

NEW DELHI (TIP)

The Supreme court on Friday refused to stay the ongoing delimitation process in the Union Territory of Jammu and Kashmir.

Two Kashmir residents had challenged the government's decision to constitute a delimitation commission for redrawing the assembly and Lok Sabha constituencies in the Union Territory.

The delimitation panel had recommended increasing the assembly seats from 83 to 90 in the union territory.

A bench of Justices Sanjay Kishan Kaul and MM Sundresh also issued notice to the Centre and Election Commission of India and sought their responses within six weeks and said that the rejoinder affidavit shall be filed in two weeks thereafter.

The court has slated the hearing for August 30.

During the hearing, Justice S K Kaul asked the Senior Advocate Ravi Shankar

Jandhyala who was appearing for the petitioner, as to why the petition had raised issues on abrogation of article 370, which has essentially challenged the delimitation exercise undertaken in J&K pursuant to the notifications of 2020, 2021 and 2022.

Justice Kaul stopped the counsel and said, "Be mindful of the language you use. Kashmir has always been a part of the country! Just a special provision was removed." The bench then noted that the petitioners have not challenged the abrogation of Article 370 of the Constitution and therefore pleadings concerning Article 370 are to be ignored.

The Court also asked Jandhyala as to why he had not challenged the constitution of delimitation that was formed two years ago.

The counsel responded to this by saying that delimitation is a process to be undertaken only by the Election Commission and not by any other body.

PAK-BASED JAISH BEHIND THE KILLING OF KASHMIRI PANDIT RAHUL BHAT

The terrorists belonging to Pak-based and globally proscribed Jaish-e-Mohammad are suspected to be involved in the killing of the Kashmiri Pandit government employee Rahul Bhat in Jammu and Kashmir's Budgam district.

According to intelligence inputs, the Jaish-e-Mohammad group has been desperate to take action against the minority community in order to keep the terror plot boiling. "After the fall of Afghanistan to Islamist Taliban and globally designated Haqqani network the Jaish-e-Mohammad leadership based in Bahawalpur believes that they can also take on the might of Indian security forces," said a senior security official.

While the JeM chief Maulana Masood Azhar runs a terror factory from Bahawalpur, the Pakistan government for the record has told the FATF that the terror kingpin cannot be located and presumably not in Pakistan.

The Jaish-e-Muhammad's desperation can be gauged by the fact that two of its terrorists were neutralised in an encounter with the security forces which had erupted after a search operation in an area adjacent to the Sunjwan military station in Jammu a fortnight ago. One of the terrorists had also worn a suicidal vest and had planned a suicide attack in Jammu, the security forces had said.

Babbar Khalsa, Pakistan's ISI behind Mohali explosion: Police

CHANDIGARH (TIP)

The Punjab Police has arrested five people in connection with the RPG attack at its Mohali office and pointed at the nexus of militant outfit Babbar Khalsa International and Pakistan's spy agency ISI.

Addressing a press conference here on Friday, May 13, Punjab Director General of Police V K Bhawra said a sixth accused is in police custody in a separate case.

The plot behind the incident has been traced and a nexus between militant outfit Babbar Khalsa International and gangsters at the behest of Pakistan's ISI has come to the fore, he said.

The DGP said key conspirator Lakhbir Singh, a resident of Tarn Taran, is a close associate of gangster-turned-terrorist Harvinder Singh Rinda.

Rinda is believed to be in Pakistan.

Bhawra said the five arrested include those who provided shelter, logistic support and the weapon to those who carried out the explosion.

The three people involved in firing the rocket-propelled grenade (RPG) are still wanted, he said. The DGP said Tarn Taran resident Nishan Singh, an

accused in the case, is already under the custody of the Faridkot police in some other case. He will be arrested in this case too, he said. Nishan Singh is facing several criminal cases, including one related to attempt to murder and another under the Narcotic Drugs and Psychotropic Substances Act.

In an audacious attack on Monday, a rocket-propelled grenade was fired at the state police's intelligence wing headquarters in Mohali's Sector 77.

Windowpanes on one of the floors of the building were shattered because of the explosion. No one was injured in the incident.

Supreme Court refuses to stop Varanasi's Gyanvapi Mosque survey

NEW DELHI (TIP)

The Supreme Court on Friday, May 13, declined to immediately stop the survey of Gyanvapi Mosque in Varanasi, saying the matter would have to be considered in due course.

Seeking an urgent intervention from Chief Justice of India (CJI) NV Ramana, senior advocate Huzefa Ahmadi pleaded for a status quo in the case pending before the Varanasi civil court, which on Thursday directed a day-to-day survey of a mosque to inspect, conduct videography and collect evidence regarding the alleged existence of Hindu deities inside the mosque located next to the Kashi Vishwanath Temple.

"A survey has been directed in relation to the Varanasi property. This is covered under the Places of Worship Act. Now, the court has ordered a court commissioner to conduct a survey. This has been a mosque since time immemorial," Ahmadi submitted.

The senior lawyer, who appeared for Anjuman Intezamia Masjid Committee that manages the Gyanvapi mosque, pressed for an order of the status quo.

But the CJI responded: "We have not seen the papers. We don't even know what is the matter. I don't know anything...how can I pass an order. I will read and then pass orders...let me see."

In a suit filed jointly by five Hindu women, the Varanasi court last month ordered an inspection of the premises through advocate commissioner Ajai Kumar Mishra. The civil court order was affirmed by the Allahabad high court on April 26.

The women asked for year-long access to pray at a shrine behind the western wall of the mosque complex. The site is currently

opened for prayers once a year. The women also want permission to pray to other "visible and invisible deities within the old temple complex".

Anjuman Intezamia Masjid Committee filed a plea before the civil court to remove the advocate commissioner. A day ago, the civil court ordered a full survey of the Gyanvapi Mosque complex, rejecting the demands of the mosque management to limit the inquiry to certain parts of the precincts and remove the present surveyor.

The judge retained Mishra as the advocate commissioner, who was appointed last month to carry out the survey while adding two more lawyers, Vishal Singh and Ajay Pratap Singh, to the commission that will inspect, and conduct videography and collect evidence regarding the alleged existence of Hindu deities. It directed Mishra and Vishal Singh to conduct the survey.

Chintan Shivir: Congress moots 'one family, one ticket' formula, but waiver for the Gandhis

UDAIPUR (TIP)

Congress president Sonia Gandhi on Friday, May 13, set the ball rolling for comprehensive organisational overhaul saying the party was in dire need of reforms and extraordinary situations called for extraordinary measures.

Near-consensus has emerged in the party over the adoption of "one family, one ticket" formula, with waivers for leaders with an exceptional track record in an organisational role for at least five years.

The waiver would cover the party's ruling Gandhi family where party chief Sonia Gandhi and son Rahul have both been contesting Lok Sabha elections. Under the waiver, even AICC general secretary Priyanka Gandhi Vadra would have qualified for the ticket by the 2024 General Election. She assumed charge as the UP general secretary in January 2019.

Kick-starting the three-day 'Chintan Shivir' of the party here, Sonia acknowledged serial electoral setbacks and the need for the Congress to change the way it worked, even as she assailed Prime Minister Narendra Modi for "keeping India in a state of permanent polarisation, brutalising minorities and resorting to wholesale reinvention of history".

Sonia's crisp 16-minute speech delivered mixed messages on issues confronting the nation and challenges confronting the Congress.

With G-23 members Ghulam Nabi Azad and Anand Sharma seated in the front alongside Rahul Gandhi, Rajasthan CM Ashok Gehlot and Chhattisgarh CM Bhupesh Baghel, Sonia said cadre unity and collective effort was the only way forward to the party's revival. The Congress chief questioned the PM on economic downslide and non-fulfilment of promises to farmers, calling upon the party to "fight the virus of divisiveness at all costs". But it was the issue of Congress' organisational atrophy that Sonia flagged most deeply, terming it "the most fundamental issue".

"The circumstances our organisation faces today are unprecedented. Such extraordinary situations demand extraordinary measures. Every organisation to live and prosper must reform itself. We are in dire need of reforms-changes in strategy, improvement in the organisation and transformation in the way Congress functions on a daily basis," she said to 422 delegates who were made to pack off cell-phones in hired lockers to prevent leaks to the media, as they proceeded to commence panel discussions at a posh local resort here. 



Pandit Shiv Kumar Sharma: More than just an exponent of Hindustani classical music


It's common to use words such as 'legendary', 'greatest', and 'iconic' to describe the life and times of illustrious artists. In most cases, the tributes are often befitting, and if anything, the words fall short, but how does one find words to summarise a stalwart such as Pandit Shiv Kumar Sharma. One of the all-time greats in every sense of the word, Pandit ji was more than an exponent of Hindustani classical music. His death on 10 May 2022 at 84 from a cardiac arrest — Pandit ji had suffered kidney failure and had been undergoing dialysis for a while — marks not just the end of an exemplary career but also the end of an incredible journey that elevated the santoor.

Born in Jammu on 13 January 1938, Shiv Kumar Sharma's family was instrumental in reviving the santoor's fortunes and popularising it. Pandit ji's father, Uma Dutt Sharma, a renowned vocalist, became obsessed with the santoor, which at the time was mostly associated with Kashmir folk music and an accompaniment to Sufi vocals. He entrusted the young Shiv Kumar Sharma with the mission to make the strains of the santoor be heard across the world.

Like his father, Shiv Kumar Sharma also played the tabla, but it was the santoor that he committed his life to and gave it mainstream recognition and acceptance. Pandit ji made several modifications to the basic santoor — he extended its range to a full three octaves and 'created a smoother glissando to allow the player to sustain and slide between notes in perfect emulation of the 'human voice.' He also developed a style of performing all the ragas and also created 'rhythmic intricacies.'

For a film-crazy nation such as ours, once a musician is associated with film music, much of their 'other' work often remains underappreciated or under-celebrated. Pandit Shiv Kumar Sharma was a rare exception. He composed the background score for a few scenes in V Shantaram's *Jhanak Jhanak Payal Baje* (1955) and soon became one of the most sought-after session players for leading music composers. SD Burman also insisted that Pandit ji play the tabla on Guide's (1965) 'Moh se chhal.' Through the 1960s and 1970s, Pandit ji toured the world and recorded his first solo album *Santoor & Guitar*, with Brij Bhushan Kabra. A few years later, Shiv Kumar Sharma collaborated with the equally illustrious Pandit Hariprasad Chaurasia on the epoch-making *Call of the Valley* (1967), which became platinum. The album remained one of the highest selling Indian classical records of all time and a perennial favourite of several musicians, including Bob Dylan. Three decades later, both Shiv Kumar Sharma and Hariprasad Chaurasia came out with the sequel, *The Valley Recalls — In Search of Peace, Love & Harmony*.

In the 1980s, Pandit Shiv Kumar Sharma and Pandit Hariprasad Chaurasia collaborated to compose film music, starting with Yash Chopra's

Silsila (1981). The two came to be known as 'Shiv-Hari', and ushered in a new chapter in film music in the 1980s, a decade that needed all the inspiration in the world. Pandit Shiv Kumar Sharma's film work might have introduced him to a broader audience, the kind who might not have approached classical music on their own. Still, unlike the norm, Pandit ji did a greater favour to India's popular culture than what it could have possibly offered him.

This was an era where RD Burman, Laxmikant-Pyarelal and Kalyanji Anandji were the first names that came to mind when thinking of film music. Shiv-Hari's compositions in *Silsila* were rooted in classic Indian melody and were blessed with an arrangement style that made it accessible. One would have imagined that Yash Chopra took a significant risk with the two. Younger composers such as Rajesh Roshan were breaking new ground, and the understated Khayyam and Jaidev were in a league of their own. Still, Chopra went ahead with the two, and *Silsila* broke new ground in more ways than expected. For one, it had Javed Akhtar's lyrics, an experiment as good as any, and featured Amitabh Bachchan's vocals on many tracks, but Shiv-Hari merged the best of all worlds to come up with an album that remains one of the best in the history of Hindi films.

Silsila's commercial failure made Shiv-Hari a somewhat 'exclusive' brand. In Hindi films, a film's inability to set the cash registers ringing often leads to the talent associated with it getting blamed. In any case, Shiv-Hari were not the kind of composers that would chase producers, but one wonders if *Silsila* and the subsequent Chopra releases, *Faasle* (1985), a platinum disc in terms of sales, and *Vijay* (1988), the lowest ebb in Yash

Chopra's career, had been triumphant would it have changed the course of Pandit Shiv Kumar Sharma and Pandit Hari Prasad Chaurasia's film works. Their biggest success in films was *Chandni* (1989). This film revived the career of Yash Chopra and also contributed to the revival of melody in film music along with Anand-Milind's *Qayamat Se Qayamat Tak* (1988) and Raam-Laxman's *Maine Pyar Kiya* (1989).

Shiv-Hari composed music for two more Yash Chopra films — *Darr* (1993) and *Parampara* (1993) — both were action-dominated scripts, but the music did exceptionally well. The last film that they collaborated on was *Sahibaan* (1993). While fans of Shiv-Hari might not rate either *Darr* or *Parampara* highly, the two albums had songs that weren't standard Shiv-Hari compositions but completed the bouquet of their film sojourn. *Parampara*'s 'Aadhi raat ko' and the Qawwali 'Mujhe ishq ho gaya' (both penned by Anand Bakshi) are vastly underrated. While *Darr*'s 'Jadu teri nazar' remains eternally popular, thanks to being Shah Rukh Khan's breakthrough, it's the perfect cocktail of melody and an underlying fear in 'Tu mere saamne' (Udit Narayan, Lata Mangeshkar, Anand Bakshi) that speaks volumes about Shiv-Hari.

When one looks back at Pandit Shiv Kumar Sharma's life, one sees how he shall remain an integral part of our conscious memory. What more could an artist ask than his name being synonymous with the instrument he played. A true crossover artist, Pandit ji created a sound that shall remain unparalleled and as unique as one can imagine.

Pandit Shiv Kumar Sharma and Hariprasad Chaurasia began their collaboration under the name Shiv-Hari and recorded their first album titled '*Call Of The Valley*' in 1967. The duo teamed up for around 8 Bollywood movies from 1981-1993. They even bagged four Filmfare Awards in the 'Best Music Director' category for Yash Raj Films' '*Silsila*', '*Chandni*', '*Lamhe*' and '*Darr*'.

Here is a list of the songs composed by the legendary duo Shiv-Hari, that breathed a fresh air into Bollywood music:

Rang Barse Bhige Chunari Wali (*Silsila*)

This lively song infused with the festive fervour gives Holi, the festival of colours, a different meaning altogether. The music perfectly blends with Amitabh Bachchan's masculine voice. This song is still a must on the occasion of Holi.

Tere Mere Hotho Pe... (*Chandni*)

The soulful romantic track featuring late actors Rishi Kapoor and Sridevi in the exotic and picturesque landscape of Switzerland is still one of the favourites for music lovers and die-hard romantics. There could not have been a better rendition of this iconic song.

Mere Haathon Mein Nau-Nau.. (*Chandni*)

Remembered as one of the most iconic songs of late Sridevi, the song is infused with a different energy. Lata Mangeshkar's voice and music by Shiv-Hari is a perfect blend of passion, longing and notoriety.

Jaadu Teri Nazar, Khushbu... (*Darr*)

Marking Shah Rukh Khan's iconic performance in a negative role, the film received equal accolades for its soulful music. The duo Shiv-Hari went on to win the Filmfare Award in the 'Best Music Director' category.

Dekha Ek Khwab To Ye... (*Silsila*)

The film starring Amitabh Bachchan, Rekha, Jaya Bachchan and late Sanjeev Kumar, still remains a blockbuster for its gripping storyline and its iconic music score. The song '*Yeh Kahan Aa Gaye Hum*' still has the power to transport the listener in a valley full of tulips while the song '*Rang Barse*' makes everyone groove. '*Dekha Ek Khwab To Ye Silsile Hue*' is a track that is liked by love-struck couples, even today.

SHERPA WOMAN CLIMBS EVEREST FOR 10TH TIME, BREAKS OWN RECORD

KATHMANDU (TIP): A Nepali Sherpa broke her own record as the most successful female climber of Mount Everest by reaching the summit of the world's highest peak on May 12.

Lakpa Sherpa and several other climbers took advantage of favourable weather to reach the 8,849-meter (29,032-foot) summit early in the morning, her brother and expedition organiser Mingma Gelu said. He said she was in good health and was safely descending from the peak.

Sherpa, 48, never got a chance to get a formal education because she had to start earning a living by carrying climbing gear and supplies for trekkers. Thursday's successful ascent was her 10th — the most times any woman has climbed Everest — and she has always said she wanted to inspire all women so they too can achieve their dreams.

A native of Nepal, Sherpa lives in the US with her three children in West Hartford, Connecticut.

Another Nepalese Sherpa guide, Kami Rita, reached the summit for the 26th time on Saturday, breaking his own record for the most climbs of Everest. Rita led a group of Sherpa climbers who fixed ropes along the route so that hundreds of other climbers and guides can make their way to the top of the mountain later this month.

Hundreds of foreign climbers and an equal number of Sherpa guides are set to attempt climbs of Everest in May, the month when weather conditions in the Himalayan peaks are most favorable for climbing. (AP)

TIBET AIRLINES' PLANE IN CHINA VEERS OFF RUNWAY, CATCHES FIRE; OVER 40 INJURED

BEIJING (TIP): Over 40 people were injured when a passenger plane of China's Tibet Airlines with 122 people on board veered off the runway and caught fire while taking off in the country's southwest Chongqing city on May 12.

All 113 passengers and nine crew members aboard the flight from Chongqing to Nyingchi in the Tibet Autonomous Region had been safely evacuated, Tibet Airlines said.

Over 40 people who sustained minor injuries had been hospitalised, China Global Television Network (CGTN) reported.

Video footage posted by China Central Television (CCTV) showed flames and billowing black smoke from the fuselage of the Tibet Airlines plane on the tarmac at Chongqing Jiangbei international airport, Hong Kong-based South China Morning Post reported. People could be seen running from the plane after escaping via an evacuation slide at the rear door. (PTI)

Imran Khan warns Pakistan government of dire consequences if poll dates are not announced

ISLAMABAD (TIP): Chairman of the Pakistan Tehreek-e-Insaf (PTI), Imran Khan, has warned that if a date for the general elections is not announced, the "sea of people" heading towards Islamabad would be detrimental to the interests of the government, media reports said.

The PTI Chairman has held a series of 'jalsas' in different cities, including Karachi, Mianwali, Lahore and Peshawar, as he rallies his party workers and leaders against the government ahead of the proposed march to Islamabad.

In his address during the Mardan jalsa, Khan said he is calling the people to Islamabad for a "revolution" that seeks "real independence" for Pakistan.

"From here, I am giving a message to the corrupt thugs... and the convict should also hear this: You will not make decisions for the country, but the citizens will decide who will rule Pakistan," Khan said. The PTI Chairman reiterated that the United States had "conspired" against his regime, while the current government's "Mir Sadiq and Mir Jafars" were involved in it.



Khan said when he came to know about the "conspiracy", he went to the "people who could stop it".

"I told them that if this conspiracy succeeds, our economy will falter given its current condition," he said.

The ex-Prime Minister said he asked former Finance Minister Shaukat Tarin to tell those who "call themselves

neutral" that the economy will collapse, but unfortunately, they did not do anything.

"The dollar is nearing Rs 200, the stock market is plunging, everything is becoming expensive... the media should ask the people how expensive things are as they would do during our government," Khan said. IANS

Ranil Wickremesinghe returns as Lankan PM

COLOMBO (TIP): Opposition leader and former premier Ranil Wickremesinghe was sworn-in as Sri Lanka's 26th Prime Minister on May 12, days after his predecessor Mahinda Rajapaksa was forced to resign following violent protests over the worst economic crisis in the debt-ridden island nation.

The 73-year-old United National Party (UNP) leader took oath before President Gotabaya Rajapaksa at a ceremony in the President's office after they held closed-door discussions over formation of a new government to address the economic crisis.

"My best wishes to the newly appointed PM, who stepped up to take on the challenging task of steering our country through a very turbulent time. I look forward to working with him to make Sri Lanka strong again," President Gotabaya tweeted along with a picture of him and Wickremesinghe.

Sri Lanka was without a government since Monday when Gotabaya's elder brother and former Prime Minister Mahinda Rajapaksa resigned after violence erupted following an attack on the anti-government protesters by his supporters. The attack triggered widespread violence against Rajapaksa loyalists, leaving nine dead.

Mahinda quickly tweeted a congratulatory message to



Wickremesinghe. He is under protection at a naval base following violent attacks on his aides.

Members of the ruling Sri Lanka Podujana Peramuna (SLPP) and some from the main Opposition Samagi Jana Balawegaya (SJB) and several other parties said they would back Wickremesinghe in Parliament, according to reports.

However, several factions opposed the move to appoint Wickremesinghe as the new Prime Minister. — TNS/PTI

SRI LANKA OPPOSITION, PROTESTERS VOW TO CONTINUE ANTI-GOVERNMENT CAMPAIGN

COLOMBO (TIP): Sri Lanka's main opposition party joined anti-government protesters on May 13 in rejecting the appointment of a new prime minister, and insisted the president resign because of the country's disastrous economic crisis.

President Gotabaya Rajapaksa appointed veteran opposition politician Ranil Wickremesinghe as prime minister late on Thursday, but the comments signalled it was not likely to resolve the political and economic disarray in the strategic Indian Ocean island nation.

A week of violent clashes between protesters and government supporters across the country has left 9 people dead and over 300 injured. The president's elder brother, Mahinda Rajapaksa, quit as prime minister on Monday as violence spiralled and is in hiding in a military base.

The rest of the cabinet had quit earlier.

"It is clear the (new) prime minister is remote controlled by the president," said Eran Wickramaratne, a parliamentarian and senior member of the main opposition party, the Samagi Jana Balawegaya. "This country wants the Rajapaksas to go home. We are committed to that goal."




Ranveer Singh calls Jayeshbhai Jordaar as an estrogen film

Principal photography on the film is scheduled to begin this summer, with the untitled movie set for a March 31, 2023, theatrical release.

The sixth Scream movie will be helmed by the filmmaking team behind the fifth installment. Radio Silence's Matt Bettinelli-Olpin and Tyler Gillett will direct, while James Vanderbilt and Guy Busick will co-write the screenplay.

Paul Neinstein, William Sherak and Vanderbilt will serve as producers on the new project, with original Scream screenwriter Kevin Williamson and Chad Villella executive producing alongside Spyglass' Gary Barber and Peter Oillataguerre, Ron Lynch, Cathy Konrad and Marianna Maddalena.

Panettiere is best known for starring in the NBC series Heroes and films like Remember The Titans and Custody.

RUSSIA-UKRAINE WAR: INDIAN EMBASSY TO RESUME OPERATIONS IN KYIV FROM MAY 17

KYIV (TIP): India on May 13 announced that its embassy in Ukraine would resume its operation from the Ukrainian capital Kyiv from May 17.

The embassy was temporarily operating from Warsaw in Poland since mid-March.

"The Indian Embassy in Ukraine, which was temporarily operating out of Warsaw (Poland), would be resuming its operation in Kyiv with effect from May 17," the Ministry of External Affairs said.

It said the embassy was temporarily relocated to Warsaw on March 13.

The decision to resume operation of the embassy from Kyiv came amid decisions by several Western powers to reopen their missions in the Ukrainian capital.

India had decided to temporarily relocate the embassy to Poland in view of the rapidly deteriorating security situation in the war-torn country, including the Russian military offensive around Kyiv.

India relocated the embassy after bringing back over 20,000 of its nationals from across Ukraine under its evacuation mission 'Operation Ganga' that was launched on February 26 in the wake of the war in Ukraine. (PTI)

RUSSIAN SPY BOSS COMPARES US TO GERMAN NAZI PROPAGANDA MACHINE

MARIUPOL, UKRAINE (TIP): A Russian spy chief on May 11 compared the US State Department to the World War II Nazi propaganda machine constructed by Joseph Goebbels, saying Washington had launched an anti-Russia messaging campaign across social media.

Sergei Naryshkin, head of Russia's foreign intelligence agency (SVR), said the United States was encouraging the spreading of fake information on the popular Telegram messaging service in an attempt to "discredit" and "dehumanise Russia's political and military leadership in the eyes of the Russian people".

"Their actions have a lot in common with the traditions of the Third Reich's ministry of public education and propaganda and its head Joseph Goebbels," Naryshkin said in a statement published on the SVR website.

Naryshkin provided no evidence to support the claims of a US-backed information campaign. Russia regularly accuses the West of funding and supporting anti-Kremlin movements and has labelled dozens of independent human rights groups and media outlets in Russia "foreign agents" over recent years. (Reuters)

Ukraine accuses Russia of forcibly deporting over 2 lakh children

KYIV (TIP): Ukraine said on May 13 Russia had forcibly deported more than 210,000 children since its invasion on Feb. 24 and accused Moscow of wanting to make them Russian citizens.

Human rights ombudswoman Lyudmyla Denisova said the children were among 1.2 million Ukrainians who Kyiv says have been deported against their will.

Reuters could not independently verify the figure given by Denisova or her allegations, for which she did not provide supporting evidence.

The Kremlin did not immediately respond to a Reuters request for comment on Denisova's allegations concerning the deportation of large numbers of children and other Ukrainian nationals.

Moscow has denied intentionally targeting civilians since launching what it calls a special military operation in Ukraine and says it is offering humanitarian aid to those who want to leave Russia.

"When our children are taken out, they destroy the national identity, deprive our country of the future,"



Denisova said on national television.

"They teach our children there, in Russian, the history that (Russian President Vladimir) Putin has told everyone." Russia has referred to "refugees" coming to Russia to escape fighting, particularly from the southern Ukrainian city of Mariupol, which is in Russian hands after weeks

of siege and bombardment.

The 1949 Geneva Conventions, which define international legal standards for humanitarian treatment in conflict, prohibit mass forcible transfers of civilians during a conflict to the territory of the occupying power, classifying it as a war crime. Reuters

Ukraine pushes Russian forces back, restricts gas flow to Europe

KYIV/VILHIVKA (TIP): Ukrainian forces reported battlefield gains on May 11 in a counterattack that could signal a shift in the momentum of the war, while Kyiv shut gas flows on a route through Russian-held territory, raising the spectre of an energy crisis in Europe.

Following days of advances north and east of the second largest city Kharkiv, Ukrainian forces were within just several kilometres of the Russian border on Wednesday morning, one Ukrainian military source said on condition of anonymity. Before the advance, Russian forces had been on the outskirts of Kharkiv, 40 km (25 miles) from the border.

The gains appear to be the fastest that Ukraine has achieved since it drove Russian troops away from Kyiv and out of the country's north at the beginning of April. If sustained, it could let Ukrainian forces threaten supply lines for Russia's main attack force, and even put rear logistics targets within Russia itself within striking range of Ukrainian artillery.

In Vilhivka, a village east of Kharkiv held by Ukrainian forces, the thump of near constant artillery and swoosh of multiple rocket launchers could be heard from fighting at the front, now pushed substantially further east, where Ukraine has been trying to capture villages on the



banks of the Donets river and threaten Russian supply lines on the far side.

Further east, Ukrainian forces seemed to be in control of the village of Rubizhne, on the banks of the Donets.

"It is burned out, just like all Russian tanks," a Ukrainian soldier told Reuters near Rubizhne next to the ruins of one Russian tank. "The weapons are helping a lot, the anti-tank ones."

KHARKIV ADVANCE

Kyiv has so far confirmed few details about its advance through the Kharkiv region, maintaining secrecy about the positions of its own forces near the

frontline while speaking in general terms about overall gains.

"We are having successes in the Kharkiv direction, where we are steadily pushing back the enemy and liberating population centres," Brigadier General Oleksiy Hromov, Deputy Chief of the Main Operations Directorate of Ukraine's General Staff told a briefing, providing no specifics.

President Volodymyr Zelenskiy said successes were putting Ukraine's second largest city - under constant bombardment since the war's early days - beyond the range of Russian artillery. (Reuters)

Kim Jong-un's lookalike disrupts Australian election campaign; extends support to Gladys Liu, the candidate opposite PM Morrison

SYDNEY (TIP): A man impersonating North Korean leader Kim Jong-un on May 13 disrupted the Australian election campaign when he burst into an event that Prime Minister Scott Morrison was attending with lawmaker Gladys Liu.

The impersonator, who later identified himself by the stage name Howard X, started talking to the gathered media.

"Thank you very much. Gladys Liu is the communist candidate for Australia," he said, before he was interrupted by an aide to Morrison.

"Excuse me, you are going to have to leave. This is the most offensive thing I have ever seen in a campaign," said the aide, Nick Creevey.

The impersonator responded: "Excuse me, you don't tell the supreme leader what to do. I support Gladys Liu." The impersonator left the Melbourne venue soon after.

In a statement to The Associated Press, Liu said she was focused on delivering outcomes for the Melbourne communities she represents.

"I will not be distracted by my opponents and their grubby tactics," she



said.

The disruption appeared to have been orchestrated in part by longshot Queensland State senate candidate Drew Pavlou, who said on social media that he was good friends with Howard X and it was "one of the best things we have ever

managed." Pavlou had earlier claimed in posts that Liu had defended China's leadership and had ties to the regime. Pavlou described himself as a "young larrikin" who thought the election was boring and needed more excitement.

During the event at Extel

Technologies in Melbourne, Morrison praised Chinese Australians.

"I talk about the assertive and aggressive nature of the Chinese government, not the Chinese people," Morrison said. "You know, Chinese Australians are the greatest patriots you could hope for in this country."

The disruption came at a time of heightened tensions between Australia and China, most recently over a security pact that China signed with the Solomon Islands.

Howard X is well-known for his impersonation of Kim Jong-un. In 2018, he was detained and questioned when he arrived in Singapore days before a summit between the North Korean leader and former US president Donald Trump. His real name is Lee Howard Ho Wun.

Media reported the impersonator was being interviewed by police on Friday.

Australia's election will be held on May 21 and early voting began this week. Opinion polls have the centre-left opposition Labour Party tracking ahead of Morrison's conservative coalition. (AP)

North Korea reports first Covid-19 outbreak, orders lockdown in 'gravest emergency'

SEOUL (TIP): North Korea confirmed its first COVID-19 outbreak on May 12, calling it the "gravest national emergency" and ordering a national lockdown, with state media reporting an Omicron variant had been detected in Pyongyang.

The first public admission of COVID infections highlights the potential for a major crisis in a country that has refused international help with vaccinations and kept its borders shut.

As of March, no cases of COVID-19 have been reported, according to the World Health Organization, and there is no official record of any North Koreans having been vaccinated.

"A most serious emergency case of the state occurred: A break was made on our emergency epidemic prevention front where has firmly defended for two years and three months from February 2020," official KCNA news agency said.

Samples taken on May 8 from people in Pyongyang who were experiencing fevers showed a sub-variant of the Omicron virus, also known as BA.2, the report said,

without providing details on case numbers or possible sources of infection.

The report was published after North Korean leader Kim Jong Un led a Workers' Party meeting on Thursday to discuss responses to the outbreak.

Kim ordered all cities and counties of the country to "strictly lock down" their regions to prevent the spread of the coronavirus and said emergency reserve medical supplies would be mobilised, according to KCNA.

"The state epidemic prevention work shall be switched over to the maximum emergency epidemic prevention system," KCNA said.

Although the North has never before confirmed a single coronavirus infection in the country, officials in South Korea and the United States have doubted that the country is COVID-free, as cases of the Omicron variant were widely reported in neighbouring South Korea and China.

The isolated North has enforced strict quarantine measures, including border lockdowns, since the pandemic began in early 2020. In July that year, Kim declared an

emergency and imposed a lockdown on Kaesong, near the inter-Korean border, for three weeks after a man who defected to the South in 2017 returned to the city showing coronavirus symptoms.

According to the latest data from the World Health Organization (WHO), 64,207 of North Korea's more than 24.7 million people received COVID-19 testing; all had been found negative as of March 31.

North Korea has declined shipments of vaccine from the COVAX global COVID-19 vaccine-sharing programme and the Sinovac Biotech vaccine from China, suggesting no civilians may have been vaccinated.

South Korea's presidential office told Reuters that President Yoon Suk-yeol, who was sworn in on May 10, will not link humanitarian aid to the political situation, opening the door to providing support to the North.

The news of the outbreak comes amid reports of preparations for an imminent nuclear test by the North, which has also aggressively pursued a ballistic missile programme, according to US and South Korean officials. (Reuters)

CHINESE FINDINGS ON MARS SUGGEST WATER EXISTED FOR LONGER ON PLANET'S SURFACE

BEIJING (TIP): Hydrated minerals discovered by China's robotic rover on Mars in a vast basin believed to be the site of an ancient ocean suggest water was present on the planet's surface for longer than previously thought, said Chinese scientists.

According to an analysis of data sent back by the rover, Zhurong, signs of water were detected in sampled minerals from just 700 million years ago, the scientists said in a paper published on May 11 in the journal *Science Advances*.

Mars is believed to have been wet until about 3 billion years ago, when the planet's second geological age, known as the Hesperian Epoch, ended. In the current Amazonian period, there is no surface water.

The soil containing the minerals Zhurong sampled had a hard crust that could have been formed by rising ground water or melted ice that had since evaporated, the Chinese scientists wrote.

The Chinese rover has been exploring the vast plain of Utopia Planitia since its landing on the planet in May last year. Zhurong has travelled about 2 kilometres from its landing site as it gathers data on the terrain.

In recent years, data from an orbiting probe operated by the European Space Agency had discovered water under the ice of the planet's south pole.

Almost all of the water on Mars is locked in its polar ice caps, with very small traces in the planet's thin atmosphere.

Locating subsurface water is key to determining the planet's potential for life, as well as providing a permanent resource for any human exploration. (Reuters)

HRWFF RETURNS WITH 33RD EDITION

The Human Rights Watch Film Festival (HRWFF), now in its 33rd year, will present a hybrid full edition of 10 groundbreaking new films, available both in-person and online nationwide in the U.S., from May 20 to 26, 2022.

For the first time in two years, the New York festival will be back with a full program of in-person screenings at Film at Lincoln Center and IFC Center, with in-depth discussions with filmmakers, film participants, activists and Human Rights Watch researchers. The festival will continue to offer the opportunity to watch all 10 new films online across the U.S. with a full digital edition of the film festival.

This year's edition highlights activism and features courageous individuals around the world standing up to powerful forces and demanding change. John Biaggi,

Director of the Human Rights Watch Film Festival, said, "We are thrilled to be back in theaters after two years away, bringing our audience a full slate of powerful films tackling urgent human rights issues including China, Russia, the climate crisis and reproductive rights."

Herbal pastes, oil massages to color hair

Here are a few homemade pastes and mixes that you can use to naturally colour your hair. Natural colouring causes less damage to the hair say experts. Skin care expert Vasundhra Ravi suggests a few oil massages and herbal mixes to darken your hair. "They will not darken your hair like a chemical mix, but they will colour your hair and help keep it healthy," she says.

HOMEMADE OIL

Take 50ml coconut oil, 50ml gingelly oil and 50ml olive oil. Mix all these and heat on low flame. In kadai, spurt 10gm mustard, 20gm curry leaves, 20gm dry amla and 20 henna leaves. Saute till they are almost dry. Now, add the oil and heat this mixture for another 10 minutes. Store it in an airtight bottle and keep it in direct sunlight for four days. Let the ingredients settle at the base. Now, use this oil and massage your scalp and hair every day. This oil helps darken your greying hair.

HENNA PASTE

Make a paste out of henna and apply over the hair for two hours and rinse. After a few hours, mix 100g of indigo (auri) powder with warm water and make a paste. Apply this paste all over the hair. Leave it on for 45 minutes and rinse. You will be surprised to see that your grey hair has turned black to an extent. Apply this paste once a week.

HAIR PACK

Make your own hair darkening



pack by mixing the following together: henna leaves 50gm, aloe vera gel 20ml, haritaki or kadukkai skin 5gm, fresh seedless amla 20gm. Grind all the above to a smooth paste, add the juice of half a lemon to this mixture and apply on the hair. Apply 10ml olive oil on hair prior to applying this pack. Leave on for 20 minutes and rinse to get a reddish-brown tint to your hair.

OLIVE OIL MASSAGE

Olive oil is an excellent hair darkener. Slightly warm 20ml of olive oil and apply it on the scalp and give a gentle massage for eight minutes. Leave it on for one hour. Wash with homemade shikakai. Apply this twice a week to get back your beautiful dark hair.

HENNA-AMLA-KADUKAI PASTE

Take henna powder 200gm, amla powder 25gm, kadukai powder 10gm, tulsi powder 10gm, tea decoction 100ml, eucalyptus oil 2ml, curd 100ml, lemon juice 10 drops, and olive oil 2tsp. Mix all the ingredients in an iron vessel and

soak overnight. Next morning, apply this mixture on the scalp and hair. Leave it on for two hours, and rinse. Do not apply shampoo while washing the hair. This paste gives a beautiful maroon tint to your hair. It also prevents further greying.

TO GET NATURAL BURGUNDY TINT

Henna leaves 100gm, beetroot one (small), aloe vera 100gm and multani mitti 2tsp. Make a hair pack by blending henna leaves, beet root and aloe vera. Mix some multani mitti to the mixture. Apply this on your hair and leave it on for one hour. This paste gives a burgundy tint to hair.

PREPARE PREMATURE GREYING

Take a handful of curry leaves, hibiscus leaves, karisalai leaves, coriander leaves and grind them together into a smooth paste. Add five drops of lemon juice to this paste. Apply on the scalp and the hair. Leave it on for an hour and then wash. Apply this paste once a week. Regular application of this pack can darken existing grey hair and it also prevents premature greying.

FOOD

Lamb Kofta

Ingredients:

Minced lamb - 250 gms, Breadcrumbs - 1/2 cup, Onion - 1, small, finely chopped, Egg - 1, beaten

Mint leaves - handful, finely chopped, Coriander leaves - handful, finely chopped, Cinnamon powder - 1 tsp, Cardamom powder - 1 tsp, Cumin powder - 1 tsp, Red chilli powder - 1/2 tsp, Turmeric powder - 1 tsp, Salt as per taste

Black pepper powder as per taste, Wooden skewers - few, soaked in cold water for 30 minutes, Olive oil - little, Optional ingredients: Ginger garlic aste - 1 tsp, Red chilli flakes - 1/4 tsp

Method:

- Combine the minced lamb and breadcrumbs in a bowl.
- Mix well.
- 3. Add the onions, mint leaves, coriander leaves, cinnamon powder, cardamom powder, cumin powder, red chilli powder and turmeric powder.
- Sprinkle some salt and pepper powder.
- Mix well.
- Add the egg and mix again until all ingredients are evenly combined.
- Make small balls of the mixture and insert a skewer into the center.
- Gently press the mixture around the skewer and keep aside.
- Heat a grill pan over medium flame.
- Add some olive oil and grill the prepared koftas until golden brown on all sides.
- Remove and serve with naan/parathas and lemon wedges.



Comparing partner could make or break your relationship



Your happiness in a relationship and how much energy you devote to maintaining that relationship depend on how your partner compares with other potential mates you may have, suggests new research.

The findings suggest that how well our partner fulfills our ideal preference is not very important.

"We do not need ideal partners for relationship bliss. Instead, satisfaction appears to come, in part, from getting the best partner available to us," said one of the researchers Daniel Conroy-Beam from the University of Texas at Austin in the US.

For the study — published in the journal Evolution and Human Behavior — the researchers surveyed 259 adults — 119 men and 140 women — who had been in relationships for an average of seven and a half years. Each participant rated the importance of 27 traits in an ideal mate and the extent to which they felt each trait described both their actual partner and themselves. Participants also reported their relationship satisfaction and happiness.

The study discovered that satisfaction was not reliably dependent on how a partner

compared with a person's idea of the perfect mate, but rather whether other potential mates better matched a person's ideal preferences. Those with partners more desirable than themselves were satisfied whether or not their partners matched their ideal preferences. But, participants with partners less desirable than themselves were happy with their relationship only if their partner fulfilled their ideal preferences better than most other potential mates in the group, Conroy-Beam said.

In a follow-up study, the researchers again tested relationship satisfaction but also surveyed participants' mate retention efforts — energy devoted to maintaining their relationships.

They found that people with partners difficult to replace, either because their partner was more desirable than themselves or their partner more closely matched their ideal preferences than others in the group, reported being happier and devoted more effort to mate retention. This included making themselves extra attractive for their partners and "mate guarding" — or shielding their partners from mating rivals to help keep their partners — Conroy-Beam said.

Stress may contribute to fertility issues in women: Study

Stress may directly impact female fertility and ovarian reserve -- the number and quality of eggs they produce, according to a small study conducted in mice.

Exposing female rats to scream sounds, researchers noted a decrease in estrogen and anti-mullerian hormone levels, which are vital for fertility.

Stress also reduced the number and quality of eggs, resulting in smaller litters, they said.

The findings, published in the journal Endocrinology, shed light on the role stress may play in female reproduction.

"We examined the effect of stress on ovarian reserve using a scream sound model in rats," said Wenyan Xi, from the Second Affiliated Hospital of Xi'an JiaoTong University in Xian, China.

"We found that female rats exposed to the scream sound had diminished ovarian reserve and decreased fertility," Xi said.

Ovarian reserve is the reproductive potential left within a female's ovaries based on the number and quality of eggs.

A female is born with a finite number of eggs and her body cannot create any more, the researchers said.

Diminished ovarian reserve is the loss of normal reproductive potential in the ovaries due to a lower count or quality of the remaining eggs, they said.

The researchers used a scream sound model to investigate the effect of stress on ovarian reserve in female rats.

They exposed female rats to a scream sound for three weeks and analysed the effect on their sex hormones, the number and quality of their eggs and their ability to get pregnant and have babies after mating.

They found the scream sound decreased the rats' estrogen and anti-mullerian hormone levels.

Estrogen is a group of hormones that play an important role in growth and reproductive development, and anti-mullerian hormone is made by the ovaries and helps form reproductive organs.

The scream sound also lowered the number and




quality of the women's eggs and resulted in smaller litters, according to the researchers.

"Based on these findings, we suggest stress may be associated with diminished ovarian reserve," Xi said.

"It is important to determine an association between chronic stress and ovarian reserve because doing so may expand our appreciation of the limitations of current clinical interventions and provide valuable insight into the cause of diminished ovarian reserve," the scientist added.

New drug that halts recurring brain tumour growth identified

An international team of scientists has identified a drug that blocks growth of the most aggressive brain tumour and how to most accurately identify which tumour will respond to the drug.

When a non-metastatic brain tumour - Meningioma - recurs after surgery and radiation treatment, a patient is out of options. No drugs are approved for these aggressive tumours, which occur in up to 20 per cent of cases and can lead to patient disability or even death.

But the new drug called abemaciclib, detailed in the journal Nature Genetics, is a cell cycle inhibitor, meaning it blocks the cell division cycle and inhibits tumour growth.

The scientists at universities of North-western, California, and Hong Kong demonstrated the effectiveness of the drug in select patients, mouse models, a 3D living tissue brain tumour (organoids) and cell cultures.

Investigators discovered that Meningiomas can be divided into molecular subgroups with different clinical outcomes and recurrence rates. This new method of classifying tumours allows scientists to predict recurrence more accurately than the current method of classifying the tumour.

Currently, after surgery, doctors examine a specimen of a tumour under a microscope and grade it one, two or three in its aggressiveness. But the grade is only about 70 per cent accurate, meaning some tumours will behave in a way that doesn't fit with how it appears under the microscope.

"Our study identifies which patients we should treat with this drug, because their tumours will likely respond to it," said Dr Stephen Magill, Assistant Professor of neurological surgery at North-western's Feinberg School of Medicine.

"We now have the potential to give them options and hope for a longer, symptom-free life." The team found that mice with Meningiomas treated with the medication lived longer and their tumours didn't grow as rapidly.

Google is mocking Apple by dropping headphone jack in Pixel 6a

Google which took a dig at Apple for removing the 3.5 mm headphone jack has now announced to ditch the jack in its new device -- Pixel 6a.

Google even created a two-minute ad celebrating the headphone jack in the Pixel 5A that parodied Apple's elaborate design videos.

That video was titled, in part, "The Circle Comes Full Circle".

Google announced the new Pixel 6a during its I/O 2022 developer conference.

Nearly all smartphone manufacturers have moved on from the headphone jack which is a trend largely kicked off by Apple with the iPhone 7 in 2016.

Google is the latest tech company to abandon the headphone port in its next smartphone.

The company may wish to make a more convincing case to sell users wireless headphones, as it revealed the new Pixel Buds Pro at its event that can be pre-ordered for \$199 in select countries from July 21.

The wireless earbuds come with Active Noise Cancellation (ANC) with a custom 6-core audio chip that runs Google-developed algorithms and custom speakers. "Built-in sensors will measure the pressure in your ear canal to make sure you're comfortable even during long listening sessions," said the company. Later this year, Pixel Buds Pro will also support spatial audio.


Astronomers capture 1st image of Milky Way's huge black hole

The world got a look on Thursday, May 12, at the first wild but fuzzy image of the supermassive black hole at the centre of our own Milky Way galaxy.

Astronomers believe nearly all galaxies, including our own, have these giant black holes at their centre, where light and matter cannot escape, making it extremely hard to get images of them. Light gets chaotically bent and twisted around by gravity as it gets sucked into the abyss along with superheated gas and dust.

The colorised image unveiled Thursday is from the international consortium behind the Event Horizon Telescope, a collection of eight synchronised radio telescopes around the world. Previous efforts had found the black hole in the centre of our galaxy too jumpy to get a good picture.

The University of Arizona's Feryal Ozel called the black hole "the gentle giant in the center of our galaxy" while announcing the new image. (Event Horizon Telescope Collaboration via AP)

The Milky Way black hole is called Sagittarius A(asterisk), near the border of Sagittarius and Scorpius constellations. It is 4 million times more massive than our sun.

This is not the first black hole image. The same group released the first one in 2019 and it was from a galaxy 53 million light-years away. The Milky Way black hole is much closer, about 27,000 light-years away. A light year is 5.9 trillion miles (9.5 trillion kilometres).

The project cost nearly \$60 million with \$28 million coming from the US National Science Foundation.

Google's new 10-shade skin tone scale to boost inclusivity, cut AI bias

Tech giant Google has launched a novel 10-shade skin tone that will be incorporated into its products over the coming months to boost inclusivity and to reduce Artificial Intelligence (AI) bias.

In a blogpost on Wednesday, Google said it designed the Monk Skin Tone (MST) scale, in partnership with Harvard professor and sociologist Dr. Ellis Monk, to make it easy-to-use for development and evaluation of technology while representing a broader range of skin tones.

Skin tone plays a key role in how people experience and are treated in the world, and even factors into how they interact with technologies. Studies have shown that products built using AI and Machine Learning (ML) technologies can perpetuate unfair biases and not work well for people with darker skin tones.

"We're openly releasing the scale so anyone can use it for research and product development. Our goal is for the scale to support inclusive products and research across the industry - we see this as a chance to share, learn and evolve our work with the help of others," Tulsee Doshi, Head of Product for Responsible AI and Product Inclusion in Search, in a blogpost on Wednesday.

"Updating our approach to skin tone can help us better understand representation in imagery, as well as evaluate whether a product or feature works well across a range of skin tones," Doshi said.

The feature could especially be important for computer vision, a type of AI that allows computers to see and understand images. When not built and tested intentionally to include a broad range of skin-tones, computer vision systems have been found to not perform as well for people with darker skin.



"The MST Scale will help us and the tech industry at large build more representative datasets so we can train and evaluate AI models for fairness, resulting in features and products that work better for everyone - of all skin tones," Doshi said.

Every day, millions of people search the web expecting to find images that reflect their specific needs. For example, when people search for makeup related queries in Google Images, one can see an option to further refine results by skin tone.

"In our research, we found that a lot of the time people feel they're lumped into racial categories, but there's all this heterogeneity with ethnic and racial categories," Dr Monk said.

"And many methods of categorisation, including past skin tone scales, don't pay attention to this diversity. That's where a lack of representation can happen. We need to fine-tune the way we measure things, so people feel represented," he added.

Scientists grow plant in lunar soil, raise hopes of growing plants on Moon

That's one small pot of soil, one giant leap for man's knowledge of space agriculture: scientists have for the first time grown plants in lunar soil brought back by astronauts in the Apollo program. The ground-breaking experiment, detailed in the journal Communications Biology on Thursday, has given researchers hope that it may be possible to one day grow plants directly on the Moon.

That would save future space missions much hassle and expense, facilitating longer and farther trips.

However, according to the study's University of Florida authors, much remains to be studied on the topic, and they intend to leave no stone unturned.

"This research is critical to NASA's long-term human exploration goals," said Bill Nelson, the head of the US space agency. "We'll need to use resources found on the Moon and Mars to develop food sources for future astronauts living and operating in deep space."

For their experiment, the researchers used just 12 grams (a few teaspoons) of lunar soil collected from various spots on the Moon during the Apollo 11, 12, and 17 missions.

In tiny thimble-sized pots, they placed about a gram of soil (called "regolith") and added water, then the seeds. They also fed the plants a nutrient solution every day. The researchers chose to plant arabidopsis thaliana, a relative of mustard greens, because it grows easily and, most importantly, has been studied extensively. Its genetic code and responses to hostile environments -- even in space -- are well known. As a control group, seeds were also planted in soil from Earth as well as samples imitating lunar and Martian soil. The result: after two days, everything sprouted, including the lunar samples.

"Every plant -- whether in a lunar sample or in a control -- looked the same up until about day six," Anna-Lisa Paul, lead author of the paper, said in a statement.

TESLA PUTS INDIA ENTRY PLAN ON HOLD AFTER DEADLOCK ON TARIFFS

Tesla Inc has put on hold plans to sell electric cars in India, abandoned a search for showroom space and reassigned some of its domestic team after failing to secure lower import taxes, three people familiar with the matter said.

The decision caps more than a year of deadlocked talks with government representatives as Tesla sought to first test demand by selling electric vehicles (EVs) imported from production hubs in the US and China, at lower tariffs.

But the Indian government is pushing Tesla to commit to manufacturing locally before it will lower tariffs, which can run as high as 100% on imported vehicles.

Tesla had set itself a deadline of February 1 to see if its lobbying brought a result, the sources with knowledge of the company's plan said.

When Narendra Modi's government did not offer a concession, Tesla put on hold the plans to import cars into India, added the sources, who sought anonymity because the deliberations were private.

MUKESH AMBANI, BRITAIN'S ISSA BROTHERS FACE OFF IN FINAL BATTLE FOR BOOTS

Britain's billionaire Issa brothers and Indian tycoon Mukesh Ambani are preparing to face off in the final battle for the Boots drugstore chain, one of the UK high street's most recognizable names.

The Issas are seen as the party to beat ahead of next week's deadline for proposals, after they submitted the highest offer in the first round, people with knowledge of the matter said. The duo are going up against Ambani, who's been working on a bid together with buyout firm Apollo Global Management Inc.

Bidders are now sizing up Boots' billions in pension guarantees -- which they'll have to take on -- as they figure out how much they can pay for the business, the people said. They're also working around the clock to arrange financing in a difficult market, which has gotten that much tougher due to the war in Ukraine, soaring inflation and rising interest rates, according to the people.

That's a lot to sort through, and suitors are getting a few extra days to firm their bids up after the chain's owner Walgreens Boots Alliance Inc. pushed back the May 16 deadline to later in the week, the people said.

India's consumer inflation at 8-yr high of 7.79% may 'trigger' quicker rate hikes

NEW DELHI (TIP)

Sounding a red alert on India's CPI inflation at an 8-year high print of 7.79% YoY in April, Acuite Ratings has said it may trigger quicker rate hikes.

"If inflation pressures continue to mount there is a likelihood of additional hikes thereby taking the rate to its pre-pandemic level of 5.15 per cent or even higher in FY23. Additionally, we also expect CRR to be hiked by another 50 bps by H1FY23," Acuite Ratings said.

Given the tone of urgency in RBI's statement to support the altered inflation-growth dynamics, "we now revise our call and expect the RBI to hike repo rate by an additional 60 bps in the rest of FY23".

The increasing price pressures was in motion even before the onslaught of the geopolitical conflicts. However, lingering war between Russia and Ukraine, unprecedented level of sanctions, elevated oil and commodity prices along with prolonged supply chain disruptions have escalated the inflationary concerns both in the global as well as domestic economies, it said.

Globally most economies have shifted from an extended disinflationary phase to tackling strong inflationary concerns, causing key central banks monetary policy rhetoric to switch to extreme hawkishness and policy tightening in 2022 from pandemic-era accommodative policies.

"From domestic standpoint, for FY23, inflation drivers are likely to face considerable pressure from persistent hardening of input prices. The heightened pressure from commodity prices is also coinciding with unlocking of the economy post Omicron wave while vaccination coverage continues to gain traction. While we stick to our estimate of 5.9 per cent for FY23 CPI inflation, we now believe that there is a buildup of upside risks," Acuite Ratings said.

"Going forward, we expect the core inflation to remain sticky at elevated levels given upward revision of petrol and diesel prices by the OMCs in order to reduce the under-recoveries being accumulated by them at the current crude prices of USD 100 plus per barrel."

Acuite Ratings said the government, however, may also consider a partial absorption of the increased prices through a further excise duty cut on petrol and diesel which could provide marginal comfort from inflation perspective. While the direct pass-through of elevated commodity prices can be seen through increasing prices of petrol and diesel and non-subsidized LPG, indirect pass-through of unprecedented input cost pressures by manufacturers is visible through rising prices of certain personal care products within FMCG sector which will get reflected in the core CPI print in the coming months.

After moderating close to RBI's inflation target rate in September-21, headline CPI inflation has been rising incessantly with the print breaching the upper tolerance threshold in Q4 FY22, averaging at 6.34 per cent. It has started to gather steam in April-22 gaining strength from the geo-political crisis and rising to an eight year high of 7.79 per cent YoY from 6.95 per cent YoY in March-22.

US inflation hit 8.3% last month but slows from 40-year high

WASHINGTON (TIP)

Inflation slowed in April after seven months of relentless gains, a tentative sign that price increases may be peaking while still imposing a financial strain on American households.

Consumer prices jumped 8.3% last month from 12 months earlier, according to government data released Wednesday. That was below the 8.5% year-over-year surge in March, which was the highest rate since 1981.

But the consumer price index (CPI) for gasoline fell 6.1% in April compared to March, the Labor Department said. Russia's unprovoked war against Ukraine is the main catalyst for the surge in gasoline prices. The war has also driven up global good prices.

On a month-to-month basis, prices rose 0.3% from March to April, a still-elevated rate but the smallest increase in eight months.

Consumer prices had spiked 1.2% from February to March, mostly because of a sudden jump in gas prices triggered by Russia's invasion of Ukraine.

Nationally, the price of a gallon of regular gas has reached a record \$4.40, according to AAA, though that figure isn't adjusted for inflation.

The high price of oil is the main factor. A barrel of US benchmark crude sold for around \$100 a barrel Tuesday. Gas had fallen to about \$4.10 a gallon in April, after reaching \$4.32 in March.

Elon Musk puts plan to purchase Twitter on hold

Elon Musk tweeted on Friday, May 13, that his \$44-billion cash deal for Twitter Inc was "temporarily on hold" while he waits for the social media company to provide data on the proportion of its fake accounts.

Twitter shares initially fell more than 20% in premarket trading, but after Musk, the chief executive of electric car market Tesla Inc, sent a second tweet saying he remained committed to the deal, they regained some ground.

The shares were down 9.6% to \$40.71 in trading on Friday, a steep discount to the \$54.20 per share acquisition price.

Musk, the world's richest person, decided to waive due diligence when he agreed to buy Twitter on April 25, in an effort to get the San Francisco-based company to accept his "best and final offer." This could make it harder for him to argue that Twitter somehow misled him.

Since Musk inked his deal to acquire Twitter, technology stocks have plunged amid investor concerns over inflation and a potential economic slowdown.

The spread between the offer price and the value of Twitter shares had widened in recent days, implying less than a 50% chance of completion, as investors speculated that the downturn would prompt Musk to walk away or seek a lower price.

"Twitter deal temporarily on hold pending details supporting calculation that spam/fake accounts do indeed represent less than 5% of users," Musk told his more than 92 million Twitter followers.

Buddha Purnima, traditionally known as Vesak or Vesakha, is celebrated as Lord Gautama Buddha's Birthday. Vaishakh Purnima is also called Buddha Purnima. Gautama Buddha's name was first Prince Siddhartha Gautama. Buddha means 'Knowledgeable and knowledgeable person', Gautama Buddha is also known as Shakyamuni.

Buddha Purnima is the biggest festival day for followers of Buddhism. Buddha was born on the full moon day. Buddha attained nirvana on the day of full moon and left this world on the day of Vaishakh sukla full moon. This day is celebrated as Buddha Purnima in the whole world. Several types of celebrations have been organized on this day. Celebrations are organized according to customs and culture of different countries in different countries.

On this day devout Buddhists and followers assemble in various temples before dawn for the ceremonial and honourable hoisting of the Buddhist Flag.

Devotees bring simple offerings of flowers, candles and joss-sticks to lay at the feet of their teacher. They come together to make a special effort to refrain from killing of any kind and are encouraged to partake in vegetarian food for this day.

Certain temples observe the practice of displaying a small statue of Buddha in front of the altar in a basin filled with water and decorated with flowers. Devotees are allowed to pour water over the statue as a symbol of cleansing bad karma.

Buddha Purnima also includes talks given by monks who engage in reciting verses uttered by Buddha 25 centuries ago to invoke peace and happiness.

Celebrating this day does not involve festivities unlike other events, but works as a mean of making special efforts to bring happiness to the unfortunate, the aged, the handicapped and the sick.

Celebrations around the world

Japan

The festival here, is based on a different legend that says, a dragon appeared in the sky on Buddha's birthday and poured soma over him, which is a Vedic ritual drink. In the modern arena, Japan celebrates Vesak by pouring amacha, a sweet tea on statues.

Nepal

Nepal is home to Lumbini-birthplace of Buddha, and Swayambhu-the holy temple for Buddhists also known as the Monkey Temple. The main door of Swayambhu is opened only on this day; hence, people from all over Kathmandu valley are stimulated by the event. Pilgrims across the world gather in thousands to celebrate Buddha's birthday at his birthplace.

Sri Lanka

Sri Lanka celebrates Vesak for about one week! During this time, the selling of alcohol and fresh meat is prohibited with abattoirs also being closed. The celebrations here include giving of alms and erection of pandals wherein each pandal illustrates a story from the Jataka Tales. Food stalls are set up by Buddhist devotees that provide eatables and drinks to passersby. Also birds, insects and animals are released by the thousands in what is known as a 'symbolic act of liberation'; of giving freedom to those who are in captivity, imprisoned, or tortured against their will.

Apart from these, other Asian countries like Korea, Vietnam, Malaysia, Indonesia, and Singapore also participate in processions and prayers by monks and make this day a true symbol of spirituality.

What Do People Do?

Many Buddhists visit temples on Vesak to listen to monks give talks and recite ancient verses. Devout Buddhists may spend all day in one or more temples. Some temples display a small statue of Buddha as a baby. The statue is placed in a basin filled with water and decorated with flowers. Visitors to the temple pour water over the statue. This symbolizes a pure and new beginning.

Many Buddhists pay special attention to Buddha's teachings during Vesak. They may wear white robes and only eat vegetarian food on and around Vesak. Many people also give money, food or goods to organizations that help the poor, the elderly and those who are sick. Caged animals are bought and set free to display care for all living creatures, as preached by

Public Life

Government offices, post offices and banks are closed in India on Vesak. Stores and other businesses and organizations may be closed or have reduced opening hours. Transport is usually unaffected as many locals travel for religious celebrations.

Background

Gautama Buddha was a spiritual teacher in India. Many scholars are uncertain when he lived. It is believed that Buddha was born at some time between sixth and fourth centuries BCE. Opinions among scholars are generally divided between those who place Buddha's death about 480 BCE and those who place it as much as a century later.

Buddha was an influential spiritual teacher during and after his lifetime. Many Buddhists see him as the Supreme Buddha. Festivals to honor Buddha were held for many centuries. The decision to celebrate Vesak as the Buddha's birthday was formalized at the first conference of the World Fellowship of Buddhists. This conference was held in Colombo, Sri Lanka, in May, 1950. The date was fixed as the day of the full moon in

May. Different Buddhist communities may celebrate Vesak on different dates in years when there are two full moons in May. This is because the Buddhist lunar calendar can be interpreted in different ways.

Symbols

The dharmacakra or dharma wheel is a symbol often seen during Vesak. It is a wooden wheel with eight spokes. The wheel represents Buddha's teaching on the path to enlightenment. The eight spokes symbolize the noble eightfold path of Buddhism.

fielded six Punjabi candidates each, New Democratic Party five, Green two and one will contest as an Independent. Most of the Punjabis are contesting from the 11 constituencies of Brampton and Mississauga suburbs of Toronto, dominated by the diaspora.

The Progressive Conservative Party has fielded Hardeep Grewal from Brampton East, Amanjot Sandhu from Brampton West and Deepak Anand from Mississauga Malton. Liberals have fielded Jannat Garewal from Brampton East, Harinder Malhi from Brampton North, Rimmy Jhajj from Brampton West, Aman Gill from Mississauga Malton, Ruby Toor from Brantford Brant and Manpreet Brar from Essex.

\$44 billion Twitter deal 'temporarily on hold' over data on fake accounts; stocks slump

electric car market Tesla Inc, sent a second tweet saying he remained committed to the deal, they regained some ground.

The shares were down 8.6% to \$41.19 in midday trading on Friday, a steep discount to the \$54.20 per share acquisition price.

Musk, the world's richest person, decided to waive due diligence when he agreed to buy Twitter on April 25, in an effort to get the San Francisco-based company to accept his "best and final offer." This could make it harder for him to argue that Twitter somehow misled him.

Since then, technology stocks have plunged amid investor concerns over inflation and a potential economic slowdown.

The spread between the offer price and the value of Twitter shares had widened in recent days, implying less than a 50% chance of completion, as investors speculated that the downturn would prompt Musk to walk or seek a lower price.

"Twitter deal temporarily on hold pending details supporting calculation that spam/fake accounts do indeed represent less than 5% of users," Musk told his more than 92 million Twitter followers.

Twitter is planning no immediate action as a result of Musk's comment, people familiar with the matter said. The company considered the comment disparaging and a violation of the terms of their deal contract, but was encouraged by Musk subsequently tweeting he was committing to the acquisition, the sources added.

Musk came to Twitter's office for a meeting on May 6 as part of the transaction planning process, a Twitter spokesperson said.

There was no immediate reaction from the investors that Musk tapped last week to raise \$7.1 billion in funding.

Spam or fake accounts are designed to manipulate or artificially boost activity on services like Twitter. Some create an impression that something or someone is more popular.

Musk tweeted a Reuters story from ten days ago that cited the fake account figures. Twitter has said that the figures were an estimate and that the actual number

may be higher.

The estimated number of spam accounts on the microblogging site has held steady below 5% since 2013, according to regulatory filings from Twitter, prompting some analysts to question why Musk was raising it now.

"This 5% metric has been out for some time. He clearly would have already seen it... So it may well be more part of the strategy to lower the price," said Susannah Streeter, an analyst at Hargreaves Lansdown.

Representatives for Musk did not immediately respond to requests for comment from Reuters.

Tesla's stock rose 4% on Friday morning. The shares have lost about a quarter of their value since Musk disclosed a stake in Twitter of April 4, amid concerns he will get distracted as Tesla's chief executive and that he may have to sell more Tesla shares to fund the deal.

There is plenty of precedent for a potential renegotiation of the price following a market downturn. Several companies repriced agreed acquisitions when the COVID-19 pandemic broke out in 2020 and delivered a global economic shock.

In one instance, French retailer LVMH threatened to walk away from a deal with Tiffany & Co. The U.S. jewelry retailer agreed to lower the price by \$425 million to \$15.8 billion.

Acquirers seeking a get out sometimes turn to "material adverse effect" clauses in their merger agreement, arguing the target company has been significantly damaged.

But the language in the Twitter deal agreement, as in many recent mergers, does not allow Musk to walk away because of a deteriorating business environment, such as a drop in demand for advertising or because Twitter's shares have plunged.

Musk is contractually obligated to pay Twitter a \$1 billion break-up fee if he does not complete the deal, and the language in the deal contract appears to cap any damages that Twitter can seek from Musk to that level.

But the contract also contains a "specific performance" clause that a judge can cite to force Musk to complete the deal.

In practice, acquirers who lose a specific performance case are almost never forced to complete an acquisition and typically negotiate a monetary settlement with their targets.

"The nature of Musk creating so much uncertainty in a tweet (and not a filing) is very troubling to us and the Street and now sends this whole deal into a circus show with many questions and no concrete answers as to the path of this deal going forward," Wedbush analyst Daniel Ives wrote in a note.

Musk has said that if he buys Twitter he "will defeat the spam bots or die trying" and has blamed the company's reliance on advertising for why it has let spam bots proliferate.

He has also been critical of Twitter's moderation policy and has said he wants Twitter's algorithm to prioritize tweets to be public and was against too much power on the service to corporations that advertise.

Nevertheless, Musk is targeting advertising revenue to more than double by 2028, according to slides he presented to investors that were reported by the New York Times.

Ads are expected to make up about 45% of Twitter's total revenue by that time, down from nearly all of its revenue today, according to the investor presentation.

Earlier this week, Musk said he would reverse Twitter's ban on former U.S. President Donald Trump when he buys the social media platform, signaling his intention to cut moderation.

Trump, who started a rival site called Truth Social, took to his own platform to weigh in on the fracas.

"There is no way Elon Musk is going to buy Twitter at such a ridiculous price, especially since realizing it is a company largely based on bots or spam accounts," Trump wrote in a post, adding that his site is much better.

Members of the ruling Sri Lanka Podujana Peramuna (SLPP) and some from the main Opposition Samagi Jana Balawegaya (SJB) and several other parties said they would back Wickremesinghe in Parliament, according to reports.

However, several factions opposed the move to appoint Wickremesinghe as the new Prime Minister.

Four-time PM

May 13

May 13, 1846 - At the request of President James K. Polk, Congress declared war on Mexico. The controversial struggle eventually cost the lives of 11,300 U.S. soldiers and resulted in the annexation of lands that became parts of Oklahoma, New Mexico, Arizona, Nevada, California, Utah and Colorado. The war ended in 1848 with the Treaty of Guadalupe Hidalgo.

May 13, 1943 - During World War II in North Africa, over 250,000 Germans and Italians surrendered in the last few days of the Tunis campaign. British General Harold Alexander then telegraphed news of the victory to Winston Churchill, who was in Washington attending a war conference. The victory reopened Allied shipping lanes in the Mediterranean.



Pope John Paul II

May 13, 1981 - Pope John Paul II was shot twice at close range while riding in an open automobile in St. Peter's Square in Rome. Two other persons were also wounded. An escaped terrorist, already under sentence of death for the murder of a Turkish journalist, was immediately arrested and was later convicted of attempted murder. The Pope recovered and later held a private meeting with the would-be assassin and then publicly forgave him.

May 14


May 14, 1607 - The first permanent English settlement in America was established at Jamestown, Virginia, by a group of royally chartered Virginia Company settlers from Plymouth, England.

May 15, 1972 - George Wallace was shot while campaigning for the presidency in Laurel, Maryland. As a result, Wallace was permanently paralyzed from the waist down.

May 16

May 16, 1862 - During the American Civil War, Union General Benjamin Butler, military governor of New Orleans, issued his "Woman Order" declaring that any Southern woman showing disrespect for Union soldiers or the U.S. would be regarded as a woman of the town, or prostitute. This and other controversial acts by Butler set the stage for his dismissal as military governor in December 1862.

New York Stock Exchange

May 17, 1792 - Two dozen merchants and brokers established the New York Stock Exchange. In good weather they operated under a buttonwood tree on Wall Street. In bad weather they moved inside to a coffeehouse to conduct business.

May 17, 1875 - The first Kentucky Derby horse race took place at Churchill Downs in Louisville.

May 17, 1954 - In Brown v.

Board of Education, the U.S. Supreme Court unanimously ruled that segregation of public schools "solely on the basis of race" denies black children "equal educational opportunity" even though "physical facilities and other 'tangible' factors may have been equal. Separate educational facilities are inherently unequal." Thurgood Marshall had argued the case before the Court. He went to become the first African American appointed to the Supreme Court.

May 18



Napoleon Bonaparte

May 18, 1804 - Napoleon Bonaparte became Emperor of France, snatching the crown from the hands of Pope Pius VII during the actual coronation ceremony, and then crowning himself.

May 18, 1998 - In one of the biggest antitrust lawsuits of the 20th century, American software giant Microsoft Corporation was sued by the U.S. Federal government and 20 state governments charging the company with using unfair tactics to crush competition and restrict choices for consumers. The lawsuits alleged Microsoft used illegal practices to deny personal computer owners the benefits of a free and competitive market and also alleged Microsoft extended its monopoly on operating systems to "develop a chokehold" on the Internet browser software market.



Malcolm X

Birthday - Black nationalist and civil rights activist Malcolm X (1925-1965) was born in Omaha, Nebraska (as Malcolm Little). While in prison he adopted the Islamic religion and after his release in 1952, changed his name to Malcolm X and worked for the Nation of Islam. He later made a pilgrimage to Mecca and became an orthodox Muslim.

If you are looking for an adventurous getaway, now would be an ideal time for it. This time around, trek through the lesser travelled areas of the Himalayas, and experience the magic of clear skies, colourful landscapes, and uninterrupted views of the lofty peaks. Take your pick.

Solang Valley

Located near Manali, at an altitude of about 2,560 m, Solang Valley offers a beautiful view of the snowclad Himayan range. A trek from Manali to Solang (16 km) is one of the best ways to reach the place. The trek will take you through paths with picturesque surroundings and deodar forests. Moreover, you won't just find snow-capped mountains to gaze at; the trail is laden with apple orchards, a few old villages, and abundant lush green environs. Once at Solang, you can try out activities such as paragliding, zorbing, horse-riding, etc.

Naggar


A trek from Naggar, a quaint settlement in the Kullu district, to the village of Malana, takes about three days. Going through the Chanderkhani Pass is a part of the Naggar trek. It's a great opportunity not just to marvel at the beauty of nature, but also to experience the selfless hospitality of the rural folk living in these mountainous areas. On your trail, you will come across villages like Rumsu and pastures like Shillu Pathar that are ideal to camp for the night. The descent to the village of Malana is steep. Therefore, it is important to be careful while trekking.

Chalal

Chalal is a small village situated very close to the small town of Kasol. It is located on the banks of the Parvati River and provides a much-needed break from the hustle and bustle of Kasol. This is a short trek, but it nevertheless proves to be an enthralling experience. The road to Chalal is scenic; the path runs along the river, which has huge boulders where one can relax in the middle of the trek. For anyone taking a trek to Rasol or higher, it is a good idea to stop by Chahal to rest or stalk up on supplies.

Sandakphu

Sandakphu, a part of the Singalila Ridge, is the highest peak of West Bengal. With an altitude of 3,636 m, the summit is a surreal experience, and is a must-see for people who love adventure treks. It is one of the few places that offers trekkers a majestic view of four of the tallest mountains in the world - Mount Everest, Kanchenjunga, Lhotse and Makalu -



spread across India, Nepal, Bhutan and further. The trek to Sandakphu is a long one, and it is advisable to carry enough supplies to last through the journey. The distances between one pit stop and the next are quite long. Once you start your trek from Manebhanjan, which is about an hour's drive from Darjeeling, it takes nearly four hours to reach Chitre. The trail is quiet steep, with a mixture of rocky, gravel-filled paths, as well as levelled land, which are easier for walking. The trail towards Kalipokhri is beautiful and you see an abundance of exotic, colourful birds. By the end of the day, you reach the small Black Lake of Kalipokhri - the sacred lake that never freezes, with Buddhist prayer flags hanging over it. You can camp at Kalipokhri and head out to Sandakphu the next morning, which is a relatively easier trek of about 6 km.

Roopkund

Situated at an altitude of 4,463 m, this is a moderately challenging trek. The Roopkund, or Skeleton, Lake, (several human skeletons were found at the site in 1942) is one of the sites that attracts adventure lovers. The challenging terrain is accompanied by picturesque sights of snow-capped mountains and the Bedni Bugyal grasslands.

INDIAN AMERICAN SIKH ATTACKED IN A ROBBERY BID

RICHMOND HILL, NY (TIP): In less than a month and a half a third targeted attack on an Indian American Sikh has taken place in Queens neighborhood of Richmond Hill, which is considered a neighborhood dominated by Punjabis.

Kuldip Singh, 62 who hails from Dasuya in Hoshiarpur (Punjab) was taking a walk at around 10:30 in the morning of Sunday, May 8 near his home in 115 Street between Liberty Avenue and 107 Avenue in Richmond Hill when a Black young man between 25 and 30 years on a bicycle stopped by him, threw his bike on the road, took out a pistol and asked

for money.

Kuldeep said told The Indian Panorama that he impulsively caught hold of the Black guy's right arm in which he was holding the gun. What followed was a kind of wrestling match between the two. The young man proved stronger than the old Kuldeep Singh and punched him ferociously.

As a result, Kuldeep Singh suffered a few injuries on many parts of the body, including a fractured nose and a fractured finger of the left hand. The assailant managed to escape.

The incident - the third attack on a Sikh- in the neighborhood has shocked and angered the community.

Delhi fire: Cops identify 7 bodies, 29 still missing; death toll likely to rise

the building during cooling operations on Saturday morning. Twelve injured were undergoing treatment at a hospital here.

They said the four-story building, which did not have a fire safety certificate, had a single entry and exit

point which could have been the reason for the high number of casualties.

"The building had a single escape route which is why there were so many casualties. Twenty-seven people have died," Chief Fire Officer Atul Garg said.

Officials said there was only one narrow staircase for entry and exit which made escape from the burning building difficult.

Garg said it is suspected that an explosion in an AC may have triggered the fire.

Harish Goel and his brother Varun Goel, owners of a CCTV camera and router manufacturing and assembling company, from whose office the fire is suspected to have started, have been arrested, Deputy Commissioner of Police (Outer) Sameer Sharma said.

Garg added it was difficult to ascertain whether the remains found on Saturday morning were of one person or more.

Of the 27 deceased, seven have been identified so far as Tania Bhushan, Mohini Pal, Yashoda Devi, Ranju Devi, Vishal, Drishti and Kailash Jyani, the DCP said.

Delhi Chief Minister Arvind Kejriwal and his deputy, Manish Sisodia, visited the spot on Saturday. The chief minister announced a compensation of Rs 10 lakh each to the kin of the deceased and Rs 50,000 for those injured in the fire, which started from the first floor of the building.

Lieutenant Governor Anil Baijal said he was "deeply pained" by the loss of lives in the tragedy and called for immediate steps to prevent such incidents in the future. He also extended his condolences to the bereaved families.

Distraught relatives of those who have not been found yet thronged the Sanjay Gandhi Hospital on Friday night looking for information about them.

One of them, Ajit Tiwari, said his sister Monika (21) had started working for the company just a month back.

"She received her first salary on Thursday. We got to know about the fire at 5 pm but had no idea that the blaze occurred at her office building. When she did not return home by 7 pm, we started looking for her," he said.

Monika lives with her two brothers and a sister in Delhi's Agar Nagar. She is from Gonda district in Uttar Pradesh.

Another woman was seen frantically looking for her elder daughter, who also works at the CCTV camera packaging unit.

"My daughter Pooja has been working at the CCTV camera packaging unit for the last three months. We live in Mubarakpur and got to know about the incident at 9 pm. She has a cut mark

MASSIVE FIRE AT MEDICAL COLLEGE IN AMRITSAR; THREE FLOORS OF THE BUILDING HAVE BEEN DAMAGED

AMRITSAR (TIP): A major mishap was averted at Government Medical College, Amritsar, after fire engulfed a hospital building near the X-Ray department. The hospital employees claimed the fire started from an electricity transformer in the parking area behind the building. Premier League: Tottenham beat 3-0 Arsenal to tighten race for CL spot

Tottenham revived its hopes of beating Arsenal to the final Champions League qualification position by overwhelming its fierce north London rival in a 3-0 win in the Premier League.

Harry Kane scored twice — including one from the penalty spot — and Son Heung-min added the other just after halftime on Thursday to move Tottenham one point behind fourth-place Arsenal, which had center back Rob Holding sent off in the 33rd when the score was 1-0.

There are two games remaining for each team and fifth-place Tottenham's finish to the season looks easier than Arsenal's. While Spurs face two of the bottom four in Burnley and already-relegated Norwich, Arsenal must travel to Newcastle before a home game against a resurgent Everton.

"This type of game is not easy — when it's a game you must win, it's not easy," Tottenham manager Antonio Conte said.

"We knew tonight, there had to be only one result. We had concentration, and had the right calm and positive pressure."

Rafael Nadal says foot injury a concern ahead of French Open

Rafael Nadal said that everyday training was a challenge and he would take a doctor with him to Roland Garros after the 21-times major winner was once again hampered by a chronic foot injury in his defeat by Denis Shapovalov at the Italian Open on Thursday, May 12.

Nadal, who only recently returned from a stress fracture in the ribs, struggled badly at the back end of his match against the Canadian as he went down 1-6 7-5 6-2 in the last-16.

"I had my foot again with a lot of pain. I am a player living with an injury - it is nothing new. It's something that is there," Nadal, a 10-times champion in Rome, told reporters.

"Unfortunately, my day-by-day is difficult, honestly. Even like this, I am trying hard... it can be frustrating that a lot of days I can't practice the proper way."

The 35-year-old missed the bulk of last season due to the foot problem before mounting a remarkable comeback to win the Australian Open in January and also prevailing in Acapulco.

"Since I came back, the foot has been tough," added the Spaniard. "Negative thing and toughest thing for me today is honestly I started to feel myself play much better. I started the match playing much better."

Nadal's preparation heading into the French Open, where he will be bidding for a record-extending 14th title, has been far from ideal after he was also knocked out of last week's Madrid Open by Carlos Alcaraz at the quarter-finals stage.

IPL: Punjab Kings demolish RCB by 54 runs

MUMBAI (TIP)

Punjab Kings buried Royal Challengers Bangalore under a deluge of runs as they kept their playoff hopes alive with 54-run victory, riding on superb half-centuries from Jonny Bairstow and Liam Livingstone in an IPL match here on May 13.

Bairstow (66 off 29 balls) and Livingstone (70 off 42 balls) propelled Punjab Kings to 209 for 9 in a must-win game and the scoreboard was always going to be telling as RCB were restricted to 155 for 9 in 20 overs.

While Punjab remain in the mix with 12 points from as many games, the margin of victory considerably improved their net run-rate to +0.210 and RCB despite having 14 points from 13 games are at a -0.323.

RCB will have to win their final game and move to 16 points but also now need to have some rub of the green with a few favourable results going their way.

It was another day and another failure for Virat Kohli (20), who got a faint under-edge tickle on his gloves before it hit his thigh pad and bobbed up to short fine leg off a Kagiso Rabada (4-0-21-3) delivery.

Rabada was literally unplayable on the day as he worked good pace and hit the ideal fuller length for better part of his spell.

Rishi Dhawan (4-0-36-2), perhaps the weakest link in Punjab attack, then made up for his lack of pace by hitting immaculate length as Faf du Plessis edged one to Jitesh Sharma behind stumps and Mahipal Lomror's rasping pull shot was taken by Shikhar Dhawan.

Rajat Patidar (26) and Glenn Maxwell (35) did add 64 runs but they were never in the game with both departing in quick succession.

And when Dinesh Karthik (11) was snuffed out by the brilliant Arshdeep

Singh (4-0-27-1) with a wide yorker and a catch by short third-man on the circle, RCB fizzled out in a jiffy.

Earlier, Bairstow's opening blitzkrieg found its ideal match in Livingstone's finishing carnage.

While Bairstow laid the foundation with a 29-ball-66, Livingstone was equally good in his 42-ball-70 as the RCB bowlers had a day which they would like to forget in a hurry.

Bairstow, who was rusty during the earlier phase of the tournament, was back in his element with as many as seven sixes and four boundaries during a knock where he literally went hell for leather.

Such was his dominance that by the time six overs of Powerplay ended, Bairstow had hit seven towering sixes and Shikhar Dhawan (21 off 15 balls) rubbed salt to the wound with another

one which made it eight in all.

Punjab Kings, which had set the template of blazing Powerplay starts, got 83 in six overs with Glenn Maxwell (1/17 in 2 overs), Josh Hazlewood (0/64 in 4 overs) and Mohammed Siraj (0/36 in 2 overs) being treated with utter disdain.

While Maxwell did manage to get Dhawan, both Hazlewood and Siraj were guilty of bowling short on a pitch offering true bounce. Bairstow effortlessly pulled and flicked them into the stands and by the time, deliveries pitched up, they landed in the stands as well. It only helped that the boundary on one side was 66 metres only, which is a dream for any power-hitter.

Siraj had a forgettable first spell where he was hit for four sixes, while Hazlewood in his first over had gone for 22. The Australian had his worst IPL figures ever.

Up against world No. 13 Rasmus Gemke, Prannoy suffered an ankle injury after slipping but he continued after taking a medical timeout. He looked in pain and his on-court movement also looked restricted. Despite the odds, he produced a sensational performance to come up trumps 13-21 21-9 21-12 to etch India's name in the history books.

India will now take on 14-time champions Indonesia, the most successful team in the history. Indonesia edged out Japan 3-2 in their semifinal.




