

## POLICE TO QUESTION JAILED GANGSTER LAWRENCE BISHNOI

**CHANDIGARH (TIP):** The Punjab police on Wednesday, June 1, said it will question jailed gangster Lawrence Bishnoi after bringing him to the state in connection with the murder of Punjabi singer Sidhu Moosewala.

Meanwhile, in order to further expedite the investigations in Sidhu Moosewala Murder case, Director General of Police (DGP) Punjab VK Bhawra has strengthened and reconstituted the Special Investigation Team (SIT) under the supervision of ADGP Anti-Gangster Task Force (AGTF) Pramod Ban.

According to the police, Bishnoi's gang was behind the killing. At present, Bishnoi is in custody of the Delhi Police's Special Cell in a case under the Arms Act and other sections related to assault on a public servant.

## CANADA TO PUT A FREEZE ON IMPORTING, BUYING OR SELLING HANDGUNS

**CANADA HAS HAD FAR FEWER MASS SHOOTINGS THAN THE US IN PART BECAUSE OF A LACK OF EASY ACCESS TO GUNS**

**OTTAWA (TIP):** Canadian Prime Minister Justin Trudeau's government introduced legislation Monday, May 30, that would put a freeze on importing, buying or selling handguns.

"We are capping the number of handguns in this country," Trudeau said.

The regulations to halt the growth of personally owned handguns are expected to be enacted this fall.

"It will be illegal to buy, sell, transfer or import handguns anywhere in Canada," the prime minister said.

Canada already has plans to ban 1,500 types of military-style firearms and offer a mandatory buyback programme that will begin at the end of the year. It already expanded background checks.

Trudeau has long had plans to enact tougher gun laws but the introduction of the new measure comes after mass shootings in Uvalde, Texas, and Buffalo, NY, this month.

## NATIONAL COMMISSION FOR WOMEN MEET RECOMMENDS HELPLINE FOR ABANDONED WIVES OF NRIS

**NEW DELHI (TIP):** A national helpline for women deserted in Non-Resident Indian (NRI) marriages and the need for a dedicated fund to provide assistance to them are among the recommendations made at a consultation on Wednesday, June 1, organized by the National Commission for Women (NCW) on ensuring access to justice to such women. Among issues discussed was ways to serve non-bailable warrant against male offender residing abroad. The NCW invited experts from the Ministry of Women and Child Development, Ministry of External Affairs, Ministry of Home Affairs, women victims, State police departments, NGOs, Indian missions in Australia and Canada, among others.



The consultation was held on two broad topics - identifying problems faced by Indian women married to Persons of Indian Origin (PIO) and NRIs, and

# Gangs of Punjab: Moosewala's murder shows gangster culture is thriving

The shocking murder of singer-politician Sidhu Moosewala underscores the impunity with which gangsters have been operating in Punjab in recent years. Some of them have killed their rivals or have been gunned down by cops, but others have sprung up to follow in their footsteps, serving up the deadly cocktail of murders, extortion, arms smuggling and drug trafficking. The Punjab Police have prima facie attributed the Mansa killing to a rivalry between the gangs led by Lawrence Bishnoi and Lucky Patial, claiming that it was in retaliation for the 2021 murder of Youth Akali Dal leader Vicky Middukhera. The alleged role of Bishnoi, who is behind bars, in the Moosewala case needs to be investigated

thoroughly as he could merely be a front for inimical forces based in India or abroad that are out to create disturbances in the state.

The ruling AAP is under fire for having pruned Moosewala's security despite a tangible threat perception, even as there is no denying that successive state governments have failed to gauge the enormity of the challenge posed by gangsters. Weeks after taking charge as CM, Bhagwant Mann had ordered the formation of a dedicated police unit for the purpose. The Anti-Gangster Task Force faces an uphill task as 70 gangs with over 500 members are reportedly active in the state, with 300 of them lodged in various jails. The activities of incarcerated gangsters lay

bare the laxity of the prison authorities in Punjab and other states.

Law enforcement agencies have their hands full in view of the rampant use of social media by criminals, who glorify gun culture to lure recruits. Rising above party lines, close coordination between the police forces of various states is a must to curb the gangster menace. The presence of Punjabi gangsters in other countries puts the onus on the Centre to press for their extradition. The political blame game can only prove counter-productive; it is imperative to build consensus on ensuring peace and stability in Punjab and preventing a regression to the blood-soaked era of terrorism.

# Another round of US cajoling

## STEADY RUSSIAN SUPPORT MAKES SWITCHING OF SIDES DIFFICULT

India has been hosting recurring waves of diplomats and government officials descending from Washington with the singular purpose of removing Russia from South Block's bouquet of painstakingly built diplomatic ties. The latest to arrive is the US Treasury's Elizabeth Rosenberg who has built a career around ensuring that recalcitrant countries from the US point of view, such as Russia, North Korea, Syria etc., suffer the maximum pain of sanctions. The US has been dispatching these officials to regurgitate their persuasive pitches when India as a sovereign nation has made its stand crystal clear during two Biden-Modi summits - one virtual in April and the other in-person in Tokyo - and at the two plus two of Foreign and Defense Ministers held in Washington last

month.

India is not the only major nation to be confronted by relentless American cajoling. Indonesia, South Africa, Turkey, Brazil and even Israel are reluctant to put all their eggs in the American basket. The miasma of distrust towards US consistency has heightened after its cut-and-run tactics in Afghanistan. Having gone along with American choices in Kabul for two decades, their precipitous withdrawal left India between a rock and a hard place. India's expectations of gaining access to critical technology through Quad have remained elusive. Even more galling, the US, the UK and Australia quietly carved out AUKUS, an exclusive club for the joint development of advanced submarine capability, to

On the other hand, India has much promising business with Russia. PM Modi is still persuading his western counterparts to liberalize the movement of skilled Indian professionals. If the war had not intervened, the first batch of Indians to work in Far Eastern Russia would have left last month. Indian industries ranging from diamonds to coking coal are finding new footholds in this region. In addition, not counting the strategic comfort that comes from the Russian readiness to watch India's back, whether it is hard-to-get defense systems or support at international fora such as the UNSC. India's ties with the West are worth their weight in gold but Russia is an anchor India would like to persist with.

# Kashmir killings: Amid fear and panic, ensure sense of security

Sense of fear and insecurity after yet another targeted killing in Kashmir is understandable, as is the anger. Yet, it is critical to ensure that the fatal attack in Kulgam on schoolteacher Rajni Bala from Jammu does not trigger mass panic or any displacement. That would mean playing into the hands of the terror networks, which the Jammu and Kashmir Police believe are resorting to such tactics in desperation. Last year, at least 35 civilians were killed in the Valley, but the spike in targeted attacks has been attributed to the gunning down of a huge number of terrorists, including those in leadership roles, destruction of their support structures and the locals not responding to their diktats. The

frustration over their rapidly thinning presence and support has led to targeting of unarmed policemen, civilians from the minority communities, and even a local television actor last week.

In most instances, the security apparatus has shown commendable swiftness and tenacity in hunting down those responsible for the dastardly acts. That would bring little solace without creating an atmosphere of secure and peaceful coexistence, minus the rhetoric. The grief and shock expressed by the Kashmiri students and staff over Rajni Bala's gruesome killing is proof of the havoc that terrorism has inflicted. No one has escaped its fangs. One response to the spate of targeted killings, though, that should have been forthcoming but

has been missing is a pan-India call for condemnation and show of support for the victims and their families, cutting across ideological lines, from activists, academics and the intelligentsia. Any loss of life in a terror attack is a national loss. That's the level of unqualified support needed.

With Amarnath Yatra round the corner and a heightened alert, it would be prudent to rework the security requirements and have adequate checkpoints and cordons near the work and living places of those believed to be vulnerable, howsoever difficult the task may be. At times, a show of force is essential.

**INDIAN AMERICAN, FIRST WOMAN OF COLOR, VERMONT SENATOR KESHA RAM HINSDALE ENDS CONGRESSIONAL BID**



Kesha Ram Hinsdale ended her Congressional bid Friday, May 27

**MONTPELIER, VT (TIP):** Kesha Ram Hinsdale, the youngest Indian American to ever serve in state elected office, ended her Congressional bid Friday, May 27, announcing plans to run for re-election to the Vermont State Senate from Chittenden Southeast District.

Ram Hinsdale, 35, daughter of Jewish mother and Hindu father, who made history in 2020 as the first woman of color elected to Vermont's State Senate, would be supporting fellow Democrat Becca Balint's bid for Congress. Earlier upon election to the State House in 2008, she became the youngest state legislator in the country.

The Vermont primary election is on Aug 9, and early voting begins on June 24.

"There is a far greater feeling than winning, and that is doing what is right. This moment calls on all of us to do what is best for our state and nation, and for me that means continuing to champion working people, climate action, and our civil rights here at home," she stated.

"Given recent resignations across the Vermont legislature and our statewide offices, it's becoming clear that there's a need for experienced leadership to remain in Montpelier," Ram Hinsdale said.

"I began serving in 2009 during the start of the Great Recession, have led through Tropical Storm Irene, and brought marginalized voices into the room as the first woman of color to serve in the State Senate. We have critical work to do on racial, social, and environmental justice, and we are still not out of this pandemic."

"It was not an easy decision, but I have decided to run for re-election to the Vermont State Senate and endorse Becca Balint, a candidate whose values align with my own and who will be a fighter for Vermont in Washington," she said.

"We built a coalition that was bigger than me, and so many Vermonters and national leaders stepped up to support my Congressional campaign and the principles I stand and fight for."

"I am so grateful to all of them and to Vermont for holding me through this

# Indian-origin Scotland Yard's anti-terror police chief to seek explanation for missed promotion

**LONDON (TIP):** Scotland Yard's Indian-origin Head of Counter-Terrorism Policing, Neil Basu, said he is "disappointed" with the way the process for a new appointment which involved a promotion has been handled and plans to seek an explanation from the UK Home Office, a UK media report has claimed.

Basu, a Metropolitan Police Assistant Commissioner and the country's senior-most non-white officer, was in the running to lead the National Crime Agency (NCA) - often referred to as the UK's version of the American Federal Bureau of Investigation (FBI).

According to 'The Sunday Times', Basu had been narrowed down as one of the final two candidates until Downing Street's preference for former Scotland Yard chief Lord Bernard Hogan-Howe emerged and applications were reopened.

"I am disappointed in the way the process has concluded and will not be applying again," Basu told the newspaper.

"I will be seeking an explanation from the Home Office," the 53-year-old said.

The newspaper said Basu is understood to be consulting lawyers and has served notice on the Home Office that he intends to lodge a formal complaint.

Privately, he is reportedly furious to miss out on the GBP 223,000-a-year job and his supporters suspect it may be linked to his outspoken views on race.

Last week, on the second anniversary of the murder of George Floyd in the US which triggered the worldwide Black Lives Matter movement, Basu wrote an article in which he said British policing had to accept that it is "institutionally racist" and also called for positive discrimination to boost the number of black and Asian officers.

If his candidacy for the NCA job had succeeded, Basu would have become the first person of South Asian heritage, born to an Indian father and Welsh

mother, to lead a UK law enforcement organization. The newspaper pointed out that any official complaint is likely to point out that delays to the recruitment process meant Basu missed the deadline to apply for the job of Met commissioner, as well as a senior leadership role at the College of Policing in England and Wales.

The top job at the NCA, the UK's lead agency against organized crime, became vacant in October last year after Dame Lynne Owens stepped down as Director-General on medical grounds.

Lord Hogan-Howe had made it through to the final four candidates but his failure to reach the last two is believed to have prompted the British Prime Minister's office at 10 Downing to intervene in the recruitment process. He and Basu worked together when Boris Johnson was Mayor of London.

Asked if he planned to rule himself out of the NCA race, Hogan-Howe said: "Out of respect to the process and to the candidates, I have no comment to make."

Downing Street sources told 'The Sunday Times' that Prime Minister Boris Johnson had no formal role in the appointment process.

"A fair and open recruitment campaign is underway to make the best possible appointment to this vital role," the Home Office was quoted as saying.

## CANADA-BASED INDIAN-ORIGIN KINGPIN GOLDY BRAR ON FARIDKOT COPS' RADAR FOR OVER A YEAR

president Gurlal Singh Pehalwan in 2021 here, the police had booked Satinder Singh, alias Goldy Brar, along with others.

Police probe suggests Brar had hatched the killing to avenge the murder of his cousin Gurlal Singh Brar in Chandigarh in 2020. Gurlal Brar was then state president of SOPU and an aide of gangster Lawrence Bishnoi, say sources.

Goldy Brar's father Shamsher Singh was an ASI in the Muktsar police. He took premature retirement.

On March 9, 2021, the police in Kotkapura arrested Shamsher for alleged role in an extortion racket. As per the FIR, it was alleged Goldy Brar was the kingpin of the extortion racket. While Shamsher used to carry out the recce of potential victims and pass on the information to his son in Canada, the latter used to extort victims using his local contacts.

Brar uses WhatsApp calls or text messages for extortion. In 2021 case, he had made an extortion call to a chemist, who owned a shop in Kotkapura, and demanded Rs 25 lakh. On March 19, 2021, a local court had issued an arrest warrant for the Canada-based gangster.

## CANADA BASED NRI INITIATES 'GURU KI RASOI' IN PUNJAB TO DISTRIBUTE FREE LUNCH BOXES TO OVER 400 NEEDY EVERY DAY

With an aim to feed poor and needy persons daily, a charitable organization, Nishkaam Sewa Society, which has been started by Canada-based NRI Gurjinder Singh, a native of Chela village in Hoshiarpur, is distributing over 400 free lunch boxes across Nawansohar and Hoshiarpur. 

The results have had far reaching impact at the grassroot levels and have been incorporated in the guidelines by the Indian health ministry and the World Health Organization. It has also become "WHO Collaborating Centre for Research in Maternal and Perinatal Health".

The Academic and Research collaboration between KLE Academy of Higher Education and Research (KAHER) and TJU in the areas of Public Health, Urology and Integrative Medicine commenced in July 2017 and has been expanded to include specialties of Neurology, Radiology, Neonatology, Psychiatry, Nursing and Physiotherapy.

The faculty and student exchange, research grants as well as the establishment of the India Centre at Thomas Jefferson University is a testimony of the strong academic bond between KLE and TJU, the release said.

The Jefferson India Center provides the framework necessary to keep pace, empowering public-private partnerships that address the social determinants of health, health disparities, and access to care in the world's two largest democracies, the center said.

By advancing the concept of distance learning and team science through bilateral faculty and student exchanges, the Center provides new generations of health leaders the global perspective necessary to effect meaningful change in healthcare delivery, it said.

To date, the collaboration between KLE University and Thomas Jefferson University has generated 150 publications and supported the acquisition of 31 funded grants conducted in India.

Varma is the third candidate to drop out of the race two weeks before the June 7 primary. If no candidate receives a majority of the vote, the two top finishers will face off in November, ABC7 reported.

That leaves nine candidates vying to replace Mayor Eric Garcetti, President Joe Biden's nominee to be the US ambassador to India.

City Attorney Mike Feuer ended his run on Tuesday, May 24, and endorsed Rep. Karen Bass, while Councilman Joe Buscaino dropped

out of the race on May 12 and endorsed Caruso.

Caruso and Bass are running neck-and-neck with about 25 percent of support from likely voters, according to the most recent polls cited by Los Angeles Daily News.


Varma had launched his campaign last fall with a bang, renting out the Banc of California Stadium for 400 people, where he'd promised to cut government waste, end homelessness and "build a city of the future - right now."

The co-founder of the online tutoring firm Revolution Prep had loaned himself \$4 million. In an April poll by UC Berkeley, just 1 percent of people surveyed said they'd vote for Varma.

With little name recognition in a city of 2.1 million registered voters, he was forced to withdraw his hat from the ring and toss his support to Caruso, Los Angeles Daily News reported.

Varma told the Daily News he was "incredibly impressed by (Caruso's) thoughtfulness, drive and genuine desire to fix problems in L.A. and build a plan for growth that will last us for decades."

Make no mistake, it will lead to large cuts in these critical programs. This should not be a choice that school leaders have to make.

If the State Legislature is going to move forward with the bill on class size limits, my appeal to our state legislators in Albany is to fully fund the bill. 
The students' walkout, which was overseen by the school, lasted 21 minutes, in honor of the 21 people who were killed by a gunman at Robb Elementary School on May 24.

**QUEENS, NY (TIP):** Queens District Attorney Melinda Katz announced on June 1, that Jordan Adderley, 32, was sentenced to eight years in prison after pleading guilty to sex trafficking of a child, rape and other crimes.

The defendant profited from the prostitution of a 16-year-old girl whom he drove to various hotels, including the now-closed Umbrella Hotel in Kew Gardens, to have sex with male customers in exchange for cash. The victim engaged in prostitution acts between September and October of 2020.

District Attorney Katz said, "This defendant lined his pockets with the money the victim made performing sex acts on strangers. Sex trafficking is a degrading industry that has caused irreparable harm to this young teenager. Although we cannot undo the trauma, we are holding this defendant accountable, and he will now spend time behind bars for his egregious actions."

Adderley, of Watkins Street in Brooklyn, pleaded guilty last month to sex trafficking of a child, sex trafficking, rape in the third degree, criminal sex act in the third degree and criminal possession of a controlled substance in the fifth degree.

Supreme Court Justice Peter Vallone, Jr. yesterday sentenced the defendant to a determinate term of eight years in prison, to be followed by five years' post-release supervision. The defendant will also be required to register as a sex offender.

According to Court records, the defendant met the victim, who was a runaway teenager, in September 2020. He manipulated the youngster into thinking he would help her find freedom. Adderley rented a room at the Hillcrest Hotel in Queens and taught the victim how to sell her body for cash. The defendant also had sexual intercourse and oral sex with the teenager, who was nearly half his age. The defendant's orchestrated a trip to the now-shuttered Umbrella Hotel on Queens Boulevard, where an undercover New York Police Department team rescued the child. The defendant was discovered by police outside the hotel in his car waiting for the victim. During the arrest, police recovered dozens of glassines of cocaine.

Assistant District Attorney Kiran Cheema, of the District Attorney's Human Trafficking Bureau, prosecuted the case, under the supervision of Assistant District Attorney Jessica Melton, Bureau Chief, Assistant District Attorney Tara DiGregorio, Deputy Bureau Chief, and under the overall supervision of Executive Assistant District Attorney for Investigations Gerard A. Brave.

# Guru Arjan Dev: The fifth Sikh master whose martyrdom changed the course of Sikhism

**GURU ARJAN DEV JI'S MARTYRDOM FALLS ON JUNE 3, 2022**

Guru Arjan (April 15, 1563 - May 30, 1606) was the first of the two Gurus martyred in the Sikh faith and the fifth of the 10 Sikh Gurus. He compiled the first official edition of the Sikh scripture called the Adi Granth, which later expanded into the Guru Granth Sahib.

He was born in Goindval, in the Punjab, the youngest son of Bhai Jetha, who later became Guru Ram Das, and Mata Bhani, the daughter of Guru Amar Das. He completed the construction of Darbar Sahib at Amritsar, after the fourth Sikh Guru founded the town and built a pool. Guru Arjan compiled the hymns of previous Gurus and of other saints into Adi Granth, the first edition of the Sikh scripture, and installed it in the Harmandir Sahib.

Guru Arjan reorganized the Masands system initiated by Guru Ram Das, by suggesting that the Sikhs donate, if possible, one-tenth of their income, goods or service to the Sikh organization (dasvand). The Masand not only collected these funds but also taught tenets of Sikhism and settled civil disputes in their region. The dasvand financed the building of gurdwaras and langars (shared communal kitchens).

In the year 1606, the fifth Sikh guru, Guru Arjan Dev, was captured by Mughal Emperor Jahangir and imprisoned in Lahore Fort. Part of the reason was the fact that he had blessed Jahangir's rebellious son Khusrau, and part because of his growing influence in Northern India and fast conversions to Sikhism that threatened the orthodox Muslim clergy as well as the Hindu elite.

After imprisoning the guru, Jahangir demanded Rs 2 lakh as a fine plus elimination of all texts from the Adi Granth, the Sikh holy book the guru had compiled, that could be 'offensive' to Hindus or Muslims.

But the guru was unrelenting and refused to omit anything from the Granth, so the Mughal emperor condemned him to be tortured to death. Famously, the guru was made to sit on a burning hot plate, hot sand poured on his face. It is said that when he was allowed to take a bath in River Ravi on 30 May 1606, he never returned. It is here that Gurdwara Dera Sahib in Lahore stands.

## The making of Harmandir Sahib

Born on 15 April 1563 to Guru Ramdas and Bibi Bhani, Arjan Dev was chosen by his father as his successor even though he was the youngest son. The decision may have led to disputes, but what is undisputed is the fifth guru's legacy.

One of the most visible, tangible and iconic contributions of Guru Arjan Dev is that he was the one who conceived of and began the construction of Harmandir Sahib, or the Golden Temple,



in Amritsar.

Arjan Dev wanted Harmandir Sahib to stand for inclusivity, a place where everyone was welcome. It is on these values that he designed the temple, which has four entries and exits denoting acceptance of the 4 Hindu

castes and all religions.

The guru also invited the renowned Muslim saint Mia Mir to lay the foundation stone of the temple. Instead of making the temple a towering elevated monument, he decided to place it at a lower elevation as a symbolic

gesture, so that one would feel humble upon entering the temple.

## The Adi Granth

Guru Arjan Dev is credited with compiling the Adi Granth which was completed in 1604. It is a compilation of the hymns composed by Guru Nanak and 32 other Hindu and Muslim saints including more than 2,000 hymns that he composed himself. This included works of Sheikh Farid, Bhagat Kabir, Bhagat Ravi Das, Dhanna Namdev, Ramannand, Jai Dev, Trilochan, Beni, Pipa, and Surdas. The Adi Granth was later declared as the ultimate Guru Bani or word of god by Guru Gobind Singh. He added 115 hymns composed by Guru Tegh Bahadur in the second rendition and the Adi Granth became the Guru Granth Sahib. The first copy of the Adi Granth is kept in Kartarpur at Gurdwara Thum Sahib.

## Influence on Sikhism

Even though Guru Arjan Dev played a vital role in completing the Adi Granth and Harmandir Sahib, two of the holiest and strongest symbols of Sikhs, it's in his death that his influence on the religion is strongest. Before he was summoned to Lahore by Jahangir where he was captured and later executed, Arjan Dev had appointed his son Hargobind as his successor.

When Guru Hargobind took the throne, he was the first Sikh guru to deviate from the poet-guru tradition established since Guru Nanak. Armed with two swords dangling by his waist, Hargobind changed the identity of the Sikh guru who was here to save the Sikhs from oppression by the Mughals. The sacrifice of Guru Arjan Dev was looked at as a sacrifice for the truth, and it became un-Sikh like to stand oppression. The guru's death became a watershed moment as from then on began the militarisation of Sikhs. This conflict that started between the Mughals and Sikhs with the execution of Arjan Dev continued till the last guru, Gobind Singh who finally established the militarised order, the Khalsa, in 1699.

## Guru Arjan Dev teachings

Guru Arjan Dev used to preach the message of God which was initiated by Guru Nanak Dev Ji. Guru Arjan Dev ji compiled the Adi Granth. This is the religious scripture of Sikhs. It consists of musical ragas and spiritual poetry. Adi Granth constitutes half of his teachings. It was installed at Harmandir Sahib. Later it was expanded and came to be known as Guru Granth Sahab. He contributed more than 2000 hymns, which is the largest collection in the Guru Granth Sahab.

# 'World order' in the context of Ukraine war

Three terms - 'corruption', 'terrorism' and 'world order' - are highly unlikely to be defined or resolved through consensus (being contentious) on any international forum. Why? Because there's bound to be several antonyms for each of these three words, meaning different things to different nations. 'Corruption' may be "subjective and biased inference" for an accused. 'Terrorism' could fluctuate between 'oppression' for the victim and the stamp of 'freedom fighter' for the perpetrator. And 'world order', being completely out of bounds, hence a joke, by a state feeling victimized by the brute force of the majoritarian club with money, muscle power and machine guns. Seen thus, one needs to delve deep into the 'world order' with reference to the ongoing conflict in Europe.

As is known, world history of the past 200 years shows a bewildering variety of alliances crisscrossing the diplomatic high table, wherein the stronger invariably dominated to set the conventional and time-tested route for a "world order" of the "fittest". Despite this collective intention, however, incessant wars continued over the two centuries, which ultimately led to the establishment of the League of Nations in 1919 and, thereafter, the UN in 1945. Masterminded by the victorious (but battered) West, the aim was to create a "world without war" (at least for the developed West) through an interconnected "globalized world order", essentially, to create, consume and concentrate the lion's share of the wealth in, and for, the West.

But that's not to be yet as is proved by another of the West-origin insatiable conflicts in the West-land, which menacingly drags the non-West (like the two World Wars of the 20th century) to a crisis-like situation of all-round shortage and scarcity, thereby fracturing the world's trade, food, finance, fuel and economic foundation.

For more than three decades, the West's over-emphasis on "globalization" and "inter-connectivity" ignored the fact that bilateral ties constitute the core competence of every nation-state in search of stability in the proximity, rather than a far-off "world order". Bilateral relations, thus, are the cornerstone of international diplomacy; else, what's the logic of having an ambassador of 'X' in 'Y' and vice versa? Therefore, all multilateral agreements, diplomacy or convention can be considered as supplementary means to strengthening international relations and diplomacy through consensus and agreement.

In the context of the Russia-Ukraine conflict, however, a big question mark suddenly appears as to the future status and position of several multilateral agreements. All these are connected with the collective security of the West, with a broken Russia as the principal potential adversary.

So, as Moscow and Washington turn implacable foes from February 2022, what happens to the Russia-US "Bilateral Consultative Commission (BCC)", a forum established in 2010 on the "Measures for the Further Reduction and Limitation of Strategic Offensive Arms"? All the more, as "its work is confidential"?

Again, how can Russia still fit into the 1992-established, 12-member "Council of the Baltic Sea States (CBSS)" of Denmark, Estonia, European Union, Finland, Germany, Iceland, Latvia, Lithuania, Norway, Poland, Russia, Sweden? Established as a "regional inter-governmental organization" for co-operation among the Baltic Sea region states, all of 11 today are against (nay, hostile towards) Russia and trying to choke the range of the Russian gun and gas with the reach of the American greenback.

What further stands remote and far-reaching, inadvertently or otherwise, is that the West does appear to have sown seeds of a major European conflict owing to its inability to create an ambience of mutual trust, faith and confidence with its giant eastern landmass spanning from (the border of) Vilnius to Vladivostok in the Far East.

The reality is, mutual trust rarely developed between the West and Russia in every era. They only changed the names of rulers on both sides, but rarely the spirit of the formation of alliance, entente or convention. 'Containment', indeed, was the password for any alliance with the Communist USSR.

Thus, came into existence in 1994 the Mediterranean Dialogue as a "forum for political dialogue" and cooperation between NATO member-states and countries of the Mediterranean (Algeria, Egypt, Israel, Jordan, Mauritania, Morocco, Tunisia). NATO's post-USSR overdrive was visible.

Subsequently, NATO progressed from the Mediterranean towards the Russia underbelly in 2008 with the establishment of the 'NATO-Georgia Commission (NGC)' to "serve the forum for political

consultation and practical cooperation to help Georgia achieve its goal of joining NATO."

The year 2008 also saw the launch of the Regional Cooperation Council (RCC) as a successor of the 'Stability Pact for South-Eastern Europe' that was initiated by the European Union at the 1999 "conference of South-Eastern Europe". Its ostensible purpose was to promote "mutual cooperation and European and Euro-Atlantic integration of states in South-Eastern Europe."

In retrospect, what strikes strange is the conspicuous absence of Russia in matters relating to South-Eastern Europe, which mutually are adjacent to each other. There were six areas of discussion for the 46 participants (included in which was NATO): "Economic and social development, energy and infrastructure, justice and home affairs, security cooperation, human capital and parliamentary cooperation." It was a virtual NATO-EU mega joint event at Moscow's vulnerable doorstep where even Kosovo was present! But, Russia absent? Was it a prelude to our turbulent times?

The somber mood was vividly expressed on May 2 by no less than the universally revered, but distraught, Pope Francis.

That the break-up of the mighty USSR constituted a lifetime opportunity for Moscow rivals would be an understatement. Understandably, once a mighty Moscow; now one of the 13 members (including Ukraine) of the "Organization of Black Sea Economic Cooperation (BSEC)" established in 1992 to "ensure peace, stability, prosperity... economic cooperation and promotion" with its permanent secretariat at Istanbul.

Of all the West-sponsored networks, however, what stands out afresh is the NATO-Ukraine Commission (NUC), established in 1997 "for consultations on political and security issues, conflict prevention and resolution, non-proliferation, transfer of arms technology and subjects of common concerns." The NUC had all NATO member-states and Ukraine as participants. The Russians saw, but had to swallow their pride, as NATO arrived inside Ukraine six years after Moscow lost power, prestige and status.

In hindsight, therefore, one can only take a cue from common sense and scholars' comments: that one factor cannot create an overnight conflict, and that it takes time to build up confrontation and a combat-like situation. War psyche bursts only when the gestation period matures.

As the conflict of the West now ravages the Europe heartland for more than three months, the January 2022 utterances of former German navy chief (Kay-Achim Schonbach) in an India meeting deserves recollection: "On the eye level, President Putin deserves respect. # The return of the great power rivalries

**T**he post-Cold War period of peace in Europe is more an aberration than norm in the continent's history of conflicts.

Herr von Tschirschky, a diplomat and politician in imperial Germany, said on New Year's Day 1906 in Hamburg: "Germany's policy always had been, and would be, to try to frustrate any coalition between two states which might result in damaging Germany's interests and prestige; and Germany... would not hesitate to take such steps as she thought proper to break up the coalition." Tschirschky, who would become Foreign Secretary in two weeks, was referring to the Franco-British Entente and Germany's growing concerns about it.

The security situation in Europe was undergoing massive changes. The Russian power had collapsed in its far east after the war with Japan in 1904-05. Faced with the erosion of Russian influence and the rise of Wilhelmine Germany, which together threatened to alter Europe's balance of power, France and Britain, competing colonial powers, came together. France had already reached an alliance with Russia. The three would later form the Triple Entente, triggering a dangerous security competition in Europe with the Triple Alliance (Germany, Austria-Hungary and Italy), which would eventually lead to the First World War in 1914.

## Similarities from the past

There are similarities between events in Europe today and what happened in the late 19th and early 20th centuries. What triggered the great power security competition in the run-up to the First World War was the phenomenal rise of Wilhelmine Germany as a military and industrial power and the regional hegemons' response to it. When Otto von Bismarck became the Minister-President of Prussia in September 1862, there was no unified German state. Prussia was part of the loose, ineffective German Confederation. Bismarck adopted an aggressive foreign policy, fought and won three wars - with Denmark, Austria and France - destroyed the confederation, established a stronger and larger German Reich that replaced Prussia.

In the last 20 years of Bismarck's reign, Germany, and Europe at large, saw relative peace. That was not because the Chancellor had turned a peacenik but because he was constrained by the geopolitical realities of Europe. Bismarck stayed focused on transforming Germany internally in his last two decades. It was on the foundation Bismarck built that Wilhelmine Germany turned to *weltpolitik* in the early 20 century, seeking global domination.

If Bismarck inherited a weak, loosely connected group of German speaking entities in 1862, Russian President Vladimir Putin got a Russia in 2000 that was a pale shadow of what was the Soviet Union. Russia had lost huge swathes of territories, its economy was in a free fall, its currency had crashed, the living standards of millions of Russians had collapsed and the global stature of the country, which had been one of the two pillars of the post-War global order for almost half a century, had fallen. Bismarck spent his years in power expanding the borders of Germany and building a stronger state and economy. His successors took it further to challenge the existing great powers in Europe. The post-Cold War Russia initially stayed focused on the restoration of the state and the economy, and then sought to expand its borders and challenge the continent's balance of power - first the Crimean annexation and now the Ukraine invasion.

The existing great powers in Europe saw Germany as a threat to Europe's balance of power and joined

hands to contain its rise. Germany, on the other side, saw the formation of the Entente as an existential threat and took steps to weaken the alliance (The 1905 and 1911 Morocco crises and the German intervention in the Bosnia crisis in 1908). The parallels are hardly to be missed. If Germany was seen as a revisionist power back then, Vladimir Putin's Russia is today's revisionist power in Europe. If Germany felt insecure by the Triple Entente, as Tschirschky warned in 1906, Russia has constantly voiced concerns about the eastward expansion of the North Atlantic Treaty Organization (NATO). If the Entente countries looked at the rise of Germany as a threat to European power balance, the western alliance continued to see modern Russia as a security challenge, even after the collapse of the Soviet Union. While NATO's expansion deepened Russia's security concerns, driving it into aggressive moves, Russia's aggression has strengthened NATO's resolve to expand further into Russia's neighborhood.

## On 'offensive realism'

The behavior of 20th century Germany and 21st century Russia can best be explained using what John Mearsheimer calls "offensive realism". Offensive realists argue that "revisionist powers" tend to use force to rewrite the balance of power if they find the circumstances are favorable, while the status quo powers, or the existing regional hegemons, would seek to thwart any new country attaining more power at their expense. The result of this type of competition is

permanent rivalry and conflict. Look at Mr. Putin's offensive moves. He sent troops to Georgia, practically ending that country's NATO ambitions. He took Crimea without fighting a war. He sent troops to Syria not just to save the regime of Bashar al-Assad and protect Russia's Mediterranean naval base in Tartus but also to neutralize Turkey and Israel, both Syria's neighbors. He reinforced Russia's primacy in Central Asia by bringing peace to the Nagorno-Karabakh and dispatching forces to restore order in Kazakhstan. These successes probably raised the confidence of Russia, prompting its leaders to believe that it was finally strong enough to change Europe's balance of power forcefully. Then, Russia invaded Ukraine.

But one major difference between the era of Wilhelmine Germany and modern Russia is that there were no well-defined international laws in the 19th and early 20th centuries. The international system has evolved ever since. But its basic instincts, as realists would argue, have not changed much. Mr. Putin's Russia is not the first country that violated the sovereignty of a weaker power and flouted international laws in the "rules-based" order. Nor will it be the last. As the Athenians told the Melians during the Peloponnesian War, "the strong do what they can and the weak suffer what they must".

## Security competition

As the Ukraine war grinds into its fourth month, there are no clear winners in Europe. Russia apparently had two strategic objectives in Ukraine - one, to expand Russian borders and create a buffer. And two, to reinforce Russia's deterrence against NATO. While Russia has succeeded, though slowly, in expanding its borders by capturing almost all of Ukraine's east, the war has backfired on its second objective - Russia's inability to clinch a quick outright victory in Ukraine and the tactical retreats it has already made have invariably dealt a blow to the perception of Russian power that existed before the war. This has strengthened NATO, driving even Sweden and Finland into its arms. Besides, the economic sanctions would leave a long-term hole in Russia's economy.

But a Russia that is bogged down in Ukraine and encircled by NATO need not enhance Europe's security. Russia's advances in Ukraine may have been slow; it seemed ready to fight a war of attrition like the long wars European countries fought against each other in the past. And despite the strong resistance it faced in Ukraine, Russia remains too strong a military and geopolitical power to be brushed aside. As Henry Kissinger said at Davos, Russia had been and would remain an important element in the European state system.

The prospects are bleak. There will not be peace in Europe unless either Russia accepts its diminished role and goes into another spell of strategic retreat (like it did after the disintegration of the Soviet Union), or Europe and the West in general accommodate Russia's security concerns. Both look unrealistic as of today. This means that even if the war in Ukraine comes to an end, the security contest in Europe would continue. The post-Cold War period of relative peace and stability in Europe, anchored in liberal internationalism, was an aberration rather than a norm in the continent's long history of conflicts. And what makes the latest round of great power rivalry more dangerous is that there are nuclear weapons on both sides.

# Sidhu Moosewala assassination case: AAP govt lands deep in hot waters

In less than 10 weeks of its landslide triumph in the Assembly elections of this trouble-torn revenue deficit border State, the ruling Aam Aadmi Party (AAP) is finding itself knee deep in hot waters. The reason: a highly publicized action that boomeranged on its face.

Neither the Chief Minister Bhagwant Mann nor any of the senior members of the High Command of AAP, including its Convener, Arvind Kejriwal, could visualize the serious consequences they would counter for their action of cutting down security cover of eminent personalities, including politicians, religious leaders, artists, and policemen.

The broad daylight assassination of folk singer-turned budding politician Sidhu Moosewala not only evoked worldwide condemnation but also

painted the action of the first-time ruling party in the State as a cheap and unlawful gimmick.

Needless to reiterate that security is a sensitive issue that is seldom revealed in public domain.

In less than 24 hours of issuance of orders of withdrawal or reduction of security cover to over 400 eminent personalities, the State plunged into one of its worst glooms in recent years with the killing of Sidhu Moosewala who had unsuccessfully contested the Punjab Assembly elections early this year.

Intriguingly, copies of the order, though confidential and marked "secret", were made available to the entire media for "wide publicity" as "another daring step by the "Government that works for people."

Without getting into the merits of the action or the order, the way it was publicized not only defeated its purpose but also made all those who felt aggrieved by it more "vulnerable".

The subsequent explanation by the State police chief that the order was part of an annual exercise of making available additional security personnel for deployment for "ghallughara week" duties.

The present strength of Punjab police is more than 70,000. In addition, it has some Punjab Armed Police (PAP) battalions as well as India reserve battalions. Punjab also has a couple of trained Commando battalions. Of these men in uniform, nearly 30,000 to 35,000 are deployed in 300-odd police stations and police posts in the State.

Providing security cover to individuals or institutions is a highly sensitive subject that need not be discussed in any public domain. In the past a little more than 10 weeks of assuming power in the State, the AAP government has been issuing orders from time to time in reviewing security cover of political bigwigs and others. Such reviews were also widely publicized as was the last order of May 28.

In India, there are various agencies that provide security cover to individuals and vulnerable institutions, including installations. They include those that are under direct control of the Central Government like the Ministry of Home Affairs or the Ministry of Defense. They assess the threat perception and accordingly provide the security cover that at times work in close coordination with the State Security Agencies depending upon the movement of the protected personalities.

In addition to the Centre, the State Governments have their own Security wings that function under a senior police officer. Though broadly, the State Security agencies follow the same pattern of assessing the threat perception before deciding the quantum of security cover in each individual

case. Normally, there is a regular review of security cover with changing threat perceptions, but this practice is not followed religiously. It is in rarest of rare cases that the State police extends its security cover to individuals who are neither Bonafide residents of the State nor have any threats emanating from within the State. There are numerous when security audits are not conducted, and even if they are done, they are only to complete the formalities.

There is no denying the fact for many, security cover is more of a "status symbol" than a necessity. The bigger or larger the security cover is used to gauge one's political or social height.

Security experts say that there is nothing like "absolute" or "foolproof" security. Their observation is corroborated by high profile assassinations taking place world over from time to time.

During my nearly 40 years stint in journalism, I reported several cases in which well protected political bigwigs, policemen or others were attacked. Many of these turned out to be gruesome assassinations, while few others left their victims shattered or crippled.

Security is a highly debatable subject as the State is mandated to protect life and property of its populace. However, deviating from this Constitutional mandate, the State or the people given the mandate to run the State start their own isolation on the pretext of security. Safety and security of a common man is getting greatly ignored.

Intriguingly, nearly 80 per cent of the police force in Punjab is undertrained.

Studies from time to time reveal that nearly 80 per cent of the training budget of the police force is consumed by the top 5 to 10 percent of the force that generally covers up the gazetted officer's level. Eight to 10 percent of the training budget is spent on the NGOs, who comprise about 10-15 per cent of the total strength and for the remaining 70-75 per cent, the constabulary, gets only five to eight per cent of the training Budget. Majority of the policemen undergo mandatory training only at the time of their induction in the force and seldom afterwards. They are the "lathi" or cane wielding policemen chosen to do route marking or simple beat duties with little or no power of investigation. They are the mainstay of the "visible" security for VIP visits or mass political events. Invisible security is an area that has generally remained ignored.

There may not be a single policeman to ensure the safety of hundreds of people at a busy marketplace, bus stand or railway station but a political bigwig or a senior police official comes surrounded by a horde of armed guards. The strength of the horde indicates the political or official rank of the protected politician or civil servant.

# Sidhu Moosewala: A life snuffed out in the prime of youth

*Ni ehda uthuga jawani ch janaja mithiye* (The funeral will happen in youth).

This is a line from Indian rapper Sidhu Moose Wala's latest track, The Last Ride. The song, which was released in May - and has gathered over 10 million views on YouTube since - features the iconic crime scene where American rapper Tupac Shakur was murdered in his BMW in 1996.

"Many hated him, and many died wanting him... everything is revealed in the eyes of the young boy," Moose Wala cackles in the music video, which is shot in slick monochrome tones.

On Sunday, in an ominous turn of events, Moose Wala met the same fate. The 28-year-old singer was shot dead by unidentified attackers in Punjab's Mansa district, not too far from his home on Sunday, May 29, evening. The incident came a day after the AAP government in Punjab pruned his security.

The killing has triggered huge row and protests, with the Congress - the political party to which he belonged - calling for the dismissal of the ruling AAP government. His family has sought an investigation by a central probe agency.

For Moose Wala's millions of fans though, the tragedy is deeply personal.

In a career spanning just four years, the 28-year-old rapper had become one of the most ubiquitous faces of Punjab's fertile hip-hop scene. His voice blares from DJ turntables at Delhi's flamboyant parties, rickety stereos at tea stalls in rural India and - as a colleague from BBC Punjabi told me - every possible radio channel in Punjab.

And he made it big in every sense. His songs, which he wrote and composed, racked up more than 5bn views, made it to the Top 5 in the UK charts last year, and he was also featured among the best new artists of 2020 in The Guardian. He had millions of fans around the world, especially in Canada and the UK which have a sizeable diaspora population.

Born as Subhdeep Singh Sidhu in Moosa village in Mansa district, the singer studied engineering from Punjab and moved to Canada in 2016. The next year, he released his first track "So High" under the name Moose Wala - a tribute to his village.

Since then, he had released three albums and more than 60 singles - at one time, the legend goes, he was churning out a song a week - and became a household name in Punjab and among Sikhs living abroad.

Drawing heavily from the genre of gangster rap, his music was a jumble of gritty opulence - measured in guns and fancy sports cars - as he made sense of life around him. His songs offered unvarnished commentary on the dark underbelly of the rural heartland, where drugs, crime and corruption often make headlines.

But Moose Wala was as controversial



as popular. Since news of his death broke on Sunday evening, heaps have been said and written about the singer's legacy.

The actor often ran into trouble with the law. In May 2020, he was booked for firing an AK-47 rifle at a shooting range during the Covid lockdown. He also had a police case against him for allegedly promoting violence and gun culture through his song, Sanju. And a cursory glance at his Instagram profile would reveal his affinity for the weapon.

The singer was never convicted for any of the alleged crimes, but critics have routinely called him out for normalising violence.

Fans say that Moose Wala was merely confronting the dark truths about modern life and holding up a mirror to society. "He was just making sense of the chaos, whether it was corruption, violence or the gun problem in Punjab," one fan said. "And that contribution in itself is valuable."

Moose Wala's music has meant different things to different people. Some say they admired him for the "courage and I-don't-care attitude" that was evident in his songs. Others liked the way he added English words to his Punjabi songs, which gave it a contemporary sheen.

For Moose Wala, though, everything was a deeply personal journey of self-expression. In 2021, he decided to give politics a chance. Although he lost the Punjab assembly election earlier this year, it didn't tarnish his popularity or his reputation as a man of the soil.

## Five songs that launched Moose Wala to superstardom

Sidhu Moose Wala began his singing career with a duet titled G Wagon. He also collaborated with Brown Boyz on several songs. The singer-rapper gained popularity with his track So High (2017). In 2018, he released his debut album PBX 1, which ranked 66th on the Billboard Canadian Albums chart.

The singer released a song titled The Last Ride on May 15. The song, which was shared on his official YouTube channel, has already close to 10 million views.

- **So High** is one of the most loved songs of Sidhu Moose Wala. The song is almost four-minutes-long and became popular with the masses. The song has over 481 million views on YouTube.
- **Same beef** is a part of an album of the same name, released in 2019. Composed by Byg Byrd, the song was sung by Bohemia and Sidhu. It has over 394 million views on YouTube.
- **Just Listen** was written by Sidhu Moose Wala and released in January 2018. It has over 144 million views on YouTube.
- **Famous** released in 2018 and is from the album PBX1. It was produced by Pyg Brd.
- **Badfella** was released under T-series and was produced by Harj Nagra. On YouTube, the song has over 91 million views.

## IRS EXTENDS VITA AND TCE GRANTS APPLICATION DEADLINE

applications for the Tax Counseling for the Elderly (TCE) and Volunteer Income Tax Assistance (VITA) grant programs which will allow some organizations to apply for annual funding for up to three years.

Grants.gov will continue accepting applications through June 17, 2022, for the TCE and VITA grant opportunities. Application packages and guidelines for 2022 are available on the IRS website.

The IRS, in the past year, awarded 34 TCE grantees \$11 million and 300 VITA grantees \$25 million. Last year, the two grant programs filed nearly 1.6 million returns nationwide.

The IRS established the TCE program in 1978 to provide tax counseling and return preparation to persons aged 60 or older and to give training and technical assistance to the volunteers who provide free federal income tax assistance within elderly communities across the nation. The VITA Grant program was established in 2007 to supplement the VITA program created in 1969. VITA provides free tax filing assistance to underserved communities. ## US Presidential Commission recommends translating federal websites in Hindi, Gujarati and Punjabi, among other Asian languages

**WASHINGTON, D.C. (TIP):** A US Presidential

Commission has recommended the translation of key government websites, such as the White House and other federal agencies, in languages spoken by Asian-Americans and Pacific Islanders, including Hindi, Gujarati and Punjabi.

A series of recommendations in this regard were recently approved by the President's Advisory Commission on Asian Americans (AA), Native Hawaiians, and Pacific Islanders (NHPI). The full commission at its meeting here early this month had recommended that federal agencies should provide key documents, digital content, and forms on their websites translated into multiple AA and NHPI languages. It also recommended that public and emergency alerts should be accessible to persons with limited English proficiency. The full commission also recommended that the federal government should ensure that emergency/disaster prevention, planning, response, mitigation, and recovery programs are inclusive of and reflect the lived experiences of limited English proficient populations.

The set of recommendations now move to the White House for the president to take a final call on it.

Such a series of recommendations is in the pipeline for some time now after Indian-American Ajay Jain Bhutoria had run a multi-language publicity campaign for Democratic candidate and now US President Joe Biden ahead of the 2020 election. Election campaigns in Hindi, Gujarati, Punjabi, Telugu and other South Asian languages helped the Biden campaign make a deep impact in the community. Based out of Silicon Valley and a successful entrepreneur, Bhutoria is now one of the members of the President's Advisory Commission on Asian Americans, Native Hawaiians, and Pacific Islanders (Commission).



## During pandemic, India and US played critical role in supporting each other: Ambassador Sandhu

**WASHINGTON, D.C. (TIP):** Over the last two years, there has been a tremendous challenge due to the disruption in global supply chains and like the US, India has also been affected, he said in his address to the Indiana Economic Summit in Indianapolis.

However, through careful policies and a concerted focus on rebuilding their capabilities, they have managed to emerge from the pandemic stronger, Sandhu said this week.

"During this period, India and the US played a critical role in supporting each other," the Indian envoy said.

This was particularly so in health supply chains where India supplied critical medicines and personal protective equipment to the US in 2020, Sandhu said.

"We supplied nearly two million masks to Philadelphia. The US reciprocated with vaccine and drug components during the second Delta wave in India in 2021. India demonstrated that it was a reliable supply chain partner to the US even in difficult circumstances.

## GUNMAN KILLS 4 BEFORE SHOOTING HIMSELF AT HOSPITAL IN OKLAHOMA

**OKLAHOMA (TIP):** A gunman carrying a rifle and a handgun killed four people on Wednesday, June 1 at a Tulsa medical building on a hospital campus, police said, the latest in a series of deadly mass shootings across the country in recent weeks, AP reported.

Tulsa Police Department Deputy Chief Eric Dalgleish confirmed the number of dead and said the shooter also was dead, apparently from a self-inflicted gunshot wound.

The spate of recent gun violence across the country, including the killing of 19 children and two teachers at a Texas elementary school eight days ago by an 18-year-old gunman carrying an AR-style semi-automatic rifle, has led to Democratic leaders amplifying their calls for greater restrictions on guns, while Republicans are emphasizing more security at schools.

The divide mirrors a partisan split that has stymied action in Congress and many state capitols over how best to respond to a record-high number of gun-related deaths in the U.S.

It was unclear what prompted the deadly assault in Tulsa, Dalgleish said.

"It appears both weapons at one point or another were fired on the scene," Dalgleish said. "The officers who arrived were hearing shots in the building, and that's what led them to the second floor."

Police responded to the call about three minutes after dispatchers received the report at 4:52 p.m. and made contact with the gunman roughly five minutes later, at 5:01 p.m. Dalgleish said.

"I was very happy with what we know so far regarding the response of our officers," Dalgleish said.

The length of time it took police officers in Uvalde, Texas, to engage the gunman during last week's deadly shooting at Robb Elementary School has become a key focus of that investigation.

# Operation Blue Star — A festering wound

38 years after it took place, the infamous Operation Blue Star is a festering wound for the Sikh community the world over whose psyche was terribly hurt to find their Holiest Shrine desecrated, the Holy Akal Takht — sign of the Sikh dignity-raged to the ground, and thousands of innocent pilgrims killed, all in the name of neutralizing "Sikh extremists/ militants" led by Sant Jarnail Singh Bhindranwale. Hundreds of books and thousands of articles have been published on the issue, and the authors have analyzed the causes and the effects, and, of course, their views on the issue diverged, but almost all have questioned the need and wisdom to have a military operation to "neutralize the Sikh extremists / militants".

Just as the Jews have not forgotten the Holocaust, the Operation Blue Star will continue to be a festering wound for the Sikh community.

It happened 38 years ago but it feels as if it was yesterday – the heart, body and mind still feel the tremors of the emotional earthquake it caused. The force of those tremors intensifies every year when June 6 approaches. Operation Bluestar (saka neela tara), a fancy-sounding name given to a dreadful military action at the Sikhs' holiest shrine, the Golden Temple in Amritsar, was launched on June 2, 1984, with a 'national broadcast to the nation' by then prime minister Indira Gandhi. It was claimed to have been completed successfully on June 6 with the ending of the last resistance by Sikh combatants to the army's entry at the Temple. State media (TV and radio) and other non-state media outlets praised the operation for saving India's 'unity and integrity' from 'anti-national' Sikh secessionism.

The most reliable estimates of the total number of deaths during Operation Bluestar range from 5,000 to 7,000. It was a tragedy that could have been avoided if – and it is a big if – Indira Gandhi had had the vision to reach a political settlement with the moderate Akali leadership. Most Akali Dal demands – regarding federal decentralisation, river water rights, territorial readjustment and the transfer of Chandigarh to Punjab as its capital – could have been negotiated. Rajiv Gandhi did agree to each of these demands, and many more besides, in the 1985 Rajiv-Longowal Accord. He implemented none.

Indira Gandhi's political decision to use the 'Hindu card' to gain electoral victories led her to choose a dangerous path of confrontation, first with the Akalis and eventually with the entire Sikh community. This miscalculation cost Mrs Gandhi her life, and left the

communities of Punjab and of India in general scarred and polarised. This polarisation peaked with the genocidal violence against the Sikh minority in

Delhi and many other North Indian Hindu majority towns in November 1984 after the assassination of Indira Gandhi by two of her Sikh security guards. Sikh nationalists in Punjab were eventually defeated, at least militarily, by the 1990s, but Hindu nationalism was promoted so powerfully that the Hindu nationalists succeeded within a few decades in capturing the Indian state.

In the Sikhs' collective memory of 1984, the deaths by army action in June and those by genocidal mob violence in November constitute two ends of the same arc of killings. The two cannot be separated and, therefore, remain indelibly linked to the memory of Operation Bluestar, which is seen as the trigger both for the killings and for later disappearances, killings in custody and deaths by 'encounters' during the military operations against the armed Sikh opposition movement after the events of 1984.

Operation Bluestar is gradually finding a place in the Sikh practice of ardaas (prayer). This practice is unique in the

history of world religions because it gives collective memory a central place. On all important occasions – birth, marriage, death, new job, promotion, passing an examination, new house, Gurpurab celebrations (in honour of the gurus' birthdays), or even the daily rituals in a gurdwara – the ardaas recounts in capsule form the history of the Sikh faith.

The ardaas narrative starts with the founding of the faith by Guru Nanak, its continuation by his nine successors and the sacrifices made by the tenth guru Guru Gobind Singh's four sons (sahibzade), the five Beloved Ones (panj piare), the 40 Liberated Ones (chali mukte) and numerous other martyrs right up to the present time. Sikhs have a long memory. Udham Singh waited for 21 years to avenge the Jallianwala Bagh massacre of 1919 by assassinating Michael O'Dwyer in 1940. The Naxalite Sikhs punished a Sikh landlord Ajaib Singh Kokri, a witness against the revolutionary Bhagat Singh, by assassinating him in 1974, 43 years after Bhagat Singh was hanged in 1931. The

socialisation from early childhood of anyone growing up in a Sikh household (irrespective of the political affiliation of the household) involves such a focused exercise in historical remembrance that most adult Sikhs remember the ardaas by heart, whether they are illiterate farmers or university academics. The ardaas contributes to the making of an active historical being who remembers the past, relates that past to the present and imagines the shaping of the future.


### Blue Star bloodbath

Shortly after 10.30 p.m. on June 5, 1984, 20 men in black dungarees stealthily entered the Golden Temple. They wore night-vision goggles, M-1 steel helmets, bulletproof vests and carried a mix of MP-5 submachine guns and AK-47 assault rifles. The men of sg's 56th Commando Company were then the only force in India trained for room intervention, the specialised art of fighting in confined spaces. Each commando was a sharpshooter, diver and parachutist and could do 40-km speed marches. Some of them wore gas masks and carried stubby gas guns meant to launch CX gas canisters, a more potent tear gas. Three months before this night, the commandos had stayed around the temple and rehearsed for Operation Sundown. Some of them still sported the beards they had grown for their undercover work as volunteers in the Golden Temple's langar. When the plan was called off, they returned to their base in Sarsawa. They had flown into Amritsar the previous day at the request of Lt-Gen Sundarji.

The three battalions that Lt-Gen Brar's 9th Infantry Division sent into the Golden Temple that night were trained to fight a conventional combat on the plains of Punjab and in the deserts of Rajasthan. They would overwhelm the enemy by sheer force of numbers. The commandos, who spearheaded the assault, made use of stealth, speed and surprise to achieve results. Soon after arriving, one of the sg officers had briefed Lt-Gen Ranjit Singh Dayal, Sundarji's chief of staff, on a plan to capture the Akal Takht by blowing off its rear wall. General Dayal, a paratrooper who had captured the Haji Pir pass in an unconventional operation in the 1965 war, immediately overruled it. "There must be no damage to the Akal Takht," he said. The commandos were to capture the sacred building by using gas to flush out the militants, he said.

The Army had clearly underestimated the defences. As soon as they entered the temple, a sniper shot the unit's radio operator clean through his helmet. The rest took cover in the long gallery of pillars that led to the Akal Takht. Light machine guns and carbines crackled from behind impregnable walls of the temple, their multiple gun flashes blinding the commandos' night-vision devices, forcing them to take them off. The commandos and infantry soldiers cautiously advanced, sheltering behind rows of pillars. Those who tried to advance towards the Akal Takht were cut down on the marble parikrama. An armoured personnel carrier bringing in troops was immobilised by a rocket-propelled grenade. "Shabeg knew the Army's Achilles heel," says an SG colonel. "He knew we couldn't fight in built-up areas."

Post-midnight, remnants of the sg unit and the Army's 1 Para huddled near a fountain at the base of the Akal Takht. The area between the Akal Takht and the Darshani Deori that led to the Golden

Temple had turned into a killing zone, covered by Shabeg's light machine guns. Attempts by the para-commandos to storm the defences were repeatedly beaten back. They lost at least 17 men, their black dungaree-clad bodies lying prone on white marble. Commandos who tried to fire the CX gas canisters discovered that the Akal Takht's windows had been bricked up. The only openings were horizontal slots out of which machine guns poured deadly fire. The commandos neutralised two of the machine gun nests by dropping grenades into them but the Akal Takht was impregnable. Then, around 7.30 a.m. on June 5, three Vickers-Vijayanta tanks were deployed. They fired 105 mm shells and knocked down the walls of the Akal Takht. Commandos and infantrymen then moved in to mop up the defenders, tossing gas and lobbing grenades inside the building.

The temple premises resembled a medieval battlefield, one sg trooper recalls. Bloodied and blackened bodies lay scattered around the white temple parikrama. In the basement of the blackened, still-smoking ruin of the Akal Takht, the commandos found the body of Shabeg. The Army recovered 51 light machine guns, 31 of which had been concentrated around the Akal Takht. "Normally, an army unit (of around 800 soldiers) would deploy this quantum of firepower to cover an area of about eight km," Lt-Gen Brar recounted in his book Operation Blue Star: The

become the de facto rulers of Punjab in the last quarter of the 18th century. By 1799, one of them (Ranjit Singh) formalised that de facto rule to become the Maharaja of Punjab. The force of memory weighed upon him too and he ruled, therefore, in the name of the gurus. Some features of feudal degeneration which emerged during his rule were the result of his dissociation from the memory of the path of the gurus.

During the dark times the Sikh community faced from 1716, when the Sikh warrior Banda Singh Bahadur was martyred, to 1799 when Ranjit Singh came to power, Harmandar Sahib (later known more popularly as the Golden Temple) became the nerve centre for the moral, political, military, spiritual and even economic empowerment of the community. While living the life of guerrilla combatants against the Moghul powers, the leading members of the community would meet twice a year on Vaisakhi and Diwali for deliberations and collective decision-making for the future survival of the community. Once in the precincts of the Harmandar Sahib, they considered themselves protected by the Guru and had no fear of any earthly powers such as the Moghul rulers they had to confront. The mystique of the Harmandar grew and this mystique has continued and strengthened over the centuries. The Golden Temple has literally become the heart of the community.

The death, destruction and sacrilege caused during Operation Bluestar pierced the heart not only of the Sikhs but also of many Punjabi Hindus. The devastation it caused in the personal lives of so many millions has still not been fully recorded and acknowledged because the political divide over the attitudes towards Operation Bluestar has overshadowed the human stories.

A whole generation has grown up after the Operation and many in this new generation have become parents. They hear and read about the Operation and try to understand the meaning of it to reconnect to the history of their parents, their grandparents and before. Many of them are devising new tools and media to relate to that history. Of many doctoral dissertations I have evaluated as an external examiner, one by Shruti Devgun of Rutgers University, USA on 'Re-Presenting Pasts: Sikh Diasporic and Digital Memories of 1984' stands out for its subject and methodology. Her thesis focuses on the work of an intergenerational cohort of Sikhs in the diaspora (in the US and Canada) who are trying to piece together the fragments of painful pasts 'to give cultural meaning and shape to broken traumatic experiences'.

Through their work, they are puncturing, and perhaps demolishing, the Indian State's narratives of Operation Bluestar. This painful 'memory work' is creating new spaces for them to understand and connect with the pain of the victims of many other genocides e.g., the Jews, the Palestinians, the Armenians and the Rwandan Tutsis.

The wounds may never heal but by connecting your pain to the pain of others, the meaning and experience of pain is transformed.

However, I was not given any responsibility even after making me working president. I was not even invited to the key meetings of the party. It never arranged my press conference during the last three years," Hardik Patel said after he quit the Congress.

# ED summons Sonia Gandhi, Rahul in National Herald case

NEW DELHI (TIP)

Weeks after the Enforcement Directorate (ED) questioned Congress leaders Mallikarjun Kharge and Pawan Bansal in connection with its National Herald money laundering probe, the central agency has summoned the party's president Sonia Gandhi and Lok Sabha MP Rahul Gandhi to appear before it on June 8 in connection with the case filed six months ago.

The summons drew furious reactions from the Congress, which described the case as "weird" since "no money was involved" and said that the charges were "more hollow than a pack of cards". "We will face them. We are not a bit scared or overawed or intimidated by such cheap tactics," the party's spokesperson Abhishek Singhvi said at a press conference along with the party's communication head Randeep Surjewala.

Reacting to the Congress' allegations that the Government was trying to quell the opposition like how the British had tried during the freedom struggle, BJP president J P Nadda said that "documents don't lie, and documents are permanent and thereby they are being scrutinised". "The problem is with the face but the mirror is being cleaned," Nadda told reporters in Bhopal where he is on a three-day visit.

The ED case is based on a trial court order that allowed the Income Tax Department to probe the affairs of National Herald newspaper and conduct a tax assessment of Sonia and Rahul. The order was the result of a petition filed by BJP MP Subramanian Swamy in 2013.

Swamy's complaint had alleged cheating and misappropriation of funds on part of the Gandhis in acquiring the newspaper. Swami had alleged that the Gandhis acquired properties owned by National Herald by buying the newspaper's erstwhile publishers, AJL, through an organisation called Young India in which they have 86 per cent stake. Sonia and Rahul were granted bail in the case by the trial court on December 19, 2015.

In Swamy's complaint before the trial court, Sonia, Rahul and others have been accused of misappropriating funds by paying Rs 50 lakh for Young Indian (YI) to obtain the right to recover Rs 90.25 crore that AJL owed to the Congress.

It was alleged that YI, which was incorporated in November 2010 with a capital of Rs 50 lakh, had acquired almost all the shareholding of AJL, which was running



National Herald. The I-T department had claimed that the shares owned by Rahul in YI would lead him to have an income of Rs 154 crore and not about Rs 68 lakh, as was assessed earlier. It has already issued a demand notice for Rs 249.15 crore to YI for the assessment year 2011-12.

Earlier, ED had initiated a money laundering probe against AJL in 2018 in connection with a plot allotted to it in Haryana's Panchkula by then chief minister and Congress leader Bhupinder Singh Hooda. The ED had attached the plot, accusing the company of having acquired it "fraudulently". Hooda is an accused in the money laundering case registered by the agency in the matter.

The Congress said on Wednesday that the summons for Sonia and Rahul were received "just a few days ago" and Sonia will "100 per cent" appear before the ED. "If Rahul Gandhi is here, he will also go. Otherwise we will seek some time," Singhvi said.

Singhvi said that AJL had come under financial stress over the decades after which the Congress stepped in and over a period of time gave around Rs 90 crore as financial support. "So AJL became an indebted company, a company with debt. AJL did what every company in India does...it converted its debt into equity. So this debt of Rs 90 crore was assigned to a new company. It is called Young India so that the books of AJL become debt-free," he said.

## Lakhimpur Kheri violence witness attacked in UP

BKU leader Dilbag Singh, a witness in the Lakhimpur Kheri violence case, was allegedly attacked by two men here, police said on Wednesday, June 1.

The attack took place on Tuesday night when the Bhartiya Kisan Union (Tikait) district president was returning home from Aliganj-Muda road in Gola kotwali area in his SUV when the bike-borne miscreants opened fire on him.

Singh did not receive any injury.

Singh is one of the witnesses in the Tikonia violence of October 3, 2021 in which eight people, including four farmers and a journalist, had died. Union minister Ajay Mishra's son Ashish Mishra was arrested in the case.

Talking to PTI over phone, the BKU leader said the miscreants punctured a tyre of his SUV following which he had to stop the vehicle.

"The assailants tried to open the



doors and windows of the SUV. Having failed to do so, they fired two shots at a windowpane," he said.

Singh said he was driving the SUV and was alone. He said sensing the intentions of the attackers he folded the driver seat and bent down.

As the windows were covered with a dark film, the attackers could not locate him in the SUV and fled the scene.

## Satyendar Jain, Delhi health minister, sent to ED custody till June 9

NEW DELHI (TIP)

Satyendar Jain, Delhi's health minister, was sent to the custody of the Enforcement Directorate till June 9, a day he was arrested by the agency in a money laundering case.

Jain, who holds various portfolios, including health, home and power, in the Arvind Kejriwal government in Delhi, was produced in the Rouse Avenue Court.

Special judge Geetanjali Goel remanded Jain in ED's custody, noting that his custodial interrogation was required to unearth the larger conspiracy. Jain was represented by senior advocate N Hari Haran, while the solicitor general Tushar Mehta appeared for the central agency.

Hours ago, Delhi chief minister Arvind Kejriwal said the ED case against his cabinet colleague is a fraud one (farzi), adding that his government "is honest and does not tolerate

corruption".

"We have faith in judiciary. This farzi (fake) case won't last. We are following the path of truth," Kejriwal told reporters.

In January, ahead of the Punjab Assembly election, Kejriwal had said he had learnt from sources that Jain could be arrested by the ED.

The central agency's probe is based on a 2017 case of the Central Bureau of Investigation (CBI), in which it was alleged that the AAP leader and his wife Poonam Jain had amassed disproportionate assets worth ₹1.47 crore between February 2015 and May 2017, which was more than double their known sources of income.

The Delhi minister was arrested under provisions of the Prevention of Money Laundering Act (PMLA) after around four hours of questioning on Monday, during which he reportedly gave evasive replies on the money trail.

## SINGLE-DAY RISE OF 3,712 NEW COVID-19 INFECTIONS, 5 DEATHS

With 3,712 new coronavirus infections recorded in a day, India's infection tally rose to 4,31,64,544, while the total number of active cases increased to 19,509, the Union health ministry said on Thursday, June 2.

The country's covid-19 death toll has climbed to 5,24,641, with five latest fatalities reported from Kerala, the ministry data updated at 8am stated.

The active cases comprised 0.05 per cent of the total infections, while the national covid-19 recovery rate was recorded at 98.74 per cent, the health ministry said.

An increase of 1,123 cases has been recorded in the active covid caseload in a span of 24 hours.

The daily positivity rate was recorded at 0.84 per cent and the weekly positivity rate at 0.67 per cent, according to the health ministry.

The number of people who have recuperated from the disease surged to 4,26,20,394, while the case fatality rate was recorded at 1.22 per cent.

The cumulative number of doses administered in the country so far under the nationwide covid-19 vaccination drive has exceeded 193.7 crore.

In April, IIT-Madras, had turned into a cluster with a total of 237 students turning positive and officials had said then it was due to students returning to campus from various parts of the country.

India's weekly positivity rate stands at .67 per cent.

## SRINAGAR (TIP)

A Hindu teacher from Jammu's Samba district, posted in Kashmir Valley's Kulgam, was shot dead just outside the school by militants on Tuesday, May 31, morning. Target killings have left seven civilians dead this month in the Valley.

Two local Jaish-e-Muhammad (JeM) militants were shot dead in an anti-militancy operation in Pulwama, taking their death toll to around 27 this month.

Officials said militants fired from close range at Rajni Bala, 36, around 10 a.m. The staff and students of the Government High School, Gopalpora in Kulgam were about to finish the morning assembly when militants intercepted Ms. Bala outside the school, which is located around eight km away from the Kulgam town at a secluded place with orchards around.

"The gunmen shot Ms. Bala in her head," the officials stated.

## Police begin process to bring Lawrence Bishnoi to Punjab; SIT recast

**Recce before attack: Toyota Corolla car used in the crime seen multiple times in CCTV footage three days before murder of Moosewala, say Punjab Police**

### BATHINDA (TIP)

Punjab Director General of Police VK Bhawra on June 1 strengthened and reconstituted the special investigation team (SIT) probing the Sidhu Moosewala murder case even as the Punjab Police have begun the process to bring jailed gangster Lawrence Bishnoi to the state for interrogation.

The six-member SIT will be headed by ADGP, Anti-Gangster Task Force (AGTF), Pramod Ban. It will have a new chairman, IGP (Punjab Armed Police) Jaskaran Singh, and two other new members — Assistant Inspector General (AGTF) Gurmeet Singh Chauhan and Mansa SSP Gaurav Toora.

Mansa SP (Investigation) Dharamveer Singh, Bathinda DSP (Investigation) Vishwajeet Singh and Mansa CIA in-charge Prithipal Singh are its existing members.

In his fresh order, DGP Bhawra stated that the SIT should conduct the investigation on a day-to-day basis, arrest the perpetrators of the crime and on the completion of the investigation, submit the report in the court of competent jurisdiction.

Talking to mediapersons, the Mansa SSP said: "We will question jailed gangster Lawrence Bishnoi after bringing him to the state in connection with the murder of Sidhu Moosewala. At present, Bishnoi is in the custody of the Delhi Police. We will make him join the investigation in this case, as per law."

It has been learnt that a Punjab Police team has left for Delhi to bring Bishnoi on production warrant.

He said the police were probing various angles in connection with the murder of the singer as they had got a number of leads. "Cops have traced the route the criminals took from the CCTV footage. From where they came, how they conducted the recce and how they escaped – we have got it all," the SSP said.

"We have arrested one person and have brought two members of the Lawrence Bishnoi gang on production warrant from Bathinda and Ferozepur jails to Mansa. They have been remanded in six-day police custody," the SSP said, adding that during the interrogation "we expect to get some more information about the assailants".

The police are probing the role of Lawrence Bishnoi and his Canada-based aide Goldy Brar, who had taken

responsibility for the crime, the SSP added. Sidhu Moosewala was killed by unidentified persons at Jawaharke village in Mansa on Sunday evening. He suffered 25 bullet wounds. On Tuesday, he was cremated in the presence of thousands of his fans.

### Suspect facing 10 criminal cases

Manpreet Singh, a person arrested by police from Dehradun, in Sidhu Moosewala murder case, belongs to Dhaipai village of Faridkot.

Police have accused Manpreet Singh of supplying vehicles and logistic support to the assailants who murdered Moosewala.

As per Faridkot police record, Manpreet Singh was involved in 10 criminal cases so far. Maximum of these cases, seven are registered at different police stations in Faridkot district. He is facing one criminal case each at Muktsar and Kurali.

In most of these cases, he was accused of making criminal assaults, possessing illegal weapons and also possessing narcotics. In four of these cases, he has been acquitted by the court. In all other cases, he is out on bail.

Baljit Kaur, mother of Manpreet Singh, claimed innocence of their son. Accusing police of framing her son in Moosewala's murder case, she alleged that her son was made an easy target due to a dossier of criminal cases against him in the past.

## Hindu teacher shot dead at Kulgam school as Kashmir sees 7th targeted killing this month

The police said Ms. Bala was shifted to a hospital in critical condition but died of her injuries. She was recruited under the Schedule Caste (SC) quota five years ago and was posted in Kashmir.

In October last, a teacher from Jammu, also recruited under the SC category, was shot dead inside a school in Srinagar's Eidgah locality.

"The government should do something about targeted killings. We want justice in our case. My sister-in-law was here (Samba) two months ago. She never complained of any threat, though she did talk about lurking fear of late," a relative of Bala said in Samba.

Earlier this month, militants killed six civilians, including a Kashmiri Pandit

employee, a woman artist, a wine shop employee and three policemen, in six separate targeted attacks in the Valley.

The killing of policeman Saifullah Qadri outside his house on May 24 in Srinagar's Soura saw the security forces stepping up operations against militants. Sixteen militants have been killed since then in the Valley. The police claimed that among the slain militants included those behind four target killings, including the cases of Kashmiri Pandit employee Rahul Bhat, artist Amreen Bhat and two policemen. Besides, the module behind the wine shop attack in Baramulla was also busted.







# Sri Lankan agricultural minister seeks India's help for food security

**COLOMBO** (TIP): Sri Lankan agricultural minister Mahinda Amaraweera on June 1 met Indian High Commissioner Gopal Baglay and sought India's help for food security and environmental protection in the island nation, as it faces the worst economic crisis in its post-independence history.

Last month, India assured Sri Lanka to immediately supply 65,000 metric tonnes of urea to avoid any disruption to the current Yala cultivation season in Sri Lanka.

Yala is the season of paddy cultivation in Sri Lanka that lasts between May and August.

Sri Lankan Agriculture Minister Amaraweera met Indian High Commissioner Baglay and they had discussed the importance of bilateral cooperation for food security and environmental protection, a statement from the High Commission said.

Sources said Amaraweera was keen on getting chemical fertiliser from India under the Indian Line of Credit.

President Gotabaya Rajapaksa's decision last year to ban chemical fertiliser imports in order to turn into a green economy has caused a food shortage with crop losses amounting to 50 per cent.

Rajapaksa a few weeks ago admitted his decision to ban chemical fertiliser to go 100 per cent organic was wrong.

The agriculturists have warned that the country may encounter a food



shortage by mid-August in the ongoing economic crisis.

India has committed more than USD 3 billion to debt-ridden Sri Lanka in loans, credit lines and credit swaps since January this year.

Sri Lanka is aiming to boost its agriculture sector to avoid any disruption in the agriculture market following the drop in the paddy cultivation in the Maha session.

Sri Lanka's annual fertiliser imports cost USD 400 million. Farmers across Sri Lanka have intensified their protests due to the lack of fertiliser and being compelled to abandon their farmlands.

The chemical fertiliser ban, combined with bad weather, led to falling crop

yields and contributed to inflation hitting a 47-month high of 8.3 per cent in October with food inflation at 11.7 per cent, Daily Mirror, an online news portal said.

Sri Lanka has more than 2 million farmers and up to 70 per cent of its 22 million people are directly or indirectly dependent on agriculture.

Sri Lanka's economic crisis is caused in part by a lack of foreign currency, which has meant that the country cannot afford to pay for imports of staple foods and fuel, leading to acute shortages and very high prices.

The crisis has provoked widespread protests calling for political reform and the resignation of President Gotabaya Rajapaksa. (PTI)

## Pakistan's fuel supply threatened as foreign banks refuse financing

**ISLAMABAD** (TIP): Amid rising subsidy allocations, the Pakistan oil industry is now facing challenges in arranging international finances for import of crude and oil products.

Informed sources told Dawn news that the Petroleum Division had informed the Prime Minister and Finance Minister that arrangements of oil imports were getting tough by the day as foreign banks were not providing financing against Letters of Credit (LCs) opened by oil marketing companies (OMCs) and refineries with the local banks.

A senior official told Dawn that except two large corporations, Pakistan State Oil (PSO) and Pak-Arab Refinery Limited (Parco), all OMCs and refineries were struggling to arrange import of petroleum products and crude.

The sources said about six-seven cargos worth \$50-75 million each (\$350-500 million cumulative) depending on size and product were held up at present because of the increased risk following some critical statements from the



relevant ministries about the tough fiscal and foreign exchange position.

They said Pakistani banks were opening LCs on behalf of the oil industry, but their partner banks were not extending credit cover, Dawn reported.

"Unfortunately, the country's fuel supply is now also being severely threatened by limited credit facilities, high inflation and increasing rupee-

dollar parity," stated an oil industry's report sent by the Petroleum Division to the Prime Minister Office and the Finance Minister.

The oil industry has told the government that this financial predicament had left the oil industry extremely vulnerable and fragile, adding that this "may result in breakdown of the supply chain". IANS

## 21 BODIES RECOVERED FROM TARA AIR PLANE CRASH SITE IN NEPAL

**KATHMANDU** (TIP): Rescuers on Monday recovered 21 bodies from the wreckage site of the Tara Air plane that crashed in Nepal's mountainous Mustang district on May 29 with 22 people on board, including four Indians, minutes after taking off from the tourist city of Pokhara, officials said.

The turboprop Twin Otter 9N-AET plane went missing on May 29 morning in the mountainous region of Nepal. The Canadian-built plane, flying from Pokhara to the popular tourist town Jomsom in central Nepal, was carrying four Indians, two Germans and 13 Nepali passengers, besides a three-member Nepali crew.

Rescuers have recovered 21 bodies from the crash site, said a statement issued by the Civil Aviation Authority of Nepal (CAAN).

One person was still missing, the statement added.

It said that 10 bodies were brought to Kathmandu, while 11 bodies were taken to the base camp from where the rescue operation is being coordinated.

Sudarshan Bartaula, a spokesperson for Tara Air, said that search and rescue teams are scouring the area for the remaining person.

President Bidya Devi Bhandari and Prime Minister Sher Bahadur Deuba have condoled the death of crew members and passengers in the plane crash.

The government has formed a five-member commission of inquiry headed by senior aeronautical engineer Ratish Chandra Lal Suman to find out the cause of the Tara Air plane crash.

A preliminary investigation revealed that the aircraft had crashed into the mountains after it swerved to the right, instead of turning to the left due to inclement weather, CAAN Director-General Pradeep Adhikari said during a meeting of the International Committee of the Parliament on Monday.

Earlier in the afternoon, the CAAN in a statement said that the plane had crashed at Thasang-2 in Mustang district at the height of 14,500 feet.

Indra Singh, who was on his way to clear a blocked road, found out that the plane had crashed. He said the plane was found in a completely damaged condition, MyRepublica newspaper reported.

"All the passengers on the aircraft are found dead," he was quoted as saying by the paper. "The dead bodies are intact and the faces of all victims are recognisable."

He said there was no fire on the aircraft. The aircraft could have met with an accident after hitting a cliff nearby.

Search and rescue teams from Nepal Army, Air Dynasty, Kailash Helicopter and Fishtail Air Helicopter and other rescue workers were deployed at the crash site. (PTI)



No matter what one's condition is, once I am on stage, I forget everything and simply perform," KK had said in his memoir on his official website, The Mesmerizer. His 1999 debut album Pal was critically acclaimed. From the early 2000s, he blazed a career in playback singing and recorded a wide range of popular songs for Bollywood films.



## Ranbir says Brahmastra was reshot on Rajamouli's dad's suggestion



## WEST ADDING FUEL TO FIRE: MOSCOW OVER MORE ARMS SUPPLY TO KYIV

**KYIV (TIP):** Western nations promised more and more advanced arms to bolster Ukraine's defence as its troops battled a grinding Russian offensive that was closing in on capturing a key city in the east.

Germany said on June 1 it would supply Ukraine with modern anti-aircraft missiles and radar systems, and the US will also unveil a new weapons package that will include high-tech, medium-range rocket systems.

The Kremlin spokesman said the US was "adding fuel to the fire". Western arms have been critical to Ukraine's success in stymieing Russia's much larger and better equipped military — thwarting its initial efforts to take the capital and forcing Moscow to shift its focus instead to the eastern industrial Donbas region.

But as the war drags on and Russia bombards towns in its inching advance in the east, Ukraine has repeatedly pleaded for more and better weapons. Ukrainian President Volodymyr Zelenskyy has occasionally criticised the West for moving too slowly in shipping arms — and military analysts have said Russia is hoping to overrun the Donbas before any weapons that might turn the tide arrive.

In addition to the rocket systems it has promised, the US package will include helicopters, Javelin anti-tank weapon systems, tactical vehicles, spare parts and more, two senior administration officials said on Tuesday. Moscow views the US plans to supply more weapons "negatively", Kremlin spokesman Dmitry Peskov said on Wednesday. — AP

## JOHNSON IN ROW WITH HIS ADVISER OVER PARTYGATE

**LONDON (TIP):** British Prime Minister Boris Johnson has been forced to explain, by his own independent ethics adviser, why he believed that the partygate fine slapped on him by Scotland Yard did not breach the country's Ministerial Code.

Lord Christopher Geidt, who reports directly to the PM in an advisory capacity, said in an annual report on ministerial interests released on June 1 that a "legitimate question" has arisen as to the fixed penalty notice issued by the Metropolitan Police over a Covid lockdown-breaching birthday party in June 2020. (PTI)

# 4 killed, 14 injured as 6.1-magnitude earthquake hits China's Sichuan province

**BEIJING/CHENGDU (TIP):** A powerful earthquake of 6.1-magnitude killed at least four people and injured 14 others as it jolted the city of Ya'an in southwest China's quake-prone Sichuan province on June 1 afternoon, according to local authorities.

The quake rattled Lushan County of Ya'an in Sichuan at 5:00 pm local time, according to the China Earthquake Networks Centre (CENC).

The epicentre, with a depth of 17 km, was monitored at 30.4 degrees north latitude and 102.9 degrees east longitude, the CENC said.


Sichuan province suffered China's deadliest 7.9-magnitude earthquake in 2008 in which 90,000 people were killed.

Wednesday's earthquake was followed by another 4.5-magnitude jolt in Baoxing County, also under the city of Ya'an.

Four people were killed and 14 others injured in the quake, the state-run People's Daily reported.

All the casualties were reported from Baoxing County, the state-run Xinhua news agency reported, quoting Ya'an city's earthquake relief headquarters.

Ya'an has activated the second-highest level of emergency response for



the earthquake and is conducting damage assessments.

More than 800 personnel from emergency rescue, the armed police, the fire department, the medical sector and the public security bureau were immediately dispatched to the earthquake-hit areas to search for and rescue the injured, repair roads and relocate affected residents.

The Ministry of Emergency Management said an A level-III

national emergency response has been activated to conduct the relief operations.

A work team has been dispatched to guide and assist the local emergency rescue efforts, the ministry said.

Local firefighters have reached the epicentre, while quake rescue teams of Sichuan and other neighbouring regions are on standby for relief operations, the ministry added. (PTI)

## Japan PM Kishida's support hits highest ever as election nears: Survey

**TOKYO (TIP):** Japan's Prime Minister Fumio Kishida scored his highest approval ratings since taking office eight months ago in a weekend survey, the Nikkei daily reported, with critical upper house elections just weeks away.

Should Kishida, fresh from talks with US President Joe Biden last week, and his ruling Liberal Democratic Party (LDP) win a decisive victory in July's election, he won't face another scheduled ballot for three years. That would give him full scope to focus on a policy programme that includes revising Japan's pacifist constitution at some point in the future.

Support for Kishida and his Cabinet climbed to 66%, a rise of 5 points from the previous April survey and the highest since he took office last October, according to a weekend survey by the Nikkei and TV Tokyo.

A total of 61% of respondents said they "approved" of his talks with Biden. During the meeting the pair agreed to cooperate on pressing security issues, such as China's increasing assertiveness, while Kishida pledged to seek a "substantial" increase in Japan's defence budget.

Kishida has recently concluded a



whirlwind schedule of diplomatic visits and talks in Tokyo, including hosting the leader of the "Quad" security pact countries - Australia, India, Japan and the United States.

Though analysts say the optics of meeting with Biden certainly won't hurt Kishida, diplomacy is unlikely to weigh as heavily with voters as domestic issues, such as the coronavirus and the economy.

Asked about the government's

handling of price rises in the wake of the war in Ukraine and surging fuel prices, 61% said they did not approve against only 28% who did.

Kishida's support also rose in a survey last week by Fuji News network, hitting hit 68.9%, up 3 points from the previous month. But asked to explain why they supported him, the greatest number of respondents - 38.2% - said "because there's no other suitable person". (Reuters)

# Italy imports more Russian oil despite impending embargo

**MILAN (TIP):** Even as the European Union decided to reduce Russian crude oil imports by 90 per cent by the end of the year, Italy has become the only country in Europe to increase them, an unintended consequence of EU sanctions against Russia.

Meant to punish Russia for invading Ukraine, the EU oil embargo is now putting at risk one of Italy's largest refineries, located in Sicily, which would deal an economic blow to the depressed region's economy.

Italy agreed with its EU partners to cut Russian crude imports by 2023, a move that Premier Mario Draghi called "a complete success, that wouldn't have been believable just a couple of days ago." But Rome also has to deal with the fate of the refinery in Sicily owned by Russia's Lukoil. As a result of previous sanctions against Russia, ISAB Srl has paradoxically gone from processing 15 per cent of Russian crude to 100 per cent.

That's because banks have refused to take the risk of extending credit to Russia-controlled ISAB that would allow it to buy oil from non-Russian sources, even if not specifically barred from doing so, said Matteo Villa, an energy analyst at the ISPI think tank in Milan.

Ships continue to arrive at the port-side refinery with crude oil from the Russian parent company.

Italy in May received about 400,000 barrels of Russian oil a day in May, four times the pre-invasion levels, according to the Kpler commodity data company. Of that total, ISAB received 220,000 barrels a day from Russia.

"Italy is the only country in Europe increasing oil imports," Villa said, going from the sixth-largest importer of Russian oil to the largest in the three



months since the invasion.

The plant employs 3,500 people at three production sites, including a refinery, gasification and electricity cogeneration plant, in Sicily's Syracuse province, and risks closure if a solution isn't found before the embargo kicks in. The plant and related activities generate half of the provincial gross domestic product and 8 per cent of the region's economic activity, processing one-fifth of Italy's crude oil imports.

The refinery's future was already at risk in the longer term, due to Italy's energy transition to more sustainable sources. The embargo has only increased the sense of urgency to find a solution.

"The mood today is even worse than yesterday," said Fiorenzo Amato, the secretary general of the Filctem Cgil union in Syracuse. "The industrial hub ... employs many people, giving families the chance to live." Since learning of the

embargo, refinery workers are growing more concerned about their future.

"It will be a disaster," said Marco Candelargiu. "We hope they find a solution. You cannot destroy a province. The choice was made a long time ago to base the economy prevalently on the refinery." Villa said one solution would be for Italy to temporarily nationalize the refinery, a move permitted for energy emergencies under Italy's Constitution, but a week of discussions has yielded no agreement.

As an Italian-owned refinery, ISAB would be able to get the necessary financing to purchase crude from other sources and keep operating while longer-term solutions are sought.

"This is important for employment in Sicily, for the provisioning of gasoline and diesel to Italy and for our own political face-saving in Europe," Villa said. AP

## Shanghai moves toward ending 2-month lockdown

**BEIJING (TIP):** Shanghai authorities say they will take some major steps on June 1 toward reopening China's largest city after a two-month Covid lockdown that has throttled the national economy and largely bottled up millions of people in their homes.

Full bus and subway service will be restored as will basic rail connections with the rest of China, Vice Mayor Zong Ming said on Tuesday at a daily news conference.

Schools will partially reopen on a voluntary basis for students and shopping malls, supermarkets, convenience stores and drug stores will continue to reopen gradually with no more than 75 per cent of their total capacity. Cinemas and gyms will remain closed. Officials, who set June 1 as the target date for reopening earlier in May, appear ready to accelerate what has been a gradual easing in recent days. — AP



## UKRAINIAN ARMY SAYS RUSSIA LOST ABOUT 30,700 TROOPS IN UKRAINE

**KIEV (TIP):** Russia has "lost about 30,700 troops" in Ukraine between February 24 and June 1, Ukrainian army claimed.

The statement was made by the General Staff of the Armed Forces of Ukraine on Facebook, Ukrinform news agency reported on June 1.

"The enemy's total combat losses, between February 24 and June 1, also included 1,361 tanks (+3 over the past day), 3,343 armored fighting vehicles (+41), 659 artillery systems (+10), 207 multiple launch rocket systems (+0), 94 anti-aircraft warfare systems (+1), 208 aircrafts (+0), 175 helicopters (+1), 2,290 motor vehicles and fuel tanks (+15), 13 warships/boats (+0), 519 unmanned aerial vehicles (+4), 49 special equipment units (+1). A total of 120 enemy cruise missiles (+0) were shot down," the report noted.

Over the past day, Russian troops have suffered the "highest losses" in the Kryvyi Rih and Bakhmut direction. The data are yet to be updated.

It is noteworthy that the Russian troops continue to conduct offensive operations in the eastern operational zone to gain "full control" over Donetsk Region and Luhansk Region. --IANS

## EU AGREES ON GRADUAL RUSSIAN OIL EMBARGO

**BRUSSELS (TIP):** European Union leaders have agreed an embargo on Russian oil imports that will kick in around the turn of the year - and for now exempts the pipeline imports that Hungary and two other landlocked Central European states rely on.

The ban, agreed overnight after weeks of wrangling, aims to remove 90 per cent of Russia's crude imports into the 27-nation bloc within eight months or so, officials said.

It is the toughest sanction yet on Russia for its invasion of Ukraine, and one that will affect the EU itself.

Russia provided just over a quarter of EU oil imports in 2020, while Europe is the destination for nearly half of Russia's crude and petroleum product exports. "The sanctions have one clear goal: To prompt Russia to end this war, to withdraw its troops, and to agree a sensible and fair peace with Ukraine," German Chancellor Olaf Scholz said. Ukraine said they would deprive the "Russian military machine" of tens of billions of dollars. French President Emmanuel Macron said nothing could be ruled out regarding further sanctions, although other leaders poured cold water on the idea of banning purchases of Russian gas, which Europe depends on heavily. — Reuters

# Hair loss: Know the causes, ways to prevent it

The digestive fire becomes erratic in summer, and the nourishment of body tissues deteriorates, impairing hair growth and affecting both appearance and strength."

She shares the following tips that should help with summer hair loss:

- Make sure you minimize or avoid the heat and chemical styling treatments. Go for towel drying, instead of using a hairdryer.
- Control hair damage by tying them into a bun, braid, or ponytail on bad hair days.



- Choose natural and reliable hair care products like shampoos, conditioners, hair masques, etc., that are sulfate-free and vegan. Too many chemical-laden products can further damage the hair.
- It is always better to go for products that are specifically made for your hair and scalp.
- Try amla hot oil treatment/hair mask at home at least once a week. It is excellent for dry damaged hair.
- Deep conditioning hair masks such as argan and keratin can also serve you. Deep conditioning hair masks will restore the lost moisture and hydrate hair strands.
- Regular trimming will make sure the dry, dead, split ends are chopped off.
- Never rub towels aggressively on your hair to dry them after washing. Just wrap a towel to squeeze out the excess water.
- Apply hair serum when the hair is still in a semi-dried state; this will make sure that not too many knots are formed.
- As a precautionary measure, wear hats, and scarves when going out, since the sun can further damage the hair.
- Try making your own massage oils with organic cold pressed and essential oils.

## Hydrate, exfoliate, moisturize to avoid dry skin


S ave your skin from dryness and dehydration. Increase water intake and exfoliate the dead skin cells to achieve smooth skin, says an expert.

### Nawabi Pulao

#### Ingredients

1/2 kg chicken  
1/4 kg mutton  
1/2 kg rice  
1 cup curd, well beaten  
1 cup milk  
3 onions  
2 eggs  
1/2 cup green peas, shelled  
1 pod arlic  
1 big piece of ginger  
1 tsp rose water  
Ghee or oil for frying  
Salt to taste

#### Method

1. Clean and wash rice and soak it in water for 15 minutes.
2. Cook the rice till half done. Keep aside. 3. Clean and cut the mutton into cubes. Joint the chicken. Boil the eggs and keep aside.
4. Slice the onions. Grind ginger and garlic to a paste.
5. Heat ghee in a frying pan, add onions, ginger-garlic paste and fry well.
6. Add the jointed chicken and fry. Add 3 cups of water and salt to taste and cook on slow fire till the meat is tender and only 1/3 of the gravy is left.
7. Add some more ghee and the well beaten curd. Cook on a slow fire until the curd gets absorbed.
8. Add 1 tsp of rose water after the meat has cooled.
9. Take a heavy bottomed pan and arrange alternate layers of rice and cooked meat taking care that the first and last layers are that of rice.
10. Place in an oven and cook for about 15-20 minutes on low heat.
11. Garnish with fried onions, quartered boiled eggs and boiled green peas.

spicy preparations are a strict no-no as well during summer.

#### Milk

# Thyroid: Types of disorders, risk factors, symptoms

The thyroid gland, located in the front of the neck, is the main source of thyroid hormones in the body and hypothalamic thyrotropin-releasing hormone (TRH) stimulates thyroid-stimulating hormone (TSH) synthesis from pituitary gland of our body. TSH stimulates thyroid hormone (T3,T4) synthesis with the help of thyroid peroxidase (TPO) enzyme from thyroglobulin protein and iodine within the gland.

Very minute amount of total thyroid hormones is not bound to any proteins in the circulation and known as free thyroid hormones, which are responsible for the biological activities within the body. For the uninitiated, thyroid hormones maintains key functions such as metabolism rate in body, heart functions, digestive functions, muscle health, brain development, bone health etc.

## Disorders due to imbalance in thyroid hormones

Dr Soumi Ghosh, Consultant Biochemist at Neuberg Anand Reference Laboratory, highlighted two types of thyroid disorders and their symptoms as:

### Hypothyroidism

It is associated with decreased free and total thyroid hormones and increased or decreased TSH according to the causative factors. Subclinical hypothyroidism is a condition where persistent elevation in TSH (6 to 12 weeks or longer) is seen but FT4 concentrations is found within the normal range.

Among the varieties of hypothyroidism, congenital hypothyroidism (presence since birth) is the most important, as it requires an early diagnosis and treatment to prevent brain damage. Maternal hypothyroidism is a risk factor for developing this disease. Other causes of hypothyroidism are antibodies developed in a person against his or her own thyroid gland, bacterial or viral inflammation in the thyroid glands leading to its damage, radiation or surgery in the thyroid glands. Apart from that certain foods (for example cabbage, cauliflower, soy products, peaches, peanuts) and certain drugs can interfere with thyroid hormone synthesis and cause hypothyroidism.

Risk factors for hypothyroidism include advancing age, type 1 diabetes, family history of thyroid disease, goitre, previous hyperthyroidism, external-beam



radiation in the head and neck area, baby born with Down syndrome and females are more prone to develop thyroid disease.

### Hyperthyroidism

This results from increased free and total thyroid hormones and decreased hormonal or increased TSH in the body as per the causative factors.

The causes are autoimmune thyroid disease like Graves' disease, viral or bacterial infections of thyroid gland lead to release of more thyroid hormones, overproduction of thyroid hormones due to certain unknown causes and over consumption of Iodine etc. Risk factors for hyperthyroidism include advancing age, personal or family history of thyroid diseases, and intake of iodine-containing drugs, like amiodarone, and females are more prone to develop thyroid disease.

Symptoms include nervousness, emotional liability, restlessness, sleeplessness, difficulty in concentrating, smooth and/or shiny hair and skin, weight loss, excessive sweating, heat intolerance, menstrual irregularities, diarrhoea etc. Physical signs are increased heart rate, irregular heartbeats, increased blood pressure, warm and damp skin, tremor, signs of ophthalmopathy (changes in the eye). Euthyroid hyperthyroxinemia is a condition where total T4 is increased but TSH, free thyroid hormones and total T3 are normal. This is usually seen in nonthyroidal illness and abnormalities in thyroid hormone binding proteins.

# Monkeypox can be contained if we act now, says World Health Organization

A World Health Organization senior official said on Friday that the priority needs to be containing monkeypox in non-endemic countries, saying that this can be achieved through quick action.

Monkeypox, typically a mild viral infection, is endemic in the African countries but its spread to non-endemic countries such as in Europe and the United States has raised concerns. So far, there are more than 200 confirmed or suspected cases in around 20 countries where the virus was not previously circulating.

"We think if we put the right measures in place now we can contain it easily," Sylvie Briand, WHO director for Global Infectious Hazard Preparedness said at a technical briefing to member states at the UN health agency's annual assembly. She stressed that there was a window of opportunity to prevent further spread, urging the




general public not to be worry since transmission is much slower than other viruses such as the coronavirus. WHO officials said that there was no need for mass vaccination at present, but targeted vaccination where available for close contacts of people infected. "Case investigation, contact tracing, isolation at home will be your best bets," said Rosamund Lewis, WHO head of the smallpox secretariat

which is part of the WHO Emergencies Programme.

Monkeypox, a mild viral infection, is endemic in the African countries of Cameroon, Central African Republic, Democratic Republic of Congo, and Nigeria.

The recent outbreak in non-endemic countries has raised concerns. The strain circulating globally is thought to have a fatality rate of around 1%, although effective vaccines and treatments are available.

Talking during an online briefing, WHO's senior epidemiologist Maria Van Kerkhove said cases have so far been detected in more than 20 non-endemic countries, adding that the agency expected the numbers to go up. "We expect more cases to be detected. We are asking countries to increase surveillance...This is a containable situation. It will be difficult, but it's a containable situation in the non-endemic countries." Source: Reuters



## Previous Covid infection does not protect kids from Omicron: Study

Children who previously had COVID-19 or the inflammatory condition MIS-C are not protected against the Omicron variant of coronavirus, according to a study which found vaccination, however, does afford protection.

The findings of the study, published recently in the journal Nature Communications, are similar to those found in adults.

"I hear parents say, 'Oh, my kid had COVID last year,'" said Adrienne Randolph, of Boston Children's Hospital, US, senior author of the research paper.

"But we found that antibodies produced by prior infections in children don't neutralise Omicron, meaning that unvaccinated children remain susceptible to Omicron," Randolph said.

The researchers, including Surender Khurana, from the US Food and Drug Administration obtained blood samples from 62 children and adolescents hospitalised with severe COVID-19.

They also used data from 65 children and adolescents hospitalised with MIS-C, and 50 outpatients who had recovered from mild COVID-19.

All the samples were taken during 2020 and early 2021, before the emergence of the Omicron variant.

In the laboratory, the researchers exposed the samples to a pseudovirus, and measured how well antibodies in the samples were able to neutralise five different SARS-CoV-2 variants of concern: Alpha, Beta, Gamma, Delta, and Omicron.

A pseudovirus is derived from SARS-CoV-2, but stripped of its virulence.

Overall, children and adolescents showed some loss of antibody cross-neutralisation against all five variants, but the loss was most pronounced for Omicron, the researchers said.

"Omicron is very different from previous variants, with many mutations on the spike protein, and this work confirms that it is able to evade the antibody response," said Randolph.

"Unvaccinated children remain susceptible," the researcher said. In contrast, children who had received two doses of COVID-19 vaccine showed higher neutralising antibody titers against the five variants, including Omicron.

The researchers hope these findings will encourage parents to have their children and teens vaccinated.



## Google Assistant to soon recognise your voice

Google Assistant will soon recognise your voice as the company is working on a personalised speech recognition feature. According to 9to5Google, the tool will help Google Assistant get "better at recognising your frequent words and names." The "Personalised speech recognition" feature will appear in Google Assistant settings.

The feature description reads: "Store audio recordings on this device to help Google Assistant get better at recognising what you say. Audio stays on this device and can be deleted any time by turning off personalised speech recognition".

The upcoming feature looks to expand AT and ML-based improvements beyond "Hey Google" to your actual Assistant commands, "especially those with names (using your voice to message contacts) and frequently spoken words".

It's still not clear when this capability will launch.

The feature will allow more advanced recognition of commands and contact names.

Owing to privacy concerns, Google will give users an option in settings to opt out of the personalised speech recognition if they don't want their voice to be stored.

## Humans could land on an asteroid between 2071 and 2087: Research

It is possible that you may witness human astronauts landing on the moon within your lifetime, according to a recently authored research article. The researchers analysed how NASA's budget has changed over the years since the 1960s to gauge how likely it is that the space agency will deploy a mission to Asteroids beyond Mars in the next century.

The non-peer-reviewed paper titled, "Impact of Economic Constraints on the Projected Timeframe for Human-Crewed Deep Space Exploration," is available on ArXiv. Co-authors include researchers from NASA's Jet Propulsion Laboratory, Radboud University, and Beijing Normal University.

While analysing how NASA's budget has changed since its inception in 1958, the researchers noticed many spikes in the amount of money that the space agency burned over the years. These spikes corresponded with the key

events of the space age, including the early years of the Apollo program in 1966 and the announcement of man's impending return to the Moon with the Artemis project in 2018. The researchers propose that a spacefaring nation or a group of spacefaring nations will send a mission to the asteroid

belt beyond Mars between 2071 and 2087. They also predict that a mission to the Jovian System, which includes Jupiter, its rings and moons, will happen between 2087 and 2101. A launch to the Saturn system is predicted to happen in the window between 2129 and 2153.

For arriving at these numbers, didn't just use NASA's budget numbers. They also analysed the evolution of technology capabilities related to deep space exploration over the years. The exploration of deep space required a variety of technological capabilities such as computing power, and the design, manufacturing and operation of hardware such as launch vehicles, guidance systems and life support systems.

Since it is difficult to quantitatively ascertain the evolution of such technologies, they analysed the number of published peer-reviewed technology articles about deep space exploration over the years. This number showed a clear upwards trend which allowed the scientists to create a model with both the technology evolution data and the budget data; allowing them to arrive at their conclusions.

## US-built 'Frontier' now world's fastest supercomputer

US-built supercomputer titled 'Frontier' has dethroned Japan's 'Fugaku' (developed by the Riken Institute and Fujitsu), as the world's fastest machine with 1.1 exaflops of performance on the 59th TOP500 list published by an international conference of computer experts.

The Frontier supercomputer at the US Department of Energy's Oak Ridge National Laboratory is the first to achieve an unprecedented level of computing performance known as exascale, a threshold of a quintillion calculations per second.

Frontier features a theoretical peak performance of 2 exaflops, or two quintillion calculations per second, making it 10 times more powerful than ORNL's Summit system.

"Frontier is ushering in a new era of exascale computing to solve the world's biggest scientific challenges," ORNL director Thomas Zacharia said in a statement.

"This milestone offers just a preview of Frontier's unmatched capability as a tool for scientific discovery," he added.

Frontier leverages ORNL's extensive expertise in accelerated computing and will enable scientists to develop critically needed technologies for the country's energy, economic and national security, helping researchers address problems of national importance that were impossible to solve just five years ago.

Frontier's speeds surpassed those of any other supercomputer in the world, including ORNL's Summit, which is also housed at ORNL's Oak Ridge Leadership Computing Facility.

Frontier, a HPE Cray EX supercomputer, also claimed the number one spot on the Green500 list, which rates energy use and efficiency by commercially available supercomputing systems, with 62.68 gigaflops performance per watt.

The work to deliver, install and test Frontier began

during the Covid-19 pandemic, as shutdowns around the world strained international supply chains.

More than 100 members of a public-private team worked around the clock, from sourcing millions of components to ensuring deliveries of system parts on deadline to carefully installing and testing 74 HPE Cray EX supercomputer cabinets, which include more than 9,400 AMD-powered nodes and 90 miles of networking cables.

"When researchers gain access to the fully operational Frontier system later this year, it will mark the culmination of work that began over three years ago involving hundreds of talented people across the Department of Energy and our industry partners at HPE and AMD," said Jeff Nichols, ORNL associate lab director for computing and computational sciences.

## New MRI technique set to transform heart transplant care

The days of heart transplant survivors undergoing invasive biopsies could soon be over after a new MRI technique has proven to be safe and effective, reducing complications and hospital admissions.

Scientists at the Victor Chang Cardiac Research Institute and St Vincent's Hospital, Sydney, hope the new virtual biopsy designed to detect any signs of the heart being rejected will be adopted by clinicians the world over.

Approximately 3,500 people worldwide receive heart transplants each year. Most patients experience some form of organ rejection and whilst survival rates are high, a small percentage will die in the first year after surgery.

The new MRI technique, described in the journal Circulation, has been proven to be accurate in detecting rejection and works by analysing heart oedema levels which the team demonstrated are closely associated with inflammation of the heart.

**INDIA COLLECTS RS 1.41 LAKH CR GST IN MAY, UP 44% YOY**

GST revenue bucked the two-month rising trend in May and stood at nearly Rs 1.41 lakh crore, registering a year-on-year increase of 44%.

Though the May Goods and Services Tax (GST) revenue came in lower than the record high collection in April at Rs 1.68 lakh crore and Rs 1.42 lakh crore in March, it is still the fourth highest collection since the rollout of the new indirect tax regime on July 1, 2017.

In February, revenue from taxing sale of goods and services was at Rs 1.33 lakh crore, while in January it was Rs 1,40,986 crore.

"The gross GST revenue collected in the month of May 2022 is Rs 1,40,885 crore of which CGST is Rs 25,036 crore, SGST is Rs 32,001 crore, IGST is Rs 73,345 crore (including Rs 37,469 crore collected on import of goods) and cess is Rs 10,502 crore (including Rs 931 crore collected on import of goods)," the Finance Ministry said.

**TATA MOTORS BEATS HYUNDAI TO BECOME 2ND LARGEST CARMAKER IN MAY**

The homegrown automaker, Tata Motors has become the 2nd largest carmaker in the month of May 2022. Tata Motors sold 43,341 cars last month, while Hyundai's total domestic sales for the month of May 2022 stood at 42,293.

Hyundai has lost its number 2 spot to Tata Motors for the second time in last 6 months. In December 2021, Hyundai recorded low sales and was slipped to No.3 in the list of top 10 car manufacturers. In May 2022, Tata Motors has defeated Hyundai by good 1,048 units.

Hyundai Motor Company sold 42,293 cars and SUVs in domestic market in May 2022, reporting a year-on-year sales growth of 69.17 per cent. In May 2022, the company's export increased by 57.31 per cent to 8,970 units from 5,702 units in May 2021.

The company reported a cumulative sales of 51,263 units (Domestic + Exports) in May 2022, registering a year-on-year sales growth of 66.96%.

Commenting on the May 2022 sales, Unsoo Kim, MD & CEO, Hyundai Motor India Ltd., said, "Indian customers have showcased their love and trust in Hyundai, making us the most sold SUV brand of 2020 and 2021. Tata Motors has sold 43,341 cars in the passenger vehicle segment in May 2022, registering a massive year-on-year sales growth of 185%. The company had delivered 15,181 PVs in the same month last year. The company sold 39,887 ICE passenger vehicles in May 2022 as against 14,705 units in the same month last year.

**India's GDP grew by 8.7% in FY22 after 6.6% contraction previous fiscal****NEW DELHI (TIP)**

India's economic growth or GDP slipped to 4.1 per cent in the fourth quarter of 2021-22, while annual growth stood at 8.7 per cent, according to the government data released on Tuesday. In the previous fiscal 2020-21, the economy had contracted by 6.6 per cent as the Covid-19 pandemic disrupted business activities.

The growth was 20.1 per cent, 8.4 per cent, and 5.4 per cent, in the first, second and third quarters, respectively, as per the data released by the National Statistical Office (NSO).

The gross domestic product (GDP) had expanded by 2.5 per cent in the corresponding January-March period of 2020-21, according to the NSO.

The Economic Survey tabled in Parliament in February had estimated the GDP growth for the current fiscal (2022-23) in the range of 8 - 8.5 per cent.

According to the NSO data, India's real GDP grew to ₹147.36 lakh crore from ₹135.58 lakh crore in 2020-21.

The NSO, in its second advance estimate, had projected GDP growth during 2021-22 at 8.9 per cent. China had registered an economic growth of 4.8 per cent in the first three months of 2022. Rising global commodity prices have sparked concern among policymakers, with the Reserve of India (RBI) announcing its first interest rate hike in nearly four years earlier this month.

Government's chief economic adviser V Anantha Nageswaran ruled out the risk of stagflation in India as the country is better placed than other nations.

Stagflationary risk to India is quite low compared to other countries, he said.

Stagflation is the phase when both inflation and unemployment rates are high with moderation in GDP growth.

Prime Minister Narendra Modi's government earlier this month announced tax breaks to offset higher food and petrol costs. Consumer inflation hit 6.95 per cent in March, according

to the Reserve Bank of India, which slashed its own yearly growth forecast to 7.2 per cent.

**Eurozone inflation hits record 8.1% amid rising energy costs**

Inflation in the 19 countries that use the euro currency hit a record 8.1% in May amid surging energy costs prompted in part by Russia's war in Ukraine.

Annual inflation in the eurozone soared past the previous record of 7.4% reached in March and April, according to the latest data from European Union statistics agency Eurostat.

Energy prices jumped 39.2%, highlighting how the war and the accompanying global energy crunch are making life more expensive for the eurozone's 343 million people.

**Ford workers face uncertain future, stage protest, seek help from Tamil Nadu govt****CHENNAI (TIP)**

With the deadline for winding up operations nearing and with no ray of hope of another company taking over the unit, workers at Ford's Chennai car plant have started a protest demanding better severance package. Currently, production at the plant has come to a standstill.

Those workers who went in for their shift on Monday refused to go to the shop floor and started an in-house agitation. "We went inside and said we won't work until they provide a solution to us. The management told us that if we don't work, it would be marked as loss of pay," one of the workers inside, who has been there for the last 36 hours, told The Hindu.

Apart from this, those who came in for the second shift are protesting outside the plant. One of the protestors, also an employee said, "the management asked us to sign a declaration that we will not protest, we refused and we are all sitting here at the plant," he added. Around six workers who spoke said they were being utilized till the company finished production of all its pending cars. "We have finished all the pending work. Work on 1,500 cars is pending, and this will get over in a week's time. So now, the management has started treating us differently," one of them lamented.

One of the key union members said there was news about plans to use this plant for making electric vehicles, so the union put on hold talks for a few days. "We were hopeful that we will get jobs. But in the second week of May, we were told that there are no such plans. And now the company has indicated that business would be wound up by end of June," he added.

Sources said the Deputy Labor Commissioner from Sriperumbudur visited the plant and held talks, and more details would be made available later.

The employees requested the Tamil Nadu government to immediately look into this issue and extend help.

Last year, on September 9, the U.S.-headquartered carmaker said it would cease manufacturing vehicles for sale in India immediately; manufacturing of vehicles for export would wind down at the Sanand vehicle assembly plant by the fourth quarter of 2021 and the Chennai engine and vehicle assembly plants by the second quarter of 2022. There was no update from Ford's public relations team on the protest until the story had gone to print.

The festival of Ganga Dussehra is celebrated on the tenth day of the Shukla Paksha of Jyeshtha month. This day is a special day for Hindus as well as all mankind. Ganges Dussehra falls in the months of May and June. On Jyeshtha Shukla Paksha Dashami on Monday and Hasta-nakshatra, this date is considered to destroy the sins. Gangavataran took place on Wednesday in Hasta Nakshatra, on this date Ganga Dussehra is also known as Gangavataran. Therefore, this date is more important. On this date, ten sins are destroyed by bathing, charity, and tarpan, hence it is called Dussehra.

This is the day when Ganga was brought down to earth to cleanse the cursed souls of her ancestors and destroy sins. Before coming to earth, Goddess Ganga was residing in the kamandal of Lord Brahma.

Bathing in the Ganges has special significance on this day. All the sins of a person are destroyed by bathing the Ganges. The Ganges does not rot even if it is kept year round.

On this day, the fair of Ganga Dussehra is also held at Prayagraj, Allahabad, Garhmukteshwar, Haridwar, Rishikesh and Varanasi, devotees can also enjoy the fair after bathing in the Ganges. The Ganga Dussehra celebrations in Varanasi are legendary. Thousands of devotees bathe in the Ganges on the day of Ganga Dussehra and participate in the Ganga Aarti at Dasaswamedh Ghat in Varanasi and Har Ki Pauri in Haridwar.

#### Story

In ancient times, a king named Sagar ruled in Ayodhya. He had two queens named Keshini and Sumati. Keshini had a son named Anshuman and Sumati had sixty thousand sons. Once King Sagar performed the Ashwamedha Yagna. A horse was left for the Yajna fulfillment. Indra stole the horse and tied it in Kapil Muni's ashram to dissolve the yagna. Kapil Muni was doing penance. The king asked his sixty thousand sons to bring a horse. The king's sons reached the ashram of Kapil Muni, which disrupted the austerity of Kapil Muni and the anger of Kapil Muni was consumed by the fire.

Seeing his brothers after getting permission from the father of Anshuman, when Kapil reached Muni's ashram, Gurud ji told all the accounts of his brothers being consumed. Garuda ji also told Anshuman that if he wants his liberation, then Ganga ji will be brought from heaven to the earth.

After the death of Maharaja Sagara, Anshuman meditated to bring Gangaji to earth, but he failed. After this, his son Dileen also did penance but he also failed.

In the end, Dileep's son Bhagiratha went to the Gokarna Tirtha to do austerities to bring Gangaji to earth. Pleased with the austerity of Bhagiratha, Brahmaji gave the boon to take Ganga to earth. Now the problem was that after leaving Brahmaji's corpuscle, who would handle the velocity of Ganga on earth. Brahmaji said that none other than Lord Shankar have this power in the land which can handle the velocity of the Ganges. # History This Week June 6 to June 12

## June 6



Susan B. Anthony

June 6, 1872 - Pioneering feminist Susan B. Anthony was fined for voting in a presidential election at Rochester, New York. After voting rights had been granted to African American males by the 15th Amendment, she attempted to extend the same rights to women. She led a group of women that voted illegally, to test their status as citizens. She was arrested, tried and sentenced to pay \$100, which she refused. Following her death in 1906 after five decades of tireless work, the Democratic and Republican parties both endorsed women's right to vote. In August of 1920, the 19th Amendment to the U.S. Constitution was finally ratified, allowing women to vote.

June 6, 1944 - D-Day, the largest amphibious landing in history, began in the early-morning hours as Allied forces landed in Normandy on the northern coast of France. Operation Overlord took months of planning and involved 1,527,000 soldiers in 47 Allied divisions along with 4,400 ships and landing craft, and 11,000 aircraft. The Germans had about 60 divisions spread along France and the Low Countries. American forces landed on two western beaches, Utah and Omaha, while British and Canadian troops landed farther east on Gold, Juno and Sword beaches. By the end of the day 150,000 Allied soldiers and their accompanying vehicles had landed with 15,000 killed and wounded.



Nathan Hale

Birthday - American patriot Nathan Hale (1755-1776) was born in Coventry, Connecticut. During the American Revolution, he volunteered for a dangerous spy mission in Long Island and was captured by the British on the night of September 21, 1776. Brought before British General William Howe, Hale admitted he was an American officer. Howe ordered him to be hanged the following morning. As Hale mounted the gallows he uttered, "I only regret that I have but one life to lose for my country."

## June 7

June 7, 1965 - The U.S. Supreme Court struck down a Connecticut law banning contraception. In *Griswold v. Connecticut*, the Supreme Court guaranteed the right to privacy, including freedom from government intrusion into matters of birth control.



Paul Gauguin


Birthday - French painter Paul Gauguin (1848-1903) was born in Paris. He worked as a stockbroker, then became a painter in middle age. He left Paris and moved to Tahiti where he developed an interest in primitive art. Among his best known paintings; *Vision After the Sermon* (1888), *When Shall We Be Married?* (1892), *Holiday* (1896), and *Two Tahitian Women* (1899). His style using broad, flat tones and bold colors, inspired artists such as Edvard Munch, Henri Matisse, and the young Pablo Picasso.

## June 8



Cochise

June 8, 1874 - Apache leader Cochise died on the Chiricahua Reservation in southeastern Arizona. After a peace treaty had been broken by the U.S. Army in 1861, he waged war against settlers and soldiers, forcing them to withdraw from southern Arizona. In 1862, he became principal chief of the Apaches. He and 200 followers avoided capture by hiding in the Dragoon Mountains. In June of 1871, Army General George Crook assumed command in Arizona and managed to win the allegiance of many Apaches. Cochise then surrendered. He disappeared briefly in the spring of 1872 but returned and settled on the reservation where he died.



Frank Lloyd Wright

Birthday - American architect Frank Lloyd Wright (1867-1959) was born in Richland Center, Wisconsin. He designed about 1,000 structures and is considered the most influential architect of his time. He became the leader of a style known as the Prairie School featuring houses with low-pitched roofs and extended lines that blend into the landscape. He once wrote, "No house should ever be on any hill or on anything. It should be of the hill, belonging to it, so hill and house could live together each the happier for the other."

## June 9

June 9, 1898 - The British signed a 99-year lease for Hong Kong, located on the southeastern coast of China. Hong Kong, consisting of an area measuring 400 square miles, was administered as a British Crown Colony until July 1, 1997, when its sovereignty reverted to the People's Republic of China.

Birthday - Composer and lyricist Cole Porter (1893-1964)



Cole Porter

was born in Peru, Indiana. He published his first song *The Bobolink Waltz* at the age of ten. His Broadway career was launched in 1928 when five of his songs were used in the musical play *Let's Do It*. Among his many contributions to the Broadway stage; *Fifty Million Frenchmen*, *The Gay Divorcee*, *Anything Goes*, *Leave It to Me*, *Du Barry Was a Lady*, *Something for the Boys*, *Kiss Me Kate*, *Can Can* and *Silk Stockings*.

June 10, 1652 - In Massachusetts, silversmith John Hull opened the first mint in America, in defiance of English colonial law. The first coin issued was the Pine Tree Shilling, designed by Hull.

June 10, 1942 - In one of the most infamous single acts of World War II in Europe, all 172 men and boys over age 16 in the Czech village of Lidice were shot by Nazis in reprisal for the assassination of SS leader Reinhard Heydrich. The women were deported to Ravensbrück concentration camp where most died. Ninety young children were sent to the concentration camp at Gneisenau, with some later taken to Nazi orphanages if they were German looking. The village was then completely leveled until not a trace remained.



Hattie McDaniel

Birthday - African American actress Hattie McDaniel (1889-1952) was born in Wichita, Kansas. She won an Academy

Award in 1940 for her role as 'Mammy' in *Gone with the Wind*.



Judy Garland

Birthday - Judy Garland (1922-1969) was born in Grand Rapids, Minnesota (as Frances Gumm). She is best remembered for her portrayal of Dorothy Gale in *The Wizard of Oz* (1939) and other films including *Meet Me in St. Louis* (1944) and *Easter Parade* (1948). She became one of the most popular concert performers of the 1950s and '60s and broke box-office records in New York City and London. She was found dead of an overdose of sleeping pills in London on June 22, 1969.

June 11, 1991 - Mount Pinatubo in the Philippines erupted, spewing ash into the air, visible over 60 miles. The surrounding areas were covered with ash and mud created by rainstorms. Nearby U.S. military bases were also damaged.

## Hunt on for killers of Sidhu Moosewala; Special Investigation Team constituted

Talking to reporters in Mansa on Wednesday, June 1, Senior Superintendent of Police Gaurav Toora said the police have got important leads and they are working on it. On whether Mansa police will bring Bishnoi on remand, the SSP said, "Definitely. We have information that the Delhi Police has taken the remand of Bishnoi. After that we will make him join the investigation in this case as per the law."

The Punjab Police has described Moosewala's murder as a case of an inter-gang rivalry. Canada-based Goldy Brar, who is a member of the Bishnoi gang, has claimed responsibility of the murder.

SSP Toora further said the police have traced the route the criminals involved in the murder took. "From where they came, how they conducted a recce and how they escaped - we have cleared this all," he said.

He said different police teams, including the cyber cell, were involved in the investigation. "We have got important leads and we are working on that," he added.

Referring to the murder, the SSP said it was the work of organized criminals and gangsters. He said two gangsters were brought here on production warrants from prisons.

One person has already been arrested in this case, he said. "They are being questioned," the SSP added.

The police on Tuesday, May 31, said they had arrested Manpreet Singh in the Moosewala murder case. Singh has been accused of supplying vehicles to the assailants who were involved in the killing. (With inputs from PTI, Tribune)

## Canada to put a freeze on importing, buying or selling handguns

Bill Blair, minister of emergency preparedness, said Canada is very different from the United States.

"In Canada, gun ownership is a privilege not a right," Blair said. "This is a principal that differentiates ourselves from many other countries in the world, notably our colleagues and friends to the south. In Canada, guns are only intended to be used for hunting

Canada has had far fewer mass shootings than the US in part because of a lack of easy access to guns, though the US population also is far larger than Canada's.

Blair noted guns are often smuggled in illegally from the US, which he noted has one of the largest small arms arsenals in the world.

The government plans to fight gun smuggling and trafficking by increasing criminal penalties, providing more tools to investigate firearms crimes and strengthening border measures. Trudeau said increased funding already helped border officials double the amount of smuggled guns confiscated at the U.S. border.

The government also said the bill would also allow for the removal of gun licenses from people involved in acts of domestic violence or criminal harassment, such as stalking.

The bill would create a new "red flag" law allowing courts to require that people considered a danger to themselves or others surrender their firearms to police. The government said the measure would guard the safety of those applying through the process, often women in danger of domestic abuse, by protecting their identities.

The government said it will require rifle magazines to be permanently altered so they can never hold more than five rounds and will ban the sale and transfer of large-capacity magazines under the Criminal Code.

"Canada can teach us a lot," tweeted Bruce Heyman, a former U.S. ambassador to Canada under the Obama administration.

Trudeau said his government recognizes the vast majority of Canadians who own guns are responsible but the level of gun violence is unacceptable. "This is a concrete and real national measure to long way toward keeping Canadians safe," Trudeau said.

The new measures are assured of passing in Canada's Parliament as the ruling Liberals and leftist opposition New Democrats have enough votes.

Pierre Poilievre, who is running to be leader of the Conservative party, said law-abiding gun owners should be respected and dangerous criminals should be jailed. (Agencies)

## National Commission for Women meet recommends helpline for abandoned wives of NRIs

challenges faced by deserted wives in the legal system in India and abroad.

"The meeting took up issues such as ways to serve a non-bailable warrant against a male offender residing abroad who has abandoned his wife. Often, these men keep changing their address and it gets challenging to track them. So, we have suggested that a special website be set up, so that summons posted there are deemed as served on a person. Another way to track them would be through their Social Security Number," ex-Chairman, Punjab State Commission for NRIs, Justice (Retd) Rakesh Kumar Garg told The Hindu.

Other matters discussed were ex-parte judgments on divorce obtained by husbands abroad, which are already addressed under Section 13 of the Civil Procedure Code that deals with conditions under which foreign judgments are not conclusive, said Mr. Garg.

Instances of child custody disputes were also raised. "For such matters, when a habeas corpus writ is brought to India for producing a child before a foreign court, Indian courts have often held that both parents are natural guardians under Indian laws and, in fact, mother is the guardian of a child under five years. We are also not signatories to the Hague convention, so we don't have to return the child."

The consultation did not, however, discuss whether India should sign the Hague Convention, which requires that if a parent has run away with a child from one country to another due to a marital dispute, the child has to be returned to the country from where he or she has been removed. The Indian government maintains that it is not ready to sign the treaty.

Another person who attended the meeting said on condition of anonymity that ways to ensure maintenance for such wives, legal assistance, and financial support through a dedicated fund were also raised.

Many of the suggestions made are not new. They were part of the report of an expert committee formed by the Ministry of Women and Child Development and headed by Justice Arvind Kumar Goel, ex-Chairperson, NRI Commission, Punjab, submitted in August 2017. On the basis of these suggestions, a meeting chaired by the then External Affairs Minister Sushma Swaraj in November 2017 took a decision to ensure compulsory registration of NRI marriages and set up a website of MEA for posting summons.

Following this, in February 2019, the Ministry of External Affairs introduced the Registration of Marriage of Non-Resident Indian Bill, 2019, in Rajya Sabha. The Bill was sent to a Parliamentary Standing Committee, which approved it with some recommendations. But after the passing of Sushma Swaraj in August 2019, the Bill has been put in cold storage. Khanna is one of the first Indian chefs to receive international acclaim. Since 2011, his main restaurant Junoon in New York City has received a Michelin star, a hallmark of fine dining.

Khanna has served food to the former US president Barack Obama, the Dalai Lama, Pope Francis, Prime Minister Narendra Modi, and many other world leaders and celebrities.

## Facebook sees 82 per cent jump in hate speech; violent content rises 86 per cent on Instagram in April

The majority of the content in the report is based on detection by social media platforms before users reporting to them.

According to the report released on May 31, Facebook detected 53,200 hate speech in April, which is 82 per cent higher compared to 38,600 detected in March, on which the platform took action.

The report showed that Instagram acted on 77,000 violence and incitement related content in April compared to 41,300 in March.

"We measure the number of pieces of content (such as posts, photos, videos or comments) we take action on for going against our standards. This metric shows the scale of our enforcement activity. Taking action could include removing a piece of content from Facebook or Instagram or covering photos or videos that may be disturbing to some audiences with a warning," the report said.

**T**himphu is known as the heart of Bhutan nestled in its central-western part. #### MEMORIAL CHORTEN

The Memorial Stupa, also known as Thimphu Chorten is one of the most prominent landmarks of the capital city. Envisioned by Thinley Norbu (1904–1987), the chorten was erected in 1974 as per Nyingma tradition of Tibetan Buddhism to honour the third Druk Gyalpo, Jigme Dorji Wangchuck (1928–1972). This is to fulfil his wish of building a chorten which represents the mind of Buddha while Jigme Dorji was alive. The remarkable thing about this stupa is that it does not preserve any human remains unlike other chortens and got only a photo of Jigme Dorji in ceremonial dress. As you will enter the gate, 100s of devotees would be seen praying around this stupa, mainly the older people. Memorial chorten is located on Doeboom Lam in the southern part of the city.


#### ARCHERY IN THIMPHU

Since archery is the national sport of Bhutan, it would be an experience of a lifetime for traveller to witness a game of archery. All you need to do is pay a visit to the archery stadium in Thimphu and simply sit back and enjoy a game which is as common as soccer in many countries. What adds to the experience is the traditional dance when an archer hits the bull's eye. Make sure you carry a pair of sunglasses and some munchies to enjoy your entire time at the stadium.

#### ROYAL TEXTILE ACADEMY

Bhutan's best museum is located at Royal Textile Academy, which was started in May 2005 with an aim to preserve and showcase the traditional art of Bhutan, weaving. It was started under the patronage of Her Majesty Queen Mother Sangay Choden Wangchuck as a non-profit organisation. The objective of this organisation has been to develop conservation centre to restore the Bhutanese textile, as well as provide the professional training to men and women in weaving and textile. The training is given free of cost to the women in lieu of promoting women empowerment. The Royal Textile Academy is Bhutan's first institute to educate, train, and fill the younger

generation with a comprehensive knowledge of the country's textiles.

#### CHANGANGKHA LHAKHANG

One of the ancient temples in Thimphu, Changangkha Temple was established on a site chosen by Phajo Drukgom Shigpo, the founder of Drukpa Lineage in Bhutan. The temple was laid in 12th century, the work of which was extended by his son in the 13th century. This oldest temple houses an eleven-headed, thousand-armed manifestation, and large prayer wheels. In fact the temple also houses incredibly huge size of Tibetan texts which are unusual from the rest. Enjoy the view from the courtyard, which has got restored in 1998-99.

#### TASHICHO DZONG

Tashichoo Dzong which translates to fortress of auspicious religious conviction conventionally was the seat of monastic body, and summer capital of the country. The dzong is serving as the government seat since 1952, and presently it houses the king office, secretariat, and other government organisations located nearby. It is also the headquarters for central monastic body of Bhutan, which opens up for general public after 5:30 pm. Unlike other dzongs, Tashichoo has two main entrances. One heads towards the south of the administrative section, and another leads towards the north to the monastic section, where annual tsechu festival is celebrated. The foundation of Thimphu dzong was first laid by Lama Gyalwa Lhanangpa in 1216. The dzong is located next to the banks of Wangchhu River, which is surrounded by a beautiful lawn. Visit this dzong for its authentic and stunning architecture. Don't forget to spot the parliament building of Bhutan, which is quite visible from here.

## INDIA TO PLAY 3 ODIS AND 5 T20IS VS WEST INDIES BETWEEN JULY 22-AUGUST 7

The Cricket West Indies (CWI) and the BCCI on Wednesday announced India's tour of the West Indies where the 'Men in Blue' will play three ODIs and five T20Is between July 22 and August 7.

India will finish its white-ball leg of UK tour on July 17 and those selected would directly leave for the West Indies from England. The ODI series and three T20Is will be hosted across Trinidad and Tobago and St Kitts & Nevis, with the final two T20Is scheduled to be held in Fort Lauderdale, Florida in the USA.

The three ODIs will be played on July 22, 24 and 27 respectively at Port of Spain's (Trinidad & Tobago) iconic Queen's Park Oval and will be followed by five T20Is, two of which will be played at Florida's Fort Lauderdale.

The first T20I will be held at Brian Lara Stadium (Port of Spain) on July 29 and followed by two games at St Kitt's Warner Park on August 1 and 2 respectively. The final two games, in order to cater to the Indian diaspora in the United States, will be held at the Broward County Stadium in Florida on August 6 and 7. The entire series will be live-streamed exclusively on FanCode.

West Indies captain Nicholas Pooran said on the upcoming series, "We have a young team that is eager to restore the brand of cricket the West Indies team is known for playing."

"As I take charge of this team, our ambition is to always be competitive, as we look to use this series to fine tune our preparations for the upcoming T20 and 50 Over World Cups." Talking about this, Johnny Grave, CEO of Cricket West Indies said: "Our four-year deal with FanCode has brought Indian cricket fans closer to CWI's live properties across multiple formats that has featured the top cricketing nations like South Africa, Pakistan, Australia and England."

## Messi inspires Argentina to 3-0 Finalissima win over Italy

Enraged at Wembley by Lionel Messi's assists, Argentina's players threw their superstar teammate in the air after he inspired them to a second title in a year. National team success is finally coming for the seven-time Ballon d'Or winner, late in his trophy-filled club career.

Argentina collected the first Finalissima trophy on Wednesday by beating Italy 3-0 in a meeting of the South American and European champions, with Messi having helped Argentina win the Copa America last July for his first major title with the national team.

And judging by the two assists on his record-extending 161st Argentina appearance, there is no sign of the 34-year-old Messi slowing down with the chance to win a first World Cup title later this year.

"What we experienced here was beautiful," Messi said. "We knew it was going to be a nice game and a nice setting in which to be champions."

# Gujarat Titans complete dream debut with IPL title

AHMEDABAD (TIP)

Nobody gave them a chance but Gujarat Titans, bucking all pre-tournament predictions, surprised everyone by lifting the Indian Premier League title in a dream maiden season after a seven-wicket victory over Rajasthan Royals in the final here on May 29.

Gujarat's highly-rated bowling attack, led by skipper Hardik Pandya (3/17) himself, limited a formidable Rajasthan Royals batting unit to 130 for nine after losing the toss.

Shubman Gill and David Miller remained unbeaten on 45 and 32, respectively, to complete an emphatic win for their team.

It should have been a comfortable chase but Rajasthan bowled their hearts out to make it an interesting final. As they showed all season, Gujarat remained calm in tough situations to finish the chase in 18.1 overs.

Not many gave Gujarat a chance in their first season especially after a mixed auction where they waited till the end to secure the services of wicketkeepers Wriddhiman Saha and Matthew Wade.

It was not a team studded with star players but Hardik impressed with his leadership and got the best out of his colleagues.

His performance with bat and ball also contributed immensely to the team's triumph besides the ability to bounce back from any situation through the brilliance of Miller and Rahul Tewatia.

After posting an underwhelming total, Rajasthan had to produce a special effort

Krishna got one to seam back in from good length to breach Saha's defence and crash into the stumps.

Boult, who also bowled a maiden over in his tidy spell, removed Wade. Gujarat would have been three down in the powerplay if Yuzvendra Chahal held on to a simple catch of Gill off Boult in the first over of the innings.

Hardik and Gill struggled to get the boundaries but never felt extreme pressure as the asking rate remained very much in control.

R Ashwin was introduced in the 12th over and Hardik (34 off 30) decided to go after him, collecting a four and six off successive balls to bring up the 50-run stand with Gill and take Gujarat to 77 for two in 12 overs. The skipper fell to a brilliant leg break from Chahal but Gill and Miller got the job done in the end. The entire stadium, housing more than a lakh people, erupted when Gill hit the winning six.

Nilam Sanjeeb Xess (9th minute), Dipsan Tirkey (21st), Mahesh Sheshe Gowda (22nd) and Sakthivel Mareeswaran (37th) scored for India, while South Korea scored through Jang Jonghyun (13th), Ji Woo Cheon (18th), Kim Junghoo (28th) and Jung Manjae (44th).

The Koreans take on Malaysia in the final tomorrow, while India play Japan in the third-fourth place classification match.

Today's match saw a midfield slugfest between India and South Korea as they



tried to take the upper hand in the first quarter.

India secured a penalty corner in the second minute but Xess' effort was saved by the Korean goalkeeper Jaehyeon Kim. But in the ninth minute Xess made no mistake from the team's second penalty corner.

Two minutes from the end of the first quarter, India conceded a penalty corner and Jonghyun levelled the scores.

The Koreans made it 2-1 five minutes later when Cheon chose his spot after being fed by Jungjun Lee following a defensive lapse by Pawan Rajbhar inside his own circle.




